M olecular dynam ics sim ulations of intensive plastic deform ation

K inetics of dislocations is studied by means of computer simulation during intensive plastic deformation. The dynamical elect in the form of soliton-like wave of sharply disrupted interparticle bonds is observed. A long with it, micropores similar to steam bubbles at water boiling are formed. A fler some deformation the solid takes an ideal structure again owing to "emission of the bubbles". The dislocations in this state (with micropore) can form a grain boundary in the case of nanostructural materials. The nanoscopic object of rotational nature is observed at uniaxial intensive deformation. Rotation of some volume of sample which realized with phase transition scenario was observed by intensive shear deformation.

I. IN TRODUCTION

A new methods of intensive plastic deformation for achievem ent of nano-structure in m etals had been developed [1]. It is common know ledge that the main vehicle of plastic deformation is dislocation. In recent papers new vehicle of plastic deform ation had been investigated widely form etal glasses. It is so called shear transform ation zone (STZ) [2], [3], [4], [5]. On other hand, there is a large body of research of di erent dynam ical objects in non-linear chains. They are moving breathers in di erent non-linear system s [6] and kinks in acoustic chains [7], [8]. The main property of these objects is spontaneous concentration energy in the large excitations at cost of suppress of weak ones. It is possible to assume that such concentration in three-dim ensional case can lead to rearrangem ent of internal structure of solid during intensive deform ation.

II. CONSTITUTIVE RELATIONS

For the check of mentioned above assumption numericalexperiment on two-dimensionalmodelwasperformed by means of MD -simulation. Model system of 18*18 particles with Lennard-Jones potential is used:

where $r_{ijlk} = \frac{P}{(X_{ij} X_{lk})^2} (Y_{ij} Y_{lk})^2$ - is the distance between the particles numbered by i; j and l;k


with C artesian coordinates X $_{\rm ij}$; Y $_{\rm ij}$ and X $_{\rm lk}$; Y $_{\rm lk}$. Indexes i; I num erate atom s in the lattice along the Y -direction, j;k do the same along the X -direction. Let use a unit in which the constants are equal to $A = 0.0025 J_c m_c^6$, $B = 1m_{c}^{6}$, where J_{c} and m_{c} are conventional units of energy and length respectively. W e put the mass of a particle to be $M = 0.01 \text{ kg}_c$, where kg_c is conventional unit of mass. The binding energy of pair interaction is found to be $E_b = A = 12B = 0.00020833 J_c$ and equilibrium distance is $r_0 = {}^{t_6} B = 1 m_c$. In case of realmaterial it is necessary to perform the re-com putation with account of realvalues of $E_{\rm b}$; r_0 and the mass M . For example, in the case of copper $E_{\rm b} = 0.5493 \quad 10^{19} \,\text{J}$, $r_0 = 2.66 \quad 10^{10} \,\text{m}$, $M = 1.0541 \quad 10^{25} \text{ kg. Then, } 1m_c = 2.66 \quad 10^{10} \text{ m},$ $1kg_c = 1.054$ $10^{23} kg$, $1s_c = 0.532$ $10^{13} s$. The time unit have the sam e order as the period of sm all vibrations $T = 2 m = U_{ijlm}^{00}$. Time step for simulation is chosen to be $4 t = 0:18s_{c}$.


III. UNIAXIAL LOADING

The rst series of real time computer simulations is fullled for uniaxial bading of a crystallite sample. The system is placed on rigid platform constructed from the atom s identical with those in the sample (the lowerm ost line of atom s on the gures). The rigid atom ic line (plane in a three-dimensional case) constructed from the same atom s moves downward with a constant velocity 2:778 10^4 m_{c} =s_c (the upperm ost line of atom s on g. 1). Initial atom con guration is hexagonal lattice with interatom ic distance r₀ = 1m_c.

In the rst stage the usual uniaxial elastic deform ation goes (Fig.1a). Further, two m icroscopic defects occur alm ost simultaneously in the left upper corner of the lattice and in the right down one (Fig.1b). Their Burgers vectors have identical direction (at a 120 angle with horizontalaxis) and opposite signs. These defects are similar to usual dislocations [9]. How ever each of them has two and only two inserted atom ic lines. They can't have one

inserted atom ic line since atom ic con guration doesn't perm it it owing to very large energy of the defects. Two inserted lines and glide line are oriented at 60 angle each to another. Both of the inserted lines always lie on one and only one side of the glide line. It is pertinent to call a defect with two inserted atom ic lines as bidislocation. A long with two-dimensional lattice, such defects m ay be observed in three-dimensional case on the planes of closely packed layers (planes f1;1;1g). In general case of hexagonal lattice six type of bidislocation having B urgers vectors with the angles 0; ; =3; 2 =3 m ay take place. In complex plane these vectors are expressed as

where a_0 - is equilibrium distance in the crystallite.

In these terms, arisen bidislocations have following Burgers vectors:

Under following loading the bidislocations move along their glide lines for as long as they reach the rigid lines of atoms (Fig. 1c). Then, the bidislocations stop for some time because the rigid lines play the role of obstacles for further moving. Owing to this retardation, the bidislocationons form the pair with zeroth total Burgers vector. In this case the rotation of the region between the bidislocations takes place. This region has approxim ately circle form. The bidislocations lie exactly on diam etrically opposite sides of the circle boundary. In this nanoscopic region the orientation of atom ic lines (planes) along B urgers vector changes continuously. O wing to this property, observed pair of bidislocations m ay be sim plest two-dim ensional m odel of displanation [10], [11]. The displanations are known as defects of m esoscopic level. It is clear from presented experim ent that sim plest m odi cation of the displanations has nanoscopic nature.

Stopping of the bidislocations creates di culties for repairing of ideal crystal sym metry. As a consequence, local concentration of elastic energy around defects takes places. It is clear that for nishing of sym metry repairing gliding lines must turn to the direction along rigid lines of atom s. W hat scenario does the system choice for it?

At the time of 600 time steps ashover-like puncture of the region between the bidislocations occurs (Fig. 1d). A fler it both the bidislocations are turned (Fig. 1e) and pressed out from the lattice in the direction parallel to rigid lines (Fig. 1f). Thereafter, the sam ple takes ideal crystal structure. Then, with continuing of loading the processes are qualitatively repeated.

It is known that di erent transform ations of dislocations can be regarded as chem ical [12] or, better still, as elem entary particle reactions. From this standpoint, in the case of two-dim ensional hexagonal lattice any bidislocation m ay be considered as an elem entary particle with vector charge (2) or as three particles (like quarks) with di erent own polarization and with internal coordinate (as spin). Let us denote the set of "elem entary particles" as

Then the transition with rotation of glide lines (g. 1.d-f) can be written in the form of reaction:

Therew ith, the law of conservation of charge is ful led:

The law of conservation of charge momentum is fullled since the distances between glide lines pre and postreaction are equal (7 lines between them on the g. 1d,f). The law of conservation of energy is full lled since the system is H am ilton one. As own energy of each of two bidislocations pre and post-reaction doesn't change (in consequence of their identic structure) accum ulated elastic energy alm ost com pletely turns into kinetic energy (relaxation of stress).

Regarding all the pictures presented in the g. 1, one can note that bidislocation nucleus isn't localized in the point, but it is continuously sm eared along the glide line in the region of several atom ic sizes. The discrepancy of crystalline atom ic lines begins with the distortion of them at bidislocation edges and increases gradually toward center. Near a glide line the chain of atom s viewed from the side of more rare ed region of crystallite is stretched. Let call this atom ic chain as "stretched" chain. The chain viewed from the opposite side of the glide line is term ed as "com pressed" chain. The atom s in the stretched chain are localized in energetically unfavorable positions to ones in the compressed chain. However, the atom s are xed in these positions owing to e ective interaction with those in their own chains and with nearest atom s of the rest lattice.

Let set as 1 equilibrium interparticle distance in the region far from the bidislocations. Then, in the com -

pressed chain interparticle distance is equal to 1.1 and to 0.95 in stretched chain. M oreover, all the simulations exhibit the next trend. In the chains parallel to com pressed and stretched ones and viewed from the com pressed chain interparticle distance takes its asymptotic value 1 rapidly, already in the st chain. A lternately, in parallel chains viewed from the stretched one several chains are markedly stretched. Thus, the region of com pression is more localized then the region of rarefying. Owing to this, potential energy of any particle in the compressed chain is more large than one in asymptotic zone. This peculiarity is the main sign for structure defects of any nature and permits to separate bidislocations in mediately during computer simulation. Moving colored bidislocations against the background of the rest atom s is very nice picture. A verage potential energy per atom in the compressed chain consists of 60-70 percent of one on free surface of the sample. Potential energy of whole the system in initial state of lattice is chosen as zeroth level.

IV. "KNIFE" LOAD ING

M ore interesting result is obtained in the second series of computer simulation for cutting the sample by three-atom knife (g. 2). Three atoms only are left from m oving upper rigid line of atom s. O ther parameters of the experiment remain as in the Sec. III.

In the rst stage, in general, the picture qualitatively boks like to one obtained in the previous num erical experiments. E lastic stage of deform ation isn't so interest. Further, the pair of bid is locations is created in the upper left and right corners of the crystallite. Their glide lines are turned by 60° each to another. The bid is locations occur in the region under three-atom indentor and move dow nw ard. Then, the bid is locations turn and they are pressed out from the sample.




FIG.2: Evolution of crystallite structure at cutting by three atom knife: a - ideal crystal structure in beginning stage, b,c - form ation of usual bidislocation, d, fh - form ation of bidislocation with m icropore, e - renew al ideal crystal structure after rst "bubble".

Interesting phenom enon is observed at such pressing out (Fig. 2). The defect displayed on the gure has two additional lines and Burgers vector as the bidislocation does, but its form su ciently di ers. The stretched chain has gap in the center of bidislocation nucleus. That is, binding am ong centered atom s is broken and m icropore arises.

Owing to the micropore, the bidisboation becomes more local and more sharp. Atom ic lines in the regions separated by the norm alto glide line are inclined at a big angle each to other. One can regard the line which separates such regions as an element of a boundary between grains.

D uring num erical experim ent new bidisboations with m icropores arise and disappeare again and again. W hole the picture is similar to formation of steam bubble at water boiling. Owing to this "em ission of the bubbles", the solid take on ideal structure again after some deformation.

On the other hand, the movement of a such object

through the lattice is similar to kink-like excitation in acoustic chain. W ave-like disruption and repairing of bonds between atom s give rapid pressing out of defects from a sample.

Thus, at intensive in uence on m etalit m ay release not only by well known shear deform ation, but by wave-like (or excitation-like) bond disruption, which moves rapidly enough. One can assume that the micropore, namely, is the sign of new state of bidiislocation, which arises just during intensive deformation. In three-dimensional case the m icropores can be spherical or elliptic bubbles. After stopping of deformation they disappear through the "condensation" into usual dislocations. Probably, it is di cult to detect the bidislocations with micropores in experim ent as separate objects. U sual X -ray di raction analysis isn't suitable for investigation of such states and structure re-arrangements for two reasons. By the rst, such analysis is ful lled much laterafter nish of intensive plastic deformation. By the second, the solid in such process can be in non-equilibrium am orphous state with large widening of X-ray spectrum line. For detection of such states and its changes, it is necessary to execute X ray analysis just during intensive plastic deform ation or, maybe, immediately after it.

V. SHEAR LOAD ING

A great am ount of such objects occurs in the case of intensive deform ation by shear scheme. This scheme is realized in the following way: the sample consisted from 28*28 particles is placed in rigid two-dimensional box constructed from atoms identical with those of sample. The box is deformed by horizontal movement of upper and down rigid lines with constant velocity.




FIG.3: Evolution of crystallite structure with shear deform ation: a -birth of rst bidislocation, b-d -m oving of two defects, e -bidislocation decay with birth of two new bidislocation, f-system after bidislocation decay.

The created dislocations with m icropores form boundary separated regions with di erent orientation of crystalline atom ic lines (Fig.3). Such boundary can play important role for form ing of nano-structural state by m eans of the m ethods of large shear deform ation.

At the beginning stage of deform ation single bidislocation is bome in the left down comer of the sample (Fig. 3a). It has the charge $a_0 \exp(2 i=3)$ and moves along glide line toward the upper boundary. At the following stage, the second bidislocation with the charge $a_0 \exp(i=3)$ comes into being and moves along glide line toward the upper boundary too (Fig. 3b). The glide lines of both bidislocations are crossed at the same point exactly on the upper boundary. W ith the lapse of time the rst bidislocation takes the form of microcrack (Fig. 3c) and preserves this form for a time (Fig. 3d). In the following lapse the st bidislocation begin to take the form of sharp bend (Fig. 3e). Upon it, pair of bidislocations arises instead the rst one. One of them has the charge a_0 and another has the charge $a_0 \exp(i=3)$. Their total charge is equal to $a_0 \exp(2 i=3)$, i.e. it is equal to the charge of the initial rst bidislocation. Such transformation can be written as decay reaction in the

where the second term in the left part of equation is the energy of stress eld which causes the birth of additional "particle". The rest of stress eld energy transform s into therm all energy. As the result, alm ost full relaxation of elastic stress take place.

The dislocations with m icropores form boundary separated regions with sharply di erent orientation of crystalline atom ic lines (g. 4). Such boundary can play important role for forming of nano-structural state by the m ethods of large shear deform ation. Single, but very interesting result had been xed in computer experiment when rotation of certain volume by scenario of phase transition takes place. At some deform ation the boundary is formed as a chain of bidislocations with m icropores. At following loading it m oves steadily until escape from the sample. In this case the boundary separates phases of identical nature, but with di erent orientation

of crystalline atom ic lines only.


W ith my point of view, the defects described above have similar nature to them considered in ref. [2] - [5]. Our "STZs" di er from [2] - [5] ones because the form er are observed in ideal crystallite, but no in am orphous m etallic glass.


VI. SUMMARY


Thus, quark-like behavior of bidislocations is observed in di erent num erical experim ents. It is established that the bidislocations m ay have at least two di erent structural states. The rst of them has whole stretched chains, the second has m icropores. The bidislocations with m icropores, as a rule, have pentagon form. The states with crack-like form of bidislocations are possible too (Fig. 3c,d). The transient bent form of m icrocrack arises at the decay of dislocation (Fig. 3e). The superhigh-speed soliton-like m ovem ent of bidislocations with m icropore is noted.
