Magnetic eld chaos in the SK Model

Abstract

W e study the Sherrington {K irkpatrick m odel, both above and below the De A lm eida Thouless line, by using a modi ed version of the Parallel Tem pering algorithm in which the system is allowed to move between di erent values of the magnetic eld h. The behavior of the probability distribution of the overlap between two replicas at di erent values of the magnetic eld h_0 and h_1 gives clear evidence for the presence of magnetic eld chaos already for moderate system sizes, in contrast to the case of tem perature chaos, which is not visible on system sizes that can currently be therm alized.

1 Introduction

The Sherrington {K irkpatrick (SK) model was introduced quite a long time ago [1] as a mean eld model for spin glasses. Its proposed analytical solution [2] displays intriguing features such as an in nite number of pure states in the glassy phase, described by an order parameter which is the non trivial probability distribution of the overlap between two states, P (q). A fler more than twenty years this solution is still the subject of works aim ing at establishing it in full mathematical rigor [3, 4], whereas long standing open issues concern the study of the corrections to the mean eld approximation below the upper critical dimension [5] and the very applicability of the mean eld picture to short range realistic spin glasses [6].

An interesting question concerns the way in which the states reorganize them selves when the system is subjected to a small perturbation p of an external parameter, in particular the tem perature T or the magnetic eld h. There is the intriguing possibility of p chaos, namely that states at p and states at p + p are as di erent as possible in the therm odynamic lim it.

The possible presence of tem perature chaos in the SK and related models is an old subject of investigations [7]-[10] that recently received a bt of attention both analytically and num erically [11]-[16]. From a very recent analytical computation [17] it turns out to be present but to be of the ninth order in perturbation theory, a very weak e ect, extrem ely di cult to be num erically observed on the system sizes one is currently able to therm alize.

The aim of this paper is to investigate the appearance of chaos with increasing system sizes (a question that cannot be addressed by existing analytical techniques, that are restricted to the asymptotic N ! 1 regime), in a case where chaos is strong, namely the case of magnetic eld chaos. The presence of magnetic eld chaos was predicted already twenty years ago [18] (see also [7, 10]). From the numerical point of view, it was observed in a previous work [9] from a study of the behavior of the second moment of the probability distribution of the overlap P_{h_0,h_1} (q) between replicas at $h_0 = 0$ and $h_1 \in 0$. This pioneering paper can how ever be criticized since m any data points are on the wrong side of the D e A lm eida Thouless (AT) line [19]. W e will revisit the problem by looking (in the SG phase) at the distribution P_{h_0,h_1} (q) itself, a quantity whose interpretation is simpler than the moments.

M one in detail, in terms of the probability distribution of the overlap between two replicas at di erent values of the external parameter h_0 and $h_1 = h_0 + h$, chaos has a very clean signature. Taking for simplicity the case $h_0 = 0$, for small volum es $P_{0;h}(q)$ has two peaks, and is very similar to $P_{0;0}(q)$ on the same volume. As the volume grows, a peak develops around the minimal value of the overlap $q_n = 0$, in such a way that for very large volum es $P_{0;0}(q)$ (q). In the temperature chaos case, this chaotic peak is hardly visible with current computers and algorithm s. Our aim is to determ ine if and how this \chaos peak" scenario takes place in the case of h chaos, that is believed to be much stronger than T chaos.

To this aim, we perform numerical simulations of the SK model at $T = 0.6T_{c}$, both above

and below the AT line, by using a modied version of the Parallel Tem pering algorithm [20,21] in which the system is allowed to move between dierent h values at xed tem perature.

2 M odel and O b servables

The Sherrington {Kirkpatrick spin glass model [22, 23] is described by the Hamiltonian

where $_{i} = 1$ are Ising spins, the sum runs over all pairs of spins and J_{ij} are quenched identically distributed independent random variables with mean value $\overline{J_{ij}} = 0$ and variance 1=N. We take $J_{ij} = N^{1=2}$.

In order to measure the probability distribution of the overlap P (q) one usually considers two independent replicas f $_{i}$ g and f $_{i}$ g evolving contemporaneously and independently (at the same temperature and at the same value of the magnetic eld):

where the therm all average h is correspondent to the average over M onte Carlo time in the simulation whereas $\overline{(}$) stands for the average over the \underline{J} realizations. This is the order parameter in the glassy phase, which in the therm odynamic limit behaves as

where $h_{AT}(T)$ is the critical value of the magnetic eld signaling the AT line, with $h_{AT}(T)$ $(4=3)^{1=2}(T_c T)^{3=2}$ for $T ! T_c (T_c = 1 in this model)$ [19]. In the glassy phase, the stable solution corresponds to a full replica symmetry breaking (FRSB), i.e. to a non-trivial P (q) with a continuous distribution P (q) between two -functions at values q_{LA} and q_n respectively. For $T ! T_c$ one nds that $x_m / q_n / h^{2=3}$, $(q_{LA} q_n) / (x_M x_m) / (h_{AT}(T) h)$. Note that at h = 0 the function P (q) is symmetric, relating the symmetry of the system for f ig ! f ig, and the -function in q disappears.

The interesting quantity to study when looking for chaos is the probability distribution of the overlap between two replicas which evolve at di erent values of the magnetic $eld_{\mu}h_{0}$

and $h_1 = h_0 + h_i$, de nable as

It is expected to become a -function in the therm odynam ic limit, where in presence of chaos states are as di erent as possible and accordingly their mutual overlap approach the minimum possible value, i.e. q_n (h_0) (which is zero for $h_0 = 0$). This happens certainly in the N ! 1 limit as soon as the condition ($h_1 \quad h_0$)²N >> 1 is veried [18].

In nite dimensions, one can de ne the overlap correlation function C_{h_0,h_1} ($\dot{\mathbf{r}}_i \quad \mathbf{r}_j$) = $\overline{\mathbf{h}_i}_j \mathbf{i}_h \mathbf{i}_j \mathbf{i}_h$ which decays exponentially with a correlation length that was evaluated (in d > 8, i.e. above the upper critical dimension of the model) [7] to be $_{h_0=0,h_1} / h_1^{2=3}$ and $_{h_0=0,h_1=h_0+h} / h_0^{1=6}$ (h) ¹⁼² respectively.

A dim ensional ratios of m om enta, such as

have been introduced in order to look for chaos in reference [9], where it was argued that they should scale as f(N $h_1^{8=3}$) for $h_0 = 0$ and approach zero for N ! 1, namely that there is magnetic eld chaos.

The nite size corrections to the asymptotic behavior of $P_{h_0,h_1}(q)$ were computed in [10] by considering two replicas, at di erent values of the magnetic eld, constrained to have a xed overlap q. The constraint causes a free energy excess for $q \in q_n$ given by $f = f(q = q_n + q) = f(q = q_n)$, with

Correspondingly one has $P_{h_0,h_1}(q) / \exp(N f)$, i.e. a Gaussian with variance $hq^2 i_{0,h_1} / (N h_1^{8=3})^{-1}$ for $h_0 = 0$, in agreem ent with the above scaling law.

3 Parallel Tem pering in M agnetic Field

The Parallel Tem pering (PT) or Multiple Markov Chain Method is a widely used numerical algorithm particularly e cient for simulating (some) systems with a corrugated free energy landscape. The basic idea is that the system at equilibrium, instead of being trapped in a single low tem perature valley is allowed to move at higher tem peratures where the landscape is trivial and to return at low T in a di erent valley. This can be achieved by considering n replicas of the system, each one at a di erent tem perature in a given set (of tem peratures), and by allowing exchanges of tem peratures between nearest neighbor replicas with the usual M onte C arb probability.

Here we consider a set of replicas at dierent values of the magnetic eld, both above and below the AT line, allowing exchange of h values between nearest neighbor replicas with the appropriate probability

In principle this h-PT method should be e cient for therm alization like the usual T-PT method, since the landscape is trivial above the AT line. It is moreover a well suited method for the kind of numerical study we are interested in, since one can easily measure P_{h_0,h_1} (q) by considering two or more independent sets of replicas. However, as we are going to discuss in detail, we not that its e ciency rapidly decreases when simulating large system sizes.

We studied the cases N = 64;256 and 1024, taking a set of n = 49 equally spaced magnetic eld values between $h = \frac{1}{2}m_{max}j = 0.6$ at the temperature T = 0.6, where the AT line occurs at the critical value h_{AT} (T = 0.6) ' 0.382 [24].

W e alternate one sweep of each replica with the usual M etropolis algorithm and one sweep with the PT algorithm .




Figure 1: On the left we plot the disorder averaged probability distribution of the m agnetization P (m) at the 21 di erent central h values of the set (i.e. from h = 0.25 to h = 0.25) for the largest considered system sizes N = 1024. On the right we present P_J (m) at h = 0 for a two-peak sample for N = 1024 again. In this last case the errors are roughly evaluated as the di erence between the values m easured in the second quarter and in the second half of the run.

The probability for two replicas to exchange their magnetic elds is related to the overlap between the corresponding histogram s of the magnetization P (m) that we check to be large enough (see Fig. 1]) even for N = 1024. However some single sample P_J (m) display two peaks at $m_0 \notin 0$ when h = 0 (see Fig 1]). As a result, replicas can separate into two distinct subsets, one evolving in the phase space with positive and the other with negative magnetic

eld values (the probability for a replica which arrive at h = 0 with m ' $m_0 < 0$ to m ove at a positive h value is of order exp (m_0 hN), much smaller than the usual exp (\hat{hN})). This happens for some N = 1024 samples. In order to avoid such a problem, we add a new possible globalm ovem ent, allowing a replica at h = 0 to reverse the sign of all its spins with probability 1/2.

Each run is divided into two equal parts and we check them alization by comparing the data obtained in the second part with the ones of the second quarter, looking in particular at the behavior of P_{h_0,h_1} (q). We perform 50.000+ 50.000, 100.000+ 100.000 and 300.000+ 300.000 h-PT steps for N = 64, 256 and 1024 respectively. In the N = 1024 case we also perform ed independent runs with temperature PT for 64 disorder samples at h = 0 and h = 0.3, obtaining indistinguishable results for P (q).

We simulated four sets of replicas evolving contemporaneously and independently (i.e. 49 = 196 replicas). Data are averaged over 256 disorder con gurations for each system size, and statistical errors are evaluated from sample-to-sample uctuations by using the Jack-knife method. The program was multi-spin coded with 64 di erent sites of the system in the same computer word and the whole simulations took about 5500 CPU hours (in the largest part used for N = 1024), i.e. about one week when running over 32 processors on the COM PAQ SC 270 (the program can be easily parallelized by running di erent samples over

di erent processors).

In the N = 64 and 256 cases the algorithm works quite nicely, as can be seen from the number of tunnelings, namely the number of times that each replica moves from one extrem a of the set (of h values) to the other and back, which is about N = 15 20 (in the second half of the run). On the other hand, already for N = 1024, despite the 300.000 PT steps of the second part of the run, this number drops to N = 5 6 and in nearly 1/4 of the sam ples there is at least one replica which is unable to go from h_{max} to h_{min} and back in the whole considered interval (in a few cases most replicas never did it).

In the case of tem perature PT, the corresponding (average) number of tunnelings are 3780, 1590 and 455 respectively (in runs of 400.000 steps starting from equilibrium con gurations, with a set of 38 tem peratures between $T_{m ax} = 1.325$ and $T_{m in} = 0.4$ at h = 0.3 for N = 64;256, and 1024). Clearly the number of tunnelings decreases much faster with system size in the h-PT case. This is presumably linked to the early appearance of magnetic eld chaos. As we will discuss in detail in the next section, P_{h_0,h_1} (q) starts to approach a -function, i.e. its therm odynam ic limit behavior, already for magnetic eld di erences of order 0.15, for N = 1024. This means that the corresponding phase spaces are very di erent and that an algorithm based on global movem ents between di erent values of h can not work well. Similarly the e ciency of tem perature PT should drop down for extrem ely large system s due to tem perature chaos nally coming out.

The bottom line is that N = 1024 is the largest size we are able to e ciently therm alize at T = 0.6 by using the h-PT algorithm, to be compared with the four time larger N = 4096that can be therm alized down to T = 0.4 with the temperature PT algorithm at zero magnetic eld.

4 Results and Discussion

4.1 On the nite size corrections to the P (q).




Figure 2: The probability distribution of the overlap P (q) between two replicas evolving at h = 0.0; 0.1; 0.2 and 0.3 respectively, for the considered system sizes.

The function P (q) is shown in Fig. 2] for h = 0.0; 0:1; 0.2 and 0.3. At h = 0.0 it agrees nicely with the expected behavior, whereas it is strongly a ected by nite size e ects for non-zero magnetic eld. This is in qualitative agreement with the theoretical nding [25] that the nite size corrections of P (q) are an order of magnitude larger in the $q < q_n$ region than in the $q > q_{EA}$ region, namely,

with $m < m \in \mathbb{R}$. The behavior for $q > q_{EA}$ was tested (for h = 0) in [26] and [27].

Here we nd that for the considered sizes P (q) has a visible tail in the q < 0 region for h as large as 0:3. Moreover the peak that should correspond to the therm odynam ic lim it (q q) is not visible and the expected exp ($N_m (q_n q)^3$) behavior is swam ped by the rem iniscence of the q = q_{EA} peak, still clearly visible at h = 0:1. For increasing magnetic elds the weight of the q = q_n peak should increase (and the rem iniscence of the q = q_{EA} peak fade away) but q_n approaches q_{EA} making di cult to distinguish between the two peaks. This kind of strong nite size e ects in magnetic eld were already observed in nite dimensional spin glasses [28, 29]. Larger system sizes and / or lower temperatures would be needed in order to see the correct large volum e behavior.

On the other hand, we note that in our data q_{EA} (de ned as the location of the maximum of P (q)) is practically independent of the eld, as predicted by Parisi theory (in the in nite volume limit). We obtain q_{EA} ' 0:53 for N = 1024, where a recent analytical computation [24] gives the asymptotic value q_{EA} ' 0:505 (independently of h).

4.2 On magnetic eld chaos




Figure 3: The probability distribution of the overlap $P_{h_0,h_1}(q)$ between replicas evolving at di erent magnetic eld values, with $h_0 = 0.0$ and $h_1 = 0.1; 0.15; 0.2$ and 0.3 respectively, for the considered system sizes.

In order to nd evidences for magnetic eld chaos we analyze the behavior of P_{h_0,h_1} (q). We rst consider the case $h_0 = 0.0$ (then P_{0,h_1} (q) is still symmetric for q ! q) and let h_1 take the values 0.1, 0.15, 0.2 and 0.3 (see Fig. 3]). A lready for $h_1 = 0.15$ we nd clear evidences for a chaotic behavior when looking at the N = 1024 data. This is very di erent from the situation one nds when looking for temperature chaos [11] where P_{T_0,T_1} (q 0) does not show a clear peak corresponding to the therm odynam ic lim it (q) for ($T_1 T_0$) as large as 0.2 and sizes as large as N = 4096. It is remarkable that the appearance of magnetic eld chaos with increasing system sizes is a very sudden phenom enon: chaos is elusive for N = 256 and blatant for N = 1024.

On the other hand, to get a nearly G aussian behavior we have to consider at least N = 1024and h_1 values as large as 0.3, but the variance is more than an order of m agnitude larger than the one predicted by (8). Our data suggest that the support of $P_{0,h}$ shrinks to zero as N grows, and the chaotic q 0 peak dom in the more and more the distribution.

M oreover, we nd that A^{2n} (h_0 ; h_1) and B^{2n} (h_0 ; h_1), which decrease for increasing sizes as soon as $h_1 > 0$, are in agreement with the expected scaling law [9], i.e. f ($N h_1^{8=3}$). We consider in particular




Figure 4:0 n top, the behavior of B 2 (h₀;h₁) for h₀ = 0:0 as function of h₁ (left) and as function of the scaling variable 1= (N h₁⁸⁼³) compared with the asymptotic behavior / 1= (N h₁⁸⁼³) for 1= (N h₁⁸⁼³) << 1 (log-log plot on the right). On the bottom, the behavior of P_{h₀,h₁} (0) for h₀ = 0:0 as function of h₁ (left) and as function of N h₁⁸⁼³ compared with the asymptotic behavior / $\frac{1}{N} \frac{1}{h_1^{8=3}}$ for N h₁⁸⁼³ >> 1 (log-log plot on the right).

which is plotted in scaling form in Fig. 4]. In the lim it $1=(N h_1^{8=3}) << 1$ the scaling function is approaching the asymptotic regime f $(N h_1^{8=3}) / 1 = (N h_1^{8=3})$ in qualitative agreement with

the rst-order perturbative result (8). This shows that the asymptotic regime is indeed approached in our data, and that we can safely deduce that $\lim_{N \to 1} B^2(0;h_1 \in 0;T) = 0$.

We conclude the analysis of the $h_0 = 0$ case by looking at $P_{h_0,h_1}(0)$ as a function of h_1 . It increases when considering increasing sizes (apart from the very small h values, where there are clearly strong nite size e ects) and scales roughly as f(N $h_1^{8=3}$) (see [Fig. 4]) with f(N $h_1^{8=3}$) approaching the expected behavior / $N h_1^{8=3}$ for N $h_1^{8=3} >> 1$. We also note that




Figure 5: The probability distribution of the overlap $P_{h_0,h_1}(q)$ between two replicas evolving at di erent magnetic eld values, with $h_0 = 0.1$ and $h_1 = 0.15; 0.2; 0.25$ and 0.3 respectively, for the considered system sizes.




Figure 6: The behavior of B 2 (h_0 ; h_1) for $h_0 = 0$:1 as function of h_1 (left) and as function of 1= (N (h_1 h_0)⁴) compared with the asymptotic behavior / 1= (N (h_1 h_0)⁴) (log-log plot on the right).

though we have plotted data only for $h_1 = 0.4$ these scaling laws appear satis ed also when including data corresponding to h_1 values on the other side of the AT line.

Next we consider $h_0 = 0.1$, $h_1 = 0.15; 0.2; 0.25$ and 0.3 (see [Fig. 5]). The $P_{h_0,h_1}(q)$ is still expected to approach a -function in the therm odynamic limit, now centered in q_1 (q_n (h = 0.1) = 0.21 independent of T from a recent analytical study [24]). However, we have already noted that the peak in q_n is not evident in our data for (the usual) P (q) and correspondingly there is no clear evidence for chaotic behavior in $P_{h_0 \neq 0,h_1}(q)$. Also for the largest size considered, i.e. N = 1024, though a sm all second peak in $q_0.05$ is appearing, the dom inant contribution is still coming from the reminiscence of the peak in q_{EA} , whose mean value and height are slowly decreasing for increasing h_1 . As a matter of fact, when going to the other side of the AT line, i.e. $h_1 = 0.4$, it is this peak that survives, becoming centered on a de nitely lower q value ($hqi_{h_0=0.1;h_1=0.6}$ ' 0.18 for N = 1024, sm aller than q_n).

It is clear that one should look at larger N's to get evidences for the expected G aussian shape / exp($(q q_n)^2=2 \frac{2}{th}$) (with $1=\frac{2}{th}=2N h_0 h_1 h_0$) in the spin glass phase. Therefore, it is not surprising that a quantity such as B² (h₀;h₁) does not scale as a function of N (h₁ h₀). In the case we are considering of h₀ = 0:1 a form B2 f (N (h₁ h₀)) still roughly works, with ' 4. Nevertheless, data presented in [Fig. 6] show that even for N = 1024 and (h₁ h₀)' 0:3 we are very far from an asymptotic regime f (x) / 1=x. When looking at larger h₀, B2 de nitely does not scale, for instance already at h₀ = 0:2 we get B2(N = 1024) > B2(N = 256) in the whole interval 0:2 < h₁ 0:4.

5 Conclusions

We perform ed num erical simulations of the SK model in a magnetic eld at temperature T = 0.6 both in the glassy phase and above the AT line. We used a modiled version of the PT algorithm in which the system is allowed to move between a chosen set of magnetic eld values, an algorithm well suited for our purpose. We found that N = 1024 is the largest size one is able to eld ciently therm alize with this method and we argue that this is related to the appearance of magnetic eld chaos at this scale.

The function P (q) shows strong nite size corrections for h > 0, with a long tail in the q < 0 region that slow ly disappears for increasing sizes, whereas the peak corresponding to the therm odynamic limit (q q) is not yet visible.

O urm ain result is on the behavior of $P_{h_0,h_1}(q)$, which in the case of $h_0 = 0.0$ show sevidence for chaos already at $h_1 = 0.15$ when considering the still relatively sm all size N = 1024. This is at variance with the situation one nds when looking for temperature chaos [11], in agreement with the very recent analytical nding [17] that temperature chaos is a much weaker elect. The appearance of the third peak in q = 0 is accompanied by a shrinking of the support of the distribution.

The expected scaling law [9] is well satis ed and for large N $h_1^{8=3} P_{h_0=0;h_1}$ (q) approaches a G aussian with variance / 1= (N $h_1^{8=3}$), in qualitative agreem ent with the result of a rst order perturbative computation [10].

On the other hand, when looking at the chaotic behavior for $h_0 \notin 0$ we found ourselves to be still very far from the expected asymptotic regime. This is to be related to the presence of strong nite size e ects observable also on P (q) itself.
