Pressure induced R am an and uorescence singularities in L iY F $_4$

A bstract

The pressure e ect on the uoride scheelite laser host L iY F_4 is studied at room tem perature up to 26 G P a by R am an scattering and up to 40 GPa by P³⁺ uorescence of doped sample. The Ram an spectra exhibit three singularities at the vicinity of 6 GPa, 10-12 GPa and 16-17 GPa. The sam ples pressurized to 21 GPa or higher do not recover the original phase after being released, giving m ore R am an lines than original sam ples. The lum inescence spectra of P³⁺ are collected in the energy range corresponding to following transitions ${}^{3}P_{0,1}$ ³H_{4:5:6}, ¹D₂ ³H 4 and ${}^{3}P_{0}$ ${}^{3}F_{2}$. Singularities are observed in the vicinity of 6 GPa, 10 GPa, 16 GPa, 23 GPa in agreem ent with the Ram an study. M oreover, an irreversible transition occurs at 23 GPa. The samples pressurized to above 26 GPa become am orphous when released and all the sharp lines disappear. Above 31 GPa, the spectra at high pressures show only som e broad bands corresponding to transitions between two multiplets of the ${}^{4}F_{2}$ conguration of P r $^{3+}$. These singularities suggest possible phase transform ations leading to low ering of the lattice symmetry.

1 Introduction

LiY F_4 doped with rare earth ions such as N d³⁺ and P r³⁺ is a well known laser material with the tetragonal scheelite structure (Figure 1 and 2) which is known to be one of the rare crystal families undergoing ferroelastic phase transition with temperature and pressure [1, 2, 3, 4, 5, 6]. At am bient condition, this crystal has C $_{4n}^6$ space group. Recently, the lattice dynamics of LiY F₄ has been well studied theoretically and experimentally with IR absorption, Ram an and neutron scattering [7, 8, 9, 10]. The crystal structure of LiY F₄ is relatively stable in temperature, no transition being observed from 10 K to 1000 K [7, 11]. But phase transform ations under high pressures have been shown to be possible by Ram an and lum inescence studies [11, 12]. These works, especially those under high pressures, are very helpful for understanding the dynam ics of this lattice and for the veri cation of the validity of the rigid ion m odels employed in the dynam ical calculations.

In a R am an study under pressure up to 20 G Pa[11], a sudden change in the R am an frequency slope $\frac{@1}{@P}$ was observed around 7 G Pa and attributed to the sti ening of L iF₄ tetrahedra. N o anom aly was noted above this pressure. D ue to the am biguty of m ode assignment for high pressure R am an frequencies, the result of this work is not unquestionable.

LiY F_4 doped with rare earth ions gives often very intense emission [14]. Each rare earth ion is coordinated to eight F-ligand ions, getting the site sym m etry D_{2d} or S₄ (gure 1). It is expected that the lum inescence spectra of rare earth ions are very sensible to the behavior (rotation or deform ation) of LiF₄ tetrahedra under pressure. A work on E u³⁺ : LiY F₄ has been carried out up to 15 GPa and led to the conclusion that a phase transition was possible at 10 GPa due to the splitting of some Stake levels meaning lowering of site sym m etry of E u³⁺.

In this paper, we present the results of the study of Pr^{3+} : LiY F₄ with both R am an and Lum inescence. Pr^{3+} in LiY F₄ gives very sharp lum inescence lines in the visible spectral region with clear line assignments[13, 14, 15, 16, 17]. It was expected that the study can be carried out at much higher pressures than in previous works and gives us more information about the lattice behavior under pressure. Our pressure has reached 40 G Pa. Several singularities in R am an and lum inescence spectra have been observed. It is concluded that phase transitions induced by pressure are indeed possible.

2 Raman study

2.1 Experiment and result

The samples are small single crystals of $LiYF_4$ of about 100 m width and 50 m thick. The pressure was generated with a gasketed diam ond anvil cell

D iacellM K 3 with a pair of anvils of type IIb/a diam ond (0.16 carat) m ounted upon tungsten carbide support plates. The anvil ats are 550 m in diam eter. The gasket in Inconel was indented before drilling a hole (pressure chamber) in the centre of the indentation. The cylindrical pressure chamber is 100 m in diameter and less than 100 m high. A chip of the sample is put into the pressure chamber together with a sm all ruby (for pressure measurement) and the pressure medium consisting of a 4:1 mixture of methanolethanol. P ressure calibration is carried out by the shift of the R lines of ruby with the non-linear pressure scale[18]. The Raman spectra are excited by the 514.5 nm line of an argon ion laser with 130 mW total power measured just before the rst anvil and collected through the type IIb anvil with a D ibr-Z24 triplem onochrom ator single channel R am an spectrom eter. The spectra are recorded under microscope with di erent orientations of the sample in the pressure chamber in order to obtain as many Raman lines as possible with di erent polarisations (since polarization analysis is di cult in the pressure cell). A bove 21 GPa, the Ram an signals of the sam ples submitted to monotonic pressure increase become so weak that they could not be observed even with a very long photon counting time (20 scans of 2 seconds). However, it was found that better signals were obtained if we used again the sam ples released from high pressure lightly above 10 GPa. Under this condition, Ram an signals were observed up to 26 GPa.

High pressure Ram an spectra are shown in Figure 3. We have observed more lines at low frequency than the previous work [11]. The 13 expected lines at ambient pressure give rise to 9 bands as expected due to frequency overlaps [7, 8, 9, 10]. Frequency splitting occurs under sm all pressure increase so that 12 lines can be clearly identi ed (the missing line overlaps the low frequency of E_g line and does not give signi cant signal. Their frequencies are reported in Table 1. The signi cant variation in the intensity of som e lines in the range of 10–14 G Pa m ainly results from the orientation change of the sam ples in the pressure chamber during the experiments. The pressure dependence of the Ram an frequencies is plotted in Figure 4. The frequencies of all modes but one increase with increasing pressure with singularities at roughly 6 G Pa, 10 G Pa and 17 G Pa.

2.2 Discussion of R am an results

2.2.1 Prelim inary remarks

Before analyzing the singularities in details, it is useful to give some inform ation about the structure and its characteristic parameters. The pressure e ect m ainly results in a contraction of the crystal, proportional to the elastic constants S_{11} and S_{33} . A coording to reference [19] these constants are 12.8 GP a ¹ and 7.96 GP a ¹, respectively, which means that the crystal will undergo greater contraction along the a parameter than along the c parameter. From the microscopic point of view, the LiF and Y-F distance are 1.902 A and 2.286 A, respectively, while the shortest sum s of the ionic radii are respectively 1.88 A and 2.30 A [20]. Sim ilarly the shortest F-F distances in LiF₄ and Y F₈ polyhedra are respectively 2.984 A and 2.815 A, while the sum of the ionic radii is 2.57 A. This suggests that the contraction of the crystal lattice will result mainly in the reduction or deform ation of LiF₄ polyhedra. Finally, it appears from gure 2 that an increase of the angle of the rotation of the LiF distance. So it is expected that increasing pressure would preferably result in a decrease of a, a decrease of the LiF bond lengths and an increase of the rotation angle of LiF₄ tetrahedra around the tetrahedra around the caxis.

2.2.2 Singularities at 6 G P a

A sobserved in the previous work [11], the rst singularity around 6 G P a mainly consist in the splitting of the Bg/Eg lines in the vicinity of 350 cm $^{-1}$ and 400 cm 1 (the splitting becomes 65 cm 1 for the former and 17 cm 1 for the latter at 17 GPa) and a sudden change in the pressure dependence of the modes at about 350 cm 1 and 460 cm 1 ; the latter corresponds to the stretching of LiF_4 tetrahedron [8]. We think that a simple stiening (without otherm odi cations) of LiF4 tetrahedra due to pressure would not be su cient to account for the abrupt slope change which suggests som e m odi cations in the structural characteristics (with or without symmetry change). A plausible hypothesis is a sudden rotation of LiF_4 tetrahedra towards the lim it value = 45° due to the contraction of the lattice along a (cf. Figure 2). Note that the decrease of the rotation angle from = 29° to = 0° . (leading to zircon structure) would require the increase of parameter a and so cannot be considered. In this case of unchanged symmetry, the line splitting is simply the separation of the overlapped Eq and Bq modes at ambient pressure, as is observed in the work of the reference [9] for the series LiX F_4 (X = Y, Ho, Er, Tm, Yb). Another possible interpretation is that it is associated with a symmetry change so the observed line splitting would rather be a splitting of the Eq modes. This idea is supported by the fact that a splitting of the lum inescence lines of P r^{3+} in L iY F₄ is also observed in this pressure range (see following section).

2.2.3 Singularities at 10 G P a

A second singularity is observed in the vicinity of 10 GPa. There is discontinuity in the pressure shift of the frequency of the lines located at about 180 cm⁻¹, 300 cm⁻¹ and 350 cm⁻¹ (see Figure 4). We should emphasize here that a splitting of the lum inescence lines of Pr_{3+} in LiYF₄ is also observed in the

vicinity of this pressure. In addition, we have recorded at am bient pressure the Ram an spectra of the samples released from pressure of about 11 GPa. The spectrum measured immediately after the releasing (spectrum c in Figure 5) is very dimension from the original one (spectrum a in gure 5). Two strong additional lines are observed at 123 cm⁻¹ and 580 cm⁻¹. All the lines are very broad, which suggests a partially am orphous state. This spectrum disappears after roughly 15 m inutes for a crystal of about 10 m thick and 50 m width which recovers the original Ram an lines (spectrum b in Figure 5). Since the structure above 6 GPa is not known, no mechanism can be proposed for this structure transform ation. As a matter of fact, any of the mechanism sproposed to explain the singularities at 6 GPa is possible in the structural change at 10 GPa.

2.2.4 Singularities at 17 GPa

A third singularity appears at about 17 GPa. It is mainly characterized by the vanishing of some lines between 400 cm⁻¹ and 450 cm⁻¹, the emergence of a new line at 435 cm⁻¹, a change of the pressure dependence of the frequency of the Ag mode at about 315 cm⁻¹, and the existence of a minimum of the low frequency Eg mode (at 154 cm⁻¹). At higher pressure, the energy of this mode increases again with a larger shift rate than below 17 GPa and reaches 156 cm⁻¹ at 26 GPa. The most striking fact is that the Ram an spectra (spectrum d in gure 5) recorded at ambient pressure of the sam ples released from 21 GPa remain de nitely di erent from those of the sam ple never pressurized. This means that an irreversible transform ation has occurred. Note that the frequencies of the new spectrum (d in gure 5) are close to those of the sam ples released from 11 GPa (c of gure 5).

The irreversibility and the signi cant change of the high pressure R am an spectra suggest that this very high pressure phase transform ation would be reconstructive. However, as previously pointed out, it seems to be associated with a softening of the low frequency Eg mode, as would occur for a second order (reversible) phase transition. This can be seen in gure 6 where the square of the frequency is plotted against pressure, giving follow ing relationship :

for P < 17 GPa, where A = 300 cm 2 GPa 1 and p_{0} = 80 GPa; and :

for higher pressure with $A^0 = 794$ cm 2GPa 1 and $p_0^0 = 7$ GPa.

In this fram ework, this phase transition would be a proper ferroelastic one since the soft mode, observed below and above the transition, has the same sym m etry as a strain tensor[1]. It is worth noticing that, due to its degeneracy,

it would be associated with the existence of a soft acoustic plane [21], a kind of transition expected but never experimentally observed to our know ledge. We recall that the scheelite B iV O₄ undergoes also a proper ferroelastic phase transition in which the softening of an acoustic branch was observed. But the soft mode has a one dimensional Bg symmetry. The values of A and A' for LiY F₄ are about three times smaller than those for B iV O₄, but (A^{0} -A) = 2.61 0.5 for LiY F₄ is very close to (A^{0} -A) = 2.67 0.2 observed for B iV O₄ [4]. What is really questionable is the fact that such a transition, clearly associated to a soft mode, is irreversible. A ctually a similar phenomenon has already been observed in the layered tetra uoroalum inate K A F₄ in which an irreversible martensitic phase transition appears after the softening of a at Brillouin zone boundary phonon branch [22]. So, the softening of the low frequency Eg mode may be associated with a similar mechanism.

3 Lum inescence study

3.1 Experimental results

The technical details of the pressure experiment are described in the above section. The sample is LiY F_4 single crystal doped with approximately 1 m ol P r³⁺. The uorescence spectra are excited at 457.9 nm with an argon ion laser. The pressure goes up to 40 GPa and the emission spectra are recorded in the range 15000 cm⁻¹ {21500 cm⁻¹ corresponding to the transitions from ${}^{3}P_{0}$, ${}^{3}P_{1}$ and ${}^{1}D_{2}$ initial states to ${}^{3}H_4$, ${}^{3}H_5$, ${}^{3}H_6$ and ${}^{3}F_2$ nal states.

The observed lines at am bient pressure are summarized in Table 2. The assignments of the transitions are given for S_4 site symmetry of the P r³⁺ ion [13, 15]. Twenty four emission lines (L_1 to L_{24}) are assigned to the transitions between ve initial states and fourteen nalones. The ³H₅ level at 2673 cm ¹ was not observed before and is determined in this work by two sharp lines at 18197 cm ¹ (from ³P₀) and 18752 cm ¹ (from ³P₁). It is assigned to $_{3;4}$ symmetry according to the calculated result of reference [15].

The pressure e ect on the observed uorescence spectra is shown in gure 7. In gure 8 is plotted the pressure shift of the observed em ission lines. It can be seen that, in spite of som e vanishing lines, the num ber of the em ission lines increases constantly up to 31 GPa at which all the lines abruptly vanish. The rem aining spectra contain only som e broad em ission bands show ing a weak pressure shift up to 40 GPa. Brie y, singularities are observed at 6 GPa (26 lines), 10 GPa (32 lines), 16 GPa (34 lines), 23 GPa (37 lines) and 31 GPa (vanishing of all the lines). They will be discussed below in detail.

3.2 Discussion of uorescence results

3.2.1 Singularity at 6 G Pa

The rst singularity occurs at 6 G Pa as in R am an spectra. Two strong lines (L₇ and L₈) from the transitions ${}^{3}P_{1}(_{3;4})-{}^{3}H_{5}(_{2})$ and ${}^{3}P_{1}(_{3;4})-{}^{3}H_{5}(_{3;4})$ vanish (gure 8b) and two additional lines at 18590 cm 1 (L_{n1}) and 15530 cm 1 (L_{n2}) are observed. L_{n1} cannot be interpreted by the splitting of the 18592 cm 1 line (L₉) from the transition ${}^{3}P_{0}(_{1})-{}^{3}H_{5}(_{2})$ between two singlets. It could be attributed to the transitions ${}^{3}P_{0}(_{1})-{}^{3}H_{5}(_{3;4})$, situated at 8 cm 1 above L₉ and observed at low temperature [9,10]. That means that the appearance of L_{n1} is only a pressure induced separation between two lines close to each other.

 L_{n2} in gure 8d seems to be the result of a splitting of the line L_{21} from the transition ${}^{3}P_{0}(_{1}){}^{-3}F_{2}(_{3;4})$ which is broadened before splitting, as shown in gure 7b. However it is di cult to conclude that this comes from the lifting of the degeneracy of the ${}^{3}F_{2}(_{3;4})$ level in a lower site symmetry, since no splitting of other levels of $_{3;4}$ symmetry was observed at this pressure. As a matter of fact, L_{n2} could be related to one of the transitions ${}^{3}P_{0}(_{1}){}^{-3}F_{2}(_{3;4})$ and ${}^{3}P_{0}(_{1}){}^{-3}F_{2}(_{2})$ with the latter situated at 20 cm 1 above the former and much less intense than the former at ambient pressure[9]. In this case, the observed splitting of L_{21} could be only the elect of dimensions dependence of two lines that fortuitously overlap at ambient pressure.

A coording to the above discussion, it is not sure that the singularity observed at 6 G P a are induced by a phase transition.

3.2.2 Singularity at 10 G Pa

The singularity in the Ram an spectra observed at this pressure is only a weak variation in the shift rate of the Ram an mode as a function of pressure. In uorescence, as shown in gure 8c, following additional lines are observed : L_{n3} (19140 cm⁻¹), L_{n4} (19020 cm⁻¹), L_{n5} (17100 cm⁻¹), L_{n6} (16400 cm⁻¹) and L_{n7} (16300 cm⁻¹). A line (L_{19}) vanishes. The slope of L_5 , L_{12} , L_{13} , L_{14} , L_{21} and L_{23} abruptly changes.

 L_{n4} emerges in the neighborhood of a strong line L_5 from the transition ${}^{3}P_{1}(_{3;4}) - {}^{3}H_{5}(_{2})$. This looks like the splitting of the ${}^{3}P_{1}(_{3;4})$ level. But as seen in gure 8a, the lines L_1 and L_2 of the transitions ${}^{3}P_{1}(_{3;4}) - {}^{3}H_{4}(_{2})$ and ${}^{3}P_{1}(_{3;4}) - {}^{3}H_{4}(_{3;4})$ respectively do not split. So L_{n3} and L_{n4} are probably due to the transitions from ${}^{3}P_{1}(_{3;4})$ to two of the levels close to ${}^{3}H_{5}(_{2})$ at 2280 cm 1 , i.e. the levels at 2253 cm ${}^{1}(_{1})$, 2272 cm ${}^{1}(_{3;4})$ and 2297 cm ${}^{1}(_{1})$ (values at am bient pressure), which were not observed at am bient pressure [9].

 L_{n6} and L_{n7} are close to L_{18} from the transition ${}^{3}P_{0}(_{1}){}^{-3}H_{6}(_{3;4})$, but none of them seems to be the result of the splitting of the ${}^{3}H_{6}(_{3;4})$ nal state. In addition, another ${}^{3}P_{0}(_{1}){}^{-3}H_{6}(_{3;4})$ transition (L_{17}) remains unchanged. So more probably L_{n6} and L_{n7} result from the transitions from ${}^{3}P_{0}(_{1})$ to ${}^{3}H_{6}(_{1})$ (4430 cm 1) and ${}^{3}H_{6}(_{1})$ (4486 cm 1) in the neighborhood of ${}^{3}H_{6}(_{3;4})$ at 4456

cm¹ at ambient pressure[9]. It should be noted that the transitions from ${}^{3}P_{0}(_{1})$ to ${}^{3}H_{6}(_{1})$ and ${}^{3}H_{6}(_{1})$ are forbidden by the electric-dipole selection rules in S₄ site symmetry [9,10].

A nother singularity at this pressure is related to a sharp line at 19260 cm $^{-1}$ (see gure 8b). It cannot be attributed to any transition between the electronic or vibronic states[9–12]. It becomes very weak at about 10 GPa and rapidly disappears in the broad band of the ${}^{3}P_{1}(_{3,4})^{-3}H_{5}(_{2})$ em ission, as shown in gure 7a.

To conclude, a structure transform ation must be invoked to explain the changes in the em ission spectra, a structuralm odi cation leading to the change of transition probability and selection rules in the S_4 site. This supports the suggestion of the previous work [12] and our R am an result that the am bient pressure spectrum of the samples released from 11 G Pa was di erent from that of the scheelite structure L iY F_4 .

3.2.3 Singularity at 16 G Pa

We recall that a minimum of a pressure induced soft Raman E mode has been observed around this pressure. In ucrescence, three additional lines L_{n8} (18560 cm⁻¹), L_{n9} (18470 cm⁻¹) and L_{n10} (15470 cm⁻¹) appear and two lines L_{20} and L_{23} vanish.

 L_{n8} and L_{n9} appear between L_9 and L_{n1} , and become two sharp lines up to 30 GPa (gure 7a). Their pressure shift being almost parallel to those of the neighbouring lines (gure 8b), they could be integrated into the ${}^{3}P_{0}{}^{-3}H_{5}$ line group and attributed to the transitions from ${}^{3}P_{0}$ to two of the three states ${}^{3}H_{5}({}_{1})$, ${}^{3}H_{5}({}_{3,4})$ and ${}^{3}H_{5}({}_{1})$, situated at ambient pressure at 2253 cm 1 , 2272 cm 1 and 2297 cm 1 respectively [9]. It should be noticed that, together with L_{n8} and L_{n9} , there are now seven observed lines in the ${}^{3}P_{0}{}^{-3}H_{5}$ group, which exceeds the number (ve) of the transitions allowed by the electric-dipole selection rules in S_4 site symmetry [9,10].

 $\rm L_{n10}$ is in the $^3P_0-^3F_2$ line group (gure 8d) and could only be considered as a transition from $^3P_0(_1)$ to one of the 3F_2 levels resulting from the splitting of the $^3F_2(_{3;4})$ level, or to the fourth Stark level of 3F_2 multiplet situated at 5159 cm 1 ($_1$) to which the transition from $^3P_0(_1)$ is forbidden in $\rm S_4$ symmetry at ambient pressure. In any case, the appearance of $\rm L_{n10}$ suggests a change in the site symmetry of P r^3+ . A coording to R am an spectra, this transition would be a second order one.

3.2.4 Singularity at 23 GPa

At 23 GPa, nine additional lines em erge. They are L_{n11} (20709 cm⁻¹), L_{n12} (20609 cm⁻¹), L_{n13} (20489 cm⁻¹), L_{n14} (18995 cm⁻¹), L_{n15} (18596 cm⁻¹), L_{n16} (16580 cm⁻¹), L_{n17} (16460 cm⁻¹), L_{n18} (16425 cm⁻¹), L_{n19} (16275 cm⁻¹) and

 L_{n20} (15510 cm⁻¹). On the other hand, L_6 , L_{13} , L_{18} , L_{24} , L_{n5} and L_{n10} vanish (gure 8).

 L_{n11} , L_{n12} and L_{n13} are in the ${}^{3}P_{0}{}^{-3}H_{4}$ group and can only be attributed to the transitions from ${}^{3}P_{0}$ to three ${}^{3}H_{4}$ levels in the energy range 0-300 cm 1 (see gure 8a) just above the ${}^{3}H_{4}({}_{2})$ ground state. This, together with L_{3} and L_{4} , gives rise to ve energy levels in this region where only four levels should be observed in the S_{4} site symmetry, namely ${}^{3}H_{4}({}_{2})$, ${}^{3}H_{4}({}_{3;4})$ and two ${}^{3}H_{4}({}_{1})$ [9]. So it is reasonable to suppose that the degenerate ${}^{3}H_{4}({}_{3;4})$ level splits into two levels giving rise to L_{n11} and the remaining L_{4} . This splitting should exist also in the ${}^{3}P_{1}{}^{-3}H_{4}$ group (L_{1} and L_{2}) but unfortunately it is not possible to be observed due to the extrem e signal weakness at high pressure.

Above 23 GPa, together with L_{n15} , there are eight observed lines in the ${}^{3}P_{0}-{}^{3}H_{5}$ (gure 8b) group and nine in the ${}^{3}P_{0}-{}^{3}H_{6}$ group (gure 8c) while only seven lines are allowed for the latter in S_{4} symmetry [9,10].

Finally, in the ${}^{3}P_{0}-{}^{3}F_{2}$ group (gure 8d), together with L_{n17} , ve lines are observed, exactly the number of states in this multiplet. This means that all the energy levels are singlet at this pressure.

A nother signi cant phenom enon is that, as in our R am an study, the lum in nescence of the samples released from this pressure are dierent from that of the samples never pressurized (Figure 9).

3.2.5 Singularity at 31 G Pa

In the pressure range above 23 GPa, the sharp lines still exist up to 31 GPa, a pressure at which all the lines suddenly disappear (gure 7 and 8). Each of the broad bands corresponds to a transition from ${}^{3}P_{0}$ or ${}^{3}P_{1}$ to one of the multiplets ${}^{3}H_{4}$ and ${}^{3}F_{2}$ a. The spectra remain the same up to 40 GPa with only a small pressure red shift of the broad bands (see gure 7 and 8). This means that the lattice of LiY F₄ becomes am orphous above 31 GPa.

Similarly to the samples pressurized to above 23 GPa, the samples released from pressures higher than 31 GPa remain de nitely amorphous at normal pressure, giving only broad lum inescence bands as shown in Figure 7.

4 Final com m ent

In sum m ary, we have presented in this paper the experim ental results of pressure studies of LiY F_4 structure by both R am an scattering and P r³⁺ lum inescence. The pressure runs up to 40 GPa. This work gives us m ore inform ation about the behaviors of the lattice structure of LiY F_4 than the previous ones[11, 12]. The R am an and uorescence results are in agreem ent concerning the pressure e ect on the structure of LiY F_4 . Singularities are observed in the vicinity of 6 GPa, 10 GPa, 16 GPa, 23 GPa and 31 GPa. M ost of these singularities suggest that a simple stiening of the lattice or the tetrahedra is not su cient to account for the pressure evolution of the spectra and that the scheelite type structure m ay undergo a series of transform ations or distorsions responsable for the lowering of the site symmetry and the singularities at 10 GPa, 16 GPa, 23 GPa and 31 GPa. The transform ations at 23 GPa and 31 GPa are irreversible, leading to am orphous structures. O fcourse, further work such as high pressure X-ray di raction is necessary to clarify the situation.

W ith regard to the mechanism of the possible structure transform ations of L iY F_4 under high pressure, no precision can be given for the time being. But any of the mechanism s including the rotation and displacement of the L iF₄ tetrahedra could be invoked. It is worth noticing that the internal binding of the L iF₄ tetrahedra is not entirely di erent in comparison with the external binding [12,13], i.e. the ionic L iF and F f forces in the tetrahedra are of similar magnitude to the ionic Y f and F f forces outside the tetrahedra. So when there is a lattice distortion, we should not exclude the possibility of the distortion of the tetrahedra and of the emergence of new kinds of polyhedra under very high pressure.




Figure 1, Scheelite structure of LiYF₄ with space group C_{4h}^6 . The Y³⁺ ion has eight F⁻ ligand ions at the corners of the tetrahedra LiF₄ around it.
