Second-quantized Landau-Zener theory for dynam ical instabilities

State engineering in nonlinear quantum dynam ics som etim es may dem and driving the system through a sequence of dynam ically unstable interm ediate states. This very general scenario is especially relevant to dilute Bose-E instein condensates, for which am bitious control schem es have been based on the powerful G ross-P itaevskiim ean eld theory. Since this theory breaks down on logarithm ically short time scales in the presence of dynam ical instabilities, an interval of instabilities introduces quantum corrections, which may possibly derail a control schem e. To provide a widely applicable theory for such quantum corrections, this paper solves a general problem of time-dependent quantum mechanical dynam ical instability, by modelling it as a second-quantized analogue of a Landau-Zener avoided crossing: a 'twisted crossing'.




FIG.1: Grayscale plot of sum of absolute values of im aginary parts of Bogoliubov excitation frequencies for a quasione-dimensional condensate owing with winding number 10 around a toroidal trap with modulated potential. Axes are control parameters: mean condensate density increases from bottom to top, severity of density modulation increases from left to right. Compare to gures in Refs. [1, 2].

Q uantum dynam ical instabilities (com plex excitation frequencies) have been associated with form ation of solitons and vortices in driven Bose-E instein condensates. For exam ple, in Refs. [1] and [2], the Bogoliubov spectra are exam ined for two-param eter families of mean eld states. A lthough the physics involved is signi cantly different (one-dimensional modulated current versus rotating harm onic trap), gures in both these works show dynam ical instabilities in narrow, nger-like regions of param eter space (see Figure 1). W e will show below that this is generic for dynam ically unstable quasiparticle excitations in weakly interacting many-body system s.

Such systems, especially condensates, may be su ciently weakly dam ped that state engineering under energetic instability becom es feasible. Interesting structures such as solitons and sonic event horizons will require this capability. But to access the entire volum e of energetically unstable control space, it will also be a common task to drive systems brie y through narrow regions of dynam ical instability. M ean eld theory and adiabatic approxim ations, which are in portant tools of state engineering, will break down during these episodes [3]. This paper therefore exploits an analogy between dynamical instability in second quantization, and avoided crossing in two-state quantum mechanics [4], to determine the quantum e ects of driving a system through dynamical instability. An alm ost identical calculation has recently been presented [5] to dealw ith the speci c dynam ical instability involved in dissociation of a molecular condensate [6]; the present paper provides an explicit derivation of the result in a general context.

Q uantum dynamical instability is not always recognized as a possibility, because with a H erm itian H am iltonian, the eigenfrequencies of Schrodinger evolution m ust all be real. But the eigenfrequencies of H eisenberg evolution m ay be com plex. It is easy to see this for the m anifestly H erm itian H am iltonian

where all co-e cients are real, and \hat{a} and \hat{a}^y are ordinary annihilation and creation operators (i.e. $[\hat{a}_j; \hat{a}_k^y] = _{jk}$ is the only non-vanishing commutator). The eigen-operators of H eigenberg evolution satisfy

where we assume 0 (without loss of generality, since we can always rede ne \hat{a}_{+} ! \hat{a}_{+}). These operators always obey \hat{b}_{+} ; \hat{b}_{-}] = 0. As long as < j j are both real, and we also have

And we can write

for E₀ = !. This means that as long as < j j one of the \hat{b} is really a creation operator which would have a ^y in m ore conventional notation; but apart from this trivial issue of labelling, we have diagonalized to noninteracting quasiparticles of the standard (bosonic) kind.

If > j j however, are complex, and neither \hat{b} nor \hat{b}^{y} are standard annihilation operators. They obey

so that we must say that the canonical conjugate of \hat{b} is \hat{b}^y , and no longer coincides with the H erm itian conjugate. In this case we have

instead of (6). One can also show that if > j jthen the eigenvalues of \hat{H} no longer involve integer multiples of

: they remain real, but are continuous. Hence in this case there is no way to interpret the energy eigenstates as having de nite numbers of any kind of quasiparticle.

If > j i then \hat{H} is unbounded below as well as above; this can also occur even for < j j if j! j> 2 2. In these cases, (1) can be physical only as the linearization of a nonlinear Ham iltonian about an excited state. And in all cases, since the anom alous coupling' term proportional to in (1) does not conserve the num bers of particles created and annihilated by $\boldsymbol{\hat{a}}^{\boldsymbol{Y}}$ and $\boldsymbol{\hat{a}}$, these must be some kind of quasiparticle, or else there must be a source of atoms (such as a molecular condensate treated as a c-number eld [5]). But there are many realistic situations in which unboundedness of the linearized Ham iltonian, and non-conservation of (quasi-)particles, are perfectly correct. For these (1) is universal, in the sense that for all eigenfrequencies, whether real or com plex, pairs of modes may be expressed in this form by using (3) to de ne \hat{a} .




FIG. 2: At left, an ordinary avoided crossing; at right, a twisted crossing' with complex interm ediate eigenfrequencies.

Two-body interactions among particles lead to quasiparticle H am iltoniansw ith anom alous couplings as in (1). is thus constrained to be small if interactions Since are weak, dynam ical instabilities tend to arise in weakly interacting systems not through becoming large, but through becoming even smaller. A dynamical instability is thus a kind of second-quantized analogue to an avoided crossing [7]. See Figure 2. If the many-body Ham iltonian depends on som e num ber D of control param eters, then any two modes will have frequencies exactly opposite on a (D 1)-dim ensional param eter subspace, and so there will be a dynam ical instability within a thin shell around that (hyper) surface. Of course, dynam ical instabilities can only arise if there is energetic

instability, so that som e negative frequency modes exist. But if the system is energetically unstable, then ngerlike (or in higher dimensioned control spaces, hypershelllike) regions of dynam ical instability are generic.

Since much state engineering can be accomplished by means of time-dependent control parameters in the Ham iltonian, we need to assess the e ects of a time dependence that brings a system through an interm ediate interval in which one dynam ical instability exists. Focusing our attention on the pair of modes involved in the instability, we can always cast them in the form of (1), with time-dependent !;; : . As long as j j we can apply standard m ethods, but a connection form ula is required to give the quantum evolution over the interm ediate interval. W ithin this interval, we assume the widely applicable case that ! and are essentially constant, and changes linearly with time. Since $(\hat{a}_{+}^{y} \hat{a}_{+})$ åâ) $\operatorname{com} m$ utes with \widehat{H} , we can elim in ate ! in an interaction picture by taking a ! e ^{i!t}a, giving us the problem

for a constant rate .

By examining the Heisenberg equations of motion with this time-dependent Hamiltonian we can straightforwardly obtain

and $\hat{a}_{\text{IN},0UT}$ are time-independent annihilation operators, whose relationship to each other unfortunately depends on the intervening evolution at nite times. (The factor multiplying t in the argument of the logarithm in (12) is not actually xed by the equation of motion, but is chosen for our notational convenience below.) O f course the point of the limitst! 1 is not literally to consider in nite times, but only to give the asymptotic behaviour

which can be smoothly matched to adiabatic approximations valid for 2 jj . Hence in the H eisenberg picture no further de nition of â $_{\rm IN}$ is required: it will be given in term s of initial time operators by solving the evolution problem for t 2 . So the problem is to determ ine the $_{\rm O \ U \ T}$ operators in term s of the $_{\rm IN}$ operators.

This problem is directly analogous to the Landau-Zener problem for amplitudes in a two-state system being driven through an avoided crossing, except that the amplitudes are replaced by operators, and the secondquantized problem allow s the 'anom alous' coupling which would be non-Herm itian in the two-state system. Because our problem is also linear, we can solve it in a very sim ilar way. Iterating the Heisenberg equations to obtain a second order equation for \hat{a}_{+} with \hat{a}^{Y} elim inated,

then Fourier transform ing from t to frequency , we nd an easily-solved rst order di erential equation in :

Inverse Fourier transform ing back to t then gives




FIG. 3: Contours used in the text, for ^{2}t (solid) and ^{2}t (dashed), plotted in the complex plane of =(^{2}tj). Saddlepoints are marked with crosses on the real axis at 2 sgn(t). At left, contour C₁ traverses from low er-left to upper-right in nity; at right, contour C₂ runs from 0 to upper-right in nity.

There are two independent solutions $A_{1;2}(t)$, with independent operator-valued co-e cients $^{1}_{1;2}$, since the integralm ay be evaluated along inequivalent contours $C_{1;2}$ in the complex -plane. Since the integrand vanishes at the branch point = 0, and at in nity between angles $(0; \frac{3}{2})$ and $(; \frac{3}{2})$, integration contours can only term inate at these points (because term inating anywhere else amounts to replacing the integrand with something that does vanish elsewhere). The simplest distinct contours are C_1 running from lower-left in nity to upper-right, and C_2 nunning from zero to upper-right in nity. Since the integrand is analytic except at upper-left and lower-right in nity, and on the branch cut (which we take to run along the negative imaginary axis), we are free to choose contours that make the evaluation easier; see Fig. 3.

A given choice of contour yields a single solution valid for allt, but for j: 1 the integral m ay be evaluated using com binations of the m ethod of steepest descents and integral representations of the G am m a function. (There is a second saddlepoint near the origin, but as j: 1 it

is too close to the branch point for the m ethod of steepest descents to work, and so contour C₂ m ust run along the in aginary axis until it reaches a contour of steepest descent through the other saddlepoint.) The asymptotic behaviours of the full solutions A_j(t) can thus be obtained explicitly, allowing us to determ ine the late time behaviour of the solutions whose early time behaviour m atches (10).

The contributions to the contour integrals for $A_j(t)$ from the diagonal portions are dom inated by the saddlepoints $t = 2^{2}t + 0(\frac{2}{2t})$, since for $t = 2^{2}t + e^{i} = 4$ s,

So if the contour passes through the saddlepoint we get a contribution to A $_{\rm j}$ (t)

If a diagonal segment shown in Fig. 3 does not cross a saddlepoint, then this segment yields only an utterly negligible contribution $e^{2^{-2}t^{2}}$.

For the vertical segments along the imaginary axis in C_2 , we let = i =t+ 0 and integrate

where in the second line we extend the integration lim it to in nity by ignoring terms of order e $2(t)^2$, and drop the exp $\frac{1}{4}\frac{2}{2t^2}$ from the integrand because it yields corrections of order (t) 2. This yields the contribution

From the two segments att > 0 where C_1 hugs the branch cut, we gain a contribution $(1 e^{\frac{2}{2}})A_{TM}$.

C om bining these contributions and recalling our definition of (t) in (12), we obtain, up to corrections of order (t) 2 ,

where the suppressed O (t) 1 term s can easily be com – puted from (19), but will not be needed.

Comparing (20) with (10) and (15), we can read o

Then comparing these last results with (11), and noting that the equations for \hat{a} and \hat{a}^{y}_{+} are exactly similar to those we have examined, we nally conclude

Equation (25) is our main result. It is indeed very similar to the Landau-Zener form ula, except for the vital di erence that the exponents are all positive rather than negative. Consequently, in the state which is annihilated by a $_{\rm IN}$, the expected numbers of quasiparticles after passing through the instability will be

D riving through a dynam ical instability in less than the characteristic time scale of the instability produces only m ild excitation, but exceeding this time generates quasiparticles explosively. And the crossover between these regimes is rather abrupt. This may set im portant practical limits to the precision of state engineering, because controlling faster than may mean not being slow enough to be adiabatic for other, dynam ically stablem odes of the total nonlinear system.

Note that changing 2 ! 2 in (9), so that the system is stable at early times rather than late, produces only e^i ! e^i in (25). And while we have analyzed the most general type of dynamical instability, with com – plex frequency and two degrees of freedom involved, the simpler case with purely in aginary frequency, which was treated in [5], can be obtained by setting ! ! 0, and a ! a = 2 in (1). Everywhere else, one must use sim – ply a ! a instead; there are also trivial changes to (6) and (8). We have therefore obtained a quite general result that will be useful for state engineering through dynamical instabilities.
