A simple model for drag reduction

D irect Num erical Simulations established that the FENE-P m odel of viscoelastic ows exhibits the phenom enon of turbulent drag reduction which is caused in experiments by dilute polymeric additives. To gain analytic understanding of the phenom enon we introduce in this Letter a simple 1-dimensionalm odel of the FENE-P equations. We demonstrate drag reduction in the simplem odel, and explain analytically the main observations which include (i) reduction of velocity gradients for xed throughput and (ii) increase of throughput for xed dissipation.

The addition of few tens of parts per million (by weight) of long-chain polymers to turbulent uids can bring about a reduction of the friction drag by up to 80% [1]. This \drag reduction" phenom enon has im portant practical in plications besides being interesting from the fundam ental point of view, integrating turbulence research with polymer physics. In spite of intense interest for an extended period of time [2, 3, 4], Sreenivasan and W hite [1] recently concluded that \it is fair to say that the extensive - and continuing - activity has not produced a m grasp of the mechanism s of drag reduction". Recently however it was shown that drag reduction is observed in D irect N um erical S in u lation of m odel viscoelastic hydrodynam ic equations [5, 6, 7]. From the theoretical view point these observations are crucial, indicating that the phenom enon is included in the solutions of the model equations. Understanding drag reduction then becomes a usual challenge of theoretical physics. In this Letter we present a further simpli cation of the m odel equations and gain analytic insights into the phenomenon. The FENE-P equation for the uid velocity u (r;t) contains an additional stress tensor related to the polym er:

where $_{\rm s}$ is the viscosity of the neat uid, F is the forcing and the stress tensor T is determined by the polymer conformation tensor R according to

here $_{\rm p}$ is a viscosity parameter, $_{\rm p}$ is a relaxation time for the polymer conformation tensor, $_0$ is the rm sextension of the polymers in equilibrium, and f (r;t) is a function that limits the growth of the trace of R . The model is closed by the equation of motion for the conformation tensor which reads




FIG.1: The mean ow velocity as a function of the distance from the wall for the FENE P (dashed line) vs. the New tonian ow (continuous line). The pro les hardly change near the wall, but the amplitude is larger for the FENE P solution.




FIG. 2: Upper panel: the dependence of the rm s velocity uctuations as a function of the distance from the wall. We are interested in $U_{\rm rm~s}$ for comparison with our model. Lower panel: the trace of the conformation tensor R as a function of the distance from the wall. We stress the qualitative similarity to the dependence of $U_{\rm rm~s}$ in the upper panel.

These equations were simulated on the computer in a channel or pipe geom etry. The main observations on the e ect of the polymer on the turbulent ow that we need to focus on are the following: (i) For a xed pressure gradient at the wall the uid throughput is increased (see Fig. 1). (ii) For a xed throughput the gradient at the wall decreases (i.e. the dissipation decreases). (iii) The trace of the conform ation tensor R follows qualitatively the rms stream wise velocity (see Fig. 2). We are particularly interested in point (iii) since in our opinion the space dependence of the amount of stretching (and with it of the e ective viscosity) is crucial, and com pare [8, 9] for a discussion of this point in the context of the instability of lam inar ows. Obviously, Eqs. (1)-(3) as they stand are not am enable to analytic investigation in the turbulent regime. To gain insight we therefore attempt to simplify them as much as possible without losing the main phenomena (i)-(iii). Consider therefore a model for the stream wise velocity which is the Burger's equation

(u in the stream wise directions with gradients in the y (wall-norm al) direction), to which the e ect of a scalar R is added:

where a subscript y stands for a partial derivative with respect to y. In the following we shall denote Eqs. (4)-(5) with the acronimous uR model. The parameters is related to the polymer concentration, and is the relaxation time of R. We will consider the model in the domain L y L, with boundary conditions chosen later. We will denote spatial averages by pointed brackets, hAi $_{\rm L}$ A (y)dy. The simplicity of the uR model allows us to state the energy budget in simple terms. Multiplying (4) by u and taking the spatial average of (4) and (5) we obtain:




FIG. 3: C om parison of the solution of the uR m odel (connected circles) to the solution of Burger's equation (continuous line). The dashed line corresponds to the function R. The parameters are $= 10^4$, $u_0 = 1:17$, s = 0.25 and $R_0 = 2.5$.

The term huR_y im easures the \energy" given by the velocity eld u to the polymer eld R. Multiplying (7) by s=2 and summing (7) with (6) we obtain:

In the steady state the overall power hF ui is balanced by the overall energy dissipation per unit time D, D = $u_y^2 + \frac{s}{2}$ hR i. The term $\frac{1}{2}$ $u^2 + \frac{s}{2}$ hR i represents the sum of the kinetic energy of the ow plus the potential energy of the stretched polymers. We remark that already from these elementary consideration it becomes clear that for a xed power input the existence of the term $\frac{s}{2}$ hR i necessarily reduces the gradients of u in agreement with point (ii) above. To address points (ii) and (iii) further we consider next the solution of the model with F = 0

and with a xed velocity u and stretching R at L and L. In other words, we take as boundary conditions

In Fig. 3 we compare the solution of the uR model to that of the pure Burger's equation (i.e. Eq. (4) with R = F = 0.) To focus our thinking we would like the reader to consider the solution in the left half space as a model of the stream wise velocity component in the lower half channel, with the solution in the right half space being simply an anti-symmetric copy. The position of the lateral \wall" is modeled by the point where u = 0. Thinking this way points (ii) and (iii) are clearly dem onstrated. We proceed now analytically to demonstrate drag reduction (point (iii)) and to understand the prole of R (point (iii)). First we consider the stationary solution of the pure Burger's equation. Integrate equation (4) in y to nd

where the constant of integration was xed by noticing that for L su ciently large u_y is expected to vanish at the boundaries. Multiplying (10) by u_y , and integrating between L and L using the boundary conditions, we

nd the viscous dissipation

Next we consider the solution of the uR model for the same boundary conditions (9) and R 0. In the stationary state $R_t = 0$, and by dividing Eq. (5) by Ru we can integrate it form ally in y and obtain:

where a is a constant of integration. This equation is the explanation of point (iii). It says that for small velocity u = 0, i.e. for y = 0, R necessarily goes to 0. In particular, approximating u = m y near the point y = 0, we obtain R jub where b = 1 + 1 = (m). Thus we should expect that at positions with small u where the gradient of u is large the generic behavior of R is a cusp with R = 0 for m = 1. To compute the dissipation analytically we consider the limit ! = 1, i.e. we look for a solution at the zero order of the perturbation series in 1 = . In this limit:

Returning to Eq. (4) we integrate it in y to obtain

We can now substitute Eq. (13) in the domain L y 0 where $j_{1j} = u$, and integrate between L and 0. Multiplying the result by a factor of 2 we nd the viscous dissipation R

This result is an analytic demonstration of point (ii). We note that our analysis has been performed in the limit

! 1. For large but nite values of the qualitative picture we have drawn is unchanged. Needless to say, the above discussion can be reform ulated by keeping constant the energy dissipation while increasing the value of u at the boundary, to dem onstrate point (i). We choose how ever to dem onstrate point (i) next, using a forced solution. Point (i) is most clearly dem onstrated in the uR m odel using periodic boundary conditions and constant forcing. We consider 0 y 2 and choose the external forcing F to be:




FIG. 4: The solution of the uR model with constant forcing and periodic boundary conditions (connected circles). Continuous line: the Burger equation without the polymer.




FIG. 5: The solution of the uR model with constant forcing and periodic boundary conditions. D ashed line: R (y). Connected circles: $20u^2$ of the solution of uR. Solid line: $20u^2$ of the solution of Burger's equation.

W e exam ined the solutions of the uR m odel for the set of parameters $f_0 = 0:1, f_1 = 0:05, = 0:01, s = 0:01$ and initial conditions $R(y) = 2\sin(y)$. The remaining param eter is the relaxation time . It turns out that for very small values of , no e ect of the polymer eld is observed. (W e remark that for periodic boundary conditions the limit ! 0 corresponds to the case of no polymer.) For ! 1 no stationary solutions can be obtained. For smaller than some critical value $_{\rm c}$, the solution of the uR model shows stable stationary solutions with drag reduction. The typical situation is presented in Fig. 4, showing the num erical solutions for = (0:15)¹ c, compared against the solution of Burger's equation. The uR model shows a larger am plitude near the strongest shock due to forcing at x = 3 = 4. It is worth noting that the gradient is maintained extrem ely close to the one obtained by the Burger equation, dem onstrating nicely point (i). Point (iii) is nicely dem onstrated in Fig. 5 which presents the solution for R together with u^2 for both the uR m odel and the Burger equation. As one can clearly see, the behavior of R is sim ilar to what observed in Fig. 1, namely there is a qualitative similarity between the space dependence of R and u², here with sharp cusp in R near the point of maximum gradient of u. On the other hand, the smallest shock present in the solution of Burger's equation has been completely sm oothed out by the uR m odel. This is an indication that when R is not su ciently suppressed where the gradient of u is signi cant, there can be drag enhancement. This important point will be addressed again in the concluding remarks. Again, the sim plicity of the model a ords an analytic explanation of why the solution near the biggest shock shows a larger velocity am plitude compared to the Burger equation. Let y_0 be the position of the maxim alvelocity near the shock. The position y_0 is unchanged in the two models. We can expand u, F and R as power series near y_0 . Let be

de ned as $= y_s y_0$, where $y_s = 3 = 4$ is where the velocity vanishes (the \wall" position in our model). We have:

$$u(y) = u_0$$
 u_2y^2 ; F (y) = F_0 + F_1y; R (y) = R_0 + R_1y

where F_0 f₀ and F_1 f₀ because of Eq. (16). Inserting (17) into the uR model, we obtain:

$$u_0 = \frac{f_0 + sR_0^{-1}}{f_0} = u_b (1 + P); \quad P = \frac{sR_0}{f_0} \quad (18)$$

where $u_b = =$ is the solution obtained without polymer, (P = 0). The increment of the velocity, which is responsible for the drag reduction, is proportional to sR₀.

In summary, we have introduced a simple model of the e ect of polymeric additives to Newtonian uids, with the aim of understanding in simple mathematical term s som e of the prom inent features associated with the phenom enon of drag reduction. Needless to say, the model cannot be taken as quantitative; we were concerned with the qualitative features sum marized above for convenience as point (i)-(iii). We dem onstrated that ourm odel reproduces these qualitative features, and provided straightforward analytic explanation to all those features. It appears that we can draw from the results of this model a few important conclusions: (i) Arguments concerning the turbulent cascade process do not appear essential. These argum ents are the hallm ark of the theory presented in [4] which proposed that the main e ect of the polymer is to introduce a dissipative cuto at scales larger than the Kolm ogorov scale, due to the polymer relaxation time m atching there the hydrodynam ic time scale. Looking at Eq. (5) one could think that the largest velocity gradients could be estimated as hjuy ji 1= . But since R can go to zero where the gradient is largest,

such estimates cannot be made. Moreover, just an increase in the dissipative scale cannot account for drag reduction; a hom ogeneous increase in the e ective viscosity should lead by itself to drag enhancem ent rather than reduction. (ii) D rag reduction is a phenomenon that appears on the scales of the system size, involving energy containing modes rather than dissipative, small scale modes [10]. (iii) The main point appears to be the space dependence of the stretching of the polymer, here modeled by the value of R(y). It is crucial that R is sm all where the velocity gradients are large. It is the space dependence of the e ective viscosity which should be looked at as the source of drag reduction. A similar conclusion was arrived to in the context of the study of the stability of lam inar ows in a channel geom etry [8,9] accept that there the space dependence of the e ective viscosity had been introduced by hand. In the FENE-P context as well as in our model (and presum ably in actual experim ents) the space dependence appears self consistently. It remains to understand this self consistent build up of di erentiale ective viscosity in the context of the much more elaborate FENE-P model. In light of the present results this appears an extrem ely worthwhile endeavor that will shed in portant light on the phenom enon of drag reduction.
