Identi cation oftopologically di erent valence bond states in spin ladders

A bstract

We discuss relation between three dierent methods to identify topologically distinct short-range valence-bond ground states in $\operatorname{spin} \frac{1}{2}$ two-leg ladders: the string order parameters, the level-crossing method, and the ground-state expectation value of the twist operator. For this purpose we reexam in a phase transition in the frustrated spin ladder. We propose a proper bosonization of the string order parameters. Then, these three methods are shown to be equivalent rejecting the Z_2 symmetry breaking of the order and the disorder elds of the two-dimensional Ising model.

K ey words: spin ladder; valence bond; string order param eter; level-crossing m ethod; tw ist operator

Since the experimental discoveries of several spin ladder compounds, there has been considerable interest in properties of various two-leg spin ladders. The ground states of these ladders are well described by short-range valence bond (dimer) states with an energy gap in spin excitations. In ladder systems, a variety of topological congurations of the dimers are possible, so that we expect phase transitions between topologically dierent valence bond ground states.

As a typical model which exhibits the topological transition, we consider the antiferrom agnetic two-leg spin $S=\frac{1}{2}$ ladder with frustration described by

where $S_{n,j}$ denotes an $S=\frac{1}{2}$ operator at site j of the n-th chain. It has been pointed out that there appears competition between two phases [2,3]: For J_2 J, the ground state is similar to that of the S=1 Haldane-gap state described by the A eck-Kennedy-Lieb-Tasaki (AKLT) model, while for J J_2 , the

system has the same property of the conventional spin ladder, and the resonating valence bond (RVB) phase including the rung dim er state is stabilized.

First, we analyze the phase transition by using the string order parameter (SOP) which is known to detect the hidden antiferrom agnetic order in the Haldane gap phase of the S=1 Heisenberg chain. In ladder systems, the AKLT and the RVB phases are identied by the following two SOPs β],

where h im eans the ground-state expectation value, and = x;y;z. The composite spin operators for p = odd, even are dened by

Then the A K LT and the RVB phases are characterized by O $_{\rm odd}$ \in 0, O $_{\rm even}$ = 0, and by O $_{\rm odd}$ = 0, O $_{\rm even}$ \in 0, respectively.

The SOPs can be bosonized by using the relation of the S = 1=2 operator exp (i $S_{n\,j\,j}^z$) = $2iS_{n\,j\,j}^z$. In the con-

tinuum lim it, however, 0^z_{odd} and 0^z_{gven} have the same bosonized form [3]: $\lim_{j_x = y, j! = 1} he^{\int_{0}^{z} \frac{y}{2} + (x)} e^{-\int_{0}^{z} \frac{y}{2} + (y)} i$ where is the sym metric/antisym metric boson eld. In order to distinguish two SOPs, we consider the boson representations of the composite spin operators,

Here $S^z_{\text{odd};j}$ and $S^z_{\text{even};j}$ are related by the shift of the phase elds,

This relation indicates that two SOPs are identied as

Note that Eq. (6) reverses the sign of the nonlinear term of the sym metric mode of the sine-Gordon model. Thus it turns out that $O_{\rm odd}^z = O_{\rm even}^z$ gives the critical point. Besides, since the phase eld is related to the order ($_{\rm i}$) and disorder ($_{\rm i}$) parameter of the two dimensional noncritical Ising models as exp ($_{\rm i}$ $_{\rm i}$ $_{\rm i}$)

 $_1$ $_2$ + i $_1$ $_2$ [9], two SOPs are identi ed as ${\rm O_{odd}^2}$ h $_1{\rm i}^2$ h $_2{\rm i}^2$, O $_{\rm even}^z$ h $_1{\rm i}^2$ h $_2{\rm i}^2$. Thus Eq. (6) for $_+$ eld corresponds to the K ram ers-W annier duality transform ation $_i$ \$ $_i$ for two Ising copies, and O $_{\rm odd}$ 6 0 (O $_{\rm even}$ 6 0) m eans the breakdown of the Z $_2$ Z $_2$ sym m etry in the order (disorder) elds.

On the other hand, it has been pointed out that a critical point between two non-degenerate ground states such as the AKLT and the RVB phases can be identified by the level-crossing of excitation spectra with different parities under antiperiodic boundary conditions [8]. A coording to the conformal finctions O $_j$ are related to the excitation spectra E_j through the scaling dimensions x_j :

where v is the spin wave velocity. The operators $\sin{(2 +)}, \cos{(2 +)}$ appearing in Eqs. (7) and (8) are nothing but those corresponding to the energy spectra that give the level-crossing point.

Finally, we discuss another order parameter. Recently, the authorw ith Todo proposed the ground-state expectation value of the twist operator as an order parameter to characterize valence bond solid states in quantum spin chains[5],

The asymptotic form of z_L is given by $z_L = (1)^n [1 \ 0 \ (1=L)]$, where n is the number of valence bonds at boundary. A similar relation was also found in two-dimensional dimer system s[6]. Therefore, we obtain $z_L > 0 \ (z_L < 0)$ for the RVB (AKLT) state. It has been proposed that z_L dened by Eq. (10) is identified by the ground-state expectation value of the nonlinear term of the sine-G ordon model[4,5],

Thus it turns out that z_L has inform ation of two SOPs, characterizing the Z_2 Z_2 sym m etry breaking in the order (disorder) elds by alternating its sign. In case that $S_{\text{odd};j}^z$ in z_L is replaced by $S_{\text{even};j}^z$, the sign of z_L is reversed [7] due to the relation of Eq. (6).

From the above argum ent, three dierentm ethods to identify the topologically distinct valence bond ground states have been shown to be equivalent. We have also perform ed num erical analysis for Eq. (2) using the exact diagonalization, and observed that phase transition point determ ined by these three methods show reasonable agreement. These three dierentm ethods are also applied to the analysis of phase transitions in the S = 1 spin ladder with bond alternation [10,11].
