# Statistics of low est droplets in two-dim ensional G aussian Ising spin glasses

A new approach to determ ine the value of the zero-tem perature therm al exponent in spin glasses is presented. It consists in describing the energy level spectrum in spin glasses only in term s of the properties of the low est energy droplets and the low est droplet exponents (LD E s)  $_{1;1}$ that describe the statistics of their sizes and gaps. We show how these LDEs yield the standard therm all exponent of droplet theory through the relation,  $= 1 + d_1$ . The present approach provides a new way to measure the therm al exponent without any assumption about the correct procedure to generate typical low-lying excitations as is commonly done in many perturbation m ethods including dom ain wall calculations. To illustrate the usefulness of the m ethod we present a detailed investigation of the properties of the lowest energy droplets in two-dimensional Gaussian Ising spin glasses. By independent measurements of both LDEs and an aspect-ratio analysis, we nd (2d)' 0:46(1) <  $_{DW}$  (2d)' 0:287 where  $_{DW}$  is the therm alexponent obtained in dom ain-wall theory. We also discuss the origin of nite-volume corrections in the behavior of the LDE 1 and relate them to the nite-volum e corrections in the statistics of extrem e values. Finally, we analyze som e geom etrical properties of the lowest energy droplets nding results in agreem ent with those recently reported by K awashim a and A oki<sup>20</sup>. A llin all, we show that typical large-scale droplets are not probed by most of the present perturbation methods as they probably do not have a compact structure as has been recently suggested. We speculate that a multi-fractal scenario could be at the roots of the reported discrepancies on the value of the therm al exponent in the two-dimensional Gaussian Ising spin glass.

### I. IN TRODUCTION .

D espite three decades of work in the eld of spin glasses m a prissues related to their low-tem perature behavior still rem ain unresolved<sup>1</sup>. A lthough in portant achievem ents have been obtained in the understanding of mean-eld theory<sup>2</sup> the appropriate treatment beyond mean-eld to include short-range interactions is yet to be found. The absence of a successful analytical approach to deal with this problem corroborates the present state of our know ledge, offen m isguided by a non-accurate, if not confusing, interpretation of the num erical data. This situation has generated a hot debate about the correct physical interpretation of the available num erical data. Leaving aside the long-standing controversy whether replica symmetry breaking is or not a good description of the spin-glass phase<sup>3</sup>, there are still unresolved issues which are not as striking but evidence our ignorance about som e fundam ental questions.

O ne am ong these problem s is the correct value of the therm al exponent in two-dimensional (2d) G aussian Ising spin glasses (G ISG). This question has received attention from time to time during the last two decades but not enough to settle it de nitively and explain the origin of some of the reported discrepancies. The study of the low-T properties of the 2d G ISG starts with the work by M cM illan who proposed<sup>4</sup> that therm alproperties in spin glasses are determined by the scaling behavior of the typical largest excitations (commonly referred as droplets) present in the system. This idea has been further elaborated and extended to deal with equilibrium and dynam ical properties of spin glasses in a scenario now adays referred to as droplet m odel<sup>6</sup>. The low-T behavior in spin glasses is determined by a spectrum of large scale gapless droplets with typical length L and energy cost E L, being the therm al exponent. As these droplets correspond to ipping some domains of spins (assumed to be compact clusters), the energy cost of these excitations arises from the set of unsatis ed bonds on their surface. The striking low-T behavior in spin glasses are been as the result of a competition between energy and entropy e ects: as the droplet become esprogressively larger there are m ore available conformations for the surface to m inim ize the energy cost of the unsatis ed bonds. In the absence of cancellations one would expect = (d 1)=2. How ever, as these cancellations are very important, the inequality

< (d 1)=2 holds and is by far less than the maximum value (d 1)=2. The value of the thermal exponent characterizes the low -T critical behavior as it is related to the correlation length exponent where T by the identity = 1= . M cM illan also used dom ain-wall renorm alization group ideas to introduce a practical way to determ ine the leading energy cost of these low -lying large-scale excitations<sup>5</sup>. The method consists in measuring the energy defect of a dom ain-wall spanning the whole system obtained by computing the change of the ground state energy when switching from periodic to antiperiodic boundary conditions in one direction. Several works have

used M cM illan's method to determ ine the value of in two and three dimensions<sup>7;8</sup>. Hereafter, in order to keep the discussion as clear as possible, we will denote by  $_{DW}$  the estimate of the exponent obtained by domain-wall calculations. The initial value for  $_{DW}$  reported by M cM illan is  $_{DW} = 0.281(5)$  for pretty m odest lattice sizes 8. Recent num erical results with much more powerful algorithms have reached sizes L ' 500 and con rm ed L = 3the initial result with much larger accuracy<sup>22;24;27</sup>  $_{DW} = 0.287$  (4). These studies would de nitively close the problem if it were not by the existence of other alternative estimates of the exponent , largely consistent among them, which yield a quite di erent value ' 0:47(2). We will denote this estimate by  $T_{\rm F}$  as several of these m ethods use transfer m atrix<sup>18</sup>. However, a word of caution is necessary here as the M onte C arlo m ethod and other approaches that are not based on transferm atrix m ethods report values com patible with that estim ate. For instance, K awashim a and A oki used another m ethod to estim ate the sti ness exponent<sup>20</sup>. The idea is to generate a droplet inside a box of size L L that includes a xed central spin, with the following procedure. First, the ground state is found with a standard algorithm s (we will denote it by the reference con guration). A flerwards, the spins at the boundaries of the box are xed and the central spin is forced to ip respect to the reference con guration. The droplet of minimum energy that includes the central reversed spin and does not touch the boundaries is computed. The spanning length of the droplets generated in this way allows to de ne the fractal dimension of both the surface (or perimeter for the two dimensional case) and the volume. It is found that these minimum energy droplets have a fractal volume dimension smaller than 2 and the therm alexponent is = 0.42 (5) in agreement with results obtained from MC methods<sup>26</sup> and heuristic optimization algorithms<sup>19</sup>. A similar study of minimum energy clusters in the three-dimensionalEdwards-Anderson model also reports evidence that DW is an upper bound to the actual value of the therm alexponent<sup>21</sup>.

The accuracy of previous estimates is poorer than the values obtained through the domain-wallmethod as they deal, in one way or another, with all possible excitations and not only with the calculation of ground state energies. More recently, another method has been used to estimate the value of . It consists in perturbing the original H am iltonian  $H_0$  with a term P, where P stands for the perturbation and for its intensity. For example, P can be the overlap between the actual con guration and the ground state of the original H am iltonian  $H_0$ . As varies the new ground state of the total H am iltonian  $H = H_0 + P$  remains unchanged until a certain value = c is reached where a excited energy level of  $H_0$  becomes the new ground state of H. The overlap between the old and the new ground states as well as the value of the shifting energy provoked by the perturbation links its energy cost E with its size providing another way to estimate . We will denote by  $_P$  the estimate obtained in this way. This method has been recently used in the 2d G ISG by Hartmann and Young<sup>23</sup> reporting the following value  $_P$  0:31. A lthough slightly more negative than  $_{DW}$ , both  $_{DW}$ ;  $_P$  appear to be statistically compatible. Yet more accurate estimates are needed to con m whether  $_P = _{DW}$ .

This last method and the domain-wall method have in common the same feature, i.e. they perturb the original H am iltonian in one way or another to probe the characteristic energy of excitations that are supposed to be the typical ones that determ ine the low-T therm odynam ic properties. In fact, the estimate  $_{DW}$  can be considered as a particular example of  $_{P}$ , where the perturbation consists in reversing all the bonds in one of the surfaces of the box. This raises the important question whether the di erent estimates of  $_{P}$ , obtained by considering di erent class of perturbations, are di erent. The question is rather subtle as there are numerical indications that indeed this could be the case. For instance<sup>8</sup>, measurements of  $_{P}$  where the perturbation is a uniform magnetic eld yield a value  $_{P} = -0.48$  (1) compatible with the other competing set of values  $_{TF}$ .

How is that the value of the exponent p could depend on the type of perturbation? This is a very dicult question to answer as our present know ledge is inadequate. We can o er only speculative answers. Strong discrepancies am ong di erent types of perturbations could arise if a multi-fractal scenario governs the statistics of excitations in spin glasses. By de nition, in all perturbation methods the probed large scale droplets are those which minimize the energy cost but constrained to maxim ize the value of the perturbation for the selected droplets. Therefore, among all possible large-scale low -lying droplets the perturbation m ethod selectively probes those that m axim ally overlap with the perturbation. A dependence of the value p on a given class of perturbations could arise if the perturbation selectively probes one or another topological property of the droplet. This rather aw kward multi-fractal scenario is not new in the eld of disordered systems. Multificatality is known to be present in the localization problem in the strongly disordered regime. A multi-fractal scenario would imply the existence of di erent critical exponents at T = 0 depending on the type of perturbation applied. On the other hand, the fact that the value estimated for P when the perturbation is a uniform magnetic eld appears to be consistent with the value TF, suggests that maybe som e types of perturbation can probe the relevant excitations while others m ay not. These good observables, which probe the typical excitations, could be called neutral observables in the sam e spirit as this term has been coined to describe observable dependences of the uctuation-dissipation ratio (i.e. the e ective tem perature) in glassy system s. Concom itant, this \perturbation class dependence" issue is presently also debated in the di erent (but related to a certain degree) eld of glassy dynam ics.

If the hypothetical multi-fractal scenario holds, then we must face the question about what is the correct procedure

to determ ine the therm alexponent . As determ ines the free energy cost of droplets, the natural answer is that is given by the lowest value among all possible estimates,

W ith the present available data this relation suggests that the estimate  $_{TF}$  is the correct value of the thermal exponent and that  $_{DW}$  as well as many other estimates  $_{P}$  are only upper bounds to the true value.

The question we want to address in this paper is the following. Is it possible to devise a method that is alternative to current perturbation methods, in which excitations are not selectively probed by the perturbation, but selected only according to the correct balance between energy and entropy? The main purpose of this paper is to show that the analysis of the statistics of the inst or lowest excitations gives a positive answer to this question. As we will see, the method we propose in this paper yields a consistent estimate of instance between the supports the result that  $_{\rm DW}$  and many other  $_{\rm P}$  are only upper bounds to the actual value of . A preliminary account of these results has already appeared in<sup>9</sup>.

The paper is divided as follows. Sec. II describes the basis of the lowest droplet approach and introduces the lowest droplet exponents. Sec. III shows the results obtained in the 2d G ISG. Sec. IV analyzes a method to extract the value of the them al exponent . Sec. V presents a more powerful method to extract the value of the lowest droplet exponents based on an aspect-ratio analysis. Sec. V I discusses the origin of the nite-volum e corrections to the value of the lowest droplet exponent  $_1$  as a problem of corrections in the statistics of extrem e values. Sec. V II analyzes some topological properties of the lowest droplets. Finally Sec. V III presents the conclusions. There are also two technical appendixes: Appendix A presents the heuristic argument that  $_1 = -d$  for G aussian spin glasses, and Appendix B explains the transferm atrix method we used to obtain the lowest droplets.

# II. BASIS OF THE LOW EST DROPLET APPROACH .

The purpose of this work is to show an alternative approach to determ ine the low-T behavior of spin glasses by studying the size and energy spectrum of the lowest excitations by introducing two exponents ( $_1$  and  $_1$ ) needed to fully characterize the zero-tem perature xed point. All along the paper we will denote this exponents as lowest energy droplet exponents, or lowest droplet exponents in short, and that we will abbreviate as LDEs. The exponent  $_1$  is the most important one and describes the probability to nd a large-scale lowest excitation spanning the whole system, while the exponent  $_1$  describes the system -size dependence of the average energy cost of these lowest excitations.

The underlying theoretical background of the approach is the follow ing. To investigate the leading low-tem perature behavior in spin glasses let us consider expectation values for moments of the order parameter by keeping only the ground state and the rst or lowest excitation. This approach was introduced in<sup>11</sup> and can be shown to capture the low-tem perature behavior at the leading order. The method that investigates the low-T properties based on a restricted analysis of the spectrum to the absolute lowest excitations has been also used for the study of the localized phase in the disordered Anderson model<sup>12</sup>. The present paper can be seen as the applicability of these ideas to the spin-glass case. At the end of the paper (see Sec. V III) we will give reasons supporting the validity of our approach.

To generate the spectrum of lowest excitations we consider the following procedure. Let us consider a set of N<sub>s</sub> samples and for each of them we determ ine both the congurations of the ground state and the lowest excitation. For a spin model the lowest excitation has v spins overturned with respect to the ground state (so the overlap between the ground and that excited state is q = 1 2v=V, V being the volume of the system) and with energy cost or gap E. It can be easily proved that the lowest excitation must be a connected cluster which we will generically call the lowest droplet. If v<sub>s</sub> and E (s) denote the volume e and excitation energy of the lowest droplet for samples, in the limit where N<sub>s</sub> is sent to in nity, we can de ne the following joint probability distribution

U sing the Bayes theorem, this joint probability distribution can be written as P (v; E) =  $g_v \hat{P_v}$  (E) where

 $g_v$  is the probability to nd a sample such that its low est droplet has volum e v and  $\hat{P_v}$  (E) is the conditioned probability for that droplet to have a gap equal to E. In what follows, we separately discuss the scaling behavior of both distributions  $g_v$ ;  $\hat{P_v}$  (E).

Before continuing, and for sake of clarity, let us make an important digression about nom enclature. There are two volumes involved in the problem : the volume v of the lowest excitation and the volume V of the lattice. If not stated otherwise we will refer to the volume v as the size of the excitation while volume w will generally refer to the lattice volume V. Thus, when we speak about nite-size excitations we usually refer to the corrections with v nite, and nite-volume corrections (which we will sometimes abbreviate as FVC) will refer to the corrections a ecting the distribution (2) due to the nite volume V of the lattice.

### A. The lowest droplet exponent 1.

The simplest scenario for the size distribution of the lowest droplets is that all sizes occur with uniform probability. The normalization condition (3) imposes  $g_v = 1=V$ . This situation is encountered in the 1d G ISG<sup>6;11</sup> with both free and periodic boundary conditions. However, in the most general situation, this does not hold and low energy droplets are found with a probability that depends on their size v. The simplest and most general way to incorporate such a dependence is to assume an ansatz solution for  $g_v$  that factorizes into a power law  $A=V^{-1+1}$  with  $_1 > 0$  and a coe cient A G(q) which depends only on the overlap q between the ground state and the lowest droplet,

The behavior of G (q) can be guessed in both  $\lim its q! 1$  (the case q! 1 is equivalent in m odels with tim e-reversal symmetry which are those we are considering here) and q! 0,

The rst relation describes the scaling behavior for the number of droplets whose size scales with the total volume of the system. As these can only depend on the volume V, G (0) must converge to a constant. The second relation is consequence of the fact that the number of droplets with nite size v cannot depend on V in the large V limit as these are not a ected by the boundaries. On the other hand, the distribution of nite size droplets  $g_v$  is self-similar as can be seen by inserting (6) in (4) and using the relation q = 1 2v=V. This yields  $g_v$   $1=v^{1+1}$ , the same relation as for the large scale limit (5) where  $g_v$   $1=V^{1+1}$ . A simple expression that interpolates both limits is given by,

Note how ever that, despite its simplicity, expression (7) is only an interpolation and the most we can say about G (q) concerns its asymptotic behaviors (5-6).

The ansatz (4), applied only to large-scale excitations, was proposed in<sup>11</sup>. Note that although  $g_v$  is dened for discrete volumes, in the limit V 1, the values of q for consecutive droplet sizes v ! v + 1 become equally spaced by q = 2=V. Therefore, in the limit, V 1, the function  $g(q) = \frac{V}{2}g_v$  becomes a continuous function if expressed in terms of the variable q instead of the integer variable v,

A word of caution is in order. A lthough (4) diverges for q = 1, leading apparently to a violation of the norm alization condition (3) for  $g_v$ , it must be emphasized that no excitation has q = 1 so there is a maximum cuto value q = 1 2=V corresponding to one-spin excitations. For instance, if we insert (8) into the norm alization condition for g(q) we get in the large V limit,

implying 1 0 as expected since otherwise the normalization would not be possible in the large-V limit. The divergent term (q! 1) in (8) shows that for  $_1 > 0$  one-spin excitations are the most large in number among the whole spectrum of sizes. In fact, from (4), g(1) ' 0 (1) g(V=2) ' 1=V <sup>+1</sup>, so the majority of excitations have a nite size. However the average excitation size

diverges in the V ! 1 lim it and di ers from the typical excitation volum e  $v_{typ}$  O (1). Relation (10) provides a way to measure the exponent 1 alternative to the use of the scaling behavior (4).

# B. The lowest droplet exponent $_1$

The analysis of the gap distribution  $\hat{P_v}(E)$  goes along the same lines as we did for the distribution  $g_v$ , but with one in portant di erence. As the gap E describes the lowest among all possible excitation energies, it has to scale in the same way for all droplet sizes independently on their size (and, in particular, whether these are nite-size or large scale droplets). This statement refers to a scenario which hereafter we will call the random energy-size droplet scenario" (RESD scenario) to speci cally indicate that the distribution of the lowest energies of droplets is independent of their size. M athem atically it can be expressed as,

In addition, we follow the standard droplet m odel and assume that the spectrum is gapless and dened by an exponent \_1 which describes the characteristic energy of the lowest droplets whatever their size or overlap q with the ground state. If the scaling function  $\hat{P_v}$  (E) is independent of v it follows im mediately that the non-conditioned or size-averaged gap probability distribution

where we used (11) and the norm alization condition (3) for  $g_v$ . From now on, if not stated otherwise, we will always refer to the size-averaged probability distribution P (E) with the clear understanding that it coincides with any of the conditioned distributions  $\hat{P_v}$  (E). As the spectrum of lowest excitations is gapless, the norm alized distribution P (E) has the following scaling behavior,

We stress that the exponent  $_1$  is completely dierent from the standard therm al exponent (see next section) as they describe totally dierent excitations. The therm al exponent describes the energy-length relation for droplets typically excited at nite temperatures while the low est energy exponent  $_1$  describes the droplets that are separated by the smallest gap respectively to the ground state, so that, in general,  $_1$ 

We will argue below in Sec. IIC that  $_1 = d$  for a generic class of spin-glass system s with coupling distributions with nite weight at zero gap. In addition, this relation will provide an alternative interpretation of the lower critical dimension in terms of the exponent  $_1$  introduced in Sec. IIA describing the properties of the spectrum of sizes of the lowest droplets.

### C. The standard therm alexponent

Now we want to show how the exponents 1 and 1 combine to give the usual scaling exponent describing the energy cost of typical them all excitations in droplet theory. There are several ways to show this result. For simplicity, here we exem plify this relation by analyzing the low-T behavior of the second moment of the spin-glass order parameter at the order linear in T by keeping only the rst excitation. If  $q_f ; g = \frac{1}{v} \int_{-1}^{1} i i$  denotes the overlap between two replicas (i.e. con gurations of di erent system s with the same realization of quenched disorder), then the expectation value  $hq^2 i$  can be written as follows<sup>11</sup>,

where P (v; E) is given by (2). A low-tem perature expansion of  $(14)^{11,9}$  up to linear order in T yields,

which shows that the leading behavior is determ ined by both  $g_v$  and the density of states at zero gap  $\hat{P}_{\mathbf{p}}(0)$ . In the standard droplet model, it is generally assumed that typical low energy droplets have an average size  $\overline{v} = v_v v g_v V$  of the order of the system size (such as those generated by DW perturbation) and nite weight at zero gap  $\hat{P}_v(0)$  1=L where is the thermal exponent. In principle, a single exponent describes the scaling behavior of typical large-scale droplets with volume v / V and determ ines the zero-tem perature critical behavior. As these large-scale droplets are typical they occur with nite (therefore independent of V) probability  $g_v = 0$  (1) while sm all scale droplets are simply irrelevant  $g_{v = 0(1)} = 0$ . This yields,

where c is a non-universal sti ness constant related to the particular model. One of the most relevant results from the ansatz (4) is that both small and large scale excitations contribute to low temperature properties. In general, let us consider any expression (such as (15)) involving a sum over all possible volum e excitations. Restricting the sum to the large-scale droplets (v=V nite) the net contribution to such sum is proportional to V  $g_V \hat{P_V}$  (0) / L  $^{-1} d_{-1}P$  (0) (where P is the scaling function appearing in (13)). C om ing back to (15) and using (4) and (13), we note that both sm all and large-scale excitations yield a contribution to (15) of the sam e order and given by,

where  $c_1$  is another constant (di erent from the constant c appearing in (16)). Identifying both relations (16) and (17) we obtain the general relation,

This relation shows how the value of can be computed from  $_1$  and  $_1$ . Through the study of a speci c example, we will see later that the exponents  $_1$  and  $_1$  have strong nite-volum e corrections arising from the corrections present in the statistics of the extrem e values. How ever, we will present alternative routes to overcom e this dependence and provide an accurate estimate of .

Now we come back to the aforementioned argument at the end of Sec. IIB claiming that in the large-volume limit  $_1$  must converge to the value d in the case of coupling distributions with nite gap at zero coupling. The details of the argument are shown in appendix A. The argument has two parts. First, it is proved that one-spin excitations provide an upper bound for the LDE  $_1$ . Then it is argued that this upper bound holds also for any nite-size excitations (such as two-spin clusters, three-spin clusters, and so on). We will see below how this result is supported by the numerical analysis of the data. Let us also note that this result, in a RESD scenario (see Sec. IIB) can be linked to the linear dependence of the speci c at low temperatures, a result widely accepted, but that has been revisited recently in <sup>10</sup> to show that it has strong FVC due to the system atic FVC present in the value of  $_1$ . Inserting  $_1 = -d$ , (18) becomes,

This relation provides a way to distinguish the lower critical dimension  $d_{lcd}$  in terms of the average size distribution of the lowest droplets. A coording to (10) the relation  $_1(d_{lcd}) = 1$  distinguishes a regime where the average size of the lowest droplet grows with the volume of the system to a regime where the average size of the lowest droplet is nite,

The marginal case  $_1 = 1$ ; = 0 is specially interesting as the average size  $\overline{v}$  could be nite or diverge with the size but slower than a power law. This scenario corresponds to the mean-eld behavior as replica-symmetry is broken in both the standard RSB<sup>3</sup> or in the TNT<sup>17</sup> (standing for trivial-non trivial) scenarios. Therefore, the study of the size spectrum of the lowest excitations in spin glasses can be very useful to nd out the correct value of the therm al exponent in models without a nite-T transition (such as the 2d G ISG) as well as establishing the correct low-T scenario in models with a nite-T transition. In the next section we apply all these ideas to evaluate the therm al exponent for the 2d G ISG. Several num erical works have recently searched for bw-lying excitations in spin glasses using heuristic algorithm  $s^{13}$ . But, to our know ledge, no study has ever presented exact results about the statistics of lowest excitations. We have exactly computed ground states and lowest excitations in two-dimensional G aussian spin glasses de ned by

where the  $_{i}$  are the spins (1) and the  $J_{ij}$  are quenched random variables extracted from a G aussian distribution of zero m ean and unit variance. These have been computed by using a transferm atrix m ethod working in the spin basis. Representing each spins state by a weight and a graduation in the energy we can build explicitly the ground state by keeping the largest energy and, by subsequent iteration, the rst excitation and so on (see Appendix B for the details on how we compute these quantities). The continuous values for the couplings assures that there is no accidental degeneracy in the system (apart from the trivial time-reversal symmetry !). Calculations have been done in system s with free boundary conditions in both directions (FF), periodic boundary conditions in both directions (PP) and free boundary conditions in one direction but periodic in the other (FP). In all cases we nd the same qualitative and quantitative results indicating that we are seeing the correct critical behavior.

We have found ground states and lowest droplets for system's ranging from L = 4 up to L = 11 for PP and up to L = 16 for FP and FF. The number of samples is very large, typically  $10^6$  for all sizes. The large number of samples assures us that many samples have large-scale droplets as instexcitations. This provides us with good statistics to properly analyze the sector of large-scale excitations. The large number of samples requires a big am ount of computational time so that calculations were done in a PC cluster during severalm on ths. For each sample we have evaluated the volume of the excitation v (and hence the overlap q = 1 2v=V between the ground state and the inst excitation) and the gap E. From these quantities we can construct the  $g_v$  and the  $\hat{P_v}$  (E).




FIG.1. g(q) versus 1 q for the PP (left panel) and FF case (right panel) for dimensional lattice sizes L = 5 11 (PP) and L = 6-16 (FF) from top to bottom. In both insets we plot the scaling function g(q)V versus 1 q with = 0.7.

In Fig.1 we show  $g(q) = \frac{v}{2}g_v$  as function of q for di erent sizes in the PP and FF cases. We can clearly see that there are excitations of all possible sizes but, as discussed in the paragraph following (9), the typical ones which dominate by far are single spin excitations. To have a rough idea of the number of rare samples giving large scale excitations let us say that nearly half of the total number of samples have one-spin lowest excitations, whereas less than 10% of the samples have lowest excitations with overlap q in the range 0 0.5. This disparity increases system atically with size. For the lattice sizes explored the typical number of large-scale droplets is in the range  $10^4$   $10^6$  which is, indeed, quite good to have a good sampling of the sector corresponding to large scale excitations. A detailed analysis of the shape of  $g_v$  reveals that it has a at tail for large-scale excitations and a power-law divergence for nite-size excitations. The  $g_v$  can be excellently tted by the interpolating form ula (7,8)),

As shown in the insets of Fig.1 a good collapse of the scaling function is obtained with the elective exponent  ${}_1^e$  '0:7 for both PP and FF cases. We also plot the line resulting from the t of (23) with numerical data with the following values for A and B: PPBC: A = 1:55 (3) and B = 0:777 (3); FFBC: A = 2:02 (3) and B = 0:85 (1). Note that the t is excellent and is hardly distinguishable from the points. The value of 1 is compatible with the one obtained by tting the average size with the expression (10) with the addition of a constant term to account for the small-V behavior,  $\overline{v} = C_1 + C_2 V^1$ . The same exponent 1 can be estimated by measuring the ratio g (V=2)=g(1) D\_1 + D\_2 V^1. In both cases we get an elective exponent  ${}_1^e = 0:70$  (5) as best tting value.

However these di erent estimates of  $_1$  are strongly a ected by nite-volum e corrections (FVC). To evidence them we have estimated an elective L dependent  $_1^e$  (L) exponent by relating the average excitation size at consecutive sizes and using relation (10),




FIG.2. E ective lowest droplet exponent  $\frac{1}{2}$  versus L for the PP case, computed using logarithm ic derivatives.

In Fig.2 we show  $\frac{e}{1}$  (L) in the range L = 4 11 for the PP case. As we can appreciate there is a system atic increase of the e ective exponent as we go to large volume sizes without any tendency to saturate. This proves that FVC in our measurements are still big and the estimate  $\frac{e}{1}$  used to collapse the data in Fig.1 is still far from the asymptotic exact value.




FIG.3. G ap distribution P (E) versus E for di erent lattice sizes in the PP case. In inset a) scaling obtained from the ansatz (13) with  $\stackrel{e}{=} = 1.7(1)$ . In inset b) we show the  $\hat{P_v}$  (E) for di erent excitation sizes (q = 0.5; q = 0) for a lattice size L = 10. Note that the distribution is independent of the size of the excitation.

A fler having discussed the  $g_v$  we jump now to discuss the scaling behavior of the energy gap distribution  $\hat{P_v}(E)$  and its average P (E). In Fig. 3 we show P (E) (main gure and inset a) and  $\hat{P_v}(E)$  (inset b) for the PP case. Similar results are obtained for the FF and FP cases. Quite remarkably, as was already anticipated in (11), the RESD scenario holds as the distribution  $\hat{P_v}(E)$  does not depend on the size v of the excitation (see inset b in Fig. 3), hence both large and nite-size excitations are described by the same gap distribution.

In the main gure we can see how the width of distribution P (E) progressively shrinks to 0 as L increases. M oreover, the P (E) has an exponential shape. This is shown in the inset a) of Fig. 3 where we plot P (E) in log-norm all scale. N onetheless, a detailed examination of the tails of P (E) reveals some deviations from linearity. In Sec. V I we discuss the origin of these deviations. We anticipate, though, that they are consequence of the strong FVC in the range of sizes investigated. In that inset we also verify the scaling ansatz (13) by showing the best data collapse for P (E) obtained with an elective exponent  ${}^{e}_{1}$  (1:7(1). This is very far from the expected value  ${}_{1}$  = 2 discussed in the preceding Sec. IIC and in the Appendix A. A calculation of the moments of P (E) (13) for dimentivalues of L shows that there are also strong sub-dominant corrections to the leading scaling (13) that result in corrections as large as the ones a ecting the exponent  ${}_{1}$ .

A gain, to manifest the magnitude of FVC in  $_1$  we have evaluated  $\overline{E}$  (L), the rst moment of  $\hat{P}$  (E), obtained by averaging the lowest gap over all possible droplet sizes for di erent lattice sizes in the range L = 4 11. We have estimated an elective L-dependent exponent by means of the following expression,




FIG.4. E ective droplet exponent  $\frac{1}{2}$  versus L for the PPBC case, computed using logarithm ic derivatives (see text).

The results are shown in Fig.4 for the PP case. A gain, as for  $\frac{e}{1}$  (see Fig.2), we observe that the estimated value for  $\frac{e}{1}$  system atically changes with size showing that, for the sizes we have explored, we are still far from the asymptotic regime.

We can sum marize the results of this section saying that both lowest droplet exponents (LDEs)  $_1$  and  $_1$  display strong system atic nite-volume corrections (FVC). In principle, without further elaboration, it is di cult to give an accurate estimate for the thermal exponent using (18). An alternative estimate for the exponent could be de ned from the analysis of the fraction of large-scale excitations with q 1=2, f (q 1=2)<sup>4</sup>, which is given by

where we have used  $_1 = d$  (19). Although (26) yields estimates for , again these are a ected by strong nitevolume corrections. In the range of sizes studied in this paper, and using (26) we get ' 0:6 quite far from the asymptotic value reported later in Secs. IV and V. How can we go further and estimate in a safer way? In the next two sections we shall answer this question.

### IV .A GOOD ESTIMATE OF THE LOW EST DROPLET EXPONENTS

An interesting aspect of the elective L-dependent exponents shown in Figs. 2 and 4 is that, while their FVC are large, their corrections are of opposite sign. While  ${e \atop 1}$  (L) increases with L,  ${e \atop 1}$  (L) decreases. As they have to be added to get according to the relation (18) their nite-volum ecorrections cancel out to a certain degree. If we combine the two estimates for the best data collapse given in the previous section ( ${e \atop 1}$  = 0:70(5),  ${e \atop 1}$  ' 1:7(1)) we obtain ' 0:3(2) which is very close to the DW value in average. However, this estimate is too pessim istic. A better route would be to use the two LDEs estimated from (24),(25) and adding them according to (18)

In Fig. 5 (left panel) we show the value of obtained in this way. Note that the value of the therm alexponent has negligible FVC but relatively large statistical uctuations with L.

A better, albeit related, way to estimate is the following. Instead of independently nding out  $_1$  and  $_1$  we look for an estimator which depends on the appropriate combination of the two exponents  $= _1 + d_1$ . The simplest quantity which satisfies this requirements is given by the combination,



Since  $\overline{E}$  (L) 'L<sup>1</sup> and  $\overline{\nabla}$ (L) 'L<sup>d(1)</sup>, using (18) we obtain A (L) L. To estimate the value of we follow two di erent routes: 1) W e use (25) by replacing  $\stackrel{e}{1}$  (L)! <sup>e</sup> (L) and  $\overline{E}$  (L)! A (L). By de nition, this procedure gives exactly the estimate (27) shown in the left panel in Fig. 5. 2) A more stable estimate can be obtained from a t of A (L) versus L, with data in the range [L; main L= 11] (for the PPBC case). This is shown in the left panel of Fig. 5 together with the previous estimate (27) and also in the right panel of Fig. 5 but there compared with the extive exponent DW obtained from domain-wall calculations. Our best value for is

This value is very close to the nite-tem perature (M onte Carlo or transferm atrix) estimates  $_{TF} = 0.48(1)^{19}$  but certainly smaller than the domain-wall value  $_{DW} = 0.285^{7/8}$ . Our estimate for is compatible with the other possible value  $_{TF}$  obtained by other methods as discussed in Sec. I but is certainly inconsistent with the value obtained with other methods with results closer to the DW estimate.

All these estimates strongly support the inequality =  $_{\rm TF} < _{\rm DW}$ . However, one cannot exclude a situation where the present tendency of the data gets modiled and !  $_{\rm DW}$  in the large-L lim it<sup>30</sup>. We have already explained in Sec. IIC that  $_{\rm 1}$  must converge to 2 in the large volume lim it in plying the relation (19). Introducing our estimate (29) in (19) we get,

A convincing proof of the correctness of the values (29,30) requires proving that the estim ate (24) converges to the value (30) when L ! 1. In the next section we present an aspect-ratio analysis to evidence that the estim ates (29),(30) are correct in the large L lim it.

# V.ASPECT-RATIO ANALYSIS OF THE LOW EST DROPLET EXPONENTS

In this section, we present some additional data obtained via an aspect-ratio analysis (ARA). This analysis has been proved to be very useful to extract the value of the dom ain-wall exponent  $_{DW}$  by generating dom ain walls in rectangular lattices M L with di erent aspect ratios  $M = L^{24;27}$ . It has been found that, in the limit of large aspect ratio, the value of  $_{DW}$  for G aussian spin glasses is largely independent of the boundary conditions. We have seen in Sec. III that our measurements on squared lattices of size L L m ix small excitations with large ones so one does not have a clear-cut separation in the statistical distribution between the two di erent regimes v = O(1) and v=V = O(1). Our main motivation here is to show that, by investigating large aspect-ratios, we can separate these two di erent scaling regimes. We made our measurements on systems of size L M, with M = LR >> L where R ranges from 1 up to 10. We have investigated di erent types of boundary conditions: periodic boundary conditions in both directions (PPBC) and periodic boundary conditions in the L direction with free boundary conditions in the M direction (FPBC).




FIG.6. g(q) versus 1 q for the FPBC for R = 1;5 and 10 and for L = 8.

In Fig. (6), we display the data for g(q) versus 1 q (8) for the FPBC case for L = 8 and R = 1;5 and 10.0 ne can clearly see that the behavior of the distribution g(q) drastically changes as one increases R. Indeed, as we have already seen in Sec. III and in (5), (6), (8), for R = 1 it is very di cult to separate the region of sm all excitations (a scaling region with  $g(q)' = \frac{1}{(1-q)^{-1+1}}$ ) from the one of large excitations (a constant q-independent contribution  $g(q)' = \frac{1}{V-1}$ ). The main advantage of separating these two regions is that one can t directly each of them. This yields two separate measurements of the LDE  $_1$  in addition to the estimate (10) obtained from the L dependence of the average size of the excitations.




FIG.7.g(q) versus 1 q for the PPBC case for R = 10.

In Fig. (7), we show g(q) versus 1 q for R = 10 for various linear sizes L and for the PPBC case. These distributions have been obtained by running a large number of samples ranging from 10 m illion of samples for L = 4 down to 5 m illion for the largest size L = 9. We have also inserted in the gure two vertical lines which indicate the lim its for the range of values we have chosen for the ts of the scaling behavior of the nite-size excitation sector  $(1 \quad q \quad 0.07)$ and for the constant contribution corresponding to large scale excitations  $(1 \quad q \quad 0.25)$ . We have chosen these values for the follow ing reasons. First, as one can clearly see in Figs. (6,7), the scaling region for sm all excitations survives up to excitation sizes v' L L. This size provides a threshold value for the overlap  $q_h$  below which the simple scaling g(q) '  $\frac{1}{(1-q)^{1+1}}$  does not hold anymore,

An second, there is a crossover region around q'  $q_{\rm th}$ . A careful look at Fig. (7) shows that the scaling region for sm all excitations ends around 1 q'0.07. At this value, one observes a change of the slope of the curves just before entering the regime of large excitations where g (q) becomes q independent. For 1 q 0.25, the curves are rather constant and the result of a t does not depend much on the choice 1 q = 0.25. This second threshold value is indicated as the rightm ost vertical bar in Fig. (7).




FIG.8. E ective lowest droplet exponent  $\frac{1}{2}^{n}$  versus L for the PPBC case for R = 10. We represent the values of  $\frac{1}{2}^{n}$  obtained from thing the distribution of g(q) for small excitations (solid line), for large excitations (short dashed line) as well as the value obtained by thing the average size of excitations (dotted line).

In Fig. (8), we show the estimated values of e ective lowest droplet exponent  $\frac{e}{1}$  obtained in three di erent ways. The stestim ate has been obtained by averaging the volum e of all excitations for di erent lattice sizes as explained in Sec. III and then taking a logarithm ic derivative, see (24). The second estim ate has been obtained by considering the large excitation sector (1 q 0:25) and its L; R dependence:

A veraging the excitation volume within this sector (1 q 0.25) and using again the corresponding logarithm ic derivatives as in (24) yields the second estimate. The third estimate for 1 is obtained from a direct t of g(q) for smallvalues of 1 q:

This third method is in fact the most direct one since it can be done for each size L (while the other two estimates require a tusing data from two di erent lattice sizes L and L $^{0}$ ). The rst conclusion that we learn from Fig. (8) is that the ARA produces a great in provem ent on the estim ated values of the exponent  $_1$ . The m ost stable m easurem ent is the third estimate obtained by tting the small-size spectrum of the excitations. In that case,  $\frac{e}{1}$  is nearly constant with a value that converges to

in excellent agreem ent with the result (30) of the previous section.

M oreover, one also observes in Fig. (8) that the two other estim ated values for  $\frac{e}{1}$ , obtained with the instand second m ethods, are strongly correlated. This shows that nite-volum e corrections, which are expected to a left the value of the exponent obtained from the analysis of large-size excitations, does a left also the value of the exponent obtained by averaging over the whole spectrum. In addition, we also observe that the ARA for large R strongly decreases the m agnitude of nite-volum e corrections. W hile on a square geometry, the elective exponent  $\frac{e}{1}$  obtained from the average size of excitations took values in the range 0.52 0.62 (see Fig.(2)), with the ARA, we obtain for the same exponent values in the range 0.54 0.72, which are much closer to the expected asymptotic value 0.77 (1).




FIG.9. E extive exponent  $\frac{e}{1}$  obtained via a logarithm ic derivative for the PPBC and the FPBC.We also plot best t curves which converge to  $\frac{e}{1}$  (L! 1) = 1:96(6) for the PPBC and to  $\frac{e}{1}$  (L! 1) = 2:12(11) for the FPBC.

The same conclusion holds for the lowest droplet exponent 1. In Fig. (9), we show the elective exponent  $\frac{e}{1}$  obtained by evaluating the logarithm ic derivative as in (25). Note that nite-volume corrections are much smaller than with the squared lattices and as a result, the value of the elective exponent convergesm uch faster to the expected value 2. Using a t of the form  $\frac{e}{1}$  (L) =  $\frac{e}{1}$  (1) +  $\frac{est}{L}$ , one gets  $\frac{e}{1}$  (1) = 1:96(6) for the PPBC, the best t being also represented in Fig. (9). In this gure, we also show the same exponent obtained for the FPBC, where the best t yields the asymptotic value  $\frac{e}{1}$  (1) = 2:12(11). In both cases the tting value we obtain for the exponent is '1. Note that the asymptotic values for  $\frac{e}{1}$  are well compatible with our prediction of Sec. IIC,  $_1 = 2$  (see also the heuristic argum ent in Appendix A).

# VI.FIN ITE-VOLUME CORRECTIONS (FVC) AND THEIR RELATION TO THE STATISTICS OF EXTREME VALUES

W hat is the origin of these strong nite-volum e corrections? Intuitively it is not di cult to nd an explanation for the strong system atic nite-volum e corrections in the low est droplet exponent  $_1$ . As the word low est indicates, these exponents describe the statistical distribution of droplet excitations which are at the tail of the energy gap distribution that includes all possible high energy levels. As the volum e of the system increases there is more available space to nd excitations with low er energy gap. This implies that there is more probability to nd a low est droplet with an energy smaller than a given threshold value E . As this probability system atically increases with L for all sam ples,  $\frac{e}{1}$  (L) must be a decreasing function of L. This is in agreement with what we have found. The behavior of  $\frac{e}{1}$  (L) is more di cult to establish. By the same token, although there is more available space for droplets we expect that di erent droplet sizes increase or decrease their relative probability in a non-trivial way making di cult to guess how the exponent  $\frac{e}{1}$  (L) system atically changes with L.




FIG.10. Local-eld distribution for di erent lattice sizes with FFBC boundary conditions.

To understand the origin of nite-volume corrections in the value of  $_1$  we have focused our attention on the behavior of the upper bound exponent  $_1^1$  describing the statistics of the lowest one-spin excitations as described in the Appendix A. The gap distribution corresponding to these excitations can be obtained from the local-eld distribution evaluated at the ground state. We have numerically computed this distribution for di erent sizes, the results are shown in Fig. 10. As discussed in the appendix A, the local-eld distribution has a nite weight at zero eld and is a self-averaging quantity. As the local eld distribution is self-averaging, the probability distribution for the low est one-spin excitations corresponds to the extrem e value statistics of the local-eld distribution p<sub>1</sub> (h) where h stands for the local eld which we assume to be positive as the gap is given by its absolute value (the subindex 1 is used to stress that this distribution describes energy gaps for one-spin excitations only). If P<sub>1</sub> (h) stands for the probability distribution of the smallest local-elds, then P<sub>1</sub> (h) can be easily related to p<sub>1</sub> (h) by standard probability argum ents (see for instance,<sup>28</sup>). A lthough the argum ent is very general, here we apply it to one-spin excitations. For a given sam ple, the lowest value h is selected as the minimum value among all the possible V local elds h<sub>1</sub> at each lattice site. The probability P<sub>1</sub> (h) is given by the follow ing expression,

which accounts for all possible ways the value h coincides with the minimum value obtained among all di erent V local elds distributed according to the  $p_1$  (h). The last identity shows that  $P_1$  (h) is norm alized. This probability can be explicitly worked out in the large V limit,

Up to second order in h the function  $g_1$  (h) is given by,

From (36) we immediately learn that the gap distribution is an exponential with a sub-leading G aussian correction whose magnitude decreases as 1=V. A ctually, plotting  $P_1$  (h)=V as function of the scaling variable x = hV one gets,

In the large V  $\lim it q_1^0 (x=V) ! p_1(0)$  and the coe cient in front of the G aussian correction goes asymptotically to zero, therefore the distribution P<sub>1</sub>(h) converges to an exponential as expected,

in agreem ent with the scaling relation (13). We can now understand the deviations from the pure exponential behavior discussed in Sec. III in the context of the inset a) shown in Fig. 3. They are simply consequence of the nite-volum e corrections of the extrem e values of the gap distribution for all energy levels (and not only one-spin excitations as we are discussing here). So one could in agine to compute for a given sample the rst V energy gaps corresponding to the rst V excitations. We also assume that the resulting distribution  $p_{all}(E)$  is self-averaging in the large volum e lim it (as it is the local-eld distribution  $p_1$  (h)). The lowest energy distribution constructed by taking the minimum value of the gap E for each sample yields the extrem es distribution  $P_{all}(E)$  de ned in (13) (from now on we will drop the subindex 'all' in  $P_{all}(E)$  as it coincides with the P (E) de ned in (13). Also the subindex 'all' for the  $p_{all}(E)$  will be dropped). In fact, the param eters  $p(0); p^0(0)$  characterizing this distribution can be obtained from the P (E)'s shown in Fig. 3. To evaluate them, the best way is to analyze the cum ulative distribution P (E) =  $\sum_{E}^{N-1} dE^{OP} (E^{O})$  which from (35) we can assume to be P (E) = exp[ V  $g_{all}(E)$ ]. Thus we can t P (E) with an exponential with G aussian corrections A exp[ Bx C  $\hat{x}=2$ ] whose tting param eters are related to p(0) and p<sup>0</sup>(0). The best ts yield the follow ing values p(0) 0.2 and p<sup>0</sup>(0) = 0.3.




FIG.11. E ective droplet exponent  $\frac{1}{2}$  versus L for the FFBC case, computed using logarithm ic derivatives (see text). We show the exponent obtained for one-spin excitations (v = 1) in comparison to the one obtained from the whole distribution of gaps.

C om ing back to our original goal we discuss now the nite-volum e corrections for the estimate  $\frac{e}{1}$ , as shown in Fig. 4. From the distribution (36) describing the whole spectrum of excitations we can express the e ective exponent (25) for L >> 1 as,

The computation of E (L) is quite straightforward as it is given by the simple relation,

where we have used (36) plus an integration by parts. The integral, up to second order in 1=V yields,

Inserting this result in (40) we nally get,

This shows that  $\frac{e}{1}$  (L) approaches d from below (as  $p^0(0)$  is positive). On the other hand the magnitude of the nite-volume corrections can be pretty large if  $\frac{p^0(0)}{(p(0))^2} >> 1$ . For instance, if one takes the results obtained from the analysis of one-spin excitations one gets  $p_1(0)$  '  $0.069; p_1^0(0)$  ' 125 yielding  $\frac{p_1^0(0)}{(p_1(0))^2}$  ' 27: which is indeed large. Inserting these values in (43) we obtain an estimation for  $\frac{e}{1}$  (L = 12) = 1:65 in good agreement with numerical results (see Fig. 11).

If we insert the previous estimated values for the whole spectrum of excitations extracted from the P (E)'s in Fig. 3, we obtain  $\frac{p^0(0)}{(p(0))^2}$ ' 7.5. From (43) it follows that  $\frac{e}{1}$  (L)' 2(1 7:5=V), which for L = 11 yields  $\frac{e}{1}$  = 1:87. All in all, the magnitude of the elective exponent 1 is well compatible with the reported value  $\frac{e}{1}$  used in the inset a) in Fig. 3 for the PP case. Note that the FVC corrections to  $\frac{e}{1}$  obtained from the local eld distributions in the FF case are much larger than FVC corrections in the PP case in agreement with ARA results (see Fig. 9). From this analysis it becomes clear that to significantly reduce the magnitude of the nite-volume corrections in the value of 1 (let us say 1' 1:95), we would need larger volumes beyond 20 20.

### VII.COM PACTNESS OF THE LOW EST ENERGY DROPLETS.

O ne intriguing question about the droplet excitations concerns their topological properties. K awashim a and  $A \circ k^{20}$  have argued that droplet excitations are not compact. Instead, their volume has a fractal structure as the number of lattice points included in the droplet scales with its spanning length (which is a measure of the length scale of the droplet) with an exponent smaller (around 1.80(2)) than the dimension of the system (2).

To answer this question we have computed the surface, i.e. the perimeter P, of all lowest droplets. The relation between the average perimeter as function of the size v of the excitation depends on both the fractal dimension of the surface or perimeter  $d_s$  and the volume  $d_v$  of the lowest droplets.  $d_s$  and  $d_v$  can be dened in terms of the spanning length 1 of the droplet which can be dened in dimension. For example, one could use the gyration radius, the average distance between the sites contained in the cluster, or the maximum distance among the sites of the cluster. As the typical length scale of our lowest droplets is small, 1 ' 10, we have not attempted to estimate it as this can strongly depend on the precise denition of the spanning length. Here, we restrict ourselves to investigate the perimeter-volume dependence. In terms of the spanning length 1 the surface fractal and volum e fractal dimensions  $d_s; d_v$  of the droplets are dened as,




FIG. 12. Perimeter (P) of the droplet versus its volume (v). The solid line corresponds to the t (46) with  $d_s=d_v=0.632$  (2).

In Fig. 12 we show P (v) as a function of v for di erent lattice sizes. As can be seen, FVC are important for large volum es. However, there is an enveloping curve that is independent of L for sm all volum es and spans a progressively increase range of volum es as L increases. This enveloping curve is excellently tted (continuous curve) by the scaling relation (46) and yields an estim ate,

consistent with the results reported by Kawashim a and Aoki  $\frac{d_s}{d_v} = 0.61(1)$  obtained with a completely di erent method.

## V III. C O N C LU S IO N S

We have shown that a proper description of low-tem perature properties in two-dimensional Gaussian spin glasses can be done in terms of the lowest droplet exponents (LDEs) 1 and 1 describing the spectrum of lowest excitations. 1 describes the spectrum of sizes of the lowest energy droplets, while 1 describes the typical energy cost of these lowest droplets whatever their size. A sum ing that 1 = -d one concludes that the LDE 1 fully characterizes the spin-glass phase. A lthough independent numerical estim ates of 1 and 1 show strong nite-volume corrections, the therm al exponent =  $1 + d_1$  can be well estim ated giving the results (29), (30)

unambiguously showing that  $<_{DW} = 0.287 (4)^{27}$ . Our estimates (48) have been con med via an aspect-ratio analysis which provides estimates much less in uenced by nite-volume corrections. Moreover, the result  $_1 = 2$ (that is believed to be correct for spin glasses with coupling distributions with nite weight at zero coupling, see the Appendix A) has been numerically con med by the aspect-ratio analysis. To sum up, M cM illan's excitations are not the typical low-lying excitations and our approach o ers a new and independent way to estimate the them al exponent without the need to generate typical low-lying excitations by hoking at the new ground state of the system after

without the need to generate typical low-lying excitations by looking at the new ground state of the system after perturbing it.

We think that discrepancies on the value of the therm alexponent reported by comparing non-perturbative methods (such as nite-temperature transfer-matrix calculations and the present lowest droplet analysis) with perturbative methods such as domain-wall calculations (or perturbations induced by introducing a coupling term in the energy function that induces a large-scale excitation) are serious enough to be taken as a clear indication that our know ledge of the low-temperature properties of the 2d G ISG is still inadequate. In this direction we want also to recall the issue of multifractality and the possibility that di erent exponents could describe the zero-tem perature critical point. Is this really possible? Well, to our know ledge no exact result precludes this possibility and, although purely speculative at the present stage, one should seriously think about it. A logether, the present analysis suggests that the excitations in 2d G ISG are very dierent from the compact droplets proposed in the context of the droplet model. If this were true, the in plications of the 2d studies in larger dimensions could be important. There are many routes that can be followed to understand better what is going on and the origin of this discrepancy. Certainly, with the outstanding accuracy of present algorithms to compute ground states in 2d, it would be very interesting to revisit again the analysis of the statistics of the large scale excitations generated by imposing a uniform magnetic eld. No di results by R ieger et al.<sup>8</sup> give an estimate for that is compatible with our estimate rather than to the domain-wallestimate. This would be an independent check of our values, but using a perturbation method with an appropriate neutral observable such as the globalm agnetization as has been explained in Sec. I before (1).

The proposed m ethod m ay appear ventures on e as, to our present know ledge, there is no num erical study in the eld along this line of research. However, as explained in Sec. I, recent studies on the disordered Anderson m  $odel^{12}$  have revealed that the analysis of the low est excitation provides a good description of the localized phase. More studies are certainly required to understand better the reliability of the present m ethod to investigate the critical properties of spin glasses. One disadvantage of our approach is that a huge num ber of sam ples is needed to reasonably sam ple large-scale excitations. However, as we saw in Sec. V, the behavior of the g(q) for sm all 1 q can be extracted with a m odest num ber of sam ples. The advantage, as has been already stressed in Sec. I, is that we do not introduce any external perturbation to generate the excitations.

Finally, we want to comment on the extension of this approach to other models. Of course, the immediate extension one could think of is the 2d J model. However, the analysis of this model appears quite troublesome. This model does not have a continuous gap distribution but a discrete one that introduces further complications. As the ground state is not unique one has to rede ne the full analysis to properly de ne the spectrum of lowest excitations. The discreteness of variables could have some unexpected e ects in the present approach as seem s to happen also with dom ain-wall calculations<sup>22;27</sup>. It is more natural to extend the research to other models such as 2d ISG with other continuous coupling distributions without gap (e.g. characterized by P (J) jJj for jJj! 0), M igdal-K adano spin glasses (where both the ground state and the rst excitation could be feasibly found with an appropriate algorithm), G aussian spin glasses beyond d = 2 (where unfortunately, algorithm s are much lesse ective than in 2d as the nding of the ground state becom es a NP complete problem) and nally mean-eld spin-glassm odels where the zero tem perature exponents are known and maybe the spectrum of low est excitations could be analytically tackled. P relim inary results in this case<sup>29</sup> con rm that the present analysis describes pretty well the data for rather sm all sizes. W e are pretty con dent that, in the near future, new results and evidences will nally resolve this interesting problem.

### APPENDIX A: HEURISTIC PROOF OF THE IDENTITY $_{L} = D$

In this appendix we show that  $_1 =$ d. In what follows we do not attempt to present a rigorous proof but we content ourselves to present an heuristic argum ent. The argum ent has two parts: rst we show that d is an upper bound, next we show that the upper bound is the exact value. For the upper bound the argum ent is well known and goes as follows. Consider the ground state and all possible one-spin excitations. Because one-spin excitations are not necessarily the absolute lowest ones, the statistics of the lowest one-spin excitations must yield an upper bound  $\frac{1}{1}$ . The statistics of the lowest one-spin excitations is determined by the behavior of  $\frac{1}{1}$  for the value of 1, 1the ground-state local eld distribution p(h) in the lim it  $h \neq 0$ . If p(h) is self-averaging and p(0) is nite (in the large-volum e lim it) then the statistics of the low est excitations must be governed by the exponent  $\frac{1}{1} = -d$ . A linearly we do not know a precise mathematical proof of the statement that p(0) is nite, it looks quite intuitive<sup>16</sup>. In any short-range system with a frustrated ground state and a coupling distribution with nite density at zero coupling, we may expect a nite probability to nd a cage containing a spin coupled to its neighbors by a set of weak bonds which produce a vanishing net local-eld acting on that spin. This argum ent should generally hold for d 2. M oreover, as its name indicates, the local-eld distribution is a local observable. An argum ent a la Brout proves that it should be self-averaging as all possible local eld values are realized across the whole lattice  $^1$ . The next part of the argument consists in proving that an identical upper bound is valid by considering excitations with size strictly larger than 1 but nite. The upper bound derived for the one-spin excitations must necessarily hold for nite-size excitations beyond one-spin excitations (for instance two-spins, three-spins and so on) as the gap corresponding to the nite-size

excitations can always be written as a linear combination of a nite number of local elds with coe cients which depend on the ground state con guration. It is easy to verify that the aforem entioned properties of the local-eld distribution p(h) imply that the new gap distribution has a nite weight at zero gap and is self-averaging. This argum ent how ever cannot be extended to large-scale (with v V) excitations in a straightforw and way because the distribution for the corresponding gap distribution corresponds to an in nite sum of terms in the V ! 1 limit. However once we argue that  $_1$  is an upper bound valid for all nite-size excitations it can be concluded that this upper bound m ust coincide with the exponent  $_1$  describing the probability of the absolute low est excitations. From (4) the fraction of large scale excitations v ! V is given by  $Vg_V = \frac{1}{V}$ . In general > 0 so this fraction vanishes<sup>2</sup> in the in nite-volume limit and nite-size excitations yield a di erent value for  $_1$  this would in ply that boundary conditions could a ect the value of the therm al exponent. That would be quite unusual as this would mean that the exponents of the T = 0 xed point would depend on the boundary conditions.

### APPENDIX B:TRANSFER MATRIX ALGORITHMS

In this appendix, we will brie y explain how we determ ine the ground state and the rst excited state. We will work on a square lattice of size L L. The energy associate to a conguration of spins S (i; j) with a xed conguration of disorder  $J^x$  (i; j) and  $J^y$  (i; j) is

where  $B_1$  and  $B_2$  correspond to the choice of boundary conditions. Here we will consider three cases : Periodic Periodic boundary conditions (PPBC) with  $B_1 = B_2 = 1$ ; Free-Periodic boundary conditions (FPBC) with  $B_1 = 1$ ;  $B_2 = 0$  (or equivalently  $B_1 = 0$ ;  $B_2 = 1$ ) and Free-Free boundary conditions (FFBC)  $B_1 = B_2 = 0$ . We will only consider the case with a Gaussian distribution of the bond disorder  $J^x; J^y$ . To determ ine the ground state and the rst excited states, we proceed as follow: we start by associating a weight for each congurations of spins in the rst row of the lattice S (1;1); S (1;2); ; S (1;L):

So far, we have only described how to compute the value of the energies associated to the ground state and the rst excited state. Since we also want to determ ine the spins con gurations for these two states, we have to store, at each iteration of the transfer matrix, the value of the spin on which one sum s, as well as the value of the previous spins. Thus, for each  $2^{L}$  weights W<sup>1</sup> (i; j 1), we have to store the con guration
