W e derive the low-tem perature properties of spin-S quantum H eisenberg m agnets from the G ibbs free energy G (M) for xed order parameter M. A ssum ing that the low-lying elementary excitations of the system are renormalized spin waves, we show that a straightforward 1=S expansion of G (M) yields qualitatively correct results for the low-tem perature therm odynamics, even in the absence of long-range m agnetic order. W e explicitly calculate the two-loop correction to the susceptibility of the ferrorm agnetic H eisenberg chain and show that it quantitatively modiles the mean-eld result.

I. IN TRODUCTION

Form any years the magnetically ordered state of quantum H eisenberg magnets has been studied with the help of the spin-wave expansion.¹ This expansion is usually in plemented by expressing the components of the spin operator $\hat{S}_i = (\hat{S}_i^x; \hat{S}_i^y; \hat{S}_i^z)$ at lattice site i in terms of canonical boson operators \hat{b}_i and \hat{b}_i^y , using either the H olstein-P rim ako transformation? or the D yson-M aleev transformation for a spin-S ferrom agnet is

where $\hat{S}_{i} = \hat{S}_{i}^{x}$ \hat{B}_{i}^{y} , and the num ber of bosons at a lattice site m ay not exceed 2S in order to faithfully represent the 2S + 1 eigenstates of \hat{S}_i^z . If long-range m agnetic order is present in the z direction and the num ber of bosons is sm all compared to 2S, the two-body bosonic interaction arising from the term in Eq. (1a) involving three bosonic operators can be treated within conventionalm any-body perturbation theory, controlled by the form al sm all param eter 1=S. Due to the maximum -occupancy constraint the e ective bosonic H am iltonian in plicitly contains projection operators that elim inate the unphysical part of the bosonic Hilbert space. U sually, these projection operators are simply ignored. For Heisenberg ferrom agnets in three dimensions it was shown by Dyson³ that in the therm odynam ic lim it the low-tem perature therm odynam ics can indeed be obtained without taking into account the so-called kinem atical interactions associated with these projection operators.

W hile in the 1960s and 1970s ordered m agnets have been intensely studied, in recent years the center of attention has shifted to low-dimensionalm agnets without broken symmetries. In this case the conventional spinwave approach described above is not applicable, because it relies on the existence of long-range m agnetic order. Nevertheless, in many magnetic materials the elementary excitations still resemble the spin waves of an ordered magnet. For example, in two-dimensional quantum H eisenberg ferrom agnets⁵ and antiferrom agnets⁶ at low but nite temperatures, where the order parameter correlation length is exponentially large, spin waves with wave vectors kj¹ are well-de ned elementary excitations.⁷ O ther examples for system s where the low-energy physics is dom inated by elementary excitations of the spin-wave type are H aldane-gap antiferrom agnets (i.e. one-dimensional H eisenberg antiferrom agnets with integer spin S) and one-dimensional H eisenberg ferrom agnets with arbitrary spin.

To study the low-temperature properties of these systems, several methods have been proposed. The Schwinger-boson mean-eld theory of Arovas and A uerbach⁸ is perhaps aesthetically most appealing. How ever, going beyond the mean-eld approximation within the Schwinger-boson approach has turned out to be quite di cult.9 At the mean-eld level the modi ed spin-wave theory (MSWT) proposed by Takahashi¹⁰ is an alternative to the Schwinger-boson approach. M SW T yields results that agree with the predictions of Schwinger-boson mean-eld theory up to num erical prefactors. This is not surprising, because both approaches are in fact equivalent to a one-loop renorm alization group calculation.^{5,6} Recently, Takahashi's M SW T has also been applied to more complex problems, such as frustrated¹¹ or disordered m agnets,¹² or m agnetic m olecular clusters.¹³ H ow ever, the M SW T has shortcom ings: (i) it is very di cult to system atically calculate corrections due to interactions between spin waves within MSWT and (ii) the absence of long-range m agnetic order is not obtained as a result, i.e., the magnetization is set to zero by hand; this leads to am biguity in the choice of the constraint if the M SW T is applied to system swith more complicated magnetic order, such as ferrim agnets.¹⁴ In this work we shall show that these problems can be resolved within the conventional spin-wave approach simply by perform ing the calculation at constant order param eter.

This paper is organized as follows. In Sec. II we discuss the calculation of therm odynam ic observables at constant order parameter. In Sec. III this approach is applied to the H eisenberg ferrom agnet in D = 1;2;3 dim ensions within linear spin-wave theory. Hartree-Fock and

two-loop corrections are obtained for the one-dimensional case in Sec. IV . The work is sum marized in Sec.V .

II. THERMODYNAM ICSAT CONSTANT ORDER PARAMETER

In this section we discuss the calculation of therm odynam ic observables at constant order param eter. A lthough this approach is applicable to a variety of correlated system s with order param eter \hat{M} and corresponding conjugate eld h, here we will focus on the spin-S H eisenberg ferrom agnet with zero- eld H am iltonian

where the sum is over all nearest-neighbor pairs of a D – dimensional hypercubic lattice with N sites, and J > 0 is the exchange coupling. In this case the order parameter is simply the total magnetization, given by $\hat{M} = \prod_{i=1}^{N} \hat{S}_{i}^{z}$, and h is the hom ogeneous magnetic eld (in suitable units). Applications to antiferrom agnets or more com – plicated magnetic system s are straightforward.

Let us rst recall some elementary therm odynam ics. For xed eld h and temperature T, therm odynam ic observables can be obtained from the H elm holtz free energy (setting the Boltzm ann constant to unity)

where the dependence on T is suppressed for brevity. G iven F (h), the magnetization is obtained as

A lternatively, we may choose to x the magnetization and adjust the magnetic eld appropriately. The corresponding therm odynam ic potential is the G ibbs free energy G (M), which is related to the H elm holtz free energy via a Legendre transform ation,¹⁵

where the function $h \not M$) is obtained from Eq.(4). From G $\not M$) we obtain the equation of state in the form h = $h \not M$) via

which shows that the equilibrium magnetization for vanishing $\;$ eld is an extrem um of G (M). If the system has a

nite spontaneous magnetization M_0 = $\lim_{h\,!\,0^+}$ M (h), then the generic expected behavior of G (M) is, for M M $_0$,

is the inverse longitudinal order parameter susceptibility for vanishing external eld. These expressions are also valid in the absence of spontaneous symmetry breaking, where M₀ = 0. Note that, in general, G (M) = G (M), because the spectrum of \hat{M} is symmetric with respect to the origin.

The parameter h(M) in Eq. (5) can be viewed as a Lagrange multiplier that enforces the condition of constant magnetization. The zero-tem perature version of the method outlined above has been used previously by Georges and Yedidia¹⁷ to study spontaneous symmetry breaking in the ground state of the Hubbard model. Note that in the limit T ! 0 Eq. (5) can be written as¹⁸ $G(M) = h0^{+} \hat{G}(M)$ $\hat{D}i$, where $\hat{D}i$ is the ground state of the $free-energy operator" \hat{G}(M) = \hat{H}$ h(M))[(M].As shown in Ref. 17, the expansion at constant order param eter is advantageous for the calculation of corrections to the mean-eld approximation. In the following section we show that for low-dimensional Heisenberg magnets without long-range order this method yields reasonable results even at the level of linear spin-wave theory; the leading uctuation corrections in D = 1 are then calculated in Sec. IV.

III. LINEAR SPIN WAVES AT CONSTANT ORDER PARAMETER

W e now calculate G (M) within linear spin-wave theory, i.e., to leading order in 1=S, assuming that the low-lying elementary excitations of the system are renorm alized spin waves. In this approximation the square brackets in Eq. (1a) are simply replaced by unity, so that the H eisenberg H am iltonian (2) becomes

For simplicity, we impose periodic boundary conditions on a hypercubic lattice with primitive lattice vectors a and lattice spacing a = ja j. The momentum sum is over the rst Brillouin zone and \hat{b}_k is the lattice Fourier transform of \hat{b}_i . The corresponding free energy is

From Eq. (4) we then obtain the usual spin-wave result for the magnetization

A. Three-dim ensional ferrom agnet

It is instructive to begin with linear spin-wave theory for the three-dimensional H eisenberg model. In the thermodynamic limit we obtain for the magnetization per site m = M = N to leading order in t = T = JS and v = h = T

(z) is the zeta function. Setting h = 0 we rewhere cover the well-known B loch T $^{\rm 3=2}$ law for the spontaneous magnetization per site, $m_0 = \lim_{h \ge 0+} m(h)$, in the ordered state of the Heisenberg ferrom agnet. Taking the derivative of Eq. (13) with respect to h, we see that the susceptibility = (M = (h Eq. (8))) diverges for h! 0 as h ¹⁼². This divergence of the uniform longitudinal susceptibility of a three-dimensional Heisenberg magnet in the ordered state is not widely appreciated, although it was noticed a long time $ago^{2,3}$ and has been con med by renormalization group calculations for the classical Heisenberg ferrom agnet^{19,20} and perturbative calculations for the corresponding quantum model.^{21,22} Due to this divergence, the G ibbs free energy G (M) of the H eisenberg ferrom agnet in D = 3 does not have the generic form (7). Instead the linear spin-wave result for G(M) is, form m₀,




FIG.1: G ibbs free energy G_0 (M) of the three-dimensional H eisenberg ferror agnet within linear spin-wave theory. Due to the divergent longitudinal susceptibility in D = 3, the G ibbs free energy grows cubically for jn j slightly above m₀, see Eq. (14).

From Eq. (13) we note that $h^{1=2}$ / (m m₀), so that we cannot solve for h as a function of m unless m > m₀. In light of the above general discussion this is not surprising, because for jn j < m₀ the G ibbs free energy is constant.¹⁶ The behavior of G₀ (M) as a function of M is shown in Fig. 1. The leading m dependence of Eq. (14) is proportional to (m m₀)³, which can be traced to the fact that the inverse susceptibility vanishes. By contrast, in D > 4 the uniform longitudinal susceptibility of the H eisenberg ferrom agnet is nite,^{19,20} so that in this case the G ibbs free energy has indeed the generic form (7).

B. One-dim ensional ferrom agnet

Let us consider now the one-dimensional case, where we know that the Heisenberg ferrom agnet does not have any long-range order at any nite temperature T. In this

case the linear spin-wave theory result for the magnetization per site is

where again t = T=JS and v = h=T. This expression predicts a divergent magnetization and susceptibility for h! 0. However, we can obtain a perfectly nite result for the susceptibility at constant magnetization [Eq. (8)]. Solving Eq. (15) for has a function of M = N m we obtain

A coording to Eq. (8) this implies for the inverse susceptibility

Anticipating that in one dimension m = 0, we obtain for the susceptibility per site at low temperatures

This expression agrees $exactly^{23}$ with the prediction of the MSW T advanced by Takahashi,¹⁰ who argued that Eq. (18) is indeed the correct asymptotic lowtemperature behavior of the susceptibility for arbitrary S.ForS = 1=2 the nearest-neighbor Heisenberg chain is exactly solvable via Bethe ansatz,²⁴ so that in this case one can obtain an independent check of Eq. (18). Indeed, from a num erical analysis of the Bethe-ansatz integral equations²⁴ Takahashi¹⁰ found perfect agreem ent




FIG. 2: Solid line: G ibbs free energy $G_0 M$) of the onedimensional H eisenberg ferror agnet within linear spin-wave theory, see Eq. (19). The cusp at m = 0 is an unphysical artefact of the spin-wave expansion, which is related to the neglect of the kinem atical interaction between the spin waves. The dashed line is the subtracted G ibbs free energy $G_0 M$) = $G_0 M$) h(0) M j.

with Eq. (18) for S = 1=2, which is remarkable because a priori linear spin-wave theory is only expected to be accurate in the ordered state and for large S. We shall further comment on this agreement below.

W ithin linear spin-wave theory, the G ibbs free energy per site is given by

see Eq. (16). In writing Eq. (19) we have used the fact that our spin-wave calculation yields G_0 (M) only for M 0 and that the exact G (M) is an even function of M. Note that G_0 (M) assumes a minimum at M = 0, indicating the absence of long-range order. However, as shown in Fig. 2, linear spin-wave theory predicts an unphysical cusp in the G ibbs free energy at M = 0. The nite slope h (0) = $(G_0 = (M \ j_{M = 0^+} \ can be identi \ ed w \ ith$

The sope $h(0) = (G_0 - (M_{-1})_{H_{-1}} = 0^+)$ can be identified with the variational parameter introduced by Takahashi¹⁰ which in his calculation plays the role of a chemical potential for the D yson-M aleev bosons, enforcing the condition of zero magnetization. On the other hand, it is physically clear that for T > 0 any nite value of the external eld will always be accompanied with a nitemagnetization, so that an exact calculation of G (M) should yield $\lim_{M_{-1} \to 0} h(M_{-1}) = 0$. Therefore we expect that the exact G ibbs free energy in one dimension has the form

given in Eq. (7). The cusp of the spin-wave result for the Gibbs free energy is related to the fact that in our simple spin-wave calculation we have ignored the kinem atical interaction between the spin waves which arises from the maxim um-occupancy constraint.²⁵ Fortunately, this cusp is intelevant for the calculation of the zero- eld therm odynam ics, which can be also obtained from the subtracted Gibbs free energy

see Fig. 2. Note that G_0 (M) has the generic behavior given in Eq. (7), with the susceptibility given by Eq. (18).

C. Two-dim ensional ferrom agnet

For completeness we now discuss the case D=2, w here the spontaneous magnetization of the H eisenberg ferromagnet is zero at any nite temperature T. The result of linear spin-wave theory for the magnetization is (with t= T=JS, v = h=T)

which again diverges for h $! \ 0.$ The function h (m) is obtained as

which diverges for T ! 0. These expressions are analogous to Takahashi's results.¹⁰ F inally, the G ibbs free energy takes the form

i.e., with a minimum at m = 0, again with an unphysical cusp; in this sense the situation is rather similar to that in D = 1. Note, however, that in D = 2 it is known that a two-loop calculation is necessary to obtain the correct low-tem perature asymptotics of the susceptibility.⁵ A lthough the exponential factor / exp[4 $JS^2=T$] is correctly reproduced by mean- eld theory, the two-loop correction changes the power of T in the prefactor of Eq. (24); the correct low-tem perature behavior of the susceptibility of the quantum H eisenberg ferrom agnet in two dimensions is / $T^2 \exp[4 JS^2=T]$. This result is not modil ed if higher-order terms involving m ore than two loops are included.^{5,6}

IV. BEYOND LINEAR SPIN-WAVE THEORY

Because uctuation e ects are usually stronger in lower dimensions, we expect that in one dimension the corrections to the mean-eld result (18) are even more important than in D = 2. We now explicitly calculate the two-loop correction. Within the Dyson-M aleev form alism the dynamical spin-wave interactions are contained in the following two-body H am iltonian:

with $_{\rm k}$ de ned in Eq. (10). First let us estimate the e ect of $\hat{{\rm H}}_1$ within the self-consistent Hartree-Fock approximation. We write our spin-wave Ham iltonian as $(\hat{{\rm H}}_0+\hat{{\rm H}}_1)+(\hat{{\rm H}}_1-\hat{{\rm H}}_1)$ and choose the one-body Ham iltonian $\hat{{\rm H}}_1$ such that the therm alexpectation value of the residual interaction $\hat{{\rm H}}_1-\hat{{\rm H}}_1$ in the ensemble de ned by the Hartree-Fock Ham iltonian $\hat{{\rm H}}_0+\hat{{\rm H}}_1$ vanishes. We obtain




FIG.3: Feynm an diagram describing the leading uctuation correction to the free energy of the ferrom agnetic H eisenberg m odel, see Eq. (33). The solid arrows denote the H artree Fock m agnon propagators and the squares are the D yson-M aleev vertices.

The quantity ZS corresponds to the second variational param eter S⁰ introduced by Takahashi.¹⁰ N ote that he gives a di erent sign for the last term in Eq. (30). In one dimension 1 $Z = O(T^2)$ at low temperatures,¹⁰ so that for the calculation of the rst two terms in low-temperature expansion of therm odynam ic observables it is su cient to set Z = 1. We conclude that at the Hartree-Fock level the dynam ical interaction between spin waves does not contribute to the low-temperature asymptotics in D = 1. At this level of approximation our theory is equivalent to M SW T.

W ithin our approach it is now straightforward to study spin-wave interactions beyond the Hartree-Fock approximation. Therefore we simply expand the Helmholtz free energy F (h) to higher order in the interaction and then perform a Legendre transformation to obtain the corresponding G ibbs free energy. We now calculate the rst uctuation correction to F (h). The relevant Feynman diagram is shown in Fig. 3. In this approximation the Helmholtz free energy is F_2 (h) = F_1 (h) + F_2 (h), where F_1 (h) is given in Eq. (30) and

At low tem peratures, we may replace the Dyson-M alæv vertex by its long-wavelength lim it, which in D dim ensions is given by V $(k_1^0; k_2^0; k_2; k_1)$ $(k_1 k)a^2=2D$. For the rest of this work we shall explicitly set D = 1. Then the leading behavior of F_2 (h) for small t = T=JS and small v = h=T can be calculated analytically. We obtain for N $\ ! \ 1$

C om paring this result with the corresponding expression obtained within linear spin-wave theory given in Eq. (15), we see that the two-loop correction gives rise to an additional term proportional to the third power of (2S) 1 (t=v)¹⁼². But linear spin-wave theory predicts that this parameter is actually close to unity, as is easily seen by setting m = 0 in Eq. (15). Hence, the leading uctuation correction to the Hartree-Fock theory is not controlled by a small parameter. Note that the extra power of S 1 that appears in the two-body part of the e ective boson Ham iltonian is canceled by the singular h dependence of the two-loop correction. If we nevertheless truncate the expansion at the two-loop order, we obtain from Eq. (35) for the leading low-tem perature behavior of the susceptibility,

with C 1:96, which is slightly smaller than the linear spin-wave prediction C = 2, and signi cantly smaller than the result C = 3 obtained within Schwinger-boson mean-eld theory⁸. We suspect that corrections involving more loops will involve higher powers of the parameter (2S) ¹ (t=v)¹⁼² in Eq. (36), which give rise to additional

nite renorm alizations of C . Hence, a num erically accurate expression for the low-tem perature susceptibility of a one-dimensional Heisenberg ferrorm agnet cannot be obtained from a truncation of the 1=S spin-wave expansion at some nite order. Note that quantum M onte C arbs simulations for the S = 1=2 nearest-neighbor Heisenberg chain²⁶ give C = 1:58 0:03, supporting the scenario described above. In light of these results it is puzzling that from the num erical analysis of the B ethe-ansatz integral equations for S = 1=2 Takahashi^{10,24} obtained C = 2. Possibly this is related to di culties in extracting the true asymptotic low-tem perature behavior of the susceptibility from the B ethe-ansatz integral equations.^{10,27}

A lthough at rst sight our spin-wave expansion for the susceptibility appears to be controlled by the sm all parameter 1=S, this parameter is renormalized by the infrared singularity of the two-loop correction to the mean-ekl result. This phenomenon is familiar from the weak-coupling calculation of the two-loop correction to the ground-state energy of the repulsive Hubbard model at constant staggered magnetization in one and two dimensions.^{17,28} D ue to infrared singularities inherent in the loop integrals, those expansions are electively in powers of the Hubbard interaction U multiplied by a function of the order parameter; as a consequence the two-loop correction to the ground-state energy has the same order of magnitude as the Hartree-Fock term.

V. CONCLUSIONS

In sum m ary, we have shown that conventional spinwave expansion at constant order param eter is an alternative to Takahashi's m odi ed spin-wave theory, which now adays is one of the m ost popularm ean- eld m ethods to study low-dim ensionalm agnets without long-range order. D ue to the conceptual sim plicity of our m ethod, we can system atically calculate corrections to the m ean- eld approxim ation using conventional diagram m atic m ethods. W e have explicitly calculated the leading uctuation correction to them ean- eld result for the susceptibility of the ferrom agnetic H eisenberg chain. W e have found that in one dim ension the predictions of M SW T are at m ost qualitatively correct, because uctuation corrections are not controlled by a sm all param eter.

Furtherm ore, com pared to M SW T the present approach has the conceptual advantage that the introduction of Lagrange multipliers by hand is not necessary, since their role is played by external elds instead. The di erence between these approaches is best visible for system s with m ore complicated order parameters. For example, recent work on molecular magnets¹³ and ferrim agnets¹⁴ has shown that the form ulation of M SW T for such system s is di cult and that the proper choice of constraints is not clear a priori. On the other hand, spinw ave theory at constant order parameter naturally yields the absence of long-range order in low dimensions as a result; applications to antiferrom agnets and ferrim agnets, with vanishing hom ogeneous and staggered magnetizations, are in progress.²⁵
