# A nalytical solution of 1D lattice gas model with in nite number

of multiatom interactions

### Abstract

We consider a 1D lattice gas model in which the atom s interact via an in nite number of cluster interactions within contiguous atom ic chains plus the next nearest neighbor pairwise interaction. A llinteractions are of arbitrary strength. An analytical expression for the size distribution of atom ic chain lengths is obtained in the fram ework of the canonical ensemble form alism. Application of the exact solution to the problem s of self-assembly and self-organization is brie y discussed.

#### I. IN TRODUCTION

In recent years there has been growing interest in studies of monatom ic chains obtained in the processes of heteroepitaxial growth [1, 2, 3] at various substrates. A major goal of these studies is to obtain the so-called quantum wires for potential use in microelectronic applications. In these experiments one usually aims at obtaining wires of in nite length for subsequent use in the studies of the Luttinger liquid [3]. In practice, however, one frequently encounters the monatom ic wires of nite length. These may be useful in more practical applications, such as the microelectronic circuitry [4]. Such nite 1D clusters were observed, e. g., in Refs. [5, 6]. Current theoretical interest is in magnetic properties of nite monatom ic clusters [7] in view of their potential use in magnetic memory devices. The latter application, however, will require the development of the techniques of mass production of such objects. In this context it would be interesting to study the possibility of their selfassem bly and self-organization sim ilar to analogous processes in 2D heteroepitaxial system s [8, 9].

In the present paper we consider an analytic solution for the cluster size distribution in the fram ework of a 1D lattice gas model with an arbitrary number of cluster interactions within contiguous atom ic chains plus the next nearest neighbor pair interaction. Such model can be justiled in the fram ework of the Frenkel-K ontorova model of strained epitaxy [12] but also can be useful in other cases, e.g., in ab initio approaches, where the cluster interactions appear because of the many-body nature of the electron interactions which cannot be reduced to the pair interatom ic potential.

# II. THE MODEL

Let us consider a lattice gas model de ned by the function E (1) describing the dependence of the energy of 1D atom ic clusters (or chains) on their length 1. Such a model was already used for the description of the self-assembly phenomena in Ref. [10]. We note, however, that in 2D this approach can be only phenomenological because the cluster size does not characterize a 2D structure uniquely. In contrast, in 1D the cluster is de ned unambiguously by its length and the function E (1) is also uniquely de ned provided the clusters do not interact.

To apply standard tools of statistical physics we need to nd the H am iltonian corresponding to our model. To this end we consider the following trial expression

where  $V_1$  are numerical coe cients to be tted to reproduce the chain energies E (1) and  $n_i$  the occupation numbers taking values 0 or 1 depending on whether site i is empty or is occupied by an atom. A ssum ing we have already tted  $V_{1\ 1};V_{1\ 2};\ldots;V_2$  to the energies E (1)  $E_{1\ 1};E_{1\ 2};\ldots;E_2$  let us consider the chain of length 1. From Eq. (1) one nds

where the V term s on the right hand side (r. h. s.) account for the interactions of the new ly added atom with the rest. Sim ilarly

Subtracting Eq. (3) from Eq. (2) we get

from where it follows that the H am iltonian of our model is Eq. (1) with the coe cients given by the recursion relation

initialized by  $E_0 = E_1 = 0$ . For the system to be well de ned in the them odynam ic lim it the chain energy  $E_1$  cannot grow quicker then linearly when 1! 1. This means that the the cluster interactions  $V_1$  tend to zero at large lbecause according to Eq. (5) they are equal to the discrete second derivative of  $E_1$  with respect to 1.

In the above m odel atom s interact only when they belong to the sam e contiguous chain, so that separate chains are not coupled to each other. To m ake the m odel m ore realistic we allow for the interchain coupling by adding to the H am iltonian (1) the next nearest neighbor (NNN) pair interaction term

#### III. THE CANON ICAL ENSEM BLE SOLUTION

We consider a 1D lattice with a xed number of atom s N which can occupy I > N lattice sites. Our major goal in this paper is to nd the equilibrium distribution of the atom ic chain sizes at nite temperature T in the model de ned by H am iltonian (6). But rst we will consider the above problem using a simpler H am iltonian (1), i. e., by neglecting the NNN interaction which will be accounted for later. W e will seek the canonical ensemble solution of our problem by generalizing the approach of R ef. [13]. In this approach one rst have to compute the energy of the system in terms of cluster variables  $m_1$  the number of clusters of length land their energy E (1). Because the l! 1 lim it is not completely trivial, we calculate the con gurational energy by assuming that all  $V_1$  with l > L are equal to zero. In this case the total energy can be calculated as

where  $E_{L}^{0} = {P \atop l_{2}} V_{1}$  is the rst (discrete) derivative of  $E_{1}$ ,  $m_{2}$  is the total number of clusters of length exceeding L 2 which below we will call the big clusters, and  $N_{2} = N {P \atop l_{2} 2} m_{1}$  is the number of atom s contained in the big clusters. The last two terms on the r. h. s. of Eq. (7) can be veriled by rst checking their correctness for  $m_{2} = 1$  and then noting that cutting a big cluster into two ones an ounts to cutting 1 1 couplings of type  $V_{1}$ . To complete the calculation of the total free energy  $F_{tot} = E_{tot}$  TS it remains to compute the entropy S. The number of atom is congurations can be expressed through the cluster variables as 0 = 1

In this equality the rst multiplier on the r. h. s. counts all inequivalent permutations between the clusters with all big clusters being considered as equivalent while the second factor accounts for the number of ways to divide  $N_{>}$  atom s into  $m_{>}$  big clusters including their permutations. We not this factor by observing that the division of  $N_{>}$  atom s into clusters of sizes exceeding L 2 is equivalent to dividing  $n = N_{>}$  (L 2) $m_{>}$  atom s into  $k = m_{>}$  clusters. The latter quantity was calculated in Ref. [13] to be equal to the binom ial coe cient 0 = 1

k 1.0 therwise it is equal to zero. The meaning of this form ula is simple. provided n In a contiguous chain of n atom s there is n 1 places to cut the chain into pieces. k pieces can be obtained with k 1 cuts. Hence, the number of the possible cuts of n atom s into k pieces is equal exactly to the above combinatorial coe cient. To complete the calculation of the total number of con gurations we have to multiply at by the corresponding factor responsible for the con quarties of vacant sites [13]. But before doing this we repair Eq. (7)by accounting for the omitted NNN pair interaction. To this end we note that as long as the contiguous chains are concerned,  $V_{N N N}$  interaction amounts simply to renormalization of V3. Additionally this term introduces the interchain coupling between the chains separated by a single vacant site (a vacancy). Therefore, the term  $V_{N N N} k_1$ , where  $k_1$  the number of vacancies, should be added to the r. h. s. of Eq. (7) (here and above we do not pay attention to the boundary conditions [13] because in this paper we are interested only in the therm odynam ic lim it). So when counting the con gurations of empty sites we should separate the con gurations with di erent numbers of vacancies. This is achieved by using Eq. (8) with the total number of empty sites I N instead of N, the big clusters in this case should exceed L 2 = 1. Denoting the total number of clusters as k from Eq. (7) we get

Our nalexpression for S is obtained from Eqs. (8) and (9) with the use of the Stirling formula as

where = N = I is the total coverage,  $q = m_1$ =I is the concentration of clusters of length l, c =  $P_1c_1$  the total cluster concentration, v =  $k_1$ =I the vacancy concentration, > =  $P_{\frac{L-1}{2}}c_1 = N_2 = I$ . This expression for reduced entropy together with the reduced energy obtained from Eq. (7) are su cient to obtain the reduced free energy as a function of the unknown quantities fc<sub>1</sub>g, c<sub>2</sub>; and v. M inim izing it with respect to these variables we arrive in the lim it L! 1 at the following set of equations

To nd the above lim it it is necessary to know the asymptotic behavior of  $c_1$  at large 1. The lim it was taken by assuming the exponential behavior  $c_1 / \exp(-1)$  which is consistent with the resulting equation (11). We note that Eq. (12) is of the second order in v, so one can exclude this variable from the rst equation to obtain a closed equation for  $fc_1g$ . From the above set, how ever, it is easier to see that if the NNN interaction is negative, than v ! c as T ! 0, i.e., the vacancy concentration becomes equal to the concentration of clusters which m eans that the system becomes ordered: the clusters self-organize into chains separated by m onovacancies. This is further con m ed by the fact that the entropy Eq. (10) tends to zero at zero tem perature provided  $V_{N N N} < 0$  and the clusters are size calibrated. Indeed, in the lim it L ! 1 only the rst two lines of Eq. (10) survive

where s = S = I is the entropy per site.

In connection with this expression it is worth noting that Eqs. (11) and (12) can form ally be obtained in the therm odynam ic lim it from the variation with respect to  $c_l$  of the expression for the free energy density

where is the Lagrange multiplier. This derivation, however, may cause doubts in the case of clusters of sizes l = 0 (N) when the term s  $lc_l = m_l 0$  (N)=N in the above equation acquire discrete values and so are not suitable for the variational treatment. The derivation presented above is more rigorous and besides can be modiled to be applicable to nite system s [13, 16].

At T = 0 and c = v the entropy density (13) takes the form

Thus, if the clusters at T = 0 are size calibrated, i.e., if for some value of  $l = l_0 c_{l_0} = cwhile c_l = 0$  for all other l, then from the above equation it follows that s = 0. For  $V_{N N N} = 0$  the entropy is positive even at T = 0 m eaning disordered state. The issue of size calibration will be considered in m ore detail in section V.

### IV. THE ISING MODEL

To check Eqs. (11) and (12) we will apply them to the known exactly solvable problem |the 1D Ising model. As is known, it is equivalent to the lattice gas model with pair interatom ic interaction. This can be easily shown (see [14]Ch. II) by substituting  $n_i = (1 \ i)=2$ ( $_i = 1$  the Ising spin variable) into the LGM H am iltonian

Thus, the Ising model with NN interaction can be solved in the canonical ensemble form alism with the use of our form ulas. In this section we will obtain the appropriate form ulas in closed analytical form. Also, we will compare our results obtained in the canonical ensemble with more familiar results obtained in the grand canonical form alism via the transfer matrix method. The latter solution can be found e.g., in Ch. V of Ref. [14], where the 1D Ising model H am iltonian was considered which in our notation can be written as (cf. Eq. (15)

was considered. The reduced free energy calculated in the grand canonical ensemble was found to be

where  $K = V_{N N} = k_B T$  and  $h = h = k_B T$  is the external eld (divided by  $k_B T$ ) which xes the magnetization M. The latter is connected to the coverage by the relation

and can be calculated as

To obtain the canonical ensemble free energy we have to perform the Legendre transform (xee Eq. (16))

where the partial derivative is calculated from Eq. (19) as

Finally, to obtain the LGM free energy F in the canonical ensemble form alism we have to add the statistical average of the last term on the r.h.s. of Eq. (15):

In our form alism the free energy F for the NN LGM can be calculated as follows. A c-cording to Eq. (12), in the case  $V_{N N N} = 0$

These two equations are su cient to express the unknown quantities c and through the coverage and the interaction parameter  $K \mid$  the independent variables in the canonical ensemble. From Eq. (25) we have after some algebra

where  $x = (1 e^{K})$ . These expressions can be used to obtain analytic expressions for all quantities of interest.

In the canonical ensemble case the free energy is

A swe see, it is quite di erent from Eq. (22). We were unable to compare the two solutions analytically and used the num erical procedure. By xing h and K we computed M with the use of Eq. (21) and F=N k<sub>B</sub> T from Eq. (22). Then was calculated according to Eq. (18) and F=N k<sub>B</sub> T was computed from Eq. (26). Both values coincided within 13-15 signi cant digits depending on how singular the values of F=N k<sub>B</sub> T are at the chosen values of h and K.

Thus we have solved the 1D NN LGM in the canonical ensemble approach and expressed all quantities of interest in terms of the atom ic density (or coverage) which is more natural and easier to measure quantity then the chemical potential variable of the grand canonical formalism.

# V. THE SIZE CALIBRATION

A coording to Ref. [10], the system exhibits the size calibration of the atom ic clusters if the energy density per atom E (1)=1 has a m in in um . The size calibration is easiest to see in the case  $V_{N N N} = 0$  when the distribution Eq. (11) takes the form

Except for the excluded volum e prefactor this expression coincides with the form ula proposed in Ref. [10] where a detailed discussion of the size calibration issue is given and which fully applies to our case provided the pair attraction  $V_{N N}$  is not too strong. In Ref. [12] we have shown that in the fram ework of the Frenkel-K ontorova m odel the elective chain energy (in fact, the free energy see Ref. [12] for details) has the form

where the last two terms represent the relaxation free energy. The length dependence of the relaxation energy  $W_1$  is governed by the dimensionless parameter =  $k_s = k_p$ , where the spring constants  $k_s$  and  $k_p$  are the second derivatives of the potentials which bind the atom to the substrate ( $k_s$ ) and of the pair interatom ic interaction ( $k_p$ ), respectively. In the




FIG.1: The length dependence of the reduced chain energy with the relaxation energy corresponding to = 10<sup>5</sup> and  $V_{N N} = 0.25$  in units of  $k_p f^2$  (see the text). The inset shows the location of the minimum.

illustrative calculations below the energy unit was chosen to be equal to the energy of the unrelaxed m is t strain  $k_p f^2$ , where the interatom ic spring constant  $k_p$  was de ned earlier and f is the m is t as de ned in Ref. [12]. The relaxation entropy S<sub>1</sub> is practically linear in 1 and so according to Eq. (5) essentially contributes only into the NN interaction.




FIG.2: Equilibrium distribution of atom ic chain lengths at the coverage = 0:1 corresponding to (from left to right) 1= $k_B T$  = 20, 22, 30, and 60 (in units of  $k_p f^2$ ). The pair interaction  $V_{N N}$  = 0:25 and = 10<sup>5</sup> (for explanation of notation see the text).




FIG. 3: The sam e as in Fig. 2 except that the entropic part of  $E_1$  is set to zero and the tem peratures are (from left to right)  $1=k_B T = 12.5, 13, 15, 20$ , and 60

In our calculations we chosen  $= 10^{5}$  to be quite small in order to visualize all qualitative details of the self-assembly behavior. Physically this would correspond to very weak binding to the substrate. In the above energy units  $V_{N N}$  was chosen to be equal to -0.25so that there was a minimum in E (1)=1 at 1 100 (see Fig.1). The calculation of the size distribution for this case is shown in Fig. 2. It qualitatively agrees with the M onte C arlo simulations of Ref. [11] (cf. Fig. 2 of that reference). The most notable feature of the above calculations is the change of the position of the maximum of the cluster size distribution with lowering tem perature | the feature not clearly understood from the theory of Ref. [10]. A lthough the entropic contribution into E<sub>1</sub> is rather sm all due to the sm all tem peratures considered, the shallow ness of the minimum in E (1)=1m akes it possible that the above shift of the maximum is due to the shift in the position of the minimum in  $E_1 = W_1$  TS<sub>1</sub> with lowering temperature. To check this possibility we repeated calculations with  $E_1$  replaced by tem perature independent part W 1. The results of this calculation is shown in Fig. 3. The only qualitative di erence with Fig. 2 is that the bin odal distribution is never observed in the case of T-independent case. P resum ably, this is due to the 1D character of our m odel, because in 2D case where also T-independent interactions were used we found a strongly

bim odal distribution [15].

# VI. CONCLUSION

In this paper we considered an analytical solution of a 1D lattice gas model with an arbitrary number of cluster interatom ic interactions within contiguous atom ic chains. We illustrated the model by applying it to the description of the equilibrium distribution of atom ic clusters in strained epitaxy in the therm odynam ic limit. However, the model can be used also in other cases when the multiatom interactions are of the above type, as well

as applied to nite systems, like those discussed in Refs. [13, 16]. Our analytical solution con m s the observation m ade in Ref. [11] in the fram ework of a phenom enological approach that the maximum in the equilibrium distribution of the cluster sizes m oves to higher values with lowering temperature. This can lead to an interesting kinetic phenom enon consisting in the saturated ripening when the system is quenched to lower temperature.
