# D ynam ics of bright $m$ atter-w ave solitons in inhom ogeneous cigar-type Bose E instein condensate

#### Abstract

$W$ e discuss the possible observation of a new type of standing nonlinear atom ic $m$ atter $w$ ave in the condensate: the nonlinear im purity mode. It is investigated dynam icale ects of a bright soliton in B ose E instein-condensed ( BEC ) system $\mathrm{s} w$ ith local space variations of the tw o-body atom ic scattering length. A rich dynam ics is observed in the interaction between the soliton and an inho$m$ ogeneity. P rocesses as trapping, re ection and transm ission of the bright $m$ atter soliton due to the im purity are studied considering an analyticaltim e-dependent variational approach and also by fill num erical sim ulation. A condition is obtained for the collapse of the bright solitary wave in the quasi-one-dim ensional BEC w ith attractive local inhom ogeneity.

## I. IN TRODUCTION

Theoretical investigations of nonlinear collective excitations ofm atter w aves, actually becam e a very interesting and relevant sub ject $w$ ith the experim ental observations of Bose $E$ instein condensation in vapors of alkali$m$ etal atom $s\left[\begin{array}{ll}{[1]}\end{array}\right]$. O ne of the interesting form sof localized $w$ aves of atom ic $m$ atter are the solitons - $m$ oving stationary nonlinear wave packets. H istorically, it was rst observed the dark solitons, represented by ob jects w ith nontrivial topological properties. They can exist in BEC system $s$ for positive tw o-body scattering length ( $a_{s}>0$ ), corresponding to repulsive interactions betw een atom $s$. $T$ hey can be presented as holes in the background of the condensates $\left.\overline{R_{i}}\right]$.

The observation of solitons in BEC system sw ith negative two-body scattering length ( $a_{s}<0$ ) - so called bright solitons, are $m$ ore com plicated from the experi$m$ ental point of view. The di culty is related to the instability of condensates in two-dim ensions (2D) and three-dim ensions (3D ), when the number of atom $s N$ exceeds the critical lim it $\mathrm{N}_{\mathrm{c}}$, which is typically a num ber of the order of 1,500 atom $s$ for $L i^{7}$. This experim ental lim itation can be softened in case of quasi-one-dim ensional (1D ) geom etry; i.e., for BEC in highly anisotropic cigartype traps. W e should observe that, for a true 1D system, one does not expect the collapse of the system with increasing num ber of atom $s\left[\begin{array}{ll}{[1,4} \\ -4\end{array}\right]$. H ow ever, it happens that a realistic 1D lim it is not a true 1D system, w ith the density of particles still increasing due to the strong restoring forces in the perpendicular directions [10ind].
$T$ he observation ofbright $m$ atter-w ave solitons in BEC w th attractive interactions has been recently reported in Ref. [7], Theoretical models, explaining the observed phenom ena, have been considered in $R$ efs. [9] It
should be noted that in principle it is possible to observe the bright $m$ atter $w$ aves solitons in BEC $w$ ith optical lattice. The possibility of changing the sign of the e ective dispersion in such lattioes $m$ akes possible to generate bright solitons for repulsive condensates [1]in]. Thus, it represents an interesting possibility to control the dynam ics of bright $m$ atter-w ave solitons. For the control, in this paper we suggest to use arti cially induced inhom ogeneities, by considering a variation in the space distribution of the atom ic tw o-body scattering length. This variation can be achieved by using opticalm ethods, asdetuned laser eld [1] applying an extemalm agnetic eld $[1 \overline{4} \overline{1} . \mathrm{M}$ athem atically, this leads to the appearance of a coordinate dependent coe cient in the nonlinear term of the $G$ ross $P$ itaevsk ii (GP) equation. W e w ill analyze this problem for a cigartype condensate using a fill num erical solution of the GP form alism and also a tim e dependent variationalapproach, which was successful in the description of BEC
 the variational approach it represents a good fram ew ork for a prelim inary insight into the basic physicalm echanism of the $m$ odel.

W e consider the local space variation of the atom ic scattering length as related to a nonlinear im purity term in the nonlinear Schrodinger equation (NLSE). P reviously, interaction of solitons w ith linear im purities have been perform ed in the sine-G ordon $m$ odel $\left[11_{1}^{2}\right]$ and in the 1D NLSE [10 \{20]. It was show $n$ that the interaction $w$ ith the im purity $m$ ode leads to unexpected behavions of the soliton. In particular, the soliton can be re ected by an attractive im purity. This happens due to a resonant interaction betw een the soliton and an oscillating im purity m ode.

For the description of the soliton dynam ics, the variational approach gives tw o coupled equations: for the soliton width and center-ofm ass position. The oscillation frequencies of the w idth can be transferred resonantly to the oscillation frequencies of the center of m ass; and, as a result, the trapped soliton can escape from the inhomogeneity. W e should also note that exists a solution representing a standing nonlinear atom ic $m$ atter $w$ ave. $T$ he soliton, trapped by the nonlinear im purity, evolves to this solution. In this work we estim ate the values of the param eters for the observation of such a new type of nonlinear standing atom ic $m$ atter $w$ ave.

The structure of the present work is as follow s: In Sect. 2, we form ulate the model for the quasi 1D BEC w ith nonlinear inhom ogeneity and derivate the equations for the soliton param eter using the tim e dependent variational approach. In Sect. 3 we present the analysis of the xed points, frequencies of oscillations for the width and center ofm ass. Section 4 contains the num ericalm odeling of the system of ODE's and num erical sim ulations of the inhom ogeneous GP equation, w ith a naldiscussion on the nonlinear im purity mode.

## II. FORM ULATION OF THE MODEL

Them ean eld equation for a B ose E instein-condensed system, trapped by an harm onic potential, is given by the follow ing G P equation:

$w$ here $a_{s}$ is the atom ic scattering length, $m$ is the $m$ ass of the atom, and the wave-function $(x ; t)$ is nor$m$ alized to the num ber of particles $N$. In the present work, we assum e a cylindricalhighly anisotropic trapped potential, such that i.e. $!_{1}=!_{2} \quad!_{3}$. In this circum stance, one can approxim ate the eld as [5인]

W e should observe that, in the realistic case one has a quasi-1D (cigar-like) trap. In $R$ ef. $\left[\overline{2}_{1}^{1}\right]$, the authors have consider the form ation and propagation of $m$ atter $w$ ave solitons, using a gas of ${ }^{7}$ Liatom s , in a quasi-1D trap. T he frequencies used in their trap are ! ? $=!_{1}=2 \quad 625 \mathrm{~Hz}$, and $!_{\mathrm{L}}=!_{3}=2 \quad 32 \mathrm{~Hz}$, w ith the scattering length tuned to $a_{s}=3 a_{b}\left(a_{0}\right.$ is the $B$ ohr radius). The ratio of such frequencies gives $=\left(!_{3}=!_{1}\right)^{2}=2: 6 \quad 10^{5}$. In this case, as shown in Ref. [G], the maxim um critical number $n_{0, m}$ ax $2: 70$ is a constant that does not depend on $a_{s}$. To study the dynam ics of the perturbed soliton we use the follow ing trial function [221]:

W hen a is constant we have the well known description of the soliton center as the unit $m$ ass particle in an anharm onic potentialU ( ) = 2 Asech $^{4}$ (A ) [ this point of view, for $<0$, a slow ly m oving soliton ( $\left.\mathrm{v}_{\mathrm{s}}<\mathrm{v}_{\mathrm{c}}=2 \bar{j}\right)$ can be trapped by the im purity. C onsidering the im purity w th $<0$, the soliton can pass through the im purity or re ect, depending on its velocity. The num erical sim ulations of the system $\left(1 \bar{T}_{1}\right)$ and the GP equation (see section 4) show s that the dynam ics is $\mathrm{m} u$ ch m ore com plicated. In particular we can observe the soliton re ecting from an attractive im purity even when $\mathrm{v}_{\mathrm{s}}<\mathrm{v}_{\mathrm{c}}$.

In order to have a more general form ulation of the m odel, in the present section we have considered a nonzero extemal potential, param etrized by . O ne could also explore the behavior of the soliton, by considering a $m$ ore general tim e-dependent form of the extemalpotential, as studied in Ref. [ $\left.{ }_{2}^{2}-1\right]$. H ow ever, in the present work our $m$ ain $m$ otivation is the propagation of $m$ atter wave solitons, in a 1D cigar-like trap [211], such that we w ill assum $\mathrm{e}=0$ in the next sections.
III. D Y NAM IC S OF BRIGHTSOLITONSUNDER TWOKINDOFINHOMOGENEITIES

## A. Point-like non-linear im purity

Let us rst consider an inhom ogeneity given by a delta type ( $f(z)=(z)$ ), and look for the xed points of the system of Eqs. $\left(1 \bar{I}_{1}\right)$. In this case,

The xed point for the soliton center is given by $=0$. $T$ his corresponds to the case of an atom ic $m$ atter soliton trapped by the local variation of the tw o-body scattering length. In case the local variation corresponds to a positive scattering length ( $<0$ ), we should observe the soliton being re ected by the inhom ogeneity. T hen, the stationary width $a_{c}$ can be de ned by

Expanding the solution near $\mathrm{a}_{\mathrm{c}}$ we obtain the frequencies of sm all oscillations for the w idth $a$ and for the center-ofm ass of the soliton, localized by the im purity. $T$ he square of such frequencies are, respectively, given by

In the variational approach for the soliton interacting w ith the im purity we have the interaction of the oscillating intemal degree of freedom (the width) w th the soliton center. A s can be seen from Eqs. (201), the frequencies of the oscillations can $m$ atch for a certain value of , w th energy transfer betw een the tw o m odes. So, as a result of the re ection from attractive inhom ogeneity in BEC, a depinning of the soliton can occur.

## B. Interface betw een tw O BEC m edia

N ow, we consider another interesting case of an interface betw een two $m$ edia, such that at $z=0$ we have a sudden change in the two-body scattering length. T he size of the inhom ogeneity is given by in Eq! ! (\%), where $f(z)=(z)$. In this case, we have

W hen $\mathrm{a}=4=\mathrm{n}_{0}$ the system (222) reduces to the single equation for describing the $m$ otion of the e ective particle, for opticalbeam crossing the interface of tw o nonlinear $K$ err $m$ edia considered in [25]. If the velocity exceeds the critical value, the soliton pass trough the inhom ogeneity. A n interesting e ect, predicted in Ref. 2 can occur when the soliton cross the interface, nam ely, the possibility of soliton splitting. The soliton is the solution in the rst $m$ edium. In the second $m$ edium it can be considered as the initial wavepacket deviating from the solitonic solution, for this $m$ edia. A pplying the approach developed in Ref. [ $\left.{ }_{[2}^{2}\right]$, such initial condition w ill decay on few solitons plus radiation [26]. The num ber of generated solitons is equal to

$w$ here $u_{0}$ is the initial solution for the second $m$ edium, and $I[:::]$ stands for integer part of [:::]. Thus, if we have $a$ jum $p$ in the scattering length given by $a_{s}=a_{s 2} \quad a_{s 1}$, then the num ber of generated splitons in the secqnd part of the BEC is equalto $n_{\text {sol }}=I \quad P \frac{a_{s 2}=a_{s 1}}{}+1=2$, where $(1+)=a_{s 2}=a_{s 1}$ is the ratio of the atom ic scattering lengths. For exam ple, for the ratio $9 / 4<a_{s 2}=a_{s 1}<25 / 4$ (or $125 \ll 5.25$ ) we obtain two solitons in the right-hand-side $m$ edium. To obtain $n_{\text {sol }}$, we need such that $\mathrm{n}_{\text {sol }}\left(\mathrm{n}_{\text {sol }} 1\right)<(+3=4)<\mathrm{n}_{\text {gol }}\left(\mathrm{n}_{\text {sol }}+1\right)$.
IV. N U M ERICALSIM ULATIONSAND

GENERALD ISCUSSION

O ur approach for pulses deviating from the exact soliton solution is interesting from the experim entalpoint of view, considering the di culty in producing exact solitonic solutions. Is of particular interest the non-trivial case of nonlinear $D$ irac-delta im purity ( $f(z)=(z)$ ), where we m ade detailed com parison betw een the variational and full num erical solution of the GP equation. In $F$ ig. 1, we are com paring the variation results $w$ ith the num erical ones, for xed point of the width, given by a (top fram e); for the frequency of oscillations of the width, $!_{a}$ ( $m$ iddle fram e); and for the frequency of oscillations of the center-ofm ass, ! , trapped by the inhom ogeneity (bottom fram e). By using the variational approach, we observe that the width goes to zero and the frequencies are singular when

Here, it is interesting to observe that we have two critical num bers that are related: one of the critical num ber $\mathrm{n}_{0, \mathrm{~m} \text { ax }} \quad 2: 7 \mathrm{com}$ es from the quasi-1D lim it of a 3 D calculation [G] $\left[\frac{1}{2}\right.$; another, is the $m$ axim um am plitude of the delta-like im purity that we have just introduced, given by (28). C onsidering both restrictions, we have that the sm aller value of $c$ is about one.

Theplots in $F$ ig. 1 are valid for any value of $n_{0}$ (w here the $m$ axim um is about $8 / 3$, according to [ $[\underline{6}]$ ), because the width and the frequencies were rescaled, such that $0 \quad\left(n_{0}=4\right)$ (im plying that $\left.{ }_{c}^{0}=2=3\right)$, and

A s shown in Fig. 1, the variational results are supported by the fill num erical calculation. T he singularity occurs when the contributions com ing from the inhom ogeneity and nonlinearity are equal to the contribution from the quantum pressure, as seen from Eq. $\left(1 \bar{T}_{1}\right)$. W hen $c$, occurs the collapse of solitary wave. So, we can observe the collapse of a 1D soliton on the attractive nonlinear im purity. This possibility can be obtained follow ing a dim ensional analysis in the 1D H am iltonian given in Eq. (10). The behavior of the eld at small widths is u $\quad 1=L^{1=2}$. Taking into account that (z) $\quad 1=L \quad j^{2} j$ we can conclude that the contribution of the potential energy due to the impurity is jug. For positive, this
term on the im purity exceeds the quantum pressure and leads to the collapse of the soliton. In realsituations, the collapse will be arrested on the nal stage of the evolution, when the soliton width becom e of the order of the inhom ogeneity scale. Then, the delta-function approxi$m$ ation for the im purity willbreak up.

In F ig. 2, we show num erical sim ulations of the w ave pro le. W e note that, after strong em ission of radiation, it evolves into the so-called non linear localized m ode. T he nonlinear localized $m$ ode represents an exact solution of GP equation w ith nonlinear im purity (9) and it is the nonlinear standing atom ic $m$ atter $w$ ave. The solution is given by

This solution can be obtained by using the solution of the hom ogeneous equation $w$ ith the requirem ent of the eld continuity at the inhom ogeneity and satisfying the jum p condition in the rst derivative [281]. T he nom alization $N^{\left({ }^{(n)}\right)}$, related to the umber of atom $s$ for this solution is

At large am plitudes, we have $\mathrm{N}^{(\mathrm{ni})}$ ! $2=$ for $>0$; and $\mathrm{N}^{\text {(ni) }}$ ! 8a for $<0$. N ote that for $<0$ we have a solution $w$ th tw o bum ps structure for the nonlinear localized $m$ ode. A $s$ show $n$ in [28], this $m$ ode is unstable. H ere, we have considered only the case $>0$.

In order to verify the stability of the solutions, one can study the behavior of the second tim e derivative of the $m$ ean-square radius, as in Refs. the second tim e derivative of the $m$ ean-square radius, we use the $V$ irial approach, w ith $H=Q_{z z}+V$ and V

U sing our solitonic ansatz, when a ! 0, we reach the critical lim it, $c=8=\left(3 n_{0}\right)$ that w as obtained before.

W e have also investigated the dynam ics of the $m$ atter soliton interacting $w$ ith inhom ogeneity, studying di erent regim es of propagation for severalvalues of. In Fig. 3, we present the results of num erical sim ulations for the nal velocity ( $\mathrm{v}_{\mathrm{f}}$ ) versus the initial velocity ( $\mathrm{v}_{\mathrm{i}}$ ) of the soliton, considering di erent strengths for the inhom 0 geneity. In the present and next num erical approaches, we have considered $n_{0}=4$, for the general1D NLSE $w$ ith nonlinear im purity, as one can easily rescale the obtained data to a value of $n_{0}$ sm aller than 2.7, in agreem ent $w$ ith the quasi-1D results.

A s observed in $F$ ig. 3, exists a region for the velocities where the attractive nonlinear im purity re ects the soliton. In the m odel involving the constant width approxim ation, this region corresponds to the trapped soliton. T he num erical results show that alw ays exists one $w$ indow corresponding to the re ection of the soliton. By increasing, this window is shifted to larger initial velocties. From the variation of the num ber $N$, w ith respect to the initial velocity $v_{i}$ (top fram e of $F$ ig 3), one can also observe strong w ave em issions by soliton, when increases and tends to the critical value (see also [281]). $T$ his picture rem inds the picture of the collapse in 2D BEC w ith attractive interaction. W e note that, by considering the interaction of sine-G ordon kink with attractive defect, $m$ any $w$ indow $s$ w ere found, corresponding to
a resonance with localm ode (see [1] $[1]$ ).

In order to com pare w th the results given in the low er fram e of Fig.3, we present in Fig. 4, for a xed value of $=0: 4$, full num erical calculation of the tim e evolution of the center-ofm ass position, considering di erent values of the initial velocity. It is clearly seen the repulsive tra jectories for $v_{i}$ corresponding to the case that the e ective particle is trapped.

By considering num ericalsim ulations of the variational equations (188) we found, qualitatively, the sam e behavior as the one observed in the full solution of the GP equation (see Figs. 3 and 5). In Fig. 5, we show the behavior of the nal velocity as a function of the in itial velocity, for di erent values of . In particular, the variational equations also show the existence of one $w$ indow when the soliton is re ected by the im purity. W hen increases the $w$ indow $m$ oves in the right direction, reducing the width.

In distinction, on the GP equation, the variational equations show s a m ore com plicated (probably chaotic) dynam ics near the points w here the regim e of re ection starts or nishes. In this region, we also can see the $m$ ore rare events $w$ ith the transm ission ofsoliton through the im purity. This observation resem bles the phenom ena observed at the interaction of the sine-G ordon equation kink w ith a localdefect. T he system of D E's (tw om ode m odel) has a sim ilar structure as our equation (1G), show ing chaotic behavior, leading alw ays to a nite time for the period of the soliton trapping. This phenom enon is due to stochastic instabilities inherent for this dynam ical system. The reason for this phenom enon is that the nite dim ensional system, like the one given by Eq. ( $\overline{1} \overline{1})$, cannot take into account the soliton radiation, that interacts $w$ ith the defect. The ect of the radiation leads to the appearance of the dam ping in Eq. (18 $\mathbf{1}_{1}^{1}$ ), that changes the long-tim e behavior of the system. In particular, the radiative dam ping can lead to the long-tim e regular dynam ics []$\left._{1}\right]$.

For a m ore detailed investigation of the interaction betw een $m$ atter $w$ ave soliton $w$ ith the nonlinear im purity m ode, excited on the inhom ogeneity, we need to develop collective coordinate approach like the one considered in


## V.CONCLUSION

In this work, we have investigated the dynam ics of bright $m$ atter $w$ ave soliton, in BEC system $s w$ ith cigar type geom etry and attractive interactions. T he inhom ogeneities can appeared in BEC due to the existence of regions in space $w$ ith di erent values of the two-body atom ic scattering length $\mathrm{a}_{\mathrm{s}}$. These variations can be
achieved using, for exam ple, the Feschbach resonances. Two kind of inhom ogeneities in the spatial distribution of $a_{s}$ have been studied: localpoint-like and jum $p$ type. The rst type has been m odeled by a D irac-delta function, that $w$ ill result in a m odulation of the nonlinear term in the GP equation, corresponding to the so called nonlinear impurity in the nonlinear Schrodinger equation. T he second type corresponds to a sudden variation of the tw o-body scattering length, that a ects the am plitude of the nonlinear term in GP equation. It correspond to the case that the BEC system is divided in two parts $w$ ith di erent values of $a_{s}$ (see discussion of recent experim ent in $R$ ef. [1] $]$ ).

The present investigation of the local variation in space of the atom ic scattering length show s that di erent regim es of the soliton interaction w ith the nonlinear im purity are possible. It is observed trapping, re ection and transm ission regim es. The $m$ ost interesting e ect is the re ection of the atom ic soliton by the attractive nonlinear im purity. W e have also veri ed the occurrence of collapse of the soliton on the attractive im purity, w hen the strength of the impurity (or the initial number of atom s) exceeds a certain critical value. This e ect in quasi-1D BEC resem bles the phenom ena that occurs in 2D BEC.U sing the tim e-dependent variationalapproach we have described successfilly both phenom ena.

For the case of a sudden variation of the two-body scattering length, represented by a nonlinear jum $p$ inhom ogeneity, using analogy w ith a nonlinear optical problem [ $\left.{ }^{2} \mathbf{L}^{-1}\right]$, we presented the condition for the m ultiple bright m atter soliton generation.

F inally, we would like to em phasize that the problem we have studied in the present work has im portant application for the control of param eters of bright atom ic $m$ atter solitons and for the generation of solitons in quasi 1D BEC.
