# D ynam ics of bright matter-wave solitons in inhom ogeneous cigar-type Bose-E instein condensate

We discuss the possible observation of a new type of standing nonlinear atom ic matter wave in the condensate: the nonlinear in purity mode. It is investigated dynamical elects of a bright soliton in Bose-Einstein-condensed (BEC) systems with local space variations of the two-body atom ic scattering length. A rich dynamics is observed in the interaction between the soliton and an inhomogeneity. Processes as trapping, relection and transmission of the bright matter soliton due to the impurity are studied considering an analytical time-dependent variational approach and also by full numerical simulation. A condition is obtained for the collapse of the bright solitary wave in the quasi-one-dimensional BEC with attractive local inhom ogeneity.

I. IN TRODUCTION

Theoretical investigations of nonlinear collective excitations of matter waves, actually became a very interesting and relevant subject with the experimental observations of Bose-E instein condensation in vapors of alkalimetal atoms [1]. One of the interesting form s of localized waves of atom ic matter are the solitons – moving stationary nonlinear wave packets. Historically, it was not observed the dark solitons, represented by objects with nontrivial topological properties. They can exist in BEC systems for positive two-body scattering length ( $a_s > 0$ ), corresponding to repulsive interactions between atoms. They can be presented as holes in the background of the condensates [2].

The observation of solitons in BEC systems with neqative two-body scattering length ( $a_s < 0$ ) – so called bright solitons, are more complicated from the experimental point of view. The diculty is related to the instability of condensates in two-dimensions (2D) and three-dimensions (3D), when the number of atom sN exceeds the critical lim it N c, which is typically a num ber of the order of 1,500 atom s for  $Li^7$ . This experimental lim itation can be softened in case of quasi - one-dimensional (1D) geometry; i.e., for BEC in highly an isotropic cigartype traps. W e should observe that, for a true 1D system, one does not expect the collapse of the system with increasing number of atoms [3,4]. However, it happens that a realistic 1D lim it is not a true 1D system, with the density of particles still increasing due to the strong restoring forces in the perpendicular directions [5,6].

The observation of bright matter wave solitons in BEC with attractive interactions has been recently reported in Ref. [7,8]. Theoretical models, explaining the observed phenomena, have been considered in Refs. [9,10]. It

should be noted that in principle it is possible to observe the bright matter waves solitons in BEC with optical lattice. The possibility of changing the sign of the e ective dispersion in such lattices makes possible to generate bright solitons for repulsive condensates [11,12]. Thus, it represents an interesting possibility to control the dynam ics of bright m atter-wave solitons. For the control, in this paper we suggest to use articially induced inhom ogeneities, by considering a variation in the space distribution of the atom ic two-body scattering length. This variation can be achieved by using opticalm ethods, as detuned laser eld [13], or by means of Feshbach resonance applying an external magnetic eld [14]. M athem atically, this leads to the appearance of a coordinate dependent coe cient in the nonlinear term of the Gross-Pitaevskii. (GP) equation. We will analyze this problem for a cigartype condensate using a full num erical solution of the GP form alism and also a time dependent variational approach, which was successful in the description of BEC dynam ics [15,5]. In spite of the well known di culties of the variational approach it represents a good fram ew ork for a prelim inary insight into the basic physical mechanism of the model.

We consider the local space variation of the atom ic scattering length as related to a nonlinear in purity term in the nonlinear Schrödinger equation (NLSE). Previously, interaction of solitons with linear in purities have been performed in the sine-G ordon model [16,17] and in the 1D NLSE [18{20]. It was shown that the interaction with the impurity mode leads to unexpected behaviors of the soliton. In particular, the soliton can be rejected by an attractive impurity. This happens due to a resonant interaction between the soliton and an oscillating impurity mode.

For the description of the soliton dynam ics, the variational approach gives two coupled equations: for the soliton width and center-ofm ass position. The oscillation frequencies of the width can be transferred resonantly to the oscillation frequencies of the center ofm ass; and, as a result, the trapped soliton can escape from the inhom ogeneity. We should also note that exists a solution representing a standing nonlinear atom ic matter wave. The soliton, trapped by the nonlinear impurity, evolves to this solution. In this work we estim ate the values of the param eters for the observation of such a new type of nonlinear standing atom ic matter wave.

The structure of the present work is as follows: In Sect. 2, we form ulate the model for the quasi 1D BEC with nonlinear inhom ogeneity and derivate the equations for the soliton param eter using the time dependent variational approach. In Sect. 3 we present the analysis of the xed points, frequencies of oscillations for the width and center of mass. Section 4 contains the numerical modeling of the system of ODE's and numerical simulations of the inhom ogeneous GP equation, with a nal discussion on the nonlinear in purity mode.

#### II.FORM ULATION OF THE MODEL

The mean eld equation for a Bose-E instein-condensed system, trapped by an harm onic potential, is given by the following GP equation:

where  $a_s$  is the atom ic scattering length, m is the mass of the atom, and the wave-function (r;t) is normalized to the number of particles N. In the present work, we assume a cylindrical highly an isotropic trapped potential, such that i.e.  $!_1 = !_2 : !_3$ . In this circum – stance, one can approximate the eld as [5]

By substituting the Eqs.(2)-(4) in Eq.(1) and averaging over the transverse coordinates,

From now, we consider a simplified notation for the functions, such that u = u(z; ),  $u = 0^2$ , and  $u_{zz} = 0^2 u = 0^2$ . Thus, we obtain the following 1D NLSE:

where is the signal of the two-body scattering length. The equation (7), for = 0 (!<sub>3</sub> ! 0) and = 1, has the solitonic solution

where A is a constant and v is the soliton velocity. In the following, let us consider the interesting case of local space variation of a negative atom ic scattering length, such that Eq. (7) is replaced by

> 0 ( < 0) refers to negative (positive) variation of the scattering length. The corresponding 1D H am iltonian energy is given by

where  $n_0$  is the norm alization of u, related to the num ber of particles N and the scattering length  $a_s$ :

W e should observe that, in the realistic case one has a quasi-1D (cigar-like) trap. In Ref. [21], the authors have consider the form ation and propagation of matter wave solitons, using a gas of <sup>7</sup>Liatom s, in a quasi-1D trap. The frequencies used in their trap are  $!_2 = !_1 = 2$  625 Hz, and  $!_L = !_3 = 2$  32 Hz, with the scattering length tuned to  $a_s = 3a_0$  ( $a_0$  is the Bohr radius). The ratio of such frequencies gives  $= (!_3=!_1)^2 = 2:6 \ 10^5$ . In this case, as shown in Ref. [6], the maximum critical number  $n_{0max}$  2:70 is a constant that does not depend on  $a_s$ . The realistic maximum number of atom s  $V_{c, m}$  will be related to  $a_s$  and the oscillator length:  $4N_c ja_s j m !_1 = h \ 2:70$ .

To study the dynam ics of the perturbed soliton we use the following trial function [22]:

where A, a, , , w, and b, are tim e-dependent variational param eters. In this case u is norm alized to  $n_0 = 2aA^2$ . To derive the equations for the tim e-dependent param – eters of the soliton, we rst obtain the averaged Lagrangian Z

The equations for the soliton param eters are derived from the Lagrangian L, by using the corresponding Euler-Lagrange equations. So, L is given by

W hen a is constant we have the well known description of the soliton center as the unit mass particle in an anham onic potential U () = 2 Å sech<sup>4</sup> (A) [23]. From this point of view, for < 0, a slow ly moving soliton ( $v_s < v_c = 2$  j) can be trapped by the in purity. Considering the in purity with < 0, the soliton can pass through the in purity or relect, depending on its velocity. The numerical simulations of the system (17) and the GP equation (see section 4) shows that the dynam ics is much more complicated. In particular we can observe the soliton relecting from an attractive in purity even when  $v_s < v_c$ .

In order to have a more general formulation of the model, in the present section we have considered a nonzero external potential, parametrized by . One could also explore the behavior of the soliton, by considering a more general time-dependent form of the external potential, as studied in Ref. [24]. However, in the present work our main motivation is the propagation of matter wave solitons, in a 1D cigar-like trap [21], such that we will assume = 0 in the next sections.

#### A. Point-like non-linear im purity

Let us rst consider an inhom ogeneity given by a delta type (f(z) = (z)), and look for the xed points of the system of Eqs. (17). In this case,

The xed point for the soliton center is given by = 0. This corresponds to the case of an atom ic matter soliton trapped by the local variation of the two-body scattering length. In case the local variation corresponds to a positive scattering length (< 0), we should observe the soliton being releved by the inhom ogeneity. Then, the stationary width  $a_c$  can be de ned by

Expanding the solution near  $a_c$  we obtain the frequencies of small oscillations for the width a and for the center-of-mass of the soliton, localized by the impurity. The square of such frequencies are, respectively, given by

In the variational approach for the soliton interacting with the impurity we have the interaction of the oscillating internal degree of freedom (the width) with the soliton center. As can be seen from Eqs. (20), the frequencies of the oscillations can m atch for a certain value of , with energy transfer between the two m odes. So, as a result of the re ection from attractive inhom ogeneity in BEC, a depinning of the soliton can occur.

#### B. Interface between two BEC media

Now, we consider another interesting case of an interface between two media, such that at z = 0 we have a sudden change in the two-body scattering length. The size of the inhom ogeneity is given by in Eq.(9), where f(z) = (z). In this case, we have

W hen  $a = 4=n_0$  the system (22) reduces to the single equation for describing the motion of the elective particle, for optical beam crossing the interface of two nonlinear K err m edia considered in [25,26]. If the velocity exceeds the critical value, the soliton pass trough the inhom ogeneity. An interesting elect, predicted in Ref. [26], can occur when the soliton cross the interface, namely, the possibility of soliton splitting. The soliton is the solution in the rst medium. In the second medium it can be considered as the initial wavepacket deviating from the solitonic solution, for this media. Applying the approach developed in Ref. [27], such initial condition will decay on few solitons plus radiation [26]. The number of generated solitons is equal to

where  $u_0$  is the initial solution for the second medium , and I [:::] stands for integer part of [:::]. Thus, if we have a jump in the scattering length given by a  $_{\rm s}$  =  $a_{\rm s2}$   $a_{\rm s1}$ , then the num ber of generated solutions in the second part of the BEC is equal to  $n_{\rm sol}$  = I  $a_{\rm s2}=a_{\rm s1}+1=2$ , where (1 + ) =  $a_{\rm s2}=a_{\rm s1}$  is the ratio of the atom is scattering lengths. For example, for the ratio 9/4<  $a_{\rm s2}=a_{\rm s1}<25/4$  (or 1.25<<5.25) we obtain two solutions in the right-hand-side medium . To obtain  $n_{\rm sol}$ , we need such that  $n_{\rm sol}(n_{\rm sol}-1)<(+3=4)< n_{\rm ol}(n_{\rm sol}+1)$ .

### IV . N U M E R IC A L SIM U LAT ION S A N D G E N E R A L D ISC U SSIO N

Our approach for pulses deviating from the exact soliton solution is interesting from the experim ental point of view, considering the di culty in producing exact solitonic solutions. Is of particular interest the non-trivial case of nonlinear Dirac-delta impurity (f(z) = (z)), where we made detailed comparison between the variational and full num erical solution of the GP equation. In Fig. 1, we are comparing the variation results with the num erical ones, for xed point of the width, given by a (top fram e); for the frequency of oscillations of the width, ! (m iddle fram e); and for the frequency of oscillations of the center-of-m ass, ! , trapped by the inhom ogeneity (bottom frame). By using the variational approach, we observe that the width goes to zero and the frequencies are singular when

Here, it is interesting to observe that we have two critical numbers that are related: one of the critical number  $n_{0,m \ ax}$  2:7 comes from the quasi-1D lim it of a 3D calculation [6]; another, is the maximum amplitude of the delta-like in purity that we have just introduced, given by (28). Considering both restrictions, we have that the sm aller value of  $_{\rm c}$  is about one.

The plots in Fig. 1 are valid for any value of  $n_0$  (where the maximum is about 8/3, according to [6]), because the width and the frequencies were rescaled, such that  $n_0 = 4$  (in plying that  $n_c^0 = 2=3$ ), and

As shown in Fig. 1, the variational results are supported by the full num erical calculation. The singularity occurs when the contributions coming from the inhomogeneity and nonlinearity are equal to the contribution from the quantum pressure, as seen from Eq. (17). W hen occurs the collapse of solitary wave. So, we can observe the collapse of a 1D soliton on the attractive nonlinear in purity. This possibility can be obtained following a dimensional analysis in the 1D Ham iltonian given in Eq. (10). The behavior of the eld at small widths is  $1=L^{1=2}$ . Taking into account that (z) 1=L u τŕ we can conclude that the contribution of the potential energy due to the impurity is jug. For positive , this term on the inpurity exceeds the quantum pressure and leads to the collapse of the soliton. In real situations, the collapse will be arrested on the nal stage of the evolution, when the soliton width become of the order of the inhom ogeneity scale. Then, the delta-function approximation for the impurity will break up.




FIG.1. The width  $a^0$  a  $(n_0=4)$ , the frequency of the width oscillations  $!_a^0$   $!_a (4=n_0)^2$ , and the frequency of the soliton center oscillations  $!^0$  !  $(4=n_0)^2$ , versus the strength of the nonlinear delta-like in purity  $^0$   $(n_0=4)$ . Solid line corresponds to full num erical solution of the GP equation, and dotted line to the corresponding variational approach. A ll the quantities are in dim ension less units, as explained in the text.




FIG.2. Density pro le evolution for a xed value of the am plitude of the delta-like in purity, = 0.3, in a projected 3D plot. At z = 0, we observe the oscillation of the am plitude, starting from the norm alone and going to the nonlinear localized one. Each line represents a xed value of . The plot is shown for a moderately small value of , in order to avoid crossing of the lines. For larger values of we can also observe the em ission of radiation. and z are dimensionless quantities, as given in the text.

In Fig. 2, we show numerical simulations of the wave prole. We note that, after strong emission of radiation, it evolves into the so-called nonlinear localized mode. The nonlinear localized mode represents an exact solution of GP equation with nonlinear in purity (9) and it is the nonlinear standing atom ic matter wave. The solution is given by

This solution can be obtained by using the solution of the hom ogeneous equation with the requirement of the eld continuity at the inhom ogeneity and satisfying the jump condition in the rst derivative [28]. The norm alization N  $^{(n\,i)}$ , related to the umber of atom s for this solution is

At large am plitudes, we have N <sup>(n i)</sup> ! 2= for > 0; and N <sup>(n i)</sup> ! 8a for < 0. Note that for < 0 we have a solution with two bumps structure for the nonlinear localized mode. As shown in [28], this mode is unstable. Here, we have considered only the case > 0.

In order to verify the stability of the solutions, one can study the behavior of the second time derivative of the m ean-square radius, as in Refs. [4,28,29]. To obtain the second time derivative of the m ean-square radius, we use the V irial approach, with  $H = (q_{zz} + V)$  and  $V = (1 + (z)) \hat{f}_{z}$

U sing our solitonic ansatz, when a ! 0, we reach the critical limit,  $_{c} = 8 = (3n_{0})$  that was obtained before.




FIG.3. Numerical simulations of the full GP equation, showing the dependence of  $n_0$ , related to the number of atom s N (top frame), and nalvelocity  $v_{\rm f}$  (bottom frame), with respect to the initial velocity  $v_{\rm i}$ . The results of both frames are shown for di erent values of , as indicated inside the top frame. As shown,  $n_0=4$  was considered the initial value (for  $v_{\rm i}=0)$  of  $n_0$ . All the quantities are dimensionless.

W e have also investigated the dynam ics of the m atter soliton interacting with inhom ogeneity, studying di erent regim es of propagation for several values of . In F ig. 3, we present the results of num erical simulations for the nal velocity ( $v_f$ ) versus the initial velocity ( $v_i$ ) of the soliton, considering di erent strengths for the inhom ogeneity. In the present and next num erical approaches, we have considered  $n_0 = 4$ , for the general1D NLSE with nonlinear in purity, as one can easily rescale the obtained data to a value of  $n_0$  sm aller than 2.7, in agreem ent with the quasi-1D results.

As observed in Fig. 3, exists a region for the velocities where the attractive nonlinear in purity relects the soliton. In the model involving the constant width approximation, this region corresponds to the trapped soliton. The numerical results show that always exists one window corresponding to the relection of the soliton. By increasing , this window is shifted to larger initial velocities. From the variation of the number N, with respect to the initial velocity  $v_i$  (top frame of Fig.3), one can also observe strong wave emissions by soliton, when increases and tends to the critical value (see also [28]). This picture reminds the picture of the collapse in 2D BEC with attractive interaction. We note that, by considering the interaction of sine-G ordon kink with attractive defect, many window swere found, corresponding to a resonance with localm ode (see [16]).




FIG.4. For a xed value of = 0.4, it is shown the time evolution of the center-ofm ass position, considering di erent values of the initial velocity, as given inside the frame. The results were obtained by using full numerical solution of the GP equation, considering  $n_0 = 4$ . All the quantities are in dimensionless units.

In order to compare with the results given in the lower frame of Fig.3, we present in Fig. 4, for a xed value of = 0.4, full num erical calculation of the time evolution of the center-ofm ass position, considering di erent values of the initial velocity. It is clearly seen the repulsive trajectories for  $v_i$  corresponding to the case that the e ective particle is trapped.




FIG.5. Final velocity  $v_{\rm f}$  versus the initial velocity  $v_{\rm i}$ , for di erent values of , as indicated inside the frame, using  $n_0=4$ . The results were obtained from numerical simulations of the variational equations given in Eq. (17). All the quantities are in dimensionless units.

By considering num erical sim ulations of the variational equations (18) we found, qualitatively, the same behavior as the one observed in the full solution of the GP equation (see Figs. 3 and 5). In Fig. 5, we show the behavior of the nal velocity as a function of the initial velocity, for di erent values of . In particular, the variational equations also show the existence of one window when the soliton is rejected by the impurity. When increases the window moves in the right direction, reducing the width.

In distinction, on the GP equation, the variational equations shows a more complicated (probably chaotic) dynam ics near the points where the regime of reection starts or nishes. In this region, we also can see the m ore rare events with the transm ission of soliton through the impurity. This observation resembles the phenomena observed at the interaction of the sine-G ordon equation kink with a local defect. The system of ODE's (two mode m odel) has a sim ilar structure as our equation (18), show ing chaotic behavior, leading always to a nite time for the period of the soliton trapping. This phenom enon is due to stochastic instabilities inherent for this dynam ical system. The reason for this phenom enon is that the nite dimensional system, like the one given by Eq. (18), cannot take into account the soliton radiation, that interacts with the defect. The e ect of the radiation leads to the appearance of the dam ping in Eq. (18), that changes the long-time behavior of the system . In particular, the radiative damping can lead to the long-time regular dynam ics [17].

For a m one detailed investigation of the interaction between m atter wave soliton with the nonlinear impurity m ode, excited on the inhom ogeneity, we need to develop collective coordinate approach like the one considered in R ef. [18]. This will be considered in future.

## V.CONCLUSION

In this work, we have investigated the dynamics of bright matter wave soliton, in BEC systems with cigar type geometry and attractive interactions. The inhom ogeneities can appeared in BEC due to the existence of regions in space with di erent values of the two-body atom ic scattering length  $a_s$ . These variations can be

achieved using, for example, the Feschbach resonances. Two kind of inhom ogeneities in the spatial distribution of  $a_s$  have been studied: local point-like and jump type. The rst type has been modeled by a D irac-delta function, that will result in a modulation of the nonlinear term in the GP equation, corresponding to the so called nonlinear impurity in the nonlinear Schrodinger equation. The second type corresponds to a sudden variation of the nonlinear term in GP equation. It correspond to the case that the BEC system is divided in two parts with di erent values of  $a_s$  (see discussion of recent experiment in Ref. [13]).

The present investigation of the local variation in space of the atom ic scattering length shows that di erent regim es of the soliton interaction with the nonlinear im purity are possible. It is observed trapping, re ection and transmission regimes. The most interesting e ect is the re ection of the atom ic soliton by the attractive nonlinear im purity. We have also veri ed the occurrence of collapse of the soliton on the attractive im purity, when the strength of the im purity (or the initial number of atom s) exceeds a certain critical value. This e ect in quasi-ID BEC resembles the phenom ena that occurs in 2D BEC.U sing the tim e-dependent variational approach we have described successfully both phenom ena.

For the case of a sudden variation of the two-body scattering length, represented by a nonlinear jump inhom ogeneity, using analogy with a nonlinear optical problem [26], we presented the condition for the multiple bright m atter soliton generation.

Finally, we would like to emphasize that the problem we have studied in the present work has important application for the control of parameters of bright atom ic matter solitons and for the generation of solitons in quasi 1D BEC.
