# Hard-sphere lim it of soft-sphere model for granular materials:

Stiness dependence of steady granular ow

# Abstract

D ynam ical behavior of steady granular ow is investigated numerically in the inelastic hard sphere lim it of the soft sphere model. We nd distinctively dierent limiting behaviors for the two ow regimes, i.e., the collisional ow and the frictional ow. In the collisional ow, the hard sphere limit is straightforward; the number of collisions per particle per unit time converges to a nite value and the total contact time fraction with other particles goes to zero. For the frictional ow, however, we demonstrate that the collision rate diverges as the power of the particle sti ness so that the time fraction of the multiple contacts remains nite even in the hard sphere limit although the contact time fraction for the binary collisions tends to zero.

#### I. IN TRODUCTION

The interactions between grains in owing granular material are roughly classied into two types; the inpulsive contact (collision) with the momentum exchange and the sustained contact with the transmission of forces [1]. The ow in which the impulsive contact is dominant is called collisional ow, while the ow where the sustained contact dominates is called frictional ow. These two types of ow may be found in a simple geometry such as granular ow on a slope. The grains stay at rest when the inclination angle is too small. If the inclination exceeds a critical angle, the material starts owing frictionally at rst. The ow becomes collisional when the inclination is large enough.

As for the collisional ow of granular material, its dynamics has some analogy with molecular uid, and the kinetic theories based on inelastic binary collisions of particles hold to some extent [2]. On the other hand, the frictional ow is drastically dierent from the molecular uid, and we have little understanding on it. Many models have been proposed for dense granular ows: For example, some models take into account the elect of non-local force transmission which comes from the network of contacting grains [3]. In the experiments, however, it is dicult to specify the nature of sustained contact in the dense ow.

For the simulations of granular dynamics, the following two models have been commonly used, i.e. the inelastic hard sphere model and the soft sphere model.

In the inelastic hard sphere model, the particles are rigid and the collisions are thus instantaneous, therefore its dynam ics can be de ned through a few param eters that characterize a binary collision because there are no many-body collisions [4]. The model is simple and there are very e cient algorithms to simulate it [5], but it describes basically only the collisional ow [6] because the sustained contact is not allowed. It is also known that the system often encounters what is called the inelastic collapse [7, 8, 9, 10]; the in nite num ber of collisions take place among a small num ber of particles in a nite time, thus the dynam ics cannot be continued beyond that point without additional assumption.

On the other hand, in the soft sphere m odel, that is sometimes called the discrete element m ethod (DEM) in the granular community [4, 11], the particles overlap during collision and the dynamics is dened through the forces acting on the colliding particles. Collision takes nite time, and not only binary collision but also many-body collision and sustained contact

between particles are possible, therefore, both the collisional and the frictional ow s m ay realize in the model. M any researches have been done on granular ow down a slope using the DEM in both the collisional regime and the frictional regime [12, 13, 14].

In actual simulations, however, the sti ness constants used in the soft sphere model are usually much smaller than the one appropriate for realmaterial such as steel or glass ball [15] because of numerical disculty. Therefore, some part of sustained contact in simulations may be decomposed into binary collisions if sti er particles are used. It is also not clear that the frictional force in the sustained contact may be described by the same forces with the one suitable for the collisional events.

It is, therefore, in portant to exam ine how the system behaviorm ay change as the sti ness constant increases in the soft sphere model, or in other words, how the soft sphere model converges to the inelastic hard sphere model in the in nite sti ness limit. In this paper, we present the results of numerical simulations of the granular ow using the soft sphere model, and investigate the system behavior when we change the sti ness constant system atically with keeping the resulting restitution constant unchanged.

In Sec. II, we brie y sum marize an inelastic hard sphere model that is used for collisional granular ows. Then we introduce a simple soft sphere model for granular material and discuss how we take the hard sphere limit keeping the restitution coe cient constant. In Sec. III, the simulation results are shown. At rst, the stiness dependence of the steady state of a single particle rolling down a slope is presented to see how the inelastic collapse appears in the hard sphere limit. The collisional ow and the frictional ow are exam ined. We nd that the interactions between particles in the collisional ow smoothly converge to binary collisions of inelastic hard spheres, while those in frictional ow shows non-trivial behavior; the behavior is also di erent from the \inelastic collapse" in the single particle system. The sum mary and the discussion are given in Sec. IV.

# II. HARD SPHERE MODEL AND SOFT SPHERE MODEL

In this section, we introduce the hard sphere m odel and the soft sphere m odel for granular m aterial. For sim plicity, we consider a two dimensional system and grains are m odeled by two dimensional disks.

A fter showing the correspondence of parameters in the soft sphere model to those of the

hard sphere m odel, we brie y sum m arize the phenom enon called inelastic collapse, which is the singular behavior in the inelastic hard sphere system. At the last part of this section, we discuss the limiting behavior of the soft sphere m odel that corresponds to the inelastic collapse of the hard sphere m odel.

## A. Inelastic hard sphere model

In hard sphere models, collisions between particles or between a particle and a wall are considered to happen instantaneously, and its dynam ics is dened by the binary collision rule. We consider the collision rule in terms of the norm all and tangential restitution coecients and the sliding friction [6, 16].

Let us consider a collision between the two spheres i and j of the diam eters  $_{i}$  and  $_{j}$ and the masses m<sub>i</sub> and m<sub>j</sub> at the contact positions r<sub>i</sub> and r<sub>j</sub>, respectively. Prior to the collision, the disks have velocities c<sub>i</sub> and c<sub>j</sub> and angular velocities !<sub>i</sub> and !<sub>j</sub>. Then the relative velocity of the point of contact v<sub>ij</sub> is given by

where the norm alvector  $n = r_{ij} = jr_{ij}j = (n_x; n_y; 0)$  with  $r_{ij} = r_i - r_j$ .

If  $v_{ij}^0$  denotes the post-collisional relative velocity, the collision rule for norm aldirection is

where e is the norm all restitution coe cient with 0 e 1.

In the case without sliding, the collision rule in the tangential direction is given by

where is the tangential restitution coe cient with 1 1. The sliding is taken into account so that the tangential component of impulse does not exceed jn J jwith the C oulomb friction coe cient, where J is the momentum change of the particle i through the collision. Namely, when the momentum change of the particle i through the collision rules (2) and (3) is  $J^{nos}$ , then (n  $v_{ij}^0$ ) is determined so that

is satis ed. The detailed description of the rule is given in Refs. [6, 16].

#### B. Soft sphere m odel: DEM

The DEM, or the soft sphere model [4, 11], is often used to simulate the dynamics of granular materials. In the present work, we adopt the two dimensional one with the linear elastic force and dissipation. When the two disks i and j at positions  $r_i$  and  $r_j$  with velocities  $c_i$  and  $c_j$  and angular velocities  $!_i$  and  $!_j$  are in contact, the force acting on the particle i from the particle j is calculated as follows: The norm all velocity  $v_n$ , the tangential velocity  $v_t$ , and the tangential displacement  $u_t$  are given by

where  $v_{ij}$  is given in Eq. (1), and  $t = (n_y; n_x; 0)$ . Here,  $t_0$  is the time when the two particles start to be in contact. Then the norm all force  $F_{ij}^n$  and the tangential force  $F_{ij}^t$  acting on the particle i from the particle j are given by

where  $k_n$  and  $k_t$  are the elastic constants, n and t are the damping parameters, is the Coulomb friction coe cient for sliding, and  $M = m_i m_j = (m_i + m_j)$  is the reduced mass.

# C. Hard sphere lim it of soft sphere model

W hen we adopt the linear dependence of the elastic and viscous force on the overlap and the norm all relative velocity as in Eq. (7), we can calculate the duration of contact  $_{\rm c}$  and the restitution coecient for a norm all binary collision e [17]; they are given by

N eglecting the sliding friction and the variation of n during the contact, the half period of the oscillation in the tangential displacement  $u_t$  is estimated as [17]

for the two dimensional disks with the moment of inertia  $I_i = m_i \sum_{i=1}^{2} = 8$ . Here we choose the parameters  $k_t$  and  $t_t$  so that the relation  $s = c_r$  or,

Equations (10) and (11) can be rewritten as

U sing Eqs. (13)-(16), we can take the inelastic hard sphere lim it of this model for given e and by taking the  $k_n ! 1$  lim it; <sub>n</sub>, <sub>t</sub>, and  $k_t$  are given by Eqs. (15), (14), and (13), and the duration time of collision <sub>c</sub> goes to zero as Eq. (16).

# D. Inelastic collapse

It is well known that the inelastic hard sphere system can undergo the inelastic collapse, i.e., the phenom enon where in nite collisions take place within a nite period of time [7]. The simplest example is the vertical bouncing motion of a ball under gravity, but it has been shown that the inelastic collapse also occurs in higher dimensional systems without gravity [7, 8, 9, 10].

The inelastic collapse never occurs in the soft sphere model because of the nite length of the collision time. However, it is worth to discuss what will happen in the soft sphere model in the simple situation where the inelastic collapse occurs in the hard sphere model. First, let us consider the vertical bouncing motion of a soft ball under gravity. We assume the same force law between the ball and the oor as in Eqs. (7) and (8), except that we replace 2M by the mass of the ball. While the ball and the oor are in contact, the equation of motion for the overlap of the ball and the oor, z, is given by

with the acceleration of gravity g, where the dots represent the time derivatives. One can show that, if the impact velocity  $v_i$  is below a critical value  $v_c$ , which is  $O(1 = \frac{p}{k_n})$  for large enough  $k_n$ , the ball stays in contact with the oor; for  $v_i = v_c$ , the restitution coe cient  $e_w$  can be considered as a constant. Therefore, for a given initial impact velocity  $v_0$ , the number of necessary collisions  $n_c$  for the ball to stay in contact with the oor is roughly estimated by the condition  $e_w^{n_c}v_0 = v_c$ , namely,  $n_c = \ln(v_c = v_0) = \ln e_w$ . Because  $v_c = 1 = \frac{p}{k_n}$  for large  $k_n$ ,  $n_c$  behaves as

in the hard sphere lim it. Thus  $n_c$  diverges logarithm ically when  $k_n \mid 1$ , which corresponds to the inelastic collapse due to gravity.

In the case w ithout gravity, the inelastic collapse results in the \m any-body collision" in the soft sphere m odel. For example, we consider three soft spheres in one dimension and assume that the binary collision can be approximated by the collision law with a constant restitution coe cient. In the situation where a particle goes back and forth between the two particles approaching each other, the inelastic collapse m ay take place in the hard sphere m odel [8]; three balls lose relative velocity com pletely in the limit of in nite collisions. In the soft sphere m odel, however, when the interval between two collisions becomes smaller than the duration of contact  $_{\rm c}$ , three balls are in contact at the same time, namely, the three body collision occurs; then they will y apart. The number of collisions before the three body collision w ill also diverge logarithm ically in the hard sphere limit because  $_{\rm c} / 1=^{\rm p} \overline{\rm k_n}$ .

On the other hand, one should note that a many-body collision in the soft sphere model does not necessarily result in the inelastic collapse in the hard sphere limit. A ctually, in most of the cases, a many-body collision will be decomposed into a set of binary collisions in the hard sphere limit. In this section, we investigate the sti ness dependence of granular material on a slope in the following three situations: (i) a single particle rolling down a slope, (ii) the dilute collisional ow, and (iii) the dense frictional ow. We focus on the steady state in each situation and compare the simulation data with changing  $k_n$  system atically. The particles are monodisperse in (ii), while they are polydisperse in (iii) in order to avoid crystallization.

In the simulations, the parameters have been chosen to give e = 0.7, = 0.5 in the hard sphere limit. All values are non-dimensionalized by the length unit, the mass unit m, and the time unit P = ---. Here, is the diameter of the largest particle in the system and m is the mass of that particle. The second order A dam s-B ashforth m ethod and the trapezoidal nule are used to integrate the equations for the velocity and the position, respectively [18]. Note that the time step for integration, dt, needs to be adjusted as  $_{c}$  becomes smaller. All the data presented in the paper are results with dt = min ( $_{c}=100;10^{4}$ ). We have commend that the results do not change for dt  $_{c}=100$  by calculating also with dt =  $_{c}=50$  and dt =  $_{c}=200$  in the case of the single particle.

## A. A single particle rolling down a bum py slope

Let us ist consider a single particle rolling down a bum py slope. It is known that the particle shows the steady motion for a certain range of the inclination angle [19]. In the simulations, we make the boundary rough by attaching the same particles with the rolling one to the slope with the spacing 0:002 (see Fig. 1). For the chosen parameters with the normal sti ness  $k_n = 2^{1}$  10, the range of for which steady motion is realized is 0:11. sin . 0:14 [13]. Here we is the inclination angle to sin = 0:13. Figure 2 shows the time evolution of the velocity in the y direction,  $v_y$ , with  $k_n = 2^{1}$  10 (solid line) and  $k_n = 2^{17}$  10 (dashed line). It is shown that  $v_y$  behaves periodically; this period (t 4) corresponds to the period for the particle to get past one particle at the oor. The period hardly depends on the sti ness.

In Fig. 3 (a), the  $k_n$  dependence of the time averaged kinetic energy E is shown. It is shown that the energy is an increasing function of  $1=k_n$  in the softer region ( $1=k_n \& 10^7$ ), but no systematic  $1=k_n$  dependence of E exists for  $1=k_n$ . 10<sup>7</sup>. The average collision

rate (number of collisions per unit time) between the slope and the particle,  $N_w$ , shows logarithm ic dependence on  $1=k_n$  in the whole region (Fig. 3 (b)). From Fig. 3 (c), we also nd that the average contact time fraction with the slope,  $t_w$ , is a decreasing function of  $k_n$  in the soft region, but it seems to approach a constant value for large enough  $k_n$ .

The logarithm ic  $k_n$  dependences of  $N_w$  and the constant  $t_w$  in large  $k_n$  region agree with our previous analysis of \inelastic collapse under gravity" in the soft sphere m odel in Section IID. The motion of the particle in one period is as follows; when the particle comes to a bump (a particle attached to the slope), the particle jumps up, bounces on the bump m any times, bees the relative velocity, and nally rolls down keeping in contact with the bump. Therefore, the contact time fraction has a nite value even in the hard sphere limit due to the rolling motion at the last part.  $N_w$  increases logarithm ically in the hard sphere limit as has been expected from Eq. (18).

## B. Collisional ow

Next we consider the steady state of the collisional ow. The system considered is shown in Fig. 4. The particles are monodisperse, and the slope is made rough as in the single particle case. The periodic boundary condition is adopted in the ow direction (x direction). The length of the slope is L = 50.1 and the number of the particles attached to the slope is 50. The number of owing particles is also 50, namely, the number of the particles per unit length along the slope is about 1. The inclination angle is set to be sin = 0.45. The initial con guration of particles is the row of 50 particles at rest with regular spacing in the x-direction, but each particle is at random height in the y-direction. A fter a short initial transient, if the total kinetic energy uctuates around a certain value, we consider it as the steady ow. All the data were taken in this regime and averaged over the time period of 1500.

As can be seen in the snapshot, Fig. 4, the particles bounce and the number of particles in contact is very small. In Fig. 5 (a), the averaged kinetic energy per one particle, E, is shown. Though E becomes larger as the particles become softer in  $1=k_n \& 10^5$ , the system atic dependence of E on  $k_n$  disappears for large enough  $k_n$  ( $1=k_n . 10^6$ ) [20]. The y-dependence of the average number density and the ow speed in this region are also shown in Fig. 6 (a) and (b).

In Fig. 5 (b), the average collision rates between particles, N<sub>c</sub> (led circles), and between particles and the slope, N<sub>w</sub> (open circles), per particle are plotted vs  $1=k_n$ . Both of them stay roughly constant in the region where E is almost constant,  $1=k_n$ . 10<sup>6</sup>. On the other hand, the average time fractions during which a particle is in contact with other particles, t<sub>c</sub> (led circles), and in contact with the slope, t<sub>w</sub> (open circles), decrease system atically as  $k_n$  increases as shown in Fig. 5 (c). Both the solid and the dashed lines are proportional to  $1=\frac{p}{k_n}$ , namely, t<sub>c</sub> decreases in the same manner as <sub>c</sub> in Eq. (16). A ctually, the collision time fractions t<sub>c</sub> and t<sub>w</sub> converge to N<sub>c c</sub> and N<sub>w w</sub> (w is the duration of a norm alcollision of a particle and the oor [21]), respectively, in the hard sphere limit. The di erences t<sub>c</sub> N<sub>c c</sub> and t<sub>w</sub> N<sub>w w</sub> are plotted in Fig. 5 (d) to show that they go to zero very rapidly upon increasing k<sub>n</sub>. This means that the interactions of the soft sphere model in the collisional ow regime converge to those of the inelastic hard sphere model with binary collisions.

If we bok carefully, however, in the large  $k_n$  region in Fig. 5 (c), we can see slight deviation of  $t_w$  from the dashed lines; it decreases slower than  $1 = \frac{p}{k_n}$ . This tendency may indicate that  $t_w$  remains nite in the hard sphere limit: A ctually, in the event-driven simulation of the hard sphere model, we always found the inelastic collapse as long as the restitution constant between a particle and the oor is less than 1. This suggests that N<sub>w</sub> should diverge and  $t_w$  should remain nite in the hard sphere limit because of the inelastic collapse due to gravity. The slight deviation of  $t_w$  from the dashed line in Fig. 5 (c) may be a symptom of it, while we cannot see the logarithm ic divergence in N<sub>w</sub>.

#### C. Frictional ow

Now we study the steady state of the dense frictional ow. We adopted the at boundary with slope length L = 10.02 and imposed the periodic boundary condition in the ow direction. In order to avoid crystallization, we used the polydisperse particles with the uniform distribution of diameter from 0.8 to 1.0. The number of particles in the system is 100. The inclination angle is set to be sin = 0.20 and the initial condition is given in the sim ilar way with the collisional ow. The ten rows of ten particles with regular spacing in the x-direction are at rest with large enough spacings between rows in the y-direction so that particles do not overlap; only the particles in the top row are at random heights in y-direction.

It turns out that the steady state is not unique and uctuation is large. Depending on the initial conditions, the particles may ow with a dimensional value of average kinetic energy, or in some cases, the whole system stops. We presume that this is mainly because the system is not large enough: Grains form a layer structure as in Fig. 7, and the ow velocity strongly depends on the con guration of particles in the bottom layer. The time evolutions of the kinetic energy per particle, E (t), of three samples with dimension gurations in the bottom layer are shown in Fig 8. Sample 1 shows stable behavior while sample 2 eventually stops after running with lower energy for some time. Sample 3 shows larger uctuation with higher energy; the sudden change of E (t) in sample 3 results from the change in the con guration of the bottom layer. This large uctuation should be averaged out if we could simulate large enough system for long enough time, but the amount of computation is too large especially for the system with sti particles.

In order to make meaningful comparison out of these largely uctuating data with a variety of behaviors, we select simulation sequences that come from similar owing behaviors in the following way. First, we de ne the steady part of the time sequence in each of the samples as the part where the width of the energy uctuations is smaller than 0.45 over the time period longer than 500. Second, we exclude the data whose averaged energy is out of the range [0.4, 0.8] [22].

M any of the excluded data by this criterion show quite di erent owing behaviors. We use only the data selected from this criterion to calculate time averages of physical quantities.

In the snapshot of the frictional ow, Fig. 7, most of the particles seem to be in contact with each other and form a layer structure. The y-dependence of the average density and the ow speed are shown in Figs. 9 (a) and (b), respectively. We can see that the relative motion between layers is largest at the bottom and very small in the bulk. The sti ness dependence of the average kinetic energy E is shown in Fig. 10 (a); the data are scattered due to the non-uniqueness of the steady state.

Nevertheless, the average collision rates show system atic dependence as shown in Fig. 10 (b). Here, the de nition of N<sub>c</sub> (t<sub>c</sub>) is the same as that for the collisional ow, namely, it is the average collision rate (contact time fraction) between particles per particle in the system . On the other hand, N<sub>w</sub> (t<sub>w</sub>) is de ned di erently; it is the collision rate (the contact time fraction) between the particles and the slope per particle in the bottom layer, because other particles never touch the slope.

In Fig. 10 (b), we can see that  $N_c$  (led circles) and  $N_w$  (open circles) increase very rapidly as  $k_n$  becomes larger: they diverge as a power of  $k_n$ . This is quite dimensional the behavior in the collisional ow in which they are almost constant. Furthermore, this increase is faster than the logarithm ic divergence found in the single particle case (see Fig. 3 (b)).

The contact time fractions,  $t_c$  (lled circles) and  $t_w$  (open circles), decrease as shown in Fig. 10 (c). The main reason why  $t_c$  and  $t_w$  decrease is that  $_c$  and  $_w$  decrease faster than  $N_c$  and  $N_w$ , namely, the contact time fractions estimated from the duration of a binary collision,  $N_{c}$  and  $N_w$ , continue to decrease. A ctually, the decrease of the contact time fraction and the increase of the collision rate are natural because a longer multiple contact breaks up into shorter binary contacts as the particles become estime.

These contact time fractions,  $t_c$  and  $t_w$ , however, do not converge to  $N_{cc}$  and  $N_{ww}$ , respectively. As shown in Fig. 10 (d),  $t_c = N_{cc}$  (led circles) and  $t_w = N_{ww}$  (open circles) are very large as compared to those in the collisional ow, even in the still est region. The comparison of this with the rapid convergence in the collisional ow regime (Fig. 5 (d)) indicates that there remains nite multiple contact time in the hard sphere limit and the interaction in the frictional ow can never be considered as many, or even in nite, instantaneous binary collisions. The particles experience the lasting multiple contact even in the hard sphere limit.

## IV. SUMMARY AND DISCUSSION

The inelastic hard sphere lim it of granular ow has been investigated numerically in the steady states of (i) a single particle rolling down the slope, (ii) the dilute collisional ow, and (iii) the dense frictional ow. In (i), it has been found that the \inelastic collapse" between the particle and the slope occurs in the hard sphere lim it due to gravity, and the contact time fraction between the particle and the slope remains nite. In (ii), the collision rates  $N_c$  and  $N_w$  are almost constant when particles are still enough. The contact time fraction between particles  $t_c$  approaches zero as  $k_n$  increase in the same manner with the duration of contact for binary collision, c. This means that the interaction between particles in the hard sphere lim it can be expressed by binary collisions in the inelastic hard sphere model. On the other hand, the decrease in  $t_w$  is slightly slower than  $1=\frac{p}{k_n}$  in the harder region,

which can be a sign of the inelastic collapse between a particle and the slope.

In the case of the frictional ow (iii), the situation is not simple: A lthough the contact time fractions  $t_c$  and  $t_w$  decrease upon increasing  $k_n$ , the collision rates  $N_c$  and  $N_w$  increase as a power of  $k_n$ , which is faster than the logarithm ic divergence found in the single particle case (i). The origin of this power divergence of collision rate does not seem to be simple because it is a property of the steady state, not a particular dynam ical trajectory of the system.

The multiple contact time fraction may be estimated by  $t_c = N_c c$  and  $t_w = N_w c$ . They were found to be quite large compared to those for the collisional ow, and seems to remain nite even in the in nite sti ness limit: This suggests that the interaction in the frictional ow can never be considered as in nite number of binary collisions. Even in the hard sphere limit, particles experience the lasting multiple contact.

The non-negligible fraction of multiple contact in the hard sphere limit implies the existence of the network of contacting grains even though they are owing. The models of dense ows should consider the elect of this lasting contacts.

Here we have investigated only the two cases, i.e., the collisional ow and the frictional ow. The system should undergo the transition between the two ows if we change continuously the parameters such as the inclination angle, the roughness of the slope, or the density of particles. It is interesting to investigate how the transition occurs by looking at the quantities measured in this paper, because their sti ness dependences are qualitatively di erent in the two ows.

They performed the simulations with three dierent values of sti ness and found the dierent behaviors. The comparison with the present results is not simple because of the dierent set up, but if we normalize their parameter of normal sti ness with the particle mass, the diameter, and the acceleration of gravity, then

their values extend over the range where  $E \$  depends on  $k_n \$ in our simulations.

The force law for the at boundary that replace 2M in Eq. (7) by the mass of the colliding particle m gives the same duration of contact with the above one for the norm alcollision.




FIG.1: A snapshot of a single ball rolling down a rough slope.




FIG.2: T in e evolution of  $v_y$  with  $k_n = 2^{1} - 10^{5}$  (solid line) and  $2^{17} - 10^{5}$  (dashed line).




FIG.3: The sti ness dependence of (a) the time averaged kinetic energy of the particle E , (b) the collision rate between the slope and the particle N  $_{\rm w}$ , and (c) the contact time fraction between the slope and the particle t $_{\rm w}$ .




FIG.4: A snapshot of the dilute collisional ow.




FIG.5: The sti ness dependences of (a) the averaged kinetic energy per one particle E, (b) the averaged collision rates between particles  $N_c$  (led circles) and between particles and the oor  $N_w$  (open circles), (c) the averaged contact time fractions between particles  $t_c$  (led circles) and between particles and the oor  $t_w$  (open circles), (d) the estimated multiple contact time fractions,  $t_c N_{cc}$  (led circles) and  $t_w N_{ww}$  (open circles). The solid and the dashed lines in (c) are proportional to  $1=\frac{p}{k_n}$ .




FIG.6: The number density prole (a) and the velocity prole (b) of the collisional ow.




FIG.7: A snapshot of the dense frictional ow.




FIG. 8: T in e evolution of the kinetic energy per particle of three samples (sample 1: red solid line, sample 2: green dashed line, sample 3: blue dotted line). (b) is the magni cation of (a). Sample 1 with  $k_n = 2^{1}$  10<sup>5</sup> shows steady behavior within the threshold. Sample 2 and 3 are with  $k_n = 2^{7}$  10<sup>5</sup>. Sample 2 shows steady behavior for a while but nally stops. E (t) of sample 3 shoots up suddenly at t 1300 when one of the particles in the bottom layer runs on other particles.




FIG.9: The density (a) and velocity (b) pro les of the frictional ow .




FIG.10: The sti ness dependences of (a) the averaged kinetic energy E, (b) the averaged collision rates between particles N<sub>c</sub> (lled circles) and between particles and the oor N<sub>w</sub> (open circles), (c) the averaged contact time fractions between particles t<sub>c</sub> (lled circles) and between particles and the oor t<sub>w</sub> (open circles), and (d) the estimated multiple contact time fractions, t<sub>c</sub> N<sub>cc</sub> (lled circles) and t<sub>w</sub> N<sub>ww</sub> (open circles). In (b) the solid line proportional to  $k_n^{0.4}$  is shown for the guide of the eyes.
