## Bose-E instein condensates with attractive interactions on a ring

Considering an electively attractive quasi-one-dimensional Bose-E instein condensate of atom s conned in a toroidal trap, we not that the system undergoes a phase transition from a uniform to a localized state, as the magnitude of the coupling constant increases. Both the mean-eld approximation, as well as a diagonalization scheme are used to attack the problem.

E ectively attractive Bose-Einstein condensates have concentrated a lot of attention recently, in connection with the experimental formation of bright solitons in them [1,2]. More speci cally, in the experiments of Refs. [1,2], <sup>7</sup>Liatom s were con ned in quasi-one-dimensional traps. W ith use of the Feschbach resonances [3] the effective coupling constant that describes the atom interactions was then tuned and as it became negative { corresponding to an e ective attraction between the atom s { localized states, \bright soliton trains" were observed to form in R ef. [1], while a single bright soliton was observed in Ref. [2]. References [4,5] have exam ined theoretically these systems. In the limit where transversely to the long axis of the trap the gas is in the lowest harm onicoscillator level, the transverse degrees of freedom are frozen out and the system is essentially one-dimensional [6].

M otivated by these developments, we study here an e ectively attractive one-dimensionalBoseE instein condensate of atom s conned in a toroidal trap. In a recent theoretical paper K anamoto, Saito, and U eda have investigated the ground state and the low-lying excited states of such a system [5] (see also Ref. [7] for a detailed discussion of this problem). As shown, the G ross-P itaevskii mean-eld theory predicts a quantum phase transition between a uniform state and a localized state as the absolute value of the strength of the interaction inreases. Furthermore, numerical diagonalization of the H am iltonian for a nite number of bosons shows that the transition in this case is smeared out, as expected in nite system s.

In our study we exam ine the same problem using different techniques. Initially we use the mean-eld approxim ation with a properly chosen variational wavefunction to study the phase transition and the order parameter in the two phases. Then, working in the same truncated space we use a Bogoliubov transform ation to diagonalize the H am iltonian. H aving diagonalized the problem, we exam ine the lowest state of the system, the low-lying excited states, as well as the depletion of the condensate at the region of the transition. Our results are consistent with those of R ef. [5].

Let us therefore consider a Bose-E instein condensate in a toroidal trap. Following Ref. [5], we assume that the system contains N bosons, that the radius of the torus is R and its cross section is  $S = r^2$ , with r R. If () is the eld operator, the H am iltonian is

where  $U_0 = 8$  aR =S, with a being the scattering length for elastic atom -atom collisions, and is the azim uthal angle. Here the length is measured in units of R and the energy in units of  $h^2$ =2m R<sup>2</sup>, with m being the atom mass.

Let us start with the m ean-eld approach. W ithin this approximation the system is described by a single wave-function, the order parameter (r), and the m any-body state is the product  $_i$  ( $r_i$ ), with i = 1; ...; N, where N is the number of atom s. Therefore this approximation ignores correlations between the atom s and in general it has a higher energy than the exact solution that one can get by diagonalizing the H am iltonian.

In this problem it is natural to work in the basis of plane-wave states  $_1() = e^{j1} = 2$  and according to the analysis of R ef. [5], the order parameter close to the transition consists of the state  $_0$  (the dom inant component), and the states  $_1$ . To get a simple physical picture, we thus develop a variational approach, expanding

() in the basis of the  $_1$  states and keeping only these three components. This is a reasonable assumption, since states with higher values of 1 have higher kinetic energy, and indeed as shown in Ref. [5] this approximation gives qualitatively (but not quantitatively) good results. We thus write

Since the dominant component of is  $_0$ , therefore  $j_0j$   $j_1j$  and  $j_0j$   $j_1j$ . Because of the symmetry of the problem,  $j_2 \ _1 j = j_2 \ _1 j$  which also guarantees that the total angular momentum of is zero, as it should. The normalization condition in poses the further constraint  $j_2 \ _1 f + j_0 f + j_1 f = 1$ .

To proceed, we express the energy per particle  $_0$  in terms of the coe cients  $c_i$ , which are then determined by minimizing  $_0$  with respect to them [8],

where = N U<sub>0</sub>=(2) = 4N aR=S is essentially the ratio between the interaction energy and the kinetic energy. If  $c_j = jc_j je^{i_j}$ , then the last two terms in Eq.(3) are equal to  $4jc_0 f jc_1 f \cos(1 + 1 2_0)$ . To minimize 0 one has to choose  $1 + 1 2_0 = 0$ . Since  $jc_0 f = 1 2jc_1 f$ ,

Here =2 is the interaction energy per particle of the uniform state. The above equation in plies that for >  $_{\rm cr}$ , where  $_{\rm cr} = 1=2$ , them inimum of the energy occurs for  $c_0 = 1$ , and  $c_1 = c_1 = 0$ . In this regime the density of the system is uniform and the energy per particle is =2. On the other hand, if <  $_{\rm cr}$ ,  $_0$  ( $\dot{p}_1$ ) is like a mexican hat, and its minimum occurs for all three  $c_i \in 0$ , the energy per particle is lower than =2 and the cloud develops a non-uniform density. Our approach implies that the transition takes place for the same critical value of as in the exact solution of the mean-eld approach [5,7]. It is interesting that within our scheme including more basis states in the order parameter does not a ect  $_{\rm cr}$ . More precisely, including the states with jlj m,

the quadratic term s in the energy have the form

From the above expression it is obvious that  $_{\rm cr}$  is always 1=2, essentially because of the high kinetic energy of

atom s in states with high values of 1, that scales as 1<sup>2</sup>. Let us now exam ine the non-uniform state when <




FIG.1. The magnitude of the trial order parameter , Eq.(2), calculated within the mean-eld approach, with the coe cients  $j_{c,i}$  j given by Eq.(6). The phases of  $c_i$  are chosen to be equal. One phase is arbitrary, the other one is chosen so that the energy is minimum, and the third one is free (re ecting the rotational invariance of the problem) and it has been chosen so that the maximum of the wavefunction is at = 0. The straight line corresponds to a uniform condensate, with  $> c_r$ , the less localized state to = 0.51, and the more localized state to = 0.55.

Figure 1 shows the corresponding order parameter. In addition

1=2 , where ! 0 and > 0, the above equation implies that  $_0 =$ 1=4 =2 8=7, which should be compared with the exact mean-eld solution [5], <sup>ex</sup> 1 = 4=2 2. Therefore our trial wavefunction reproduces the linear correction, but it fails in the quadratic term and it has higher energy. This is not a surprise, how ever, since our approach is variational and it does not necessarily capture all these features. Including m ore basis states, one can im prove the wavefunction and the energy to the desired order in .

Turning to our alternative approach of the problem, where we will go beyond the mean-eld approximation

and we will calculate term s in the energy of order 1=N, let us expand the eld operator  $\hat{}$ ,

where  $c_1$  is now the annihilation operator of an atom with angularm om entum 1. A gain we have restricted ourselves to the states with l = 0; 1. In this basis the H am iltonian (1) can be written as

A sim ilar H am iltonian has been studied in Ref. [B] in the context of weakly-interacting B ose-E instein condensates under rotation. D enoting the basis vectors as

where  $N_{pl}$  is the occupancy of the state 1, with  $_1N_1 = N$ , and  $_1 lN_1 = 0$ , it is straightforward to calculate the diagonalm atrix elements,

A ssum ing that the system is close to the transition point, but on the side of the \uniform state" (in the in nite-N lim it of the mean-eld approximation), then m is of order unity and thus m N. In this lim it,

where (N 1)=2 is the total energy of a condensate with uniform density. In Eq.(12) term s of order m<sup>2</sup> have been neglected, and therefore this approach is not valid for  $<_{\rm cr}$  (since m becomes of order N there).

Turning to the o -diagonalm atrix elements,

The above Ham iltonian can be diagonalized with use of a Bogoliubov transformation [9],

Having diagonalized  $\hat{H}$ , we can easily get the occupancy of the l=1 states, which is

Since the occupancy of the  $_1$  states is a smooth and continuous function for any value of when N is nite, and since in the lim it N ! 1,  $hc^{V}{}_{1}c_{1}$  i=N has to equal jc  $_1 j$  [10], a simple geometric construction shows that the value of the function in Eq. Turning to the energy spectrum , in the lowest state  $n_b = n_d = 0$ , and thus the ground state energy is




FIG.2. The energy  $E_0$  ( + N  $^{2=3}$ ) of the lowest state of  $\hat{H}$ , Eq.(28), for N = 100 (top curve), 500 (m iddle curve), and N ! 1 (bottom curve), with = 1:077.

m easured from the energy of the state with uniform density, (N 1)=2. Making use of Eq. (27) we plot the function E<sub>0</sub> ( + N <sup>2=3</sup>) in Fig.2 for N = 100 (top curve), 500 (middle curve), and N ! 1 (bottom curve), with = 1:077. From Eq.(27) we get that to leading order E<sub>0</sub> ( = 1=2) =  $1=2 + (2 \ 1)^{-2} N^{-1=3}$ .

The low -lying excited states of  $\hat{H}$  lie above the low est state by E ( ) ( $n_b + n_d$ ), where




FIG.3. The energy E ( + N  $^{2=3}$ ) of the rst excited state of  $\hat{H}$ , Eq.(29), for N = 100 (top curve), 500 (m iddle curve), and N ! 1 (bottom curve), with = 1:077.

The energy of the lowest excited state is thus E ( ), in agreement with Ref. [5]. Figure 3 shows E ( + N  $^{2=3}$ ) for N = 100 (top curve), 500 (middle curve), and N ! 1 (bottom curve). From Eq.(27), E ( = 1=2) = (2)^{1=2}N  $^{1=3}$ .

Finally the depletion of the condensate N is,




FIG.4. The depletion N ( + N  $^{2=3}$ ) of the condensate, Eq.(30), for N = 100 (bottom curve), 500 (m iddle curve), and N ! 1 (top curve), with = 1:077.

Figure 4 shows N ( + N  $^{2=3}$ ) for N = 100 (bottom curve), 500 (m iddle curve), and N ! 1 (top curve).

According to Eq. (27), to leading order N ( = 1=2) =  $\begin{pmatrix} p \\ -2=4 \end{pmatrix}$   $^{1=2}N^{1=3}$ .

To sum marize, we exam ined a Bose-E instein condensate in a toroidal trap, with an elective attractive interaction between the atom s. U sing a variational approach and working within an appropriately chosen set of basis states, we demonstrated that within the mean-eld approximation for a strong enough coupling constant a condensate of uniform density becomes unstable against the formation of a localized state. Going beyond the mean-

eld approximation, we diagonalized the Hamiltonian in the same truncated space just above the transition and we calculated the energy of the low -lying states, as well as the depletion of the condensate. While the energy in this case is lower than that of the mean-eld, the two methods give the same results in the N ! 1 limit, assumed implicitly in mean-eld.
