## O ceanic coastline and super-universality of percolation clusters.

New fractal subset of a rough surface, the \oceanic coastline", is de ned. For random G aussian surfaces with negative H urst exponent H < 0, \oceanic coastlines" are mapped to the percolation clusters of the (correlated) percolation problem. In the case of rough self-a ne surfaces (H  $_{0}$ ), the fractal dimension of the \oceanic coastline" d<sub>c</sub> is calculated numerically as a function of the roughness exponent H (using a novel technique of minimizing nite-size e ects). For H = 0, the result d<sub>c</sub> 1:896 coincides with the analytic value for the percolation problem (91/48), suggesting a super-universality of d<sub>c</sub> for correlated percolation problem.

R andom surfaces are common objects which can be found in various situations; good examples are deposited m etal lms [1], fractured surfaces [2, 3], stream functions of two-dimensional (2D) turbulent ows [4] etc. For various applications, it is important to know the statistical geometrical properties (statistical topography) of such surfaces. This problem has been studied with a considerable success, both numerically and analytically [1, 2, 3, 4, 5, 6, 7].

Here we introduce a new scale-invariant measure of such surfaces, the fractal dimension of the \oceanic coastlines". An \oceanic coastline" includes the outer perimeter of the ocean (the \continental coastline"), and the coastline of \oceanic islands", i.e. of such islands, which are adjacent to the largest (possibly in nite) connected

ooded region, when water oods the surface up to a certain level; \oceanic islands" are to be opposed to such islands, which are inside the lakes. Thus, each ooding level de nes its own \oceanic coastline". Here we show that for the so called \m onoscale" random surfaces (with bounded height, cf. [5]), the \oceanic coastlines" can be m apped to the percolation clusters of the correlated percolation problem. For rough surfaces (with unbounded height), the fractal dimension  $d_c$  is calculated num erically, using a noveltechnique of minimizing the nite-size e ects. The results suggest that for the correlated percolation (and hence for the \m onoscale" surfaces), there is a super-universality,  $d_c$  91=48.

A n important characteristic of random surfaces [given by the surface height (x;y) (r) over the twodimensionalplane] is the Hurst exponent H; in the case of G aussian surfaces, all the statistical topography scaling exponents are functions of H. The most intuitive de nition of the Hurst exponent is given by the scaling law of the surface height drop at a distance a jaj (c.f. [8]):

Here angular braces denote averaging over an ensemble (or over the radius vector r); we assume that a is larger than the lower cut-o scale a, and 0 H 1. More general de nition (not bounded to 0 H 1) of the exponent H is given via the power spectrum  $P_k$  [with  $h_{k} = k^{\circ}i = P_k$  (k + k<sup>0</sup>), where k is the Fourier transform of the surface height; c.f. [4]]:

A coording to the value of H , surfaces can be divided into three classes [5]:

(i) H < 0: \monoscale", surface looks like a landscape with hills of approxim ately sam e size, the surface height is bounded;

 (ii) 0 H < 1: \rough", looks like rocky m ountains with sm aller and higher peaks and unbounded height;

(iii) H 1: \sm ooth", the largest scale de nes the slope of the surface.

For \m onoscale" surfaces, there is a simple m apping between statistical topography and percolation problem, developed by Z im an and W einrib [9, 10] [the m in im a of the surface de ne the sites of an irregular percolation lattice; the saddle-points Sij (between i-th and j-th m inin a) correspond to the bonds of the lattice (which can be drawn as the steepest descend paths from S<sub>ii</sub> to the i-th and j-th m in in a); when the surface is odded by water, a bond is declared broken if the corresponding saddle is (\dry"), i.e. above the water level; the water level itself is the counterpart of the bond-keeping probability p]. This mapping can be also applied to the case of rough surfaces. Then, how ever, the lattice problem is no more the (correlated) percolation problem . In particular, there is no critical probability  $p = p_c$  at which the global connectivity disappears. Indeed if we \look far enough", we can

nd as deep (hence also as wide) connected wet region as we want, because the height is unbounded. Therefore, the mapping between the percolation problem and statistical topography allows us to extend various concepts of the percolation problem outside the range of applicability of the very percolation problem.

A straightforward example here is the hull of a percolation cluster: this is dened as the outer perimeter of a percolation cluster. Since the percolation cluster corresponds to a connected wet region, its outer perimeter corresponds to an isoline of the surface. It has been shown that for uncorrelated percolation, its fractal dimension  $d_h = 7=4$  [11]. Note that percolation with weak correlation (with H < 3=4) belongs to the same universality class as the uncorrelated percolation [12]. Meanwhile, for

rough surfaces, d<sub>h</sub> 1:5 0:5H [13], with an exact result  $d_h = 1.5$  for H = 0 [6]. Therefore, for 3=4 < H < 0, one can expect a non-trivial decreasing function  $d_h$  (H ), with  $d_h$  ( 3=4) = 1:75 and  $d_h$  (0) = 1:5. Further, for the percolation problem, one can distinguish between the hull and the unscreened perimeter. This is because the hull is very twisted, and typically, there are narrow \necks" of peninsulas separating \gulfs". We can postulate that these \necks" are too narrow, so that the coastline of the respective peninsulas is \screened"; the rest of the coastline is called \unscreened perimeter". For percolation clusters, the fractal dim ension of the unscreened perim eter is  $d_u = 4=3$  [11]. Since for rough surfaces, narrow \necks" are untypical,  $d_u$  (H) =  $d_h$  (H) for H 0. Com paring  $d_u$  ( 3=4) = 4=3 and  $d_i$  (0) = 1:5, one can expect an increasing function  $d_u$  (H) for 3=4 < H < 0.




FIG. 1: All the bonds of a percolation cluster (black bold lines) are touched from both sides, either by external perim eter (hull, dark grey lines) or internal perim eter (light grey lines).

Now we are ready to turn to the percolation cluster. Each bond of the cluster is touched by the perimeter (hull) from both sides; thus, the length of the net perim eter scales as the cluster size. However, the perimeter touching it can be either external or internal, see Fig. 1. The sum of external and internal perimeters is the sum of (a) the coastline between the \ocean" (= cluster) and the \continent" (= in nite cluster of broken bonds), and (b) the coastline between the \ocean" and the \islands" (= broken bond clusters inside the cluster of undam aged bonds); we call this the \oceanic coastline". Note that the coastlines of the \lakes" inside the \islands", \islands" inside the \lakes" inside the \islands", etc., do not touch the \ocean", i.e. the bonds of the cluster, and are not relevant here (including these coastlines, too, would result in the set of all the isolines at the given height, the fractal dimension of which  $d_f = 2$ H for O Η 1; for H 0, there is a super-universality, d 2).

In order to calculate num erically the fractal dimension of the <code>\oceanic</code> coastlines", we have opted for the follow – ing procedure. First, 1+1-dimensional [(1+1)D] random surfaces (which are assumed to belong to the same universality class as the statistically isotropic 2D surfaces) were generated on the lattice of the four-vertex m odel [13]. The one-dimensional discretized fractional B row n-ian functions  $f_{\rm H}$  (i) were generated as fractional integrals of uncorrelated random sequence of <code>\spins" s\_i = 1</code> as follow s. The aim function  $g_{\rm H}$  (i) is found as

Further, the discretized function  $f_H$  (i) is found increm entally, starting from H = 0, by rounding  $g_H$  (i) to such a nearest integer that

F inally, the (1+1)D function is given by the superposition of two 1D -functions,




FIG.2: The polygon (N = 2048, H = 0.5) has been odded so that the odded region (grey area) connects left and right edges of the polygon. The striped patterns (in horizontal and vertical directions) are due to the (1+1)D geometry of the surface.

After generating a 2D surface on a square polygon of side length N, we started \ ooding" the polygon. To this end, at the perimeter of the polygon, the lowest point  $P_0$  was found. Further, \water" was incrementally \injected" into that point, until the ooded region connected opposite edges of the polygon (either left and right or top and bottom), see Fig. 2. Such a procedure guarantees that only the \ocean" (and not the \lakes") becomes wet. At that stage, three quantities were recorded: L<sub>1</sub> the coastline length, L<sub>2</sub> the num ber of cells touching the coastline, and  $L_3$  the coastline length im mediately before achieving the critical ood level. The procedure was repeated (for each polygon size and Hurst exponent value) 10<sup>8</sup> or m ore times. The covered polygon sizes are given by formulae N = 128  $k^2$  and N = 196  $k^2$ , with k = 1;2;3;4, and N = 4096 (the largest polygon size was used only for H = 0). The simulations were performed on the cluster often A thlon XP-1700 work stations during three m onths, using an assem bly-optim ized code.




FIG. 3: Finite-size e ects for H = 0 give rise to a very slow convergence of the estimated fractal dimension  $\mathfrak{C}_{c}(\mathbb{N}) = \ln [\underline{l}_{k}(\mathbb{N}_{k+1} = \underline{l}_{k}(\mathbb{N}_{k})] = \ln (\mathbb{N}_{k+1} = \mathbb{N}_{k}), \mathbb{N} = \frac{1}{N_{k}} \frac{1}{N_{k} N_{k+1}}$ .

It was expected that the nite-size scaling of the average values  $l_i(N) = hL_i(N)$  i allow sus to estim ate the fractal dimension  $d_c$ . Such an asymptotic behavior was observed, indeed, for larger Hurst exponents (H 0:375). However, for smaller values of H (and in particular, for H = 0), the convergence  $l_i(N)$  ! AN  $d_c$  was very slow, see Fig. 3 (here A denotes a constant). Consequently, if we assume that  $l_i$  can be expanded asymptotically,

the non-leading exponents ( $\stackrel{6}{=}$  0) have to be very close to the leading term. In order to resolve this di – culty, we made an assumption that for the three recorded quantities  $l_i$  (i = 1;2;3), the three leading exponents (= 0;1;2) are the same,  $_i = _i$ . The validity of this assumption is evident in the case of the leading exponent  $_0$  d, but not so clear for the other exponents. However, if we accept the assumption, it can be veried later using the num erical results. Thus, if we assume that

 $_{i}$  =  $_{i}$ , one can construct such a linear combination of the three quantities  $l_{i}$ , for which two terms (out of the three leading ones) cancel out. It su ces to nd a root-m ean-square t by m inim izing the expression




FIG.4: The quantity  $\log_{10} [S(d)=(n 4)]$  [see Eq.(7)] is plotted versus d for di erent values of the Hurst exponent H (each curve is labeled with a number indicating the value of H). For all the curves, three m inim a are clearly distinct. At these m inim a, d = \_i, where \_i is the i-th leading exponent of the asymptotic expansion of the quantities  $l_1$ ,  $l_2$ , and  $l_3$ .

Here, i is the variance of the expression  $A_1 l_1$  (i)  $A_3 l_3$  (i), and can be expressed via the indi-A2l2(i) vidual variances of the quantities 1(i), and the pair-wise correlation coe cients; all this is easily calculated, using the M onte-C arlo simulation results. The resulting curves  $\log_{10} [S(d)=(n 4)]$  are given in Fig. 4; here n is the num ber of terms in the sum S (d) (so that n 4 is the num ber of degrees of freedom). Note that the two smallest datapoints (with N  $_0$  = 128 and N  $_1$  = 196) have been excluded from the sum, otherwise, the residual squares would have been unacceptably large [resulting in S=(n 4) & 1]. Evidently, for N 196, the higher ( 3) terms of

the expansion (6) become important. The existence of three sharp m inim a for all the curves in Fig. 4 con m s the assumption which was made about the equality of the leading exponents. Indeed, if the second and third asymptotic expansion term s of  $l_1$ ,  $l_2$ , and  $l_3$  were linearly independent, they would not cancel out in Eq. (7), and there would be no minim a with S = (n - 4) - 1.




FIG.5: The m ism atch between a linear estim ate  $d_{\rm lin}=\frac{91}{48}$  H  $\frac{43}{48}$  and the fractal dimension of the \oceanic coastline"  $d_c$  is plotted versus the Hurst exponent H .




FIG. 6: Second and third largest exponents ( $_1$  and  $_2$ ) of the asymptotic expansion of the \oceanic coastline" length are plotted versus the Hurst exponent H.

This novelm ethod of interpreting the nite-size  $\sin u$ lation results allowed us to calculate not only the fractal dimension of the \oceanic coastlines" (see Fig. 5), but also the second and third exponents in the asymptotic expansion of the length of \oceanic coastlines" (Fig. 6).

The values  $d_c = 1.8965$  0.0025 and  $_1 = 1.58$  0.01 for H = 0 are relatively close to each other, exactly as it was expected, judging by the nite-size scaling in Fig.3.

Note that for H 3=4 (uncorrelated percolation), there is analytic result  $d_c = 91=48$ 1:8958 [14], which is indistinguishable (at our num erical uncertainty) from our result for H = 0. W hile the author is not able to give a rigorous proof, it seems natural to assume that the function  $d_f$  is a monotonically decreasing function of H. Indeed, a larger H m eans a stronger in uence of long scales, which results in less twisted isolines, and a lesser num ber of sm all islands (note that these argum ents do not apply for  $d_u$ : excessive twists of the hull can e ciently screen and sm ooth the perimeter). This leads us to the conjecture  $d_c$ 91=48 for H 0.

In conclusion, we have introduced the concept of  $\concept$  of  $\concept$  of the concept of percolation clusters. The nding that their fractal dimension d<sub>c</sub> is clearly distinct from both the dimension of single isolines d<sub>h</sub> and the dimension of the full set of isolines at a given height d<sub>f</sub> is partic-

ularly in portant, because in the context of E arth's landscapes, the coastlines of "oceanic islands" have been often m istakenly treated as the full set of isolines [8]. Based on the numerical results, we have conjectured that for H 0, the fractal dimension of percolation clusters is super-universal,  $d_c$  91=48. Last but not least, a novel and universal approach to the problem of interpreting the nite-size simulation results has been devised.
