# M agnetic phase diagram and structure of the magnetic phases in the quasi-one-dimensional antiferrom agnet B aC $u_2Si_2O_7$ : symmetry analysis.

We have performed a symmetry analysis of the properties of the recently discovered quasi-onedimensional compound  $BaCu_2Si_2O_7$ . The existence of the unusual spin-reorientation transitions is explained as an elect of the unusually strong relativistic interactions. The possible connection between the magnitude of the relativistic interactions and the low-dimensional structure of the  $BaCu_2Si_2O_7$  is discussed. The structure of the magnetic phases is determined.

I. IN TRODUCTION.

Low -dim ensionalm agnets are subject of intense interest due to the important role of the quantum uctuations in these system s. As it was rigorously show  $n^1$ , no antiferrom agnetic order can exist in an one-dim ensional system . How ever, a weak interchain interaction leads to the form ation of long-range m agnetic order.

D i erent types of magnetic order (di ering by the relative orientation of the spins) are possible if the unit cell of an antiferrom agnet contains more than two magnetic ions. A transition from the paramagnetic phase to the phase with lowest exchange energy occurs at the N eel point. The di erence between energies of di erent types of magnetic order in usual 3D -antiferrom agnets is of the scale of the exchange interaction J.

Quasi-one-dimensional antiferrom agnets have some unique properties: First, if the order types di er only by the orientations of the spins in the directions perpendicular to the chain, the energy di erence between these ordered states will be small (of the scale of the small interchain-exchange interaction J?). A second peculiarity arises from the microscopic structure of lowdim ensional magnets. Sm all values of the interchainexchange constants in inorganic compounds are frequently due to the orthogonality of the corresponding electron orbitals. Since this "90 "-rule is not applicable to other interchain interactions, relativistic interchain interactions (such as an isotropic or D zyaloshinskii-M oriya exchange interactions) can compete with the interchain Heisenberg-exchange interaction. These features of low dim ensional magnets can result in magnetic phase transitions with a change of the exchange structure, as in the case of La<sub>2</sub>CuO<sub>4</sub>.<sup>2</sup>

The recently discovered compound  $BaCu_2Si_2O_7$  has attracted attention, since it was reported that it is a quasi-one-dimensional antiferrom agnet<sup>3</sup>. The CuO<sub>4</sub> plaquettes form zigzag chains along the c direction of the orthorhom bic crystal with a Cu-O-Cu bond angle of about 124 . The exchange constants determined by means of neutron scattering<sup>4</sup> are  $J_{\rm c}$  = 24:1 meV,  $J_{\rm b}$  = 0:20 meV,  $J_{\rm a}$  = 0:46 meV and  $J_{[110]}$  = 0:15 meV. The susceptibility<sup>3</sup> (T) also demonstrates a broad maximum characteristic for one-dimensional antiferrom agnets<sup>5</sup> at a temperature near 200 K.

The weak interchain interaction leads to the form ation of long-range antiferrom agnetic order at  $T_{\rm N}~=~9.2~{\rm K}$ . The N eeltem perature is wellm arked by a kink in  $_{\rm C}$ , indicating easy-axis ordering in low magnetic edd. Above  $T_{\rm N}$  the susceptibility demonstrates a deviation from the Bonner-Fisher law  $^3$  |  $_{\rm C}$  strongly increases on approaching the N eeltem perature. Them agneticm om ent per Cuion is strongly reduced in the ordered phase due to the e ect of quantum uctuations: according to the inelastic neutron scattering experiments  $^8$  h i = 0.15  $_{\rm B}$ .

Unexpectedly, the magnetization study in the ordered state reveals the existence of two spin-reorientation transitions at H k c (transition elds  $H_{c1} = 2.0$  T and  $H_{c2} = 4.9 \text{ T}$ ).<sup>6</sup> Two spin-reorientation transitions are a surprising feature for a supposed-to-be-collinear antiferrom agnet. U sually an easy-axis antiferrom agnet exhibits only one spin-reorientation transition (spin- op transition) caused by the competition of the gain in magnetization energy with the loss in an isotropy energy. The observation of an additional spin-reorientation transition<sup>7</sup> at H? cat the eld  $H_{c3} = 7:7$  T is also intriguing the 'classical' easy-axis antiferrom agnet does not undergo a spin-reorientation transition, if the external eld is applied perpendicular to the easy axis of the anisotropy. Neutron-scattering experiments<sup>8</sup> have shown that the interm ediate- eld phase is noncollinear. However, the origin of these exotic spin-reorientation transitions remains a mystery.

In the present paper we perform an analysis of the phase diagram and magnetic structure of  $BaCu_2Si_2O_7$  from a macroscopic approach taking into account the symmetry of the crystal. We show that both two spin-reorientation transitions and the behavior of the suscepti-

bility above  $T_{\rm N}\,$  are due to the unusually large relativistic term s in the therm odynam ic potential.

# II. CRYSTALLOGRAPHIC STRUCTURE AND MAGNETIC VECTORS.




FIG.1: Position of the magnetic ions in the unit cell.

The compound  $BaCu_2Si_2O_7$  crystallizes in the space group Pnma ( $D_{2h}^{16}$ ) with four formula units per unit cell i.e. with 8  $Cu^{2+}$  ions per unit cell. The magnetic ions occupy the 8d positions forming 4 zigzag chains along the c axis (see Figure 1). The lattice parameters are a = 6.862 A, b = 13.178 A, and c = 6.897 A.

As it follows from neutron scattering, the magnetic unit cell coincides with the crystallographic one. In the ordered state each magnetic ion has a non-zero average




FIG. 2: Relative ordering of spins in the plane perpendicular to the chains for di erent antiferrom agnetic vectors. The next layer is aligned antiferrom agnetically. All spins can be rotated sim ultaneously on an arbitrary angle, including out of plane.

spin S<sub>i</sub> (i = 1:::8). We will describe the magnetic structure using linear combinations of these spin vectors which components transform by the irreducible representations of the crystal-symmetry group. The space group D<sub>2h</sub> exhibits only one-dimensional irreducible representations. Thus, the magnetic vector components will remain the same or change their sign under symmetry operations.

In further analysis we will use the inversion I ((x;y;z) ! (x; y; z)) and two sliding axes:  $\hat{\mathcal{C}}$   $((x;y;z) ! (\frac{1}{2} x; y\frac{1}{2} + z))$  and  $C_y^2 ((x;y;z) ! (x;\frac{1}{2} + y; z))$  as independent symmetry operations. The fractional cell coordinates of the  $Cu^{2+}$  ion (1) in Figure 1 are given by  $(\frac{1}{4} 0.028; 0.004, \frac{3}{4} + 0.044)$  (see Ref. 3).

A fier trivial calculations we obtain 8 m agnetic vectors (see Table I). The components of the m agnetic vectors that transform within the same representation are gathered in Table II. Here and further on we will use coordinates with x k a, y k b and z k c, respectively. All possible m agnetic structures for this sym m etry group (including canted ones) can be analyzed in terms of these vectors.

A strong in-chain exchange favors ordering of the types  $L_1; L_2; L_4; L_6$ . In these cases in-chain neighboring spins are antiparallel. We will not consider other antiferrom agnetic vectors in the further analysis. The relative orientation of the spins is shown for these order types in Figure 2.

If we will neglect the interchain interactions, in classical (S 1) approximation the exchange energy for these ordering types is the same, i.e. the antiferrom agnetically ordered state is four times degenerated. Interchain interactions lift this degeneration. Taking into account the exchange-integral values found by neutron scattering, one can estimate the hierarchy of the energies of the collinear ordering described by each of these vectors in the classical approximation.

Zheludev et al. have found the structure of the m agnetic phases by m eans of neutron scattering (see R ef. 8). In term softhe above-de ned magnetic vectors the results of this work can be expressed as follows: At low edds (phase I, H < H  $_{c1}$ ) all spins are aligned collinearly with antiferrom agnetic vector L  $_6$  k z. For the high- edd phase (phase III, H > H  $_{c2}$ ) the magnetic structure was found to be described by the same ordering type L  $_6$  with the antiferrom agnetic vector along the x axis. The interm ediate-

eld phase (phase II,  $H_{c1} < H < H_{c2}$ ) was identi ed as noncollinear antiferrom agnetic structure described by two m agnetic vectors  $L_6$  k y and  $L_2$  k x.

The easy-axis m agnetic ordering is in agreem ent with susceptibility m easurem ents, which show a characteristic kink at  $T_N$  for  $_{\rm c}$ . The order of type L<sub>6</sub> is also expected from classical estimations (see Eqn. (1)). How-ever, the identication of the noncollinear phase can be questioned. First, since nuclear Bragg rejections coincide with m agnetic ones, the determination of m agnetic rejection intensities initially involves a big relative error. As it was shown in Ref. 8, a tof the experimental data with the collinear model L<sub>6</sub> k y yields  $^2 = 2.3$ , while for the proposed noncollinear structure  $^2 = 2.4$  was found. Second, from Table II one can see that  $L_2^x$  and  $L_6^y$  transform di erently under symmetry operations. This means that canting towards  $L_2^x$  cannot be induced by the internal elds.

# III. MAGNETIC PROPERTIES OF BACU 2SI207.

The following discussion is organized as follows: in Section IIIA we will analyze the magnetic phase diagram of  $BaCu_2Si_2O_7$ . The structure of the magnetic phases and the possible reason of the big values of the relativistic constants in the thermodynamic-potential expansion will be discussed in Section IIIB. The behavior of the static susceptibility above the N celpoint will be treated in Section IIIC.






FIG.3: Field dependences of the therm odynam ic potential  $^{\mbox{e}}$  for di erent orientations of the m ain antiferrom agnetic vector. External eld H k z.

### A. M agnetic phase diagram .

The phase diagram of an antiferrom agnet can be analyzed in terms of the main antiferrom agnetic vector (i.e.  $L_6$ ) only.<sup>9</sup> D istortions of the collinear order (i.e. canting of the sublattices) are of no interest in this subsection, while we are interested in the phase diagram only. Relativistic interactions leading to these distortions contribute to the corresponding relativistic constants, as it will be demonstrated in the next subsection.

Following the standard procedure, we will write down an expansion of the therm odynamic potential<sup>e</sup> (1), where  $l = L_6 = j_{L_6} j_{.6}$ 

The potential e is de ned in such a way that<sup>10</sup>

Since magnetization appears only in the presence of a magnetic eld, the potential expansion can be written via the l and H variables.<sup>10</sup> R equiring invariance of the energy to sym m etry operations we obtain:

The small parameter in this expansion is the ratio between the relativistic constants and the exchange constants. The rst two terms  $(a_i)$  describe the orthorhom – bic anisotropy, the terms containing  $_k$  and  $_2$  describe the exchange part of the susceptibility | they do not change under simultaneous rotation of l and H on the same angle. The terms with describe the relativistic contribution to the susceptibility which is independent on the l orientation. Of the higher order terms containing the magnetic eld, we have kept only exchangerelativistic terms which are a product of exchange part (invariant under simultaneous rotation of l and H ) and relativistic part. O ther higher-order terms are smaller due to the supposed smallness of the relativistic constants and, thus, can be om itted. Easy-axis ordering at low

ekls requires that  $a_1;a_2 > 0$ . Concerning the anisotropy term s in the expansion (3), it is also necessary to point out that, if one (or both) of the anisotropy constants is equal to zero or if  $a_1 = a_2$ , then a consideration of the higher-order anisotropy term s would become necessary. How ever, there are no symmetry reasons, causing these special values of the anisotropy constants.

M inimization over the orientations of l in the exact orientations of the external magnetic eld demonstrates that the antiferrom agnetic vector l is aligned along one of the crystallographic axes except maybe for the narrow eld interval near the reorientation transitions where its behavior would be determined by the higher-order anisotropy term s.

The therm odynam ic-potential expressions and m agnetic susceptibilities for di erent possible orientations of H and lare given by:

Now we can not the elds of the spin-reorientation transitions by equalizing the therm odynamic potentials in the phases with di erent orientations of l.

All parameters involved can be estimated using the static magnetization data from Refs. 3,6 and the H $_{\rm c3}$  value from Ref. 7. Note, however, that the sam ples used in the above mentioned papers were dierent, thus, some uncertainty is possible. The values of the parameters calculated from the 5 K data are presented in Table III.

Since  $a_1 > a_2$ , the hard axis of the magnetization is established along the x direction. Substituting the found values to Eqn. 13, one can ascertain that  $H_{c^0} > H_{c1}$ , i.e. a two-spin-reorientation transition scenario is more energy bene cient than a direct transition from ljz to ljx. The positiveness of  $B_2$  explains the absence of a phase transition for H = k x: for  $a_2 > 0$  and  $B_2 > 0$ Eqn. 15 has no physical solutions.

The anisotropy constants determ ine the gaps of the antiferrom agnetic resonance spectrum  $^{11}$ . Antiferrom agnetic resonance on the BaC  $u_2\,S\,i_2\,O_7$  was studied in Ref.12 and two gaps given by  $_1$  = 40 GHz and  $_2$  = 76 GHz were found. The ratio of the AFMR gaps can be expressed as

Inserting the values of the anisotropy constants from Table III yields for this ratio 0.57 0.04 which is in perfect agreement with the value 0.53 found from the experiment. The absolute value of the AFM R gap can be approximated<sup>11</sup> as

which is in reasonable agreem ent with the experim ent, since a good deal of uncertainty is involved in the estimation of the exchange eld  $H_e$  in the case of a low-dimensional magnet. Thus, expansion (3) correctly describes the observed spin-reorientation transitions and is in agreement with other experimental observations.

The additional phase transitions occur as a result of the com petition of an isotropy and relativistic corrections to the susceptibility. The transition at H c1 is a norm alspinop transition: all spins are rotated perpendicular to the eld direction and are aligned along the second-easy axis y. At this transition the loss of the easy-axis an isotropy is compensated by the gain in magnetization energy, since  $_{2}$  >  $_{k}$ . The second phase transition (at H  $_{c2}$ ) is caused by the competition of the in-plane anisotropy and di erence of the magnetization energy in di erent orientations of I due to the relativistic corrections: The magnetic susceptibility for 1 k x turns out to be larger than that for 1 k y, thus, the loss of an isotropy energy is overcom e by the gain in magnetization energy. The spin-reorientation transition at H k y is due to the same e ect: relativistic corrections to the susceptibility make the susceptibility to be the largest for 1 k x, thus, the gain in m agnetization energy overcom es the loss in an isotropy energy.

N ote that the relativistic corrections B  $_{\rm i}$  and are unusually large in  $BaCu_2Si_2O_7$ : z turns out to be com parable with  $_{2}$ . The B<sub>i</sub>H<sup>2</sup> term s norm ally should become com parable with the anisotropy constants only at magnetic elds of the scale of the exchange eld. Thus, a mechanism, which strongly enhances the role of the relativistic interactions, has to be found. One possibility is the e ect of an isotropic reduction of the spin in di erent phases. A coording to the neutron-scattering data<sup>8</sup>, the average magnetic moment of the Cu ion changes as 1 changes its orientation. Accounting for this e ect would result in the same exchange-relativistic terms in the therm odynam ic-potential expansion. A nother possible reason for the large values of these constants will be discussed in the next section.

It is necessary to recall that the above expansion of the therm odynam ic potential was perform ed assuming the relativistic contributions to be small compared to the exchange part. Hence, higher-order terms have been neglected. However, in principle the increasing in portance of the relativistic interactions should also lead to an increase of the higher-order terms, which especially would a ect the phase transitions at higher elds ( $H_{c2}$ ,  $H_{c3}$ ). Moreover, this should give rise to other e ects, such as a nonlinearity of the magnetization, which has not been reported yet.

We also have to note another possible explanation of the comparable magnitude of the elds  $H_{c1}$  and  $H_{c2}$ : namely that, if  $a_1 = a_2$ , then Eqn.12 becomes ill-de ned. As it was noted earlier, in this case higher-order (fourth-order) anisotropy terms have to be considered, and higher-order anisotropy constants (containing additional relativistic sm allness, compared to  $a_{1,2}$ ) would appear in the numerator of Eqn.12. The B<sub>i</sub>H<sup>2</sup> terms should become comparable with the fourth-order anisotropy terms in elds of the order of the normal spin-

op eld  $H_{c1}$ . How ever, we would like to point out again that there are no sym metry reasons causing the equivalence of the anisotropy constants, and the values of the  $a_1$ and  $a_2$  constants derived from the experimental data are




FIG.4: Proposed structures for all phases (eld-induced distortions are om itted): phase I: collinear structure  $l_6^Z$  (direction of the spins is shown by the sign); phase II: weakly noncollinear antiferrom agnet  $l_6^Y$  and  $l_4^X$ ; phase III: weakly noncollinear structure  $l_6^X$  and  $l_4^Y$ . Next layer of spins aligned antiferrom agnetically.

alm ost four-fold di erent. A m icroscopic consideration of the interspin interactions, which is beyond of the scope of the present paper, is necessary to check this probability in detail. The angular dependence of the transition eld H  $_{c2}$  also has to contain inform ation on whether secondor fourth-order anisotropy terms are responsible for the additional spin-reorientation transition.

N evertheless, the present experim ental results can be consistently explained in the fram ework of our simplied approach. Therefore, it seems to be reasonable to start again with the assumption of small relativistic contributions in the following renement of the therm odynamic potential with the aim to analyze the magnetic structure in detail.

#### B. Structure of the m agnetic phases.

Relativistic interactions, such as the D zyaloshinskii-M oriya interaction, can cause small distortions of the collinear structure, which can be expressed by m agnetic vectors. These distortions, however, have to be com – patible with the crystal sym m etry. This means that the com ponents of the m agnetic vectors corresponding to the distortions in the given phase have to transform in the same w ay as the corresponding com ponent of the m ain m agnetic vector, i.e. they have to belong to the sam e representation of the sym m etry group. The possible types of canting of the spins can be easily found from Table II. W e will consider here only distortions described by the m agnetic vectors  $L_1$ ,  $L_2$  and  $L_4$ , for only these m agnetic vectors correspond to the antiferrom agnetic in-chain order. O ther distortions would lead to a violation of the in-chain antiferrom agnetic ordering and, therefore, they are strongly suppressed by the strong in-chain exchange interaction.

The structure of the m agnetic phases is shown in Figure 4. Note that the proposed structure is di erent from that of R ef. 8, where canting described by the m agnetic vector  $L_2$  was proposed. However, vector  $L_2$  has components transforming in the same way as the m agnetization, i.e. distortions described by the components of  $L_2$  can be induced by the m agnetic eld.

To nd the amplitudes of the distortions we have to write an expansion of the therm odynam ic potential including vectors  $L_1$ ,  $L_2$  and  $L_4$  and then to m inim ize this potential with respect to the components of these vectors. In this expansion we will normalize all magnetic vectors by the length of the main magnetic vector  $L_6$  j

W e want to emphasize that this expansion is essentially the same as Eqn. (3). The only dimension is that the interactions leading to the distortions of the collinear order are written explicitly, now.

In the expansion given above, the term s containing A $_{\rm i}$  are of exchange origin, they describe the loss in exchange energy. A llofA $_{\rm i}$  are positive. The term swith  $_{\rm i}$  describe the canting of the antiferrom agnetic sublattices (so called weak antiferrom agnetism), those with  $_{\rm i}$  describe eld-induced distortions. Both  $_{\rm i}$  and  $_{\rm i}$  parameters arise due to the m icroscopic D zyaloshinskii-M origa interaction.

M inimization over the components of magnetic vectors will demonstrate that the amplitudes of  $l_1$ ,  $l_2$  and  $l_4$  are proportional to the ratio of some relativistic constant to the exchange constants  $A_i$ . We will suppose here that all relativistic constants are small compared with exchange constants. Then, the magnitude of  $l_1$ ,  $l_2$  and  $l_4$  already contains relativistic sm allness and we can neglect all higher-order relativistic terms containing these vectors.

The canting angles (see Figure 4) can be expressed as follows:

N ote that the distortions of type  $I_2^{\times}$  (which were found in R ef. 8) are possible, but they are induced by the external eld and they are independent on the orientation of them ain antiferrom agnetic vector. Thus, they have to be observed in all phases. M oreover, their am plitude should increase with increasing m agnetic eld, while according to the ndings of R ef. 8 the noncollinearity is suppressed by the m agnetic eld in phase II.

On the other hand, the distortions described by the components of  $l_4$  are consistent with the experimental observations: they are absent in phase I, and their am – plitude in phases II and III are governed by di erent constants  $_i$ . The fact that the canting in phase III is much smaller than in phase II forces us to suppose that  $_1$  2. A suppression of the canting in phase II corresponds to > 0.

Substituting these results to Eqn. 19 we obtain an equation of the same type as Eqn. 3 with renormalized constants. The comparison of Eqn. (3) with the results of the substitution yields

If the relativistic constants are small compared to the exchange constants (as it was supposed in the expansion (19)), then the distortions caused by relativistic interactions result in small corrections to the constants connected with the main antiferrom agnetic vector.

In the case of the low-dimensional antiferrom agnet, it is another situation. The antiferrom agnetic ordering of the types  $L_1$ ,  $L_2$ ,  $L_4$ , and  $L_6$  di ers only by the relative orientation of the spins in the direction perpendicular to the chain. Thus, the loss in exchange energy for the canting from one of these order types to the other (i.e.  $A_i$  constants in the expansion (19)) is governed by the weak interchain exchange. As it was mentioned in the Introduction, in a quasi-one-dimensional magnet the interchain-exchange interaction can be comparable in strength with the relativistic interactions. Thus, the relativistic contributions in Eqns. 27-33 will not become small.

This argumentation cannot be considered as a strict proof of the role of low-dimensionality for the large values of the relativistic constants in Eqn. 3, because expansion (19) becomes incomplete, if some of the relativistic constants are comparable to the exchange ones. However, the fact that in quasi-one-dimensionalm agnets strong distortions with small losses of exchange energy are possible, can result in an increase of the e ect due to relativistic interactions.

# C . Susceptibility of BaC $u_2 \, Si_2 O_7$ above the N eel point.

The susceptibility of BaCu<sub>2</sub>Si<sub>2</sub>O<sub>7</sub> above the N eelpoint strongly deviates from a Bonner-Fisher law<sup>5</sup> characteristic for one-dimensional magnets<sup>3,6</sup>. It demonstrates a broad maximum near 200 K but then shows a strong Curie-like increase to lower temperatures. This increase is anisotropic. It is strongest for  $_{\rm c}$  and smallest for  $_{\rm a}$ .

Such a behavior is typical for antiferrom agnets with possible weak ferrom agnetism  $^{13,14}$ . As it follows from Table II, weak ferrom agnetism is allowed for antiferrom agnetic order of types  $L_1$  and  $L_2 \ |$  these vectors have com ponents transform ing in the sam eway as the m agnetization com ponents.

At the vicinity of the N eel point the am plitude of the order parameter is small and we can write down an expansion over the powers of the order parameter as in the usual Landau theory of second-order phase transitions:

Here the  $A_i$  terms are of exchange origin, those with and are responsible for the canting, p is the param agnetic state susceptibility. We neglect an isotropy terms and higher-order terms. Here we have used designations for the terms similar to those in Eqn. 19. Note, how ever, that coe cients with the same designations are di erent in Eqn. 19 and Eqn. 34.

At the transition point the factors  $A_i$  change their sign: it is positive above the transition temperature and negative below. In the vicinity of the corresponding N eel temperatures

At the N eelpoint order of type  $L_6$  is established. W e will suppose that in some tem perature range above  $T_N$  the values of  $A_1$  and  $A_2$  continue to increase with increasing tem perature and, thus, can be approximated as

To nd the values of the magnetic vector components we have to m in in ize expansion (34). Here we will restrict our analysis to the case of  $T > T_N$ . Above the N eelpoint we have  $A_i > 0$ , and in absence of an external eld H the m in in um of the potential (34) corresponds to  $j_{L\,i}j=0$ . If a magnetic eld is applied, weak antiferrom agnetic order parameters of the types  $L_1$  or  $L_2$  are induced. All other m agnetic vectors are zero.

The existence of eld-induced order parameters leads to an additional contribution to the susceptibility. U sing Eqn. 36, we obtain for the magnetic susceptibilities:

I.e. with decreasing temperature the susceptibilities should increase. The amplitudes of this increase in different orientations<sup>3</sup> allow to conclude that

The strongest e ect for  $_{zz}$  is in accordance with the large relativistic contribution  $_{z}$  in Eqn. 3.

# IV. CONCLUSIONS

Starting from a symmetry approach we have analyzed the magnetic phase diagram and the corresponding magnetic structures of the antiferrom agnet BaC  $u_2 Si_2 O_7$ . In the rst step, we have obtained a therm odynamic potential in terms of the main antiferrom agnetic vector only, demonstrating additional spin-reorientation transitions, which are due to the unusually strong relativistic terms in the expansion of the therm odynamic potential. The strength of the relativistic terms is probably connected to the low-dimensionality of the compound.

In the second step, we have re ned the therm odynam ic potential by including the magnetic vectors, which describe distortions of the magnetic structure compatible with the crystal symmetry. Based on our analysis, we proposed a structure of the magnetic phases (cf. Fig. 4), which is di erent from that in Ref. 8.

In addition, we were able to explain the deviations of the susceptibility from the Bonner-Fisher law on ap-

proaching the 3D-m agnetic order. The analysis of the susceptibility behavior above  $T_{\rm N}\,$  also shows the importance of the relativistic interactions for the understanding of the properties of B aC  $u_2 \, S \, i_2 \, O \, _7$ .

The strong enhancement of the relativistic e ects should result in other interesting properties of this com – pound, such as nonlinear magnetization. Thus, further experimental and theoretical studies are necessary to achieve a deeper insight into the unusual properties of  $BaCu_2Si_2O_7$ .
