Bosonic model with Z_3 fractionalization

Bosonic model with unfrustrated hopping and short-range repulsive interaction is constructed that realizes Z_3 fractionalized insulator phase in two dimensions and in zero magnetic eld. Such phase is characterized as having gapped charged excitations that carry fractional electrical charge 1=3 and also gapped Z_3 vortices above the topologically ordered ground state.

I. INTRODUCTION

A urry of recent theoretical activity has produced speci cm odel system realizations of fractionalized phases in two dim ensions. 1,2,3,4,5,6 Essentially all of the fractionalized states constructed so far are Z₂ states. On a form al level, these realizations employ the following route to Z2 fractionalization: Strong local correlations lead to a U (1) gauge theory as a low-energy description; this gauge theory is then driven into a decon ned state by a condensation of objects carrying gauge charge 2 that also appear in the low-energy description. This form alstructure has been brought out very directly in Refs. 5,6,8.0 n a m ore physical level, the fractionalized insulator is produced departing from a superconducting state by a condensation of double vortices, 9,10 The main body of work concentrated on the Z₂ states since these are expected to be the simplest to realize. However, it is clear that more com plicated fractionalized states are also possible. For example, it is conceivable that in some system the superconducting state is quantum -disordered by a condensation of triple vortices; the resulting insulator is then a Z₃ fractionalized state.

In this paper, we indicate how a Z $_3$ fractionalized state can be engineered in a relatively simple bosonic model with unfrustrated nearest-neighbor hopping and short-range two-body repulsive interaction. Much of the construction parallels closely the Z $_2$ examples of Refs. 3,5,6: The low-energy Hilbert space is selected by stipulating particular charge interactions in a manner that naturally admits splitting boson charge into three pieces; this Hilbert space is protected by a large charge gap. The effective description of the fractionalized state has gapped chargons carrying electrical charge 1=3 and coupled to some special Z $_3$ gauge theory which we analyze in detail. Our main message here is that one does not need very contrived systems to obtain more complicated fractionalization patterns.

II. Z_3 V IA CHARGE FRUSTRATION




FIG. 1: Josephson junction array formed by penetrating hexagonal (r) and triangular (R) lattices, modeled by the H am iltonian Eq. (1). The shaded area indicates schematically hexagon charging energy UN $_{\rm R}^{\,2}$.

The model is de ned on the lattice shown in Fig. 1, which we can think of as a hexagonal lattice with additional sites placed at the hexagon centers. We have $_{\rm r}^{\rm y}=e^{i_{\rm r}}$ bosons residing on the hexagonal lattice (these sites are always labelled lower-case r), and $b_{\rm k}^{\rm y}=e^{i_{\rm R}}$

bosons residing at the hexagon centers (upper-case R). Bosons can hop between the neighboring sites as indicated by the links on the gure; the hopping amplitudes are w_1 for hr; Ri links and w_2 for hr; $r^0\mathrm{i}$ links. We also stipulate strong repulsive interactions that favor charge neutrality of the hexagons, in addition to the on-site repulsion that favors charge neutrality of the individual sites. The complete quantum rotor Hamiltonian is

Here, fn_R^b ; $_R$ g are conjugate number-phase variables [e.g., in the phase representation n_R^b i $\theta = \theta_R$, b_R^y $_r$ + h.c.: $2\cos(_R$ $_r$)], and similarly for fn_r ; $_r$ g. The number-phase variables are particularly appropriate if we think of the model as describing an array of Josephson-coupled superconducting islands. Both b_R and $_r$ bosons carry electrical charge q_b .

In the above H am iltonian, N $_{\rm R}$ is the boson number associated with each hexagon:

General analysis of the possible phases proceeds as in Ref. 6. Here, we focus on the insulating states that are obtained for large U $w_1; w_2; u_b; u$. If the $w_1; w_2; u_b; u$ terms are all zero, there is a degenerate manifold of ground states specied by the requirement $N_R = 0$ for each R. The ground state sector is separated by a large charge gap U from the nearest sectors. Including the $w_1; w_2; u_b; u$ terms lifts this degeneracy in each sector, which is best described by deriving the corresponding e ective Ham iltonian in each sector.

The e ective H am iltonian in the ground state sector $(N_R = 0)$ is, to third order in the perturbing term s,

Here, $H_{u_b;u}$ stands for the on-site repulsion terms as in Eq. (1); R_1 ; R_2 ; R_3 label the three hexagon centers adjacent to r; $J_c = w_1^3 = (6U^2)$ and $K_{ring} = 3w_2^3 = U^2$.

This is our main step in obtaining Z $_3$ fractionalization. The above Ham iltonian looks similar to a compact U (1) gauge theory coupled to a charge 3 scalar eld. Thus, if we think of the $_{\rm r}$ as some gauge elds, then it is very suggestive to think of the $_{\rm k}$ as carrying gauge charge 3 [see also Eq. (2)]. Standard Fradkin-Shenker analysis then suggests that by condensing the $_{\rm k}$ eld, which can be arranged by making $_{\rm c}$; K $_{\rm ring}$ large, we can decon ne objects carrying gauge charge 1. By virtue of Eq. (3), such objects carry fractional electrical charge $_{\rm c}$ =3, and we obtain a Z $_{\rm d}$ fractionalized insulator.

The reader who ands the above statements believable may now declare victory in achieving Z_3 fractionalization. However, if we want to describe the deconant phase (s) in any detail, we need to study the above Hamiltonian directly since it is not related in any simple manner to the conventional gauge theory. This is our focus in the remainder of the paper. Of course, we will conamt the deconant nember of the state that obtains for large $K_{\rm ring}$ on all hexagons is in fact a Z_3 Z_3 state (see below for details).

Proceeding with this analysis, consider the regime of large J_c ! 1 and small u_b ! 0. It is convenient to perform the following change of variables. De ne the operators $b_{\scriptscriptstyle CR}^y = e^{i \, _{\scriptscriptstyle CR}}$ and ${}^{\sim}_r = e^{i \, ^{\sim}_r}$:

Here, $s_R=1$; e^{i2} =3, or e^{i4} =3, so that $_{CR}$ 2 [0;2). One can readily verify that N $_R$ is conjugate to $_{CR}$, while n_r is conjugate to $_{r}$. b_{CR}^y carries electrical charge q_b =3 and can be thought of as a chargon eld, while $_{r}^{y}$ is charge

neutral. These new variables are indeed natural in the description of the decon ned phase, but to recover the physical Hilbert space, we need to impose the constraint

In the new variables, the Hamiltonian becomes

Note that we are left with gauge $ekds^{\sim}_r$ only, since we are working in the \uncharged" ground state sector

The term J_c acts as a Z_3 anisotropy on the \tilde{r}_r edd. In the lim it J_c ! 1 , $e^{i\tilde{r}_r}$ becomes a Z_3 edd: \tilde{r}_r = 0;2 =3, or 4 =3. The operator P_r^+ e $i^{(2)} = 3 \cdot n_r$ shifts the states of the quantum Z_3 clock by + 1, $i^{(4)}$ whereas the constraints specifying the uncharged sector $N_R = 0$ become

Theu $(n_r)^2$ term causes tunneling between the dierent states of the quantum clock, and this can be described by an elective \transverse eld" $h(p + P_r)$ acting on the clock.

The e ective Ham iltonian now becomes Z_3 \ringexchange" Ham iltonian on the hexagonal lattice of r sites




FIG. 2: Generic phase diagram of the $Z_{\rm N}$ ring exchange on hexagonal lattice, Eq. (9). To explore the dierent decon ned states, we allow two dierent ring exchange couplings, K $_{\rm ring}$ = K $_{\rm A}$ for A-type hexagons and K $_{\rm ring}$ = K for B- and C-type hexagons (see Fig. 3).

The H am iltonian together with the constraints Eq. (8) can be viewed as some special Z_3 gauge theory and is analyzed below and in further detail in Appendices A and B. We not that generically this theory can have two deconned phases (in addition to the conned phase) with the phase diagram shown in Fig. 2. Here we only describe the deconned phase that obtains when all ring exchange couplings are large, K $_{\rm ring}$ h. As explained below, this phase is a Z_3 Z_3 deconned phase.

From here on, our focus is on the above Z $_3$ ring exchange H am iltonian. We drop all tildes on Z $_3$ elds $_r$ and superscripts on n_r (which are now integers modulo 3). A lso, we consider a Z_N generalization of the above H am iltonian and carry out the analysis in the general case. This is done for clarity of notation.

For K $_{ring}$ h, a good caricature of the bulk ground state is given by the wavefunction

where the primed sum is over all con_p gurations fn_rg that satisfy the constraints Eq. (8), i.e., $n_r = 0$.

Let us de ne Z_N ux through a given hexagon R




FIG. 3: Hexagonal lattice on phich the Z_N ring exchange modelEq.(9) is de ned. N_R $_{r2R}$ n_r measures Z_N \number" on each hexagon; we can increase N_R on a given hexagon (?) by one by applying a \string" operator y y :::along the indicated path. $_R$ $_1$ $_2$ + $_3$ $_4$ + $_5$ $_6$ measures Z_N \ ux" through a given hexagon (123456); to x the sign convention we always take 1 to be the lowerm ost hexagon site. We can increase the ux through a given hexagon () by one unit by applying a string $P^+P^+P^+P^+$:::along the indicated path. The lower-right corner of the gure shows the three sublattice structure of the lattice of honeycom bs.

with the sign convention as in Fig. 3. The ground state has zero—ux through each hexagon. Excitations above this ground state are Z_N vortices. For example, we can add a unit of—ux through a given hexagon by applying a \string" operator as indicated in Fig. 3. The gap for a vortex carrying one unit of—ux is $2K_{\rm ring}$ [l— $\cos(2=N)$].

O bserve now (Fig. 3) that the hexagon centers R form a triangular lattice, which consists of three sublattices A, B, and C. O bserve also that the ux-adding string operator \steps" only through the same sublattice hexagons. We are thus led to the possibility of a topological distinction between vortices on the dierent sublattices, in addition to the usual distinction between two vortices carrying dierent ux. Indeed, one can see that the topologically distinct situations can be characterized by saying that we have two species of Z_N vortices, say A and B vortices. A lternatively, if we want to preserve the symmetry among the three sublattices, we can say that there are three types of Z_N vortices A, B, and C vortices but these are not independent and instead satisfy \fusion nules" such as

This means that a nearby pair of +1 A and B vortices is indistinguishable from a 1 C vortex (note also that the \states" on the left and on the right can be connected by local h terms in the H am iltonian).

Consider now introducing Z_N charges in the above gauge theory Eq.(9), e.g., consider placing a pair of opposite 1 charges on two hexagons R_1 and R_2 : $_{r2R}$ $n_r = _{RR_1}$ $_{RR_2}$. This is appropriate when studying the charged sectors of the microscopic Hamiltonian Eq.(1) since the formal gauge structure represents the crucial coupling of chargons with the above Z_3 degrees of freedom. A charge can be added to a hexagon by applying

a string operator as indicated in Fig. 3. From several perspectives, one can see that all such charges are decon ned in the $K_{\rm ring}$ h phase: Thus, in Appendix A we approach this \fully decon ned" phase starting from a \partially decon ned" phase, in which charges are deconned on one sublattice only. Also, this fully decon ned phase corresponds to the fully disordered phase in the

Sim ilarly to vortices, we need to distinguish the charges on dierent sublattices. A gain, as far as the gauge structure is concerned, we have fusion rules such as

Statistical interactions between the dierent particles are readily identied by studying the commutation properties of the corresponding strings. These are summarized in Table I by specifying \gauge charges" of the different N $_{\rm R}=+1$ excitations with respect to the A, B, and C uxes. Thus, N $_{\rm A}=+1$ excitation carries gauge charges Q $_{\rm A}=0$; Q $_{\rm B}=1$; Q $_{\rm C}=+1$, i.e., it does not \see" A vortices, but when transported around a B or C vortex of unit strength, the wavefunction acquires an additional phase e 12 $^{-N}$ or e^{i2} $^{-N}$ correspondingly.

This completes the particle description of the fully deconned phase. The minimal description would be to say that we have A hexagon charges that see B hexagon Z $_{\rm N}$

vortices and B hexagon charges that see A hexagon vortices. This is essentially the claim ed Z_N Z_N structure. Thus, we expect N 2 -fold ground state degeneracy if the system is put on a cylinder, as can be veri ed by constructing the corresponding ground states starting from the state Eq. (10) and threading vortices through the hole of the cylinder.

It should be emphasized here that the above discussion assum ed that the three-sublattice structure is respected by the boundary conditions. W hile it is clear that the bulk properties do not depend on this, there is an additional quirk when we consider topological degeneracy in a geometry that does not respect the three-sublattice structure. This is legitim ate when all ring exchange couplings are equal. Consider, e.g., a cylindrical geometry with the circum ference along the horizontal direction of Figs. 1 and 3. When an A-type particle is transported around the periodic direction, it does not return to its initial position, but rather becomes a B-or C-type particle. It takes three turns for the particle to return to the original position. From table I, such N $_{\rm R}$ = +1 particle will not register any ux in this process. A detailed analysis shows that for N mod 3 & 0 the ground state of the system in this geometry is nondegenerate. On the other hand, for N m od 3 = 0 the ground state is found to be three-fold degenerate, since in this case there is a composite object that returns to its initial state when transported once around the cylinder and that senses some ux through the hole of the cylinder in the process.

Returning to our microscopic bosonic model, the \particle description" of the Z_3 Z_3 phase is as follows: We have two species of Z_3 vortices (with gap $K_{\rm ring}$) and we have charged particles (with charge gap U) that can be classified as carrying two distinct Z_3 gauge charges, in addition to their fractional electrical charge. Finally, note that the Z_3 Z_3 state is associated with the additional symmetries in the hexagonal lattice ring exchange H am iltonian but is protected by the same charge gap projection, since any move within the uncharged state sector is necessarily a combination of hexagon ring exchanges.

III. CONCLUSIONS

W e showed that it is possible to produce m ore complicated fractionalization patterns such as Z $_{\rm 3}$ fraction-

alization in relatively simple bosonic models. While the resulting fractionalized state turned out to be even more complicated than initially intended, them icroscopic model was not too contrived. It is hoped that this work will encourage further searches for other exotic states. For example, can a non-Abelian fractionalized state be produced in a condensed matter system with a global symmetry only, short-range interactions, and in zero magnetic eld?

APPENDIX A:PARTIALLY DECONFINED (Z_N) PHASE

To better appreciate the character of the decon nement in the special gauge theory Eq. (9), we allow different ring exchange couplings for dierent hexagons and consider particular parameter space with two such couplings: K $_{\rm ring}$ = K $_{\rm A}$ for the A hexagons and K $_{\rm ring}$ = K $_{\rm B}$ = K $_{\rm C}$ K for the B and C hexagons. This is indicated schematically in Fig. 3 where the A hexagons are shaded. Note that by allowing the two couplings we implicitly assume that the boundary conditions on the lattice respect the three-sublattice structure; this is done throughout.

We argue below that the ring exchange Ham iltonian has the phase diagram shown in Fig.2 with three phases: For h K; KA, the system is in a fully conned phase. For K h KAK the system is in a partially deconned (ZN) phase. In this phase, the charges on the A hexagons are deconned, while the charges on the B and C hexagons are conned. Finally, for K; KA h the system is in a fully deconned (ZN) phase with all charges deconned. The phase diagram of Fig. 2 is also supported by the analysis of the dual global ZN spin model sum marized in Appendix B.

In what follows, we give a detailed description of the partially decon ned phase. As a representative of this phase, consider the H am iltonian with K $_{\rm A}$ = 0, i.e., with ring exchanges around the B and C hexagons only (see Fig.3). In this case, there are additional conserved quantities:

for each hexagonal lattice link hrr 0 i between two A hexagons A and A 0 (see Fig. 3). This facilitates the analysis, since we can consider separately each subsector speci ed by the corresponding eigenvalues $\mathrm{fI}_{A\,A}\,{}^{}_{}$ g. Note that the allowed $\mathrm{fL}_{A\,A}\,{}^{}_{}$ g are very much constrained

by the constraints Eq. (8) on the n_r them selves; however, we will not use the details of these explicitly.

First of all, observe that the A hexagons in turn form a triangular lattice, while the links hrr 0 i between such hexagons can also be viewed as the links of this \A-lattice", hAA 0 i hrr 0 i. In a given subsector with xed fL_AA $^\circ$ g, there remains one Z $_{\rm N}$ degree of freedom for each such link. It is convenient to work in the number basis and label these remaining link degrees of freedom by

which are the neutrality constraints Eq. (8) for the A hexagons.

The action of the Ham iltonian Eq. (9) in this subsector is readily described in terms of the new variables. Thus, the transverse eld (h) terms are diagonal in the new number variables, while the B and C hexagon ring exchanges simultaneously raise (or lower) the three oriented number elds circulating around the corresponding A-lattice triangular plackets. Writing the raising operator for a given link number variable N $_{\rm A\,A^{\,0}}$ as e^{i} $_{\rm A\,A^{\,0}}$, the resulting Ham iltonian is

Together with the constraints Eq. (A 3), this is precisely the conventional $Z_{\rm N}$ lattice gauge theory de ned on the triangular A-lattice but with link-dependent $_{\rm A\,A\,^{\circ}}$ speci c for the particular subsector $fL_{\rm A\,A\,^{\circ}}g$. We can now use the conventional wisdom to characterize each such subsector and in turn the full hexagonal ring exchange H am iltonian with K $_{\rm A}$ = 0.

When h 0, all the di erent subsectors are degenerate. The lowest energy state in each such subsector has the energy of 2K per triangle and is an equal weight superposition of all possible con gurations of $N_{A\,A\,^{\circ}}$ that satisfy the constraints Eq. (A 3). Nonzero h eliminates this degeneracy and selects one particular subsector, namely with all $L_{A\,A\,^{\circ}}=0$, as containing the true ground state of the full H am iltonian with K $_{A\,^{\circ}}=0$. Indeed, treat-

ing $_{\rm A\,A\,^{0}}$ perturbatively, the lowest energy in a given subsector is

where for sim plicity we assumed that the system has no boundaries. It is now clear that for small nonzero hathe ground state of the full ring exchange Ham iltonian with K $_{\rm A}=0$ is in the subsector with all $L_{\rm A\,A^{\,0}}=0$. The subsectors that are closest in energy have the smallest number of nonzero $L_{\rm A\,A^{\,0}}$ and can be characterized as having alternating $L_{\rm A\,_0A^{\,0}}=+1$ and $L_{\rm A\,_0A^{\,0}}=1$ values on the six links to a given hexagon A $_{\rm 0}$ (this subsector is obtained from the ground state subsector by applying the hexagon ring exchange around the hexagon A $_{\rm 0}$). The energy gap to these subsectors is $6h^2$ =K . We see that we have a peculiar situation where a nonzero transverse eld h is needed to stabilize this Z $_{\rm N}$ deconned ground state; this is because we are competing here against the Z $_{\rm N}$ $Z_{\rm N}$ deconned state that is obtained for large K $_{\rm A}$; K .

We are all set to discuss con nement of charges in the model with $K_A = 0$. The above analysis was carried out in the uncharged sector but is readily extended to the charged sectors. First, consider placing a pair of opposite charges on two B hexagons: $n_{2B_1} n_r = +1$ and $_{r2B_2} n_r =$ 1. Proceeding exactly as before, one is led to consider di erent subsectors (of this charged sector) speci ed by fI_{AA} og. In each such subsector, the H am iltonian has precisely the form Eq. (A4) with the number variables satisfying precisely the constraints Eq. (A3). All information about the two charges is encoded in the allowed con gurations $fL_{AA} \circ g$, and one can clearly see that LAAO 6 0 at least on a string of A-lattice bonds connecting B₁ and B₂. From the earlier arguments, the energy cost of introducing two such charges is then proportional to the length of this string, i.e., such charges are con ned with the string tension Й=К .

Consider now placing pair of opposite charges on two A hexagons A_1 and A_2 : $n_r = +1$ and n_{r2A_2} $n_r = +1$ 1. The analysis of the subsectors $fI_{AA} \circ g$ will be som ewhat di erent in this case. For each such subsector in this charged sector there corresponds a subsector in the uncharged sector having exactly the same fLAAOQ. It is convenient to \m easure" each charged subsector relative to the corresponding uncharged subsector. This is achieved by de ning link variables N_{AA} via Eq. (A2) using an uncharged instance $fn_r^{(0)}g$ of $fL_{AA}\circ g$ (i.e., r_{2R}^P $n_r^{(0)}=0$ for each R and $L_{AA^0} = n_r^{(0)} + n_{r^0}^{(0)}$ for each hAA^0 i). In each subsector, the Hamiltonian again has the form Eq. tify the Z_N vortex excitations of the A-lattice gauge theory with Z_N vortices on the B and C hexagons. These vortices will have usual statistical interactions with the decon ned charges on the A hexagons. A lso, as should become clear by reviewing the above discussion, we can essentially account for the dierent subsectors $\mathrm{FI}_{A,A}\circ g$ by saying that there are additional particle excitations living on the A hexagons obtained from the ground state by the action of the corresponding A hexagon ring exchanges. These new particles have a \mass" of $6h^2$ =K and have no statistical interaction with the other particles.

We can now consider what happens when we allow nonzero K_A . As discussed above, the ring exchanges around the A hexagons introduce m ixing between the di erent subsectors. However, as long as K_A is much smaller than the corresponding gap $l\hat{l}^2 = K$, the partially decon ned phase survives and is characterized by the same particle description.

Once K $_{\rm A}\,$ is su ciently large, the system enters the fully decon $\,$ ned phase described in the main text.

APPENDIX B:DUALGLOBAL Z_N SPIN MODEL

Here we sum marize dual perspective on the hexagonal lattice ring exchange Ham iltonian Eq. (9). We work directly in the Ham iltonian language. Simple counting shows that the dimensionality of the physical Hilbert space is consistent with having one $Z_{\rm N}$ degree of freedom per hexagon. Let us de ne

which is a global $Z_{\rm N}~$ spin m odel with three-spin interactions. A little thought shows that the model has in fact a $Z_{\rm N}~$ Z_{\rm N}~ global sym m etry corresponding to independent global rotations of the spins on two of the three sublattices. Note also that the three-spin interaction around triangles promotes ordering of the spins on the same sublattice. This is because two neighboring sites A and A on the same sublattice share a B C side in the respective triangle interactions 4 A B C and 4 A $^0{\rm B}$ C .

The globalm odel clearly has a fully disordered phase for K h. In the original ring exchange H am iltonian, this corresponds to all vortices being gapped, and we obtain the Z_N Z_N fully decon ned phase. Varying the A hexagon ring exchange coupling K $_A$ independently, for su ciently small K $_A$ and large K the system can clearly order on the A sublattice (i.e., A vortices condense), but remain disordered on the B and C sublattices. This is our partially decon ned Z_N phase.
