Probing therm al uctuations and inhom ogeneities in type II superconductors by means of applied magnetic elds

A superconductor is in uenced by an applied magnetic eld. C lose to the transition temperature T_{c} uctuations dominate and the correlation length increases strongly when T_{c} is approached. However, for nonzero magnetic eld H there is another length scale $L_{\rm H}$ = universal amplitude. It is comparable to the average distance between vortex lines. We show that the correlation length is bounded by this length scale, so that cannot grow beyond LH. This implies that type II superconductors in a magnetice eld do not undergo a phase transition to a state with zero resistance. We sketch the scaling theory of the resulting magnetic eld induced nite size e ect. In contrast to its inhom ogeneity induced counterpart, the magnetic length scale can be varied continuously in terms of the magnetic eld strength. This opens the possibility to assess the im portance of uctuations, to extract critical point properties of the hom ogeneous system and to derive a lower bound for the length scale of inhom ogeneities which a ect therm odynam ic properties. Our analysis of speci cheat data for under-and optimally doped YBaCu3O7, MgB2, 2H-NbSe2 and Nb₇₇Zr₂₃ con rms this expectation. The resulting lower bounds are in the range from 182 A to 818 A. Since the available data does not extend to low elds, much larger values are conceivable. This raises serious doubts on the relevance of the nanoscale spatial variations in the electronic characteristics observed with scanning tunnelling microscopy.

I. IN TRODUCTION

A primary e ect of a magnetic eld on a type II superconductor is to shift the specic heat peak to a lower temperature. Indeed, this shift provided some of the earliest evidence for type II superconductivity [1]. In a meaneld treatment this behavior can be comprehended as follows: To retain the continuous character of the zero eld transition the Ginzburg-Landau correlation length = 0 jl $T = T_c j^{1-2}$ is supposed to diverge along the so called upper critical line of continuous phase transitions dened by

Calculations of the speci c heat within the fram ework of the Abrikosov theory and its generalizations [2] yield at this mixed state to normal state phase boundary for the jump in the speci c heat coe cient the expression $c(H_{c2};T_{c2})=T_{c2}$ / $(dH_{c2}=dT)^2$, where the factor of proportionality is of order unity and takes the e ect of the vortex lattice into account. M atching with the zero eld jump then requires that

Thus, the magnetic eld reduces both, the transition temperature and the jmp in the specic heat. Although this mean—eld scenario describes the experimental data of various type II superconductors with comparatively large correlation length amplitude $_0$, including MgB $_2$ [3], 2H-NbSe $_2$ [4], and Nb $_{77}$ Zr $_{23}$ [5], reasonably well, it neglects an essentiale ect of an applied magnetic eld. In analogy to liquid 4 He in a uniform ly rotating container [6], the magnetic eld applied to a type II superconductor is an external perturbation which drives the system away from criticality. C lose to the transition temperature T_c the correlation length—increases strongly when T_c is approached. However, for nonzero rotation frequency—or magnetic eld H the average distance between vortex lines, L (\sim)=m $_4$ or L_H $_0$ =(H) is a limiting length scale. For this reason—cannot grow beyond L $_{;H}$. Consequently, for nite or H, the thermodynamic quantities like the specic heat are smooth functions of temperature. As a rem nant of the singularities along T_{c2} (H) the quantities exhibit a maximum or an injection point along T_p (H). Such a nite size e ect also occurs in zero magnetic eld due to inhom ogeneities with length scale L.

In this context it is instructive to refer to the early literature focused on uctuation e ects in type II superconductors. Implicit in most of these treatments is the assumption that uctuations do not interact; that is, only G aussian uctuations are considered [7]. Although this assumption breaks down in the critical region, it captures some of the qualitative aspects of uctuations in zero magnetic eld. If the G aussian approximation is used to calculate thermodynamic properties of a type II superconductor near the mean-eld phase boundary T_{c2} (H), singular behavior of them odynamic and transport properties is predicted to occur [7]. However, the uctuations of a bulk superconductor in a magnetic eld become e ectively one dimensional, as noted by Lee and Shenoy [7]; and a bulk superconductor behaves like an array of rods parallel to the magnetic eld with diameter $L_{\rm H}$. Since uctuations become more important with reduced dimensionality and there is a limiting magnetic length scale $L_{\rm H}$ it becomes clear that the critical line T_{c2} (H) is an artefact of the approximations. Indeed, calculations of the special heat in a magnetic eld which treat the interaction terms in the Hartree approximation and extensions thereof, and that the special heat is smooth through the mean-eld transition temperature T_{c2} (H) [8{10}]. In the context of nite size scaling this is simply due to the fact that the correlation length of uctuations which are transverse to the applied magnetic eld are bounded by the magnetic length $L_{\rm H}$ / H $^{1=2}$.

A main point of this paper is to show that in a type II superconductor the correlation length cannot grow beyond the magnetic length scale

where a is a universal amplitude when critical uctuations dominate. Hence, the correlation length (t) is bounded by

where is the critical exponent of the correlation length. Beyond the mean-eld approximation it diers from = 1=2. Due to this nite size elect the maximum of the specic heat peak is shifted to a lower temperature T_p given by

A lthough this nite size scaling result agrees form ally with the mean-eld expression for t_{c2} (Eq.(1)) with = 1=2 and a = 2 , t_p (H) is not a line of continuous phase transitions. A long this line the speci c heat peak adopts its maximum value and the correlation length attains the limiting length scale L_H . On the other hand, there are sample inhom ogeneities with length scale L, as well. They imply that the correlation length cannot grow beyond L,

Thus, the zero-eld speci cheat singularity is rounded. Replacing in Eq.(5) $L_{\rm H}$ by L, it is seen that the maximum of the zero-eld speci cheat shifts to the lower temperature $T_{\rm p}$ (L). However, in contrast to the magnetic counterpart, where the length scale $L_{\rm H}$ / H $^{1=2}$ can be varied at will in terms of the magnetic eld strength, the length scale of the inhom ogeneities remains xed. In type II superconductors where inhom ogeneities are unavoidable, two limiting regimes, characterized by

can be distinguished. For $L_H < L$ the magnetic eld induced nite size e ect limits to grow beyond L_H , while for $L_H > L$ it is the length scale of the inhom ogeneities. Since L_H can be tuned by the strength of the applied magnetic eld (Eq.(3)), both limits are experimentally accessible. $L_H < L$ is satisfied for suiciently high and $L_H > L$ for low magnetic elds. Thus, the occurrence of a magnetic eld induced nite size e ect requires that the magnetic eld and the length scale of inhom ogeneities a ecting thermodynamic properties satisfy the lower bounds

It is important to recognize that these bounds hold, whenever uctuations are at work. Noting that them odynam ic and transport measurements are usually performed up to 12 T, it becomes clear that the magnetic eld induced nite size elect allows to trace uctuations, to extract critical properties of the homogeneous system and to derive a lower

bound for the length scale of inhom ogeneities which a ect the therm odynam ic properties of type II superconductors. Such an analysis may also help to distinguish between possible mechanisms where the length scale of the inhomogeneities enters in an essential way. Below, we give a summary of the main results of this paper. A related analysis of expansivity measurements on YBa₂Cu₃O₇ exposed to a magnetic eld was recently performed by Lortz [11], in terms of a comparison with a model for uniform by rotating ^4He [6].

 ${\tt W}$ e show that in isotropic extrem e type ${\tt II}$ superconductors and nonzero magnetic eld ${\tt H}$ the correlation length cannot grow beyond the \lim iting length scale L_H = $_0$ = (aH), where a is a universal amplitude. Since a turns out to be of order one, LH is comparable to the average distance between vortex lines. Given this limiting length scale, we derive the scaling expression for the line T_D (H), along which the correlation length attains the limiting m agnetic length scale L_H . It turns out that close to zero eld criticality the ratio between T_p (H) and the melting line T_m (H) is a universal number. These results, extended to anisotropic type II superconductors are found to be in good agreem ent with the experim ental results of Schilling et al. [12] and Roulin et al. [13] for YBa₂Cu₃O₇ . Moreover, we nd that the data of Roulin et al. [13] for the tem perature and magnetic eld dependent speci cheat coe cient, properly rescaled, falls on a single universal curve, which is the nite size scaling function. The phase diagram which em erges consists of the lines T_p (H_i) and T_m (H_i), where H_i is the i-th component of the applied magnetic eld H. Our analysis of the data for the optimally doped sample [13] provides consistent evidence for critical properties falling into 3D-XY universality class [14{16], while the data of the underdoped sample [17] uncovers the characteristics of a 3D-2D crossover [18,19]. Although the mean-eld scenario describes the experimental data of various type II superconductors with comparatively large correlation length amplitudes, including MgB₂ [3], 2H-NbSe₂ [4] and $Nb_{77}Zr_{23}$ [5], rem arkably well, we nd that this treatm ent underestim ates the relevance of uctuations. Indeed the experim ental data for the speci c heat coe cient is fully consistent with a magnetic eld induced nite size e ect, although the critical regime is not attained. As a by-product we deduce for the length scale of the inhom ogeneities a ecting the therm odynam ic properties of $YBa_2Cu_3O_7$, MgB_2 , $2H-NbSe_2$ and $Nb_{77}Zr_{23}$ lower bounds ranging from 182 A to 814 A. Surprisingly enough, 814 A applies to the cubic superconducting alloy N b₇₇ Z r_{23} . Since the available data does not extend to very low elds larger values are conceivable. In any case, these lower bounds are consistent with the estimates obtained from a nite size scaling analysis of the zero eld speci cheat data of nearly optimally doped YBa₂Cu₃O₇ single crystals, giving length scales ranging from 290 to 419 A [18,20]. This raises serious doubts on the relevance of the nanoscale spatial variations in the electronic characteristics observed in underdoped Bi-2212 with scanning tunnelling microscopy [21{24]. As STM is a surface probe, it appears to be that these nanoscale inhom ogeneities represent a surface property. Furtherm ore, in spite of the consensus that in type II superconductors in an applied magnetic eld a phase transition to a state of zero resistance should occur, we show that the magnetic nite size e ect points to the opposite conclusion. This is in agreement with the work reported in Refs. [25] and [26].

The paper is organized as follows: In Sec.II we present a short sketch of the nite size scaling theory [27,28] and show that in isotropic extreme type II superconductors and nonzero magneticeld H the correlation length cannot grow beyond the \lim iting length scale $L_H = \int_0^\infty e(aH)$, where a is a universal constant. Since a turns out to be of order one, LH is comparable to the average distance between vortex lines. Given this magnetic eldinduced limiting length scale, we derive the scaling expression for the line T_p (H), along which the correlation length attains the limiting magnetic length scale L_H . It turns out that close to zero eld criticality the ratio between T_p (H) and the melting line T_m (H) is a universal number. These results are then extended to anisotropic type II superconductors. Moreover, we nd that the data for tem perature and magnetic eld dependent specic heat coe cient, properly rescaled, should fall on a single universal curve, which corresponds to the nite size scaling function. In Sec.III we analyze experimental data for the tem perature dependence of the speci cheat coe cient in various magnetic elds in terms of the inhom ogeneity and magnetic eld induced nite size e ects. We concentrate on under- and optimally doped YBa2Cu3O7, where single crystal data for elds applied parallel and perpendicular to the ab-plane are available [12,13,17] and extend to the critical regime. A coordingly, the full potential of the magnetic eld induced nite size e ect can be explored. The analysis of the data for the optim ally doped sample provides consistent evidence for critical properties falling into 3D-XY universality class, while the data of the underdoped sample uncovers the characteristics of a 3D-2D crossover [18,19]. Although the mean-eld scenario describes the experimental data of various type II superconductors with com paratively large correlation length am plitudes, including M gB₂ [3], 2H-N bSe₂ [4] and N b₇₇ Z r₂₃ [5], rem arkably well, we nd that this treatment underestimates the relevance of uctuations. Indeed, the experimental data for the specic heat one cient is fully consistent with a magnetic eldinduced nite size e ect, although the critical regime is not attained. As a by-product we obtain for the length scale of the inhom ogeneities a ecting the therm odynam ic properties of YBa₂Cu₃O₇ ,MgB₂,2H-NbSe₂ and Nb₇₇Zr₂₃ lower bounds ranging from 182A to 814A. Surprisingly enough, 814 A applies to the cubic superconducting alloy N b₇₇Z r₂₃. Since the available data does not extend to very low elds larger values are conceivable. This raises serious doubts on the relevance of the nanoscale spatial variations in

the electronic characteristics observed in underdoped B i-2212 with scanning tunnelling m icroscopy [21{24]. A lthough we concentrate on the speci c heat, it is shown that the magnetic eld induced nite size e ect also a ects the other therm odynam ic and the transport properties, including the magnetoconductivity.

II. SKETCH OF THE SCALING THEORY FOR THE MAGNETIC FIELD INDUCED FINITE SIZE EFFECT

The nite size scaling theory is based on the assumption that the system feels its nite size when the correlation length becomes of the order of the conning length L. For a physical quantity Q this statement can be expressed as [27,28]

L denotes the relevant con ning length, T_c the transition temperature and (t;L = 1) the correlation length of the bulk system. Thus, the correlation length, (t;L = 1) = $_0$ tj, with critical amplitude $_0$, critical exponent, where = sign(t), cannot grow beyond L as t! 0. Thus at T = T_p , where

there is no singularity and the transition is rounded. Due to this $\$ nite size e ect the maximum of the speci c heat peak occurs at a temperature T_p shifted by

the magnitude of the peak located at $T_{\rm p}$ scales then as

between the critical amplitudes of the specic heat coecient A , correlation length and correlation volume V_c . is the critical exponent of the specic heat singularity and R are universal numbers. Since superconductors fall in the experimentally accessible critical regime into the 3D-XY universality class, with known critical exponents and critical amplitude combinations, we take the universal properties, including [16]

for granted. In superconductors the order parameter is a complex scalar for which one has to de ne below T_c the transverse correlation length T . It is proportional to the helicity modulus, related to the London penetration depth via [14,15,18]

Since real systems are not only inhom ogeneous but are almost always impure, it is important to clarify whether or not quenched disorder a ects the critical behavior. In general, the critical behavior of disordered systems is complicated, but there is a criterion, due to Harris [31]. It states that the critical behavior of disordered systems does not dier from that of the pure system when < 0. This is the case when the critical exponent of the special heat is negative.

Rewriting Eq.(14) in the form

we realize that the L dependence of the speci c heat coe cient at T $_{\rm p}$ allows to determ ine critical amplitude and exponent combinations. A useful generalization of this relation is obtained from Eqs.(9) and (10), namely [32,33]

where g (y) is the nite size scaling function of its argument. In the lim it L! 1 and at small but xed values of t, g (y = 1) = 1. When we leave L xed and consider the lim it t! 0, we obtain g (y) / jyj, while at T_p , where $y = y_p = t_p$ L= $_0^T$ = 1, Eq.(14) requires that g (1) = 1. This scaling form allows to determ ine how far the specicheat of a system with restricted extent can be described in terms of a universal scaling function.

The study of nite size e ects in the -transition of ⁴He, as the bulk is con ned more and more tightly in one or more dimensions [32,33], as well as computer simulations of model systems [28], have been a very good ground for testing such nite size scaling predictions. In this context it is essential to recognize that a nite size scaling analysis allows to assess the importance of critical uctuations and to extract universal critical point properties of the hom ogeneous system. Moreover, a systematic analysis also allows to determine the length scale and even the shape of the inhom ogeneities [32,33].

In type II superconductors and nonzero m agnetic eld H there is an additional limiting length scale. To derive this m agnetic length scale we note that the free energy density of an anisotropic type II superconductor adopts below but close to the zero eld transition temperature T_c the scaling form [18,30,34,35]

and a is a universal constant. This relationship between the limiting magnetic length scale and the transverse correlation length is also obtained from the scaling form

because e=a=1 follows from Eq.(22), rewritten in the form $f_s=k_B\,T_cQ_3=^T$ (T_c ;H) $^3=L_H^3$. Noting that the limiting magnetic length scale L_H does not depend on temperature it applies above and below the zero eld transition temperature. In particular, below T_c the transverse correlation length T (T;H) is bounded by L_H ,

This implies that in the (H;T)-phase diagram there is no line of continuous phase transitions requiring $^{\rm T}$ (T;H) to diverge. Furtherm ore, in the presence of a weak magnetic eld the thermodynamic property, O, of a type II superconductor takes below $T_{\rm c}$ the scaling form

It establishes the connection to the scaling form (9) for a system in a con ned geometry of length L.

In practice there are also inhom ogeneities of length scale L . As aforem entioned, two limiting regimes characterized by $L_H < L$; $L_H > L$ (Eq.(7)) can be distinguished. For $L_H < L$ the magnetic eld induced nite size e ect sets the limiting length scale, because T (T;H) is bounded by L_H , while for $L_H > L$, T (T;H) is limited by L, the length scale of the inhom ogeneities. Since $L_H = \frac{1}{0} = (aH)$ (Eq.(23)), both limits are experimentally accessible. $L_H < L$ requires su ciently large and $L_H > L$ smallmagnetic elds. Moreover, the occurrence of a magnetic eld induced nite size e ect requires that the magnetic eld strength exceeds the lower bound $H > 0 = aL^2$ (Eq.(8)). On the contrary its absence up to the eld H provides a lower bound for the length scale of the inhom ogeneities L > 0 = (aH) (Eq.(23)).

Supposing that $L_H < L$ is satis ed, the singularity in the speci c heat is replaced by a broad peak reaching its maximum value at $T_p < T_c$ which decreases with increasing eld strength. From Eq.(12) we obtain for the shift and with Eq.(14) for the height of the peak in the speci c heat coe cient the expressions

respectively. We note that for <0 (Eq.(16)) the peak height decreases monotonically even for small elds. Since for xed magnetic eld strength H, $J_p j / \int_0^T \int_0^{T-1} dt dt$, while $c(T_p) = T_p / \int_0^T \int_0^{T-3} dt dt$ becomes clear that the critical regime considered here can be attained in superconductors with su ciently small correlation length amplitude only. Here $J_p j$ can be tuned into the experimentally accessible range by increasing the magnetic eld, while $c(T_p) = T_p$ is controlled by the small inverse correlation volume.

Since the transverse correlation lengths which are parallel to the applied eld are limited by the length scale $L_{\rm H}$, Eq.(29) is readily extended to the anisotropic case for magnetic elds applied parallel to the a, b or c-axis:

The speci c heat coe cient at T $_p$ adopts then the form given by Eq.(5) with the correlation volume appropriate for the anisotropic case. This behavior applies when the condition $L_H < L$ (Eq.(7)), extended to the anisotropic case,

O therw ise the nite size e ect is due to inhom ogeneities. When the magnetic eld induced nite size e ect dominates, the scaling form (19) of the speci cheat coe cient adopts then with Eq.(31) or Eq.(28) the form,

A coordingly, given estimates for A = B and $_{0c}^{T}$, determined from experimental zero eld data or the magnetic eld dependence of t_p (Eq.(31)), their consistency can be checked in terms of this scaling relation. At T_p , where $y = y_p = 1$, we have g(1) = 1 and Eq.(18) is recovered, while for $y \neq 0$ it diverges as $g(y) \neq 0$.

At the str-order melting transition there is a discontinuity in the internal energy associated with coexistence of the Abrikosov lattice and the vortex liquid. This in turn gives rise to a -function peak in the specisc heat [37,38] and to a singularity in the scaling function G_3 (z) of the free energy density (Eq.(20)) at some universal value z_m of its argument. A coording to Eq.(20) the melting line T_m (H $_i$) is then xed by

turns out to be universal. Because a limiting length scale, like $L_{\rm H}$ / $H^{-1=2}$, also leads to a rounding of rst-order transitions [28], the vortex melting transition is expected to broaden with increasing magnetic eld.

We we are now prepared to analyze experimental data in terms of the nite size scaling theory.

III. COM PARISON W ITH EXPERIMENT

We have seen that measurements of thermodynamic properties in an applied magnetic eld open a rather direct route to trace thermal uctuations, to estimate various critical properties, to derive an upper bounds for the length scales associated with inhom ogeneities, to assess the relevance of critical uctuations and to probe the interplay of the nite size elects stemming from sample inhom ogeneities and the applied magnetic eld. In particular, the relevance of thermal uctuations is established whenever there is a remnant of the zero eld singularity at T_p , shifting to a lower value with increasing magnetic eld strength. In this case condition (31) is satisted and the eld dependence of the relative shift t_p should evolve according to Eq.(37). However, due to unavoidable inhom ogeneities the available experimental data do not extend to the asymptotic critical regime, as required to deduce estimates for the critical exponents. Since type II superconductors fall in the experimentally accessible critical regime into the 3D-XY universality class, we take the critical exponents and critical amplitude combinations, listed in Eq.(16), for granted.




FIG.1. Total species cheat of an untwined YBaCu₃O₇ single crystal with $T_c = 91.87$ K for $H_c = H$ kc. The numbers on top of the spike indicate the strength of the applied magnetic eld and the location of the melting transition. Taken from Schilling et al. [12]




FIG. 2. (a) t_p j versus H_c for the data shown in Fig.1. The solid line is Eq.(39) with listed in Eq.(16). (b) Melting line T_m (H_c) in term s of t_m jversus H_c for the data shown in Fig.1. The solid line is Eq.(41)

In Fig.1 we displayed the data of Schilling et al. [12] for the tem perature dependence of the heat coe cient of a YBa $_2$ Cu $_3$ O $_7$ single crystal with $T_c=91.87$ K at various magnetic elds applied parallel to the c-axis (H $_c$). As a remnant of the zero eld singularity, there is for xed eld strength a broad peak adopting its maximum at T_p which is located below T_c . As T_p approaches T_c , the peak becomes sharper with decreasing H and evolves smoothly to the zero-eld singularity, smeared by the inhomogeneity induced nite size e.ect. The spike at $T_m < T_p$ is due to the melting transition [12]. Since T_p increases systematically with increasing eld, condition (33) is satistic ed and there is a magnetic eld induced nite size e.ect. A coordingly Eq.(37) for the eld dependence of the relative shift should apply as long as 3D critical uctuations dominate. In Fig.2 we displayed t_p versus H for the data shown in Fig.1. The solid line is Eq.(37) with

H in T and given by Eq.(16). In the low eld regime, where this asymptotic form applies it describes the data remarkably well, while for t_p is 0.04 deviations pointing to corrections to scaling become manifest. In 4 H e this value leads with L = p \overline{h} = $(2am_4)$ and = (2) 1 s 1 to L 2 cm, which compares reasonably well with 5 10 2 cm, the estimate derived by Haussmann [6]. The existence of the rst order melting transition of the vortex lattice, seen in Fig.1 in terms of the spikes with numbers on the top, implies that the scaling function G_3 (z) in the free energy density (Eq.(20)) exhibits at some universal value z_m of its argument a smeared singularity. For a magnetic eld applied along the c-axis the melting line is then given by Eq.(37). In Fig.2b we compare this prediction with the experimental melting line, derived from the data shown in Fig.1, in terms of the solid line, which is

Since a limiting length scale, like L_H / $H^{-1=2}$, leads also to a rounding of rst-order transitions [28], the vortex melting transition is expected to become broader with increasing magnetic eld. This behavior appears to be confirmed by the extended study of the vortex melting transition in YBa₂Cu₃O₇ single crystals of Roulin et al. [13].




FIG. 3. f_p j versus H for YBa₂Cu₃O_{6:9} with f_c = 92:56 K derived from the data of Roulin et al. [13]. (a) f_p j versus H_{ab}; (b) f_p j versus H_c. The solid lines are Eqs.(43) with listed in Eq.(16).

To explore variations between data and single crystals of di erent provenance we show in Fig.3 t_p versus H_{ab} and H_c for YBa₂Cu₃O _{6:9} single crystal with $T_c = 92.56$ K derived from the data of Roulin et al. [13]. The solid lines are






FIG. 4. (a): $c(T;H_c)=T$ B = A f:f = versus $t=H_c^{1=2}$ for $YBa_2Cu_3O_{6:9}$ with $T_c=92:56$ K derived from the data of Roulin et al. [13], with and given by Eq.(16), c(H;t)=T B in J/K^2 gat and H in T. The values for A = and B are listed in Eq.(48). The solid line is Eq.(47); (b): Speci c heat coe cient c=T versus t of $YBa_2Cu_3O_{6:9}$ with $T_c=92:56$ K at various magnetic elds derived from the data of Roulin et al. [13]. The solid lines are Eq.(13) with and $A^+=A$ given by Eq.(16) and the parameters listed in Eq.(48). The deviations of the zero eld data from these lines reveal around t = 0 the nite size e ect due to inhom ogeneities.

As the data of Roulin et al. [13] are rather dense and extend close to zero eld criticality, a more detailed nite size scaling analysis appears to be feasible. U sing Eq.(35), it is seen from Fig.4a that data collapse is obtained over a rather wide range of the scaling variable. Indeed, nite size scaling requires the data to collapse on the universal curve g (y) with y = t $_0$ = aH $_c$ $_0^T$ $_0^T$. Furtherm ore, scaling also requires that at T_p , where $y = y_p = 1$, and for y! 0, g (1) = 1 and g (y) / $_0$ $_0$ $_0$ for < 0 should hold, respectively. and the critical exponent listed in Eq.(16), to indicate the inhom ogeneity induced deviations from the leading zero eld critical behavior of perfect YBa₂Cu₃O_{6:9}. Since the data collapse onto the universal nite scaling function has been achieved without any arbitrary tting parameter, the consistency with the magnetic eld induced nite size scenario is well con rmed. Furthermore, Fig.4b shows how the broad anomaly in the speci c heat coe cient sharpens and that the maximum height at T_p (H $_c$) increases, evolving smoothly to the zero eld peak, rounded by inhom ogeneities.

To estimate the correlation volume from the specic heat coe cient in terms of the universal relation Eq.(15) we note that $A = T_c$ A^2 , A (cm 3)= 10^4 = k_B = V_{gat} A (m J/K/cm 3) and V_{gat} = 8cm 3 give A = 7.96 10^4 A 3 , yielding with R = 0.815 (Eq.(16)) the correlation volume V_c $680A^3$, which is reasonably close to the value derived from the magnetic eld induced nite size e ect (Eq.(44)). As in zero eld the correlation volume V_c $J_p j^3$ cannot grow beyond the volume V_i of the inhomogeneities, this limiting volume scale is obtained from




FIG. 5. (a) j_p j versus H $_c$ for YBa $_2$ Cu $_3$ O $_{6:6}$ with T $_c$ = 642K derived from the data of Junod et al. [17]. The solid line is Eq.(47) with listed in Eq.(16). (b) H $_c$ versus j_p j of the same data. The solid curve is Eq.(55) which takes the correction to the leading scaling term, H $_c$ = 33:97 j_p j_p displayed by the dashed line, into account.

Noting that the critical amplitudes, the anisotropy = $\frac{T}{ab0} = \frac{T}{c0}^{1=2}$ and the length scale of the inhom ogeneities depend on the dopant concentration [19] it is instructive to analyze the data of Junod et al. [17] for underdoped YBa₂Cu₃O_{6:6} with T_c = 64.2K and 20 [29]. In Fig.5 we displayed the data for $\frac{1}{3}$ 0 jversus H_c together with

Thus, the critical amplitude of the correlation length $_{0c}^{T}$ increases in the underdoped regime, rejecting the approach to the 2D quantum superconductor to insulator transition in the underdoped limit, where tends to in nity [18,19]. Typically, the leading scaling behavior becomes valid when jbecomes mall and H is small. However, one needs to know: How small is small enough? As there are corrections to the leading scaling behavior we know, when jb is no longer small, the temperature dependence of the transverse correlation length scales as [15,16,18]

The dimensionless correction amplitude a $_{\rm T}$ will in general become larger near a crossover. As YB a $_2$ C u $_3$ O $_7$ undergoes with reduced oxygen concentration a 3D-2D crossover, a $_{\rm C}$ is expected to increase, while the critical regime where the leading term dominates shrinks. To substantiate this expectation and to illustrate the e ect of the corrections to scaling, we set $_{\rm C}^{\rm T}$ (T;H) = L $_{\rm H}$, to obtain with Eqs.(31) and (32) for H $_{\rm C}$ (t $_{\rm p}$) the expression

with and! given by Eqs.(16) and (53), respectively. This gives $_{0c}^{T}=40.86A$ which is considerably larger than $_{0c}^{T}=32.6A$, the value derived without the correction to scaling. On the contrary, a to the data displayed in Fig.3b yields H $_{c}=319.66\, t_{p}\, j^{2}\, (1-0.014\, t_{p}\, j^{2})^{-2}$, revealing that close to optimum doping the correction is up to $t_{p}\, j=0.04$ negligibly small, while in the underdoped sample it is significant down to $t_{p}\, j=0.02$. This confirms the expectation whereupon the 3D-2D crossover in the underdoped regime enhances the correction to scaling and reduces the critical regime where the leading scaling term dominates. From the data of Junod et al. [17] we also deduce that at the lowest attained eld, H $_{c}=0.2T$, a shift from T $_{c}$ to T $_{p}$ occurs. This yields with Eq.(34) the lower bound




FIG.6. j_p jversus H for N b₇₇ Z r_{23} [5], 2H -N bSe₂ [4] and M gB₂ [3] derived from the respective references. The straight lines are Eq.(57) with the parameters listed in Table I.

Next we turn to Nb₇₇Zr₂₃ [5], 2H-NbSe₂ [4] and M gB₂ [3], type II superconductors supposed to have comparative large correlation volumes. In Fig.6 we displayed f_p j versus H derived from the respective experimental data. In contrast to the corresponding plot for nearly optimally YBa₂Cu₃O₇ (Fig.3), the data points to a linear relationship. Consequently, the critical regime, where f_p j / H ¹⁼² with 2=3 holds (Eq.(37)), is not attained. Nevertheless, there is clear evidence for a magnetic eld induced nite size e ect, because T_p shifts monotonically to a lower value with increasing magnetic eld. Since the data points to an elective critical exponent 1=2 which applies over an unexpectedly extended range, we use Eq.(37) with 1=2 to derive estimates for the amplitude of the respective transverse correlation lengths and the correlation volume in terms of

with a = 3:12 (Eq.(40). The respective straight lines in Fig.6 are this relation with the parameters listed in Table I. For comparison we included the corresponding parameters for YBa₂Cu₃O_{6:9} and YBa₂Cu₃O_{6:6} where the critical regime is attained. It is evident that Nb₇₇Zr₂₃, 2H-NbSe and MgB₂ are type II superconductors with comparatively large correlation lengths. Compared to YBa₂Cu₃O_{6:9} and YBa₂Cu₃O_{6:6} the correlation volume is 3 orders of magnitude larger, which renders the amplitude of the specic heat singularity very weak (see Eq.(13)). Nevertheless, the unambiguous evidence for the magnetic eld induced nite size elect reveals that uctuations, even though not critical, are at work. For this reason there is no critical line T_{c2} (H) of continuous phase transitions, but a line T_{p} (H) where the specic heat peak, broadening and decreasing with increasing eld, adopts its maximum value and the correlation length attains the limiting magnetic length scale L_{H} . Because the uctuations are also subject to the nite size elect arising from inhomogeneities with length scale L, the magnetic nite size elect is observable as long as $L > L_{H}$. The resulting lower bounds for the length scale of inhomogeneities also ecting the thermodynamic properties are also included in Table I. Noting that these bounds stem from studies where no attempt was made to explore the

low eld behavior, it is conceivable that the actual length scale of the inhom ogeneities is much larger. To our best know ledge, the only absolute reference stems from the nite size scaling analysis of the zero eld speci cheat data of nearly optimally doped YBa₂Cu₃O₇, where L was found to range from 290 to 419A [20,18]. Interestingly enough, the largest bound found here applies to the cubic superconducting alloy Nb₇₇Zr₂₃. In any case, the lower bounds ranging from 182 to 814A raise serious doubts on the relevance of the nanoscale spatial variations in the electronic characteristics observed in underdoped Bi-2212 with scanning tunnelling microscopy [21{24}].

Using the fact that at the lowest attained magnetic elds, H = 0.1T ($Nb_{77}Zr_{23}$) [5], $H_{ab} = H_c = 1T$ ($2H-NbSe_2$) [4] and $H_{ab} = 1T$, $H_c = 0.5T$ (MgB_2) [3], a shift from T_c to T_p was observed, we obtain with Eq.(34) the quoted lower bounds for the length scale of the inhom ogeneities which a ect the thermodynam ic properties. For YBa₂C u₃O₇ the estimates stem from the critical behavior shown in Figs.3 and 5, quoted in Eqs.(43), (44), (50) and (51), and the lower bounds are Eqs.(45) and (56).




FIG.7. $c(H;T_p)=T_p$ versus H for N $b_{77}Zr_{23}$. Experimental data taken from M immelstein et al. [5]. The solid line is Eq.(2) rewritten in the form (58) and the parameters listed in Eq.(59).

The occurrence of uctuations in type II superconductors with comparatively large correlation lengths also implies a rounding of the special heat peak in zero eld, where inhom ogeneities set the limiting length scale. Such a rounding was found in the special heat data of polycrystalline M $g^{11}B_2$, obtained with high resolution accalorimetry [39]. Further evidence for the relevance of uctuations can be deduced from the special heat coefficient at T $_p$. In Fig. 7 we show the experimental data for N b_{77} Z r_{23} [5]. For comparison we included Eq.(2) in the form

Here uctuations enter via the coe cient b (Eq.(57)). For H > 0.2T the data is consistent with a linear relationship and the coe cient b derived from the eld dependence of T $_p$ (see Table I). The di erence between the zero eld value $c (H = 0; T_c) = T_c c = 2 \text{Im J/K}^2 \text{gat}$ and the lim it $c (H ! 0; T_p) = T_p = c = 18 \text{Im J/K}^2 \text{gat}$ is due to the triangular vortex lattice, for which the ratio between these coe cients should be 1:16 [2,5].

A lithough we concentrated hitherto on the speci cheat, it should be kept in m ind that the magnetic eld induced nite size elect also a ects other thermodynamic and the transport properties, including the magnetoconductivity. As an example we consider the linear magentoconductivity of a bulk sample. In the isotropic case the uctuation contribution scales in zero eld as / T z 1 [18], where z is the dynamic critical exponent. Together with the evidence for static 3D-XY critical exponents there is mounting evidence for z = 2 [18,30,40,41] deduced from zero eld data of the uctuation contribution to the conductivity. In the presence of a magnetic eld we obtain from Eq.(28) the scaling form

This implies that type II superconductors in a magnetic eld do not undergo a phase transition to a state with zero resistance. In particular there is no resistive upper critical eld H $_{c2}$ (T). It is replaced by the line H $_{p}$ (T) where the resistivity attains the residual value $(H_{p}) = 1 = (H_{p})$. A characteristic feature is the positive curvature, $d^{2}H_{p}$ (T)= $dT^{2} > 0$, for > 1=2. This anomalous behavior has been found in a variety of cuprate superconductors [42,43] and close to T_{c} the data appears to be consistent with 2 d=3, the value for 3D-XY critical behavior (Eq.(16)).

To sum m arize, we have shown that in type II superconductors subject to a magnetic eld the correlation lengths cannot grow beyond the magnetic length scale $L_{\rm H}$. Invoking the nite size scaling theory and the scaling form of the of the scaling form of the free energy density of an anisotropic type II superconductor close to zero eld criticality we determ ined $L_{\rm H}$ and explored the resulting nite size e ect. In contrast to its inhom ogeneity induced counterpart,

arising from inhomogeneities with length scale L, $L_{\rm H}$ / H $^{1-2}$ can be varied continuously in terms of the magnetic eld strength. Thus, as long as $L > L_H$ the magnetic eld induced nite size e ect is observable and allows to assess the importance of uctuations, to extract critical point properties of the homogeneous system and to derive a lower bound for the length scale of inhom ogeneities which a ect therm odynamic properties. Our analysis of specic heat data for under- and optim ally doped YBa2Cu3O7, where the critical regime is attained, revealed remarkable agreem ent with the nite size scaling scenario. On the other hand the existence of the limiting magnetic length scale does have even away from the regime where critical uctuations dominate essential consequences. Since the correlation length $^{\rm T}$ cannot grow beyond ${\rm L_H}$, there is no critical line ${
m H}_{
m c2}$ (T) retaining the continuous character of the zero eld transition. To illustrate this point we considered M gB₂, 2H-NbSe₂ and Nb₇₇Zr₂₃, type II superconductors with com paratively large correlation lengths. A lthough the analyzed experim ental data do not extend to the critical regim e, we have shown that there is a magnetic eld induced nite size e ect and with that uctuations at work. Furtherm ore, lower bounds for the inhom ogeneities a ecting the therm odynam ic properties have been derived. Their length scales range from 182 A to 814 A. Since the available data does not extend to low elds, much larger values are conceivable. This raises serious doubts on the relevance of the nanoscale spatial variations in the electronic characteristics observed with scanning tunnelling microscopy [21{24]. In any case, we have shown that the various predictions we have made here are experimentally veriable. In particular, the analogy with nite size scaling is robust and it should be possible to determ ine in exactly what regions the data collapses onto a one-variable scaling formulation and to what extent corrections to scaling can describe any deviations. Furtherm ore, in spite of the consensus that in type II superconductors in an applied magneticeld a phase transition to a state of zero resistance should occur, we have shown that the magnetic nite size e ect points to the opposite conclusion. This is in agreement with the work reported in Refs. [25] and [26].
