R etarded and nonretarded van der W aals interactions between a cluster and a second cluster or a conducting surface

Abstract

In some respects, a cluster consisting of m any atom s m ay be regarded as a single large atom . K now ing the dielectric properties of such a cluster perm its one to evaluate the form of the van der W aals (dispersion) interactions between two clusters or between one cluster and a surface. In this paper, we derive these interactions in two extrem e opposite regim es of separation: fully retarded and nonretarded. In the fully retarded regim e (very large separation), the m agnitude of the interaction is determ ined by just the static polarizability of the cluster(s). In the nonretarded regim e (sm all separation), we employ a single resonant frequency m odel of the cluster polarizability to derive expressions for the interactions' coe cients. Num erical exam ples are presented to dem onstrate that m any-body screening of these interactions can be signi cant. The results represent the corrections to the commonly used approxim ation of pairw ise additivity of interatom ic interactions.

I. IN TRODUCTION

Van der W aals (vdw) interactions have been much studied in recent years, in part because of increasing interest in phenom ena involving surfaces, interfaces, and nanoparticle interactions^{1,2,3,4,5,6,7}. In this paper, we evaluate two distinct interactions involving clusters, which we assume to be spherical. One of these is the interaction between two clusters, denoted A and B; the other is the interaction between a cluster and a at surface. We consider both of these interactions in two extrem e opposite regimes of separation: nonretarded and fully retarded, corresponding to sm all separation and very large separation, respectively. The word sm all" is used advisedly because we assume throughout this paper that the separation is large compared to the size of the clusters.

N onretarded vdw interactions, som etim es called London forces, can be derived from quantum mechanics and electrodynamics. Most research involving interactions within condensed states of m atter pertains to the nonretarded regim e because short-range forces predom inate in determ ining the physical behavior of such systems. However, the onset of e ects of retardation occurs at su ciently sm all distance scales (10 nm) that such e ects are offen present to some extent; they become particularly important when studying large molecules or clusters, because of their size. The interaction is said to be fully retarded 8,9,10 in the separation regime where the nite speed of light causes a signi cant attenuation of the (nonretarded) vdw interaction. Indeed, even the power law describing the distance dependence of the interaction is altered by retardation (increasing the fallo by one power of distance). The regime of retardation is that where the separation r is large compared to both the cluster size (radius R) and a typical wavelength determ ined by the spectra of both interacting species: = hc= E; here E is a characteristic energy in the electronic spectrum of the cluster and/or surface. If E is the rst ionization energy, for example, 0.1 to 1 m icron (for N a and Si, 0.24 m icrons and 0.15 m icrons, respectively). then The surface force apparatus has been used to measure van der W aals forces between two m acroscopic m ica surfaces¹¹. O ther techniques (e.g., atom ic force m icroscopy¹² and total internal re ection m icroscopy¹³ have been used to measure interaction forces, and a few techniques (e.g., laser trapping¹⁴ and di erential electrophoresis¹⁵) have been used to m easure sub-piconew ton interaction forces between B rownian particles. Figure 1 presents results for the interaction between two N a clusters obtained in this paper for the nonretarded and fully

retarded regim es, along with a plausible interpolation over the interval 0:1 < r = < 10.

Because vdw interactions arise from uctuating electrom agnetic elds in the interacting media, there arise many-body elects associated with screening of these interactions by neighboring particles within a cluster. This means that one should not simply add together the interactions of individual particles without taking the screening into account¹⁶. As an example, we demonstrate the importance of screening in the case of alkalim etal clusters. There occurs a general increase in the elect of screening as a function of cluster size, but the trend is not completely monotonic because of electronic shell elects on the cluster's polarizability.

The outline of this paper is the follow ing. Section II describes the case of fully retarded interactions. In that case, the vdw interaction is determ ined by just the static polarizability of the interacting clusters (because long wavelength elds give rise to the interaction). In Section III, we explore the nonretarded regime, for which all wavelengths contribute, in principle. That treatment requires the introduction of a model form for the polarizability as a function of frequency. In the present case, we employ the simplest possible model (single resonant frequency) that is consistent with both the static value and the known high frequency limit of the polarizability. Section IV summarizes our results and comments about possible extensions to related problem s.

II. FULLY RETARDED REGIME

The starting point of our analysis is the fact that the fully retarded interaction between two atoms (here denoted a and b) separated by distance r (with r) is known to satisfy⁸:

Note the interesting fact that the interaction falls o with distance as r^{7} , with a coe cient determ ined by the static atom ic polarizabilities (P_{a}^{0} , P_{b}^{0}) of the species involved. This behavior contrasts with the nonretarded vdw interaction in both the latter's power law (r^{6}) and its dependence on the frequency-dependent polarizability, rather than just the static value P^{0} (see Eqs. 10 and 11 below).

A. Cluster-cluster interaction

We now turn to the problem of the interaction between two clusters. The key idea of this paper is simple: one may treat a cluster as though it is a large atom, insofar as the cluster has an excitation spectrum with an energy gap and it is of nite extent. Here, we consider the case of separation r large compared to its size. Specifically, the present calculation requires that the cluster's radius R r. Validity of that criterion perm its one to use the local, dipolar approximation to describe the electrodynam ic response of the cluster to the uctuating electrom agnetic elds that are responsible for vdw interactions. Based on this argument, the interaction between two clusters A and B may be written

Here P_A^0 and P_B^0 are the static polarizability of cluster A and B, respectively, a subject of much attention in recent years^{17,18,19,21}. Now, one may ask a simple question: how di erent is this cluster-cluster interaction from a naive estimate, V_{est} , obtained from summing pairs of interactions between the constituent a, b atom s? The latter may be written as a product of the interatom ic pair interaction and the number of such interactions between the two clusters:

We compute the ratio of the exact result Eq. (2) to this estimate and de ne the ratio as a \screening" function S_{AB}^{r} :

This screening function is separable, a product of two independent screening functions f (N), each of which is the ratio of the cluster's polarizability to a nom inal cluster polarizability, equal to the product of the atom ic polarizability and the number of atom s. Because each of these f functions is less than one if N > 1, then $S_{AB}^{r} < 1$ if either of the clusters possesses more than one atom. Thus the true interaction is reduced relative to the naive estim ate V_{est} .

Figure 2 presents the screening function for the case of a Na cluster interacting with a second Na cluster. The static polarizability of the Na clusters $P^{0}(N)$ was taken from

theoretical results, obtained using the jellium model and density-functional calculations¹⁸. This simple model was adequate to explain the experimental polarizability data¹⁹. For the extreme case $N_A = 1 = N_B$, the screening function is unity, by denition. For increasing N, typically, the screening causes S_{AB}^r to decrease below one. Note that the reduction is by a factor near 0.4 for two 40 atom N a clusters and this is essentially the asympotic value²⁰ for N_A , N_B ! 1. The dependence on number is not monotonic, how ever, because of shell structure of the electronic states of the cluster. This nonmonotonic behavior makes the gure interesting; notice the shape of a \bat head" in the center of the Figure 2.

We remark that the hypothetical case of clusters comprised of weakly polarizable, inert gases represents an instance for which the functions whose product determines S_{AB}^{r} are close to 1, i.e. $P_{A}^{0} = N_{A}P_{a}^{0}$. Indeed, in the framework of local, continuum electrostatics, this relation is exact if the C lausius-M ossotti relation describes the static dielectric constant

of the material, since the dipole moment of a dielectric cluster²² in an external eld E is [(1)=(+2)]RE. Thus, the interaction between two such inert gas clusters is not significantly screened.

B. Cluster-surface interaction

Next, we address very brie y the case of a cluster (A) near the surface of a sem i-in nite perfectly conducting m et al, a simpli ed version of a more general adsorption problem. In that case, the cluster's interaction with the surface obeys a relation³

Here K⁰ = $3hc=(16^{2})$ and z is the separation between the cluster's center and the boundary of the surface. The ratio of this cluster-surface interaction to a naive estimate, based on N_A individual constituent atoms of the cluster is analogous to the ratio S_{AB}^{r} for the cluster-cluster interaction:

This behavior therefore involves the same function as the previous problem 23 .

Finally, we evaluate the retarded cluster-surface interaction in the case of a solid made of m olecules of static polarizability P_m^0 and density n. We specialize the discussion to the

situation where the product nP_m^0 1; this weak-screening limit is essentially the extreme opposite case from the perfect conductor considered above. In this new limit, the interaction V_{weak} can be evaluated by integrating the cluster-molecule interaction density $K nP_A^0 P_m^0 = r^7$ over the half-space z < 0 in the presence of the cluster, centered at distance d above the surface:

The result of that integration is:

W e m ay compute the ratio of this interaction to that of the perfect conductor with the sam e cluster (Eq. (5)):

Note that these interactions strengths are similar if nP_m^0 0.2. Even for such a small polarizability, therefore, the interaction is comparable to that obtained with a perfect conductor. In the case of an Ar solid, in contrast, the ratio in Eq. (9) is about 0.2.

III. NONRETARDED INTERACTION

We rst recall that the nonretarded interaction between two atoms a and b separated by a distance r is given by 8

where the constant C_6^{ab} is

Here, P_a (!) and P_b (!) are the dynam ic polarizabilities of the atom s, continued to im aginary frequencies ! = iu. The atom ic polarizability has the form

where f_{0n} is the oscillator strength that m easures the probability of the transition from the ground state 0 to the excited state n, at frequency $!_{0n}$.

A. Cluster-cluster interaction

To compute the interaction between two clusters A and B, we use the same idea as in the last section of considering the clusters as large atoms (R = r). In that case, we may write the cluster-cluster interaction as:

We propose a simple form for the dynam ical polarizability of the cluster²⁴:

designed to give the static polarizability of the cluster at zero frequency, and the known asym potic behavior, $P_A \, ! \, Z N_A e^2 = (m \, u^2)$ in the high frequency limit (free electrons) if we dene $!_A$ with

Here m is the electron m ass and Z is the number of electrons in the atom . An analogous aproximation can be made for the atom ic polarizability P_a (iu) using a single characteristic frequency $!_a$ to determ ine its form. The characteristic frequency of the cluster, $!_A$, is larger than the corresponding result for a single atom, $!_a$, by a factor of $1 = p \frac{T_A}{T_A}$. We have tested the quality of our proposed function by comparing it with the dynam ical polarizability of sm all m etal clusters, calculated by K resin within the random -phase approximation²¹. A ssum ing the cluster polarizability to be that from Eq. (14) (and using the corresponding approximation for the atom ic polarizability), we compute the ratio S_{AB}^{nr} between the nonretarded cluster-cluster interaction and the simple estimate that results from summing pair interactions, assuming Z = 1:

Figure 3 shows this function for the case of two interacting Na clusters. It shares the same qualitative behavior as the screening function in the retarded case (Eq. (4)). In the case a = b, $N_A = N_B$, $S_{AB}^{nr} = f_A^{3=2} (N_A)$. This compares with the result f_A^2 in the fully retarded limit (Eq. (4)).

B. Cluster-surface interaction

The nonretarded vdw interaction between an atom and a surface at separation d is given $\ensuremath{\text{by}}^3$

which can be approximated by

if the response is dom instead mainly by the resonance at $!_s$ (the surface plasm on resonance in the case of a metal). The parameter g_0 is equal to 1 in the case of a free electron metal, in which case the ansatz Eq. (20) is exact, with $!_s = \frac{p}{2}$ times the bulk plasm a frequency. Following the spirit of the previous sections, the van der W aals coe cient for the clustersurface problem is

A fler carrying out the integrations for C_3^{A} ^{surf} and C_3^{a} ^{surf}, the screening function for the cluster-surface interaction results:

We plot this function in Figure 4, for dierent ratios $!_s = !_A$. As can be seen in the gure, $S_{A \text{ surf}} ! \stackrel{p}{f_A}$, if $!_s !_A$, and goes to f_A when $!_s !_A$. This relative interaction ratio is the smallest in the latter case (since $f_A < 1$).

IV. SUMMARY

In this paper we have evaluated two kinds of interaction (cluster-cluster and clustersurface) in two extrem e opposite regimes of separation (nonretarded and fully retarded).

We have described a particularly simple result for the fully retarded interactions involving clusters. The interaction between two clusters is reduced (relative to the naive estimates) by a screening function, derived from the product of individual cluster screening functions f(N), that depend on the electronic properties of the cluster. Because the latter shows interesting, nonmonotonic behavior as a function of atom ic number, the dependence on the individual clusters' numbers is nontrivial, as exemplied in Figure 2. Qualitatively similar behavior occurs in the nonretarded case, seen in Figure 3.




FIG.1: D i erent regim es of the van der W aals interaction between two 20 N a atom s clusters, in units of a characteristic energy $E = h!_0$. The nonretarded regim e (NR) when R = r = 1 is analyzed in Section III, and the retarded regim e for separations such that r = 1 R = is explored in Section III. The interm ediate regim e (dashed line) is not considered in this work, but note that it can be interpolated between the r⁻⁶ (nonretarded) and r⁻⁷ (retarded) functional form s.

This work can be generalized in many ways. One potential extension involves exploration of the intermediate regime of separation. While straightforward in principle, this is complicated in practice, so we simply mention results obtained elsewhere for analogous problems in this intermediate separation regime (the dashed region in Figure 1). In the case of the interaction between two identical atoms, the elect of retardation is to reduce the nonretarded interaction by a factor of two when the atoms are separated by one-tenth of the characteristic wavelength in their excitation spectrum (i.e., r is about 40 nm if the relevant energy is 3 eV²⁵). In the case of the interaction between an inert gas atom, or sm all molecule, and a surface, the corresponding distance is somewhat sm aller, about 20 nm²⁶. These distances are su ciently sm all that one should not ignore the elects of retardation in many applications. If one were to accept the linear interpolation in Figure 1, the ratio of this interaction to the (extrapolated) nonretarded interaction at r = would be 0.49.

The second problem of potential interest is the e ect of a medium in which the clusters are dissolved. This is the principal focus of our future research. A third problem of potential interest is larger clusters (i.e. radii not much smaller than their separation). Both of these present no question of principle but neither problem is as simple computationally as the problem s described here.




FIG.2: Retarded screening function $S^{r}(N_{A};N_{B})$ for the case of two Na clusters containing N_{A} and N_{B} atom s, respectively.




FIG.3: Same as Fig.1 for the nonretarded interaction.




FIG.4: Nonretarded screening function $S_{A \text{ surf}}$ for the case of a N a cluster of N_A atom s interacting with a surface which has a characteristic energy h!_s.
