P seudogap and quantum -transition phenom enology in HTS cuprates

The bw-energy excitation spectrum of HTS cuprates is exam ined in the light of therm odynam ic, transport, quasiparticle and spin properties. Changes in the therm odynam ic spectrum associated with the norm al-state pseudogap disappear abruptly at a critical doping state, $p_{\rm crit} = 0.19$ holes per Cu. M oreover, ARPES data at 100K show that heavily damped quasiparticles (QP) near (,0) suddenly recover long lifetim es at $p_{\rm crit}$, relating an abrupt loss of scattering from AF spin uctuations. This picture is con rm ed by SR zero- eld relaxation measurements which indicate the presence of a novel quantum glass transition at $p_{\rm crit}$. Consistent with this picture resistivity studies on thin $\ln s$ of Y_{0.7}Ca_{0.3}Ba₂Cu₃O₇ reveal linear behavior con ned to a V-shaped dom ain focussed on $p_{\rm crit}$ at T = 0. The generic phase behavior of the cuprates may be governed by quantum critical uctuations above $p_{\rm crit}$ and the pseudogap appears to be caused by short-range AF correlations.

1. IN TRODUCTION

The highly anom alous properties of the high- T_c superconducting (HTS) cuprates are attributable in part to the presence of a norm al-state (NS) pseudogap extending across the underdoped region of the phase diagram. The onset of the pseudogap opens up a gap in the density of states (DOS) which

profoundly a ects all physical properties in both the norm all and superconducting (SC) states.¹ Considerable debate has ensued as to the nature of the pseudogap and, in particular, whether it is some form of precursor SC pairing² or a NS correlation which competes (or coexists) with SC.³ We believe the evidence is maly in support of the latter scenario and present here further supporting evidence. In particular we show that the SC ground state is strongly perturbed by the pseudogap and that the magnetic spectrum undergoes abrupt and major changes at the critical doping state p_{crit} at which the pseudogap and resistivity is connected to a V-shaped region in the T-p phase diagram that is centered on p_{crit} . That is, only at p_{crit} does the NS resistivity remain linear to T = 0. This behavior is consistent with a quantum critical point (QCP) scenario.⁴

2. THERM ODYNAM IC PROPERTIES

O ur starting point is to recognize that the therm odynam ic and transport behavior discussed here seems to be universal amongst the HTS cuprates. Thus we will alternate between the three com pounds $Y_{0.8}Ca_{0.2}Ba_2Cu_3O_7$ (Y-123), $Bi_2Sr_2CaCu_2O_{8+}$ (Bi-2212) and $La_{2 x}Sr_xCuO_4$ (La-214) under the assumption that our deductions are universal. O focurse there are some features which seem unique to La-214, such as a strong stripe character and a high degree of disorder, but the properties we discuss here are also realized in the other two systems.




Fig. 1. The doping dependence of various parameters for Bi-2212 (a) and E_g , (b) U_0 and (c) the normalized quasiparticle peak at (,0) and 100 K.

Each of these system s exhibits abrupt changes in their therm odynam ic properties at p_{crit} . This is illustrated, in the case of Bi-2212, in Fig. 1 using previously reported data.⁵ Panel (a) shows the doping dependence of the jump in the speci c heat coe cient, , and of the pseudogap energy, E_g , obtained by thing the temperature dependence of the entropy using a triangular NS DOS N (E) = N₀ (E = E_g) for E < E_g and N (E) = N₀ for E > E_g . Such a DOS is non-states conserving and has been shown to t the therm odynam ic data very well over a broad range of T and p.⁵

Panel (b) shows the p-dependence of the condensation energy U_0 . Notably the opening of the pseudogap, as shown by the value of E_g , is abrupt and it has an immediate e ect in sharply depressing U_0 and (a measure of the pair density). A coompanying these abrupt changes the super uid density at T = 0 is also sharply reduced, as shown by ac susceptibility⁶

eld-dependent speci c heat m easurem ent5 and SR.⁷ This re ects a sudden change in the ground state with the opening of the pseudogap and is not compatible with the precursor pairing m odels but rather suggests that P seudogap and quantum transition phenom enology

the pseudogap represents som e correlated state that coexists with SC.

3. QUASIPARTICLE W EIGHT AND LIFETIME

The Bi-2212 system has been widely investigated using other techniques, and many key observations on the pseudogap have been assembled for this system. We mention brie y recent scanning tunnelling microscopy (STM) m easurem ents which appear to suggest a very high degree of local inhom ogeneity. Pan et al.⁸ suggest that such disorder m ay be a characteristic of allHTS system s. W e believe this not to be the case. Inhom ogeneity involving separate spatial regions of SC and NS m etallic behavior would result in nite DOS at the Ferm i level that is not observed, while spatially sepaа rate insulating and metallic regions would result in a reduction of the NS DOS at high tem perature, T > E $_{\alpha}$ =k $_{B}$. This is not observed either, indeed the speci c heat coe cient for Bi-2212 is constant at high T, independent of doping.⁵ A stronger case, still, can be made with reference to NMR linew idths and transition broadening. M oreover, the abruptness of the various onsets shown in Fig. 1 raise major questions about the very large static spatial inhom openeity inferred from STM (30% spread in energy gap, local DOS and doping level). We emphasize that the heat capacity is a bulk measurement while STM probes just the outermost CuO_2 layer which is likely to be subject to inhom ogeneity arising from reconstruction, oxygen disorder and B i/Sr intersubstitution.

Another technique that has contributed in a major way to our understanding of the cuprates is angle-resolved photoelectron spectroscopy (ARPES). System atic studies of underdoped samples show that NS quasiparticle (QP) lifetimes are very short near (,0) due to pronounced scattering from antiferrom agnetic (AF) spin uctuations because it is at the zone boundary that the AF wave vector spans the Ferm i surface. This is manifested by the alm ost complete absence of the NSQP peak⁹ whose weight is redistributed due to these scattering events. On the other hand, near the zone diagonal QP lifetim es are long and the QP peak is fully recovered.⁹ W e have analyzed the leading-edge energy dispersion curves for a large num ber of reported m easurements on $Bi-2212^{9,10,11,12,13,14,15,16}$ at (,0) and at 100K (i.e. in the NS) and we have tted these to a background curve plus a Gaussian QP peak. The magnitude of the latter has been ratioed with that of the form er (as a measure of the loss or redistribution of QP weight) and plotted as a function of doping in panel (c) of Fig. 1. Rem arkably the QP weight is very small across the entire underdoped region and is abruptly and fully recovered at p_{crit} in the lightly overdoped region. (Them ost highly doped sample is for Bi-2201). While the data used is obtained from a variety of sources with di ering experim ental conditions, the changes are so m arked that they must re ect a real and dram atic alteration in the spin spectrum, presum ably the alm ost complete dem ise of scattering from AF uctuations. E lsew here we have presented evidence from other studies for the collapse of short-range AF correlations at p_{crit}. This includes inelastic neutron scattering in Y-123, induced local moments in Zn-substituted Y-123 samples and two-magnon Raman scattering in Bi-2212.¹⁷ This accumulated evidence is rather strong and implies that the pseudogap is associated with short-range AF correlations which suddenly disappear at p_{crit} , as does the pseudogap.

4. QUANTUM GLASS TRANSITION

One of the questions which arises from the foregoing is whether p_{crit} is a QCP. Therm odynam ic measurements show that there is no phase transition associated with the characteristic temperature $T = E_g = k_B$ which should rather be considered as a cross-over temperature. Various authors have proposed some form of hidden order parameter which is established below T .¹⁸ N one has thus far been substantiated. However we note that a quantum phase transition at p_{crit} could be associated with a spin-glass transition with long-range Edwards-Anderson order.¹⁹




Fig. 2. The doping dependence, for La-214, of the upper (open symbols, dashed curves) and lower (solid symbols, solid curves) crossover tem peratures, T_f and T_g , at which spin uctuations rst enter (10 ¹⁰ sec) and leave (10 ⁶ sec) the SR time window. D ata is shown for 0 (black), 1 (red) and 2% (blue) Zn substitution for Cu.

We have recently completed a series of zero- eld SR studies on the spin uctuation spectrum in pure and Zn-substituted La-214²⁰ These investigations allow the determ ination (for any given doping state) of the tem perature, T_f, at which spin uctuations rst enter the SR time window (10¹⁰ sec) and the tem perature, T_g, at which they have the SR time window (10⁶ sec) i.e. at which they become essentially static as far as the SR technique is concerned. These two crossover tem peratures are plotted in Fig. 2 for La_{2 x} Sr_xCu_{1 y} Zn_yO₄ with y = 0, 1 and 2%. For each Zn concentration the pairs of crossover tem peratures, T_f and T_g, converge to zero at p_{crit}. Thus at p_{crit} the rate of slowing down of spin uctuations diverges, a clear signature of a quantum glass transition. We note, without further discussion, the enhancement in T_f and T_g seen at 1/8th doping which co-incides with the local reduction in T_c. Evidently, AF spin uctuations slow markedly in this region, possibly due to incident stripe form ation.

AF spin uctuations are also slowed by Zn substitution and this, again, m oves T_f and T_g to higher values for a given p-value. In each case there is no evidence of slow uctuations (within the SR timewindow) for $p > p_{crit}$. O ne interpretation is that the m obile carriers for $p > p_{crit}$ ip spins so rapidly that the AF spin uctuation lifetime is suppressed e ectively to zero. There em erges, then, the picture that for $p < p_{crit}$ the AF spin lifetim e is long but the QP lifetim e at (,0) is strongly attenuated due to scattering from AF spin uctuations while for $p > p_{crit}$ the QP lifetim e at (,0) recovers while the spin lifetim e is strongly attenuated. The crossover is rem arkably abrupt.

5. LINEAR RESISTIVITY AND THE QCP




Fig. 3. Colour-scale plot, on the T p phase diagram, of $(T)=(_0 + T)$ for the resistivity of thin $\ln s$ of $Y_{0:7}Ca_{0:3}Ba_2Cu_3O_7$. T_c (p) is shown by the solid curve.

If there is a quantum glass transition (QGT) at p_{crit} then one expects, within the phenom enology of quantum critical behavior, a resistivity which is linear in T occurring at p_{crit} .⁴ To either side of the QGT the region of linearity would be expected to be pushed to higher temperatures thus describing a V-shaped dom ain of linear-T resistivity in the quantum critical regime which is focussed on p_{crit} . Within this picture the crossover line T (p) would form the boundary of the "V" for $p < p_{crit}$ while another line T⁰(p), for $p > p_{crit}$, would form the other boundary of the "V". This is precisely what is observed in the three model cuprates we are discussing. Below T (p) the resistivity (T) is found to be sub-linear while below T⁰(p) the resistivity of epitaxial thin Im sof Y_{0:7}Ca_{0:3}Ba₂Cu₃O₇ to show this very behavior.⁴ In Fig. 3 we show this data in a more illustrative way. We plot a map of the p- and T-

show this data in a more illustrative way. We plot a map of the p- and T - dependence of the resistivity with the high-tem perature linear-T dependence divided out. The gure shows that the region where $(T)=(_0+T)$ is close to unity indeed form s a V-shape about the critical doping state $p_{crit} = 0.19$ holes per Cu. A s can be seen, the tendency of this region to focus to p_{crit} at T = 0 is cut-o by the appearance of superconductivity. Ideally one would like to suppress SC so as to follow this behavior to low tem perature. The use of Zn substitution provides a possible route but the data is com plicated by the e ects of residual scattering and localization. Nonetheless Fig. 3 illustrates a phenom enology strongly rem in iscent of QCP behavior. Sim ilar studies could be carried out in high pulsed magnetic elds (perhaps com bined w ith Zn substitution) to expose this behavior to low tem peratures.

6. CONCLUSION

In the light of these compelling evidences for coexisting NS correlations and possible QCP behavior we believe it is time to abandon the previously widespread notion of the pseudogap deriving from precursor SC pairing. Clearly such pairing elects occur close to T_c , and indeed have been observed, but the dom inant pseudogap behavior that is observed over a large dom ain of the phase diagram (and to high tem perature) seems clearly to be associated with short-range AF spin correlations that result in the opening of a gap P seudogap and quantum transition phenom enology

in the NSDOS. This takes away spectral weight otherwise available for SC pairing around the Ferm i surface with consequent dram atic weakening of the ground-state SC as well as strongly modifying the NS properties. We hope that the present data (and other related data) will help establish much-needed consensus in these matters.
