Quasiparticle Delocalization Induced by Novel Quantum Interference in Disordered d-W ave Superconductors

Abstract

The diagram m atic approach is applied to study quasiparticle transport properties in two-dimensionald-wave superconductors with dilute nonmagnetic impurities both in Born and in unitary limits. It is found that a novel quantum interference process gives rise to a weak-antilocalization correction to the spin conductivity, indicating the existence of extended low-energy quasiparticle states. W ith com im g close to unitarity and the nesting, this correction is suppressed and eventually vanishes due to the global particle-hole symmetry.

In recent years there has been increasing interest in the understanding of lowenergy quasiparticle (QP) states in disordered d-wave superconductors [1]. The d_{x^2} v^2 wave pairing state is characterized by an anisotropic energy gap, which vanishes along four nodal directions. There exist low -lying D irac-type QP excitations near the gap nodes. In sharp contrast to the conventional s-wave superconductors, even nonm agnetic in purities can drastically change the behavior of the low-energy QP states in d-wave superconductors. A central issue, not noly experim entally relevant but also theoretically intricate, is whether these QP states are localized and how the disorder a ects the lowenergy QP transport properties. Over the last decade, a variety of conceptually and methodologically di erent approaches to the problem have been developed, many of these theories contradict each other. Based on the self-consistent treatments [2], a nonlinear sigm a m odel [3], or num erical studies [4, 5, 6], som e groups suggested that all the QP states are localized. On the other hand, Balatsky and Salkola have shown that a single strong in purity produces a virtual-bound state at zero energy, and the long-range overlaps between these in purity states yield an extended QP band [7]. The singularity in the density of states (DOS) at zero energy obtained recently by the nonperturbative T-m atrix method signals the QP delocalization as well[8]. The possible appearances of critical states [9, 10] and localization-delocalization transitions [11] in random D irac ferm ions have been also discussed. As a result, the problem of QP (de) localization

in disordered d-wave superconductors still remains controversial and deserves further scrutiny.

The problem of low -energy QP localization was usually studied or discussed on the basis of calculations of the DOS [2, 6, 8, 9]. An alternative approach to this issue is to calculate the spin conductivity, which was st proposed and done by Senthil et al. based on the nonlinear sigm a model[3], and recently used by Zhu, Sheng and Ting based on the num erical transfer m atrix m ethod [4]. It is well known that the quantum interference e ects (Q E s), resulting from the cooperon and di uson in diagram matic language, play an important part in the low-energy QP transport in two-dimensional (2D) disordered d-wave superconductors [1, 3, 12, 13]. Unlike in a norm alm etal, every cooperon and di uson mode in the retarded-advanced (RA) channel entails a corresponding mode in the retarded-retarded (RR) or advanced-advanced (AA) channel due to the local particle hole symmetry (LPHS) in the superconducting state[14]. In the unitary limit and nesting case, each of these 0-m ode cooperons and di usons has a -m ode counterpart induced by the global particle-hole symmetry (GPHS) [13, 15]. Recently, the above sym m etries in these G oldstone m odes have been used to account for the physical origin of previous contradictory theoretical predictions for the DOS in disordered d-wave superconductors[15]. It is highly expected that the features of these Goldstone modes could be used to address the issue whether the low-energy QP states are localized.

In this Letter we present a diagram matic study of the Q Es on low-energy QP transport properties in 2D d-wave superconductors with dilute nonmagnetic in purities both in Born and in unitary limits. At the one-loop level, we do not not impurity-scattering polarization diagram related to the LPHS, which has never been considered in the previous diagram matic analyses. This novel quantum interference process is found to have a profound e ect on the spin conductivity. It is shown that, in general, the spin conductivity is subject to a weak-antilocalization correction while the electrical conductivity has a weak-localization correction. In the singlet superconductors, the spin of QPs is a good quantum number but the charge is not [3]. Therefore, this weak-antilocalization e ect indicates the existence of extended low energy QP states. With coming close to unitarity and the nesting, the corrections of both spin and electrical conductivities are suppressed, and eventually vanish due to the GPHS. A sem iclassical picture involving interfering trajectories of the novel quantum interference process is also presented.

Let us start from a most extensively studied model for a 2D $d_{x^2 y^2}$ -wave superconductor, in which the normal-state dispersion and energy gap are given, respectively, by $_k = t(\cos k_k a + \cos k_y a)$ and $_k = 0(\cos k_x a \cos k_y a)$, with t the nearest-neighbour hopping integral, a the lattice constant, and $_p$ the chem ical potential. In the vicinity of the four gap nodes $k_n = (k_F; k_F) = \overline{2}$, the QP spectrum $_k = (k_F^2 + k_F^2)^{1=2}$ can be linearized as $_k = [(v_F K)^2 + (v_g K)^2]^{1=2}$, where $v_f = (\ell_k = \ell_k)_{k_n}$, $v_g = (\ell_k = \ell_k)_{k_n}$, and K is the momentum measured from the node k_n . Consider pointlike nonmagnetic in purities to be random by distributed with low concentration n_i and the impurity potential V, then the time-reversal and spinrotational symmetries are preserved (symmetry class CI[14]). In the self-consistent T-matrix approximation, the QP self-energy can be expressed in the Nambu spinor representation as[15] $P^{R(A)}() = n_i T^{R(A)}() = (i_k) + \frac{1}{3}$ for j j . Here

is the mass renormalization factor, is the impurity-induced relaxation rate, is a dimensionless parameter, and $_0$ and $_i$ (i = 1;2;3) stand for the 2 2 unity and Pauli matrices, respectively. A use of D yson's equation yields the impurity-averaged one-particle G reen's functions as

The in purity-induced DOS at zero energy is calculated as $_{0} = (1 -) \text{Im}^{P} \text{TrG}_{k}^{R}(0) = 41 = {}^{2}v_{f}v_{g}$, where $1 = \ln(=) > 1$ with ${}^{P}\overline{v_{f}v_{g}}=a$. The parameters , , and can be evaluated consistently [15], yielding $= 2n_{i} = {}_{0}(1 + {}^{2})$, $= (1 - {}^{2})(1 - {}^{2}$

In the generic situations, only the 0-m ode cooperon and di uson contribute to the Q IE [13, 15]. Owing to the LPHS, ${}_{2}G_{k}^{R}()_{2} = G_{k}^{A}()$, they exist both in RA and RR channels, and can be expressed as D'(q; ; ${}^{0})^{RR(A)} = C'(q; ; {}^{0})^{RR(A)} = {}_{i}C(q; ; {}^{0})^{RR(A)}_{ii}$ i, where




Figure 1: Leading polarization diagram swith 0-m ode cooperon (shaded blocks). The doubled line in Fig. 1(d) represents a nonsingular ladder.

with $c_0^{RA} = c_1^{RA} = c_2^{RA} = c_3^{RA} = c_0^{RR} = c_1^{RR} = c_2^{RR} = c_3^{RR} = 4^{2} = 0$ and $D = (v_f^2 + v_g^2)=41$ the QP di usion coe cient. Equation (2) is valid both in Born and in unitary limits. As in the study of disordered interacting electron system s[16], all the leading polarization diagram s responsible for the Q IE can be generated from the low est-order self-energy corrections Figs. 1 (c) and 1 (d) in Ref.[15]. Figure 1 represents all the one-loop diagram s with 0-m ode cooperon. Diagram s 1 (a) and 1 (b) have been studied by A Itland and Z imbauer in the context of the random matrix theory of mesoscopic norm al/superconducting system s[14]. Figure 1 (c) is a new polarization diagram, its contribution can be shown to be of the same order as that of Figs. 1 (a) and 1 (b). It can be shown that Fig. 1 (d), as well as all the one-loop diagram s with 0-m ode coperon in [17]. Therefore, to the lowest order, it is Figs. 1 (a) {1 (c) that result in the Q IE. The norvanishing contributions of both diagram s 1 (a) and 1 (c) stem from the existence of the cooperon in RR channel. We wish to emphasize here that diagram 1 (c) describles a novel quantum interference process in 2D d-wave superconductors. A s will be shown below, it is the existence of diagram 1 (c) that leads to a weak-antilocalization correction to the \classical" value of the spin conductivity.

The Kubo formula is used to calculate the QP transport ∞ cients. For the spin conductivity, each vertex of the diagrams in Fig. 1 contains a vector = $(v_{g 1} + v_{f 3})=2[18]$. The contributions of these diagrams to the spin conductivity can be expressed by ^s = (1=2) Re(^{RA} ^{RR}) (= a;b;c), where ^{RA} and ^{RR}

stand for the corresponding zero-frequency spin current-current correlation functions in RA and RR channels, respectively. The expressions for RA are given by

with $G_{k}^{R,(A)} = G_{k}^{R,(A)}(0)$ and $C(q)_{ii}^{RR,(A)} = C(q;0;0)_{ii}^{RR,(A)}$. The expressions for ^{RR} are easily obtained by replacing \A " by \R " in those for ^{RA}. As an example, we evaluate C_{c}^{RR} as follows

with $M_q = \frac{P}{k} G_q^R G_k^R$, $(G_k^R G_k^R)$, where the sum mation over k is restricted in the vicinity of the four gap nodes. For small q, M_q can be evaluated to be

where = $(v_f^2 + v_g^2)=2v_f v_g$, = $(v_f^2 \quad v_g^2)=2v_f v_g$, and $\hat{q} = q$ (fg + gf) with f and g the unity vectors parallel, respectively, to v_f and v_g at one of the four nodes. The upper and lower cuto s of q are set to be 1=1 and 1=L, respectively, where $l_e = D = 2$ is the elastic mean free path and L is the sam ple size. Substituting Eqs. (2) and (4) into Eq. (3), we can readily obtain $C_c^{RR} = (4 = 1) \ln (L = 1)$. Sim ilarly, we can show that $C_c^{RR} = 0$. As a result, we get the contribution of diagram 1 (c) as

U sing the same procedure, we obtain $a^{s} = b^{s} = 2 = (1-2^{2}) \ln (L=l_{e})$. The total correction to the spin conductivity is given by $s^{s} = 2 a^{s} + b^{s} + 2 c^{s}$, leading to a weak-antilocalization correction as

where ${}_0^s = (v_f^2 + v_g^2) = 4 {}^2 v_f v_g$ is the universal spin conductivity [3, 18] and satisfies the Einstein relation ${}_0^s = {}_0D = 4$. For the electrical conductivity, each vertex in the diagram s equals to $ev_f {}_0$ [18], from which we can easily show that ${}_b = {}_c = 0$. Then the total correction to the electrical conductivity is given by $= 2_a$, yielding a weak-localization correction as

with $_0 = e^2 v_f = {}^2 v_g$ the universal electrical conductivity [2].

In the unitary limit (! 0) and at the perfect nesting (! 0), there exist the -m ode cooperon and di uson [13, 15]. Owing to the GPHS we have ${}_{2}G_{k}^{R,(A)}()_{2} = G_{Q+k}^{R,(A)}()$ with Q = (=a; =a) the nesting vector. Any small deviation either from the unitary limit or from the perfect nesting makes the -m ode cooperon and di uson gapped. At nite L, both corrections given by Eq. (8) are suppressed by decreasing = and vanish at = 0, indicating that s ! ${}^{s}_{0}$ and ! 0 . This result is in agreement with the num erical studies for s in the weak-disorder lim it [4]. Here we show that the physical origin is the existence of -m ode cooperon. The contributions of 0-m ode and

-m ode cooperons have the sam e m agnitude but opposite signs due to the GPHS.As a result, the corrections to the spin (electrical) conductivity coming from the 0-m ode and -m ode cooperons just cancel each other out.




Figure 2: Sem iclassical scattering paths of QPs corresponding to Figs. 1 (a) {1 (c).

It is instructive to analyse the scattering processes described by Fig. 1. While Fig. 1(a) yields a suppression of forward scattering of QPs, Fig. 1(b) corresponds to an enhancement of back scattering. Therefore, both Figs. 1(a) and 1(b) give rise to the weak-localization e ect on the QP states. Figure 1(c) represents a more complicated scattering process, including an enhancement of forward scattering (k and k^0 located near the same node) and a suppression of back scattering (k and k^0 located near the oppsite nodes). The total contribution of diagram 1(c) leads to a weak-antilocalization e ect on the QP states. As has been seen above, the QP delocalization stems from the fact that the weak-antilocalization e ect prevails over the weak-localization one. In order to understand the novel Q E, we depict in Fig. 2 the Feynm an paths corresponding to diagram s 1(a) {1(c). Figure 2(a) describes a pair of QP scattering paths, in which

the closed loop circled twice involves only one of the two paths. Figure 2 (b) represents a pair of paths that di er by a sequence of scattering events transversed in opposite directions. The scattering paths in Fig. 2 (c) look like a composite of Figs. 2 (a) and 2 (b). All the interference e ects in Fig. 2 arise from a combination of impurity and Andreev scattering processes. In the unitary limit and at perfect nesting, the contributions of 0-m ode and -m ode cooperons cancle each other. This is because the phase di erences of coherent paths in Fig. 2 for -m ode cooperon di er by from those of 0-m ode cooperon, due to the additional GPHS.

Since the QP spin is conserved, the behavior of the dimensionless spin conductance $g^s = {}^s = (1=2)^2$ as a function of L enables construction of a scaling theory of QP (de)localization [3]. The one-parameter scaling function is de ned by (\hat{g}) = d ln g^s=d ln L. It is easily shown that both Eqs. (6) and (8) can be collapsed into a single universal scaling function as

for $g^s ! 1$. The positive (g^s) strongly indicates the existence of extended low -energy QP states. This spin m etal state is characterized by the absence of charge di usion, as the electrical conductivity has a weak-localization correction. The observation that

 (g^{s}) decreases with g^{s} in plys that these extended low-energy QP states are dimensional of the usual extended bands. We argue that this novel phenomenon is related to the strong anisotropy of energy gap in d-wave superconductors, as the wave vectors of all extended low-energy QP states are nearly along the four nodal directions. It is worthy to mention that the extended low-energy QP states have been predicted by Balatsky et al.[7] from the novel network of delocalized in purity states in the unitary limit. However, the physical mechanisms for the formation of extended states are dimensional error of the calculations in Refs.[1, 3, 12] are incomplete in which the contribution of Fig. 1 (c) was omitted (see Fig. 1 in Ref.[12]), and thus yielded a negative logarithm is expected to exist in superconductors that belong to symmetry classes C and D.We note that RR-cooprons are not in unced by the time-reversal breaking[1, 3, 12]. How a magnetic will ever all (or dilute magnetic in purities) a ects the QP delocalization e ect is another interesting and open problem.

The QP delocalization e ect is expected to have a manifestation in the low-tem perature them all transport property. Since the QP energy is also conserved, the electronic thermal conductivity K should obey the W iedem ann-Franz law K = T^S = 4²k_B² = 3. Here the tem perature dependence of the quantum interference correction ^S(T) results from the dephasing time (T), the latter m ay be obtained by considering the interactions between QPs[13]. Since the self-consistent T-matrix approximation is valid only for the case of dilute in purities[15], we do not rule out the possibility of localized low-energy QP states at higher in purity concentrations. Should it appear, there m ight exist a quantum transition from spin metal to spin insulator in 2D disordered d-wave super-conductors, which is expected to be observed in a low-tem perature therm all transport experiment. By increasing the impurity concentration, the tem perature dependence of K would change from metallic to insulating behavior.

In conclusion, we have studied the Q E s on the low-energy Q P transport in weaklydisordered 2D d-wave superconductors both in Born and in unitary limits. We nd a new, one-loop diagram related to the LPHS, which qualitatively modiles the usual weak-localization results. In generic situations, the existence of this novel quantum interference is shown to yield a weak-antilocalization correction to the spin conductivity. W ith coming close to unitarity and the nesting, this correction is supressed and eventually vanishes due to the GPHS.W ith a universal one-parameter scaling function, we show that the novel Q E can produce the extended low-energy QP states in the weak-disorder limit.
