Phonon dispersion and electron-phonon interaction for Y B a_2 C u_3 O $_7$ from rst-principles calculations

W e present a rst principles investigation of the lattice dynam ics and electron-phonon coupling of the high-T_c superconductor Y Ba₂C u_3O_7 within the fram ework of density functional perturbation theory using a mixed-basis pseudopotential method. The calculated phonon dispersion curves are in excellent agreem ent with R am an, infrared and neutron data. C alculation of the E liashberg function

 2 F leads to a small electron-phonon coupling = 0.27 in disagreem ent with earlier approximate treatments. Our calculations strongly support the view that conventional electron-phonon coupling is not an important contribution to superconductivity in high-T_c materials.

Since the discovery of superconductivity in copper oxides in 1986 m any di erent m echanism s have been suggested to explain the high transition temperatures observed in these m aterials [1]. However, even after more than 15 years of intensive research no consensus has been reached apart from the fact that conventional electronphonon coupling alone cannot explain the observed transition temperatures [2, 3, 4]. Even the much simpler question concerning the m agnitude of electron-phonon coupling has not been answered conclusively due to the fact that calculations in the past treated the lattice dynam ics only in a very approximate way. Recent progress in the ab initio calculation of the lattice dynam ics has m ade it possible to overcom e these limitations.

Modern bandstructure calculations together with abinitio determ ination of the phonon dispersion, electronphonon coupling and solution of the E liashberg equations have made it possible to calculate transition temperatures and study in detail the electron-phonon coupling. This has recently been done very successfully for the new ly discovered superconductor M qB_2 [5]. For high-T $_{c}$ superconductors (HTSC) in the past how ever only a few attempts have been made to proceed along the above mentioned road map to a deeper understanding of the electron-phonon coupling [2, 3, 4, 7, 8, 9]. The most involved ones are those concerned with La2CuO4 and doped CaCuO₂. For La₂CuO₄ the complete phonon dispersion has been calculated how ever no electron-phonon coupling was determined. Complications arise from the fact that the calculations are carried out for the high-T c tetragonal phase while at low T_c experimentally an orthorhom bic phase is observed. M ore in portant how ever is the fact that for undoped La₂CuO₄ an anitferrom agnetic non-metallic ground state is observed while LDA calculations nd a m etallic ground state which questions the reliability of the calculations. The system $CaCuO_{2}$ which is much simpler, also requires hole doping which has been taken into account in an average way, how ever only after properly doping the Ferm i surface becom es sim ilar to those of other high-T c superconductors. Thus these results are also questionable. To our know ledge

so far all other ab-initio treatments are restricted to the calculation of phonon modes for the -point only. In addition, even these calculations are not complete but have been restricted to modes of special symmetry classes only. Due to these limitations estimates of the coupling strength are not very accurate, thus asking for a more complete treatment of the electron-phonon coupling in the whole Brillouin zone (BZ).

To clarify the role of electron-phonon coupling in the copper oxides we have studied as a prototype $YBa_2Cu_3O_7$ along the above mentioned lines. This system has been selected since it is the best experimentally studied high-T_c superconductor with detailed inform ation available about the Ferm i surface and the lattice dynamics and in addition does not have the com plications of doping and/or structural phase transitions. Furthermore, bandstructure calculations based on the local-density approximation for exchange and correlation (LDA) have been successful in describing the Ferm i surface and account properly for the metallic ground state [6]. For $YBa_2Cu_3O_7$ we have carried out a system atic study of the lattice dynam ics and the electron-phonon coupling using the mixed-basis pseudopotential method [10]. For all atom swe have used well-tested potentials of BHS-type [11]. As valence states we included Y4s, Y4p, Ba5s, Ba5p and O2s which led to fairly deep potentials, but they could be dealt with very e ciently due to the m ixed-basis form ulation. The wave functions were constructed from localized s,p,d functions at the yttrium and barium sites, s and p functions at the oxygen sites and d-functions at the copper sites supplemented by plane waves with an energy cut-o of 20 Ry. Detailed tests were carried out to ensure convergence with respect to the number of plane waves as well as with respect to k-point sam pling. For the structural optim ization 576 kpoints in the BZ together with a Gaussian sm earing of 0.2 eV have been used. The calculation of the phonon dispersion is based on a recently developed mixed basis perturbation approach [12] which also allowed for the calculation of the electron-phonon coupling [13]. Since these parts are very k-point sensitive up to 5184 k-points

in the BZ have been used here. Allour calculations were carried out using the local exchange-correlation potential of Hedin and Lundquist [14].

Since $YBa_2Cu_3O_7$ crystallizes in the orthorhombic crystal structure optim ization requires the determ ination of 8 parameters (the length of the axis a, b, c and 5 internal positions) (see Fig. 1). In table I our results are sum marized and compared to all-electron results [6] as well as experimental data [15, 16].

The two calculations give very sim ilar results and the di erences are well within the limit of numerical accuracy. The calculated equilibrium volume turns out to be 4% to 5% smaller than the experimental one in agreement with previous calculations [2, 6] and general trends observed for LDA-calculations.

Having determ ined the equilibrium structure we now proceed to the calculation of phonon modes. For com parison with other calculations as well as experimental studies we concentrate rst on the point. Here, besides neutron scattering studies also R am an and infrared data are available. Table II sum marizes the even symmetry modes and compares our results with those of an all-electron study [9](full potential linearized augmented plane-wave calculations (FLAPW)) which is to our know ledge the most extensive phonon study available up to now as well as with experimental data [17, 18]. As pointed out in

connection with the FLAPW -study structure optim ization has an important e ect on phonon frequencies. This has also been found in our study. The agreem ent between both theoretical treatments and the Ram an data is very satisfactory. The pseudopotential treatment is of equal quality as the FLAPW -m ethod, in addition it is com putationally less dem anding and allow s thus the calculation of odd m odes as well which are given in table III together with neutron- and IR -data [18, 19].

So far, we have discussed -point modes only, how ever, a reliable calculation of electron-phonon coupling requires the know ledge of the complete phonon disper-

sion throughout the BZ.R esults for dimentions in the BZ obtained using our mixed basis perturbation approach [12] are presented in Figs.2 and 3. The modes are classified according to symmetry. For comparison also experimental data points are indicated. The dispersion curves were obtained by determining the dynamical matrix on a (4,4,2) reciprocal lattice grid in the BZ.K eeping in mind the complexity of the system the results are in excellent agreement with the available neutron data.

A num ber of points are worth m entioning in connection with the dispersion curves. The strong renormalization in respect to YB a_2 C u_3 O $_6$ of the top-m ost mode of $_1$ -symmetry along [100] shows up quite naturally in these calculations while model studies had extremed i culties in reproducing this behavior. The eigenvector shows that it is an oxygen bondstretching mode in the Cu-O plane.

For experimentalists one of the major obstacles in the past has been the lack of untwinned single crystals of $YBa_2Cu_3O_7$ which made sometimes the assignment of a measured phonon to the (100) or (010)-direction very di cult. Som e of these am biquous cases have been reassigned in view of the calculations and in agreement with very recent experim ental studies [20]. Concerning the role of the Cu-O chains we found that most of these modes are in the range between 10 and 20 meV and only oxygen modes along the bond direction are high-lying ones with frequencies around 60 m eV. No indication of a possible instability of the bond-bending chain modes (as proposed by earlier calculations [2]) was found in agreem ent with experim ent. Consistent with the expectation of weak coupling perpendicular to the Cu-O-planes the dispersion in (001) direction is very sm all.

In the upper panel of F ig. 4 we show the generalized phonon density-of-states which should be compared with the neutron-scattering results presented in R efs. [21, 22]. Peaks and even shoulder positions agree quite well, as also the frequency cut o of 75 to 80 m eV. The ratio of peak intensities di ers substantially between the two m easurem ents which is most likely due to the sensitivity of intensities to the background corrections. This prohibits comparison with our calculation.

To address the superconducting properties we have calculated the so-called E liashberg function ${}^{2}F(!)$ [23], using a very ne (24,24,4) k-point grid in performing the Ferm i-surface average of the electron-phonon matrix elements [24]. Extensive tests have shown that this grid is su cient for our calculations. Results are presented in Fig. 4 (lower panel). Comparing the phonon density of states F(!) and ${}^{2}F(!)$ we nd a substantial shift of weight for ${}^{2}F(!)$ to higher frequencies. From the E liashberg function we calculate the electron phonon coupling constant $= 2 {}_{0}^{-1} d! {}^{2}F(!)=!$ which gives = 0.27. For the logarithm ically averaged phonon frequencies as de ned in Ref. [25] we nd 27.7 meV. A fter solving the isotropic gap equation for *=0 we obtain only a T_c of 2 K. Any realistic * suppresses superconductivity completely.

The very smallvalue of is in substantial disagreement with earlier estimates based on -point results only. Analyzing the behavior of throughout the BZ we nd it to be varying by a factor of two only, however, variation as function of individual modes for given q is much larger. For the -point for example modes of A_g and B_{1u} -symmetry account for 80% of . The largest contributions come from modes in the copper-oxygen planes as expected. Previous estimates of assumed that all modes at contribute with similar strength as the A_g modes. This elucidates why -values of the order of 1 or even larger have been obtained. How ever, this is a pure artefact of the unjustied assumption.

R am an measurements at allowed for the determ ination of the anomalous frequency shifts of lattice vibrations occurring when cooling a superconductor below T_c [26]. Based on a theory by Zeyher and Zwicknagl for the phonon-self energy it could be shown that values of $_1$ =0.02 for the A_g mode around 42 m eV and $_2$ =0.01 for the A_g-m ode around 54 m eV, as determined by an LM TO-calculation [3], are consistent with the observed experimental frequency shifts. Our calculation give slightly larger values of $_1$ 0.06 and $_2$ 0.02 which are equally consistent with the measurements due to the

approxim ations inherent in the calculation of the phononself energy [27].

So far we have discussed only s-wave pairing, how ever m any experim ental facts support d-w ave pairing [28]. In the much simpler system CaCuO₂ the in uence of s-versus d-pairing has been studied [7] and it has been found that both channels give very sim ilar results for which should also hold for $YBa_2Cu_3O_7$. One other question which has not been discussed so far is the in uence of correlations beyond LDA. Here the strongest argum ent in favor of our calculations is the fact that the calculated phonon dispersion is in very good agreem ent with experiment. If the electron-phonon coupling would be very strongly dependent on correlations this should show up in signi cant discrepancies between calculated and measured phonon modes. The good agreem ent supports the claim that correlation e ects are of minor importance for electron-phonon coupling.

In sum m ary, we have presented here ab-initio results for the lattice dynam ics of Y B $_2$ C $_{13}$ O $_7$ which are in excellent agreement with available R am an, infrared and neutron data. B ased on the know ledge of the complete phonon spectrum the electron-phonon coupling has been calculated. The electron-phonon coupling constant turns out to be very sm all. These calculations strongly support the view that in high-T $_c$ m aterials conventional electronphonon coupling is not an important contribution to superconductivity.
