Em ergence of m em ory

A bstract. { We propose a new self-organizing mechanism behind the emergence of memory in which temporal sequences of stimuli are transformed into spatial activity patterns. In particular, the memory emerges despite the absence of temporal correlations in the stimuli. This suggests that neural systems may prepare a spatial structure for processing information before the information itself is available. A simple model illustrating the mechanism is presented based on three principles: (1) Competition between neural units, (2) Hebbian plasticity, and (3) recurrent connections.

M em ory is believed to be a universal feature of the nervous system [1] and exciting results im proving our understanding of m olecular as well as organizational mechanisms underlying m em ory have been obtained in recent decades [2]. On the organizational level signi cant work has been devoted to the study of \brain m aps" underlying the ability to recognize patterns or features from a given sensory input [3,4]. M any intriguing suggestions have been given as to how a m em ory em erges that is able to extract and recall features from a spatial pattern of neural activity [5,6].

In this Letter, we focus on the mechanism behind self-organization from a temporal sequence of activity. Time is important in many cognitive tasks, e.g. vision, speech, signal processing and motor control. The crucial point is how to represent time, and methods offen involve time delays in one form or another [7,8]. How does a structured memory emerge that can cope with temporal sequences of activity? For example, the information we receive through a temporal sequence of input must at least to some extent be memorized spatially in the neuronal activity pattern. Here we present a simple conceptual model for the time to space transformation, from which a memory emerges.

The fundamental assumptions of the model presented here are the following: (1) C om petition between neural units; excited neural units have an inhibiting e ect on other units. In the limit of strong inhibition this is winner-take-all [9] where only the region of units with the strongest excitation remains active, suppressing all surrounding units. (2) Hebbian Plasticity is an abstract formulation of long term potentiation depending on pre- and postsynaptic activity: If activity of unit A is followed by activity of unit B the connection from A to B is strengthened [10,12]. (3) Recurrent connectivity opens up the possibility for ongoing inform ation processing in the network by internal feedback.

Features (1) and (2) mentioned above are employed by the self-organizing map model form ulated by K ohonen [4]. Recently it has been argued [6] that the self-organizing map is a biologically plausible large-scale model of cortical information processing. However, the selforganizing map has a purely unidirectional information ow without internal dynamics. We know of few attempts to explicitly integrate memory of past stimuli into the self-organizing map [13[17]. These approaches have been shown to work well on speci c tasks.

The scope of the current paper is to investigate generally, i.e. task-independent, the form ation of an internal dynam ics that can lead to form ation of m em ory. In our approach, m em ory is not designed but em erges as a result of the self-organized dynam ics of the neural system.

Consider M neuralunits arranged as a one-dimensional lattice with periodic boundary conditions (a ring). The model describes the time-discrete evolution of the real-valued activities $y_0(t)$;:::; $y_M \stackrel{h}{=} (t)$ of the units. At a given time step t each unit i receives a recurrent excitation $h_i^{rec}(t) = \int_j w_{ij} y_j(t-1)$ through connections w_{ij} . A dditionally there is an S-dimensional input $x = (x_1(t); :::; x_S(t))$ to the system causing an external excitation $h_i^{ext}(t) = \int_j v_{ij} x_j(t)$ through connections v_{ij} . The total excitation is $h_i(t) = h_i^{rec}(t) + h_i^{ext}(t)$. Next, we denote the centre of activity i as the unit with the largest total excitation: i (t) = argmax_ih_i(t). The updated unit activities form a Gaussian prole around the centre of activity (we suppress t in the notation here)

where dist(i, i*) denotes the distance between units i and i in lattice points. The model parameter is a measure of the width of the neural activity eld. The constant value c > 0 is chosen such that the normalization $(y_i)^2 = 1$ holds. Finally, all connections are updated according to a Hebb-rule with a saturation term. Each recurrent connection w_{ij} is changed by

where > 0 is a constant learning rate. Correspondingly, the increment for the input connections is

$$v_{ij} = y_i(t) (x_j(t) v_{ij})$$

This completes one time step of the dynamics. The learning rate has a value = 0.2 in all the simulations presented in the following. The length scale is taken to be = 1.0. The connections w_{ij} and v_{ij} are initialized with random values in the interval [0;0:001].

The mem orization ability of the network is the degree to which the state of the network, given by i, depends on the past stimuli. A suitable measure of statistical dependence between the two stochastic variables is their mutual inform ation [18]. Given a discrete set X of possible stimuli, the mutual inform ation between the current centre of activity i (t) and the stimulus x (t) presented time steps before reads

where $p(i;x^0) = Pr(i(t) = i^x(t) = x^0)$ is the joint distribution of the centre of activity and the past stimulus. When estimating the joint probability distribution p and its marginals for a given network at a certain time, the dynamics is sampled over 5000 time steps with = 0. Consequently these time steps are not included in the learning time measured.

Let us now demonstrate the emergence of memory by simulations where the network is presented with a random time series. The considered networks have M = 64 units and S = 2

inputs. We present only two dimensional stimuli, x = (2;0) and x = (0;2)g. We use 0 and 1 as shorthand for the two stimulus vectors. At each time step one of the vectors 0 and 1 is drawn random by with probability p = 0.5.




Fig. 1 { The time evolution of the mutual information T indicates the formation of memory. The stream of stimulix (t) contains 1 bit of information per time step (two di erent stimulipresented with equal probability). Thus T = 1 means that the network perfectly remembers the stimulus presented time steps before whereas T = 0 means statistical independence between the stimulus and the network state. The displayed results were obtained as averages over 100 independent simulation runs with networks of size M = 64 units.

Fig. 1 shows the time evolution of the mutual information T . Originally the state of the network depends only on the current stimulus. This means $T_0 > 0$, but T = 0 for all > 0. A fler approximately 40 time steps the two stimuliare always discriminated by dimensionated by the evolution of the memory states ($T_0 = 1$). Before step t = 200 we observe the emergence of memory: $T_1 = 1$ indicates full discrimination between stimuli presented the previous time step. W ith further learning the memory length expands to more time steps, hence $T_2 > 0$, $T_3 > 0$ and so on. The maximum information content of the network is bounded by the number M of possible states (centres of activity). Thus the condition $\begin{bmatrix} 1 \\ 0 \end{bmatrix}_{= 0}^{1} T$ $\log_2 M = 6$ causes a saturation in the formation of the memory.




Fig. 2 { Spatial representation of m em ory. (a)-(e) The return-m ap of the centre of activity i after $0; :::; 10^5$ steps of learning. The diagram s show i (t) as a function i (t 1). The function has two branches (lled and un lled squares) corresponding to the two di erent values the stimulus x (t) can assume. (f) Idealized return-m ap for a network with M = 8 units. Each unit represents a certain history of stimuli. The histories of the units are given as bit strings on the axes.

M ore insight can be gained by considering the geom etrical structure of the m em ory. In Fig.2 we have plotted the evolution of the return m ap of the network dynam ics for a typical simulation run con gured as in the previous section. The diagram s are to be interpreted as follows: The abscissa is the centre of activity i (t 1) in the previous time step. The ordinate is the subsequent centre of activity i (t). Depending on the given stimulus x(t) either the

led or the un led squares represent the mapping i (t 1) ! i (t). We observe that the two branches of the return map tend to become straight lines with slopes 1/2 and -1/2, respectively. Panel (f) of FIG. 2 shows an idealized version for the case of M = 8 units. The emerging return map f can be interpreted as the inverse of a tent map where the ambiguity

of the two branches is resolved by the given stimulus.

By bx we denote the integer part of the argument. In order to understand how the stimuli are stored in the network state, it is convenient to write the centre of activity as a binary number $i = \sum_{k=0}^{L} 2^k i_k = :(i_{L-1};:::;i_0), where L = \log_2 M$ denotes the number of bits used. Writing also the stimulus x as a binary value x 2 f0;1g, the return map Eq. (5) reads

The operation is the exclusive-or (a b = 0 if a = b, otherwise a b = 1). Thus the operation f_0 shifts all bits of the argument to the right, discards the least signi cant bit and inserts x as the highest signi cant bit. f_1 additionally inverts all bits of the argument. Applying f_x iteratively L times we obtain

Thus at any time t the values x(t); x(t = 1); x(t = L + 1) of the L previous stimuli can be extracted from i (t). Note that, due to the non-linear superposition of the stimuli by the exclusive-or, the memory e ect in general cannot be observed when applying purely linear measures. In particular, the linear correlation function between i (t) and x(t = 1) vanishes for

> 0. However, using the mutual inform ation T (Eq. (4)) one detects the mem orization of past stimuli in i (t). For more than two discrete stimuli the emergence of mem ory is observed accordingly, form ing a return map with more than two branches.

We now consider the case of a sym m etry in the presentation of stimuli. We use the same two stimuli as in the preceeding sections. Unlike before, we admit the probability p of presenting stimulus 1 to assume values di erent from the symmetric case p = 0.5. The amount of information per time step in the stream of stimuli is then given by the Shannon function S (p) = $p \log_2 (p) + (1 p) \log_2 (1 p)$.




Fig. 3 { A daptation to asymmetry in the occurence of the stimuli, as the probability p of presenting the stimulus 1 deviates from 0.5. The network adapts to the value of p by varying thememory length. For p = 0.5 only a few time steps can be remembered with the available number of units. Lowering p < 0.5 decreases the information per time step in the stream of stimuli. Then longer memories are possible. Each plotted value is an average over 100 independent runs with networks of size M. The networks had learnt for 100,000 time steps before mutual information was estimated.

Figure 3 shows the mutual information as a function of the time-lag for di erent values of p. For small the mutual information is close to S (p) for all considered values of p. This means that in any case the network almost perfectly memorizes a few preceeding time steps. However, varying p causes a redistribution of memory: As the parameter p decreases, the decay of T with growing becomes weaker: The smaller p, the \longer" the memory. Thus the neural network autom atically adapts to the statistics of the stimuli.




Fig.4 { Typical simulation results for the case that one of the two stimuli occurs very seldom ly (here with probability p = 0.05). (a) Return map of i, after 10^6 learning steps. W hen the seldom stimulus x (t) = 1 occurs, i (t) = 2 becomes the centre of activity (led horizontal branch). P resentation of the other stimulus x = 0 in the subsequent time steps leads to the iteration dynamics indicated by the dotted lines. (b) Corresponding time series of the centre of activity i. 20 time steps after the last presentation of stimulus 1 the dynamics reaches a two-cycle.

Again we consider the emerging return m ap as done before in Fig.2 for the special case of p = 0.5. Low ering p reduces the num ber of units stimulus 1 is m apped to, thereby increasing the num ber of units stimulus 0 is m apped to. C on paring with Fig.2 (e) the un lled branch of the return m ap becomes steeper whereas the lled branch becomes atter. For values of p 0.1 typically a return m ap as shown in Fig.4 (a) develops. Here one branch of the m ap is a constant (horizontal line). such that after presentation of the infrequent stimulus the centre of activity i (t) does not depend on the previous one i (t 1). As illustrated by Fig.4 (b) the network state i passes a transient and reaches an attractor provided persistent presentation of the frequent stimulus. The network state is a measure of the time having passed since the last presentation of the infrequent stimulus.

In sum m ary, we have form ulated and exam ined a sim plem odel of m em ory dynam ics based on a few asumptions. We have shown that the dynam ics based on these assumptions readily builds up a structure for system atic storage of recent stimuli. We have also dem onstrated the adaptation of the m em ory in reaction to the inform ation contained in the stimuli. Im portantly, no correlations in the stream of stimuli are required for the structure to em erge. A neural network can learn a basic spatial representation of tem poral inform ation before tem porally correlated inform ation itself is available. Noise is enough in order to build up a m em ory.
