E lectrosorption of Br and C lon Ag(100):

Experiments and Computer Simulations

Abstract

W e present chronocoulom etry experim ents and equilibrium M onte C arlo simulations for the electrosorption of B r and C lon A g (100) single-crystal electrode surfaces. Two di erent m ethods are used to calculate the long-range part of the adsorbateadsorbate interactions. The rstm ethod is a truncated-sum approach, while the second

is a mean-eld-enhanced truncated-sum approach. To compare the two methods, the resulting isotherms are t to experimental adsorption isotherms, assuming both a constant electrosorption valency and also a coverage-dependent . While a constant to the Br/Ag(100) well, a coverage-dependent or potential-dependent is needed for C l/Ag(100).

1 Introduction

Speci cally adsorbed anions strongly in uence the structure and dynam ics of adsorbed layers on electrode surfaces [1, 2]. Am ong these systems, halides electrosorbed on single-crystal m etal surfaces have been extensively studied both experimentally and theoretically over the last decade. Examples of these studies include the electrosorption of Cl, Br, I, and F on low-index surfaces of Ag [3, 4, 5] employing classical electrochem ical techniques [3, 5, 6, 7], (see also literature cited in ref. [5]), and structure sensitive techniques such as electrore ectance [8], in-situ scanning tunneling microscopy (STM) [9, 10], surface X-ray scattering (SX S) [4, 5, 11], and X-ray absorption ne structure (XAFS) [12].

O cko, W ang, and W and low ski [4] showed that the sharp peak observed in cyclic voltam ogram s of Br electrosorption on A g (100) corresponds to a continuous phase transition in the layer of adsorbed Br. This transition separates a low -coverage disordered phase at m ore negative electrode potentials from a c(2 2) ordered phase at m ore positive potentials. M oreover, in recent static and dynam ic studies, M itchell, B rown, and R ikvold [13, 14] have num erically investigated the phase ordering and disordering m echanism s in cyclic-voltam m etry (CV) and sudden potential-step experiments. U sing M onte C arlo simulations

of a lattice-gas model rst used by K oper [15, 16], they also produced theoretical adsorption isotherm s for this system that were t to experim ental adsorption isotherm s. From these ts, parameters such as the electrosorption valency, , and the next-nearest neighbor interaction parameter, $_{nnn}$, were estimated.

Less attention has been given to Clelectrosorption on Ag (100), perhaps because previous studies [3] have assumed that this system is similar to Br/Ag (100). In the present paper we compare M onte Carlo simulation results with experimental equilibrium isotherms obtained by chronocoulom etry for both Cland Br, using a lattice-gasm odel and two dimentations for calculating the long-range part of the conguration energies.

The remainder of this paper is organized as follows. The experimental procedures and results are discussed in Sec. 2. The lattice-gas model is presented in Sec. 3. Equilibrium simulations using the two diment methods of calculation are discussed in Sec. 4, and the thing procedures and resulting parameter estimates for each system are discussed in Sec. 5. Finally, a summary and conclusions are presented in Sec. 6.

2 Experim ental

The electrochem ical measurements were performed with Ag(100) single-crystal electrodes (4 mm diameter and 4 mm thickness) using the so-called hanging meniscus technique. The silver electrodes were chemically etched in cyanide solution before each experiment until the surface appeared shiny [17] and, after careful rinsing in M illi-Q water, annealed in a hydrogen ame for about 30 s. A fler cooling in a stream of argon the electrode was quickly transferred into the electrochemical cell. C ontact with the electrolyte was established under strict potential control, usually at values close to the potential of zero charge of 0.05 M KC D₄ (E_{pzc} 0.900 V) [18]. The counter electrode was a platinum wire, and a saturated

calom elelectrode (SCE) in a side compartment served as reference. A llpotentials are quoted with respect to the SCE. The temperature was $(20 \quad 1)$ C.

The set-up and procedures for the electrochem ical experiments (cyclic voltammetry, capacitance measurements, chronocoulometry) were described previously [5, 19]. We focus here only on some additional details of the chronocoulometric experiments [20]: The potential was initially held at a value E_i between 1:375 V and 0:300 V (25 mV interval length), up to 300 s for the lowest chloride concentrations, and then stepped to the nal potential $E_f = 1:400$ V, where chloride is completely desorbed from the electrode surface. The waiting time at E_i was chosen (in control experiments) to be always su cient to establish adsorption equilibrium. A comprehensive account of the setup and detailed results of the SX S experiments for Ag (100)/C lw ill be given elsewhere [20].

Results of the electrochem ical experiments

Figures 1 (A) and 1 (B) show voltam m ogram s (CV) and capacitance (CE) curves (5 m V peakto-peak amplitude, 18 H z ac-frequency) for the Ag(100) electrode in 0.05 M KC D_4 and 0.02 M KC 1+ 0.03 M KC D_4 as obtained after continuous cycling of the potential between 1:40 V and 0:10 V. The capacitance curves m erge at E < 1:20 V, indicating complete

desorption of chloride. The onset of chloride adsorption is characterized by broad peaks in the CV and CE curves, which are la belled P1 in Fig. 1. In-situ SXS experiments revealed that chloride adsorbs in this potential region as a lattice gas corresponding to random ly adsorbed species on fourfold hollow sites [20]. The sharp peak P2 in Figs. 1 (A) and 1 (B) represents the continuous transform ation of the lattice gas into an ordered c (2 2) chloride adlayer [20]. This phase is stable until rather com plex AgC l_x -surface com pounds are being form ed at more positive potentials E > 0.20 V for the system shown in Fig. 1 (A) [7, 20].

Equilibrium data on the adsorption of chloride ions at A g (100) electrodes were obtained from chronocoulom etric m easurements in a gently stimed solution. Figure 1 (A) shows selected charge density curves for KCl in (0.05 x)M KC D₄ + x M KCl. Adsorption of chloride causes a positive charge to ow to the metal side of the interface. This is accompanied by a negative shift of the potential of zero charge. Phenomenologically, the charge density vs. potential curves as measured in the presence of chloride concentrations $C_{c1} > 10^{-3}$ M are composed of two segments. The region of low charge densities corresponds to the potential range of the broad features in the CV and CE curves. The second one appears at a potential just positive of the adlayer phase transition at P2, corresponding to charge densities between 35 and 40 C cm⁻². It is characterized by an initial increase of $\frac{M}{4} = E$. Subsequently the slope decreases and seem s to become a less dependent on the chloride concentration for $C_{c1} > 10^{-3}$ M at the most positive potentials studied.

The corresponding G ibbs surface excess has been calculated at constant potential (see Fig. 2) and constant charge (not shown, c.f. [20]), using the approach of Stolberg and Lipkowski [5, 20, 21]. The surface excess increases in the potential region of disordered chloride and at constant concentration monotonously with potential. At $C_{c1} > 10^{-3}$ M one observes in the potential region of the sharp volum etric peak P2 a distinct increase in slope ($6 - 10^{-10} \text{ mol cm}^{-2}$). At the most positive potentials experimentally accessible, the surface excess levels o and approaches a chloride-concentration independent limit of $_{m} = 10.2 - 10^{-10} \text{ mol cm}^{-2}$. This chronocoulom etric result is close to 9:94 - 10⁻¹⁰ m ol cm⁻² expected for a complete c (2) chloride adlayer, and is well supported by in-situ SX S experiments employing the so-called interference scattering technique [20].

The electrosorption valency, as determ ined from a plot of the charge density vs. surface excess at constant potential for the Ag(100)/Cl system is shown as an inset in Fig.2. U sing this method, the electrosorption valency is found to be potential dependent, decreases with

increasing potential, and approaches -0.45 at -0.40 V. This value is larger than the result for A g(100)/Br (0.80) [5, 13] (see also discussion in Sec. 5), indicating the stronger ionic character of adsorbed chloride, in comparison to brom ide on silver.

3 Lattice-gas M odel

The model used for both the Br and Cl systems is a lattice-gasmodel similar to that used by K oper [15, 16] and M itchell et al. [13, 14]. In this model the Br or Clions adsorb at the four-fold hollow sites of the Ag (100) surface, as shown in Fig. 3. The model is de ned by the grand-canonical elective H am iltonian

where $P_{i < j}$ is a sum over all pairs of sites, ij are the lateral interaction energies between particles on the ith and jth sites measured in meV/pair, and — is the electrochem ical potentialm easured in meV/atom. Here the local occupation variables c_i can take the values 0 or 1, depending on whether site i is occupied by an ion (1) or solvated (0).

The simulations were performed on an L L square lattice, using periodic boundary conditions to reduce nite-size e ects. The interaction constants $_{ij}$ between ions on sites i and j a distance r_{ij} apart (measured in Ag(100) lattice spacing units, a = 2.889 A [4]) are given by

where the in nite value for $r_{ij} = 1$ indicates nearest-neighbor exclusion, the interaction for large r_{ij} is most likely a combination of dipole-dipole and surface-mediated elastic interactions, and negative values of $_{ij}$ denote repulsion. The previous studies by K oper [15, 16] have shown that large but nite nearest-neighbor repulsion has only minor elects on the coverage isotherms. Consequently, we have chosen a simplied model with nearest-neighbor exclusion.

In the weak-solution approximation, the electrochem ical potential - is related to the bulk ionic concentration C and the electrode potential E (measured in mV) as

where $-_0$ is an arbitrary constant, C_0 is a reference concentration (here taken to be 1 m M), e is the elementary charge unit, is the electrosorption valency [22], and - has the sign convention that - > 0 favors adsorption.

The anion coverage is de ned as

where $N = L^2$ is the total number of lattice sites. The coverage can be experimentally obtained by standard electrochem ical methods as well as from the integer-order peaks in surface X-ray scattering (SXS) data [4, 20].

To compute the isotherm s $(\)$ or (E), the change in energy must be calculated before each attempted M onte C arlo m ove. This requires evaluation of the interaction sum in Eq. (1), which is computationally intensive even for modest system sizes. In the next section we compare a direct sum m ation approach with a more e cient truncated sum m ation combined with a mean-eld approximation for the in uence of adparticle pairs at large separations.

4 M onte Carlo M ethods

The M onte C arlo simulation proceeds as follows. On a square lattice with L = 64 and periodic boundary conditions we random ly select a lattice site, i, and attempt to change the occupation variable ($c_i = 1 ! c_i = 0$ or $c_i = 0 ! c_i = 1$). The energy di erence, H, between the initial state of the system and the proposed state is then calculated using Eq. (1). We use the M etropolis acceptance probability [23]

for accepting the new trial con guration as the next con guration in the Monte Carlo sequence.

Since the value of H determ ines R in Eq. (5), the approximations made to calculate the large- r_{ij} contributions to the pair sum in Eq. (1) are important. In our computations, we used two dimenters methods to calculate H. The rst was a direct-summation-plustruncation method previously used by M itchell et al. [13, 14]. In the second method, which we introduce here, we include the exact contribution of fewer sites on the surface, using a mean-eld approximation to calculate the contribution from all the sites at larger distances.

4.1 D irect sum m ation

The rst m ethod involves calculating the contribution of the sites that are less than or equal to ve lattice spacings away from the site of interest. Since nearest-neighbor adsorption is prohibited, the acceptance probability vanishes for any move that would bring two particles into nearest-neighbor positions. In addition to the four nearest-neighbor sites, there are a total of 76 sites such that $1 < r_{ij}$ 5. These are divided between 12 di erent distance classes as shown in Fig. 4. This summation provides approximately 87% of the total energy due to the long-range interactions [14].

This method of approximation proved to be acceptable for simulating Bradsorption on Ag(100) [13, 14] as it produced values for the electrosorption valency that are in good agreement with experimental data. On the other hand, because of its computationally

intensive nature, this method of calculating H made it harder for dynamic simulations to achieve CV scan rates within the experimental range [14].

4.2 M ean-eld-enhanced m ethod

The method of calculating H can be modiled from the previous one so that, without reducing the accuracy of the calculation, the cuto radius is reduced from ve to three lattice constants. This decreases the number of sites beyond nearest neighbors that are included in the summation from 76 to 24, as shown in Fig. 4.

Thism odi cation includes a mean-eld approximation to estimate the interaction energy contribution from those particles that are farther than three lattice constants from the site in question. Consequently, the change in energy associated with desorbing from the surface a particle at lattice site i is

which is both more e cient and more accurate than calculating the exact energy contributions out to $r_{ij} = 5$. Here $_1 = {}^P {}^1_{r=1} 1 = r^3$ is a Zucker sum over the sites of a square lattice of unit lattice constant [15], and the quantity in the parenthesis is a constant, independent of the adsorbate con guration. It can easily be calculated to arbitrary num erical precision. The energy change upon adsorption at a previously empty site i with four empty nearest-neighbor sites is the negative of the result in Eq. (6).

This modi cation of the calculation of the energy changes for the M onte C arlo steps makes the program run m ore than twice as fast as when using the m ethod described in Sec. 4.1 and used in R efs. [13, 14]. It is consequently better suited for dynam ical simulations [24]. The results of the calculations perform ed with this method are similar to those using exact summation for r 5. At higher coverages, the numerical elect of introducing the mean-eld approximation is more pronounced, as expected. We note that this method is successful because the interactions in our model are repulsive, which ensures that the spatial distribution of adparticles is approximately uniform on large length scales. For system swith attractive interactions more sophisticated methods to calculate the contributions from the long-range interactions, such as the Fast Fourier Transform or Fast Multipole Method [25], would be needed.

4.3 Comparison

A comparison of the calculated coverage as a function of the electrochem ical potential, obtained with both mean-eld and non-mean-eld methods for dierent cuto radii, is shown in Fig. 5. The mean-eld enhancement makes a signi cant contribution to the adsorption isotherms for both cuto lengths. However, when the mean-eld enhancement is used, increasing the cuto radius beyond three does not signi cantly in prove the results. Tests with even smaller cuto radii revealed that three is an optim al choice to increase the computational speed with only a minim al loss of accuracy.

5 Param eter Estimation

To estimate the parameters in the lattice-gas model, nnn and , we performed standard equilibrium MC simulations [23] with H calculated by the mean-eld-enhanced method at room temperature ($k_B T = 25 \text{ meV}$ or T 290 K) to obtain () for dierent parameter values. These simulated isotherms were then compared with the experimental chronocoulom etry data using two thing procedures. The rst procedure assumed a constant

electrosorption valency , while the second assumed a coverage-dependent (). The experimental coverage data for Br/Ag(100) [5], which were also used in Refs. [13, 14], were provided to the authors of those papers by JX.W ang.

5.1 Constant

To extract the values of and $_{nnn}$ that would best t the experimental data, we used a least-squares thing procedure that minimizes 2 with respect to three thing parameters for Cland Brelectrosorbed on Ag(100) [14],

where sin and exp are the simulated and experimental coverage values respectively, k is the concentration index, N $_{conc}$ is the number of dimension concentrations used in a t, and l is the point index of the experimental data points.

This thing procedure, which provides good to for Br/Ag(100) in Refs. [13, 14] (see also Table 1) does not give satisfactory to for Cl/Ag(100). The assumption that the electrosorption valency is independent of the coverage is consistent with the Br results, but appears to be invalid for the Cl system.

5.2 dependent

Since a coverage independent does not appear to be a valid assumption for C 1/A g (100), we assume that depends linearly on the coverage as

This adds to the model a fourth parameter, 1, that must be determined by comparison to the experimental results. The -dependent is allowed to vary in the interval [1;0], which

lim its the values that $_0$ and $_1$ can assume according to Eq. (8). The range of variation for $_0$ is [1;0], while it is [2;0] for $_1$ since the latter is multiplied by , which can assume a maximum value of 0.5. As determined by 2 Eq. (7)], the inclusion of a coverage-dependent electrosorption valency in proves the ts to the adsorption isotherms, shown in Fig. 6. It also gives reasonable values for and $_{nnn}$. The resulting parameter values, based on tting C1 and Br simulations to the experimental isotherms, are shown in Tables 1 and 2, respectively.

The tables include values for the thing parameters, $_{\circ}$ for the constant ts and $_{0}$ and $_{1}$ for the coverage-dependent ts. Moreover they include values for $_{nnn}$ and 2 per degree of freedom, 2 , for all the ts. Fitting to the experimental data was performed both for the truncated-sum M onte C arlo isotherm s and for the mean-eld-enhanced isotherms. For each of these simulated isotherms we performed three kinds of ts. First, the numerical isotherms s were t to a single set of experimental data with a certain halide ion concentration (columns 3-8 in Tables 1 and 2, labeled 1-t). Second, each numerical isotherm was simultaneously t to two experimental isotherms with ionic concentrations of 10 m M and 20 m M for C lor 1 m M and 10 m M for Br (columns 9 and 10, labeled 2-t). Third, numerical isotherms were t to three experimental isotherms s in ultaneously with the concentrations 6, 10 and 20 m M for C lor 1 m C land 0.1, 1.0, and 10.0 m M for Br (columns 11 and 12, labeled 3-t).

In thing two orm one isotherms simultaneously, several conclusions may be drawn from the tables shown. With one exception, the values of $_1$ in Table 1 for Br/Ag(100) are zero (i.e., $j_1j < 0.01$) or nearly zero for all of the ts. This supports the conclusion that a constant is a good approximation for that system. Moreover, the quality of the ts is enhanced by using two orm one concentrations simultaneously because this utilizes a greater number of experimental data points in one t and constrains more directly through the $h(C=C_0)$ term of Eq. (3). For constant the 2-t and 3-t values for nnn and for the mean-eld-enhanced method are consistent with those obtained by the non-mean-eld

m ethod. However, sm aller values of 2 are found for the mean-eld-enhanced m ethod than for the non-mean-eld m ethod, indicating that the mean-eld-enhanced isotherm s t slightly better to the experimental data than the non-mean-eld ones. Comparing the values found using the 2-t and 3-tm ethods for mean-eld-enhanced isotherm s, suggests __nnn = 21 _ 2 m eV and _c = 0:71 _ 0:01 as reasonable estimates. These results are consistent with those obtained in Refs. [5, 13, 14].

The results for the ts to the C 1/A g (100) experiments are given in Table 2, whose layout is the same as for Table 1. Notice that $_1$ assumes non-zero values for most of the ts, and that { except for the t to the 6 m M isotherm { the values of 2 obtained with variable are less than those obtained with the constant- ts. This supports the conclusion that, for the Clsystem, a coverage-dependent should be adopted. The exception can be attributed to the fact that the 6 m M experim ental data points do not cover the whole range, especially in the important region near the phase transition. Consequently, we hereafter ignore the 6 m M data in estimating parameters for the Cl/Aq(100) system. This leaves the 2-t parameter values for a -dependent . The mean-eld and non-mean-eld parameters are similar and, as determ ined by ^2, provide equally valid descriptions of the experiment. From this we conclude that, for $C \frac{1}{A}g(100)$, nnn = 14 2 m eV and = (0.66 0.01) + (0.68 0.01). W hile these results for $_0$ and $_1$ are more negative than those obtained from the chargedensity curves in Sec. 2, the trends of a stronger dependence on coverage or electrode potential and a higher (less negative) overall value than for Br/Aq (100) are the same. The reasons for the quantitative di erence between the estimates based on the two methods to determ ine the electrosorption valency are left for future study.

6 Conclusions

In this paper we have presented a new method for implementing the lattice-gas model for the electrosorption of halide ions on a Ag(100) surface by introducing a mean-eld-enhanced method to calculate the contributions to the conguration energy of widely separated adparticle pairs. We t adsorption isotherms obtained by Monte Carlo simulation to the experimental adsorption isotherms based on chronocoulometric data after comparing them to the results obtained using the non-mean eld method.

The isotherms from both methods were t to experimental data for both Cl and Br. It was shown that it was safe to assume a coverage-independent or potential-dependent electrosorption valency for Br on Ag (100) while a coverage-dependent electrosorption valency had to be implemented for the Cl on Ag (100).




Figure 1: (A) Cyclic voltam ogram (50 m V s¹) for Ag(100)/(0.05 x) M KC D₄ + x M KC L, x=0 (dotted curve) and x=0.02 M (solid curve). (B) Capacitance vs. potential curves for the system of Fig. 1(A), 10 m V s¹. (C) Charge density vs. potential curves for Ag(100)/(0.05 x) M KC D₄ + x M KC l (x in M), as indicated in the gure.




Figure 2: Plots for surface excess for $Ag(100)/(0.05 \times)M \text{ KCD}_4 + \times M \text{ KCl}(x \text{ in } M)$, employing the electrode potential as the independent electrical variable for selected chloride concentrations. The inset shows the potential-dependent electrosorption valency.




Figure 3: Br or Cl (bigger spheres) adsorbed at the 4-fold hollow sites of the (100) surface of A g (sm aller spheres). The squares of the grid fram e correspond to the adsorption sites.




Figure 5: Simulated coverage isotherms vs. electrochem ical potential, computed with di erent m ethods. Here R is the cuto radius up to which exact sum m ation was performed. The simulations were performed at T 27 C with $_{nnn} = 26 \text{ m eV}$. The line segments connecting the data points are included as a guide to the eye.




Figure 6: One simulated Cl/Ag(100) isotherm t to two experimental isotherms with dierent bulk concentrations. The simulated isotherms were obtained using the meaneld-enhanced method described in Sec. 4.2. (a) Using coverage independent . (b) Using coverage-dependent () = $_0 + _1$. 24
