V ibrational properties of single-wall nanotubes and m onolayers of hexagonal BN

We report a detailed study of the vibrational properties of BN single-walled nanotubes and of the BN monolayer. Our results have been obtained from a well-established Tight-Binding model com plem ented with an electrostatic model to account for the long-range interactions arising from the polar nature of the material, and which are not included in the Tight-Binding model. Our study provides a wealth of data for the BN monolayer and nanotubes, such as phonon band structure, vibrational density of states, elastic constants, etc. For the nanotubes we obtain the behavior of the optically active modes as a function of the structural parameters, and we com pare their frequencies with those derived from a zone-folding treatment applied to the phonon frequencies of the BN monolayer, nding general good agreement between the two.

I. IN TRODUCTION

The discovery of the fullerenes¹ in the m id 1980's, and especially that of carbon nanotubes² in the early 1990's has fueled a frenzy of research activity in the eld of carbon nanostructures, doubly motivated by their large potential for practical applications on one hand, and because these system s constitute a new open eld for basic research at the nanoscale on the other. Nanotubes can be single-walled or multi-walled, and are quasi-1D structures having large aspect ratios (the quotient of length over diam eter). Single-wall carbon nanotubes (SW NTs) can be either sem iconducting or metallic, depending on their structural param eters, and can be chiral or achiral. They have large them al conductivity, and have the highest Young's modulus ever measured^{3,4,5,6}. Nanotubes can be led with other elements, compounds or even fullerenes in their internal channel, forming structures sim ilar to nanoscale coaxial cables. All these properties confer nanotubes a large potential for technological applications, some of which have already been dem onstrated. Nanotubes have been used to fabricate eld em ission devices⁷, tips for scanning probe m icroscopy instrum ents⁸, constituents of nanoelectronic devices⁹, gas sensors¹⁰, com posite reinforcem ent¹¹, lubrication, etc. It is therefore not surprising that these systems have been and continue to be the focus of considerable interest; the large num ber of review articles¹² and m onographs¹³ devoted to the di erent aspects of fullerenes and nanotubes in recent years provides further proof of this interest.

O ne of the probes m ost frequently used to characterize carbon nanotube sam ples is vibrational spectroscopy, and speci cally R am an spectroscopy¹⁴. R am an spectroscopy o ers experim entalists a rapid way of estim ating the diam eter distribution of tubes present in a sam ple, because the low frequency radial breathing m ode (RBM) of SW NTs has a frequency which is inversely proportional to the square of the nanotube diam eter, independently of the nanotube structure, determ ined by the nanotube indices (n,m). A lso, the high frequency G band m odes resulting from atom ic vibrations in the nanotube shell, can help to distinguish between m etallic and sem iconducting nanotubes in the sam ple¹⁵. Jorio and cow orkers¹⁶ have recently dem onstrated the ability of R am an spectroscopy to provide full structural determ inations of isolated carbon SW NT's. The diverse aspects of phonons in carbon SW NT's and the use of R am an spectroscopy as a tool for their characterization have been recently reviewed by D resselhaus and E klund¹⁴.

Soon after the discovery of carbon nanotubes it was speculated that other materials could possibly form sim ilar nanostructures, since there are several elements and m any compounds which form layered structures bearing som e resem blance to graphite. The most obvious candidate was hexagonal BN (h-BN), which was predicted on the basis of theoretical calculations^{17,18} to be capable of form ing nanotubes, a prediction which was later corroborated experim entally by the synthesis of such nanotubes¹⁹. Today we know that m any other structures can form nanotubes (M oS₂, W S₂²⁰, B f^{1} , ...); nevertheless it is still the case that carbon nanotubes continue to attract a larger interest, but certainly these other structures are interesting in their own right, and may be able to o er di erent possibilities for technological applications that carbon nanotubes cannot provide. B oth multi-walled and single-walled²² BN nanotubes can now be readily synthesized, and these tubes are uniform ly insulating, tending to have a zig-zag structure.

As other types of nanotubes become more common, many of the characterization tools and techniques extensively used in the case of carbon nanotubes will undoubtedly also nd application in the study of these other

structures. In particular, vibrational spectroscopy, which has proved to be such a useful tool in the case of carbon nanotubes, is likely to prove useful also in these cases. In this context, it is interesting to consider the phonon properties of BN nanotubes from a theoretical point of view; their study will help to develop the characterization potential of spectroscopic techniques when they are applied to BN nanotubes. The aim of this paper is to provide such a theoretical study. We report extensive theoretical calculations of the vibrational properties of a h-BN layer and of a number of BN nanotubes having diam eters in the range of 0.4 to 2 nm, including zig-zag, arm -chair and several chiral nanotubes. From our results for the at sheet we have perform ed a zone-folding analysis in order to predict the vibrational properties of the tubular structures from those of the at layer, a technique which has been frequently used in the case of carbon nanotubes. The direct calculation of the vibrational properties of tubular structures allow us to compare the predictions of zone-folding with the actual results, and thus gauge the applicability of the zone-folding approach for BN nanotubes. O ther authors have previously considered the vibrational²³ and elastic²⁴ properties of isolated h-BN monolayers and of bulk h-BN^{25,26}. Some aspects of the elasticity of BN nanotubes have also been studied in references 27 and 24. However, the study of the vibrational properties in the case of BN nanotubes has not, to our know ledge, been addressed to date.

The structure of the paper is as follows. In sec. II we describe the model and calculation procedure used in our study; later in sec. III we discuss our notings, starting with a thorough description of the vibrational properties of an isolated h-BN monolayer, followed by the results obtained for the nanotubes, establishing a comparison between the results obtained from the zone-folding analysis and those obtained from direct calculation. Our sum mary and conclusions are discussed in sec. IV.

II. M ODEL AND COMPUTATIONAL PROCEDURE

All calculations have been performed using the nonorthogonal Tight-Binding (TB)²⁸ param etrization of W idani et al.²⁹. This is a parametrization following the scheme proposed by Porezag and $cow \, orkers^{30}$. This m odelem ploys a basis set consisting of one S and three P functions per atom, to represent valence states, and the resulting Ham iltonian and overlap matrix elements extend up to a range of approxim ately 5 A. The core-core repulsion is modeled by means of a simple pair-repulsive potential. The original work of Porezag et al.30 described a non self-consistent TB m odel; although an extension of the methodology has been proposed which incorporates som e degree of self-consistency³¹, here we only have used the model of W idany²⁹ in its non self-consistent form . It is worth commenting that in spite of its simplicity this m odel has proved to be quite $successful^{27,29}$.




FIG.1: Force constants derived from the TB m odel (sym bols) and the typical behavior of the electrostatic interactions (approxim ated in the plot by f(r) $Z_k^2 = (r^3)$) (solid line), as a function of distance. The inset show sm ore clearly the behavior for large distances.

The equilibrium structures of the tubes were obtained by carefulm inimization of the total energy with respect to both the atom is coordinates and the lattice constant along the tube axis. For the phonon calculations, we then computed the force-constant matrix in real space using a nite-di erence approach². We used atom is displacements of 0.02 A, and the force constants were taken as the average of the results obtained with positive and negative displacements, in order to eliminate anharm onic e ects. Since all nitrogen and boron atoms are equivalent by symmetry in the tubes, we only calculated the force constants for one nitrogen and one boron atom in the supercell and generated the rest of the matrix using the symmetry operations.

The force-constants have to be calculated between a given atom and all the other atom s in the system . H ow - ever, since the interactions in our TB model decrease rapidly with distance, only the elements with atom s suf-

ciently close have to be computed. To do so, we set up a supercell large enough that a su-cient number of neighbors is included. It must be kept in mind that, in the supercell geometry, a given atom ic displacement in the central cell is always accompanied by the same displacement of all in age atom s. We need, therefore, to use a supercell such that the e ect of the in age displacements is negligible. For this purpose we have used supercells containing six unitcells in the case of (n,n) and (n,0) tubes, and two and one unitcells, respectively, in the case of the (10,5) and (10,7) tubes. The supercells contain hence a

m in im um of 144 atoms for the (6,0) and (6,6) tubes, and a maximum of 384 atoms in the case of the (16,0) tube.

The above described TB model does not by itself incorporate any long-range electrostatic interactions. Such interactions are important when considering the vibrational properties of polar materials, because they will make a long-range contribution to the force constants. Therefore we have opted for correcting this shortcom ing in the TB model in a physically sound but otherwise empirical way. The key observation in order to introduce the e ects of the electrostatic interactions is that, when an atom i su ers a displacement u (i) from its equilibrium position, a net electric dipole of magni- $Z^{i} u^{i}$ appears associated with this atom ic $tude p^{i} = i$ m ovem ent^{33} . Here Zⁱ is the Born e ective charge tensor³³ of the atom i. As a consequence, if two atom si and j are simultaneously displaced from their positions, besides the interaction energy given by our TB m odel, it is necessary to include the long-range interaction between the two electric dipoles generated. This gives rise to a new term in the force-constants matrix of the form 33

where the superindex LR in C^{LR} (r_{ij}) indicates that this is the long-range contribution to the force constants; f (r_{ij}) is a switching function (see below), is the dielectric constant, r_{ij} is the vector going from atom i to atom j, and r_{ij} is the distance between these two atom s. The switching function is designed to come into play at distances su ciently large so as to not a ect the TB m odel; it takes the form

Following the usual approach³³, it is also necessary to modify the on-site elements of the force matrix in order to satisfy the acoustic sum rule. Therefore, we take

The Born e ective charge tensor has been taken from recent ab initio density functional calculations²⁶: $Z_2^B =$ $Z_{2}^{N} = 0.82$ for out-of-plane, and $Z_{k}^{B} = Z_{k}^{N} = 2.71$ for in-plane displacements³⁴. We have taken = 4 and $r_c = 2.6 A$, the distance of separation between second nearest neighbors in the h-BN layer. We have not attem pted to t these values in order to im prove agreem ent of our results with experim entalm easurem ents. Rather, our approach has been to take reasonable values for them in order to estimate the e ect of the polar interactions on the vibrational properties of the BN m onolayer and in the nanotubes. Our chosen value for is close to the experimental one for h-BN (4-5 depending on the direction^{26,35}), and the value of r_c used in Eq. (2) is motivated by the fact that force constants arising from the

TB model alone decay very rapidly with distance, and they are already very small at this value of r_c , as can be seen in Fig.1. By choosing r_c equal to the second nearest neighbor distance we ensure a smooth switching between the short-range TB model and the long-range electrostatic one, with minimum interference between them.

Once we have the force-constant matrix in real space, we can calculate the dynamical matrix in reciprocal space, and diagonalize it to obtain the phonon modes and frequencies. In the case of bulk polar systems the computation of the dynam icalm atrix in reciprocal space has to be made with some care. The reason is that, due to the long-range nature of the dipole-dipole interaction in Eq.(2), a di erent lim it for the dynam ical matrix is obtained, as the phonon wavevector k approaches , in the cases of longitudinal and transversal vibrations. In our case how ever, due to the reduced dimensionality of the system s considered (a monolayer and single-walled tubes), the Fourier transform of the dynamical matrix can be perform ed without further com plications by sim ply adding up the elements of the real-space matrix with the appropriate phase factors. G iven its simple analyticalform, we can include a large num ber of neighbors (we tipically take all neighbors within a radius of 200 A) in the summation involving the dipole-dipole interactions and quarantee a good convergence. The same lim it is found for both polarizations when k! , and there are no splittings between in-plane longitudinal and transversalopticalm odes at (see Appendix).

III. RESULTS AND DISCUSSION

O ne of the aim s of this work is to judge the validity of the zone-folding approach for obtaining phonon inform ation of tubular structures from the phonon band structure of the at sheet, a procedure which has been frequently used in the case of carbon nanotubes¹⁴. To this end we have perform ed a phonon analysis of the at sheet, and of several nanotubes (arm -chair, zig-zag and chiral) so as to com pare the zone-folding results with those obtained directly from the tubular structures. In the following we will rst present the results obtained for the at sheet, followed by those for a selected set of nanotubes. The com parison between these latter results and the zone-folding predictions will be then presented.

A. Flat sheet




FIG. 2: (a) Phonon band structure of the BN hexagonalm onolayer (right) and the corresponding density of vibrational states (left); thick lines correspond to band structure and density of states calculated with electrostatic interactions included, while thin lines give results obtained only with the TB model. (b) Projected density of states on the B atom s; continuous line represents the density of states projected onto the plane of the monolayer, while the discontinuous line gives the density of states projected perpendicular to the plane of the monolayer. (c) As in (b) for the N atom s.

U sing the TB m odel discussed in section II, with and without the dipolar interactions, with a supercell containing 192 atom s we have obtained the phonon dispersion curves and vibrational density of states for a at sheet of h-BN, plotted in Fig. 2. In order to check the convergence of the results with respect to the supercell size, we perform ed a test with a supercell containing 320 atom s; the results obtained with the sm aller cell are in-

distinguishable from those of the larger cell, and hence all subsequent analysis was performed with the 192 atom cell results. W e also perform ed a m ore detailed analysis of the convergence of the phonon bands with respect to the lower threshold of the elements of the real-space force-constant matrix included in the construction of the dynam icalm atrix. We focus rst on the convergence with respect to the TB force constants. W e found that including all the couplings coming from the TB ham iltonian $10^{2} \text{ eV}/\text{A}^{2} \text{ was}$ with absolute value larger than 12 necessary to adequately converge all bands. This threshold corresponds to a spatial cuto of 6.7 A, which includes all atom swithin the tenth nearest-neighbor shell. This large cuto is required to correctly reproduce the quadratic behavior of the lowest acoustic band [labeled ZA in Fig.2] in the lim it k! , with a zero sound velocity (slope of the band) as k approaches . This quadratic behavior of the ZA band is a consequence of the fact that, at least to the lowest order in its amplitude, the strain energy created by this vibration is solely associated with the curvature that this out-of-plane bending mode induces in the layer. O ptical bands typically convergem uch faster (ca. including interactions with neighbors within the third or fourth nearest-neighbor shell). It is worth mentioning in this respect that in the earlier theoretical

work of M iyam oto et al.²³ a supercell which only perm itted the inclusion of second nearest neighbor interactions was used due to computational limitations (Miyam oto and coworkers used rst-principles methods, which are signi cantly more costly, to evaluate the force-constant matrix). Although inclusion of up to second nearest neighbor interactions is su cient to adequately converge most bands, it fails to reproduce the over-bending (see below) of the longitudinal-optical (LO) band, for which the maximum occurs not at but approxim ately half way along the sym metry lines M and K , and is insu cient to reproduce the quadratic behavior of low est acoustic band around .

Let us now comment brie y on the convergence with respect to the long-range electrostatic interactions. As already commented in the previous section, due to its simple analytical form we have used a large cut-o of 200 A for the dipole-dipole interactions. However, we have checked that already with a cut-o of 25A the results are well converged. Further reducing the interaction range starts to have an appreciable e ect. Not only the position of the optical branches at and close to start to shift from their converged values, but the nite slope at that the LO m ode m ust exhibit as a consequence of the long-range nature of the interactions also disappears

As can be appreciated in Fig. 2, due to the twodim ensional character of the system, there is a separation between in-plane and out-of-plane modes, the latter being the lower frequency ones, with a maximum at of 719 cm 1 with dipolar interactions included (706 cm 1 if these are not included). This frequency separation is to be expected, since in-plane modes excite both bondstretchings (hard) and bond-bendings (soft), while outof-plane modes result mostly in bond-bending motion and very little bond-stretching. The highest frequency bands, the LO and the transversal-optical (TO), have a frequency at of 1446 cm¹ when the dipolar interactions are included (1479 cm 1 without). The maximum of the LO band occurs not at , but at an interm ediate point away from the Brillouin zone edges, as pointed out above. This is known as over-bending, and the presence of over-bending in the at sheet phonon band structure can have interesting consequences for the phonon band structure of the nanotubes, as it may lead to the appearance of new modes at having higher frequencies in the tubular structures than in the at sheet³⁶. Note that including the dipolar interactions increases the overbending, which is much smaller when the electrostatics are not appropriately accounted for. A nother notew orthy characteristic of the phonon band structure displayed in Fig. 2(a) is the splitting of approximately 250 cm $^{-1}$ existing between the ZO and ZA bands along M-K. In a hom opolar hexagonal sheet such as graphene these two bands cross at K 37 .

From the slopes of the transversal-acoustic (TA) and longitudinal-acoustic (LA) bands in the lim it k ! we deduce a sound velocity of 13 Km /s and 21 Km /s, respectively. As already pointed out above, the ZA band exhibits a k^2 behavior in this limit, as expected, and therefore the sound velocity associated to this band is zero. Fitting the frequencies below 250 cm $\,^{1}$ to the expression $!=2 = k^2 + k^3$, we can estimate a value of $60 \text{ cm} {}^{1}\text{A}^{2}= 5.5 0.2 10 {}^{7}\text{m}^{2}\text{s}^{1}$. This 1820 param eter is interesting because it allows to estim ate the energy necessary to roll up the BN sheet in order to form the nanotubes. Simple arguments show that the strain energy per atom can be approximated by $E_{st} = C/r^2$ with $C = \frac{2}{(m_N + m_B)}/4$, being m_N and m_B the masses of the nitrogen and boron atom s, respectively, and r the tube radius. The value obtained for C in this way is 1.91 eVA², which is in reasonable agreement with the m agnitude obtained from total energy calculations performed using both, a tight-binding ham iltonian similar to the one utilized here²⁷, and rst-principles density functional calculations^{18,24}. A similar estimation in the case of graphene³⁷ ($6 \ 10^{7} \text{m}^2 \text{s}^1$) leads to a value C 2.3 eVA². Therefore, already looking at the phonon band structures it is possible to nd an indication that the strain energy is smaller in the case of BN tubes than for carbon nanotubes, a result which is con rm ed by m ore sophisticated calculations.^{18,24,27,38}

U sing the calculated force-constants m atrix we can directly obtain the elastic constants³⁹ of the at sheet, which are given in Table I. In bulk three-dimensional system s it is custom ary to quote elastic constants in units of pressure, due to the inverse equilibrium cell volum e factor that appears in the de nition of the elastic constants^{39,40}. However, in two-dimensional systems the de nition of the cell volum e is arbitrary, and it is therefore m ore appropriate to use cellarea in the de nition of the elastic constants²⁷; hence, we provide our results in units of pressure times length. Comparing with previous calculations in the literature, our result for C_{xxxx} is in reasonable agreem ent with the value of 0.271 TP a nm obtained for the in-plane sti ness⁴¹ by Kudin and coworkers using density-functional theory and Gaussian type orbitals²⁴. Our result is also in quite good agreem ent with the value of 0.309 TPa nm that can be deduced from the plane-wave density-functional calculation of the elastic constants of bulk h-BN reported by O hba et al. in Ref. 26 (we use here the calculated interlayer distance of 3.25 A to translate the data from the bulk to the monolayer geom etry). How ever, the com parison is poorer for the C_{xyxy} elastic constant, for which the data of 0 hba and cow orkers translate into 0.055 TPanm for them onolayer (roughly half our value). The origin of this large discrepancy is unclear, although it might be related to the interactions with neighboring layers, which are not present in our case.

For a hexagonal two-dimensional crystal only two elastic constants are required⁴², and due to the underlying crystal symmetry we obtain the following rule:

This provides an internal consistency check for our results, which, as can be seen from the results in Table I, is satisfactorily obeyed [the num erical value obtained for C_{xxxx} using C_{xxyy} and C_{xyxy} in Eq. (4) is within 3 % of its calculated value, given in Table I]. A second consistency check is provided by the comparison of these values of the elastic constants with those obtained from the sound velocities reported above using the identities

where is the surface mass density of the sheet. These data are also given in Table I. As can be seen there, the values obtained in these di erent fashions are in rather good agreement. From the elastic constants we can also calculate⁴² the Poisson ratio,


The values obtained for and Y are also given in Table I. These values can be compared with those obtained previously for BN nanotubes using the same TB m $odel^{27}$; the value of obtained here is a little bit larger than that obtained for the nanotubes (0.263), but the agreement with the tube Young's modulus (0.298-0.310 TP a nm depending on the tube diameter) is nearly perfect. W e also point out that the inclusion of the dipolar interactions does not a ect the values of the sound velocities or elastic constants, as expected from the fact that they only in uence the high frequency optical phonon bands, but not the acoustic ones, as can be seen in Fig.2.

At the zone edge the ZA band corresponds mostly to N atom out-of-plane displacements, while the ZO mode corresponds to B displacements. This is most clearly seen in Fig. 2 (b) and (c), which shows the partial vibrational density of states (DOS) separated into its in-plane and out-of-plane atom ic contributions.




FIG. 3: C om parison of the the phonon dispersion curves of the (10,10) tube (40 atom s in the unit cell and a diam eter of 13.9 A) calculated directly from the tube structure, and those obtained using the zone-folding approach from the results for the at sheet shown in Fig.(2a).

The frequency of the Ram an and infrared-active (IR) modes in bulk h-BN has been investigated by several authors^{35,43,44,45} obtaining similar results. The values reported for the high energy Raman-active E_{2q} mode are $1366^{43,44}$, 1367^{45} , and 1370^{35} cm⁻¹. For the IR m odes the values given in the literature are: 1367^{35} and 1383 5^{45} cm 1 for the E $_{1u}$ (TO) mode, 1610 35 cm 1 for the E $_{1u}$ (LO) mode, and 770 3^{45} and 783 35 cm $^{-1}$ for the A_{2u} (TO) mode. At this point it is important to note that, since our calculations refer to a free-standing (isolated) at sheet of h-BN rather than to the bulk material, the comparison with these experimental observations has to be made with some care. In analogy to the case of graphite, and assuming relatively weak interlayer interactions, the frequencies of a single BN sheet should be closely related to those of the bulk. However, there is an important exception related to the role of the long-range electrostatic interactions. In a strictly twodim ensional (2D) system like the one treated here (i.e. a sheet of m onatom ic thickness), the electrostatic interactions do not result in a macroscopic term at for in-plane modes, and hence we do not obtain any LO-TO splitting in that limit (see Appendix). This striking di erence is quite notorious, for example, comparing our phonon band structure in Fig. 2 (a) with the calculations for bulk h-BN diplayed in Fig. 3 of Ref. 25. The absence of LO-TO splitting for the systems of reduced dimensionality

Our results for the planar BN sheet have, therefore, to be compared with the TO frequencies of the bulk. We obtain for the highest modes at a frequency of 1446 cm $^{-1}$, to be compared against the empirical values of the E_{2q} and E_{1u} (TO) modes, and 719 cm $^{-1}$ for the ZO mode, to compare with the measurements for the A_{2u} (TO). The discrepancies are therefore smaller than 10 %, which we regard as acceptable, given the sim plicity of the TB model employed in this work. It is noteworthy that the e ect of the inclusion of the longrange electrostatic interactions in proves the com parison with experiment, correcting the under-estimation of the ZO () frequency and the over-estim ation of the TO () and LO () value, as well as giving a more realistic overbending of these modes along M and K .We should emphasize here that no empirical information on vibrational or structural properties has been used in the construction and parametrization of the $m \operatorname{odel}^{29}$. As pointed out above, it is also important to take into account that at least som e of the discrepancy m ay not be attributed to the model, but to the geometry used in the supercell calculation. The presence of near-by sheets in the experiment is likely to soften somewhat the inplane LO and TO modes, while hardening the ZO mode, which could account for som e of the discrepancy between our results and the experim ental ones. D iscrepancies of sim ilar size also occur between the st-principles values of M iyam oto et al.23 and the experim ental values. The overall topology of our phonon band structure is in good agreem ent with the results of M iyam oto et al., although we cannot make a direct com parison due to the unusual shape of the h-BN supercell used in that work. Kern et al.²⁵ have also perform ed rst-principles density functional calculations of the phonon properties of both cubic and h-BN.Our phonon band structure is in reasonable agreem ent with that obtained by them, bearing in mind the di erent m ethodologies and geom etries used in their work and ours.

Rokuta et al.46 have obtained the phonon spectra of a BN monolayer deposited over a series of metal surfaces (N i, P d and P t) using high resolution electron energy loss spectroscopy. A gain, there is overall good agreem ent between the results reported by Rokuta and coworkers, and our own. Interestingly, they nd no splitting at between the LO and TO modes when the BN monolayer is placed over a Ni(111) surface, but som e splitting is seen when the other metals are used. This result was considered as quite surprising by these authors, especially taking into account that Ni(111) was the sole substrate on which BN form ed well ordered commensurate monolayers, and it was suggested that this is because Ni can e ectively screen the polarization eld of the LO mode, while Pd and Pt cannot. However, we maintain that the polarization eld only arises in 3D systems; in the 2D

case the electrostatic interactions do not give rise to a macroscopic eld for in-plane modes, i.e. the eld has zero component at , and hence there is no splitting of the TO and LO bands in that lim it. However, the electrostatic interactions do give rise to non-zero components of the eld in regions of the Brillouin zone away from , and these result in a higher over-bending when the electrostatic interactions are included. A nother consequence of the inclusion of the electrostatic interactions is the fact that the LO mode approaches with a nite slope, which does not occur when the electrostatics are not included [see Fig. 2 (a)].

P rom pted by this experim ental study, we have considered the e ect of the presence of an ideal m etal surface in the proxim ity of the BN layer on the phonon properties of the latter. The m etal surface is sim ply considered as a m edium which generates dipolar im ages of the BN m onolayer. The net result is to e ectively shorten the range of the electrostatic interactions: the nite slope of the LO m ode at is lost, and although quadrupolar interactions persist in the BN-m etal surface system, the dipolar interactions are screened out.

Interestingly, Rokuta et al.⁴⁶ report a degeneracy of the ZO and ZA modes at K. This is unexpected, because such modes should display a splitting related to the different masses of B and N. The fact that no splitting is observed in the experiments is probably a result of a deviation from planarity in the BN monolayer due to the presence of the metal surface. Another in portant point

m ight be the quite di erent positions occupied by B and N atom s on the surface. In fact, R okuta and coworkers reported a buckling of the BN m onolayers on N i(111), where B atom s, which occupy fcc sites, lie 0.2 A below the N atom s, which site directly on top of the N i atom s in the surface.

B. Nanotubes

Let us now move on to discuss the results obtained for BN nanotubes. We have considered a series of (n,n)(arm -chair), (n,0) (zig-zag) and (n,m) ($n \notin m \notin 0$, chiral) nanotubes. For (n,0) nanotubes we have included all tubes with n from 6 to 16, i.e. diameters from 5 to 14 A, approximately; while for (n,n) tubes we considered speci cally the (6,6), (10,10) and (15,15) tubes, with diameters between 8 and 21 A. Only two chiral nanotubes were considered, since these structures usually have very large unit-cells, namely the (10,5) and (10,7) tubes, with diameters of 10.6 and 11.9 A, respectively.

In Fig.3, for the (10,10) tube, and Fig.4, for the (14,0), we compare the phonon dispersion curves calculated directly from the tube structure, and those obtained for the same tubes employing the zone-folding approach from the phonon bands of the at sheet discussed above. Firstly, let us remark that the zone-folding method cannot reproduce certain low energy modes; in particular, it cannot give rise to a breathing mode, which in the at sheet corresponds to a zero energy translation perpendicular to the plane. However, the high frequency modes are expected (and indeed are) to be reasonably well described. In spite of the limitation regarding low frequency modes, the zone-folding approach has been extensively used for the interpretation of experim ental results of carbon nanotube vibrationalm odes^{14,36}, partly due to its sim plicity, and also to the fact that the phonon modes of graphite can be determ ined with very high accuracy. One of the aim s of the present paper is to study if the zone-folding approximation can also be useful in the case of the BN nanotubes.

G enerally speaking, for experimentally relevant tube diameters, the zone-folding method reproduces quite well the overall phonon band structure. Deviations can be larger for the smaller nanotubes, where the e ects of curvature are more noticeable. In particular, we shall see below how curvature e ects in uence the breathing mode. Another di erence that can be appreciated between the tube dispersion bands and those determ ined from zone-folding is a general softening of frequencies for the explicit calculation, where curvature e ects are taken into account. The downward shift is especially clear at high frequencies, but is also noticeable at intermediate ones. This shift is not hom ogeneous, and it has also a non-trivial dependence on the wave vector and on the nature of the mode (radial or tangential).

A lso shown in Fig. 4 is the vibrational DOS for the (14,0) tube decomposed in the different directions of the atom ic displacements. This curve resembles closely the result obtained for the BN monolayer. There is a clear energy separation between radial and tangential modes (parallel or perpendicular to the tube axis), the radial modes corresponding to frequencies below 700 cm⁻¹. This corresponds to the already mentioned separation between out-ofplane and in-plane-modes in the case of the planar sheet, as could be expected, since the radial modes are roughly derived from the out-ofplane vibrations of the plane.

There are four acoustic bands for the tubes. They correspond to a longitudinal mode (atom ic displacem ents parallel to the tube axis), two degenerate transversal modes (atom ic displacem ents perpendicular to the tube axis), and a torsion of the tube around its axis (the socalled twiston band which, in the lim it of k = 0, generates a rigid rotation of the tube around its axis). This last mode is characteristic of a one-dimensional system like the nanotubes, and no analog can be found for the bulk or the in nite planar sheet. A coording to Saito et al.⁴⁷, and in contrast to the case of the at sheet, all four bands would be required to approach linearly. This relates to the fact that none of the acoustic bands of the nanotubes is solely derived from the quadratic out-of-plane acoustic band of the sheet: the transversal acoustic bands can be regarded as a combination of the TA in-plane and ZA out-of-plane modes of the planar sheet. However, it is interesting to point out here that the low energy behavior of the transveral acoustic bands in the nanotubes is

still the subject of som e controversy and som e authors have recently proposed that these bands should exhibit a quadratic behaviour for sm all values of k^{48,49}. The situation is more clear for the other acoustic bands since it is possible to establish a one-to-one correspondence between the longitudinal and twiston bands of the tubes and the LA and TA bands of the planar sheet, respectively. In fact, the sound velocities of the latter bands are, within the precision of the calculations (1 Km/s), independent of the tube radius and chirality, and alm ost identical (although som ew hat sm aller) to those of the corresponding planar-sheet bands. Sim ilar results have been obtained for the case of the carbon nanotubes^{47,50}. This insensitivity to the tube structure and radius con ms the predictions of a simple continuum elasticity model of the tubes 51 where the elastic constants are directly taken from the planar sheet, from which one obtains $v_{L\,A}^{tube}$ = $v_{L\,A}^{2D}$ and $v_{tw\,iston}^{tube}$ = $v_{T\,A}^{2D}$. The independence of the mechanical properties on the chirality of the tubes is here a simple consequence of the isotropy of the underlying hexagonal structure of the BN planes. We have used this model to estimate the sound velocity of the transversal band, obtaining $v_{TA}^{tube} = \frac{1}{2} v_{TA}^{2D} = 9 \text{ Km/s}$. In the TB calculations, however, the transversal bands seem to be more sensitive to the num erical uncertainties than the other acoustic bands, being di cult to extract an accurate slope. In fact, although the transversal bands apparently exhibit a linear dependence with the phonon wavevector (see gures 3 and 4), for very sm all values of k, and consequently for very sm all frequecencies, they seem to bend slightly. This would be roughly consistent with the proposed 48,49 quadratic behavior, although problem s of num erical accuracy cannot be ruled out. The clari cation of this point will be the subject of future work. Here we have decided to make an estimation of the sound velocity of the transversalm odes from the slope of these bands in the region where they still exhibit a clear linear behaviour. In this way we have found values ranging from 7 Km/s, for the narrow er tubes, to 8 Km /s, for those with larger diam eters. This is again in reasonable agreem ent with the result that we obtained from continuum elasticity theory.




FIG. 5: Active modes for the (n,0), chiral and (n,n) BN nanotubes considered in this work. Symbols have the same m eaning for (n,0) and chiral tubes, except that for chiral tubes A1 has to be read as A (see the text). See Ref. 52 for the num erical values of the frequencies.

In Fig. 5 we have plotted the frequencies of the optically active modes for the di erent tubes considered as a function of the tube radius⁵². The values plotted have been obtained including the long range electrostatic interactions, but the picture does not change signi cantly if they are not included⁵³. We have classi-

ed the modes according to the corresponding sym metry point group⁵⁴, which for zig-zag (n,0) nanotubes is C_{2nv} , for am -chair (n,n) nanotubes is C_{2nh} , and for chiral (n,m) nanotubes is C_{n} , where $N = 2 (n^2 + m^2 + nm)/d_R$ with d_R being the greatest common divisor of 2n+m and $2m + n^{54}$, i.e. N = 70 for the (10,5) nanotube, and N = 146 for the (10,7) nanotube. The total num ber of R am an and IR active modes and their distribution over the frequency spectrum is very sim ilar for both zig-zag and chiral nanotubes. In the (n,0) nanotubes the rotationally invariant

modes can be classi ed according to how they transform under re ection through the sym metry plane v, namely A_1 and A_2 m odes; only the rst are R am an and IR active, the A₂ being inactive. The chiral tubes do not contain a w m irror plane, and therefore all six A m odes are active. In total, the (n,0) nanotubes have eight m odes with non-zero frequency which are both IR and Ram an active (three belong to the A_1 representation, and ve to the E_1), and six modes (E_2) which are only Raman active, while for the chiral tubes the count is nine \mathbb{R} and Ram an m odes (four A and ve E_1), plus six (E_2) R am an active m odes⁵⁴. In the case of the (n,n) nanotubes, due to the existence of inversion sym metry in the point group the active modes can only be either IR or Ram an active, having a total of four IR active (one A $_{\rm u}$ and three E $_{\rm 1u}$) and nine R am an (three A_q , two E_{1q} and four E_{2q}) active modes. Comparing with carbon nanotubes, the bigger di erence appears in the case of the (n,0) nanotubes, where the number of active modes is nearly double for BN nanotubes than for carbon nanotubes 5^{5} .




FIG. 6: (a) Frequency of the radial breathing mode of BN nanotubes as a function of tube radius. The inset presents a log-log plot which clearly shows the r¹ behavior. Panel(b) shows the relative radial displacement of the B atom s and the N atom s in the radial breathing mode. The evolution of the buckling in the nanotube structure is plotted in the inset as a function of the radius. The meaning of the sym bols is identical in all the panels and plots. See Ref. 52 for the num erical values of the frequencies.

In Fig. 6(a) we have plotted the frequency of the breathing mode as a function of the tube radius. This mode is of importance in carbon nanotubes because it can be correlated with the tube radius and it is R am an active

for all tube chiralities. The same is true here. A lthough there are m inor deviations at sm all radii (below 4 A), the breathing m ode frequency follows very closely a dependence on the inverse of the tube radius: $_{\rm BM}$ (r) = A=r. This is corroborated in the log-log plot shown in the inset

of Fig. 6 (a), which ts very well to a linear behavior with a slope -0.97 0.01 (-1.09 0.03 including the tubes with r < 4 A). Leaving out the tubes with r < 4 A, a t to this expression gives $A\,=\,1091$ cm ^{-1}A , with a standard deviation sm aller than 3 cm $^{-1}$. This value is quite in sensitive to the tube structure, as occurs also with carbon nanotubes^{37,56}. As can be seen in Fig. 6(a), the breathing mode exhibits a hardening for the smaller structures (r < 4 A) respect to what would be expected from the r¹ t to the frequencies of the tubes with the larger diam eters. If we include the frequencies of the sm aller tubes, the quality of the t decreases (m ean deviation of 16 cm⁻¹) and the value obtained for A increases to 1160 cm ${}^{1}A$, in accordance with the mentioned hardening. Interestingly, this behavior is the oppositte to what was observed for the carbon tubes 37 , where there is a softening of the breathing m ode for increasing curvature. Therefore, this e ect must be related to an unique characteristic of the BN tubes as compare to the carbon nanotubes: the buckled structure of its surface. For sm all and m oderate radius BN nanotubes, the B atom s lie som ew hat closer to the nanotube axis than the N atoms. This buckling is of the order of 0.1 A for the sm allest nanotubes, but decreases rapidly with increasing radius²⁷. Fig. 6(b) shows how the nanotube atom s are displaced in the breathing mode. The values plotted are the magnitude of the radial displacem ent of B atom s (R_B) divided by that of the N atom s (R_N). For $R_B = R_N = 1$ the displacements are of equal magnitude, and we would have a pure breathing mode, just as in a carbon nanotube. The observed behavior is slightly di erent: for tubes with r < 4A the displacement of the N (outer) atom s is larger than that of the B (inner) atoms. This can be explained in a simple model as a consequence of the tendency to preserve in the pattern of displacem ents of this vibrationalm ode the bond angles of the buckled surface.

As is well know $n^{24,48,56}$, the constant A can be estimated from the elastic constants of the plane,

U sing this equation we obtain the value A = 1135 cm ${}^{1}A$, which is in reasonable agreem ent with the value found by the direct calculation.

Finally, let us discuss the ability of the zone-folding approach to predict the frequencies of the active modes of BN nanotubes. In the gures 7 and 8 we plot the frequencies obtained from zone-folding side-by-side with those obtained directly from the nanotubes, in both cases including the electrostatic interactions. For clarity, this is done separately for interm ediate frequencies (around 700 cm⁻¹) and for high frequencies (above 1250 cm⁻¹), and separately for (n;0) and (n;n) nanotubes. O verall, we can say that zone-folding is capable of rather accurate estimations of the actual frequencies, particularly for nanotubes with radii larger than 4 A. In this case even




FIG. 7: C om parison between the optically active m odes predicted by the zone-folding approximation and those obtained directly from the tubes geometry. Here we show the results for (n,0) BN tubes with n running from 6 to 14. The modes have been classified according to their symmetry (the meaning of the symbols is the same in the four panels). For clarity, intermediate frequencies (around 700 cm⁻¹) and high frequencies (above 1250 cm⁻¹) are shown separately. See Ref. 52 for the numerical values of the frequencies.




FIG.8: Sam e as Fig.7 but for (n,n) tubes, with n = 6,10 and 15. See Ref. 52 for the num erical values of the frequencies.

the ordering of the m odes is accurately reproduced, both for (n;0) and (n;n) tubes. The interm ediate frequency m odes are very well reproduced, but there is a slight overestimation of the high-frequency m odes, of the order of a few tens of wavenum bers.

That the zone-folding approach is capable of providing accurate estim ates of the BN nanotube phonon frequencies rests on the absence of a k = 0 (m acroscopic) dipolar eld in the BN monolayer. The reduced dimensionality of the system prevents the build up of a k = 0 com ponent of the electrostatic eld, which thus only has a nite range. Therefore, no splitting of modes is observed at ; the only e ect of the electrostatic interactions is to shift slightly the high frequency modes and to confer a nite slope to the LO mode in the k ! lim it, m odi cations which do not prevent zone-folding from providing accurate estim ates of the phonon m odes of isolated nanotubes. A subtle point here is that the applicability of zone-folding in the case of BN also depends on the degree of transferability of the dielectric constant and the Bom e ective charges [see Eq.(2)] between the monolayer and nanotube geom etries. For sm all nanotube radii there m ay be noticeable changes in the dielectric constant, but this is unlikely to a ect the application of zone-folding to all but the narrowest nanotubes.

IV. SUMMARY AND CONCLUSIONS

In this work we have presented a detailed analysis of the vibrational properties of a BN monolayer, and of single-walled BN nanotubes of di erent diam eters, including (n,0), (n,n) and two chiral nanotubes. Our calculations are based on a non-orthogonal TB model com – plem ented with long-range electrostatic interactions, not included in the TB model. The incorporation of these electrostatic interactions corrects to som e extent the de-

ciencies of the TB m odel at interm ediate and high frequencies in the BN layer. Using a simple m odel for a m etal surface, we have analyzed the in uence of placing a BN m onolayer over such a surface on the phonon bands of the m onolayer. The e ect appears to be sm all and con-

ned only to the high frequency range, above 1250 cm $^{-1}$. Generally, our calculated phonon frequencies, sound velocities and elastic constants are in good agreem ent with previous experim ental and theoretical results. Concerning the nanotubes, we have obtained phonon band structures and have analyzed the optically active modes (IR and R am an) as a function of the nanotube structure and radius. W e have also perform ed a detailed com parison between the predictions of the zone-folding approach and the actual frequencies of optically active modes obtained directly from the nanotubes, nding rather good agreem ent between the two for all except the narrow er tubes, having radii below 4 A. High frequency mode frequencies are system atically overestim ated by about a few tens of wavenum bers, but interm ediate m ode frequencies are given with high accuracy. Therefore, zone-folding should

also be useful in the context of BN nanotubes, as it has been in spectroscopic studies of carbon nanotubes. We also report on the behavior of the frequency and the pattern of atom ic displacem ents of the radial breathing mode as a function of the tube radius.

APPENDIX: ABSENCE OF LO-TO SPLITTING FOR A BN MONOLAYER

In this appendix we brie y discuss the role of longrange electrostatic interactions in a monolayer, com paring the results with those found for bulk systems. Let us consider a thin slab of polar material parallel to the xy plane. We focus rst in the in-plane optical modes, for which the atom ic displacem ents u are parallel to the xy plane. A spociated with this phonon there is an electric polarization eld $P = \frac{1}{\lambda} (Z u) f(z) \cos(k r)$ and a charge density P = r P, where Z is the Born e ective charge tensor within the unit cell, A is the area of the unit cell, and f (z) is a function related to the pro le (num ber of layers) of the slab which can be approxim ated by (z) for a monolayer. We stress that k, u, and P are all parallel to the slab for pure in-plane modes. For the particular case of a system with hexagonal sym m etry, like our BN sheets, the in-plane properties are isotropic, and Z can be regarded as a scalar. A lthough this is not crucial for our argum ents, we will make this sim pli cation in the following. The charge density $_{_{\rm P}}$ is proportional to the product k u, and no m acroscopic charge accum ulations appear due to the TO modes. However, a macroscopic electric eld $E_{m ac}$ can appear associated with the LO modes. The correct lim it when $k \ ! \ 0$ is then calculated by solving Poisson's equation for . The components of the electric eld in the directions parallel to the slab are

where k is the modulus of k, and B (z;k) is given by

f (q) being the Fourier transform of f (z). Once the electric eld has been calculated, the corresponding modi cation of the force-constants matrix can be obtained taken into account that the force acting on an atom is given by F = Z $E_{m ac}^{33}$. In the case of the monolayer we take f(z) = (z), then B (z = 0;k) = 1=2 and the correction of the force-contants matrix for the in-plane m odes becomes

This correction goes to zero when k ! 0 irrespective of the polarization of the m ode and, therefore, both LO and TO in-plane m odes have the same frequency. This is in agreem ent with the results obtained for slabs of ionic materials using di erent m odels^{57,58}: pure in-plane optical m odes have frequencies close to those of the TO phonons in the bulk. It can also be noticed the linear behavior of the LO m ode as it approaches . We move now to analyze the bulk limit. By taking f(z) = 1=L, being L the distance between atom ic layers, we can study the limit for bulk phonons with $k_z = 0$ (k_z is the wavevector perpendicular to the atom ic layers in the bulk). B (z;k) becom es now 1=(Lk), and the term in the force-constants matrix takes the usual form for bulk system s³³

which has a di erent value for LO and TO modes. For the interm ediate case of a slab with nite thickness we nd bulk behavior for phonons with su ciently large k, while the behavior of the monolayer is recover when k goes to zero. The slope of the LO modes at is proportional to the num ber of layers in the slab.

For modes with polarization vectors having components along the norm al to the slab (out-of-plane com ponents within the nom enclature used throughout this paper) things can be quite di erent. For these modes, P has a component along z and, when k = 0, the charge distribution $\ _{_{\rm P}}$ associated to them can be rationalized as a number of in nite planes with charges of alternating signs along z. There are also surface charges given by $\hat{n} = P$. All these charged planes give rise to elec-Ρ tric elds which do not decay along the entire thickness of the slab. In fact, those modes with atom ic displacem ents perpendicular to the slab, although are transversal by de nition (since the only phonon wavevector that can be safely de ned is parallel to the slab), are known to have frequencies similar to those of the corresponding longitudinal phonons in the $bulk^{57,58}$. For this reason, Fuchs and K liew er⁵⁷ and Lucas⁵⁸ arrived to the conclusion that the phonon-frequency distribution of an ionic crystal slab converges very rapidly to that of bulk. How ever, for anisotropic systems like h-BN, where the frequency range of the in-plane and out-of-plane vibrations is very di erent, the conclusion m ight be di erent.

In the case of a free m on olayer the separation between in-plane and out-of-plane m odes is exact for an arbitrary wavevector k. There is only one out-of-plane optical m ode (ZO) which, although its frequency is slightly m od-i ed by the long-range interactions, cannot exhibit any splitting since it is a non-degenerate m ode. The LO and TO in-plane m odes do not exhibit splitting as explained above.
