Spin triplet superconductivity in Sr₂RuO₄

A bstract

 $\rm Sr_2R\,uO_4$ is at present the best candidate for being a superconducting analogue of the triplet super uidity in $^3H\,e.$ This material is a good (albeit correlated) Ferm i liquid in the normal state and an exotic superconductor below T_c . The mechanism of superconductivity and symmetry of the order parameter are the main puzzling issues of on-going research. Here we present the results of our search for a viable description of the superconducting state realised in this material. Our calculations are based on a three-dimensionale ective three-band modelw ith a realistic band structure. We have found a state with non-zero order parameter on each of the three sheets of the Ferm i surface. The corresponding gap in the quasi-particle spectrum has line or point nodes on the and

sheets and is complex with no nodes on the sheet. This state describes remarkably well a number of existing experiments including power low temperature dependence of the speci c heat, penetration depth, therm al conductivity etc. The stability of the state with respect to disorder and di erent interaction parameters are also analyzed brie y.

Introduction. The discovery of superconductivity in $Sr_2 R uO_4$ [1,2] has generated renewed interest in this material [3]. O riginally the main motivation in Ref. [1] was the close similarity of its crystal structure with that of high temperature superconducting oxide $La_2 \ge Ca_x C uO_4$. How ever, unlike cuprates, strontium nuthenate is metallic without doping and is not readily superconducting. Indeed, very pure single crystals have superconducting transition temperature $T_c = 1.5K$, rather low on the scale of the high T_c cuprates.

In the normal state the electrons in strontium ruthenate form a well behaved, albeit anisotropic and correlated, Fermi liquid. In particular the resistivity shows a typical quadratic dependence on temperature $_{i}(T) = _{i}^{0} + A_{i}T^{2}$ at low temperatures. Here $_{i}^{0}$ is the residual' resistivity measured at temperature just above T_{c} and i denotes the direction of the current (i = ab for in plane and i = c for c-axis resistivity). Electronic transport is very anisotropic with the ratio of $_{c}=_{ab}$ exceeding 500. Normal state electronic speci c heat shows a typical linear dependence on temperature, $C_{e} = T$, with a high value of $= 37.5 \text{ m J/K}^{2}$ m ol. The appreciable enhancement (factor 3-5) of over the band structure calculations indicates the existence of strong carrier correlations in the system. The same conclusion can also be drawn from the enhanced value of the ratio between Pauli spin-susceptibility and (W ilson ratio) and the so called K adow akiW oods ratio of the coe cient A_{ab} to . These values exceeds those for non-correlated system s.

C onsistent with the above picture is the fact that rst-principles calculations based on the LocalD ensity Approximation (LDA) give a good qualitative account of the electronic structure [4]. The energy spectrum around the Fermi level of strontium ruthenate is dominated by electrons occupying t_{2g} orbitals (d_{xz} , d_{yz} , d_{xy}) of R u⁴⁺. The Fermi surface consists of three

cylindrical sheets open in the z-direction. Those called and stem from hybridised d_{xz} and d_{yz} orbitals, while the sheet is mainly of d_{xy} character. The sheet is a hole Ferm i surface. It is centered at the point X of the bct B rillouin zone and possesses two fold sym metry. The calculated shape of the Ferm i surfaces agrees nicely with that measured via de H aas{van A lphen e ect [5].

W hile the norm al state, as shown above, is quite typical of a good metal, the superconducting state is very exotic. The superconducting transition temperature T_c is strongly suppressed by even small amount of in purities [6]. The NMR measured relaxation rate shows no Hebel-Slichter peak, and the SR experiments indicate the appearance of spontaneous magnetic elds at $T < T_c$. Together with a temperature independent K night shift, all that points towards very unconventional, presumably spin-triplet, and superconductivity with a time reversal symmetry breaking pairing state.

Because the electrons form ing Cooper pairs in superconductors are ferm ions, the pair wave function has to be odd with respect to interchange. It consists of spin and orbital components. If the total spin of a pair is zero then such a pairing state is called spin-singlet. The corresponding spin-wave function is odd so the orbital part has to be even. In G alilean invariant systems they correspond to even values of the orbital quantum number l = 0;2::: and the corresponding superconducting states are referred to as having s $_{,d}$, ::: wave sym m etry. The s wave sym m etry is realised in conventional superconductors, while d wave is the case in high tem perature superconductors. The electrons in strontium ruthenate m ost probably pair in relative spin triplet state. Their spin wave function is even and thus the orbital one has to be odd. Even though a crystal has only discret rotational sym m etry, the corresponding sym m etries of the superconducting state are still called p , f , ::: wave.




Figure 1: Calculated tight binding Ferm i surface of Sr₂RuO₄.

A swell known, a relatively weak dependence of T_c on the concentration of in purities and an exponential dependence of the electron speci c heat on temperature point to spin singlet s-wave superconductivity. On the other hand a power law temperature dependence of speci c heat is characteristic of a superconducting gap which vanishes at points or along lines on the Ferm i surface, and a dram atic decrease of T_c with impurity concentration is a signal of 1>0wave' paring.

The puzzling behaviour of Sr_2RuO_4 in the superconducting state is connected with the facts that NM R, SR and related experiments indicate the realisation of the $(k) = e_z (k_x ik_y)$ state which does not vanish at the Ferm i level and that the power law temperature dependence of the speci c heat [7], penetration depth [8] or therm al conductivity [9] which require the gap to vanish along lines of the Ferm i surface. The point is that out of all the sym m etry distinct states of a bct crystal [10] none of the odd-parity states have to be time reversal sym m etry breaking and also possess gap nodes at the same time (c.f. table I). The various states, form ally full lling both requirements proposed in literature [11, 12] can be shown to be the sum of sym m etry allowed states with distinct transition temperatures. The single superconducting transition observed in all studied sam ples rules out all these proposals as the single transition could only be a result of accidental degeneracy. Instead of relying on a sym m etry arguments alone, we present a m ethodology which is based on explicit construction of an e ective pairing interaction.

Bebw, we shall present in Sec. 2 the model and our approach. In Sec. 3 we present the results of calculations, and nally we end with our conclusions.

The model and the approach. Our model of superconductivity in strontium ruthenate is motivated by the experimental facts, sum marised above. The electronic structure features three Ferm is urfaces, and all of them are gaped to ensure the vanishing of the specie cheat at T = 0K. Further, there exists a single superconducting transition and the gap has to both break the time reversal symmetry and vanish on the lines of the Ferm is urface. We shall full leal these constraints in the context of a realistic three dimensional band structure with parameters tted to the known details of the Ferm is urface, and assumed e ective attractive interactions between electrons occupying various orbitals.

W e thus take the follow ing sim ple multi-band attractive H ubbard H am iltonian:




Figure 2: The relative positions of Ru ions in the tetragonal Sr₂RuO₄ lattice. The heavy lines symbolise them aim interactions. Interplane U_k for the electrons occupying d_{xy} orbitals at the neighbouring in planes ions and U₂ for out of plane neighbours and d_{xz} and d_{yz} orbitals.

as our model which is to describe superconductivity in Sr_2RuO_4 . Here m and m⁰ refer to the three Ruthenium t_{2g} orbitals to be denoted a = d_{xz} , b = d_{yz} and c = d_{xy} in the following. i and j label the sites of a body centered tetragonal lattice. The hopping integrals $t_{m\,m\,0}$ (ij) and site energies "m were tted to reproduce the experimentally determined three-dimensional Ferm i Surface [5, 13]. We found that the set $t_{m\,m\,0}$ shown in Table 2 gave a good account of the data.

In choosing the interaction parameters $U_{m\ m\ 0}^{0}$ we adopted a frankly sem iphenom enological approach. Namely, we eschewed any e ort to derive these from an assumed physicalmechanism of pairing and endeavoured to nd a minimal, hopefully unique, set of parameters which describes the available data. The point of such strategy is that at the end we can claim to have identied the position and orbital dependence of the interaction and therefore provided guidance for constructing microscopic models for specific mechanisms.

In the above spirit we consider two sets of interaction constants: $U_{m\,m\,0}^{k}$ for nearest neighbours in the plane and $U_{m\,m\,0}^{?}$ for nearest-neighbour Ru-atom s in the adjacent plane as indicated in Fig. 2. To lim it further the parameter space we need to explore, we assume that




Figure 3: Lowest energy quasiparticle eigenvalues, E (k) on the (a) and (b) Ferm i surface sheets; (a) polar plot of the sheet in the plane $k_z = 0$, E $_{m \ ax} (k_F) = 0.22 \text{ meV}$, E $_{m \ in} (k_F) = 0.056 \text{ meV}$ (b) vertical cross-section of the cylindrical sheet in the plane $k_x = k_y$, E $_{m \ ax} (k_F) = 0.32 \text{ meV}$. A non-zero f wave order parameter (dotted line) lifts the p-wave line nodes (solid lines).

In fact, we take $u = u^0 = 0$ for most of our calculations and we use only one in plane, U_k , and one out of plane U_2 , parameters to the experimental data on the speci c heat, $c_v(T)$, super uid density $n_k(T)$ and the thermal conductivity $_T(T)$. The purpose of the few calculations with $u \in 0$, $u^0 \in 0$ was only to investigate the stability of the U_k ; U_2 results to variations in $U_{m\,m\,0}^k$ and $U_{m\,m\,0}^2$.

W ithin the above m odel, we solved the Bogolubov-de Gennes equations:


which follow from Eq. (1) on making the usual BCS-like mean eld approximation [14]. Since $H_{mm0}(ij)$ and $\int_{mm0}^{0} (ij)$ depend only on the dimension \mathbb{R}_{i} \mathbb{R}_{j} the solution of Eq. (3) is rendered tractable by taking its lattice Fourier transforms and, thus transforming the problem into that of a 12 12 matrix, eigenvalue problem at each k in the appropriate Brillouin Zone. For $u = u^{0} = 0$ the general structure of $\int_{mm0}^{mm0} \mathbb{R}$ turns out to be of the form



form ; $m^0 = a \text{ or } b$.

Our self-consistency procedure always converged on the amplitudes \sum_{c}^{x} ; \sum_{c}^{y} , $\sum_{m,m}^{z}$, $\prod_{m,m}^{r}$, (T), $\sum_{m,m}^{f}$, (T), $\sum_{m,m}^{x}$, (T) and $\sum_{m,m}^{y}$, (T) to an accuracy higher than 10⁴ %. The principle results of such calculations are these amplitudes and the corresponding quasiparticle energy eigenvalues E (k). These eigenvalues are shown in Fig. 3, for the interaction values U_k , U_i given in Table 2, and with the constraint that \int_{m}^{f} , (T) = 0. Evidently from the gure, on the sheet there is an absolute gap below E m in (K_F), in the quasi-particle spectrum, while the

sheet is gapless with a line of nodes in the gap functions at $k_z = \frac{1}{c}$ This dram atically di erent gap structure and symmetry on di erent sheets of the Ferm i Surface is the striking new results of an interaction matrix $U_{m n^0}$ (ij) which couples electrons in di erent Ru-planes.

From the results in Fig. 3, one is encouraged to investigate this form of interaction further because, on the one hand, the line of zero gap on the sheet explains the power-law behaviour of various therm odynamic quantities and, on the other, on the fully gapped sheet (k) = k

 $_{\rm cc}$ (k) = $_{\rm cc}^{\rm c}$ (sin $k_x \, a + \, i \, sin \, k_y \, b)$ which in plies the broken time reversal symmetry demanded by a number of other experiments. Indeed, for the above pair of interactions, U₂ and U_k, and the corresponding quasiparticle spectra well that specific cheat $_{\rm c}(T)$ shown in Fig. 4 as a function of T. A lthough these parameters were chosen to the experimental data which is also shown, the agreement between theory and experiment is truly remarkable. The point to appreciate is that in general two dimensions and U₂ in ply two separate transitions at $T_c^{\rm k}$ and $T_c^{\rm 2}$. Thus, to agree with the experiments which features a single transition at $T_c = 1.5$ K we had to use both degrees of freedom s. N amely, ttting T_c determined both coupling constants U_2 and U_k . Now, one might suggest that it is a short-coming of our model that we have to rely on such an accidental coincidence of U_k and U_2 to the number $T_c^{\rm exp}$. However, in the light of the very good to the very non trivial experimental variation of ς with temperature this is not a strong objection. Indeed, the fact that having tted to $T_c^{\rm exp}$ only and we have reproduced the slope as T goes to zero and the size of the jump at T_c has to be regarded as a conimit of our model.

C oncluding remarks. Our calculations [15] of the super uid density $n_{E}(T)$ [8] and therm all conductivity (T) [9], for the same parameters as above, provide further evidence in support of our model. Note that these calculations do not involve additional adjustable parameters




Figure 5: The structure of the order param eter. The big arrow corresponds to the orbital momentum lofthe Cooper pair, while sm all arrows show the spins of the electrons which add to s = 1. In the frame in which $l_z = 1$ one has $s_z = 0$.

and thus the results are not only qualitative consequences of nodes of the gap on the and sheets of the Ferm i Surface but are also quantitative predictions of the theory.

In what follows we conclude this brief survey of our very encouraging results by two further important comments. The set concerns the constraints $\int_{mm0}^{f} (T) = 0$ imposed at each step of the selfconsistency cycle during the above calculations. Without this constraint there would be a second transition $T_c^f < T_c$, where $\int_{mm0}^{f} (T)$ becomes non zero and this would imply a peak in $c_v(T)$ at T_c^f ' 0.2 K, which has not been seen experimentally. Fortunately, we have been able to show by explicit quantitative calculations that a small amount of disorder will eliminate the $\int_{mm0}^{f} c$ or ponent of the order parameters without changing the other amplitudes in Eq. (4) very much. The details of these calculations will be published elsewhere [15]. This justi es, at the present level of the mean-free path in samples on which the experiments were made, the simultaneous neglect of disorder and the f-component $\int_{mm0}^{f} c(T)$.

The other comment is that we have studied the stability of the above model (Eqs. 1-5, Fig. 5) to introducing further interaction constants and found it to be satisfactorily robust. In particular we have carried a number of calculations with $u \in 0$ and $u^0 \in 0$ and, as we shall report in a separate publication, we found [15] that the overall picture presented above remained the same e. N am ely, our conclusion that a model with just two interaction constants, one in plane U_k , and one out of plane U_2 (Fig. 4) roughly of the same size, around 50 m eV, is capable of explaining all the available data we have analyzed remained valid.
