# GRIFFITH CRACKS IN THE MESOSCOPIC MICROCRACK THEORY

Abstract. The m esoscopic concept is applied to the description of m icrocracked brittle m aterials. The m esoscopic equations are solved in a special case when the m icrocracks are developing according to the R ice-G ri th evolution law. The evolution of the crack distribution function is investigated in case of sim ple loading conditions and for two di erent initial crack distribution functions. The tim e dependence of the average crack length is calculated, too.

## 1. Introduction

There are several di erent approaches for the description of the behavior of material with complex m icrostructure, e.g. granularm edia, liquid crystals or dam aged solid m aterials. One of the basic approaches is the m acroscopic one applying therm odynam ic concepts and principles to describe the m icrostructure (e.g. internal therm odynam ic variables). The other basic but di erent approach is the statistical one where the m icrostructure is considered as a statistical ensem ble and the m acroscopic variables are calculated from the interactions between the m icrostructural elem ents using the principles of statistical m echanics. M odelling the m icrostructure tests the lim its of applicability of both theories and therefore the basic principles of our understanding regarding the m aterial behavior.

The microscopic elements of statistical cracking phenomena are the single cracks. The form and validity of single crack evolution equations is an important problem in statisticalm icrocracking. Beyond the well known classical results (see e.g. [1, 2]) there are new and promising approaches and investigations in this eld that should be considered. Langer and his coworkers  $[\beta, 4, 5]$  gave a microscopic background of the internal variable approach of plasticity [6]. Using molecular dynam ic sim ulations they found some good microscopic candidates of the internal variables. Based on these observations a so called shear deform ation zone (STZ) model was established, suggesting a dynam ical equation of these internal variables, including also special unilateral requirem ents. Several inconsistencies of classical single crack m odels can be explained using this theory. Another interesting approach to single crack phenom ena considers cracking as a kind of nucleation problem, where elastic and conservation e ects are included in the nonlocal (coarse grained) phase eld model [7, 8, 9], or the elastic e ects are included into a more direct nucleation approach [10, 11, 12]. Both STZ and the phase eld approaches can be considered as phenom enological therm odynam ic theories.

On the other hand, partially independently of the previous considerations m icrocracking is treated also from a statistical point of view. There are two competing

m odels in this respect. Somette and his coworkers considers cracking as a critical phenom enon where rupture is a critical point. Their approach is supported by experim ental scaling observations, by num erical simulations (see [13, 14] and the references therein). O ther observations and simulations suggest that the rupture of the material is better considered as a rst order phase transition and the cracking as spinodal nucleation [15]. Scaling calculations based on the previously mentioned nucleation models partially support that approach. From the point of view of nonequilibrium therm odynam ics the background of both the statistical and single crack models is the violation of therm odynam ic stability in the nonequilibrium state space. This observation alone can unify several classical failure and fracture criteria and explain experimental observations [16, 17].

However, between pure phenom enological and statistical approaches there is an independent family of theoretical descriptions that we can call hypercontinuum theories. In these theories the physical quantities are not simple m acroscopic elds given on the appropriate space-time (classical, special or general relativistic), but one assumes that in addition to the space-time variables they depend also on some m esoscopic variables characterizing the m icrostructure of m aterials. These theories have alm ost as long history as the traditional m acroscopic and m icroscopic ones. At the beginning they were used to m odel rotating internal particles in m icrocrystalline m aterials (see the basic works of the C osserat brothers and M indlin [18, 19]), now adays generalized continua are used to m odel e.g. granular m edia [20, 21, 22], liquid crystals [23, 24], ferro uids [25, 26], polymer solutions [27, 28], but one can m eet hypercontinuum in general relativity, too [29, 30] (see also [31] and the references therein).

Hypercontinuum theories represent models of the material where one can get inform ation from below the macroscopic but above the microscopic level. That gives the basic motivation and modelling idea to the so called mesoscopic theory, that uses both macroscopic, continuum and microscopic, statistical concepts constructing the basic equations of motion for the hypercontinuum. This approach was successfully applied for the description of liquid crystals (see [32] and the references therein).

Recently a mesoscopic theory was suggested for a special class of dam aged materials, form icrocracked brittle solid media [33]. In this paper we will see, that considering the peculiar properties of microcracking simpli es the mesoscopic equations well enough to make them solvable with relatively little e ort. This simpli cation results in a generalized Liouville equation that we will solve considering a simple evolution equation for the microcracks in case of two dimentions. We applied Rice-G ri th microscopic dynamic equations as the simplest unilateralmicrodynamics that is exactly (analytically) solvable on the statistical level. The explicit expression of the microcrack distribution function makes possible to investigate the relevance of some damage parameter and its respective evolution equation and the role of microscopic unilateral constraints.

## 2. Basic concepts of mesoscopic microcracking

In this section we give a short sum m ary of the m esoscopic m icrocrack theory and the related equations governing the developm ent of crack distribution function. For a m ore detailed treatm ent we refer to [33].

In a mesoscopic theory of a microcracked continuum our quantities are interpreted on the directional space that includes the 1 length of the microcracks and the x;t space-time coordinates. The cracks are considered as penny shaped surfaces with area  $l^2$  and orientation n. These two quantities characterizing the crack are put together as a vector l = ln, where l is the crack radius. The m icrostructure consists of this surface vector of the cracks. This vector is an axialone, that we do not consider as an antisymm etric tensor but for the sake of convenience we use norm al polar vectors with a symm etry requirement on their number density function:

The basic equations of the m esoscopic theory are the m esoscopic balances of the fundam ental physical quantities. Due to the enlarged con gurational space, the m esoscopic velocities and the m esoscopic m aterial current densities have six com – ponents and can be decom posed into a 'norm al' part (with respect to the position variable) and a 'm esoscopic' or 'directional' part. The m acroscopic num ber density of m icrocracks of any size and orientation at position x and time t. N can be introduced with an integration over the directional part of the m esoscopic space [34]: N (x;t) = hN (l;x;t)i =  $\frac{1}{2} R^3 N (l;x;t) dV_1$ : Now the balance of the m esoscopic num ber density, the generalized continuity equation can be written as:

Here v is the translational velocity, the space part of the m esoscopic velocity and  $v_1$  is the 'directional' part. r<sub>1</sub> denotes a derivation with respect to the variable l and as a part of the m esoscopic divergence represents physical requirem ent that the num ber of crack with a given length at a given m aterial elem ent can be changed by changing the length of som e sm aller or larger cracks. dot stands for the divergence, the source term  $_n$  characterizes the creation and coalescence of m icrocracks.

We introduce a distribution function f as the probability density of a crack having a particular length and orientation as follows

From the mesoscopic balance of number density follows the equation determining the time development of the crack distribution function is

In addition we have balance equations for the m esoscopic densities of all other extensive quantities e.g. one can give the m esoscopic balances of m ass, m om entum, angular m om entum and energy [35]. The m acroscopic balances can be introduced with averaging the corresponding physical quantities over the additional, enlarged part of their dom ain, using the previously introduced directional probability distribution function.

W e are interested here in the evolution of crack lengths and dam age is described in terms of the crack length distribution function. However, crack orientation was introduced as an additional mesoscopic variable together with crack length, and there m ay be an arbitrary distribution of crack orientations. Special cases of orientation distributions are: an isotropic distribution of all orientations, or, as the other extrem e case parallel orientations of all cracks. Very offen we will meet cases in between: the cracks are not oriented exactly parallel, but there is a preferred orientation. In these cases the orientation distribution can be rotation symmetric (uniaxial) or not (biaxial). This classi cation in terms of the orientation distribution is analogous to liquid crystals [36, 37], where the mesoscopic variable is the orientation of elongated molecules. Here we want to consider only averages over all crack orientations. We introduce the crack length distribution function as the average over all crack orientations:

A veraging of the di erential equation (3) over orientations results in the equation of m otion for the crack length distribution (11). (For m ore details see [38].) It is the same form of di erential equation for any orientation distribution. Only the value of the crack length change velocity  $v_1$  depends on the orientation distribution via the e ective stress acting on cracks of di erent orientations. Therefore we have only a parametric dependence of the di erential equation to be solved for the crack length distribution distribution, and the same form of solutions is expected for any orientation distribution.

The distribution functions are norm alized:

3. Solution of the mesoscopic equations

There are essentially two m ethods to gain inform ation from the basic equations of the m esoscopic theory. The rst one, that was used mainly for liquid crystals, is to calculate a moment series expansion of the equations. Using this expansion we can introduce a hierarchy of macroscopic internal variables together with their evolution equations. This can be useful also in our special case, the nature of macroscopic damage parameters and the properties of their evolution equations is an old and strongly discussed problem in continuum damage mechanics. How ever, now we will prefer another method: we will solve the mesoscopic equations in sim ple cases to get direct inform ation how the distribution function of microcracks evolves in time.

The system of mesoscopic balance equations given in the previous section is too general for most of the practical problem s and materials in damage mechanics. In case of brittle (rock or ceramic) material the following simplications are suitable

- 1. The base m aterial does not have an internal spin, that is a crack does not rotate independently from the base m aterial.
- 2. There are no couple forces and couple stresses.
- 3. There are no external body forces (f = 0),
- 4. The material is in (local) mechanical equilibrium ( $\underline{v} = 0$ ).
- 5. The translational velocity v does not depend on the crack size and orientation. It is the same for all cracks, namely it is equal to the velocity of the center of m ass of the surrounding continuum element (v (l;x;t) = v(x;t)). This does not imply restrictions on the length change velocity.
- 6. There is no creation of cracks. This is not a crucial restriction. For example preexisting voids are considered as m icrocracks of very small size. In the

progress of dam age they are growing, but their number is constant. (The voids in the initial stage are "counted" as cracks.)

7. There is no crack coalescence. Together with the previous assumption we postulate that there are no crack sources, i.e. the number of cracks is constant in time. Let us remark, that the absence of coalescence does not mean the absence of interaction. Interaction can be considered in the microscopic dynamics as we will see below.

Let us rem ark that these assumptions are not necessary, more general cases can be treated in the frame of our model. E.g. crack creation and coalescence can be considered through a suitable source term in (1). However, in this paper we maintain the theory as simple as possible to investigate some e ects of microscopic unilateral dynamics.

All the previous assumptions are reasonable in case of solid materials. Considering these assumptions we nd that the balance of moment of momentum is trivial, the balance of momentum simpli es to the condition of mechanical equilibrium :

r t= 0;

where t is the stress. Moreover at present we are not interested in the changes of the mass density and the produced energy during cracking, we will concentrate on the evolution of the crack distribution function.

As a result of the conditions 5–7 the m acroscopic number density of m icrocracks does not change in a material element (only the lengths can be changed) and there is no source term at the mesoscopic level. Therefore there is no source term in the dimential equation for the crack distribution function (3). Due to condition 4 choosing a comoving frame results in a zero translational velocity and we get the following simple equation:

Let us m ention here that in this case the equation above has a direct interpretation. From a pure statistical mechanical point of view this is a continuity equation for the probability density of m icrocracks having the "m icroscopic" dynam ical equation

#### $1 = v_1(1)$ :

Here the point denotes the substantial (com oving) time derivative. How ever, the special form of the di erential equation for the distribution function depends on the equation for the length change velocity. This expression can involve a dependence on orientations and lengths of surrounding cracks and also several other forms of crack interaction. The equation (7) is a generalized form of the classical reversible Liouville equation of statistical mechanics, determ ining the dynam ics of the distribution function f with the help of a known determ inistic (!) m icroscopic dynam ics [39]. From this observation it is clearly seen, that in the simplest non-interacting, reversible case the m esoscopic theory is fully compatible with the basic statistical theories and continuum theories, too.

## 4. Rice-Griffith dynamics

As an example we will use one of the simplest, but well known dynam ics that was given by Rice from general therm odynam ic considerations giving an irreversible therm odynam ic background to the energetic considerations of G ri th [40, 41]. The

condition is derived for a single crack under uniform tensile loading parallel to the direction of the crack surface norm al. The main assumption in the construction of the dynam ics is that the G ibbs potential depends not only on the stress but also on the crack length in the following way

Here is usually considered as a kind of surface energy, is connected to the energy release rate in case of simple geom etric situations, is the elastic coe cient, l is the length of the crack and is the tensile stress parallel to the crack norm al. Let us remark here that similar conditions can be given in case of compressive stresses with modiled material parameters (a compressive stress can result in a tensile force on a crack surface for certain crack orientations). The rst term in (8) is usually interpreted a surface energy of the crack, the second as the extra elastic energy of the surrounding continuum and the last one is the pure elastic term in this sim ple case. The sign and Legendre transform ation conventions are according to Landau and Lifsic [42].

The parameters , and , the coe cients in the G ibbs potential, are e ective parameters of the surrounding continuum , including other cracks.

From this G ibbs potential we can derive the entropy production  $\ _{\rm s}$  due to the crack extension in case of isotherm al conditions

It is easy to identify them odynam ic forces and currents in the expression. M oreover, we are interested only in the crack propagation e ects, therefore we will suppose that during the propagation of the crack the m aterial is in m echanical equilibrium, because the crack propagation is considerably slower than the deform ation process. W e conclude, that

where is the deform ation and we arrive to the evolution law of crack propagation

Here L is a positive kinetic coe cient (according to the Second Law) and  $^{0} = L$ ,  $^{0} = L$ . The equilibrium solution of this equation gives the celebrated G ri th condition [40]. A fler simple stability considerations one can see easily that the cracks start to grow if the right hand side of the above di erential equation is positive (at least if we are investigating brittle rocks under room temperature) expressing the unilateral nature of crack propagation. If the healing of the cracks is excluded, then the above evolution law can be written m ore exactly as

This evolution equation will be a core for the m esoscopic dynam ical investigation resulting in an explicit expression for the m esoscopic velocity. The above unilateral dynam ics will be called R ice-G ri th dynam ics.

Let us remark here that there is much more information that can be gained from these thermodynamic considerations. For example as a condition of thermodynamic stability we get an upper limit for the crack length  $(\frac{2}{3} > 1^2)$  that one cannot read from the single (10) evolution equation without considering the mechanical interaction. The role of thermodynamic stability in the failure of real materials is investigated in more detail in [16, 17, 43], where it is shown that localization and critical damage can be considered as the loss thermodynamic stability, and some empirical failure criteria (like G ri th) can be understood well from a thermodynamic point of view.

#### 5. Solutions of the Liouville-approximation

Let us consider now a sample with tensile hydrostatic bading. The m esoscopic variable in a given frame can be decomposed into the crack length and the crack orientation l = (l; ). Similarly the m esoscopic velocity can be decomposed into a length change part and an orientation change part, as  $v_1 = (v_1; !)$ . A coording to assumption 1 and 4 the cracks cannot move independently of the surrounding continuum, and let be the material at rest v = 0, therefore the orientational change velocity is zero (! = 0). Here we will investigate pure tensile loading. Due to our simplic cations a the role of crack orientation changes can be neglected in the development of the di erent order parameters [38].

In the following we will investigate constant loading rate conditions = v t, v = const: common in standard failure tests. Considering all of our assumptions regarding the cracks we can conclude that the crack density distribution depends only on time and the length of the cracks. The evolution equation (7) in spherical coordinates and in the mesoscopic space is the following

where the m esoscopic speed, the crack length change velocity  $v_1$  is given by the help of the right hand side of the equation (10), that is  $v_1 = \frac{1}{2}$ .

Easy to check that the general solution of the rst order partial di erential equation (11) with the m icroscopic dynam ics (10) is the following

Here is the generalized incomplete G amma function de ned by  $(a;b;c) = {}_{i}(a;c) {}_{i}(b;c)$ , where  ${}_{i}$  denotes the incomplete G amma function. F is an arbitrary function to be determined from the initial conditions. One can observe that there is no stationary solution of (11), but the crack distribution with a - nite support does not change under a de nite bading. A solution with arbitrary initial conditions cannot be given analytically because of the non-healing m icrocracks, the non di erentiable right hand side of (10). As a consequence of this non-di erentiability, the solutions of the partial di erential equation can be splitted into two parts connected by a moving boundary. Sm aller and sm aller cracks start to grow arriving at the m oving boundary. The arbitrary function F should be determined in such a way that the nal distribution function will be continuous.




Figure 1. The crack length distribution function at di erent instants. Exponential initial condition.


In the following we introduce dimensionless variables with measuring the time in units of  $f = v^{2=3} = 1^{-3}$ , the length in  $\hat{1} = v^{2=3} = 1^{-3}$  and the mass  $\hat{m} = v^{5=3} = 4^{-3}$  as the crack length l, the stress , the stress change velocity v and the material parameters 0 and 0 are measured in SI units. The dimensionless microdynamic equation (10) does not contain material parameters (e.g. can be written as v = 1, 0 = 1 and 0 = 1 in (10)). In the following all the variables are understood as dimensionless.

The solution of this equation is calculated num erically in case of two di erent initial length distribution functions. First an exponential initial crack length distribution function was considered

You can see the solution with the parameter value = 1 at dimensions on gure 1. On the vertical axis the function  $l^2 f(l;t)$  is drawn (because f multiplied with the spherical weight has the direct probability interpretation). One can observe, that the breaking point of the initial exponential distribution moves to the left, according to Rice-G ri th dynamics.

In gure 2 we can observe the full time and crack length development of the distribution function. The projection of the thick pointed line, where the surface is broken, onto the 1 t plane gives the Gri th condition, considering the time dependence of stress. The other lines show the distribution function at the instants on gure 2.

As a more realistic example, that considers an upper limit of the possible crack lengths we treat a bounded uniform initial crack distribution function, too:

In the following we choose  $l_c = 1$ . In gure 3 one can see the crack length distribution at di erent instants. Figure 4 shows together the time and length dependence. The pointed line and its projection onto the 1 t plane is the G ri th condition, that is more apparent on the backward view. The thin lines are the crack distribution functions at the same instants as in gure 4.

Here the resulted solution is discontinuous, due to the discontinuous initial condition. The initial discontinuity, the largest cracks, move to larger crack sizes with increasing time.

In [38] we suggest several possible m acroscopic internal variables from a mesoscopic point of view. D i erent order and dam age parameters are introduced and the possible advantages and disadvantages are discussed. Here we will investigate one of the most remarkable candidates, the average crack length and calculate its time dependence in case of the treated two initial crack length distributions. The




Figure 3. The crack length distribution function at di erent instants. Stepwise initial condition.




Figure 4. Dierent views of the time development of the crack length probability distribution. Stepwise initial condition.

The notion of an order param eter is chosen in analogy to the m esoscopic theory of liquid crystals, where the analogously de ned orientationalm om ents of the distribution function, the alignment tensors, are the order param eters in a G inzburg-Landau theory. There the gradient of the order param eter contributes to the free energy density in the form of the Frank elastic energy. Here, in the m esoscopic theory of dam age, we did not take into account any spatial gradients at all, and therefore there is no direct comparison to a G inzburg-Landau theory. Denitely the dam age parameter introduced here is dierent from the order parameter, the displacement eld in phase eld models. The spatial structure of the crack is out of the scope of the mesoscopic theory, and we are dealing only with microcracks smaller than the typical dimension of the continuum element. On the other hand the onset of dam age has been interpreted as a loss of therm odynamic stability with the help of a free energy depending on a dam age parameter density [16]. The inclusion of spatial inhom ogeneities of the dam age parameter, and the form ulation of an extension of a G inzburg-Landau type theory of dam age (with a mesoscopic background) is an outstanding problem for the future.

A fler calculating the time dependence of the dam age (the dots on gure 5 and 6) we can observe that time development is similar to the solution of the microscopic dynamic equation. Therefore we can investigate, whether the dam age development is determined by a Rice-Gri th dynamical equation. More properly we suppose that the evolution equation that determines the dam age dynamics is the following



One can get these equations by averaging the mesoscopic dynamic equations without considering the unilateral property of the microdynamics. The above equation is the only reasonable candidate to describe the macroscopic dynamics of the averaged crack length.

To compare the exact and the suggested macrodynamics we tted the solutions of the above equation with the exact solution to determ ine the parameters of the dam age dynamics and the dependence on the initial conditions. In both cases we considered the possibility, that the dam age starts from the initial value determ ined from the initial crack distribution (dashed lines on gure 5 and 6) or the initial dam age belongs to the parameters to be determ ined (continuous lines on gure 5 and 6). The results are sum marized in the table.

The param eters were determ ined by an asymptotic approximation method considering more and more sample points. We can observe that the  $^{0} = 1$  parameter of the microscopic crack dynamics is the same as the analogous b in case of damage dynamics, however the  $^{0} = 1$  and a parameters (the "surface energy" times the dynamic coecient) are smaller for both initial distributions. The averaged macroscopic equations especially in case of tted initial conditions give remarkable well approximation for larger times as one can see e.g. on 5. However, at the beginning when the number of "frozen" cracks is large, the damage developments are qualitatively di erent (see gure 6). One can observe a kind of "pseudo healing", the damage curves calculated from the macroscopic considerations start to decrease, instead of the expected increasing. This e ect is due to the unilateral microdynamics. The averaged distribution function is monotonously increasing but the suggested approximate macrodynamic equation at the beginning start to decrease. The decreasing depends on the initial distribution. The initial part of the curves




Figure 6. Time dependence of damage, in case of exponential and stepwise initial distribution. (Enlarged initial part of gure 5)

related to the stepw ise distribution is an extrapolation in both gures to show that an unilateral macrodynam ic equation would not improve the situation.

#### 6. Discussion and final remarks

In this paper the equations of m esoscopic m icrocracking were solved in case of simple cracking processes. We have seen that under reasonable assumptions the seem ingly complex m esoscopic balances are reduced to a solvable rst order partial di erential equation giving a kind of Liouville-approximation of the m esoscopic theory. There we could get the m esoscopic velocities introducing some constitutive assumptions based on known single m icrocrack dynamics. The partial di erential equation has an independent statistical physical interpretation and can be useful to describe the evolution of m icrostructure w ithout the underlying m esoscopic theory, too. M oreover, it gives a sure basis of the internal variable calculations, giving particular interpretations of the di erent internal variables and clues regarding their dynamics, the changes of the elastic m oduli or the stress distribution w ithout any further physical assumptions.

The developm ent of the average crack length was investigated in detail and we have got a macroscopic dynamics that was almost the same as for single cracks with the remarkable property that the corresponding parameters of the damage evolution equation strongly depend on the initial crack distribution. Moreover, the statistical calculations resulted in a new qualitative phenomena: the average crack length was decreasing at the beginning, seem ingly contradicting to the unilateralm icrodynamics of the microcracks. That calculations give some insight into the applicability of internal variable approaches in nonequilibrium situations. The unilateralm icroscopic conditions alone (without quenched disorder) resulted in a macroscopic dynamics of the damage (internal variables) that proved to be a good approximation of to the microscopic dynamics, but with parameters strongly depending on the initial crack distribution.

O ur assumptions regarding the m icroscopic, single crack propagation evolution equations can be extended to far more di cult cases, for example we can consider more general loading conditions, a m icroscopic dynamics with term inal crack velocity, too.
