Stability, Electronic Structure and Vibrational Modes of Ti₈C₁₂ Dimer

We present our density functional results of the geometry, electronic structure and dissociation energy of $T_{18}C_{12}$ dimer. We show that as opposed to the currently held view that $T_{18}C_{12}$ are highly stable monodispersed clusters, the neutral $T_{18}C_{12}$ clusters form covalent bonds and form stable dimers. We determ ine that the T_{11} atoms bond weakly (0.9 eV/bond) to organic ligands such as ammonia. Alternatively the Met-Car dimer has a cohesive energy of 4.84 eV or approximately 1.2 eV per bond. While Met-Car dimers are stable, formation of these dimers may be quenched in an environment that contains a signicant population of organic ligands. The ionization and dissociation energies of the dimer are of same order which prevents the observation of the dimer in the ion mass spectroscopy. The analysis of the vibrational frequencies show the lowest-energy

structure to be dynamically stable. We also present infrared absorption and Raman scattering

The Ti $_8$ C $_{12}$ clusters consisting of eight metal and twelve carbon atoms were found to be highly stable. Let use a such clusters of other sizes were found to be less abundant as seen from them ass-abundance spectrum reported by C astlem an and his co-workers. A part from T i atoms, similar clusters with eight metal atoms were found to form with other transition metals such as V, Zr, Hf, Nb, Mo, Fe, Cr 1,2,3,4 etc. These metallocarbohedrene clusters are generally referred to as Met-Cars. A detailed account of the various Met-Cars can be found in Ref. 5

spectra of the Ti₈C₁₂ dim er.

The ground state structure of M et-C ars has generated a lot of debate. The early studies have assigned a structure with T_h symmetry which later on was shown to be Jahn-Teller unstable. 6,7 D ance 7 has shown the existence of a barrierless transition path from T_h leading to a T_d structure. A nother calculation by C hen et al. 8 have proposed a D $_{\rm 2d}$ structure for the T $_{\rm 1g}$ C $_{\rm 12}$. Recently, G ueorguiev and Pacheco 9 have shown that Jahn-Teller distorted T_d structure is lowest in energy among the T_h , T_d , and D $_{\rm 2d}$ structures. A recent calculation by the present authors found the M et-C ars to possess a C $_{\rm 3v}$ structure which is lower in energy than either the T_d or the D $_{\rm 2d}$ structures. 10

An important aspect of these clusters is their paradoxical nature - while they are highly stable in vacuum they are found to be very air sensitive. The ionization potential and electron a nity of the M et-C ars suggest that these clusters have moderate reactivity. 10,13,14,15 A nother such issue which has not yet been studied is the form ation of larger clusters in which the individual M et-Cars are the building blocks. It may be mentioned here that M et-C ars of various sizes, e.g. T 13 C 22 exist but their structures show them to be di erent from TiC 12 .11,12 They can not be considered as made up from Met-Car units. In this article, we exam ine the possibility of two Met-Cars coalescing to form a stable dimer. We show that a dim er connected through four-m em bered rings of Tiand C atoms form a stable structure in which both the individual M et-C ars retain their identity. This may form a basis for future studies on M et-C ar based molecular

solids. We also present the calculated infrared absorption and the Ram an spectra of the T i_8 C $_{12}$ dim er. We believe this may help in identifying the M et-C ar dim ers in experimental IR and Ram an spectra.

The theoretical calculations were carried out within the density functional theory²¹ using a linear combination of atomic-orbitals (LCAO) approach. The calculations were performed using the NRLMOL²² program which employs a Gaussian basis set. The molecular orbitals were expanded as linear combinations of Gaussian functions centered at the atom ic sites. The exponents for the single Gaussians have been fully optimized for DFT calculations. The calculations were carried out at the all-electron level with the generalized gradient approxim ation to the exchange-correlation functional. A variational mesh is used to reduce the computation as well as storage of data and still maintain the high accuracy of the calculations. The code is massively parallelized 26 which allows one to perform calculations on a cluster of PCs. The geometry optim ization was carried out using the conjugate-gradient technique. The self-consistent calculations for each geom etry was carried out till the energy di erence fell below 1:0 10 6 a.u., so as to obtain accurate forces. The force m in im ization was carried out to a tolerance lim it of 0.001 a.u on each atom.

The calculation of infrared absorption and Raman scattering spectra were performed according to the method described in Ref.²⁷ The dynamical matrix is generated by moving the atoms by 0.08 a.u. from their equilibrium positions. The Raman and infrared intensities are obtained by applying an electriceld of strength 0.005 a.u. and calculating the rst and second derivatives of the dipole moment and polarizability with respect to the applied electriceld.

Our earlier calculations have shown that the lowest energy structure of the neutral T $_{16}$ C $_{12}$ possesses C $_{3v}$ symmetry 10 while the D $_{2d}$ and the T $_{d}$ structures lie slightly higher in energy. We have also determined that both the C $_{3v}$ and D $_{2d}$ structures are vibrationally stable. To determine the lowest-energy structure of the

Ti₈C₁₂ dim er, we started out by considering several di erent dim ers com posed of two C3v structures. A schem atic diagram of the optim ized structures of the various dimers is shown in Fig. 1. The gure shows the m etal cages with the carbon dim ers lying on the surfaces of each M et-C ar. The bonds between the M et-C ars are also pointed out. The structure that we studied retains the C_{3v} structure and tests whether a Ti-Ti\bond" may form. This corresponds to structure (a) in Fig. 1. Since the two Met-Cars are related by inversion, the overall sym m etry of this dim er is D_{3d}. This structure m ay exist in either the staggered or eclipsed form (Fig. 1(b)). The second structure that we considered was determined by allowing two C-C dim ers to form 4-m em bered rings. This corresponds to structure (c) in Fig. 1. The underly $ing C_{3v}$ sym m etry of this structure is broken and the nal sym m etry consists of the 8-m em bered group generated by all re ections. Another structure, labeled (d) in the qure, m ay be generated by allowing 4-m em bered T i-C -Ti-C rings to connect the two Met-Cars. This structure is bound relative to two C 3v M et-C ars by 2.9 eV . The fourm em bered ring is com posed of intra-and inter-m olecular Ti-C bonds of 1.96 A and 2.15 A respectively. The symm etry group is generated by inversion and (xyz)) (zyx). Exam ination of this structure shows that an interm olecular Ti₄C₄ cubane unit may be formed by bending the respective M et-Cars out of the planar ring and toward one another. This leads to structure (e) in Fig. 1. The resulting TiC is composed of bondlengths that average 2.18 A . However, the cubane connector is distorted with both long (2.32 A) and short (2.04 A) bonds form ing the intram olecular faces and medium (2.18 A) bonds form ing the intermolecular bonds. This dim er structure is com prised of 4 Ti-C bonds between the neighboring balls. It is bound by 4.84 eV or approximately 1.21 eV per Ti-C bond. This structure has only one symmetry operation (xyz)) (-x,y,-z). The binding energy per Ti-C bond is sim ilar to the energy we found for the Ti-N bonds in our titration calculations discussed later. W ithin the symm etry constraints discussed above, the geom etry of these structures were modi ed until the forces on atoms were less than 0.001 a.u. We wish to point out that while carrying out the optim ization, the sym m etry of the individual M et-C ars was not enforced, rather the M et-C ars were allowed to relax while forming a dimer. This will allow the individual M etC ars to relax into sym m etry allowed structures other than C_{3v} while forming the dimer.

We not the structure labelled as (e) to possess the lowest energy among all the structures considered. In Table I, we present the relative energies of the dimers with respect to the energy of (e). The dissociation energies required for the dimers to dissociate into the constituting Met-Cars are also presented. The dissociation energy of the structure (e) is highest showing it to be the most structurally stable form. In Table I we also present the HOMO-LUMO gaps of all the structures. The HOMO-LUMO gap of the (b) structure is highest followed by that of the structure (e) while in structures (c) and (d) the gap

is smallwhich will show more metallic behavior and also higher chemical reactivity. To assess the chemical reactivity of the lowest-energy dimer, we also calculated the vertical ionization potential and electron a nity (VEA). In this calculation, the charged clusters were not allowed to relax. The VIP of the structure (e) is $4.4~{\rm eV}$ while the VEA is $1.3~{\rm eV}$. The VIP is of the same order as that of a single Met-Car (4.47 eV) while the VEA of the dimer is higher than that of T igC $_{12}$ (1.05 eV). The reactivity of the dimer is therefore higher than that of single T igC $_{12}$.

To investigate the retention of individual sym metry of the Met-Cars while forming a dimer, we studied the energy surface of the dim er as a function of T i_8 C $_{12}$ - $T_{i_{0}}C_{12}$ distance. In this case, the sym m etry of the M et-Cars were maintained while the distance between them was varied. The energy vs. dim er separation curve is shown in Fig. 2. Them in im um in the curve indicates the equilibrium separation when the individual M et-C ar's geom etries do not relax. This minimum energy point is close to the structure (d) in Fig. 1. The di erence between the equilibrium point in Fig. 2 and the structure (d) arises from the fact that in structure(d) the symm etry of the individual M et-C ars were not retained and therefore the energy of structure (d) is lower. The small energy di erence (0.1 eV) suggests that the sym m etry distortion is small in the structure (d).

Another relevant question is how stable a molecular solid made from Ti₈C₁₂ would be. Our calculations show that an isolated M et-C ardimer would form chem ical bonds and lead to a binding energy per M et-C ar of approximately 2.42 eV. For chemically bound systems, this is on the weak side which suggests that a condensed phase of M et-C ars m ay behave di erently. For exam ple, when the Met-Car center-to-center distance is increased by 2.0 au, the interm olecular chemical bonds are completely broken and the isolated structure of the Met-Cars is retained. However we nd that this structure is still bound by 0.285 eV/M etcar which would suggest an FCC lattice of M et-Cars would be bound by roughtly 12*0.285/2 = 1.8 eV per M et-Car. Such a lattice m ight be further stabilized by some metallic bonding due to the unclosed electronic shell. As such the weak covalent bonds form ed for a M et-C ar dim er m ay not be strong enough to survive in the condensed phase and a lattice of isolated M et-C ars is at least competitive. The binding energy of the dim ers for the sam e particle-particle separation but averaged over dierent orientation is about 0.06 eV /M et-C ar which by the above analysis shows a binding energy in the crystalline environm ent to be about 0.36 eV. This is much more weak than predicted by the earlier considerations. Additional calculations on the bulk phase would be useful for clarifying this point.

W hile our results show that the M et-C ardimer is stable with respect to separated M et-C ars, observation of this dimer will almost certainly require an environment devoid of ligands. The reactivities of M et-C ars have not yet been fully explored. Some investigations on the reaction of M et-C ars with molecular oxygen have been

reported. 16,17,18 An ab initio calculation by Ge et al. 19 on $T_{18}C_{12}$ (H₂O)₈ and $T_{18}C_{12}$ (C₂H₄)₄ have shown the stability of the Ti₈C₁₂ to increase upon reaction with water while it decreases in reaction with C_2H_4 . Another calculation by Poblet et al. 20 have shown an exotherm ic reaction for addition of Cl, NH3, CO, C6H6. They also showed that addition of eight amm onia or Clis easy while adducts with eight CO or benzene is di cult. To check whether the energy ordering of Met-Carswith different sym m etry is in uenced by absorption of radicals, we have carried out optim izations of the geom etries of the M et-C ar in T_d and T_h and eight am m on ia m olecules bonding with the Tiatom s. The energy of the am monia covered T_d structure is signi cantly lower than that of the T h structure. However, the vertical ionization potential (VIP) of these two structures do not follow the same trend. The V ${\mathbb P}$ of the am m onia covered T $_{\rm h}$ structure is $2.76 \; \text{eV} \; \text{while that of the T}_{\text{d}} \; \text{structure is } 2.41 \; \text{eV} \; . \; \text{The}$ binding energy of the lowest structure with respect to the dissociation into eight ammonia molecules and the $T_{10}C_{12}$ is 7.43 eV which suggests an average of 0.93 eV perbond. The structure of the Met-Carsafter absorption of eight am monia retains the sym metry thereby implying that the structure does not change upon reaction. Our calculated Ti-NH3 binding energy of 0.9 eV is sim ilar to other calculated Ti-ligand binding energies. For example, $Ref.^{19}$ and 20 nd binding energies for Cl, NH_3 , CO, and to $\rm H_{2}O$ be in the range of $0.5~\rm eV$ (CO) to 2.3eV (H₂O). In an amm onia rich environm ent the system could either form a dim er with at most 12 adsorbed N H $_3$ ligands or two monomers with a total of 16 adsorbed NH 3 ligands. Steric e ects would probably prevent a total of 12 adsorbed NH₃ ligands on the dimer and would also weaken the TiNH $_{\rm 3}$ bonds. The former structure would have energy of at most 15.6 eV while the latter structures would have an energy of 14.4 eV. Steric e ects would probably lower the ligandated dimer below that of two ligandated monomers and kinetic considerations would also favor growth of the separated ligandated monomers. These considerations may also explain why the Met-Cars seem to be stable in soot.

To facilitate an understanding of the possible molecular processes which could hinder the observation of the dim er form ation, we have com pared the dim er total energy with that of $Ti_{13}C_{22}$ and $Ti_{3}C_{2}$. The $Ti_{13}C_{22}$ is earlier reported to be stable 11,15 which has a cubic structure. We found that such a process would cost an energy of 12.3 eV for the lowest-energy structure predicted in Ref.11 which ruled out any possibility of the dimer fragm entation into these products. On the other hand, the ionization energy of the dimer (4.4 eV) is of the sam e order as the energy required for dissociation into m onom ers (4.84 eV). Since the m ass spectrography m easurem ents are carried out on ionized clusters, the ionization process is likely to induce dissociation. A detailed investigation of the dim er cation is beyond the scope of the present work.

W e have also calculated the vibrational modes of the

lowest-energy structure of the dimer. The calculations show the dimer to possess no imaginary frequencies thereby indicating that the structure (e) indeed refers to an equilibrium structure. One noticeable feature of the vibrational modes is that this structure exhibits a few low frequency modes which are absent in the individual M et-C ar vibrational modes. 10

The IR absorption spectrum of the dimer is shown in Fig. 3 (upper panel). The spectrum has been broadened with a Gaussian of full width halfmaximum of 40 cm $^{-1}$. In the low frequency region, peaks occur at 186, 241, 260, 272, 280, 292, and 330 cm ¹ which corresponds to Ti-C stretching and also twisting modes. In the single M et-Car, IR active peaks at the low frequency range are observed at 183, 204, 244, 266, 271, 373, 467, 517, and 559 cm⁻¹ which are due to Ti-C stretching mode. 9,10,28 In the slightly higher frequency region, the dim er IR spectrum closely resembles that of the Met-Car IR spectrum with a relatively large peak around 460 cm $\,^{1}\,$ and 550 cm ¹. These are actually composed of peaks at 460, 464, 472, 480, 527, 541, 551 cm⁻¹. These correspond to the C-C twisting modes and also translation of a carbon dim er on each M et-C ar which leads to stretching of the Ti-C bonds. In the high frequency region, the spectrum shows a pronounced broad peak slightly beyond 1400 cm⁻¹. In fact this broad peak consists of three narrowly spaced peaks at 1411, 1417, and 1446 and another large peak at 1493 cm $^{-1}$. These correspond to C-C stretch modes in which all carbon dimers except the ones forming the four membered ring, take part. Other two sm aller peaks appearing at 1349 and 1354 cm $^{-1}$ are due to the C-C stretch mode involving only the carbon dimers form ing the $T_{i_0}C_{12}$ - $T_{i_0}C_{12}$ bonds. It may be mentioned here that our calculation of the Met-Car IR spectrum shows a pronounced peak near 1400 cm 1 which also arises due to the C-C stretch mode. In the dimer, this peak appears to be shifted to the high frequency region.

Figure 3 (lower panel) shows the Raman scattering spectrum of the Ti₈C₁₂ dim er. In this case, a broad peak occurs in the low frequency region below 700 cm ¹ . As mentioned earlier, there are a few low frequency vibrational modes which are Raman active. The rst peak is comprised of two narrow peaks occuring at 44 and 84 cm 1 . These correspond to Ti₆C₁₂ -Ti₆C₁₂ bond stretch m odes. The highest peak at about 200 cm 1 consists of narrow peaks at 185, 203, and 207 cm ¹ corresponding to twisting and squeezing of the Ti-C and Ti-Ti inter-Met-Carbonds. The shoulder seen about 260 cm 1 is also due to Ti-C bonds form ing the Ti₄C₄ cubane joing the two Met-Cars. The other noticeable peaks in the broad spectrum around 337 cm ¹ occur due to Ti-C stretching where the Ti is part of the cubane, around 480 which is due to Ti-C squeezing mode. The smaller peaks around 591 cm⁻¹ and 687 cm⁻¹ are due to, respectively, the C-C stretching mode where one atom of the C-C dimer is a member of the cubane and a rocking motion of some of the carbon dimers which do not form part of the cubane. The high frequency spectrum

shows two prominent peaks. One peak consists of narrow ly spaced peaks at 1367 and 1375 cm $^{-1}$ and the other of peaks at 1417, 1448 and 1500 cm $^{-1}$. A llof these correspond to C-C stretching modes of which the 1367 and 1375 cm ¹ correspond to the stretching and squeezing of the C-C dim ers involved in the form ation of the cubane. The above results show that the vibrations involving Ti-C bonds occur at lower frequency and are Ram an active whereas the C-C stretch modes occur at high frequecy and are IR active. Similar features are seen in case of the IR and Ram an spectrum of the single Met-Car¹⁰ although the spectrum is slightly shifted in frequency. The low frequency modes (< 100 cm^{-1}) seen in the dimer are not visible in the single M et-C ar spectra 10 which as m entioned above arise from the vibrations involving the Tiand C atoms forming the Met-Car-Met-Carbonds.

In conclusion, we have carried out st principle density functional based study of the structure and stability

of T i_8 C $_{12}$ dim er. Our calculations have shown the dim er to be stable by 4.84 eV. An analysis of the vibrational frequencies show the structure to be a local minimum. The IR and Ram an spectrum of the dimer are presented and analyzed. The IR active modes are found in the high frequency region while the Ram an active ones are located in the low-frequency region of the spectra. The symmetry of the individual T i_8 C $_{12}$'s are somewhat modied in the form ation of the dimer. Our calculation predicts that a Met-C ar solid will be weakly bound. From the ionization potential and the dissociation energy of the dimer, we predict that during the ionization process in the mass spectrography, the dimer is likely to dissociate into two Met-C arm onomers which accounts for the lack of experimental observation of the dimer.




FIG. 1: The various dim er con gurations considered in the present work. The m etal cage structure with the carbon dim er on the surface of each M et-C ar is high lighted. A lso, the bonds between the M et-C ars are shown.




FIG. 2: The potential well form ed when two M et-C ars are brought closer without relaxation. The relative energies and the distances are given with respect to the dim er (d) in Fig. 1.




FIG .3: The infrared absorption and R am an scattering spectra of the lowest-energy structure of T $i_8\,C_{\,12}$ dim er (solid lines) and the T $i_8\,C_{\,12}$ m onom er (dashed lines) with C $_{3v}$ sym m etry. The intensities are broadened with a G aussian of FW HM of 40 cm $^{-1}$.
