E lectronic structure and m agnetic anisotropy of the $[Co_4 (hm p)_4 (CH_3OH)_4Cl_4]$ m olecule

A courate density-functional based calculations have been perform ed on the Co_4 (hm p)₄ (CH_3OH)₄ Cl_4 m olecular m agnet where hm p is deprotonated hydroxym ethylpyridine. In addition to the experim entally observed staggered geom etry, we identify two isom ers, referred to as eclipsed and half-staggered/half-eclipsed, that are reasonably low in energy. O ur calculations show that the magnetic anisotropy is strongly dependent on the pyridine-pyridine separation and that the three structures exhibit easy axis, easy plane and triaxial behavior. O there ects such as partial reprotonation of the hm p is considered.

The magnetic molecules containing transition m etal atom s are being widely studied due to potential technological applications for inform ation storage and quantum computing [1]. The magnetic molecules show magnetic hysteresis behavior rem iniscent of single dom ain magnets and exhibit the phenomenon of quantum tunneling of magnetization. Observation of such behavior in a molecular magnet is greatly facilitated by a reasonably high net spin and a large magnetic anisotropy energy (MAE). A very recent experimental report of a single molecule magnet consisting of C o4 (hm p)4 (C H 30 H)4 C l4 where hm p- is the deprotonated hydroxym ethylpyridine, suggests that this molecule is quite prom ising since the magnetic anistropy energy per transition metalatom is high (25-50K) [2] compared to other magnetic molecules Fe₈-tacn [3], M n_{12} acetate [4{7] where it is (3-6K). The reported ferrom agnetic ordering of the Co4 m olecule also diers qualitatively from the ferrin agnetic spin ordering observed in the M n_{12} and Fe₈. The negative an isotropy energy for a transition m etalw ith more than 5 d electrons is also considered to be unusual.

In order to gain more insight into the prop-

erties of this molecule, we have carried out a detailed ab initio study of the electronic structure and magnetic anisotropy energy of $[Co_4 (hm p)_4 (CH_3 OH)_4 Cl_4]$ for di erent conform – ers. Density functional theory [8,9] based allelectron, spin-polarized calculations were carried out with the NRLMOL code [10,11] within the generalized gradient approximation to the exchange-correlation functional [12].

In the experim entally obtained Co_4 cluster [2], the four cobalt atom s in the molecule are bonded to organic hydroxy-methyl-pyridine (hmp) ligands (Fig. 1(a)). The four Co(II) atom s and the four oxygens from the CH₂O radicals of the hmp ligand form an inner cubane structure. The experim entally observed m olecule exhibits S4 point group symmetry and is made up of four units where each 22-atom unit (Fig. 1(b)) consists of Co^{+2} , Cl, $CH_{3}OH$ and the hmp ligand. An eclipsed geometrical isomer (Fig. 2(a)) can be generated by continuously distorting the lower half of the staggered experim ental geom etry or from the inequivalent 22-atom complex from the group of order 4 generated from (xyz) ! (-x, $y_{r}z$) and (xyz) ! $(y_{r}x_{r}-z)$. A nother energetically competive structure (Fig. 2(b)), which we refer to as half staggered and half eclipsed (HSHE), can be generated by rotating and appropriately reorienting only the Cl and ligands on the lower

half of the experimental structure. This structure has one symmetry operation [(xyz) ! (x,-y,-z)]. Complete geometry optimizations were carried out for each conformer.

The starting parameters for the experimentally reported staggered geometry were taken from the reported isostructure of the $[N_{4} (hm_{p})_{4} (CH_{3}OH)_{4}C_{4}] [13] m olecular crystal.$ Upon relaxation, the volume of the molecule increases due to the repulsion of the hmp ligands in parallel positions. The eclipsed structure was found to be higher in energy than the staggered structure by 2.77 eV. Since this energy di erence is probably due to intraplanar and interplanar steric repulsions, we have been m otivated to look at the half-staggered and half-eclipsed geometry as well. We nd that the relaxed HSHE geom etry is only 0.79 eV above the experim ental geom etry. The cohesive energy was found to be approximately 4.7 eV /atom for all structures.

The spin-projected total density of states $(D \circ S)$ as well as the C o d density of states of the staggered structure are shown in Fig. 3. The Fig. 3 clearly show sthat the states near the Ferm i level arises mainly from the C o atoms. These states also contain m inor contributions from the oxygen and chlorine atoms. The C o d m a prity states are fully occupied. The gure shows that both the HOMO and the LUMO belongs to the m inority spin C o d levels which is true in all the structures. The m inority gap in the staggered structure is 0.55 eV. A smaller gap leads to a higher value of the m agnetic anisotropy energy. The gap is found to be highly sensitive to the orientation of the ligands.

The spin-density in a sphere of radius 2.6 a.u. around each C o atom show sthat C o atom shave a localm on ent of 3 $_{\rm B}$ which is also expected from electron counting considerations. This leads to a ferrom agnetic structure with a totalm on ent of 12 $_{\rm B}$ (or S= 6) for all isom ers and is in agreem ent with experiment [2]. Therefore, the orientation of the hmp ligands does not a ect the magnetic m on ent. An isolated C o₄O₄ cubane is also found to possess a magnetic m on ent of 12. O ur investigation on the e ect of hydrogen dopants show s that the inclusion of additional hydrogens leads to a partial reprotonation of the cubane O C -C H₂

groups and insertion of the electrons into the vacant m inority Co_{3d} states just above the Ferm i level. This reduces the magnetic moment by 1 $_{\rm B}$ per hydrogen atom .

O ur calculations have shown that the states near the Ferm i level are dom inated by the cobalt d states with both the highest occupied and low – est unoccupied molecular orbitals (HOMO and LUMO) belonging to the minority spin Cod levels. The HOMO-LUMO gap in the staggered structure is 0.55 eV. The gap is found to be highly sensitive to the orientation of the ligands. In the eclipsed structure, the HOMO-LUMO gap is sm all (0.09 eV), while for the HSHE structure, it is 0.41 eV. This leads to interesting magnetic behavior in the three structures. The values of the gap and the MAE of the three conform ers are sum marized in Table 1.

The lowest order spin ham iltonian for a single molecular magnet can be modelled as

$$H = D S_z^2 + E (S_x^2 - S_y^2) + g B S$$

where D and E are the second-order axial and transverse anisotropies. B' and g are the applied magnetic eld and the Lande g-factor, respectively. The main contribution to the secondorder an isotropy energy arises from the spin-orbit coupling. The e ect of the spin-orbit coupling and the second-order anisotropy energy was calculated here using the second-order pertubative treatment presented in Ref. [14]. We also used an alternative treatment given in Ref. [15] where the principalaxes and an isotropy energies m ay be determ ined by diagonalizing the anisotropy tensor. W hile the experim ental staggered structure with S_4 sym m etry is uniaxial, (i.e. E = 0 by sym m etry) the other two structures will have a transverse component (E).

The calculated magnetic anisotropy energy of the uniaxial, optimized staggered structure was found to be 23 K although the initial structure, based on experim entalparam eters, showed a high value of MAE of 57 K. The separation between pyridine rings was found to increase upon optimization which in turn increased the HOMO-LUMO gap. The HOMO-LUMO gap for the initial geometry of the experimental structure was found to be 0.09 eV. This observation opens up an exciting possibility of altering the MAE by manipulating the pyridine pyridine separations, in particular, by the application of pressure. It may be mentioned here that Y ang et al. [2] have established that the magnetization barrier is 100-200 K. The large discrepancy between the theoretical and experimental values further supports the possibility that the MAE may exhibit signi cant pressure dependencies. So crystal packing e ects may play an important role here.

The eclipsed structure, on the other hand, shows a more promising magnetic behavior (Table 1). In this case, the magnetization has easy, medium and hard axes. The easy axis lies along the axis of the molecule as in the experimental structure. The energy barrier between the easy and the medium axes is 95K while that between the medium and hard axes is 65K. This leads to a rather large D param eter of -3.55K and an E param eter of -0.91K . Interestingly, the MAE of the HSHE structure (50K) lies between the MAE of the staggered and the eclipsed structures. How ever, this geom etry has an easy plane of magnetization. Thus, changing the orientation of the ligands signi cantly, albeit indirectly, in uences the magnetic behavior of the Co4 through band gap changes.

One possible way of achieving an overall easy axis is through the orthogonal hard axis alignm ent m odel in w hich each cobalt exhibits a local easy plane and the intersection of easy planes between the lower and upper C o atom s determ ines an easy axis [2]. A nother way is for each atom to exhibit a local easy axis along the global uniaxis. W ithin the second-order perturbation theory, and the LCAO method used here, it is possible to decompose the anisotropy ham iltonian into a sum of 4-center term s by expanding the relevant m atrix elements into their atom ic constituents. Because the Cod states are localized and dom inate the behavior near the Ferm i level, one expects that the single-center diagonal term s will be prim arily responsible for the anisotropy energy. W e have determ ined num erically that this is an excellent approximation and nd that in all structures, the local alignments are identical with the local hard axis lying along the in-plane Co-O bond in the cubane (C o and O are attached to two parallelhm p ligands) and the local m edium axis lying along the Co-N bond (Fig. 4). This leads to the situation where the local hard and easy axes lie on a plane bisecting the m olecule. For the case of the staggered structure, the local hard axes of the upper and low er C o atom s are orthogonal, which leads to the global easy axis lying along the axis of the m olecule. In the other two structures, the local hard axes are aligned parallel and the com – petition between the m edium and the local easy axes leads to a triaxial alignment in one and to an easy plane of alignment in the other. For the latter, the easy and the m edium axes are nearly degenerate.

In conclusion, we show that the magnetization of the Co4 m olecule varies strongly with the orientation of the various ligands. W hile the staggered and eclipsed structures have a preferred axis of magnetization, the intermediate structure has a preferred plane of magnetization. For the higher energy isom er, the energy barrier between the hard and the medium axis is quite high (95K). This is especially interesting in view of the small number of transition metal atoms in the molecule. Our results suggest that the anisotropy energy may be strongly varied by manipulating the pyridine-pyridine spacing and ligand orientation. Determining a means for constraining the ligands by either chem ical, physical or electrostatic m eans would be a worthwhile investigation.




Figure 1. (a) The geometry of the lowest-energy staggered structure in which the hydrogen atom s are not shown. (b) The inequivalent building block of each molecule which consists of the Co^{2+} , Cl, CH_3OH and the hmp ligands.





Figure 2. The optim ized (a) eclipsed and (b) half-staggered half-eclipsed geometries in which the hydrogen atom s are not shown.






Figure 3. The total and Co-d majority and m inoroty spin density of states of the staggered Co_4 molecule.
