Breakdown of the Fermiliquid theory in heavy ferm ion compounds

A bstract

We review the anomalous properties of heavy ferm ion compounds like $C \in Cu_{6 \times} Au_{x}$ or $C \in M$ In₅ close to a zero temperature phase transition called a quantum critical point. A nomalous behavior of the resistivity, special heat and magnetic properties observed in various compounds suggests a fundamental breakdown of the Fermiliquid theory. Recent measurements on $Y \triangleright Rh_{2}Si_{2}$, eld-tuned through the quantum critical point, provide interesting insights on the evolution of the Fermiliquid close to criticality. We discuss the possibility of a kind of spin-charge separation at the quantum critical point and make some remarks about its possible link with the underscreened K ondo model.

1. Experim ental overview and theoretical insights

1.1. experim ents

Ferm i liquid theory [1], developed by Landau in the m id 1950's, provides the foundation for much of our current understanding of electron uids. A coording to the Landau Ferm iLiquid theory (LFL), therm odynamic and transport properties of a metal at very low tem peratures are described in term s of weakly interacting ferm ions, or \Landau quasiparticles" . Landau quasiparticles consist of electrons, surrounded by a cloud of spin and charge polarization. They share the sam e quantum num bers as free electrons but their m asses can be strongly renormalized by the back ow of the surrounding uid. A striking example of the robustness of the LFL is provided by heavy ferm ion behavior, where the e ective mass of the quasiparticles can be hundreds of times greater than that of a bare electron. The physical properties of this uid follow certain characteristic power-law dependences on temperature. For exam ple, the speci c heat has a linear tem - perature dependence, the resistivity a quadratic one.

A wide body of experim ental results show that when heavy ferm ion materials are tuned to a zero temperature antiferrom agnetic transition, their physical properties depart qualitatively from LFL theory. There is a growing list of heavy electron materials that can be tuned into the quantum critical point by, either alloying, such as CeCu₆ x Au_x [2] or the layered materials CeM In₅ [3], through the direct application of pressure, as in case of CeIn₃ [4] or CeP d₂Si₂ [5], or via the application of a magnetic eld, as in the case of YbR h₂Si₂ [6]. At the quantum critical point (QCP) the key properties suggesting a breakdown of the Fermi liquid are:

{ the speci cheat coe cients diverge at the QCP [7{9]. For most cases the divergence displays a logarithm ic tem perature dependence

This implies that the the quasi-particle mass diverges and the Ferm item perature goes to zero at a QCP.

{ a quasi-linear tem perature dependence of the resistivity, contrasting with the quadratic dependence of the FL [5,6,10].

with in the range of 0 0:6. Several compounds including YbR h_2 Siz [11] and CeCu₆ x Au_x [9] have perfectly linear resistivity, a property rem in iscent of the normal phase of high tem perature superconductors

In the case of $C ext{ eC } u_{6}$ $_X ext{ A} u_{x}$ [9] magnetization measurements reveal that at nite elds H , the dierential magnetic susceptibility exhibits exhibits H = T scaling. Neutron scattering measurements on the same material [9] reveal the presence of! = T scaling in the dynamic spin sysceptibility, which may be cast into the form

where the function f (q) vanishes in the vicinity of the ordering wave vector. The q independence of second term suggests a local origin to the dam ping of the critical spin uctuations, an observation that has stim ulated recent e orts to develop a self-consistent locally quantum -criticalm odel of the heavy electron QCP.[12] Rem arkably, a single exponent a 0:75 governs both the H=T and !=T scaling. The presence of the anom alous exponent a suggests that the interaction am ongst the quantum criticalm odes has renorm alized to strong coupling. This fact is made clear by the scaling laws in !=T and H=T. This type of \naive" scaling property (quantities scale according to their dim ensions) is the hallm ark of a system lying below its upper critical dim ension.[13]

12. Key theoretical insights

The experimental observations at criticality suggest an underlying universality in the physics. [13]. The ability to express the dynam ical susceptibility of Cu_{5:9}Au_{0:1} in term sofa scaling function F (!=T;B=T) and the observation that the e ective Ferm i tem perature $T_{\rm F}$ renorm alizes to zero at the QCP, both suggest that underlying physics at the QCP is scale invariant. In this situation, we expect that the physical properties will be independent of them icroscopic scales of the material—they are universal.

M oreover, the observation of anom alous exponents in the magnetic susceptibility, the transport and thermodynamic properties are evidence that the quantum critical physics may be described by an elective theory whose coupling constants ow to strong coupling. In particular the elective critical lagrangian must lie below its upper critical dimension.

13. Spin density wave scenarios

The constraints at criticality enable us to rule out the 3D spin density wave (SDW) theoretical scenario [14,15] for the heavy electron quantum critical point (gure 1,left). In this scenario, magnetism develops by the spin polarization of the Ferm i surface and non-Ferm i liquid (NFL) behavior results from Bragg diraction of electrons o quantum critical spin uctuations in them agnetization. As shown in gure 1, three dimensional spin uctuations only couple strongly to electrons along \hot lines" of the Ferm i surface, separated by the wave vector Q of the antiferrom agnetic order. The term \hot lines" refers to the k points on the




Fig.1. Com parison between the 3D SDW Ferm isurface topology (left), where hot lines are separated by the scattering wave vector Q and the 2D SDW scenario where a nite part of the Ferm i surface is \hot" at T = 0.

Ferm i surface which are coupled the magnetic uctuations at zero tem perature. The width of the hot lines increases with tem perature like (T).On the hot lines, the electrons are strongly perturbed by the magnetic uctuations and their life time is strongly suppressed. M ore precisely in three dim ensions the im aginary part of the self-energy varies like H !.Their e ective m assexperiences a logarithm ical increase with temperature. A way from the hot lines however, the scattering of the electrons o the critical modes is strongly suppressed - the magnetic uctuations getting massive. W ithin the 3D SDW scenario, the hot lines are not wide enough to destabilize the FL theory. In this situation, the critical contributions to the free energy and the speci cheat coe cient are given by

When the temperature is driven to zero at criticality, the system eventually owstowards the FL xed point, keeping the universal exponents of the FL theory.

In order to account for the properties at criticality, one can imagine that the spin uid is magnetically frustrated, dividing into layers of decoupled plans. In

this scenario, the 2D SDW [16,17], the dim ension of the spin uid (2D) is lower than the one of the conduction electrons (3D). W ithin this assumption a nite region of the Ferm i surface is hot, as shown in gure 1, right. This intuitively corresponds to an \innite" width of the hot lines. This situation-a fully anisotropic magnet-, while dicult to realize experim entally, is strong enough to destabilize the FL theory, accounting for the logarithm ic divergence of the specic heat coe cient with temperature as well as the linear in T resistivity. Two important remarks are due here. First, this scenario is remarkably sensitive to magnetic anisotropy. If the 2D spin uid retains a sm all inter-plane coupling, then Ferm i liquid behavior will recover at tem perature scales smaller than the interlayer coupling. The second comm ent relates to the upper criticald im ension. C lose to an antiferrom agnetic instability at zero tem perature, the system experiences strong uctuations in time which scale with respect to the length like z. z is the dynam ical exponent of the QCP, and is equal to 2 for the antiferrom agnet. Thee ective dim ension of the system is now D = d + z, where d is the number of spacial dimensions for the spin uid. In the 2D SDW scenario, D = 2 + 2 = 4 so the e ective lagrangian lies at its upper critical dim ension, im plying m arginal coupling constants. This feature wouldn't be enough to account for the anom alous exponents observed in the magnetic susceptibility.

2. A study of Y bR $h_2 \, S \, i_2$: the breakdown of the 2D SD W scenario

In the next section, we would like to discuss new insights into the the mechanism by which the heavy quasiparticle may disintegrate at the QCP, revealed by recent studies of the compound YBR h_2 (Si $_{\rm X}$ Ge $_{\rm X}$)2 [18,19]. The undoped (x = 0) compound lies remarkably close to a QCP, with a tiny antiferrom agnetic ordering temperature $T_{\rm N}=70$ m K [11] that can be suppressed to zero by a smallmagnetic eld of just B $_{\rm C}=0.06$ T perpendicular to the easy axis. By allowing tiny amount of Germanium into the crystal, it is possible to ne-tune the Neel temperature $T_{\rm N}$ and the critical eld B $_{\rm C}$ to zero, without appreciably increasing the disorder in the material. The materials can then be controllably driven back into the FL state by application of a small magnetic eld.

21. The upturm in the speci cheat

Several unusual features are revealed at criticality. In addition to the previously observed logarithm ic increase when lowering the temperature, the specicheat

coe cient shows a strong upturn below 30m K (gure 2). The electronic nature the upturn has been checked rst by carefully removing the nuclear contribution, second by the observation that under a smallmagnetic eld, the electronic contribution in the FL phase gradually saturates the upturns, as one gets closer to the QCP. Such an upturn of electronic nature reveals a




Fig. 2. Strong upturn in the specic heat coecient of YbRh₂ (Si_{1 x}Ge_x)₂ for x = 0:05 [19]. One observes how the upturn lls in as one reaches the QCP by decreasing the applied magnetic eld.

strong departure from any SDW scenario, where the maximum possible increase of the specic heat coecient is logarithmic. More specically, the behavior of can be cast into the form

with 0:33 and 1. is a scaling function of the tem perature and the magnetic eld. The form of (7) is remarkable in many respects. It reveals that two energy scales govern the behavior of the electrons in the FL phase. A rst energy scale $T_{\rm F}$ is associated to the inverse of the density of states. The second energy scale $T_{\rm O}$ (B), characteristic of the excitations of the system appears in the scaling function . These two energies vary with the applied magnetic eld as follows:

The scaling form (7) of ensures that at zero magnetic eld (T; B=0) / T=. Since the exponent is smaller than one, no residual entropy is sitting at the OCP.

22. K adowaki-W oods ratio is weakly eld dependent

An alternative way of investigate the scattering behavior at the QCP is to approach it from the FL phase, gradually reducing the applied magnetic eld towards its critical value B_c. Away from criticality, the resistivity is quadratic (T) = (T) $_{0}$ = A (B)T² ($_{0}$

is the residual resistivity), below a characteristic temperature $T_{\rm F}$. The temperature at which the T 2 behavior, characteristic of the Landau FL theory appears, sets the crossover between the heavy ferm ion regine and the quantum critical regine. Inside the FL phase, even though the quantum uctuations are not strong enough to destabilize the FL, the electron undergoes virtual scattering of the critical magnetic modes. The variation of A(B) close to the QCP provides insight into these virtual excitations. Initial measurements on germ inium doped YbR h_2 S i_2 $_{\rm X}$ Ge $_{\rm X}$ show that A(B) 1=(B $_{\rm C}$) in the approach to the QCP. Over a wide range of eld, the K adowaki W oods ratio is found to be approximately constant, with a value

is found to agree within 40% with the empirical K adowaki W oods ratio. M ore recent measurements closer to the QCP show a slow upturn in K at very small values of B B_c. [19] C onstancy of the K adowaki woods ratio in plies that the transport scattering rate scales strictly with the square of the renormalized $T_{\rm F}$ (B) of the heavy electron uid. A truly eld independent K adowaki W oods ratio would indicate that the momentum dependence of the scattering amplitude does not renormalize with $T_{\rm F}$ (B).

23. The 2D SDW scenario is ruled out

This set of data allows us to rule out the 2D SDW scenario. While the 2d SDW scenario leads to the result A / 1=(B B_c) as observed experimentally, the soft 2D spin uctuations produce only a small renormalization in the heavy electron density of states with / $\ln 1$ =(B B_c). This would give a strongly diver-

/ $\ln 1=$ (B B_c). This would give a strongly divergent K adow aki W oods ratio in the approach to the QCP: K_{SDW} / 1= (B B_c) \ln^2 (B B_c). The weak eld dependence of the K adow aki W oods ratio suggests that the most singular quasiparticle scattering am plitudes have a far weaker momentum dependence than expected in a spin density wave scenario.

3. The breakup of the heavy electron-is there a preform ed K ondo e ect at the QCP?

The study of Y bR h_2 (Si $_2$ x G e_x) reveals a very unusual property. While the specicheat coecient experiences a strong uptum below T=30m K, there is no rejection of this sudden loss of entropy in the transport properties: the resistivity stays linear in T for the whole temperature regime. This suggests that the degrees of freedom associated with the uptum in the

speci c heat are not involved in the charge transport. W hat is the origin of this separation?

One of the challenges here is to understand the clear separation between the single ion K ondo tem perature T_K , which clearly remains nite at the QCP, and the renormalized $T_{\scriptscriptstyle F}$ (B) which is driven continuously to zero. Burdin et al.[20] have suggested the analogy with pre-form ed pairs in a superconductor, according to which T_K is the temperature at which pre-formed local K ondo singlets develop and $T_{\scriptscriptstyle F}$ is the scale at which phase coherence sets in to form mobile quasiparticles. By analogy one can consider the QCP in heavy ferm ions as a king of preform ed scenario for the K ondo e ect. In such a picture, the presence of very strong antiferrom agnetic uctuations close to a QCP dephases the heavy ferm ion composite quasi-particles at increasingly low temperatures, as one gets closer to the QCP. Eventually at the QCP the coherence tem perature is driven to zero, leading to the disintegration of the heavy com posite electron.
