M agnetic relaxation and dipole-coupling-induced m agnetization in nanostructured thin lm s during grow th: A cluster M onte C arlo study

For growing inhom ogeneous thin in swith an island nanostructure similar as observed in experiment, we determ ine the nonequilibrium and equilibrium remanent magnetization. The single-island magnetic anisotropy, the dipole coupling, and the exchange interaction between magnetic islands are taken into account within a micromagnetic model. A cluster Monte C and method is developed which includes coherent magnetization changes of connected islands. This causes a fast relaxation towards equilibrium for irregularly connected systems. We enalyse the transition from dipole coupled islands at low coverages to a strongly connected ferrom agnetic in a thigh coverages during in grow th. For coverages below the percolation threshold, the dipole interaction induces a collective magnetic order with ordering tem peratures of 1 { 10 K for the assumed model parameters. A nisotropy causes blocking tem peratures of 10 { 100 K and thus pronounced nonequilibrium e ects. The dipole coupling leads to a som ew hat slow er magnetic relaxation.

I. IN TRODUCTION

The investigation of low -dim ensional magnetic nanostructures has become a very active eld of current research.¹ The controlled preparation of di erent nanostructures allows for the investigation of a variety of interesting magnetic properties.^{2,3,4} The dependence of these properties on the nanostructure and magnetic interactions in such systems is still not well understood. So far, no consistent theoretical analysis has been perform ed for the magnetic behavior of an ultrathin lm during grow th, ranging from an island-type structure to a smooth lm, in particular the in uence of structural disorder on the magnetic properties. In this study, we present M onte Carlo (MC) calculations of the nonequilibrium and equilibrium magnetization of growing inhom ogeneous lms. Dierent coverages below and above the percolation threshold and di erent m agnetic interactions are taken into account. This analysis needs a new ly developed cluster M C m ethod including coherent rotations of neighboring m agnetic islands.

To illustrate the problem, we discuss for instance an ultrathin Co lm grown on a Cu (001) substrate.^{5,6} This system shows a perfect layer-by-layer growth for cov-> 2 monolayers (ML). Here, the exchange erages coupling results in a large Curie temperature T_{C} & 350 K.Below the measured percolation coverage of $_{\rm P}$ = 1:7 M L, random ly positioned Co islands with a considerable adm ixture of C u atom s are observed, exhibiting a com parably strong rem anent m agnetization up to tem peratures as large as 150 K.At _P, a jump of T_C of about 100 K occurs.⁵ The important question arises which mechanism causes the strong remanence of an island-type lm for coverages < P.On the one hand, this could be induced by nonequilibrium blocking e ects due to single-island anisotropies which im pede m agnetic

relaxation. On the other hand, an equilibrium magnetization can originate from long-range magnetic interactions. We like to discuss these two limiting cases.

An ensemble of magnetically isolated single-domain islands behaves like a superparam agnet. The single-island anisotropy causes a nite tim e-dependent m agnetization below the nonequilibrium blocking temperature T_b. For thin Co/Cu (001) In s this tem perature is estim ated to 5 K³¹_I following from the Arrhenius-Neelansatz be T_b $k_{\rm B} T_{\rm b} = N K = \ln (m_{\rm m})^{7/8}$ Note that an island size dispersion will in uence the relaxational behavior and T_b sensitively. Second, a nite magnetization may also originate from a collectively ordered state in therm alequilibrium. Such a magnetic state, not necessarily a collinear one, of an ensemble of isolated islands results from longrange m agnetic interactions.9 W e consider here the m agnetic dipole coupling between islands.³² The corresponding ordering tem perature T_c should be com parable to the average dipole energy per island which is, how ever, di cult to determ ine for an irregular system . A ssum ing two neighboring disk-shaped Co islands containing N atom s each, the dipole energy E_{dip} of this island pair is proportional to \overline{N} . For N = 1000, we estimate E_{dip} 6 K 33

Note that both simple estimates for the temperatures $T_{\rm b}$ and $T_{\rm C}$ disagree with experimental observations. Hence, in proved calculations are needed taking better into account the inhomogeneous $\,lm$ structure characterized by varying island sizes, shapes, and positions. In particular for coverages close to $_{\rm P}$, the island coagulation leads to a larger elective island size $N_{\rm e}$ and thus to a larger average dipole energy $E_{\rm dip}$ / $^{\rm N}$ $_{\rm e}$. Correspondingly, also the blocking temperature $T_{\rm b}$ / $N_{\rm e}$ K due to anisotropy will be larger than the single-island estimate $T_{\rm b}$ 5 K. Thus, for a disordered $\,lm$ structure one may expect a remanent m agnetization at much higher temperatures than obtained by these simple estimates.

For the investigation of the magnetic relaxation, the magnetic anistropy and the dipole interaction are taken into account. In case of coagulated islands, the exchange coupling between islands has to be considered as well. For three-dimensional systems of interacting magnetic particles, either longer¹⁰ as well as shorter¹¹ relaxation times as compared to noninteracting ensem – bles have been calculated. Experimentally, longer relaxation times for increasing interparticle interactions have been measured.^{12,13} The existence of a collective, spin-glass-like magnetic ordering was discussed.¹⁴ For two-dimensional systems only few investigations have been reported, also indicating longer relaxation times for increasing interaction times for increasing interactions have been reported, also indicating longer relaxation times for increasing interaction strengths.^{13,15}

In this paper, we report on MC calculations of the nonequilibrium and equilibrium remanent magnetization for nanostructured thin Im s during grow th as function of coverage, tem perature, and M C time. 16,17,18 By application of a modi ed Ising model, which allows one to take into account m agnetization dynam ics, the blocking as well as the ordering tem peratures are determ ined. Of particular concern is the consideration of structurally inhom ogeneous systems ranging from isolated islands to smooth ferrom agnetic Ims. Num erical simulations are unavoidable since the low sym metry of these systems and the complicated nature of the involved magnetic interactions preclude analytical approaches. However, the application of the common MC technique runs into a severe problem . A ssigning a \super" spin to every island magnetic moment (Stoner-Wohlfarth model¹⁹), conventional single-spin-ip algorithm syield an extrem ely slow and unrealistic relaxation towards equilibrium for coverages where the islands are partly coagulated.³⁴ Hence, we apply a cluster-spin- ip algorithm, which includes simultaneous rotations of magnetic moments of connected islands.^{20,21} W e em phasize that with this m ethod the relaxation behavior and the equilibrium magnetization are calculated e ciently. For all Im coverages, the clusterspin-ip method enables an appropriate analysis of the in uence of the anisotropy and dipole coupling besides the dom inating exchange interaction.

The lm growth, the micromagnetic model for the calculation of the magnetic properties, and the cluster M C method are described in Sec. II. In Sec. III, we test the cluster algorithm for the obtained island nanostructure and present results for the remanent magnetization, as well as for the blocking and ordering temperatures. A conclusion is given in Sec. IV.

II. MODELAND MC SIMULATION

A. G row th m ode and m icrom agnetic m odel

For the simulation of the island-type growing lm, we use the simple solid-on-solid Eden model.^{17,22} W ithin this model, each additional atom is deposited on an

island perimeter site i with probability $p(q_i;z_i) / exp[A(z_i)^p \overline{q_i}]$, where q_i is the local coordination number and z_i the layer index. A bilayer island growth mode is assumed yielding an island structure similar as observed for epitaxial Co/Cu (001).⁶ A 2 500 500) frc-(001) unit cell with lateral periodic boundary conditions is applied. The island density is = 0.0025 islands per site, resulting in Z = 625 random ly distributed islands in the unit cell. For the ratio of binding parameters,¹⁷ we use A (1)=A (2) = 0.989.

For the obtained atom ic structures, a m icrom agnetic m odel for the total (free) energy of a system of interacting m agnetic islands is applied. 16,17

with being the Im coverage and T the tem perature. Each magnetic island with N $_{\rm i}$ () atom s is treated as a Stoner-W ohlfarth particle¹⁹ with a single giant m agnetic moment i = atm iNi, whose direction is con ned to the lm plane, where _{at} is the atom icm agneticm om ent. The unit vector $S_i = i = i$ characterizes the magnetic moment direction of the ith island. The rst term in Eq. (1) represents the magnetic domain wall energy between connected islands, with Lij the number of bonds between islands i and j, and ij the dom ain wall energy per atom ic bond. The second term is the long-rangem agnetic dipole interaction between the island m agnetic m oments i where $r_{ij} = jr_i$ $r_j j$ is the distance between the centers of islands i and j. The point-dipole energy is calculated by applying the E wald sum mation technique over all periodically arranged unit cells of the thin Im .^{18,23} The last term denotes the uniaxial in-plane anisotropy energy with K_i the anisotropy per atom ic spin. Due to this an isotropy we allow for only two stable directions for each island moment ($S_i^x = 1$). Thus, our system refers to a modi ed Ising model, for which during magnetization reversala possible an isotropy energy barrier is taken into account, hence allowing the consideration of magnetization dynamics. Finally, due to the nite exchange coupling J between neighboring atom ic spins, the internal island m agnetization m $_{i}$ (;T) is taken into account within a mean-eld approximation. This leads to tem peraturedependent e ective anisotropy coe cients K \rm_{i} (;T) and dom ain wall energy densities ii (;T), as described in greater detail in R ef. 17.

E quation (1) describes a system of dipole-coupled single islands at low lm coverages $_{\rm P}$ as well as a connected ferrom agnetic lm at high coverages $_{\rm P}$. We point out that the transition between these extrem al cases during the lm grow this described within the same model. The assumption of individual magnetic islands

with varying interactions is a good approximation as long as the system is laterally nanostructured, whereas for smooth lms (here 2:0 ML) it represents an unphysical discretization of the system.

B. Cluster M C m ethod

The magnetic equilibrium and nonequilibrium properties are calculated by performing kinetic cluster M C simulations. Especially, close to the percolation coverage $P_{\rm P}$, most of the magnetic islands are connected to neighboring islands and form large but still nite clusters. A single-spin-ip (SSF) algorithm 22 for such an irregular atom ic structure yields a very slow relaxation towards therm odynam ic equilibrium, since subsequent ips of island m agnetic m om ents in this cluster of connected islands, as considered by SSF updates, are strongly hindered by the exchange energy, see Ref. 34. Thus, a rotation of the entire island cluster is very unlikely, and its dependence on dipole interaction and anisotropy is strongly underestim ated. For an improved simulation of the magnetic relaxation, a coherent or simultaneous rotation of the spins in these clusters has to be taken into account. For this purpose, we propose a cluster-spin-ip (CSF) algorithm^{20,21} in the present study.

In a rst step of each M C update, a cluster C consisting of connected islands is constructed by the following scheme:

(a) C hoose random ly a single island i, representing the rst (sm allest) island cluster $C_1=\mbox{ fig.}$

(b) Add a random second island j which is connected to island i ($L_{ij} \in 0$), form ing the second island cluster $C_2 = fi; jg$.

(c) C onstruct subsequently larger island clusters C by adding a random ly chosen island to the preceding cluster C $_1$, provided that this island is connected to at least one of the 1 islands of C $_1$.

(d) C ontinue this construction procedure till either no additional adjacent islands are present or if a maximum allowed number $_{max}$ of islands in the cluster is reached. From this procedure, we obtain a set of $_{max}$ island clusters fC₁;::;C g.

(e) Out of this set choose one cluster C with weight ! for probing (! = 1).

A Monte Carlo step (M CS) is de ned by the usual condition that Z islands in the system are probed. Employing a cluster C containing islands considers the portion =Z of the system in a single update. To ensure that probing large clusters does not dominate the relaxation process, we assign the weight ! = 1= for choosing C out of the set fC_1 ;:::;C g. This de nition im plies that within a single M CS no additional relaxation channels are opened by the consideration of island cluster

ips.³⁵ W e em phasize that not only is the largest possible island cluster C probed for ipping, but all island clusters out of the corresponding set are considered. The island m om ents within an island cluster need not to be

parallel.

In the second step of each update, all island spins of the chosen cluster C are probed for a coherent ip. The corresponding ip rate is calculated in the usual way as if these connected islands form a single large island.¹⁷ From Eq. (1), the magnetic energy of this island cluster as function of the in-plane angle is given by

and the total anisotropy energy of the cluster K = $_{k=1}^{k} N_k K_k$. Here, the k sum runs over all spins inside, and the l sum over all spins outside the island cluster C . We have neglected the dipole sum s $_{R^1}(x_{k1}y_{k1})=r_{k1}^5$ which are usually smaller than the sum s $_{k1}(x_{k1})^2=r_{k1}^5$ and $_{k1}(y_{k1})^2=r_{k1}^5$.

The Ising-like states $S_i^x = 1$ of C represent either energy m inim a which are separated by an anisotropy energy barrier, or refer to an energy maximum and m inimum. The respective energy barriers for the forward and backward transitions are given by

The ip rate ⁽¹⁾ of the island spin cluster C to overcome E ⁽¹⁾ is calculated from the common Arrhenius-Neel ansatz.^{7,8} W e use a constant prefactor $_{\circ} = 10^9 \ \text{sec}^{-1}$ which determ ines the time unit of the magnetic relaxation in kinetic M C simulations.³⁶ The latter case is treated with the usual M etropolis-type rate, using the same prefactor.²²

The growing thin lm is characterized by a large am ount of nonequivalent lattice sites, corresponding to a large number of di erent interaction param eters. Since little is known about these values, we use in our sim – ulation averaged quantities for the magnetic param eters which are xed as follows, using as an example the Co/Cu (001) thin-lm system. The atom icm agneticm om ents are set to $_{\rm at} = 2.0$ $_{\rm B}$.²⁴ The dom ain wallenergy

is adjusted to give the observed Curie tem perature of the ferrom agnetic long-range order of $T_c = 355$ K of a 2-M L Co/Cu(001) lm,⁵ yielding = 5.6 meV/bond. The exchange interaction for the calculation of the internal island magnetic ordering is set equal to J = 7.0 meV/bond.¹⁷ For the uniaxial anisotropy, two di erent values K = 0.1 and 0.01 meV/atom are investigated.

In this study, we determ ine the remanent magnetization M rem (;T;t) = ${}_{i}N_{i}S_{i}^{x}(t)m_{i}(;T) = {}_{i}N_{i}$ of the growing thin lm, where t is the MC time in units of MCS. The simulation starts from a completely aligned island spin state. The choice of this initial state refers to experiments which saturate the magnetic system by an

externalm agnetic eld and determ ine the rem anentm agnetization after removal of the $eld.^{3,5}$ W e have no evidence that m agnetic arrangem ents end up in m etastable states during relaxation when starting from a saturated state. In addition, we calculate the equilibrium magnetization $M_{eq}(;T)$, which is obtained by averaging M rem (;T;t) over a range of 500 M C S after the system has become equilibrated. M $_{rem}$ (;T;t) and M $_{eq}$ (;T) are averaged over at least 20 di erent structural runs. The magnetizations are given in units of a saturated monolayer (i.e., = 1 ML) at T = 0. Since the nitesized unit cell undergoes eventually total magnetic reversals during MC probing, accidental cancellation of a nite M rem and M eq during structural and tem poral averaging may occur. To avoid this, we use in this study merely the absolute values $M_{\rm rem}$ j and $M_{\rm eq}$ j.

III. RESULTS AND DISCUSSION

A. Island grow th and CSF algorithm

Snapshots of the atom ic structure during thin Im growth, resulting from our growth model, are shown in Ref. 17. The resulting static atom ic structure is sim ilar to the one observed for the Co/Cu (001) system .⁶ In the initial stages of growth, random ly located islands with alm ost rectangular shapes are obtained. With increasing Im coverages, the single islands start to coagulate and form island clusters with a still nite size. By analysing the percolation probability using the Hoshen-K opelm an algorithm, we yield a percolation coverage of 0:9 M L^{25,26} Continued Im grow th leads to about P a connected thin lm. In this coverage range, the system still exhibits a distinct irregular nanostructure. Isolated island clusters vanish rapidly upon further adatom deposition. The coverage = 2.0 ML corresponds to a smooth magnetic lm with two closed layers.

At rst, we investigate the e ect of the cluster-spinip M C m ethod on the simulation of the rem anent m agnetization 1/1 rem (;T;t)j. Here we consider only the exchange interaction. For a strongly connected lm = 1:8 M L we test whether by use of C SF (_P $M_{\rm rem}$ (;T;t) j relaxes into the correct equilibrium value M_{eq} (;T); starting from a fully aligned state. As can be seen from Fig. 1(a), this condition is fullled, since dierent maximum allowed numbers max of islands in the cluster lead to the same equilibrium value as for the single-spin-ipMC method. The larger the number max is, the slower is the relaxation. This property is caused by the fact that in this coverage and tem perature range the magnetic relaxation is mainly provided by ips of single islands or sm all island clusters. As m entioned in Sec. IIB, no additional relaxation channels are opened by use of CSF, hence the num ber of single-spin- ip attempts becom es reduced in favor of unprobable cluster-spin-ip ones. Examples for the error bars are also given. The statistical error, which is similar for all forthcom ing gures,

results mainly from averaging over dierent structural realizations of the unit cell and could be reduced by using

W e point out that the main im provem ent of the CSF with respect to the SSF method is obtained for cover- $_{\mathbb{P}}$, characterized by a considerable amount ages . of island cluster form ation, and which is very di cult to be studied analytically. In Fig. 1 (b), the magnetic relaxation for = 0.8 ML is depicted using di erent m_{ax} . The equilibrium magnetization M $_{\rm eq}^{\rm 0}$ (;T) should vanish for < P, since long-range m agnetic interactions are neglected here. Due to the use of the absolute value a nite but sm all M_{eq}^{0} (;T) jis obtained in our calculations. The SSF algorithm exhibits an extremely slow magnetic relaxation toward M_{eq}^{0} j. Even after 10^{6} M C S the rem anent magnetization is relaxed only to $M_{rem}^{0} = 0.60$. The reason is that this method considers very unfavorable interm ediate states. A lready the allow ance of a few coherently ipping island spins results in a much faster relaxation. The relaxational behavior converges rapidly with increasing m_{ax} . Using the CSF with $m_{ax} = 50$ or larger the equilibrium is reached already after 100 M C S. To obtain a fast equilibration, the closer the coverage to P the larger the value chosen for m_{ax} . The CSF algorithm leads to a much faster equilibration also for coverages & P. In this coverage range, island clusters are still present which have only weak links to other clusters. In the following investigations, we set m_{ax} equal to the number of single islands Z = 625, except for cov-P where we yield a better perform ance for erages $m_{ax} = 100.$

larger unit cells.

Hence, by use of the SSF algorithm the exchange interaction grossly dom inates the M C simulations for strongly inhom ogeneous system s. This is avoided by applying CSF, allowing thus for the investigation of the e ect of the much weaker anisotropy and dipole interaction.

B. E ect of interactions

First, we study the combined e ect of the dipole and the exchange interaction on the lm magnetization for coverages < P. We determ ine equilibrium properties which within our model are not in uenced by the anisotropy. In Fig. 2(a), we present M_{rem} (;T;t)j for dierent temperatures T as a function of MC time t. The coverage is assumed to be = 0.8 ML. Starting from the fully aligned state M_{rem} (;T;t = 0)j = 0.8, the rem anent Im m agnetization relaxes fast to its equilibrium value. For the assumed temperatures the dipole coupling leads to a net magnetization $M_{\rm rem}$ j > $M_{\rm rem}^0$ j where for $M_{\rm rem}^0$ j the dipole interaction is neglected. A fter several hundred M C S equilibration is obtained for the dipole-coupling induced M_{rem} jwhich then stays stable within the simulation time. We emphasize that it is im possible to obtain these and the following results with conventional SSF algorithm s.

In Fig. 2(b), the equilibrium magnetization

 $M_{eq}(;T)$ j is shown as function of temperature T for di erent coverages . For low tem peratures, clearly a magnetic ordering due to the dipole interaction is seen. The larger the coverage is, the larger is the ordering e ect, since with an increasing the average island cluster size and thus the average dipole coupling energy increases. Above the ordering temperatures $T_{\rm C}$ (), the magnetizations $M_{eq}(;T)$ reach the corresponding values M_{eq}^{0} (; T) j as calculated without the dipole interaction. Due to the use of absolute values, M_{eq}^{0} (;T)j stays always nite. $T_{
m C}$ () is estimated by extrapolating the linear part of M_{eq} j to M_{eq}^{0} j. The ordering tem perature even for the largest investigated coverage is quite small, yielding T_C 6 K for = 0:8 M L. The rounding of M_{eq} j near the ordering tem perature is caused by (i) the nite unit cell size, (ii) the use of the absolute value, (iii) the presence of island size and -position dispersions, and (iv) the average over 20 di erent realizations of the unit œll.

The existence of a long-range magnetic ordering due to the dipole interaction has been calculated for periodic lattices.²⁷ In our study, we nd that also within an irregular island system below the percolation threshold the dipole interaction leads to a magnetic ordering, indicated by a net magnetization $M_{eq}j > M_{eq}^{0}j$. Such a collective state is expected to be spin-glass-like, as discussed for three-dimensionalmagnetic particle system s_r^{14} and which needs a further investigation. We remark that the obtained ordering tem peratures will increase by considering a noncollinear island magnetization beyond 1_{ℓ}^{28} by taking into account the nite island ex- $S_i^x =$ tension for the dipole interaction beyond the point-dipole approximation,²⁹ or by consideration of densely packed three-dim ensional particles.

In Fig. 3, we investigate the in uence of the magnetic anisotropy and the exchange interaction on the magnetic relaxation for coverages < P. Here, the dipole coupling is neglected. In Fig. 3(a), the remanent magnetization M_{rem} (;T;t) jis given as function of MC time t for di erent temperatures T and for K = 0.01 m eV/atom. The coverage is assumed to be = 0.8 ML. Starting from the fully aligned state, at rst M_{rem} (;T;t) jdrops rapidly due to relaxation of single islands and sm all island clusters. The further relaxation happensm uch more slow ly since here larger island clusters have to be reversed. For T & 25 K, the magnetization M_{rem} (;T;t) j reaches within the depicted time range the curve M_{rem}^{0} j as calculated for K = 0.

In Figs. 3(b) and 3(c), we show M_{rem} (;T;t)jafter t = 1000 MCS for di erent coverages as function of tem perature, using the anisotropy parameters K = 0.01 and 0.1 meV/atom. W ith increasing tem perature, the magnetization M_{rem} (;T;t)japproaches the equilibrium value M_{eq}^{0} j. The corresponding blocking tem peratures T_b (;K) are obtained by extrapolating the linear part of M_{rem} jto M_{eq}^{0} j. A rounding of M_{rem} jnear T_b is observed due to the same reasons as discussed in connection with Fig.2.

W e em phasize that for a connected island structure an increase of the anisotropy K by a factor of 10 does not necessarily lead to an increase of $T_{\rm b}$ (;K) by the same factor as obtained from the Stoner-W ohlfarth m odel. 19 This is caused by internal cluster excitations, i.e., creation or motion of domain walls inside island clusters. To discuss this, we have perform ed additional calculations for an in nite domain wall energy , indicated by the full lines in Figs. 3(b) and 3(c), hence allowing only for coherent island cluster rotations. Above a certain tem perature, the curves for nite and in nite deviate, since then internal cluster excitations become e ective. For K = 0.01 m eV / atom and coverage = 0.6 M L, the di erence between these curves is small, thus the magnetic relaxation happens mainly via coherent rotation. In contrast, for = 0.8 M L or for the larger an isotropy K = 0:1 m eV/atom, obviously both relaxation processes are present.

W hich relaxation process is e ective at a given tem perature is determ ined by its energy barrier E. For a coherent rotation of an isolated island cluster, E is given by its total an isotropy energy K . In contrast, E for an internal cluster excitation consists of both the an isotropy of the actually reversed islands and the dom ain wallenergy, see Eqs.(4) and (5). By closer investigation, we found that a particular relaxation process becom es effective above a tem perature amounting to 5 { 10 % of E. In the temperature ranges T < 40 K for K = 0:01 meV/atom and T < 100 K for K = 0:1 meV/atom, each internal cluster excitation consists mainly of reversing only one or two islands. For markedly larger tem peratures, the internal cluster excitations will become more com plex, depending in a com plicated way on the nanostructure.

The in uence of the dipole coupling on the relaxation behavior is discussed in Fig. 4. For . $_{\rm P}$ and K = 0.01 m eV/atom, the dipole interaction results in a small increase of $M_{\rm rem}$ jand T_b. Thus, the dipole interaction leads to a sbwer magnetic relaxation. Interestingly, this e ect is visible in the whole temperature range up to T_b, and is not limited to those small temperatures where the dipole coupling induces a magnetic ordering, see Fig. 2. The increase of $M_{\rm rem}$ j will become a larger if a stronger dipole coupling is assumed, for example for larger island magnetic moments. Experimentally, a sim – ilar e ect was observed for two-dimensional arrays of interacting magnetic nanoparticles with random anisotropy axes.¹³ A m ore detailed investigation of this property is needed.

Next, we investigate the magnetization for coverages above the percolation threshold, $>_{\rm P}$. In Fig. 5, the equilibrium magnetization $M_{\rm eq}(;T)$ jis shown as function of temperature for di erent coverages. Here, the exchange coupling causes a fast magnetic relaxation and a strong ferrom agnetic long-range order. For large coverages and at low temperatures, the behavior of $M_{\rm eq}$ j is reigned by the decrease of the internal island magnetization m_i(;T), whereas at elevated temperatures a

strong decay of M _{eq}j is caused by the disturbance of the island spin alignment. The resulting ordering tem peratures $T_{\mbox{\scriptsize C}}$ () are deduced from the in ection points of $M_{eq}(;T)$ i. In addition, for = 1:0 M L and 12 ML we show the nonequilibrium remanent magnetization M_{rem} j after t = 1000 M C S, considering K = 0:01 eV /atom . The corresponding blocking tem peratures $T_{\rm b}$ () are markedly larger than $T_{\rm C}$ () in the coverage $_{\rm P}$, where the nanostructure of the percorange & lated thin lm is still very irregular and nonequilibrium e ects due to anisotropy barriers are pronounced. For In swith larger coverages, having a higher connectivity between islands, the exchange coupling results in a fast m agnetic relaxation and thus the tem perature di erence between $T_{\rm b}$ and $T_{\rm C}\,$ is small. A very weak ordering e ect due to the dipole interaction is visible only for very low tem peratures and coverages & $_{\rm P}$. Here, still a few isolated islands or island clusters exist which are coupled to the percolating cluster by the dipole interaction.

In Fig. 6, we sum marize the most important results of this study. The (nonequilibrium) blocking tem perature T_b (;K) and the (equilibrium) ordering tem perature T_C () are presented as functions of coverage in the whole investigated growth range. For a better visualization, a logarithm ic tem perature scale is applied. T_{b} is determined for two di erent anisotropies K = 0.01 and 0:1 m eV /atom and t = 1000 M C S. Below the percolation coverage P, the dipole interaction induces sm all ordering tem peratures T_c of the order of 1 { 10 K for the assum ed m odelparam eters. D ue to the coagulation of islands with increasing coverage the exchange interaction becom es m ore im portant, since it couples single islands to magnetically aligned large clusters. This results in a strong increase of T_C in particular close to P. This behavior has been observed in experim ents on Co/Cu (001) ultrathin $lm s (T_C - jum p")$.^{5,6} For percolated thin lm s, the ordering tem perature is of the order of 100 { 300 K and is, within the accuracy of our calculations, exclusively determ ined by the exchange coupling. The slope of T_C () for > P is not as steep as for < P. In addition, we show the ordering temperature $T_{\rm C}$ due to dipole interaction by neglecting the exchange coupling between islands. Evidently, a distinct variation of $T_{\rm C}$ near $_{\rm P}$ is not obtained in this case.

The nonequilibrium behavior as caused by the anisotropy K di ers strongly for coverages below and above $_{\rm P}$. Due to the slow relaxation of the irregular atom ic structure for < $_{\rm P}$, a blocking temperature $T_{\rm b}$ () is obtained which is an order of magnitude larger than $T_{\rm C}$ () resulting from the dipole interaction. Evidently, $T_{\rm b}$ depends on the anisotropy K and the M C time t. On the other hand, for > $_{\rm P}$, the relaxation is accelerated by the exchange interaction. W ith increasing

the rem anent m agnetization reaches the equilibrium value within t = 1000 M C S, hence $T_{\rm b}$ () m erges into $T_{\rm C}$ ().

Recently, a mean eld theory (MFT) for the dipolecoupling induced magnetic ordering temperature has been performed, using a simplied growth model.⁶ A qualitatively similar behavior of T_C () as compared to the present MC calculations was obtained, in particular the strong variation of T_C near $_P$ due to the exchange interaction between coagulated islands. Evidently, MFT yields much larger values for T_C () for such low-dimensional systems especially for $< _P$, since thermal uctuations are neglected.

In the following, we discuss our results in connection with measurements on Co/Cu (001) ultrathin lms. A lthough several model parameters are chosen in accordance with this system, a full quantitative comparison cannot be drawn yet. The main reason is that the observed intermixing of Co adatoms with Cu substrate atoms is not taken into account within our grow th model due to the incom plete knowledge of the resulting atom icm orphology. The measured percolation threshold 1:7 ML is much larger than the one as obtained

with the growth parameters used by us.

To investigate solely the e ect of an enlarged $P_{\rm P}$, we have perform ed additional simulations simply by taking into account magnetic islands with up to three atom ic layers, yielding the observed $\ _{P}$. Then for a coverage = 1:6 M L, the dipole coupling induces a ordering tem -50 K. The corresponding blocking tem perature T_C perature for K = 0:01 m eV and t = 1000 M C S is obtained to be T_b 150 K.Hence, we nd that for the assum ed grow th m odes and m agnetic param eters the blocking temperatures are always markedly larger than the ordering tem peratures. These tem peratures are com parable with m easured tem peratures $T_{\rm C}$ 150 K for coverages slightly below $P^{.5}$ In addition, to draw a quantitative comparison with the Co/Cu (001) system a fourfold symmetry of the in-plane an isotropy has to be taken into account. W e expect that the above stated general behavior of the magnetic relaxation and ordering obtained with a uniaxial anisotropy will not be changed.

IV. CONCLUSION

In this study, we have calculated the nonequilibrium and equilibrium remanent magnetization of growing ultrathin lms, using a cluster M onte C arlo method. An island-type nanostructure with a nonuniform distribution of island sizes, shapes, and locations was investigated. W ithin a micromagnetic model (modi ed Ising model) the single-island magnetic anisotropy, the dipole coupling, and the exchange interaction between magnetic islands were taken into account. We have analysed the transition from dipole-coupled islands for lm coverages below the percolation threshold $_{\rm P}$ towards a connected ferromagnetic lm above $_{\rm P}$ with increasing lm coverage.

For coverages $< P_{\rm P}$, the dipole interaction leads to an equilibrium net magnetization referring to a collectively ordered state. A sm all ordering temperature $T_{\rm C}$ of about 1 { 10 K results for the assumed model parameters. T_C increases strongly near $_P$ due to exchange interaction which aligns coagulated islands. On the other hand, the anisotropy induces a pronounced nonequilibrium remanent magnetization which may be visible in experim ent even after long waiting times. The corresponding blocking tem perature Tb is obtained to be of the order of 10 { 100 K, which is alwaysm arkedly larger than T_c. Approaching P, the proportionality between blocking tem perature and anisotropy is no longer valid due to relaxation via internal island cluster excitations. A nonequilibrium rem anent m agnetization due to an isotropy is visible also for coverages & P where the lm is still very irregular. For sm oother Im s at larger coverages the exchange interaction induces a fast magnetic relaxation towards equilibrium .

W e have obtained these results with a cluster-spin- ip algorithm which takes into account coherent magnetic rotations of island clusters. This method leads to a very fast and more realistic magnetic relaxation towards equilibrium in the coverage range with an irregular nanostructure. O ur results cannot be achieved by conventional single spin- ip algorithm s. The suggested C SF algorithm can be applied also to other inhom ogeneous spin system s such as diluted magnets and spin glasses. Several possible in provements of our microm agnetic model are pointed out. In this study, we have used Isinglike states $S_i^x = 1$. By applying continuously varying spins S_i , noncollinear magnetic arrangements can be analysed,²⁸ allowing one to also determine the elects of an external magnetic eld for these strongly inhom ogeneous lms. In particular, the movement of magnetic domain walls can be investigated. Furthermore, various magnetic nanostructures like chains and stripes³ can be studied easily by a proper variation of the parameters of the Eden-type growth model. A nisotropies with, e.g., a four-fold in-plane symmetry will be considered. Finally, the relaxation laws and times of the remanent magnetization can be investigated for such thin lm systems.³




FIG.1: Comparison of the calculated lm m agnetization using the single-spin- ip (SSF) and cluster-spin- ip (CSF) algorithm. Only the exchange coupling between m agnetic islands is considered. The rem anent m agnetization M_{rem}^{0} jas function of MC timet for two lm coverages (a) = 1.8 ML and (b) = 0.8 ML above and below the percolation coverage $_{P}$ 0.9 ML is shown. W ithin the CSF m ethod, di erent m axim um num bers $_{m ax}$ of coherently ipping island m agnetic m om ents are used.




FIG. 2: Long-range magnetic ordering due to dipole interaction for coverages below the percolation coverage $_{\rm P}$. Only dipole and exchange interactions are included. The quantities $M_{\rm rem}^0$ j and $M_{\rm eq}^0$ jneglect the dipole interaction. (a) Rem anent magnetization $M_{\rm rem}^{\rm rem}$ j as function of MC time t for = 0.8 ML < $_{\rm P}$ and di erent temperatures T. (b) Equilibrium magnetization $M_{\rm eq}$ jas function of temperature T for di erent coverages < $_{\rm P}$.




FIG. 3: Relaxation of the rem anent m agnetization for coverages below the percolation coverage $_{\rm P}$. Only anisotropy and exchange interaction are taken into account. (a) Rem anentm agnetization $M_{\rm rem}$ jas function of M C timet for $= 0.8 \, \text{M L} < _{\rm P}$, anisotropy K $= 0.01 \, \text{m eV}$ /atom, and di event temperatures T. The full line refers to K = 0 and T $= 35 \, \text{K}$. Furtherm ore, (b) and (c) show the rem anent m agnetization $M_{\rm rem}$ jaffer t $= 1000 \, \text{M CS}$ as function of temperature T for K $= 0.01 \, \text{and}$ 0.1 m eV /atom. The full lines are calculated with an in nite dom ain wall energy .




FIG.4: In uence of m agnetic anisotropy and dipole coupling on the rem anent m agnetization M_{rem} (T) jas shown in Fig.3(b). Results for two coverages below the percolation coverage P_{P} are presented.




FIG.5: Long-range ferrom agnetic ordering due to exchange interaction for di erent coverages above the percolation coverage $_{\rm P}$. The equilibrium magnetization $M_{\rm eq}$ j is shown as function of temperature T. For comparison, for = 1.0 and 1.2 M L also the rem anent magnetization $M_{\rm rem}$ jafter t = 1000 M CS is depicted for an anisotropy K = 0.01 m eV/atom.




FIG.6: Sem i-logarithm ic plot of the magnetic ordering temperature T_c and the blocking temperature T_b as functions of the lm coverage . The temperatures T_c and T_b are extracted from the preceding gures. The entire investigated coverage range below and above the percolation coverage $_P$ is shown. The di erent magnetic interactions dom inate in di erent coverage and temperature ranges as indicated. The dashed curve refers to the dipole-coupling-induced ordering temperature neglecting the dom ain wall energy between islands.
