# G ravotherm al C atastrophe and T sallis' G eneralized Entropy of Self-G ravitating System s III. quasi-equilibrium structure using norm alized q-values

#### A bstract

We revisit the issues on the therm odynam ic property of stellar self-gravitating system arising from Tsallis' non-extensive entropy. Previous papers (Physica A 307 (2002) 185; ibid. (2003) in press (cond-m at/0204315)) have revealed that the extrem um -state of T sallis entropy, so-called stellar polytrope, has consistent therm odynam ic structure, which predicts the therm odynam ic instability due to the negative speci c heat. How ever, their analyses heavily relies on the old T sallis form alism using standard linear m ean values. In this paper, extending our previous study, we focus on the quasi-equilibrium structure based on the standard fram ework by m eans of the norm alized q-expectation values. It then turns out that the new extrem um state of T sallis entropy essentially remains unchanged from the previous result, i.e., the stellar quasi-equilibrium distribution can be described by the stellar polytrope. While the therm odynamic stability for a system con ned in an adiabatic wall com pletely agrees with the previous study and thereby the stability/instability criterion remains unchanged, the stability analysis reveals a new equilibrium property for the system surrounded by a therm albath. In any case, the stability/instability criteria are consistently explained from the presence of negative speci c heat and within the form alism, the stellar polytrope is characterized as a plausible non-extensive meta-equilibrium state.

## 1 Introduction

In many astrophysical problem s involving self-gravitating many-body system, them odynamic or statistical mechanical treatment usually loses its power due to the peculiar feature of long-range attractive force. In some restricted cases with the long-term evolution of stellar self-gravitating systems, how ever, therm odynamic stability criterion or statistical mechanical analysis recovers the physical relevance and plays an essential role in predicting the fate of such system. In fact, it is well-known that late-time stellar dynamical evolution of the globular clusters as a real astrophysical system is driven by so-called gravotherm alcatastrophe, i.e., therm odynamic instability arising from the negative speci c heat, which is widely accepted as a fundamental astrophysical process [1{3]. Historically, the gravotherm alcatastrophe has been investigated in detail considering the very idealized situation, i.e., stellar self-gravitating system consisting of many particles con ned within a cavity of hard sphere [4{8]. In particular, special attention to the statistical mechanical approach using the Boltzm ann-G ibbs entropy has been paid.

Recently, this classic issue was re-analyzed by present authors on the basis of the non-extensive therm ostatistics with T sallis' generalized entropy [9] (for comprehensive review of T sallis' non-extensive form alism and its application to the other subject of physics, see R efs.[10,11]). In contrast to the B oltzm ann-G ibbs entropy, the quasi-equilibrium distribution<sup>1</sup>

characterized by the T sallis entropy can be reduced to the stellar polytropic system [12,13]. Evaluating the second variation of entropy around the quasiequilibrium state, we have developed the stability analysis and discussed the criterion for onset of gravotherm al catastrophe (R ef.[14], hereafter paper I). Further, to clarify the origin of this instability, therm odynam ic properties has been investigated in detail calculating the speci c heat of the stellar polytrope (R ef.[15], hereafter paper II). The most noticeable thing in their papers is that the existence of therm odynam ic instability indicated from the second variation of entropy or free-energy is com pletely explained from the presence of negative speci c heat. As a consequence, the gravotherm al instability appears at the polytrope indices n > 5 for a system con ned in an adiabatic wall and at n > 3 for a system surrounded by a therm albath.

While the results in papers I and II are indeed satisfactory and the physical interpretation of the instability is fully consistent with previous early

works, from a standard view point of the T sallis non-extensive form alism, several in portant issues still rem ain unresolved. Am ong these, the most crucial problem is the choice of the statistical average in non-extensive therm ostatistics. The previous analyses have been all investigated utilizing the old T sallis form alism with the standard linear mean values, however, a more sophisticated fram ework by means of the norm alized q-values has been recently presented [16,17]. As several authors advocated, the analysis using normalized q-values is thought to be essential, since the undesirable divergences in some physical systems can be eliminated safely when introducing the normalized q-values. Further, non-uniqueness of the Boltzm ann-G ibbs theory has been shown using the norm alized q-values [18]. Of course, this does not imply that all the analyses with standard linearm eans or un-norm alized q-values lose the physical signi cance<sup>2</sup>, however, in order to pursue the physical reality of the non-extensive them odynam ics, them odynam ic structure of the stellar selfgravitating system still needs to be investigated and the relation between the old and the new form alism must be claried.

This paper especially focuses on this matter starting from the construction of the extrem um-entropy state by means of the normalized q-values. Within a mean-eld treatment, we investigate the thermodynamic property of the quasi-equilibrium distribution surrounded by an adiabatic and a thermally conducting wall. In particular, we discuss the existence or the absence of thermodynamic instability evaluating the speci cheat of the quasi-equilibrium systems. Further, in order to check the consistency of the thermodynamic structure, the stability/instability criteria obtained from the thermodynamic property are re-analyzed from the second variation of entropy and free-energy. We found that the extrem um state of the T sallis entropy essentially remains unchanged and is described by the stellar polytrope. While the stability of the system in an adiabatic wall exactly coincides with the results in paper I, the new form alism using the normalized q-values reveals a new thermodynamic structure for a stellar system surrounded by a therm all bath. This point will be discussed in detail com paring it with the previous results.

The paper is organized as follows. In Section 2, employing the standard T sallis form alism, we revisit the issue on the most probable state of stellar quasiequilibrium distribution on the basis of maximum entropy principle. While the resultant extrem um state of T sallis entropy reduces to the same stellar polytropic distribution as previously found, the new equilibrium distribution has several distinct structures. Taking fully account of this fact, in Section 3, the therm odynam ic properties of stellar polytropic system are investigated in detail. Therm odynam ic temperature in stellar system is identi ed through them odi ed C lausius relation, which is indeed consistent with the recent claim

based on the therm odynam ic zero-th law. Then, we evaluate the speci c heat and discuss the existence or absence of therm odynam ic instability. In Section 4, the stability/instability criteria are re-considered by means of the second variation of entropy and free-energy. In contrast to the previous analysis using the old T sallis form alism, the second variation of free-energy shows a distinct therm odynam ic structure. N evertheless, the zero-eigenvalue problem in each case exactly recovers the marginal stability condition inferred from the speci c heat. Thus, within the new form alism using norm alized q-values, all the analyses are consistent and the stellar polytrope can be regarded as a plausible non-extensive therm al state. Finally, Section 5 is devoted to the conclusion and the discussion.

## 2 Maximum entropy principle revisited

Throughout the paper, we pursue to investigate the equilibrium property of the stellar self-gravitating system consisting of N particles con ned in a spherical cavity of radius  $r_e$ . For simplicity, each particle has the same mass m<sub>0</sub> and interacts via New ton gravity only. Then, the total mass becomes  $M = N m_0$ . In this situation, owing to the maximum entropy principle, we seek the most probable quasi-equilibrium distribution in an adiabatic treatment. That is, we consider the quasi-equilibrium structure as the extrem um -entropy state in which the particles elastically bounce from the wall, keeping the mass M and energy E constant.

Following the papers I and II, we treat this issue on ploying the mean-eld approach that the correlation between particles is smeared out and the system can be simply described by the one-particle distribution function f(x;v), dened in six-dimensional phase-space (x;v). In this treatment, the one-particle distribution is regarded as a fundamental quantity characterizing the stellar system. Let us denote the phase-space element as  $h^3 = (l_0 v_0)^3$  with unit length  $l_0$  and unit velocity  $v_0$  and dene the integral measure  $d^6 = d^3x d^3v = h^3$ . Regarding the function f(x;v) as a fundamental statistical quantity, the energy and the mass are respectively expressed as follow s:

where the quantity (x) is the gravitational potential given by

On the other hand, in the new fram ework of T sallis' non-extensive therm ostatistics, all the macroscopic observables of the quasi-equilibrium system can be characterized by the escort distribution, but the escort distribution itself is not thought to be fundamental. Rather, there exists a more fundamental probability function p(x;v) that quanties the phase-space structure. W ith a help of this function, the escort distribution is dened and the macroscopic observables are expressed as the normalized q-expectation value as follows (e.g., Refs.[16,17]):

And based on the fundam ental probability p(x ; v), the T sallis entropy is given by

To apply the above T sallis form alism to the present problem without changing the de nition of energy and m ass (1) and (2), we identify the one-particle distribution with the escort distribution  $P_{q}$ , not the probability function p(x;v):

so as to satisfy the mass conservation (2). W ith this identication (8), the normalized q-values are naturally incorporated into our mean-eld treatment. As a consequence, later analyses become almost parallel to the previous study, in a form -invariant manner.

Now, adopting the relation (8), let us seek the extrem um -entropy state under the constraints (1) and (7). As has been discussed recently, there are two approaches that extrem ize the entropy under certain constraints, i.e., the m ethod developed by T sallis, M endes & P lastino (TM P) [16] and the optim alLagrange multiplier (O LM ) m ethod by M artinez et al. [17]. Here, we speci cally apply the TM P procedure and nd the extrem um entropy state. The alternative derivation using O LM m ethod is presented in Appendix A. The only di erences in the nalexpressions between the TM P and the O LM m ethod are the dependence of the quantity  $N_q$ , which can be summarized in a uni ed form (see Eq.(15) with (16)).

The variational problem in the TMP method is given by the following equation:

where the variables and denote the Lagrange multipliers. The variation with respect to the probability p(x;v) leads to

Here, we used the fact that  ${}^{R}d^{6}$   $f = {}^{R}d^{6}$  f. The above equation includes the variation f, which can be expressed with a help of the relation (8):

In arriving at the equation (12), we have exchanged the role of the variables (x;v) ( $x^0;v^0$ ). Since the above equation must be satistic ed independently of

the choice of the variation p, we obtain

which reduces to the same power-law distribution of "as has been derived in papers I and II. That is, even in the new form alism, the extrem um -entropy state rem ains unchanged and can be described by the so-called stellar polytrope. Together with the result by OLM method (Appendix A), it can be sum marized as follows:

Note that the quantity N  $_{q}^{0}$  m eans N  $_{q}^{0}$  = N  $_{q}$  for the TM P m ethod and N  $_{q}^{0}$  = 1 for the result using 0 LM procedure.

For later analysis, we de ne the density (r) and the isotropic pressure P (r) at the radius r = jx jas

Here, the function B (a;b) denotes the beta function. These two equations lead to the following polytropic relation:

which agrees with the previous result (see Eq.(16) with the identi cation  $(n + 1)K_n = (n \quad 3=2)T$  in paper I).

W hile the resultant form of the quasi-equilibrium distribution (22) turns out to be invariant irrespective of the choice of the statistical averages, we should be aware of the two important di erences between the old and the new T sallis form alism, which we shall describe below.

First, the relation between the polytrope index n and T sallis parameter q in the polytropic relation (19) diers from the one obtained previously, but is related to it through the duality transform ation, q \$ 1=q (see Eq.(14) in paper I or Eq.(12) in paper II). This property has been in the addressed in Ref.[16] in more general context, together with the changes in Lagrangian multiplier. The duality relation implies that all of the therm odynamic properties in the new form alism can also be translated into those obtained in the old form alism. As shown in section 3 and 4, this is indeed true in the system con ned in an adiabatic wall(m icro-canonical ensemble case), however, the duality of therm odynamic structure cannot hold in the system surrounded by a therm al bath (canonical ensemble case).

Second, notice that the quasi-equilibrium distribution (15) with (16) contains the new quantities  $N_q$  and ", which implicitly depend on the distribution function itself. In marked contrast to the result in old T sallis form alism, this fact gives rise to the non-trivial therm odynam ic relations as follow s.U sing the de nitions of density and pressure (17) and (18), the quantity " becomes

Equations (23) and (24) play a crucial role in determ ining the therm odynam ic tem perature of stellar polytrope in section 3, as well as the onset of gravotherm al instability in section 4. In particular, the equation (23) yields the radiusm ass-tem perature relation characterizing the quasi-equilibrium structure of the system con ned in a therm al bath.

K eeping the above remarks in m ind, hereafter, we will speci cally focus on the spherically symmetric case with the polytrope index n > 3=2 (q > 0), in which the quasi-equilibrium distribution is at least dynamically stable (see Chap.5 of Ref.[1]). In this case, despite the above detailed di erences, the stellar quasi-equilibrium distribution can be characterized by the so-called Em den solutions (e.g., [21,22]) and all the physical quantities are expressed in terms of the homology invariant variables (u;v), which are subsequently used in later analysis. In Appendix B, together with some useful integral formulae, we summarize the relation between the Em den solution and the stellar polytropic distribution.

#### 3 Therm odynam ic properties of stellar polytrope

Having established the quasi-equilibrium distribution, we now investigate the therm odynam ic properties of stellar polytropic system. To do this, we adopt the same procedure as in paper II. That is, we exam ine the C lausius relation under the quasi-static variation for the new equilibrium system in section 3.1. In contrast to the previous analysis, the therm odynam ic tem perature can be identied with a help of (23), consistently with the recent claim based on the therm odynam ic zero-th law. U sing this tem perature, in section 3.2, presence or absence of therm odynam ic instability is discussed evaluating the speci c heat of stellar system.

## 3.1 On the de nition of therm odynam ic tem perature

A susual, the therm odynam ic instability in stellar system is intim ately related to the presence of negative speci c heat [5,23]. The evaluation of speci c heat is thus necessary for clarifying the therm odynam ic property. In this regard, the identication of temperature in stellar system is the most essential task.

In the new fram ework of T sallis' non-extensive them ostatistics, the physically plausible them odynam ic tem perature,  $T_{\rm phys}$ , can be de ned from the zero-th law of them odynam ics [24{26]. Then, the therm odynam ic tem perature in non-extensive system di ers from the usual one, i.e., the inverse of the Lagrange multiplier, . D epending on the methods extrem izing the entropy, one has

Translating the above result into our notation immediately yields that the physical temperature in stellar polytropic system is given by  $T_{phys} = N_q^0 =$ . However, the relation (26) should be carefully applied to the present case, since the veri cation of therm odynam ic zero-th law is very di cult in stellar equilibrium system with long-range interaction. Furtherm ore, even using the new form alism, the energy E still keeps non-extensive due to the self-referential form of the potential energy (see Eqs.(1)(3)). In order to validate the use of the de nition (26), we therefore adopt a rather simple procedure as exammined in paper II. That is, we consider the relation between heat transfer and entropy change in the quasi-static treatment under keeping the totalm ass constant. A coording to the de nition (26), the C lausius relation is appropriately

modied and is expressed as follows [24{26]:

This is in marked contrast to the result using the standard linear mean (c.f. Eq.(31) of paper II). While the radius mass temperature relation in previous paper includes the residual dimensional parameter  $h = (l_0 v_0)^3$ , the expression (42) has no such parameter dependence and is quite similar to the result in

Boltzm ann-G ibbs case (e.g., Eq.(29) in Ref.[5] or Eq.(25) in Ref.[27])). The nice form of the radius mass tem perature relation in plies that the speci c heat can be determ ined independently of the residual parameter h, which is indeed a desirable property for a rigid theoretical prediction without any uncertainty.

By de nition, the speci c heat at constant volum e C  $_{v}$  is given by

P rovided the hom ology invariants at the boundary, the speci c heat in the new form alism is uniquely determined, free from the residual parameter h (c.f. Eq.(42) in paper II). In this sense, the result (47) can be regarded as a successful outcom e of the new T sallis form alism using the norm alized q-values.

Now, we focus on the therm odynam ic instability inferred from the qualitative behavior of speci c heat. Recall that the therm odynam ic instability appears when the speci c heat of the system changes its sign. From (47), we readily

expect the two possibilities. One is the case when the function  $g(u_e; v_e)$  changes its sign. In this case, the condition for marginal stability,  $C_v = 0$ , becomes

To see how and when the instability develops, in Fig. 1, we plot a fam ily of Em den solutions in the (;)-plane. Since the dimensionless parameters and are respectively proportional to E and  $T_{phys}^{-1}$ , the signature of the speci c heat can be easily deduced from the slope of the curve. Note that each point along the trajectory represents an Em den solution evaluated at the di erent value of the radius r. .> From the boundary condition (83), all the trajectories start from (;) = (0; 1), corresponding to the limit  $r_e$  ! 0. As increasing the radius, the trajectories rstm ove to the upper-right direction as marked by the arrow, and they suddenly change their direction to upper-left. This means that the divergent behavior of speci c heat eventually appears and beyond that point, the signature of speci c heat changes from positive to negative. That is, the potential energy dom inates the kinetic energy ( > 0) and the quasi-equilibrium state ceases to exist for a system in contact with a therm al bath (paper II). Notice that even in this case, the stable quasi-equilibrium state still exists for a system surrounded by an adiabatic wall. On the other hand, for more larger radius, while the curves with index n < 5 abruptly term inate, the trajectories with n > 5 next reach at another critical point d = d = 0, i.e.,  $C_v = 0$ . Further, they progressively change their direction and nally spiral around a xed point. The appearance of the critical point  $C_V = 0$  is explained as follows. W hile the inner part of the system keeps the speci c heat negative, the outer part seems to have positive one. Thus, the heat current from inner to outer part causes the raise of the tem perature at both parts. For a system with the radius re smaller than certain critical value, the amount of the heat capacity at outer part is small so that the outer part easily catches up with the increase of the inner-part tem perature. A sincreasing re, the fraction of the outer norm alpart grows up and it eventually balances with the inner gravothern alpart. Thus, beyond the point characterized by the condition  $C_{\rm V} = 0$ , no therm all balance is attainable and the system becomes gravotherm ally unstable. This is even true in the system surrounded by an adiabatic wall.

>From these discussions, one can immediately verify that the condition (48) represents the marginal stability for a system con ned in an adiabatic wall,

which exactly coincides with the previous result using standard linear means. Hence, one concludes that the quasi-equilibrium structure obtained from the new formalism does not alter the thermal properties in micro-canonical ensemble case. On the other hand, the condition (48) indicates the onset of therm odynamic instability for a system in contact with a therm albath (i.e., canonical ensemble case), which signi cantly diers from the results in old T sallis form alism . Of course, this m ight be a natural consequence of the different choice of statistical average, leading to the di erent de nition T<sub>phys</sub>, however, the appearance of instability in present case might seem somewhat curious. W hile the previous results indicate the unstable state at the indices n > 3, consistent with the suggestion by Chavanis [28], Fig. 1 in plies that therm odynam ic instability appears for stellar polytrope with any value of the index n.O nem ight worry about whether the present results rigorously m atch the stability analysis from the variational problem. In next section, to check the consistency of new T sallis form alism, we develop the stability analysis based on the second variation of entropy and free-energy.

F inally, in Fig. 2, varying the radius  $r_e$ , the speci c heat  $C_v$  is plotted as a function of density contrast, D c= e for typical polytrope indices with n 3=2.C learly, the critical point  $f_v j!$  1 m arked by crosses exists in each case, while the marginal stability  $C_v = 0$  only appears when n > 5 at a certain high density contrast (c.f. Fig. 3 in paper II). The num erical values indicated by arrows represent the critical values D  $_{\rm crit}$  evaluated at the point C  $_{\rm v}$  = 0, which are the same results as in Table 1 of paper I (see also Fig. 5). These behaviors can also be deduced from the energy-radius-mass relation and the radius m ass tem perature relation. In F igs. 3 and 4, using the expressions (42) and (37), the dimensionless values and for various polytrope indices are evaluated and plotted as a function of density contrast, respectively.<sup>3</sup> The Em den trajectories in (;) plane (see Fig.1) state that the marginal stability for the system in contact with a thermal bath,  $\mathcal{C}_{v}$  j! 1 in plies the rst turning point  $d = d_e = 0$ , or equivalently d = dD = 0. Similarly, the marginal stability  $C_v = 0$  represents the condition d = dD = 0.>From Figs. 3 and 4, we readily estimate the critical density contrast at the struming points in each case, which exactly coincide with the points marked by the arrows and the crosses, respectively. Consistently, the turning point disappears when n < 5in Fig. 3, while it does always exist independently of the polytrope index in Fig.4.

4 Stability/instability criteria from the variational problem s

P revious section reveals the existence of two types of them odynam ic instability. Then, the marginal stability conditions (48) and (49) are obtained for a system con ned in an adiabatic walland for a system in contact with a therm al bath, respectively. In this section, in order to check the consistency of these results, we reconsider the marginal stability criteria based on the variational problem.

A coording to the maximum entropy principle, the stable quasi-equilibrium state for a system con ned in an adiabatic wall is only possible when the second variation of entropy around the extremum state is negative, i.e.,  ${}^{2}S_{q} < 0$ . Sim ilarly, the stable quasi-equilibrium distribution surrounded by a therm all bath should have minimum free-energy, indicating the positive value of the second variation of free-energy, i.e.,  ${}^{2}F_{q} > 0$ . Thus, the condition  ${}^{2}S_{q} = 0$  or  ${}^{2}F_{q} = 0$  readily in plies the marginal stability in each case.

To begin with, let us write down the entropy of quasi-equilibrium state. >From (24) and (28), we have

The resultant form of the second variation of entropy  $^{(2)}S_q$  seems rather complicated, however, recalling the fact that the background solution of stellar polytropic distribution always satis as the condition  $^{(1)}S_q = 0$ , the last three terms in right-hand-side of equation (56) can be rewritten in more compact form. A fler some algebra, we obtain

A part from the over-all positive constant, the above expression is indeed the same equation as previously obtained in paper I (see Eq.(36) in paper I, with the identi cation  $T_{phys}=W = f(n \quad 3=2)=(n + 1)gT$ ). Thus, just following the same calculation as in paper I, the stability/instability criterion from  $^{(2)}S_q = 0$  can be obtained, from which one can rigorously prove that the marginal stability condition for a system con ned within an adiabatic wall exactly reproduces the equation (48). As a result, for certain critical values of dimensionless energy and density, crit and D crit, the onset of the gravotherm al instability appears when the stellar polytrope with index n > 5 (see Figs.3 and 5).

### 4.2 Stability/instability criterion from the second variation of free-energy

Now, turn to focus on the second variation of free-energy. In paper II, usual de nition of free-energy

has been used to investigate the marginal stability for a system surrounded by a therm al bath. As several authors recently pointed out, the usual de nition of free-energy becomes inadequate when the physical temperature cannot be identied with the inverse of Lagrange multiplier . A coording to the modi – cation of C lausius relation (27), the free-energy must be generalized as follows [24,25]:

U sing this generalized free-energy, we consider the variation up to the second order, keeping the therm odynam ic tem perature  $T_{\rm phys}$  constant, not the total energy E:

Substituting the equations (52), (53) and (54) into the above equation and keeping the term sup to the second order, after som emanipulation, one obtains

Note that apart from the over-all factor, the rst variation  ${}^{(1)}F_q$  exactly coincides with the rst variation of entropy,  ${}^{(1)}S_q$ , which ensures the fact that extrem um state of generalized free-energy is the same quasi-equilibrium distribution as obtained from the maximum entropy principle. U sing the fact  ${}^{(1)}F_q = 0$ , equation (60) is now rewritten with

O byiously, the above equation di ers from the old result based on the usual de nition of free-energy (58) (c.f.Eq.(51) in paper II). This fact readily in plies that the therm odynam ic stability has nothing to do with the dynam ical stability, which apparently contradicts with the recent claim by Chavanis [27,28].

Thus, in present case using norm alized q-values, it seems non-trivial whether the above equation indeed leads to the marginal stability condition (49).

In what follows, restricting our attention to the radial mode of density and potential perturbations, we discuss the existence or the absence of perturbation mode satisfying the equation  ${}^{(2)}F_q = 0$ . Following the papers I and II, we introduce the new perturbed quantity:

Then the mass conservation M = 0 implies the boundary condition Q (0) = Q ( $r_e$ ) = 0. Substituting (63) into (62) and repeating the integration by parts, the second variation of generalized free-energy is reduced to the following quadratic form :

Thus, the problem reduces to the eigenvalue problem and the marginal stability condition just corresponds to the zero-eigenvalue problem :

To obtain the solution of the above zero-eigenvalue problem, we follow the sim ilar procedure in paper I.F irst recall the fact that the follow ing equations are satis ed:

In addition to the above condition, we must further consider the boundary conditions Q (0) = Q ( $r_e$ ) = 0. W hile the condition Q (0) = 0 is automatically fulled, the remaining condition Q ( $r_e$ ) = 0 requires

Hence, from (70) and (72), the coe cients  $c_1$  and  $c_2$  are determ ined and are expressed in terms of hom obgy invariants:

A snoted in paper I, the above coe cients are not specified completely because of the quantity  $_n$  in the coe cients, which depends on the solution (69) itself. To elim inate this self-referential structure, we directly evaluate the non-local term  $_n$ , leading to the consistency condition for the existence of solution (69). Substitution of the solution (69) with the coe cients (73) into the expression (71) yields

In the above equation, the integrals in the right-hand-side can be evaluated using the formulae (89) and (90) listed in Appendix B.Further, the radiusm ass-tem perature relation (42) eliminates the dependence of  $T_{\rm phys}$ , leading to

which coincides with the marginally stability criterion (49) derived from the condition for speci c heat, C  $_{\rm v}$  ! 1 .

Therefore, unlike the rst impression, we reach at the fully satisfactory conclusion that the therm odynam ic instability inferred from the speci c heat is consistently explained from the variational problem s. In other words, the application of new T sallis form alism to the stability of stellar quasi-equilibrium system reveals a consistent therm odynam ic structure of self-gravitating system, as well as the existence of therm odynam ic instability.

# 5 Discussion & conclusion

In this paper, we revisited the issues on the therm odynam ic properties of stellar self-gravitating system arising from the T sallis entropy, with a particular emphasis to the standard fram ework using the norm alized q-values. It then turns out that the new extrem um -entropy state essentially remains unchanged from the previous study and is characterized by the stellar polytrope, although the distribution function shows several distinct properties. Taking these facts carefully, the therm odynam ic tem perature of the extrem um state was identied through them odi ed C lausius relation and the speci c heat was evaluated explicitly. The detailed discussion on the behavior of speci c heat nally leads to the conclusion that the stability of the system surrounded by a therm al

wall(canonical case) is drastically changed from previous result, while the onset of gravotherm al instability remains unchanged for a system con ned in an adiabatic wall(m icro-canonical case). The existence of these therm odynam ic instabilities can also be deduced from the variation of entropy and free-energy rigorously. As a result, above the certain critical values of or D, the thermodynamic instability appears at n > 5 for a system conned in an adiabatic wall. As for the system in contact with a thermal bath, the onset of thermodynamic instability appears at  $(_{crit}; D_{crit})$  with any value of n. In Figs. 5 and 6, for the sake of the completeness, the critical values evaluated from the conditions (48) and (49) are summarized, respectively. Note also the fact that the critical values in Fig. 5 exactly coincide with the previous results (c.f. Table 1 in paper I).

The one noticeable point in the present result is that the macroscopic relation such as the radius mass tem perature relation or the speci c heat as a function of density contrast can be solely determined from the Emden solutions without any uncertainty. Indeed, previous study using the standard linear means seriously su er from the residual dimensional parameter  $h = (l_0 v_0)^3$ , which must be practically disappeared from the macroscopic description. In paper II, the origin of this residual dependence has been addressed in connection with the non-extensivity of the entropy. A lthough the scaling relation appeared in the old results is simply deduced from the asymptotic behavior of the Em den solutions, the explicit h-dependence itself has originated from the radius-m ass-tem perature relation. By contrast, in present case, the radiusmasstem perature relation was derived from the non-trivial relation (23), in which no such h-dependence appears. The resultant speci c heat is thus obtained free from the residual dependence, which is a natural outcom e of the new fram ework using the norm alized q-values. Therefore, it seems likely that the new form alism provides a better characterization for non-extensive m etaequilibrium state.

In fact, for several application of the new formalism, the equation of state for non-extensive system has been found to be similar to the result from the ordinary extensive them odynam ics. For instance, the equation of state for the classical gas m odel without interaction reduces to the ideal gas sate even in the power-law nature of velocity distribution [24]. Indeed, this fact can be clearly seen in our case neglecting the gravity. Recalling that both the density and the pressure become hom ogeneous in the limit G ! 0, the equation (41) immediately reduces to the relation  $T_{phys}$  = PV, i.e., P /  $T_{phys}$ , where V denotes the volum e of the system. This result apparently seem a contradiction with the polytropic relation (19), however, it turns out that the dimensional constant K  $_{\rm n}$  im m ediately yields the relation K  $_{\rm n}$  = P =  $^{1+\;1=n}$  from the de nition (21) and thereby the polytropic relation makes no sense in the limit G ! 0. Thus, the stellar polytropic system using norm alized q-values successfully recovers the ideal gas limit, in contrast to the old results (see Appendix B in paper II). In other words, if the interaction is turned on, the equation of state for the ideal gas is no longer valid and instead the polytropic relation holds. In Sec2, the polytropic relation was derived without assuming any speci c choice of the gravitational potential. This in turn suggests that at

least in the mean-eld treatment, the polytropic relation is a common feature in presence of long-range interaction and it generally holds for non-extensive quasi-equilibrium system.

Finally, we have main when med that the stellar polytropic system can be consistently characterized as a plausible meta-equilibrium state in the new fram ework of the non-extensive therm ostatistics, as well as in the old formalism. At present, however, one cannot rigorously discriminate the correct and the applicable form alism among them (there might be another possibility that both the form alism become indeed correct depending on the situations). W hile the new fram ework by means of the norm alized q-values has theoretically desirable properties as mentioned above, the results in old form alism m ight provide an interesting connection with dynam ical instability of gaseous system, as has been suggested by Chavanis [27,28]. In paper II, the therm odynam ic instability of stellar polytropic system in the canonical ensemble case is shown to exist at the polytrope indices n > 3, which is exactly the same condition as derived from the gaseous system . On the other hand, in the new form alism, there is no such correspondence, since the instability is completely di erent from that of the gaseous system (see Sec.4.2). This means that the choice of the statistical average is crucial for the therm odynam ic properties and the physical reason for this discrepancy should be further clari ed. In any case, in order to pursue the physical reality of the non-extensive therm ostatistics, the limitation of therm odynamical approach is now apparent and the detailed kinem atical study based on the Boltzm ann or the Fokker-Planck equation provides an deep insight into the therm al transport property. In the light of this, the long-term stellar dynam ical evolution by N -body simulation also becomes useful and the analysis is now in progress. The results will be presented elsewhere.

Appendix A: Extrem um -state of T sallis entropy from the OLM method

Here, owing to the maximum T sallis entropy principle, we derive an extrem um state of the stellar quasi-equilibrium distribution by means of the OLM method. A coording to Ref.[17], with a help of the relation (8), the variational problem that extrem izes the entropy under the energy constraint becomes

A ppendix B:Stellar polytropic system characterized by Emden solutions

In this appendix, we brie y describe the equilibrium con guration of stellar polytrope in the spherically symmetric case, together with some useful form ulae which has been used in the main analysis of section 3 and 4.

First notice that the one-particle distribution function (15) does not yet com – pletely specify the equilibrium con guration, due to the presence of gravitational potential which implicitly depends on the distribution function itself. Hence, we need to specify the gravitational potential or density pro le.>From the gravitational potential (3), it reads

A fam ily of solutions satisfying (83) is referred to as the Em den solution, which is well-known in the subject of stellar structure (e.g., see Chap.IV of Ref.[21]).

To characterize the equilibrium properties of Em den solutions, it is convenient to introduce the following set of variables, referred to as hom obgy invariants [21,22]:




Fig. 1. Trajectory of Em den solutions in (;)-plane.




Fig.2. Specic heat as a function of density contrast D (=  $_c$ =  $_e$ ) for various polytrope indices.




Fig. 3. Energy-radius-m ass relation as a function of density contrast.




Fig. 4. Radius mass tem perature relation as a function of density contrast.




Fig. 5. Critical values (D  $_{\rm crit}$ ;  $_{\rm crit}$ ) for a system con ned in an adiabatic wall.




Fig. 6.C ritical values (D  $_{\rm crit};~_{\rm crit}$ ) for a system in contact with a therm albath.
