MULTIPLICATIVE STOCHASTIC MODEL OF THE TIME INTERVAL BETWEEN TRADES IN FINANCIAL MARKETS

A bstract

Stock price change in nancialm arket occurs through transactions in analogy with di usion in stochastic physical system s. The analysis of price changes in realm arkets show s that long-range correlations of price uctuations largely depend on the num ber of transactions. We introduce the multiplicative stochastic model of time interval between trades and analyze spectral density and correlations of the num ber of transactions. The model reproduces spectral properties of the realm arkets and explains the mechanism of power law distribution of trading activity. Our study provides an evidence that statistical properties of nancialm arkets are enclosed in the statistics of the time interval between trades. Multiplicative stochastic di usion may serve as a consistent model for this statistics.

1 Introduction

C om plex collective phenom ena usually are responsible for power-law swhich are universal and independent of them icroscopic details of the phenom enon. E xam ples in physics are num erous. Power-law s are intrinsic features of the econom ic and nancial data as well. The aim of this contribution is to analyze a relation between the origin of the power law distribution and the power-law correlations in nancial time series. There are num erous studies of power-law probability distributions in various econom ic system s [1, 2, 3, 4]. The time-correlations in nancial time series are studied extensively as well [5, 6, 7]. The random multiplicative process built into the model of wealth distribution yields Pareto style power law [2]. The generalized Lotka Volterra dynam ics developed by S.Solom on and P.R ichm ond is in the use for various systems including nancial markets [1]. However, these models generically lead to the non-universal exponents and do not explain the power-law correlations in nancial time series [8]. Recently we adopted the model of 1=f noise based on the Brownian motion of time interval between subsequent pulses, proposed by K aulakys and M eskauskas [9, 10, 11, 12] to model share volume traded in nancial markets [13] . The idea to transfer long time correlations into stochastic process of the time interval between trades or time series of trading activity is in consistence with the detailed studies of the empirical nancial data [5, 6] and fruitfuly reproduces spectral properties of nancial time series [13]. However, the investigation of the model revealed, that the simple additive Brownian model of time interval between trades failed to reproduce powerlaw probability density distribution (pdf) of trading activity. On the other hand, several authors showed empirically that the uctuations of various nancial tim e series possess multifractal statistics [14, 15, 16]. Therefore we introduce the stochastic multiplicative model of time interval between trades and analyze the statistical properties of the model trading activity num erically and analytically. We show the consistence of the approach with the results of statistical analyzes of the empirical nancial time series. This sheds light on the relation between the power-law probability distribution

and the power-law correlations in nancial time series.

Following our previous model [13] we consider a signal I (t) as a sequence of the random correlated pulses

where q_k is a contribution to the signal of one pulse at the tim e m om ent t_k , for example, a contribution of one transaction to nancial data. Signal (1) was introduced by K aulakys and M eskauskas for the m odelling of 1=f noise and could be used in a large variety of system s with the ow of point objects or subsequent actions. In the statistical data analysis we usually deal with the discrete time series in equal time intervals d_k . Integrating the signal I (t) in the subsequent time intervals of length d_k we get discrete time series and, in analogy with nancial time series, we call it the volume

We can de ne the num ber of trades N $_{j}$ in the time intervalt $_{j}$ (t $_{j}$ + $_{d}$) by the same form ula (2), when q_{k} 1, N $_{j}$ V $_{j}$. The power spectral density S (f $_{s}$) of the signal V $_{j}$ is de ned as

where $f_s = (s \ 1)=T$, $T = _dn$. In this paper we investigate statistical properties of the time series N_j, when the sequence of event time t_k is generated by the multiplicative stochastic process. There are some arguments for this choice of interevent time model. First of all the multiplicativity is an essential feature of the processes in econom ics [1, 2, 3, 4]. Multiplicative stochastic processes yield multifractal interm ittency and are able to produce power-law pdf. Pure multiplicative processes are not stationary and article usion restriction mechanism shave to be introduced. Let us start our analysis introducing the multiplicative process with the logarithmic di usion restriction for the large deviations of k from the mean value $\overline{k} = 1$

Here the interevent time $_k$ uctuates due to the external random perturbation by a sequence of uncorrelated normally distributed random variables $f^{\prime\prime}_{k}g$ with zero expectation and unit variance, where denotes the standard deviation of the white noise and <<1 is a damping constant. The choice to introduce multiplicative logaritm ic di usion damping $_{k}\ln_{k}$ retains symmetry in logaritm ic scale and multiplicative nature of the process for small values of \ln_{k} . Long time stationary pdf of $_{k}$ is a Lognom al distribution

W e derive the distribution (5) from the solution of the generalized Langevine equation [17]

where h (t) i = 0 and h (t) (t⁰)i = 2 (t t⁰). Note that Lognorm al distribution is invariant to the change of variables: n = 1 = 1 and in the wide range of argument values jh j < j = 1 is equivalent to the power-law

1= . Nevertheless, we have to point out that lognorm all distribution of $_k$ is not appropriate to reproduce the power-law distributions of variables in nancialm arkets. We expect that iterative stochastic model (4) producing universal lognorm all distribution will be useful for other applications. We base our model on the generic multiplicative process

as the most appropriate seeking to reproduce power-law probability density distributions of variables in nancial markets. In this paper we will use a very simple $_k$ di usion damping model assuming that 0 $_k$ 1 and 0 <

<< . M ore sophisticated damping models can be introduced in further developments of this approach. The most natural choice is to assume = 1, giving pure multiplicativity of $_k$. We decided to keep this parameter in our notation seeking to sustain generic de nition. In the k scale Eq. (7) de nes generalized Langevine equation (6) with F () = $_k^2$ and G () = $_k$. Note that the solution (6) of the generalized Langevine equation is based on the Stratanovich convention. Our numerical analysis con rm s the preference of the Stratanovich convention in comparison with Ito convention regarding discrete iterative equation (7). The stationary pdfof $_k$ de ned by iterative relation (7) can be derived from the solution (6) of the generalized Langevine equation,

where the norm alization constant $C_{(}$) can be defined from the integral R_{P_k} ()d = 1. The stationary distribution function for the number of $_0^{0}$ trades N_k in the time interval d can be derived from (8). Simple change

of variables $N~=~_d=~$ in (8) having in m ind that P_k ()d $~=~P_k$ (N)dN ~ , gives probability distribution function of N

where the time interval $_{\rm d}$ is included in norm alization constant $C_{\rm N}$. Note that variance ${\rm hN}_{\rm k}^{\ 2}i$ ${\rm hN}_{\rm k}i^2$ diverges when $2 = ^2 < +1$. We will see later that the transition from the stationary regime to the non-stationary one is essential for the appearance of 1=f power spectral density. D istribution function (9) can be transformed to the time scale taking into account that every step in the iteration equation (7) is equal to the time interval $_{\rm k}$. In the real time scale the pdf of N takes the form

Here $C_{N_{t}}$ is a new normalization constant.

3 Num erical results and discussion

W e have already introduced the multiplicative stochastic process as a model for the time interval between trades in nancial markets. This yields the power-law distribution for the number of trades per constant time interval d, equation (10). The exponent of cumulative power-law distribution for pure multiplicative model, = 1, depends only on the parameter = $2 = {}^{2}$, i.e.,




Figure 1: Power spectral density of trading activity N (N PSD) versus frequency f calculated from the model described by Eqs. (1), (2), (3) and (7) with = 1. The sinuous curves represent results of the numerical simulations smoothed with standard moving average procedure over 43 points with = 0:1 and $_{\rm d}$ = 10, while the straight lines represent power-law power spectral density S (f) 1=f with the various slopes . For = 0:012, = 1:5 (a); for = 0:01, = 1 (b) and for = 0:0075, = 0:5 (c).

Parameter de nes the ratio of damping constant to the coe cient of stochastic di usion $\frac{1}{2}$ ². In this chapter we will analyze spectral properties of the model and related autocorrelation of trading activity N. The model presented can be easily calculated num erically using equations (1), (2), (3) and (7). We smooth the power spectral density with standard moving average procedure. We present the num erically calculated power spectral density S (f) of N for = 2.4;2.0 and 1:5 on the Fig. 1. (a), (b) and (c) respectively with = 0:1 and d = 10. For the values of parameter > 2, we observe the power spectral density S (f) 1=f^{1:5}. For ' 2 we obtain S (f) 1=f and we get the slope of S (f) 1=f^{0:5} when < 2.




Figure 2: The same as in g. 1 but with parameters = 0.032 and $_d = 100$ or 200. The straight lines represent power-law power spectral density S (f) 1=f with the various slopes . For = 0.0012, = 1.5 (a); for = 0.001, = 1 (b); for = 0.0008, = 0.5 (c).

Numerical results con m that 1=f noise occurs when stochastic process dening the trading activity N $_{\rm k}$ experience the transfer from the stationary to the non-stationary regime. This general rule is probably applicable to the various m odels of the tim e intervals between pulses and is in agreem ent with the theory of self-a ne fractals, see [18]. It should be noted that transition from slope = 1.5 to = 0.5 of the power spectral density is very sharp with the change of parameters or less then twice. Calculations with di erent values of parameters con m a universal nature of the relation between the slope of the power spectral density and parameter of multiplicative di usion \cdot . This relation is independent of d in wide range of values. We present our num erical results of power spectral density for dierent sets of parameters in Fig. 2. The slopes = 1.5;1:0and0.5,of power spectral density are related with the corresponding values of parameter = 2:4;2:0and1:6, as in Fig. 1. Num erous calculations con m that the slope of power spectral density is de ned by , exhibiting sharp transition from = 1.5 to = 0.5, when ' 2.0. This transition is related with divergence of N_k variance hN_k² i hN_ki² de ned from (9).

In the previous section we derived the power-law probability distribution function of N, Eq. (10). Let us compare the exponent of cumulative




Figure 3: The exponent of power-law distribution function for N versus multiplicative di usion parameter calculated num erically from the model described by Eqs. (1), (2), (3) and (7). Points represent various realizations with the parameters = 0:05 0:1, = 0:001 0:015, $_{\rm d}$ = 10 100. Straight line represents the least square approximation to the num erical data = 0:96 + 0:97.

distribution from (10), = 1 + , with numerical results in the interval of values 1:5 3:5 related with the slope change. In Fig. 3. we present numerically calculated as a function of for various values of ; , and d. The least square linear approximation of numerical results, straight line, yields that = 0:96 + 0:97. It shows that the probability distribution function (10) derived from the generalized Langevine equation (6) describes the power-law distribution of N very well and serves as an evidence that the Stratanovich convention is appropriate for the multiplicative stochastic m odel (7). For ' 2, corresponding to = 1:, we get the value of ' 3: This is in good agreement with empirical data of power-law distribution of trading activity N in the nancial markets ' 3:4 [5].

N um erical results con m that multiplicative stochastic model of the time intervals between trades in the nancial markets is able to reproduce the main statistical properties of trading activity N : First of all, even in a very simple multiplicative di usion restriction 0 $_{\rm k}$ 1, the model reproduces the power-law distribution function with '3. The power-law exponent is related with the parameter $= 2 = ^2$, which de nes the distribution functions of time interval between trades , and of trading activity N as well as the slope of its' power spectral density S (f) 1=f. This sheds light on the origin of universal nature of the power-law distributions of such variables as trading activity in nancial markets N and its' power spectral density S (f).

4 Conclusions

W e have introduced multiplicative stochastic model of the time interval between trades in the nancialm arkets Eq. (7) with the di usion restriction in the interval 0 k 1. This de nes stochastic uctuations of trading activity N, Eq. (2), and reproduces its' power-law distribution of probability and the slope of power spectral density S(f) = 1 = f. The comparison of the empirical data from the nancial market analysis with the model proposed in plies that markets function in the area of parameters, where convergence of N_k variance disappears and 1=f noise of N occurs. This rather a sharp transition to the non-stationary regime of N_k uctuations probably is the indispensable feature of the nancialm arkets. This relates the exponent of the power-law distribution to the slope of power spectral density into universal interdependence. It in plies that the main statistical properties of the nancialm arkets have to be de ned by the uctuations of tim e interval between the trades accum u lating the power-laws and the long time correlations. Further empirical analysis of statistics and the adjusted speci cation of the model is desirable. We do expect that multiplicative model of time interval between the trades with more specic diusion restriction conditions and more precisely adjusted lies in the background of the nancial market statistics and can be very useful in nancial time series analysis.
