SO (5) superconductor in a Zeem an magnetic eld: phase diagram and therm odynam ic properties

In this paper we present calculations of the SO (5) quantum rotor theory of high-T $_{\rm c}$ superconductivity in Zeem an magnetic eld. We use the spherical approach for ve-com ponent quantum rotors in three-dimensional lattice to obtain form ulas for critical lines, free energy, entropy and speci c heat and present tem perature dependences of these quantities for dimensional magnetic eld. O ur results are in qualitative agreement with relevant experiments on high-T $_{\rm c}$ cuprates.

I. IN TRODUCTION

The SO (5) theory of high-T_c superconductivity, unifying antiferrom agnetism and superconductivity was proposed to combine SO (3) antiferrom agnetic (AF) staggered magnetization with superconducting (SC) twocomponent U(1) real paring eld into a new order param eter.¹ The sm allest sym m etry group m eeting this requirem ents is the SO (5) group. It contains SO (3) group of spin rotation and U (1) gauge group of \charge rotation"as subgroups along with additional, the so-called \ "operators rotating AF to SC state and vice versa. In the SO (5) theory ordered phases arise once SO (5) symmetry is spontaneously broken: with SO (3) symmetry breaking AF phase arises, while for U (1) symmetry breaking SC phase appears. Consequently, AF and SC order parameters are grouped in ve component vector called \superspin", which direction is related to the com petition between AF and SC states and the kinetic energy of the system is that of a SO (5) quantum rigid rotor. The low -energy dynam ics is determ ined in term s of the G oldstone modes and their interactions specied by the SO (5) sym m etry.

Although, the SO (5) theory was originally proposed

in the context of an e ective quantum non-linear model (NLQ M) description of the SO (5) rotor model its predictions were tested also within microscopic models.^{2,3,4,5,6,7} Calculations based on NLQ M showed that the features of the phase diagram deduced from the SO (5) theory agree qualitatively with the global topology of the observed phase diagrams of high-T $_{\rm c}$ superconductors.⁸ M agnetic correlation functions within the SO (5) theory were investigated showing that the theory predicts a scenario for the evolution of magnetic behaviour, which is qualitatively consistent with experiments.⁹ Furthermore, the study of the quantum critical point scenario within the concept of the SO (5) group showed that the scaling of the contribution to the electrical resistivity due to spin uctuations, displayed a linear resistivity dependence on tem perature for increasing quantum uctuations, which is a hallmark example of anom alous properties of cuprate m aterials.¹⁰ F inally, therm odynam ic properties of the SO (5) m odelwere studied, where entropy and speci c heat were calculated and

com pared with experim ental ndings.¹¹

M any experimentally observed properties of high-T_c cuprates show strong dependence on the magnetic eld, e.g. entropy, speci c heat, magnetic susceptibility, electrical resistivity, etc. Therefore, a proper theory of high-T_c superconductors must be able to explain the magnetic properties of these materials. Since, SO (5) model in the presence of nite chemical potential and a nite Zeem an magnetic eld has the exact SU (2) U (1) symmetry, the Zeem an magnetic eld can be introduced, and the SO (5) theory can be tested in any doping level.¹²

The aim of this paper is to study in uence of the Zeeman magnetic eld within the SO (5) theory. Obtained results (e.g. specic heat) can be then (qualitatively) compared with the relevant experim ents and test the basic principles of the SO (5) theory.

The outline of the rem inder of the paper is as follows. In Section II we introduce the quantum SO (5) Ham iltonian in the Zeem an magnetic eld and nd the corresponding Lagrangian of NLQ M. In Section III we establish the phase diagram of the system in an applied magnetic eld. Section IV is devoted to the study of magnetic dependence of various therm odynam ic functions: free energy, entropy and the speci c heat. Finally, in Section V we sum marize the conclusions to be drawn from our work.

II. HAM ILTON IAN AND THE EFFECTIVE LAGRANG IAN

We start from the low-energy Ham iltonian of superspins n_i placed in the discrete 3D s.c. lattice (3D SC) in the Zeem an magnetic eld B along y axis. The sites are numbered by indices i and j running from 1 to N { the totalnum ber of sites. The superspin components, labeled by and = 1;::::5 refer to AF $(n_i^{AF} = (n_2;n_3;n_4)_i)$ and SC $(n_i^{SC} = (n_1;n_5)_i)$ order parameters, respectively. The superspin components are mutually com muting variables¹ and their values are restricted by the rigid rotator constraint $n_i^2 = 1$. The SO (5) Ham iltonian

consists of three parts: the kinetic energy of the rotors (where u is an analogue of moment of inertia), intersite interaction energy (with J_{ij} being the sti ness in the charge and spin channel) and SO (5) symmetry breaking part (including the Zeem an magnetic eld acting in AF sector). The quantities $L_i = n_i p_i n_i p_i$ are generators of the Lie SO (5) algebra (related to the total charge, spin and so-called ` operators¹) and p_i are linear momenta given by:

Furtherm ore, we assume that $J_{\rm ij}~~J~(R_{\rm i}~~R_{\rm j})$ is nonvanishing for the nearest neighbours and its Fourier transform

is $sim p ly J_q = J (k)$, where

is the structure factor for the 3D s.c. lattice.¹³

The last three parts of the H am iltonian provide SO (5) symmetry breaking terms. In the result of their interplay, the system favours either the easy plane' in the SC space $(n_1;n_5)$, or an easy sphere' in the AF space $(n_2;n_3;n_4)$. Two of the three terms in uence directly AF order parameter:

where w is the anisotropy constant, B is the Zeem an magnetic eld and L_1^{24} is y component of the spin vector. Positive values of w and B favour the AF state. The remaining term acts on SC sector and contains total charge operator L_1^{15} , whose expectation value yields the doping concentration and the chemical potential (m easured from half-lling), which positive value fovours the SC state.

We express the partition function Z = Tre $^{\rm H}$ using the functional integral in the M atsubara \im aginary time" formulation 8 (0 $1{=}k_{\rm B}\,T$, with T being the tem perature). Explicitly:

with L being the Lagrangian:

The problem can be solved exactly in term s of the spherical model.¹⁴ W e note that the superspin rigidity constraint $(n_i^2 = 1)$ implies that a weaker condition also holds, namely:

Therefore, the superspin components $n_{\rm i}$ () satisfying the quantum periodic boundary condition $n_{\rm i}$ () = $n_{\rm i}$ (0) will be treated as continuous variables, i.e., 1 < $n_{\rm i}$ () < 1, but constrained on average (due to Eq. (8)). The constraint can be implemented using D irac-function (x) = $\frac{R_{+1}}{1}$ [d =2]e^{i x}, which introduces the Lagrange multiplier () adding an additional quadratic term (in $n_{\rm i}$ elds) to the Lagrangian (7). Consequently, the partition function reads:

In the therm odynam ic lim it (N $\,!\,$ 1), the method of steepest descent is exact and the saddle point () = $_0$ satis as the condition:

At the antiferrom agnetic and superconducting phase transition boundaries the corresponding order susceptibilities become in nite (see, Ref. 8), which implies for the Lagrange multipliers:

for AF and SC critical lines, respectively.

P roviding the spherical condition (8) with values of the Lagrange multipliers (12) one can nally arrive at the expression for the critical lines separating AF (or SC) and QD (quantum disordered) states:

and $_0 = {}_0^{AF} ({}_0^{SC})$ for AF (SC) line. For convenience, in order to perform momentum integration over the 3D B rillouin zone, we have introduced the density of states

Regions of AF and SC phases are separated by the rst order transition line (for $= _{c}$) given by the condition of equality of free energies of both states, which reads:

It is instructive to present the phase diagram as a function of physically measured quantity {the charge concentration x instead of the chem ical potential. In the SO (5)theory, the charge concentration can be deduced from the free energy:




FIG.1:T x B phase diagram for uJ = 3 and w = J = 1.

The tem perature-charge concentration phase diagram is depicted in Fig. 1. Here, AF to SC transition line splits into a region of constant chem ical potential, where AF and SC states coexist (mixed region M). This behaviour can be explained by a two-phase mixture with di erent densities at rst-order phase transition. In this case the system globally phase-separates in two di erent spatial regions with di erent charge densities, but the same free energy. As a result, the added charges only change the proportion of the mixture of the two phases, bun not the free energy, which im plies in nite com pressibility (de ned as dx=d).

A. Free energy

The free energy is de ned as $f = (N)^{1} \ln Z = ()^{1} (_{0})$. Using the form ula (10), it can be explicitly written:

and A (), B (), B_{+} (), D () and D_{+} () are de ned by form ulas (14).

B. Entropy

The entropy is de ned as $S = k_B \frac{2 \frac{\partial f}{\partial t}}{\partial t}$. Using the form ula (18) we obtain:

C. Specicheat

The specic heat at constant volum e is de ned:




FIG .2: Tem perature dependence of speci c heat for various m agnetic elds, for uJ = 3 and w=J = 1.

The tem perature dependence of the specic cheat in various magnetic eld is depicted in Fig. 2. For low tem – peratures C (T) is independent on B and can be approximated by C (T) T^3 . For higher tem peratures the dependence become roughly linear with higher values of C (T) for higher magnetic elds. The critical tem perature is depressed for higher elds, which is in agreement with experimental nodings. Only, the size of nite jump occurring at the critical point, seem s to be independent on B (for Y-123 jump of specic cheat in critical tem perature is absent because of ux lattice melting, see Ref. 15,16). Consequently, Zeeman magnetic eld does not in uence the value of the critical exponent = 0. In high tem peratures C (T) dependence saturates.

V. FINALREMARKS

In conclusion, we have considered the in uence of the Zeem an magnetic eld in the SO (5) theory of high-T $_{\rm c}$ superconductivity proposed by Zhang. Experimentally, in high-T $_{\rm c}$ cuprates the Zeem an magnetic eld can be realized by applying a magnetic eld parallel to ab planes. U sing non-linear quantum model and the spherical approximation we have found explicit expressions for the critical lines and various therm odynam ic functions (free energy, entropy and speci c heat). O btained results are in qualitative agreement with experimentally observed features of high-T $_{\rm c}$ cuprates. The maximum of the speci c heat is depressed and shifted tow ards low er temper-

ature in higher magnetic elds. However, it should be stressed that the case of the Zeem an eld considered in the present paper neglects the orbital e ects, which are important in high- T_c cuprates, when the magnetic eld is applied perpendicularly to ab planes.
