Relationship between dynam ical heterogeneities and stretched exponential relaxation

W e identify the dynam ical heterogeneities as an essential prerequisite for stretched exponential relaxation in dynam ically frustrated system s. This heterogeneity takes the form of ordered dom ains of nite but diverging lifetim e for particles in atom ic orm olecular system s, or spin states in m agnetic m aterials. At the onset of the dynam ical heterogeneity, the distribution of tim e intervals spent in such dom ains or traps become sstretched exponential at long time. W e rigorously show that once this is the case, the autocorrelation function of the renew al process form ed by these time intervals is also stretched exponential at long time.

I. INTRODUCTION

The stretched exponential relaxation (SER), I(t) exp[(t=)], describes the relaxation of pure glasses very accurately, often over very wide ranges [1]. For example, SER describes equally well stress experiments on am orphous Se, centered on 10³ s, as well as spin-polarized neutron scattering experiments, centered on 10⁹ s, both with the same value of , over a time range of m ore than 10¹². SER also describes accurately stress relaxation of the superconducting transition temperatures in the cuprates, probably associated with the two-gap dom ain structure revealed by high resolution scanning tunneling m icroscopy [2]; m oreover, the m easured value of is the predicted value, 3/5, for YBCO, by far the most extensively studied cuprate, with the highest quality sam ples. The agreem ent is such that it has been recently proposed that the SER be used as an independent m easure of sam ple quality in these materials [3]. Phillips' review [1] gives m any m ore exam ples and dem onstrates the power of SER as a guide to understanding the dynam ical properties of intrinsic glasses, especially network glasses. One of the m ost spectacular examples was the successful prediction [4] of the long-and short-preparation-time values of of orthoterphenyl (OTP), as measured by multidim ensional NMR.OTP is the purest organic glass form er available com m ercially; the predicted values were 0.43 and 0.60, and the observed values were 0.42 and 0.59.

It appears that SER m ay arise as a result of spatial inhom ogeneities that are quenched into m acroscopically pure, non-phase separated glasses on a m icroscopic scale as traps or sinks that appear as part of the glass-form ing process. The existence of these inhom ogeneities is dif-

cult to detect experim entally, but they readily account for SER, and predict correctly the values of beta in m any experim ents [1]. Dynam ical heterogeneities have been seen experim entally and num erically in glasses and supercooled liquids [5, 6], spin-glassm odels [7, 8], Lennard-Jones alloy m ixtures with ellipsoidal probes [9] as well as in coupled-chaotic system s such as diode-resonator arrays [10]. In particular, the concept of dynam ical heterogeneities has emerged as critical for the description of the microscopic dynamics associated with the dramatic slowing down of the relaxation and di usion processes as the temperature approaches T_g , the glass-transition temperature [11, 12, 13].

These spatial heterogeneities occur over time scales that are long with respect to the basic unit time of the systems one step in coupled maps and a lattice vibration in supercooled liquids | but shorter than the m acroscopic relaxation, where m aterials are known to be hom ogeneous. As the tem perature or the driving force is decreased, these regions becom e m ore and m ore stable and might overtake the whole sample at a transition tem perature. A lthough the nature of spatial heterogeneities and their relation to the macroscopic dynamics remains incom pletely understood, there is a considerable am ount of work that relates directly to this issue. The modecoupling theory describes the dynam ics from the liquid phase into the supercooled regime and makes quantitative predictions that have been veri ed num erically in many systems [14, 15]. It cannot yet describe accurately the very long time behavior in the supercooled regime, however [14]. Numerically, dynamical heterogeneities have been studied using a wide range of criteria tied various aspects of this feature [5, 16, 17]. Recently, however, some groups have focused on the renewal or mean rst-passage time (MFPT) [18] and the waitingtime distribution (WTD) which provide some link to the structure of the energy landscape [19, 20].

A lthough both the dynam ical heterogeneities and the stretched exponential behavior are characteristics of m any frustrated system s (e.g. supercooled liquids [21]), it is not clear what the relation between these two properties is. In this paper, we address this question and show that dynam ical heterogeneities can be directly responsible for the observation of stretched exponential relaxation in coupled m ap lattices. We also show that these results are applicable to supercooled liquids and can provide a m icroscopic basis for the stretched exponential relaxation in these system s, in line with the observations of D enny et al. on the long time dynam ics of m eta-basin hopping [20].

Recently, Hunt et al. found that the distribution of the renew altim e of a certain stochastic processm easured in a one-dim ensional lattice of coupled diode resonators could be tted to a stretched exponential function over 6 orders of m agnitude [10]. Simulations on a related m odel of di usively coupled via short range interactions nonlinear maps show that the t can be extended to more than 9 orders of m agnitude, ruling out any other power law or simple combination of pure exponentials [10, 22]. The quality of the t in this system is su cient to distinguish the region of the parameter space where the dynam ics is described by power-law distribution coupled with an exponential cut-o from the really stretched exponential distributions. (Ref. [22] contains background information important for understanding the results of the present work and will be referred to as [I] in the follow ing.)

These simulations [I] also demonstrated the importance of the system's size on its dynamics. While stretched exponentials are su ciently robust and are observed even in some small samples, the quality of such ts is much poorer than in the big samples. This is in direct analogy with real experimental results and supports the observation that the quality of the samples is crucial for obtaining unam biguous stretched exponential behavior and meaningful values of the exponent [1, 3].

U sing simulations on this and other models, as well as some analytical results, we show here that (1) the stochastic process studied in Refs. [10] and [I] can be identi ed with a renew alprocess [23], (2) a stretched exponential distribution of the renew altime im plies a sim ilar shape for the decay of the two-point auto-correlation function, and (3) renew alprocesses are present in a supercooled liquid and play a central role in its dynam ics.

G ranted the universal features of SER, readers unfam iliar with chaos theory and coupled m aps m ay not see im m ediately the relevance of these m athem atical tools to understanding the dynam ical properties of supercooled liquids and glasses. E ven the successful predictions of the trap (sink) model [1, 24] appear to be unexpected. For instance, the survival probability of a random walker in the presence of random ly distributed static traps crosses over from exponential to SER only at longer times where very few (10³⁰ for 10% traps) of the walkers have survived [25]. In our examples of steady-state dynamics in coupled maps, the analogous crossover in trap-time distributions (t) occurs near 10 1 to 10 2 maxf (t)g depending on the value of a control parameter. Even the latter number is small compared to the crossovers observed, for example, for relaxation of the st peak in the structure factor in molecular dynamics simulations (MDS) of crystallization-avoiding soft sphere mixtures [26], which occur near 3/4 of the maximum value. The reason for these di erences is that the system s chosen for MDS already represent prepared states with strong glass-forming tendencies. The random walker with random traps model contains spatial inhom ogeneities, which we will show represent an essential feature necessary for

SER, and which are absent from some popular models of static glass structure such as mode-coupling theory [27]. That model does not contain the collapse of phase space that occurs as the liquid is supercooled to the glass transition, and that is why SER appears only at very long times. However, it does contain the correct dimensional dependence of di usive behaviour that leads to the relation = d = (d + 2), which is in portant for comparisons to experiment. That the one-dimensional coupled map lattice discussed here reaches a steady-state much more rapidly than the random walker is a clear indication that this model is physically relevant. The way in which this happens was illustrated in Fig. 8 of [I]: the surviving periodic domains are those that have avoided chaotic regions.

We also emphasize that in this simple model, the behavior of the stretching exponent as a function of a control parameter r is similar to the dependence of on the temperature in both 3D [28] and 1D [8] spin-glass models. This similarity not only captures the qualitative tendency for to decrease with decreasing r (or T), but also the quantitative agreement in the low -r (or T) limit

1=3. The same lowest value of was obtained in studies of random walks on fractals [29, 30, 31].

II. RESULTS

A. Properties of the coupled m ap m odel

The nonlinear model of Ref. [10], used to reproduce qualitatively the experimental system, is a onedimensional chain of N di usively coupled nonlinear determ inistic maps, f(x), with a coupling constant and periodic boundary conditions. The time evolution of this system is discrete and is described by the following iterative equation,

which, given initial conditions x_n (0) for each site n = 1;2;:::;N, generates a time series fx_n (t)g. The interaction is totalistic and involves only the nearest neighbors. Following [I], in this study we use the logistic map f(x) = rx(1 - x).

Following the analysis of the experimental data, the stochastic process of interest is represented by a coarsegrained variable de ned as

where the quantity x_n (t) is defined in Eq. (1) and x_{thr} is a certain threshold value. The basic dynam ics of the coupled oscillators being period two, the analysis is also done over even (or odd) time steps.

This model shows a stretched exponential distribution of the renewal (or trap) times, which are de ned in the next section IIB, over a wide range of the control param eter r, which plays a role akin to temperature as

can be seen in Fig. 1. This gure shows the stretching exponent $_0$ and the time scale $_0$ as a function of the control parameter r. The values of $_0$ and $_0$ were obtained by least-square thing the long-time part of the trap-time distributions for a chain of N = 10;000 coupled logistic maps f(x) = rx(1 x) with the expression A exp[(t= $_0$) °]. Although $_0$ (r) and $_0$ (r) are nonm onotonic, the overall behavior is similar to the results in both 3D [28] and 1D [8] spin-glassm odels. This broad similarity not only captures the qualitative tendency for to decrease with decreasing r (or T), but also the quantitative agreem ent in the low-r (or T) limit 1=3; the same limit as that obtained in studies of random walks on fractals [29, 30, 31].

A lthough the bifurcation diagram for a site in the coupled map lattice (Fig. 1(d)) appears to be uniform with respect to r down to r 3:8275, the non-m onotonicity of $_{0}(\mathbf{r})$ and $_{0}(\mathbf{r})$ most probably arises from the fact that for the isolated logistic m ap and the values of r < 4chaotic orbits are interspersed with period cascades seen in Fig. 1 (c), i.e. the approach to full chaos as r goes to 4 is not uniform. (For an explanation of the concept of bifurcation diagram s see e.g. R ef. [32].) Interestingly, the lowest value of $_0$ is attained within the widest window of the period-three cascade in the bifurcation diagram of the uncoupled logistic map. About and below r = 3.82, in the coupled map chain, very narrow chaotic windows are also interspersed with periodic ones and the stretched exponential behavior of the trap-time distribution, with $_0$ greater or about 1/3, is recovered only for som e values of r. This interesting behavior suggests that SER is uncovering a new aspect of the dynam ics of coupled m ap lattices. A full analysis of this new behavior lies outside the framework of this paper, but we plan to return to studying it elsewhere.

In other models and experiments, the time scale monotonically grows with decreasing temperature. It is not the case here, although the values of $_0$ are greatest at the low -r (and low - $_0$) end, following the general trend observed elsewhere.

B. Renew alprocesses in coupled m aps

The stochastic process $_n$ (t) is a renewal process [23] provided that the tim e intervals (renewal tim es) between two subsequent zero crossings are statistically independent random variables. We tested the independence of these time intervals for the present model, Eq. (2), by calculating the distributions of the time intervals following time intervals of a specified length. The distributions were identical regardless of the length of the preceding time intervals.

In general, a renewal process is de ned so that (t) = +1 for $t_0 < t t_1$, (t) = 1 for $t_1 < t t_2$, (t) = +1 for $t_2 < t t_3$, and so on. The renew alprocesses are the simplest possible stochastic processes readily susceptible of probability theoretical analysis [33]. The dynamics represented by such processes can be understood in term s of transition probabilities between the two possible states = 1 [34].

In [I], it is shown that the existence of very long renew al time intervals t_{n+1} t_n associated with the stretched exponential distribution can be attributed to the presence of time-limited ordered domains (or traps) with dom inant spatial period of 4 sites. Fig. 2 (a) shows a typical distribution of the renewaltime intervals (or trap times) for this model.

These results suggest that the dynam ical heterogeneity manifested by the presence of time-limited ordered domains could be at the origin of the stretched exponential relaxation in supercooled liquids and glasses and the renewal processes could provide a simple picture for describing heterogeneous dynam ics in these condensed phases. In order to support these two a mations, we rst need to show that (1) there is a one to one correspondence between renew alprocesses and their tim e auto-correlation functions, because experim entally m easurable relaxation responses are m athem atically described by auto-correlation functions of certain dynam icalvariables and not directly by non-observable renew al processes, and that (2) the renew alprocesses are present in supercooled liquids and glasses and can be calculated e ectively, exhibiting unam biguous stretched exponential distributions of renew altim e intervals.

The relation between the auto-correlation function

of a renewal process (t) and the distribution (t) of time intervals t_{n+1} t_n between the zero crossings (or, in other words, renewals) of this process was recently studied for a range of distributions [23]. Following this approach, G odreche and Luck also showed [35] that C (t) corresponding to the stretched exponential distribution

We can Laplace transform the distribution of intervals (t), obtaining a function with a small singular part, $^{(u)} = 1$ htiu + $\pm_{ing}(u)$, u ! 0 [36], where hti = $_0$ (2= $_0$)= (1= $_0$), is the rst moment of (t). A lso from Ref. [23], we know that the Laplace transform of the auto-correlation function is given by

T his in plies that for a stretched exponential (t) in the asymptotic lim it C_{eq} (t) / (t) [35].

The range of relevance for this analytical result can be con m ed num erically by studying the statistical properties of a computer-generated sequence of (pseudo) random numbers distribution according to the stretched exponential probability density function (pdf) Eq. (4). U sing the fundam ental transformation law of probabilities [37], given a computer-generated sequence of (pseudo) random numbers f g distributed uniform ly in the interval 0 1, we apply a transformation nule $t = {}_0 [2 {}^1 (1 = {}_0;)]^{1=0}$ so that the resulting sequence ftg is distributed according to the stretched exponential pdf (t). In order to compute the inverse regularized incom plete gam m a function $2 {}^1$ (a;), we used the software from R efs. [38, 39].

G iven a sequence of tim e intervals distributed according to a prescribed pdf, it is straightforw and to construct the corresponding renew alprocess and its autocorrelation function and second derivative. The second derivative is calculated num erically, after applying a sm oothing function before each derivative to im prove the quality of the operation.

The resulting C^{∞}(t) and C (t), shown in Figs. 2 and 3 respectively, demonstrate clearly that the correspondence between (t) and C^{∞}(t) holds for long times for C (t) calculated both for the coupled map lattice model, Eq. (1) with f(x) = rx(1 x), r = 3:83, = 0:25 and N = 1000, and for a renew al process where the renew al time-interval distribution is stretched exponential by prescription. C^{∞}(t) obtained numerically agrees with (t)=hti, Eq. (8), without any free parameter within a

multiplicative factor of the order of unity.

Interestingly, for the range m easured, C (t) also follows the stretched exponential form, albeit with somewhat di erent parameters $_{\rm c}$ and $_{\rm c}$. This indicates that the true asymptotic regime for C (t) or (t) m ay be reached at longer time with a gradual approach towards this long time behavior. This agrees with the theories (see e.g. [24]) where the stretched exponential functions are

accompanied by time-dependent multiplicative factors. For practical purposes, however, it is remarkable that the stretched exponential t to the correlation function agrees with C (t) starting with a well-observed experimentally value between 3/4 and 1/2 maxfC (t)g and follows with very high accuracy for several orders of magnitude to the regime beyond the reach of the experiments.

C. M olecular dynam ics

Having established the correspondence between the distribution of time intervals of renewal processes and their auto-correlation functions, we now show that a renew al process can also be identi ed in a supercooled liquid and it appears to provide a simple and elegant description for the stretched exponential relaxation. In order to do so, we have performed molecular dynam ics simulations of a 16000-particle single-com ponent system where the interactions between the particles are described by a pair potential labeled Z2 in Ref. [40]. This potential is similar to that introduced initially by D zugutov [41] but provides a longer-lived m etastable supercooled state prior to crystallization. O there ise the properties of the Z2 liquid are similar to those of the D zugutov liquid, in particular it exhibits dynam ical heterogeneities form ed by short-lived clusters com posed of connected icosahedra [42]. The simulations are perform ed at T = 0.68, below the melting temperature of $T_m = 0.70$ 0.05 with a time step of 0.01 in reduced Lennard-Jones units [43]. W e take m easurem ent over the 16 000 atom s with the number density = 0.85 for 7 million time steps, stopping before the system starts crystallizing. This simulation time would correspond to a 150-ns simulation for argon.

A renewal process representing the atom ic dynam ics in the liquid can be constructed so that each renewal time interval correspond to the time a particle spends in a dynam ical trap. This is identical to the rst passage time, in the parlance of A llegrini et al. [18], but diers form ally from the waiting time of Doliwa and Heuer [19] and Denny et al. [20] which focuses on hops between energy basins. We say that particle i is trapped as long as its displacement

m easured starting from an arbitrary initial position $r_i(0)$ remains less than a certain threshold value d_{thr} . The moment $t = t_{thr}$ of surpassing the threshold is counted as a renewal and the value of $r_i(0)$ is reset to $r_i(t_{thr})$ as well as the time origin for the next trap.

The corresponding trap-time distribution (see Fig. 4) is not particularly sensitive to the choice of d_{thr} as long as it is of the order of the elective atom ic diameter. For de nitiveness, we choose $d_{thr} = 2 = Q_0 = 0.88$ [43], where Q_0 is the position of the main peak in the static structure factor S (Q) and neglect the temperature dependence of this length scale. A threshold of 0.88 is about 4 times

larger than the critical value estim ated by A llegriniet al. in a binary Lennard-Jones system . W hile the focus of Ref. [18] is on the inertial regime, which takes place as small distance, on the order of 0.1 atom ic radius, we are interested in the atom ic displacem ent leading to a change in the con guration. Figure 4 (a) also shows in inset that the trap-time distribution is exponential at the tem perature well above the melting point $(T_m = 0.70)$ 0:05) and its long-time tail well agrees with a stretched exponential twith ₀ 0:71 in the supercooled regime. In order to be considered as a fully M arkovian process, we also assess the correlation between subsequent trapping time intervals, as was done for the coupled map lattice. C om paring trap distributions considering only the subset of events following traps of various length, again, we nd no correlation between renewaltime intervals. The value of $_0$ agrees well with = 0:70 0:05 for the self part of the interm ediate scattering function $F_s(Q_0;t)$ calculated at the same temperature and for the same length scale. (For the de nition of F_s (Q;t) see, e.g., Ref. [44].) F_{s} (Q₀;t) for the Z2 liquid behaves similarly to the same quantity calculated for the supercooled D zugutov liquid [45] and is not shown here.

These results appear at odds with the analysis of A legrini et al. who report a power-law distribution for the long-time tail of the renewal time [18], although admitting that the asymptotic cuto in the distributions is di cult to resolve num erically. Fig. 4(b) shows our simulation results at T = 0.68 plotted on a log-log scale with a tentative tof the long-time behavior. It is clear that the stretched exponential provides a much better t to the simulation data. This di erence between the two simulations can be due to both a physical range of param eters and the precision of the simulation. First, A 1legriniand collaborators focus on the inertial length-scale while the results presented here require atom ic di usion, not only therm alvibrations; second, focusing on a single tem perature, our simulation uses a larger cell and averages over a tim e scale roughly 6 tim es longer.

Denny et al. [20] also note that the distribution in Ref. [18] may not be a power law. A lthough the waiting time distribution in Ref. [20] diers form ally from that is studied here, at long time they can be comparable since the escape of a particle from a sphere of radius of the order of the atom ic diam eter is likely to correspond to the transition of the phase point in the con guration space between energy m etabasins. We note how ever, that the log-norm alform of the waiting time distribution proposed by Denny et al. results in a correlation function that can only be approximated with SER, whereas the stretched exponential rst passage-time distribution results in a correlation function that is also stretched exponential at long time.

III. CONCLUSION AND DISCUSSION

A swas shown in [I], traps in coupled m ap lattices correspond to ordered short-lived dom ains. In direct analogy, it is natural to expect that the trap condition $d_i(t) < d_{thr}$, for $d_i(t)$ from Eq. (9), is satistical as long as particle i is literally trapped within a relatively stable environment - a \cage". Thus formed renewal process and the associated trap-time distribution and the autocorrelation function provide a simpler description of the structural relaxation in a condensed matter system than, e.g., the cage correlation function [46] recently used to demonstrate the stretched exponential relaxation in a Lennard-Jones m assively defective crystal.

In particular, traps in the coupled map lattice show only very short spatial extension that does not seem to diverge as the overall dynam ics of the system slows down. As $_0$ goes from 0:6 > $_0$ > 0:5 to 0:4 > $_0$ > 0:3, the longer traps go from about 120 to more than 30,000 time steps but the characteristic time-averaged width of these traps only quadruple, from 2 to 8 sites [I]. These observations are consistent with the behavior of dynam ical heterogeneities observed in a number of model system s [7, 8, 16, 42].

We note that the only model that rigorously derives the stretched exponential long time asymptotic behavior is that of a random walker in a system with static traps (see e.g. Ref. [1]). Ref. [24] cites both upper [47] and lower [48] bounds for the asymptotic behavior of the survival probability. Both bounds have the same , but di erent . It is not obvious, how ever, that the above theory directly applies to the results of this works. N evertheless, our results are obtained in terms of rst passage statistical distributions of the type encountered in the static-trap m odel and the use of sim ilar m athem atical techniques m ay shed m ore light on the nature of the dynam ics in the m odels presented here.

In conclusion, we focused on a relation between dynam ical heterogeneities and stretched exponential relaxation in two models: a coupled chaotic oscillator system and a supercooled liquid. W ithout insisting that the former model represents the actual behavior of real liquids, we have shown that the asymptotic long time behavior of the autocorrelation function of a renew alprocess is stretched exponential provided that the distribution of the renew al time intervals (t) is also stretched exponential at long time, i.e. (t) exp[(t= $_0$) °]. Using this relation, we have demonstrated that, at least in the two model systems considered here, the relaxation dynam ics can be described in terms of well-de ned dynam ical traps, providing useful insight regarding the absence of a diverging static length scale at the glass transition.
