Giant Clusters in Random Ad Hoc Networks

The present paper introduces ad hoc communication networks as examples of large scale real networks that can be prospected by statistical means. A description of giant cluster formation based on the single parameter of node neighbor numbers is given along with the discussion of some asymptotic aspects of the giant cluster sizes.

I. IN TRODUCTION

N ow adays, natural and designed networks are in the focus of research in di erent scienti c disciplines. Using computers the am ount of available empirical data on real world networks has been increased during the past few years. Examples of real networks include the W orld W ide W eb [1, 2], the Internet [3, 4, 5, 6, 7], collaboration networks of m ovie actors and scientists [8, 9, 10], power grids [11, 12] and the m etabolic network of living organism s [13, 14, 15, 16].

R andom graphs are natural candidates for the description of the topology of such large system s of sim ilar units. In [17, 18, 19] the authors have developed a model { which assumes each pair of the graph's vertices to be connected with equal and independent probabilities { that treats a network as an assembly of equivalent units.

This model, introduced by the mathematicians Erdøs and Renyi, has been much investigated in the mathematical literature [20, 21]. How ever, the increasing availability of large maps of real-life networks has indicated that the latter structures are fundamentally correlated systems, and in many respects their topologies deviate from the uncorrelated random graph model.

Two classes of models, commonly called the smallworld graphs[11, 12, 22] and the scale-free networks[23,




FIG.1: Nodes and connections of an exam ple ad hoc network. The transm ission range is the same for all nodes { it is noted by the dotted circle for two of the nodes. The shortest path between the s source and d destination users touches 3 interm ediate nodes, and there is an alternative route of 6 hops, which has no common interm ediate nodes with the rst.

24] have been developed to capture the clustering and the power law degree distribution present in real networks[1, 3, 8, 9, 10, 11, 12, 13, 23, 24, 25, 26, 27, 28, 29].

Here we present ad hoc networks [30] as new examples of real structures that can be investigated using the above network models. Ad hoc networks arise in next generations of communication systems and hereby we try to sum marize the principal characteristics of such system s. In the ad hoc scheme users communicate by means of short range radio devices, which means that every device can connect to those devices that are positioned no farther than a nite maximum geometrical range. We call this range the given device's transmission range and the exact value of this range may depend on the transmitter's power and various other physical parameters. See Fig. 1 for an example ad hoc network topology. Neighbor nodes talk the way ordinary radios { like CBs { do, how ever communication between non-neighboring users is also possible. The latter case is accomplished by sending the information from the source user to the destination hop by hop, through interm ediate nodes. If the density of users in the area is high compared to their transm ission ranges, it is highly possible that more than one alternative route exists between two users. This last feature can be exploited in the case if the shortest route is overloaded or broken, or if the system allows splitting the information ow into separate parallel ows. Moreover, the users are free to move random ly and organize them selves arbitrarily; thus, the network's topology may change rapidly and unpredictably. Such a network may operate in a stand-alone fashion, or m ay be connected to the Internet.

G iant clusters in ad hoc networks are made interesting because a communication network provides a meaningful service only if it integrates as many users as possible within the covered area (e.g., 99% may be considered a good coverage). In this paper we introduce a fractal model, that duplicates the giant component form ation in ad hoc networks in an area inlaid with obstacles, partially screening radio transmission. Our main result is that in such networks the giant component size can be described by a single parameter: the average number of neighbors a node has. The rest of this paper is structured as follows. Section II gives a detailed description of our random ad hoc network model. In Sections III and IV we delve into the topology di erences between

random graphs and graphs built using our model. Section V shows the num erical simulation results supporting these analyses.

II. THE RANDOM AD HOC NETWORK MODEL

A wireless ad hoc network consists of a num ber of radio devices, also referred to as "nodes" in the following. Every node may be connected to one ormore other nodes in her vicinity; the actual set of connections depends on the distance of the nodes. In a static environment these connections de ne the topology of the system; if the nodes allowed to move then the topology may change, how ever at any given point of time there is still a well de ned topology available.

To be precise we de ne a random ad hoc network as a set of uniform ly distributed nodes on the arena of the unit Euclidean square [0;1] [0;1] with connections between pairs of them. The connections are two-way in the sense that if node A can communicate to node B, then node B is also able to communicate to node A.

Two nodes are connected if the geom etrical distance of the two is less than a certain value r_t , that is the nodes can communicate up to their "transmission range". We represent a realization of such a system using an undirected graph G (V;E), where the vertices and the edges denote the nodes and the two-way connections respectively. Sometimes a graph resulting this way is referred to as a geometric random graph or GRG. Note that there are no loops and nomultiple edges in G: a) a node should not communicate to itself; and b) if two nodes are neighbors, then technically there is no sense to open a second communication channel between them.

Furtherm ore, all the length param eters in the system are made dimensionless as follows. Length is measured as the multiples of the unit radius r_0 , which is in turn de ned by the share of the whole area for each node:

$$r_0 \coloneqq \frac{1}{N} \tag{1}$$

where A is the size of the arena. The ratio of the transm ission range and the unit radius is called the norm alized transm ission range and noted by:

$$r_n \coloneqq \frac{r_t}{r_0}$$

As mentioned in the Introduction, a communication network may deliver meaningful service only if the network is connected, or at least has a vast subset that is connected. Our work is focused on exam ining the criteria for giant cluster form ation and in particular in networks with fractal connectivity properties.

In the following we give a short overview of networks on random graphs and afterwards we turn to our model of fractal ad hoc connectivity.

III. CONNECTIVITY IN RANDOM NETWORKS

A fler distributing and connecting the nodes as described previously, the largest connected component of G can be determined. Let S be this components' size fraction:

$$S = \frac{\text{nodes in the largest component}}{N}$$

which quantity is obtained by counting. This quantity is of particular importance because the network gets fully connected if S diverges and for this end we are to investigate its relationship with other network parameters.

In [31] the authors present the theory of random graphs [18] of arbitrary degree distribution. Am ong others, an exact result for the component sizes is given, which we shall cite here. It is shown, that the average component size diverges if

holds, where p_k is the degree distribution of vertices in G. Let us use here the actual distribution of our ad hoc network: it is easily seen that the probability distribution of the number of nodes contained in any disc with radius r_n is the Poisson-distribution with expectation value of r_n^2 . It means that

$$p_{k} = \frac{r_{n}^{2}}{k!} e^{r_{n}^{2}}$$

is the probability that a vertex will have k 1 neighbors (the 1 is because the node itself does not count for a neighbor). Applying the result in [31], one can derive the relationship of the size of the giant component S and the transm ission range:

$$r_n^2 = \frac{\log(1 - S)}{S}$$

It shall be noted here that while (4) holds for random networks and { as it is to be shown in Section V { for fractalad hoc networks, the r_n S relationship is di erent for the nite range ad hoc case, how ever, the latter is to be discussed in a separate paper.

IV . THE FRACTAL AD HOC NEIGHBORSH IP $\label{eq:linear} A \mbox{ LG OR IT H } M$

The results of the previous section apply for scenarios where the arena is " at": that is the only lim it to build a connection between two nodes is their geom etrical distance. In the present section we introduce the idea of generalized obstacles that can screen nodes from each other even if they are positioned within transm ission range. This change produces graphs with extended




FIG.2: Giant component sizes for various values of N and . Note that S(N) reaches 1 for 6 2, yet $\lim_{N \ge 1} S(N;) = S_{m ax}() < 1$ for > 2.

spatial structure which is why we call the algorithm fractal.

The obstacles are adopted by changing the algorithm for edge generation. Now two nodes within the transm ission range will be connected with a probability which is given as the function of their geometrical distance. For every two nodes $u;v \ge V$ let p(dist(u;v)) be the probability that an edge $e_{uv} \ge E$ connecting them is set up. For the description of our obstacles we use a long tailed probability function which is in plied by the picture of a hilly landscape, where the possibility of connections drops with the increasing geom etrical distance between the nodes, how ever long range connections are still possible:

$$p(\mathbf{r}) = \frac{a}{1 + \frac{r}{r_0}}$$

with parameter values a > 0 and > 0.

Performing computer simulations of networks connected according to (5), one obtains di erent results, as

changes. On Fig. 2 we compared the resulting giant cluster sizes for di erent values. At lower parameter values S(N) saturates to S = 1 { all nodes become elements of the giant cluster above a certain nite node number. For = 2.5 and above S still converges to a nite value, however the limit now is strictly less than 1. It means that networks with such parameter values will not become fully connected even at large node numbers, moreover, the proportion of the largest connected subgraphs drops with worse than linearly. In the rest of this Section we try to interpret this dual behavior of S().

It is easy to imagine that the more connections the nodes have in average, the larger the giant cluster grows. M ore accurately we state that the average vertex degree hC i determ ines the cardinality of the largest connected subgraph in G.C learly, if hC i = 0, then every connected component contains a single node, and in the N ! 1 lim it S becomes 0. A lso, if hC i diverges or even if only a single node is connected to all the others, the graph obviously gets fully connected. B ased on these considerations we are to exam ine hC i in detail.

Vertex degree in G can be calculated by xing a single node and totaling the hC_ri expectation value of the number of neighbors that reside exactly at the distance r away from the xed one. A ssum ing that the density of nodes is constant (N = A), hC_ri can be expressed by multiplying the average number of nodes in distance r and the probability (5):

$$hC_r i = \frac{2r}{A} N p(r)$$

Now if = N = A, the average vertex degree is

$$hC i = hC_r i dr = p(r)2 r dr$$

where A represents the physical boundaries of the arena. As there are no nodes outside this region, thus the integral shall be 0 outside A.

In general solving (6) yields

$$r 1 + \frac{r}{r_0}^{1} \frac{r_0}{2} 1 + \frac{r}{r_0}^{2} (7)$$

However the expectation value of hC i is dependent on the value of . Accordingly, our discussion is separated into several cases.

a > 2. In this case (7) can be evaluated for A being the interval r 2 [0;1) in the lim it where $r_0 ! 0$:

Concerning the r-dependence in $[:::]_{A}$ we can assume that there is a maximal transmission range $r_{m ax}$ such that for transmission ranges $r > r_{m ax}$ the contribution of the integrand in (6) is negligible. This way the $[:::]_{A}$ part of (9) can be estimated as

Now if $r_0 ! 0$ (which happens to be the case at su ciently large node numbers) the rst term in (10) vanishes and the + 1 becom es negligible in the denom inator of the second term . A fiter substituting this second term and simplifying the expression, (7) nally becom es

The N-dependence of hC i can be derived from here by substituting de nition (1), $\overline{} = N = A$ and the fact that $r_{m \ ax}^2$ / A. By these means the above expression yields:

To sum marize, if > 2, then a nite neighbor count is expected, and thus such networks are not going to be fully connected (see again Fig. 2). On the other hand, if

< 2, then hC i diverges exponentially with increasing node numbers, which in theory leads to fully connected networks at large N , and m eans, that the m ore nodes are in the system , the larger the fraction of connected nodes is to become.

V. SIM ULATION RESULTS

We carried out computer sinulations to illustrate our ndings, especially Eqs. (8) and (11). During a sinulation run we rest pick the random coordinates for the N nodes. Second the probability p is calculated according to (5), using the input parameters a, and r. Then for every two nodes a uniform random number 2 [0;1] is generated and compared to p: for cases r_n^2.




FIG. 3: Simulations of ad hoc networks using the fractal neighborship algorithm with parameter values both < 2 and > 2 yield the same giant cluster size vs. average vertex degree as random graphs. Inset displays the same plots with log(1 S)=S as the abscissa.

As the rst test we recorded the giant cluster size vs. transm ission range relationship. Data points were obtained by repeated runs, changing only the amplitude param eter a of (5) in an appropriate interval (e.g., a 2 [1;9] for the = 2:5 case). Fig. 3 illustrates that in a network connected using the fractal neighborship algorithm




FIG. 4: A verage vertex degree of ad hoc graphs for > 2. D ata points were acquired using a = 0.8, = 5.6; the dashed line yields the analytical result hC i = 3.03, which shall hold in the N ! 1 limit.

the observable S hC i relationship m atches the equivalent analytical result for random graphs for both relevant cases a and c in Section IV.

On the other hand, the behavior of hC i turns out to be sensible to the value of , as it was expected. Let us start with the case > 2. Fig. 4 presents the simulation results for networks connected as by (5), using a = 0.8 and = 5.6. A coording to (8), the average vertex degree is expected to be

$$hCi = \frac{2 5.6}{4.6 3.6}, 3.03$$

in this case. It is clearly seen on the Figure that increas-




FIG.5:D ivergence of average vertex degrees with N for $\,<\,$ 2. Crosses: data points for a = 0:1, = 1:56; dashed line is / N 1 $^{=2}$ = N $^{0:22}$. Inset displays the same plot with both axes logarithm ic.

ing N , the simulation output converges to the analytical result.

Now let us turn to the 0 < < 2 case. On Fig. 5 the data obtained for a = 0.1 and = 1.56 is shown along with a numeric function t according to (11):

hC (N)

(the parameters turn out to be c_0 = 0:74 and c_1 = 1:38). The simulations agree with the N $^1~$ =2 diver-

gence well, as calculated in Section IV .

Figs. 4 and 5 now illustrate the di ering S-behavior presented on Fig. 2, as a data set for = 5.6 would converge to some connectivity < 20% even at very large N, while the one for = 1.56 is clearly reaching S = 1 for node num bers in the magnitude of several thousands.

VI. CONCLUSIONS

In the present paper we have investigated the connected components that are produced in random ad hoc networks. Based on the results, the number of nodes needed for a given connectivity ratio can be estimated. Thus our results may hint about the usefulness of random fractal ad hoc networks.

W e m odi ed the conventional connection function and m ade long range connections possible. This way the producing networks become extended in their spatial structure, as thought the network is situated in an area with obstacles screening some of the transm issions. We have found that a single parameter { the average neighbor count hC i { can characterize the proportion of the largest connected subnetwork. We have also seen that depending on the connection function parameters, this proportion can be either bounded or unbounded as the system size N is increased. For both cases hC (N) i was derived analytically and con med by simulations.
