Goldstone mode kink-solitons in double layer quantum Hall system s

It is shown that in charge unbalanced double layer quantum Hall system with zero tunneling pseudospin G oldstone mode excitations form moving kink-soliton in weakly nonlinear limit. This charge-density localization moves with a velocity of gapless linear spin-wavem ode and could be easily observed experimentally. We claim that mentioned G oldstone mode kink-solitons de nedi usionless charge transport properties in double layer quantum Hall system s.




FIG.1: Conditions for appearance of linear (upper graph) and nonlinear (lower panel) pseudospin Goldstone mode excitations. In unbalanced situation when the lling factors are di erent from each other the nonlinear solution could be detected as counter propagating inhom ogeneous currents through the layers.

The recent observation [1] of split-o peaks of tunneling conductance versus in-plane magnetic eld in double layer quantum Hall system s with total Landau level

lling factor = 1 have been naturally interpreted as "footsteps" of linearly dispersing pseudospin Goldstone mode [2]. Thus the correctness and e ciency of eldtheoretical approach according which the quantum Hall double layer system could be described as easy-plane type (pseudo) ferrom agnet $[\beta]$ was indirectly con m ed. The Goldstone mode appears in system swith continuous sym m etries as a result of spontaneous sym m etry breaking which in presence of nonlinearity leads to the appearance ofGoldstonem ode kink-solitons [4]. The present paper is devoted to the investigation of dynam ical nonlinear properties of the mentioned Goldstone mode in quantum Hall (pseudo) ferrom agnets Particularly, the existence of moving localized solutions is predicted. As it is mentioned below such localizations could be detected experim entally via observing counter propagating inhom ogeneous currents through the layers (see Fig. 1).

The phenom elogical model for isolated double layer quantum Hall (pseudo) ferrom agnet in the absence of tunneling is e ectively described by the following Ham iltonian [3]:

where n (x;t) is an order parameter unit vector, particularly, n_z (x;t) has a meaning of local charge in balance between the layers $n_z = 1$ where 1 and 2 are lling factors for top and bottom layers, respectively (thus in fully balanced situation 1 = 2 = 1=2); A and E are out of plane and in-plane pseudospin sti nesses and gives a hard axis anisotropy.

The time-space behavior of ordering vector could be described in terms of Landau-Lifshitz equation:

where H_{eff} is the e ective (pseudo)m agnetic eld. Then from (2) one can write down the motion equations ex-

The set of equations (3) perm its the uniform solution in the form :

P reparing initially the sample with a given charge im – balance $n_z^0 = {0 \atop 1} {0 \atop 2}$ this quantity will stay unchanged for in nitely long time period as far as the isolated double layer system s are considered and tunneling does not exist.

Let us seek for the solution of (3) as a perturbation of uniform solution (4):

A coording to the general approach [5] we present m (x;t) in the form of multiple scale expansion:

where and are the slow space-time variables, v is a propagation velocity of nonlinear wave and " is a form all sm allparam eter indicating the sm allness or "slow ness" of the variable before which it appears. Considering weakly nonlinear limit (perturbative solution) we have a follow-ing restriction (m)² 1.

Building the perturbative solution we substitute Exps. (5) and (6) into the motion equation (3) collecting the terms of the same order over ". Using the general approach [5] we nally come to the Korteweg - deVries equation with a well-known one solution solution:

and v is a propagation velocity of the kink-soliton coinciding with the velocity of linear Goldstone mode $v = n_2^{0} \frac{P}{8} \frac{1}{E}$ (see e.g. Ref. [3]).

A sit is seen from Eqs. (7) and (8) this localized object has a kink like form in pseudospin xy plane while it is an ordinary moving soliton considering the z component in the pseudospin space. From the same expressions we also see that in fully balanced case n_z^0 ! 0 the kink-soliton solution disappears – its localization width and excitation amplitude go to in nity and zero, respectively. Thus we can conclude that for balanced situation and nonzero distance between the layers the linearized G oldstone mode is an exact solution even in the nonlinear limit while in unbalanced state $n_z^0 = \int_1^0 \int_2^0 \mathbf{6} \ 0$ only excitations in the system are G oldstone mode kink-solitons (see Fig. 1).

Considered kink-solitons are moving charged localizations and therefore could be detected experimentally. Indeed, any perturbation of unbalanced double layer system will induce counterpropagating inhom ogeneous electric current through the layers. We can also take into account the dissipation e ects adding to the Landau-Lifshitz equation (2) a damping term. This will cause decreasing (in time) of amplitude of kink-soliton with its simultaneous widening like it happens in case of magnetization solitons in magnetic thin Ims [6].
