A nisotropic dissipation of super uid ow in a periodically-dressed Bose-E instein condensate

A bstract. The introduction of a steady-state spatially-periodic R am an coupling between two components of an ultracold atom ic gas produces a dressed-state gas with an anisotropic and tunable dispersion relation. A Bose-E instein condensate form ed in such a gas is consequently characterized by an anisotropic super uid critical velocity. The anisotropic dissipation of super uid ow is quanti ed by considering the scattering of impurities owing through this super uid. A gradual transition from the isotropic nature of an uncoupled Bose-E instein condensate to the anisotropic periodically-dressed condensate is obtained as the strength of the R am an coupling is varied. These results present a clear signature for future experiem ental realizations of this novel super uid.

The experimental attainment of quantum degenerate dilute gases, composed of both bosonic and fermionic atoms, has created many new opportunities in the study of quantum uids. In particular, recent years have seen a unry of experimental studies of super uidity in dilute, scalar Bose-E instein condensates. These include the observations of critical velocities for super uid ow about microscopic [1] and macroscopic [2] obstacles, the onset of turbulent ow above this critical velocity [3], beautiful studies of quantized vortices and vortex lattices in rotating Bose-E instein condensates [4, 5, 6], and other manifestations of irrotational super uid ow [7, 8]. These experiments are closely analogous to those performed on another scalar super uid, liquid ⁴He, but apply new experimental probes and allow new insights due to the vastly di erent parameter regime of the dilute atom ic gases, and their amenability to a new set of tools form anipulation and probing.


D ilute atom ic gases also o er the opportunity to create novel quantum uids by using these various tools to manipulate the internal and external states of the atom s comprising the super uid. For example, di erent types of multi-component condensates have been studied: externally-coupled two-component condensates of 87 Rb at JILA (reviewed in [9]), and F = 1 spinor condensates of sodium at M II (reviewed in [10]). O ne experiment at JILA explored how a spatially-selective coupling between two trapped hyper ne levels of a nubidium condensate leads to a \winding" of the order parameter, akin to the phase winding of the order parameter which occurs due to rotation about a vortex core, and how this winding is recurrently \undone" due to the motional dynam ics of a two-component condensate [11]. This observation illustrates that vortices in such a novel system should not be metastable (sim ilarly predicted for spinor condensates [12]), a major modi cation from the super uid behaviour of a single component gas.

In a similar vein, we have previously considered the novel super uid properties introduced to a two-component Bose condensed atom ic gas which is coupled by a spatially periodic coupling eld [13]. This spatially-periodic coupling results from intersecting, non-collinear laser beam s which induce a Ram an coupling between two internal states of the ultracold gas. The Ram an coupling introduces an anisotropy to this periodically-dressed uid which should manifest itself in an anisotropic super uid critical velocity. Controlling various param eters of the Ram an coupling laser beam s allow s one to dram atically alter this critical velocity, leading to the dissipation of super uid ow at velocities much lower than the critical velocity for the uncoupled Bose condensate.

In this paper, we develop further a theory describing the dissipation of super uid ow in a periodically-dressed Bose-Einstein condensate. Using the Bogolibov approximation theory which was introduced in Ref. [13], the possible disspation of super uid ow is treated by analyzing the scattering of massive impurities which ow through the super uid. In analogy with similar calculations for a scalar Bose-Einstein condensate [15, 1, 14], impurity scattering at low impurity velocities is found to be suppressed by the energetics of the quasi-particle spectrum (related to the Landau criterion for super uidity [16]), by the suppression of density uctuations in the lowmomentum phonon regime [17], and by variations of the internal-state compositions of quasiparticles at di erent wavevectors. These e ects combine to give a smooth evolution in the disspation rates for super uid ow as the Raman coupling strength is increased, gradually converting an uncoupled two component Bose-E instein condensate (essentially a scalar super uid) to a periodically-dressed condensate with dramatically di erent super uid properties. This super uid dissipation rate gives an appealingly clear signature for future experimental studies.

1. Quasi-particle modes of the periodically-dressed condensate

As presented in Ref. [13], a periodically-dressed Bose-Einstein condensate (PDBEC) is form ed of atoms of mass m with two internal states, A and B, separated by an energy di erence $h!_0$. These atoms are exposed continuously to two laser beams of wavevectors k_1 and k_2 and frequencies $!_1$ and $!_2$, which couple the states A and B via a Ram an transition (see Figure 1). In such a Ram an transition, an atom in internal state A with wavevector q k=2 absorbs a photon from beam 1 and em its a photon into beam 2, arriving in internal state B with wavevector q + k=2 gaining a momentum $hk = h(k_1 \quad k_2)$ and a kinetic energy $h = h(!_1 \quad !_2 \quad !_0)$.

K exping in m ind this coupling between atom s of di erent m om enta, we let a_q (a_q^y) be the creation (annihilation) operator for an atom in internal state A and wavevector q = k=2, and similarly let b_q (b_q^y) be the creation (annihilation) operator for an atom in internal state B and wavevector q + k=2. We refer to these as the bare-state creation and annihilation operators. The justi cation for this particular notation lies in the dressed-state picture [18], in which one considers the driving optical elds to be part of the quantum system. In this picture, the R am an transition connects the states $ja_q i = jA; q = k=2; N_1 + 1; N_2 i$ and $j_q = jB; q + k=2; N_1; N_2 + 1i$, where $ja_q i$ represents an atom in state A and wavevector q = k=2 and an optical eld with $N_1 + 1$ photons in beam 1 and N_2 photons in beam 2, and similarly for $j_q i$. In the dressed-state picture,

 $ja_q i$ and $jb_q i$ are states for which the total momentum of the atom + photon system is equal { by a proper choice of intertial frame, this total momentum is taken to be hq). The states are separated by an energy di erence h, and coupled by a static and (in the dressed-state picture) spatially uniform R am an coupling. The system is then represented by a many-body H am iltonian of the form

Here is the two-photon Rabi frequency characterizing the strength of the Ram an transition, determ ined by the polarizations and intensities of the driving laser beam s and by dipole matrix elements of the atom s.

This H am iltonian is diagonalized by transform ing to the dressed-state creation and annihilation operators $_{q}$, $_{q}^{y}$, $_{q}$, $_{q}^{y}$ which are de ned as linear combinations of the bare-state operators

The mixing angle $_q$ is defined by the relation tan $_q = ! = (hq k = m)$. The dressed states have energies

Here, the m inus sign refers to the lower dressed-state dispersion curve and to the operators $_{q}$ and $_{q}^{y}$, while the plus sign refers to the upper dressed-state dispersion curve and to the operators $_{q}$ and $_{q}^{y}$.

A Bose-Einstein condensate form ed from this periodically-dressed atom ic gas has a macroscopic population of N₀ atom s in the lowest energy momentum state: this state lies on the lower dressed-state dispersion curve and is taken to have momentum hQ [19]. In Ref. [13], a Bogoliubov-approximation theory was developed to account for the e ects of weak interatom ic interactions on a PD BEC. An interaction H am iltonian of the form H int = $\frac{g}{2}^{P}_{q}$ (n_qn q N) was considered, where N is the total number of atoms in the system and n_q = $P_{k}^{P}_{k+q}a_{k} + b_{k+q}^{Y}b_{k}$ is the Fourier transform of the density operator. Quasi-particle energies and operators were found by diagonalizing a 4 matrix (H_q)_{ij} = (E_q)_{ij} + x_ix_j where E_q is a diagonal matrix with entries (E_q; E_q; E⁺_q; E⁺_q) with E_q = h(!_{Q+q} !_Q), = gN is the chemical potential, and x = (cos q; icos q; sin q; isin q), where q = (_{Q+q} Q)=2.

where H_q is a diagonal matrix with entries $h(\vdots_{Q+q}; \vdots_{Q-q}; \vdots_{Q+q}; \vdots_{Q+q})$ by which the lower (m inus sign) and upper (plus sign) quasi-particle energies $h \vdots_{Q+q}$ are de ned. One

also obtains the creation and annihilation operators for the lower (\sim_q , \sim_q^y) and upper (\sim_q , \sim_q^y) branch quasi-particles through the following relation:

Here R_q contains trigonom etric functions of $Q_{q+q}=2$ and $Q_q=2$ in accordance with Eq. 2. The Bose commutation relations take the form



where represents any of the four-component vectors in Eq.5. These relations are clearly preserved by the rotation matrix, i.e. $R_q A R_q^y = A$, while the imposition of Bose commutation relations for the quasi-particle operators enforces a norm alization criterion $M_q A M_q^y = A$.

Experimentally, values for the Ram an detuning , the Rabi frequency , the chemical potential and the Ram an momentum transfer hk can be chosen over a wide range of parameters. For example, let us consider a particular realization of a PDBEC using two hyper ne states of 87 Rb. One may consider the case of Ram an excitation using two lasers both tuned near the D2 optical transition at a wavelength ' 780 nm . Thus, the Ram an recoil energy $E_{\rm k} = h^2 k^2 = 2m$ can be readily tuned in the range 0 $E_{\rm k}$ h 15 kHz. Properties of a PDBEC are governed by the ratios h =E_k, =E_k and =E_k. The Ram an detuning and the Rabi frequency can be chosen nearly arbitrarily, reaching maximum values which are orders of magnitude larger than E_k . The chemical potential = 4 h^2 an=m has a typical value of 1 kHz for a density of n ' 1 10^{14} cm ³ and a scattering length a ' 100 bohr { thus the ratio =E_k can be as sm all as 1=10 for counter-propagating Ram an excitation lasers, and greatly increased by using Ram an beam s intersecting at sm all angles.

For illustration, we show in Figure 2 the quasiparticle dispersion relations for a PDBEC with a chemical potential $=E_k = 1$, a Ram an detuning of of $h =E_k = 1=2$ and Ram an coupling strength $h =E_k$ varying between 0 and 2. For this case of > 0, a condensate is formed in the Q ' k=2 state of the lower dispersion relation. In the absence of Ram an coupling, this equality is exact, and the condensate is formed in the B i internal state. Quasiparticle excitations in the B i state follow the standard Bogoliubov result, while quasiparticles in state A i have a free-particle dispersion relation { this can be though of as due to the lack of a spatial interference term between the condensate and excitations in the A i state at any wavevector. For sm all Rabi coupling strengths, one speaks more properly of excitations in the lower and the upper quasiparticle dispersion relations, although the energies and internal-state com positions of these states rem ain relatively unchanged for wavevectors q far from the D oppler-shifted Ram an resonance condition q = k=m = 0. The lower quasiparticle dispersion

relation has a local minimum near q = k=2 caused by the minimum of the dispersion relation for the bare A istate atoms. By analogy to the roton minimum in the excitation spectrum of super uid ⁴He [17], we denote this feature as an \articial roton," although we mean to suggest no similarity between the speci c structure of a roton and of the plane-wave excitations of a PDBEC. As the Rabi frequency is increased further, a greater mixing of the internal state composition of the Bose condensate and of the quasiparticle excitations occurs, and energy levels are shifted. In particular, the energy of the \arti cial roton" is shifted upwards due to interactions as the internal state composition of the Bose condensate and of these excitations becomes more similar.

2. Im purity scattering

We now consider the scattering of impurities passing through a uniform PDBEC. We consider impurities of mass M_c which have a free-particle dispersion relation $E_c = h^2 k_c^2 = 2M_c$ where k_c is the impurity wavevector. Such impurities interact with the two components of the periodically-dressed condensate through an interaction of the form

Here a_q , a_q^y , b_q , and b_q^y are dened as above, and c_q and c_q^y are the creation and annihilation operators, respectively, for the inpurity particles. The coupling strength for the inpurity scattering is , which we parameterize as $= 2 h^2 a_c = M^0$. This parameterization correctly describes low-energy s-wave scattering with a scattering length of a_c and the reduced mass $M^0 = mM = (m + M)$. Note that we have made the assumption that the scattering strengths between the inpurity and atom s in states A and B are equal, and assume further that state changing collisions do not occur (the in purity is considered \non-m agnetic"). We may consider also the limit as the impurity mass becomes in nite while the impurity velocity v = hk=m remains constant (k is the impurity wavevector). We thereby obtain a description of the PDBEC owing past a rigid obstacle with a velocity v, and the concept of impurity scattering is replaced by the dissipation of super uid ow.

The scattering rate of these in purities can be calculated using a perturbative approach as follows [15,14]. We consider the system to be initially in the state \mathfrak{Pi}_{AB} ki_c, i.e. a PDBEC with no excitations, and a single in purity particle of wavevector k. The scattering Ham iltonian of Eq. 7 may couple this state to the nal state \mathfrak{fi}_{AB} k \mathfrak{qi}_c in which the periodically-dressed gas is in the state \mathfrak{fi} and the impurity wavevector changes from k to k q. The matrix element for this transition is hf \mathfrak{jn}_q \mathfrak{fi} , where \mathfrak{n}_q is described above, and where the AB subscript labeling the quantum states of the periodically-dressed gas has been dropped. We then obtain the rate of in purity scattering by summing over all nal states \mathfrak{fi} and momentum transfers q using Ferm i's G olden Rule.

We now make use of the Bogoliubov approximation. If we consider only weak scattering, we may restrict the nalstates to those containing a single quasiparticle, i.e. fi = jq i where jq i = $^{y}_{Q+q}$ fi and $jq^{+}i = ^{y}_{Q+q}$ fi. The rate of impurity scattering is then

where v = hk=M is the impurity velocity. We have introduced the quantities S (q) and S (q) which relate to the static structure factor describing density-density correlations in the Bose condensate. For a single-component Bose Einstein condensate, the static structure factor S (q) has been evaluated and measured [20, 22, 21]. For the PDBEC, we separate the contributions of the lower and upper excitation spectra as

Physically, these quantities describe two e ects. First, the magnitude of S and S describes the contributions of quasiparticles in the lower () or upper () quasiparticle state to density uctuations (as opposed to phase uctuations, which dom inate, for example, for phonon excitations of a scalar B ose condensate [20, 21, 23]). Second, these quantities describe the degree to which the internal state com position of the condensate m atches that of the quasiparticle. For instance, a condensate which is predom inantly in the β i internal state w ill not scatter strongly into quasiparticle states in which the β i internal state is dom inant, and thus the structure factor describing this scattering w ill be sm all.

Before proceeding to a calculation of S and S , it is useful to consider the scattering rate $_0$ for an ideal-gas, single-component Bose-E instein condensate as the target gas. In

this case, we may conveniently take S (q) = 1, S (q) = 0 and $t_q = hq^2 = 2m$. Replacing $P_q = V = (2^{-1})^3 d^3q$, and substituting for we evaluate Eq.8 and obtain simply

i.e. the conventional expression for the scattering rate where N $_0=V$ is the density of the target gas and 4 a_c^2 is the collision cross section. We may then determ ine the impurity scattering rate in a PDBEC relative to that in an ideal gas, $F_{tot} = =_0 = F + F$:

3. Structure factor form alism

To calculate the structure factors S and S we start by expressing the density operator n_q in terms of the quasiparticle operators

Acting on a PDBEC, the only important terms in the sum are those which include the condensate operators \sim_Q and \sim_Q^Y . Applying the relations $\sim_{Q+q} Di = \sim_{Q+q} Di = 0$ for $q \in 0$, and the relation $M_0 = 1$, we de nem atrices $= M_{\alpha}^{\gamma} R_{\alpha}^{\gamma} R_0$ and $= R_0^{\gamma} R_{\alpha}^{\gamma} M_{\alpha}$ and obtain






Figure 4. Static structure factor (a) S (q) and (b) S (q) for a PDBEC. The wavevector q is collinear with the Ram an momentum transferk with q = q = k. Three black curves describe a PDBEC with $h = E_k = 1=2$, $h = E_k = 1$, and $= E_k = 0$ (solid), 1=4 (dashed) and 1 (dotted). The condensate in the $_Q$ state is predom inantly in the internal state B; thus scattering predom inantly occurs into the lower quasiparticle branch for q < 0 and into the upper quasi-particle branch for large q > 0. For q = 0.5 both S (q) and S (q) are signi cant since quasiparticles contain large fractions of both A i and B i. Interactions suppress scattering at small m om entum transfer, an e ect seen also in the structure factor S (q) for a scalar B ose-E instein condensate (gray dot-dashed curve) with $= E_k = 1$.

The static structure factors S (q) and S (q) for a PDBEC are shown in Figures 3 and 4. The specic values for the Ram an detuning , the Rabi frequency and the chem ical potential are relevant for a particular realization of a PDBEC using two hyper ne states of a ⁸⁷Rb, as discussed above. The division of the scattering weight between the lower (S) and upper (S) quasiparticle branches can be understood by considering the composition of the dressed-state quasiparticles, which is related by

Eq. 2 to the mixing angle $_{q}$. This angle ranges from $_{q} = 0$ for q k ! 1 to a = for q = k + 1, reaching q = -2 at the D oppler-shifted R am an resonance q = k = m = 0. For sm all R abi frequency, and hence the internal state composition of the dressed states varies rapidly about the Raman resonance condition, while for large Rabi frequency, this variation occurs over a broader range of q. This behaviour is released in the structure factors, as illustrated by Figure 3. By continuity, the internal state composition of the condensate in the o state is nearly identical to that of excitations in the lower quasiparticle branch (created by $\sim_{0+\alpha}^{y}$), and nearly orthogonal to that of excitations in the upper quasiparticle branch (created by \sim_{0+q}^{y}). Thus, since elastic scattering from a \non-magnetic" in purity does not a ect the internal state distribution, S (q) ' 0 generally for small q. Away from q = 0, the division of the scattering weight between the upper and lower quasiparticle branches depends on the strength of the Rabi coupling. For small Rabi frequencies, the scattering strength shifts abruptly from the lower to the upper quasiparticle branch at the D oppler shifted R am an resonance. For large Rabi frequency, the changes in the scattering strengths are more gradual, with scattering into both branches showing a signi cantweight for a wide range about the Ram an resonance condition. This variation is particularly relevant for the scattering of in purities near the Landau critical velocity, as discussed below .

As illustrated in Figure 4, interatom ic interactions suppress scattering at small momentum transfers. For a single-component hom ogeneous Bose Einstein condensate,

the structure factor $S(q) = q^2 = q^2 (q^2 + 2^{-2})$ is small for wavevectors of magnitude q < 1 = w here $= 2m = h^2$ is the healing length. Sim ilarly, for the PDBEC, we nd a suppression of the structure factors S(q) and S(q) for $q < k^2 = E_k$, as shown in the gure. This suppression of the structure factor in a PDBEC could be probed experimentally as it was for a scalar Bose-Einstein condensate by studying shallow-angle optical Bragg scattering [20, 21].

4. Dissipation of super uid ow


Finally, let us use the formalism developed above to describe super uid properties of a PDBEC. In Ref. [13], we applied the Landau criterion to determ ine the critical velocity for super uidity in a PDBEC given the quasiparticle dispersion relations. This criterion gives the super uid critical velocity along a direction \hat{q} as having a magnitude $v_c = m \ln_{q;i} E_i(q\hat{q}) = hq$ where $E_i(q)$ are the energies of possible excitations with wavevector q; using the momentum de nitions for a PDBEC, these would be the quasiparticle energies $h!_{Q+q}$. In an unperturbed, single component weakly-interacting condensate, this critical velocity v_c^0 is equal to the Bogoliubov speed of sound $c_s = \frac{q}{m}$ in all directions. In a PDBEC, the anisotropic quasiparticle dispersion relation leads directly to the prediction of an anisotropic super uid critical velocity, and to the possibility of a critical velocity lower than that of the unperturbed condensate.

O nem ay determ ine this critical velocity graphically by noting the line of minimum absolute slope which connects the origin and the quasiparticle dispersion curve (see Figure 2). For the PDBEC, the super und critical velocity may be suppressed by the presence of the \arti cial roton" feature in the lower dispersion curve. This suppression occurs in the direction of the Raman momentum transfer hk for the case of > 0 (as shown in the gure), or in the opposite direction for < 0.

However, while the Landau criterion determ ines the minimum velocity for the dissipation of super uid ow, it does not quantify the onset of such dissipation as the velocity is increased beyond the critical value. Indeed, for extremely weak R am an coupling, even though the super uid critical velocity is strictly dierent, one should expect the uid properties of a PD BEC to be nearly identical to that of a two-component BEC in the complete absence of R am an coupling. We can quantitatively assess this description using the formalism developed above for the determination of the matrix elements S and S, and therefrom the normalized scattering rates F and F.

The results of such calculations for in nitely massive in purities (i.e. super uid ow about rigid obstacles) are presented in Figures 5 and 6. Values of F and F were determined by numerical integration in which the delta function in Eqs. 12 and 13 was approximated by a narrow G aussian distribution whose width was adjusted to give reasonable numerical convergence. As we expect, for small Rabi frequencies the properties of a periodically-dressed BEC are quite similar to those of an uncoupled two component B ose-E instein condensate. The scattering probability for in purity atoms s (related to the viscosity of the uid) is indeed non-zero at velocities lower than the super uid critical velocity for the unperturbed gas, demonstrating that the critical velocity is suppressed along the direction of Ram an scattering. This scattering at low velocities occurs through the excitation of quasiparticles near the local minimum (the \arti cial roton") in the lower dispersion relation. However, this scattering strength F tot remains weak until the curve joins that of the uncoupled condensate and the scattering strength is increased by phonon scattering.

The elects of increasing the Rabi frequency are twofold. First, as increases, the internal state composition of the \arti cial roton" excitation becomes more similar to the internal state composition of the Bose-Einstein condensate. This causes an increase in the scattering strength (as indicated also in the calculations of S shown in Figures 4 and 3). Simultaneously, because of this overlap of the internal state composition, the energy of these excitations is increased, approaching the energy given by the one-component Bogoliubov spectrum, albeit with an appropriately modiled elective mass. Thus, the minimum velocity at which scattering occurs increases as the Rabi frequency increases. At moderate values of the Rabi frequency (where h = E k 1), the scattering rate vs. velocity has a two-step shape as scattering is insteinanced by strong scattering when the velocity is near v_c^0 . A s shown in Figure 6 for one typical parameter setting, only F contributes to the weak scattering at velocities smaller than v_c^0 . At velocities greater



than v_c^0 , scattering into the upper dispersion curve is allowed and F $\neq 0$.

The super uid critical velocity of the PD BEC in the direction of the R am an momentum transfer is suppressed with respect to an uncoupled condensate. For weakly R am an coupling, the dissipation at low velocities is weak. This dissipation grows stronger as the R am an coupling strength is increased.

This two-step curve gives a clear signature which should be visible in experimental probes of super uid ow. Indeed, experiments such as those performed by Chikkatur et al [1], in which atom s of another ground state hyper ne level were used as scattering in purities in a dilute atom ic Bose condensate, could be carried out in a straightforward manner. It would be interesting to consider further how other aspects of super uidity, such as the onset of turbulent ow [2] or the metastability of quantized vortices [4, 5], are a ected by the anisotropic nature of a periodically-dressed Bose-E instein condensate.

In conclusion, dissipation of super uid motion in a periodically-dressed Bose-E instein condensate above the super uid critical velocity was treated. A formalism was developed for the calculation of the static structure factors S and S describing density-density correlations from quasiparticles in the lower () and upper () excitation branches of the periodically coupled gas. Following a perturbation theory approach, the scattering rate of massive in purities, or equivalently the damping rate of super uid motion past m icroscopic obstacles, was calculated. R am an coupling of a two-component condensed gas leads to a suppression of the super uid critical velocity. The impurity scattering rate evolves sm oothly as the R am an coupling strength is increased. The the super uid damping is weak for weak R am an coupling, and becom es m ore signi cant as the R am an coupling strength is increased.




Figure 6. Normalized rates for production of lower (F, dashed line) and upper (F, dotted line) quasiparticle excitations due to scattering o in nitely massive in purities moving at velocities v in a PDBEC. Velocities parallel to the Raman momentum transfer are considered, with v = vk=k. Black curves show results for a PDBEC with $h = E_k = 1 = 2$, $= E_k = 1$, and $h = E_k = 1$, with the solid curve showing the total norm alized scattering rate F_{tot}. The gray dot-dashed curve shows the norm alized scattering rate for a one-component condensate with $=E_k = 1$. For v > 0 (for this case where > 0), in purity scattering at low velocities is enhanced as compared to the one-component condensate. This scattering leads to the creation of excitations in the low erdispersion curve (F > 0) around the \article cial roton "feature in the quasiparticle dispersion relations. At velocities near the critical velocity for the unperturbed condensate, v_0^0 , scattering is allowed into the upper dispersion relation F > 0, and the norm alized scattering rate approaches that of a one-com ponent condensate. For v < 0, energy and momentum conservation imply that only scattering into the lower quasiparticle excitations is allowed at the velocities considered.
