# Staggered ux state of electron in two-dim ensional t-J m odel

The competition between the staggered ux state, or the d-density wave state, and the d-wave pairing state is analyzed in two-dimensional t-J model based on the U (1) slave boson mean-eld theory. Not only staggered ux of spinon but also staggered ux of holon are considered. In this form alism, the hopping order parameter of physical electron is described by the product of hopping order parameters of spinon and holon. The staggered ux amplitude of electron is the di erence of staggered ux amplitude of spinon and that of holon. In - ux phase of spinon, staggered uxes of spinon and holon cancel completely and staggered ux amplitude is not , uxes does not cancel completely and staggered ux amplitude is not , uxes does not cancel completely and staggered ux phase of spinon, becomes a second order transition in physical electron picture. The order parameter which characterizes this transition is staggered

ux order parameter of electron. A mean-eld phase diagram is shown. It is proved analytically that there is no coexisistence of staggered ux and d-wave pairing. The tem perature dependences of Ferm i surface and excitation gap at (0; ) are shown. These behaviors are consistent with angle-resolved photoem ission spectroscopy (ARPES) experiments.

## I. IN TRODUCTION

Recently the staggered ux state [1,2] has been revived as a candidate of pseudo-gap phase of high T<sub>c</sub> superconductors. The staggered ux state is characterized by the staggered orbital-current. Tim e-reversal-symmetry is broken if staggered current is the current of physical electron. W eak m agnetic signals were caught in recent experiments of underdoped  $YBa_2Cu_3O_{6+x}$  (YBCO) by neutron scattering [3,4]. Static alternating magnetic signals were also caught by muon spin rotation experiment in the vortex cores of underdoped YBCO [5]. The staggered ux state contains a density wave ordering whose symmetry is  $d_{x^2}$  y<sup>2</sup> [6]. Because of this, it is also called d-density wave. Thus, there is the gap whose symmetry is  $d_{x^2} v^2$ . A lthough  $d_{x^2} v^2$ -gap exists in both the staggered ux state and the  $d_{x^2 \ y^2}$ -wave pairing state, the structures of the ferm ion excitation in these states are different. The staggered ux state should have a segmentlike Ferm i-surface as observed in angle-resolved photoem ission spectroscopy (ARPES) experiments [7{14]. On the contrary,  $d_{x^2 \ y^2}$  -wave pairing state has a point-like Ferm i-surface. The absence of speci cheat anom aly may be thought to deny the staggered-ux phase. However, we rem ark that there are argum ents to justify the absence [15,16]. The lack of anomaly is either because of nite chem ical potential [15], or because that this transition can be described by 6-vertex m odel [16].

The high- $T_c$  superconductors are doped M ottinsulators. Essential physics of these materials comes from strong C oulom b repulsion. This physics is described by t-J m odel [17,18]. A method that restrict double occupancy is the slave boson method. In both the slave bo-

son methods, the U (1) method and the SU (2) method, the physical electron operator is described by a product of auxiliary ferm ions and bosons. In the U (1) slave boson theory, the physical electron operator ci is described by a product of an auxiliary spin-1/2 neutral ferm ion operator fi called spinon and a auxiliary spinless charged boson operator  $b_i$  called holon;  $c_i = b_i^y f_i$ with a constraint  $b_i^y b_i + f_i^y f_i = 1$ . Here, the reis summed up over the two spin peated spin index states. On the contrary, in the SU (2) slave boson theory [19,20], two auxiliary bosons are introduced. The physicallelectron operator  $c_i$  is described by a product of an auxiliary isospin-1/2 neutral ferm ion operator  $f_i$  and two auxiliary spinless charged boson operators,  $b_{i1}$ ,  $b_{i2}$ ;  $c_i = h_{i}^{y} = 2 = (b_{i1}^{y} f_i + b_{i2}^{y} = f_{i}^{y}) = 2$  with three constraints,  $\frac{1}{2}$   $\stackrel{\text{y}}{_{i}}$   $_{i}$  +  $h_{i}^{\text{y}}$   $h_{i}$  = 0. Here,  $h_{i}^{\text{T}}$  = ( $b_{i1}$ ; $b_{i2}$ ),  $f_i^T = (f_i; \circ f_i^Y)$ , and  $= (f_i; f_i; f_i)$  are Paulim atriœs.

W en and Lee proposed based on the SU (2) theory [20{22] that the pseudo-gap state is a mixture of staggered ux state and  $d_{x^2 y^2}$  superconducting state. These orders are dynamical rather than static and that the tim e-reversal symmetry is not broken. They discussed this in the region where bosons are condensed,  $(z_{i1}; z_{i2}) \notin$ 0, based on the O (4) sigm a-m odel description. It is also proposed by Lee and W en [21] that the static staggeredux order can only exists in the vortex core. Short com ings of this theory are that nite size Ferm i-surface is not obtained naturally and that the condensation of bosons is assumed. The staggered current of physical electron and that of spinon are not equivalent in the staggered ux [1,2] phase at nite temperature because the staggered ux phase of spinon exists above the tem perature of Bose-condensation of holon [19,20,23]. Above the tem – perature of Bose-condensation, holon operators cannot be treated as classical num bers (c-num ber). [24] The correspondence between the electron current and the spinon current is not obvious.

On the contrary, Chakravarty, Laughlin, Morr, and Nayak [25] proposed that the staggered ux order exists as a static form in the pseudo-gap state. They proposed this at zero tem perature based on G inzburg-Landau theory. The staggered ux state they proposed is that of electron and time-reversal symmetry is broken. They also proposed that there exist three ground states. The ground state changes as doping increases from pure staggered ux phase to the coexisting phase of staggered ux state and d-wave superconductivity (dSC) state and nally to pure dSC phase. A short com ings of their theory is that it is a phenom enology without m icroscopic foundation.

In this paper, we analyze the staggered-ux state of physical electron in two-dimensional t-J model by the U (1) slave boson method without assuming the Bose condensation of holons. The relation between the staggered current of electron and the staggered current of spinon is provided. In Sec. II, our form ulation will be reviewed. Not only an auxiliary eld ij that describes spinon-hopping but also an auxiliary eld B<sub>ii</sub> that describes holon-hopping will be introduced to decouple the hopping Ham iltonian. The advantages of this form ulation will be stated in Sec. II A. Form ean eld solution, not only staggered ux of spinon but also staggered ux of holon will be considered. This solution provides the relation between the staggered ux state of spinon and that of electron. In Sec. III, The self-consistent equations will be derived. In Sec. IV, the phase diagram is shown.where the staggered-ux phase of electron exists. In Appendix, it is proved analytically that the staggered ux and the d-wave pairing do not coexist. The instability of these two states, the staggered ux state and the d-wave pairing state, are discussed. In Sec. V, the tem perature dependences of Ferm i surface and excitation gap at (0; ) are shown. We show that the Ferm isurface in the staggered-ux state resembles segment-like Ferm i-surface observed by ARPES experiments. Finally, conclusion will be given in Sec. VI. Part of the present results will be published elsewhere [26].

## II.FORMALISM

#### A.Slave boson t-J m odel and auxiliary elds

The starting H am iltonian is two-dimensionalt-Jm odel on a square lattice [18],

Here, hi; ji represents sum over the nearest-neighbor sites, the repeated spin index is sum med up over the two spin states, and P is a projection operator to no doubly occupied state,  $S_i = \frac{1}{2}c_i^y$  ()  $\circ c_i \circ$ , where  $= (_1;_2;_3)$  are Paulim atrices. One way to represent the projection to no double occupancy is the slave boson m ethod. In the U (1) slave boson m ethod, the electron operator  $c_i$  is described by a product of an auxiliary spin-1/2 neutral ferm ion operator  $f_i$  called spinon and an auxiliary spinless charged boson operator  $b_i$  called holon;  $c_i = b_i^y f_i$  with a constraint  $b_i^y b_i + f_i^y f_i = 1$ . Here, the repeated spin index is sum med up over the two spin states. In the path integral form alism , the partition function Z () = Trexp (R H) is described by following functional integral, Z = [db][df][d] ]exp(S),

where is the inverse temperature = 1=T, is the RQ in aginary time,  $[db] = RQ^{ij}$ ,  $db_i^y$ ()  $db_i$ () is a complex boson integral,  $[df] = RQ^{ij}$ ,  $df_i^y$ ()  $df_i$ () is a complex boson integral,  $[df] = R^{ij}$ ,  $df_i^y$ ()  $df_i$ () is a complex G rassmann integral,  $[d] = I_i$ ,  $d_i$ () is the Lagrangemultiplier integral that represents a constraint  $b_i^y b_i + f_i^y f_i = 1$ ,  $S_i = \frac{1}{2}f_i^y$ ()  $\circ f_i \circ$ , e is chemical potential. We introduce three complex auxiliary elds  $I_i$ ,  $I_i$ ,  $I_i$ , and  $B_{ij}$  on links to decouple the Ham iltonian.

A coording to these relations, ij describes the hopping of spinon, ij describes the singlet pairing of spinon which is

called resonating-valence bond (RVB), and B<sub>ij</sub> describes the hopping of holon. The quantity  $B_{ij} = \hbar b_i^y b_j i$  can have a nite value even if there is no Bose-condensation of holon (see Sec. IV).

P resent treatment is dierent from previous one by Ubbens and Lee [23]. In Ref. [23], B<sub>ij</sub> was not introduced. Then h<sub>ij</sub>i can not be interpreted as spinon hopping hf<sup>y</sup><sub>i</sub> f<sub>j</sub> i, but the correct relation becomes h<sub>ij</sub>i =  $hf^y_i f_j + \frac{8t}{3j}b^y_i b_j$ i as can be known from Eq. (4) without B<sub>ij</sub> term. In their method, the four-boson term  $b^y_j b_j b^y_j b_j$ is created by the decoupling, but it is neglected based on an argument that the e ect of this term is small at low doping. The situation is sim ilar in the SU (2) method [19,20], if B<sub>ij</sub> is not introduced. Our treatment has a merit that the four-boson term does not appear in the decoupling.

## B. Saddle point solution




FIG.1. Staggered ux of spinon  $_{\rm s}$  and holon  $_{\rm h}$ .

We approximate the integral by auxiliary elds  $_{ij}$ ,  $_{ij}$ , and  $B_{ij}$  with their saddle point values  $_{ij}$ ,  $_{ij}$ , and  $B_{ij}$ . For the saddle point solution of  $_{ij}$  and  $B_{ij}$ , we considered not only the staggered ux order of the spinon  $_{s}$  but also the staggered ux order of the holon  $_{s}$  (Fig. 1), namely

Here,  $\hat{x}$  and  $\hat{y}$  are unit vectors in the x and y direction,  $x_s = \cos(s=4), y_s = \sin(s=4), x_h = B\cos(h=4),$   $y_h = B\sin(h=4)$  [28]. The staggered ux state contains a density wave (particle-hole pairing) ordering whose symmetry is  $d_{x^2-y^2}$ , which is called \d-density wave" [6]. The order parameters  $y_s$  and  $y_h$  correspond to the d-density wave order parameter of spinon and holon, respectively [29]. For the symmetry of spinon pairing, we considered  $d_{x^2-y^2}$  [30,31], namely

The integralby Lagrange multiplier eld  $_{i}$  is also approximated with its saddle point value  $_{i} = i_{0}$ . Then spinon and holon have chemical potentials,  $= e_{0}$  and  $_{h} = 0$ , respectively. These chemical potentials enforce the global constraints of spinon number and holon number,  $hf_{i}^{y}f_{i}i = 1$  and  $h_{0}^{y}b_{i}i =$ , respectively.

This method that treats the spinon and the holon as separated degrees of freedom s is justi ed because the low tem perature phase of the t-J model is in the decon nement phase of spinon and holon even when full gauge uctuations ( uctuations around this saddle point) are included. It is shown based on the compact U (1) treatments of the gauge elds [32,33]. As the gauge eld couples with nite density fermion, the gauge coupling gets weaker. In the decon nement phase of spinon and holon, the gauge eld can be treated perturbatively.

O ur form alism is an extension of the study by Ubbens and Lee [23]. The  $f_j^y f_i$  term couples not only to (3J=8)  $_{ij}$  but also to tB<sub>ij</sub>, namely the spinon feels the spinon staggered-ux( $_s$ ) and the holon staggered-ux( $_h$ ). The expectation values of the holon, B and  $_h$ , have nite values for the solution of self-consistency equations. Two advantages exist in our form alism; 1) this is a new saddle point solution whose free energy is lower than the previous one, 2) this solution provides the relation between the staggered-ux of electron and that of spinon.

W ith holon order parameters  $B_{ij}$ , the hopping order parameter of electron becomes a product of the hopping order parameters of spinon and holon,

The electron staggered-ux order parameter  $_{e}$  and the electron d-density wave order parameter  $y_{e}$  are given by

According to eq.(12), the d-density wave order parameter of electron  $y_e$  can also be written as,  $y_e = i\frac{1}{2N} \int_{k}^{L} (\cos k_x - \cos k_y) hc_k^{\gamma} q_{k+Q}$  i.

## III. SELF CONSISTENT EQUATIONS

the spinon chemical potential is  $= e_0$ , and the holon chemical potential is h = 0. The saddle point value of i<sub>i</sub> is i = 0. Here, the matter part of this Ham iltonian is given by

The spinon couples not only to spinon order parameters,  $x_s$  and  $y_s$ , but also to holon order parameters,  $x_h$  and  $y_h$ . The holon couples only to spinon order parameters,  $x_s$  and  $y_s$ . There exist two components,  $W_k$  and that compute the descent

 $_k$  , that generate the  $d_{x^2 \ y^2}\,$  wave gap.

Both  $_{ks}$  and  $_{ks}$  are fermionic elds,  $_{ks}^{h}$  is bosonic eld, and  $E_{ks}^{(h)}$  is excitation spectrum of spinon (holon). Index s describes the band index, which takes the value + 1 or

At half-lling, where spinon chemical potential is zero and holon is absent (B<sub>ij</sub> = 0, i.e.  $x_h = y_h = 0$ ),  $E_{ks} = \frac{p_{ks}}{k} + (3J=4)^2 (y_s^2 + 2) (\cos k_x - \cos k_y)^2$ , and both  $y_s$  and have the same self-consistent equations. Thus, staggered ux state and d-wave pairing state are degenerate. All states that have the same value of  $y_s^2 + 2^2$  are degenerate. How ever, which state has the low erenergy at nite doping is known only after actualm inim ization of the free energy is done.

## IV.PHASE DIAGRAM AND STAGGERED CURRENT

## A. Phase diagram




FIG.2. Mean eld phase diagram for t=J = 1, where is hole concentration. The staggered- ux order of electron exists only in region 2. In this phase, staggered- uxes of spinon and holon do not cancel completely. Thus the staggered ux of electron remains. In region 1, both spinon and holon are in the - ux state. The uxes cancel completely. The region 3 is the d-wave RVB phase where the  $d_{x^2 y^2}$  pairing of spinon exists. The region 4 is the uniform RVB phase where hopping order parameters exist how ever it is real. In the region 5, all order parameters are zero. The phase diagram for t=J = 2 is quantitatively sim ilar to the phase diagram for t=J = 1.

We solved the self-consistency equations numerically, and obtained the phase diagram (Fig. 2) where 1) a region of the staggered-ux phase of the electron exists, 2) staggered-ux and d-wave pairing do not coexist, and 3) the ground state is a purely superconducting state.

At half-lling, the holon order parameter B<sub>ij</sub> is zero and the degeneracy of spinon states between the staggered-ux state and the d-wave pairing state exists due to local SU (2) symmetry [34]; € 0;B<sub>ii</sub> =  $0; y_s^2 + z^2 = \text{const} \in 0$ . In region 1, the staggered-ux of electron does not exist although the staggered ux of spinon exists. The spinon and holon states are both ux state [35] respectively. In the electron picture, the staggered – ux is canceled completely;  $\notin$  0; B  $\notin$  0; s = h = i = 0. The d-density wave order parameter of the electron is  $y_e = B \sin ($ )=4 = 0. The staggered-ux order of the electron exists only in region 2. The staggered current of electron exists in this phase. The spinon staggered –  $ux_s$  and holon staggered –  $ux_h$ are not equal to nor 0, and the holon staggered - ux am plitude h is not equal to the spinon staggered - ux am plitude s, s f h; f 0; B f 0; s f 0; h f 0; = 0, and  $y_e = B \sin (s_h) = 4 \in 0$ . In region 3,  $d_{x^2} y^2 = -1$ wave pairing exists;  $\notin$  0 and B  $\notin$  0;  $_{s} = _{h} = 0$ ;  $\notin$  0. and  $y_e = 0$ . In region 4, there exists only uniform hopping order;  $\notin$  0; B  $\notin$  0; s = h = 0, and y<sub>e</sub> = 0. In region 5, all order parameters are zero. Spinon and holon cannot hop;  $= B = {}_{s} = {}_{h} =$ = 0. and  $y_e = 0$ . The phase transitions, region 1 to region 3 and region 2 to region 3, are rst order. O ther phase transitions are second order. It is proved analytically that the staggered ux and the d-wave pairing do not coexist at

nite doping. Details are given in Appendix.

W ith the boson order parameter  $B_{ij}$ , the - ux phase and staggered-ux phase of spinon and holon extends to higher-doped region compared to the previous work [23], where  $B_{ij}$  was not considered. The transition between region 1 and region 2 is a second order transition in our theory. (If one only focuses on spinon degree of freedom, this does not look like phase transition [19,20,23].) There exists an order parameter that characterizes this transition. It is the staggered-ux of the electron. This is shown in Sec. IV B.

A lthough the ground state is the d-w ave superconducting phase at nite doping, the staggered- ux phase exists at nite tem perature. The staggered- ux state has larger entropy than the d-w ave pairing state, due to the larger num ber of the excitation around nite size Ferm i-surface. On the contrary, the Ferm i-surface in the d-w ave pairing state is always point-like. Therefore the staggeredux state arises when tem perature increases. These are shown in Sec. V.

W hen the uctuation around the saddle point solution (gauge eld) is included, it is expected that the staggered ux phase extends to still higher doped region com pared with the mean eld phase diagram. There are three reasons, 1) the d-wave pairing of spinon will be destroyed, 2) the instability to the staggered-ux state exists, and 3) the symmetry breaking of the staggered-ux order is discrete. Let us elaborate these reasons. Firstly, the d-wave pairing of spinon is destroyed above the Bosecondensation temperature of holon when the uctuation around the saddle point solution (gauge eld) is included [36]. The d-wave RVB state without Bose-condenstation does not occur, and the transition to the d-wave pairing state becom es the direct transition to the d-w ave superconducting state. The second reason is that the instability to the staggered-ux state has been discovered also in the gauge theory that includes the full lattice structure [37,38]. It is to the staggered-ux state at low doped region and to the ux density-wave state (incommensurate staggered-ux state) at high doped region. The mom entum that has anomaly is Q = (;) to the staggered-ux state, and is (; ) to the ux density-wave. At nite tem perature, these anom alies occur. The third reason is that staggered ux state is more robust against the uctuation than the d-wave pairing (d-wave RVB) state. This com es from the di erence in the symmetry breakings. The symmetry breaking in the staggered-ux state is discrete sym m etry, Z<sub>2</sub>. On the other hand, continuous symmetry, U (1), is broken in the d-wave pairing state.

#### B.Staggered-ux of the electron




FIG.3. The staggered ux order parameter of spinon s, holon h, and electron  $_{e}$  = s h at T = 0:15J for t=J = 2. is hole concentration.

The doping dependences of the staggered-ux am plitudes are shown in Fig. 3. The electron staggered-ux am plitude  $_{e}$  is a di erence of the staggered-ux am plitude of spinon  $_{s}$  and holon  $_{h}$  Eq.(12). In Fig. 3 the phase changes as doping increases from region 1 to region 2 and to nally region 3. In region 1 which is - ux phase of spinon, staggered-uxes of spinon and holon cancel completely and staggered-ux order of electron does not exist. How ever, in region 2, staggered ux am plitude is not , uxes does not cancel completely and staggered-ux am plitude of electron remains. The staggered-ux am plitude of holon decays rapidly as doping increases but it is not zero. At the transition point to d-w ave pairing, staggred-ux order param eter becom es zero discontinuously.

#### C.Spontaneous current of the electron

The h  $_{ij}f_i^{y}f_ji$  term does not contribute to the current because it is real. Only hB  $_{ij}f_i^{y}f_ji$  term contribute to the current.

The local cancellation of spinon current and holon current does not exclude the possibility of the electron staggered current. In our form alism, the physical electron current is given by the imaginary part of the product of hopping order parameters of spinon  $_{\rm ij}$  and holon B<sub>ij</sub>.

The explicit form of the electron current in this saddle point is  $J_{i+\hat{x}i}^{e} = (1)^{i}2t B \sin(e^{-4}) = (1)^{i}2ty_{e}$ ,  $J_{i+\hat{y}i}^{e} = (1)^{i}2t B \sin(e^{-4}) = (1)^{i}2ty_{e}$ . The current of the electron is small at low erdoped region because it is in proportion to the  $B = jb_{i}^{y}b_{j}ij$ . At low doping, B is proportional to and small. The magnetic eld due to the orbital current of electron is same order with previous estimations of 10 <sup>3</sup>T [2,25].

# V.FERM ISURFACE AND EXCITATION GAP AT (0, )

The tem perature dependences of Ferm isurface and excitation gap at (0; ) are shown. These behaviors are consistent with angle-resolved photoem ission spectroscopy (ARPES) experiments [7{14].

#### A.Ferm isurface




FIG. 4. The temperature dependence of the zero-energy-line of ferm ion at = 0.02. In (a), the rst quadrant of the Brilluin zone is shown. In (b), expanded view around (=2; =2) is shown. In this doping, transition tem - perature to the d-wave pairing phase is about T = 0:135J.

Fem i-surface is the loci of gapless excitation in momentum space. It is de ned by the zero-energy line of the electron excitation energy. The Ferm i surface for = 0.02 is shown in Fig. 4 at several temperatures. When temperature decreases, the Ferm i-surface becomes smaller in the staggered-ux phase, and changes to a point-like Ferm i-surface discontinuously at the transition temperature to the d-wave pairing phase. However, this discontinuity is small because Ferm i surface in the staggered-ux phase has shrunk alm ost to a point at the transition point. The shape of Ferm i-surface in the staggered-ux state of our theory is segment-like because the spectral weight has large enough value only along a part of the contour.

This result is quite di erent from the SU (2) m ean-eld theory, where the shape of Ferm i-surface is always pointlike because the particle hole symmetry (ie SU (2) symmetry) of ferm ion remains even at nite doping. As the lling of ferm ions are always half-lled, the staggered ux state and d-wave pairing state can be assumed to be gauge equivalent. Arti cial introduction of the phenom enological interactions are needed for the ferm ion to have a segment-like Ferm i surface in the SU (2) theory.

Now we give the details. The electron G reen function  $G^{e}$  is described by the product of spinon G reen function  $G^{s}$  and holon G reen function  $G^{h}$  [39];

The contribution of holon G reen function comes mainly from the bottom of the holon band. The momenta at the bottom of the boson band are (0;0) and (;) in the staggered ux state, and are (0;0), (;0), (0;), and (;) in the -ux state. We can treat the bosons as if they are Bose condensed at these band m inim a. In this approximation, the spectral function of electron has the following form,

In reality, the boson excitations exist at nite temperature. They make the discrete -function peaks have a nite width. This e ect, however, will not change the shape of the Ferm i-surface. Thus, we show the zero-energyline of spinon in the staggered-ux phase de ned by  $\frac{2}{k} + W \frac{2}{k}$ = 0 in Fig.4. The upper band E<sub>k</sub> = spectrum E<sub>k</sub><sup>+</sup> is always positive at nite doping where 0.




FIG.5. The spectral weight  $A^{e}(!;k)$  at ! = 0 divided by  $\frac{1}{2}$  (i.e.  $jv_k \hat{j}$ ) at T = 0.178J. View from the (;)-direction is shown.

A lthough the zero-energy-line of ferm ion forms an ellipse, the Ferm i-surface can be considered as segment-like. The reason is that the intensity of spectrum function  $\frac{1}{2}j_k \hat{j}$  is not symmetric between in the inner region (where  $j_x j + j_y j$ ) and in the outer region (where  $j_x j + j_y j$ ). As shown in Fig.5 it is stronger in the inner region. For example, on the line  $k_x = k_y$ , where  $d_{x^2 \ y^2}$ -gap due to staggered-ux order (W  $_k^2$ ) is always zero, the intensity is  $\frac{1}{2}$  at the inner side of the ellipse as  $j_{y_k} \hat{j} = 1$ , but the intensity is zero at the outer side of the ellipse as  $j_k \hat{j} = 0$ .

## B.Excitation gap at (0; )




FIG.6. The temperature dependence of the excitation gap at (0; ) at = 0.02 for t=J = 2. The phase changes as temperature decreases from the uniform phase to the staggered-ux phase and nally to the d-wave pairing phase.

The tem perature dependence of the excitation gap at (0; ) boks alm ost continuous at the transition point between the staggered- ux phase and the d-wave pairing phase (Fig.6), although it is a rst order transition in the present mean eld analysis. The energy at (0; ) are  $E_{staggered}$ ; (0; ) =  $j4ty_h + 3Jy_s=2j_p$  in the staggered ux state, and  $E_d$  pairing; (0; ) =  $\frac{1}{2} + (3J = 2)^2$  in the d-wave RVB state, respectively.

## C.Com parison with experim ents

The ARPES experiments on Bi<sub>2</sub>Sr<sub>2</sub>CaCu<sub>2</sub>O<sub>8+</sub> (BSCCO) [7{13] and recent one on  ${\rm La}_2$   ${\rm SrCuO}_4$ (LSCO) [14] showed that a segment-like Ferm i-surface exists near the (=2; =2) in pseudo-gap region. [7[9]. There is the gap whose symmetry is  $d_{x^2}$   $v^2$ . The gap is largest near (;0) and does not exists on the (0;0)-(;) line. The reason that these Ferm i-surface often called segment-like, or arc, is due to the shape where the spectral weight is nite. It does not form a closed curve. When one scan on the (0;0)-(;) line, the spectral weight only exists in inner region of Brillouin zone (where  $k_x j + k_v j$ ) [8]. Thus, this is called segm ent-like. W hen tem perature decrease, the segm entlike Ferm i-surface becom e smaller in pseudo-gap phase and change to the Ferm i-point in the  $d_{x^2}$   $v^2$  -wave superconducting state [10,13]. On the other hand, the tem perature dependence of the excitation gap at (0; ) alm ost looks continuous at the transition point between the pseudo-gap phase and the  $d_{x^2}$   $v^2$ -wave superconducting phase [13]. Our present results are consistent with these observations.

# VI. SUMMARY

The competition between the staggered ux, or the ddensity wave, and the d-wave pairing is analyzed in twodim ensionalt-J m odelbased on U (1) slave boson m eaneld theory. Not only staggered-ux of spinon but also staggered-ux of holon are considered, independently. In this form alism, the hopping order parameter of electron is described by a product of hopping order parameters of spinon and holon. The staggered-ux amplitude of the electron is a di erence of staggered-ux amplitudes of spinon and holon. A phase diagram is obtained where 1) a region of the electron staggered - ux state exists, 2) the staggered ux and the d-w ave pairing do not coexist, and 3) the ground state is a purely d-wave superconducting state. In - ux phase of spinon, staggered-uxes of spinon and holon cancel com pletely and the staggeredux order of the electron does not exist. However, in the staggered-ux phase of spinon whose staggered-ux is not , uxes do not cancel com pletely and staggeredux order of electron exist. Thus, the phase transition between these two phases, - ux phase and staggeredux phase of spinon, becom es a second order transition in electron picture. The order param eter that characterizes this transition is the staggered-ux order parameter of the electron. The relation between the staggered current of electron and that of spinon is provided. The local cancellation of spinon current and holon current does not exclude the possibility of the electron staggered current. It is proved analytically that the staggered-ux and the d-wave pairing does not coexist except at half-lling. The condition for coexistence of staggered-ux and dwave pairing as a saddle-point solution is provided. The instability of these two states, staggered ux and d-wave pairing, are discussed. The tem perature dependence of following two quantities, Ferm i surface and the excitation gap at (0; ), are shown. The behaviors are consistent with ARPES experim ents. W hen tem perature decreases, the segments-like Ferm i-surface in the staggered ux phase becomes smaller and changes to a point at the transition tem perature to the d-wave pairing phase. The temperature dependence of the excitation gap at (0; ) looks continuous at the transition point between the staggered-ux phase and the d-wave pairing phase although these two phases are qualitatively di erent.

## APPENDIX : COEX ISTENCE CONDITION AND IN STABILITY

It is proved analytically that the staggered ux and the d-wave pairing coexist only at half-lling. The instability of these two states, staggered ux and d-wave pairing, are also discussed.

From self-consistent equations (27)(28)(30), following equation is derived. It must be satis ed for any states whose free energy is at saddle point.

where  $k = \cos k_x - \cos k_y$ , A > 0, B = 0, C = 0. Here, the quantity B is di erent from B which describes the am plitude of the boson-hopping. B is zero at half-lling as = 0, and is negative at nite doping. C is zero at half-lling or when all holon condense at (0;0) or (;), and is negative when excited holon exists or when holon condense at (;0) or (0;) which is the situation of -uxstate. If the staggered ux and the d-wave pairing coexists, y<sub>s</sub> is non-zero. Then in order for the coexistence, eq.(A1) requires that the quantity in the square bracket must vanish. At half-lling, B = C = 0, so the condition is satised. At nite doping B < 0, so if C = 0 there is no coexistence. W hen C 6 0, we cannot expect the quantity in the square bracket vanish except at a special point in the phase space. However, from the continuity of the order param eters, it is in possible to have both  $y_s$ and nonzero only at a single point.

The curvature of free energy at the saddle points of pure staggered-ux state and pure d-wave pairing state have the following form s respectively,

The stability of the states depends on B and C. There are three cases: (i)The case that B and C are both zero: This is realized at half-lling, and  $(@^{2}F = @y_{s}^{2})_{j \in 0, y_{s}=0} = (@^{2}F = @^{2})_{j_{s} \in 0; s=0} = 0$ . We need not discuss this case. (ii) The case that B is negative and C is zero (this is the same situation that Zhang discussed [40]): In this case, pure d-wave pairing are always stable, and pure staggered- ux state is unstable against in nitesimal d-wave pairing. The curvature at each state are  $(@^2F = @y_s^2) j_{e \ 0; y_s = 0} = 2N \ (3J=4)^2B > 0$  and  $(@^2F = @^2) j_{y_s \in 0; = 0} = 2N \ (3J=4)^2B < 0$ . (iii) The case that B and C are both negative: A region where pure d-density wave is stable and a region where d-wave pairing is stable can both exist.

The situation where B is zero and C is negative does not occur. B is zero only at half-lling where C is zero.

However, the ux through a plaquette of ij and that of B<sub>ij</sub> are gauge invariant. O f course, the hopping of the electron,  $c_i^y c_j = i_j B_{ij}$ , is also gauge invariant quantity,  $Be^{i(_{ij} _{j}^{h})} ! Be^{i(_{ij} _{j}^{h})}e^{if(_{i} _{j})(_{i} _{j})g} =$ Be<sup>i(ij h</sup>ij).
