Sensitivity of the Superconducting Transition Tem perature to Changes in the Spin-Fluctuation SpectralW eight

Abstract

In the simplest model of magnetic pairing, the transition temperature to the superconducting state depends on the dynam ical susceptibility (q;!). We discuss how T_c is a ected by di erent momentum and frequency parts of (q;!) for nearly antiferrom agnetic and nearly ferrom agnetic m etals in two dimensions. W hile in the case of phonon-mediated superconductivity any addition of spectral weight to ${}^{2}F(!)$ at ! > 0 leads to an increase in T_c , we nd that adding magnetic spectral weight at any momentum q and low frequencies ($[0:3T_c]$ and $[0:(5 9)T_c]$ for nearly antiferrom agnetic and ferrom agnetic metals respectively) leads to a suppression of T_c . The most e ective frequency and momentum range consists of large momenta (;) and frequencies around $10T_c$ for nearly antiferrom agnetic m etals q and sm all m om enta q 0 and frequencies of approximately (13 $22)T_{c}$ for

I. IN TRODUCTION

In principle there are over one million ternary and over one hundred million quaternary crystalline m aterials. Even the binary compounds number well over eleven thousand. Only a tiny percentage of these materials have been synthesized. Clearly an exhaustive search of the periodic table for superconductivity is out of the question. However, there exist in nature a wide range of compounds which are very close to a magnetic instability, and in quite a number of cases, an anisotropic superconductivity is sometimes connectivity is sometimes connectivity is sometimes connectivity is needed to detect. The heavy-ferm ion superconductor UGe_2^{-1} is a case in point. An intuitive understanding of the trends in T_c not only provides a test of our models of anisotropic superconductivity but can also guide the experimental search for new anisotropic superconductors.

O ne of the most extensively investigated models of an isotropic superconductivity is based on a magnetic interaction, in which quasiparticles interact via the exchange of ferrom agnetic or antiferrom agnetic spin- uctuations. An understanding of the properties of this model is essential in assessing its ability to describe metallic systems on the border of magnetic long-range order. The role of dimensionality, whether one is close to a ferrom agnetic or antiferrom agnetic instability and the sensitivity of T_c to model parameters have been investigated within a mean-eld framework.^{2;4;3} In these calculations, the transition temperature re ects an integral property of the magnetic excitation spectrum and does not tell us how much dierent parts of (q; !) contribute to the answer.

For the traditional isotropic superconductors, the transition temperature T_c depends upon the spectral function 2F (!) which characterises the phonon-mediated electronelectron interaction. The sensitivity of the transition temperature to variations in the spectral distribution 2F (!) was ret investigated by Bergm ann and Rainer⁵. They found that all frequency regions of 2F (!) yield a positive contribution to T_c . Frequencies ! T_c and ! T_c contribute little (nothing in the limit ! ! 0) while frequencies around 2 T_c

contribute the most.

Later M illis, Sachdev and Varma⁸ extended the Bergmann-Rainer analysis of the E liashberg equations to the case of magnetically mediated singlet superconductivity. They assumed that the dynamical magnetic susceptibility could be expressed as a momentum – dependent factor times a frequency-dependent factor and that the spin uctuations could be described by an E instein model. In their model the sensitivity of T_c to changes in the magnetic spectral weight did not depend on the paramagnon momentum q and made the computational analysis of the problem very similar to that of the phonon case. They showed that, in contrast to the latter problem, there is a crossover frequency ! cross such that adding magnetic spectral weight at frequencies ! < ! cross led to a reduction in T_c .

M ore recently, M onthoux and Scalapino⁶ carried out this analysis for the uctuationexchange approximation to the two-dimensional Hubbard model. For thism ore realistic magnetic pairing interaction, which is very non-local in space, they generalized the Bergmann-Rainer approach in order to study how sensitive the transition temperature to the $d_{x^2 y^2}$ superconducting state is to in nitesimal changes in the spectral weight at frequency ! and momentum q. In agreement with the results of Millis et al⁶, they found that adding spectral weight at very low frequencies and for any momentum q led to a reduction in T_c . They also found that there was a region in momentum space near q = 0 where any small addition of spectral weight at any frequency also led to a reduction in T_c . They mapped out the region in q and ! space that gave a positive contribution to T_c , essentially wavevectors near q = (; ;) and frequencies ! > T_c .

Here we report the results of a similar analysis using a param etrization of the elective interaction arising from the exchange of magnetic uctuations. We consider systems on the border of antiferrom agnetism and ferrom agnetism. We study changes in T_c brought about by small variations in the spectral weight at some wavevector q and frequency !. We map out the regions of wavevector and frequency space where a small addition of spin-uctuation spectral weight yields an enhancement or suppression of T_c . This will give a more detailed understanding of the trends in T_c that one calculates from the model. We

shall contrast these ndings with those obtained for the conventional phonon-induced pairing m echanism 5 to gain insights into the sim ilarities and di erences between phonon-m ediated and m agnetically m ediated superconductivity.

II.M ODEL

W e consider quasiparticles on a two-dimensional square lattice and postulate the following e ective action

where $\frac{y}{p}$ and $_{p}$ are G rassm an variables and N is the total number of allowed wavevectors in the Brillouin Zone. The spin density is given by

where is the vector whose components are the three Pauli spin matrices.

The dispersion relation is

where for simplicity we use units in which the lattice spacing is unity. For comparison with earlier work on this model^{2;4} we set $t^0 = 0.45t$ and adopt the value n = 1.1 for the band lling.

W e param etrize the retarded generalized m agnetic susceptibility as:

where and $_0$ are the inverse correlation lengths with and without strong magnetic correlations respectively. The correlation length is related to the pressure applied to the sam ple with $^2 = 0$ coinciding with the quantum critical point. Let

where T_{sf} is a characteristic spin- uctuation tem perature. In the ferrom agnetic case

We obtain the total spin-uctuation propagator on the imaginary axis $(q; i_n)$ via the spectral representation

To get $(q; i_n)$ to decay as $1 = \frac{2}{n}$ as $\frac{1}{n} + 1$, as it should, we introduce a cuto $!_{cut}$ and take Im (q; !) = 0 for $!_{cut}$. A natural choice for the cuto is $!_{cut} = (q) \frac{2}{0}$.

Using the elective action in Eq. (1) and the dynamical susceptibility in Eq. (10), the two-dimensional mean-eld Eliashberg equations for the transition temperature T_c in the M atsubara representation reduce to

 $(p;i!_n)$, $G(p;i!_n)$ and $(p;i!_n)$ are the Fourier components of the quasiparticle selfenergy, the one-particle G reen's function and the anom abus self-energy respectively. In Eq. (13) the prefactor g^2 is for singlet pairing while the prefactor $g^2=3$ is for triplet pairing.

We nd an instability to a d-wave gap function with $(p; i!_n)$ transforming as $\cos(p_x)$ $\cos(p_y)$ in the nearly antiferrom agnetic case and an instability to a p-wave gap function with $(p; i!_n)$ transforming as $\sin(p_x)$ or $\sin(p_y)$ in the nearly ferrom agnetic case.

The momentum convolutions in Eqs. (11) and (13) were evaluated with the aid of a fast-Fourier-transform algorithm on a 128 128 lattice. The corresponding frequency sum swere carried out using the renorm alisation group technique of P ao and B ickers⁷. Between 8 and 16 M atsubara frequencies are kept at each stage of the renorm alization group procedure. The renorm alization procedure is started at a tem perature $T_0 = 0.4t$ and the frequency sum cut-o used is $_{\rm c}$ 20t. The renorm alization procedure restricts us to discrete tem peratures so that the point at which the condition in Eq. (14) is met must be determined by interpolation. The discrete tem peratures were su ciently close that a linear interpolation was adequate. The renorm alization procedure a orded us considerable savings in computer time and storage requirements. Because of this we were able to carry out a thorough analysis of the dependence of our results on the spin- uctuation coupling parameter g^2_{-0} =t and the inverse correlation length parameter 2 .

To investigate how strongly the transition tem perature is in uenced by various frequency and m om entum parts of the param agnon spectral function, we add an in nitesim alam ount of spectral weight at frequencies $!_0 > 0$ and $!_0$ and wavevector q and num erically calculate the change in T_c . M ore speci cally, the param agnon spectral weight is changed from Im (q;!) to Im ((q;!) + (q;!)) with

where is a positive in nitesimal dimensionless parameter. The sum over q_i includes q and those wavevectors in the B rillouin zone related to it by the symmetry operations of the lattice. N_q is the number of such wavevectors including q itself. N is the total number of

allowed wavevectors in the Brillouin zone.

In the M atsubara representation, the addition of this in nitesimal amount of spectral weight corresponds to changing the elective interaction $V_{eff}(q;i_n) = g^2$ $(q;i_n)$ in Eqs. (11) and (13) to $V_{eff} + V_{eff}$ where

The total elective interaction thus depends on the parameters , $_0$, g^2 $_0$ =t as well as the ratio = $_0$, and therefore so does T_c . For sm all , one has

where ::: denote all the other parameters in the problem . The quantity

is a measure of how sensitive T_c is to an in nitesimal change in the value of Im at $(q;!_0)$. We calculate this derivative using the nite-di erence estimate

The value of the parameter $=_0$ must be chosen small enough, such that the function $T_c(=_0)$ is approximately linear in the vicinity of $=_0$. But if $=_0$ is chosen too small, then it becomes very dicult to obtain reliable numerical estimates of the dierences in T_c . We found that $=_0 = 4$ 10⁴ t was a good compromise in the nearly antiferrom agnetic case. A smaller value of $=_0$ was necessary for some of the nearly ferrom agnetic results. In particular, we carried out the nearly ferrom agnetic calculations for $^2 = 0.5$ and $g^2_{-0}=t=$ 10;5 and for $g^2_{-0}=t=$ 30 and $^2 = 2;3;4$ with $=_0 = 5$ 10⁵ t. We estimate that the accuracy with which we calculated the derivative dT_c=d in all cases is of the order of a few per cent.

As in Reference⁸, we de ne a crossover frequency $!_{cross}$ (q) by T_c (q; $!_{cross}$) = 0.

Similarly, one can de ne an optimal frequency $!_{opt}(q)$ as the frequency where T_c is maximum. $!_{opt}(q)$ then indicates which paramagnon frequency and wavevector q contribute most to pairing.

In order to make a comparison with the corresponding electron-phonon problem it is instructive to de ne a mass renormalization parameter $_{\rm Z}$ and interaction parameter $% {\rm R}$. We de ne

in the case of d-wave spin-singlet pairing (d). In carrying out the frequency integrations, we om itted the cuto which was used in Eq. (10). The approximate e ect of the cuto is to multiply and _z by a common factor which is weakly dependent on wavevector and ². This can be ignored since we will only be interested in the quotient $=_{z}$. The Ferm isurface averages are given by

In practice, we compute the Ferm i-surface average with a discrete set of wavevectors on a lattice and we replace the delta function by a nite-tem perature expression

where f_p is the Ferm i function and N is the number of wavevectors in The Brillouin Zone. Note that $\frac{1}{T}f_p(1 \quad f_p)$! (p) as T ! 0. We used T = 0:1t and N = 12%. The nite temperature electrically means that van Hove singularities will be smeared out. The Ferm i-surface average that appears in z, Eq. (20), plays a role similar to that of ${}^{2}F$ (!)=! in the case of phonon-mediated superconductivity.

III. R E SU LT S

The model consists of the parameters $g^2_{0}=t$, $T_{sf}=t$, $_{0}$ and \cdot . It is found experimentally that $T_{sf}_{0}^{2}$ is approximately constant. We shall use this relation to eliminate one parameter from the set and pick a representative value of the product $T_{sf}_{0}^{2}$. We put $T_{sf} = \frac{2}{3}t$ which corresponds to a temperature of 1000 K if the bandwidth is 1 eV, and ${}_{0}^{2}a^{2} = 12$ for comparison with earlier work carried out on this model². To obtain a representative value for the dimensionless coupling parameter $g^{2}_{0}=t$, we make use of the Stoner criterion. In the vicinity of the magnetic instability, $g_{0}(Q;0) = 1$, where $_{0}(q;!)$ is the usual tight-binding Lindhard susceptibility and Q the ordering vector. With $_{0}(Q;0) = N(0) = \frac{1}{8t}$ where N(0) is the single-particle density of states at the Ferm i level, the value of the coupling parameter $g^{2}_{0}=t$ obtained is about 10. We stress that this is only an order of magnitude estimate of the coupling parameter.

Figures 1 and 2 show $T_c(q;!_0)$, Eq.(18), versus frequency $!_0$ for several values of (a) $g^2_0=t$, (b) 2 and (c) q. Figure 1 shows the results in the case of a nearly antiferrom agnetic m etal and Figure 2 shows the results in the case of a nearly ferrom agnetic m etal. By contrast to the phonon case where T_c is always positive, note that there are wavevectors q for which T_c is always negative, which m eans that spectral weight at these wavevectors is deleterious to superconductivity. And if spectral weight is added at su ciently sm all frequencies $!_0$, T_c is negative for all wavevectors q. Finally, note that the overall scale of T_c for nearly ferrom agnetic system s is larger than that for nearly antiferrom agnetic system s. This indicates a larger sensitivity of the relative changes in T_c with respect to changes in the spin- uctuation spectral weight for nearly ferrom agnetic system s.

Figure 3 is a representative plot of

as a function of the wavevector q at which spectral weight is added for several values of !₀=t and for a nearly antiferrom agnetic m etal. T_c⁺ indicates the region of m om entum and frequency space where adding a sm all am ount of spectral weight enhances the superconducting transition tem perature. Figure 4 is a complem entary plot for

which indicates the region of m on entum and frequency space where adding a small amount of spectral weight suppresses the superconducting transition temperature. These results should be compared with the corresponding plots, shown in Figures 5 (T_c^+) and 6 (T_c), for the nearly ferrom agnetic case. We have chosen the values of !₀ for graphs (a-c) to be less than !_{opt} (which, for these parameter values, is about 2.5t in the nearly antiferrom agnetic case and about 0.32t in the nearly ferrom agnetic case) and the values of !₀ in graph (d) to be greater than !_{opt}. The region in wavevector space where T_c^- 0 grows monotonically with !₀, starting from zero when !₀ < !_{cross}, the crossover frequency corresponding to the incipient ordering wavevector. However the maximum value of T_c^- passes through an extrem um at !₀ = !_{opt}, the optim al frequency corresponding to the incipient ordering wavevector. It is interesting to nd that the size of the region T_c^- 0 is approximately the sam e in the nearly antiferrom agnetic and nearly ferrom agnetic cases if !₀ is chosen close to the corresponding optim al frequency !_{opt}, and that it is a signi cant fraction of the total area of the B rillouin Zone. This suggests that except for very small values of 2 , the pairing occurs mostly through the short-ranged magnetic uctuations. Comparing the values of T_c in the frequency and wavevector scans suggests that removing spectral weight from low frequencies may be an elective way to enhance T_c.

We show in Figure 7 plots of T_c^+ for various values of 2° in the nearly ferrom agnetic case. The surfaces are very similar to one another in the small 2° limit. This can also be seen in the T_c versus $!_0$ curves. However, since our mean-eld calculations are likely not accurate very close to the critical point for magnetic order, we cannot state categorically what the limiting values of T_c are. The $T_c = 0$ contour in wavevector space is quite insensitive to the value of 2° , but is, how ever, very sensitive to the value of $!_0$.

Figure 8 shows how the crossover frequency $!_{\rm cross}$ (q) depends on the coupling constant g^2_{0} =t and the correlation wavevector 2° , for the optimum wavevector, namely q = (;) for nearly antiferrom agnetic system s and q = (0;0) for nearly ferrom agnetic system s. The gure shows that $!_{\rm cross}$ (q) when scaled by $T_{\rm c}$, is more robust to changes in g^2_{0} =t and 2° in the nearly antiferrom agnetic case than in the nearly ferrom agnetic case. The value of $!_{\rm cross}$ in the nearly antiferrom agnetic case is about $3T_{\rm c}$ which is quite close to the value $2T_{\rm c}$ obtained in the H ubbard m odel⁶. The value of $!_{\rm cross}$ in the nearly ferrom agnetic case lies between $5T_{\rm c}$ and $9T_{\rm c}$. It is interesting to observe that in the lim it of sm all coupling and far away from the magnetic instability, $!_{\rm cross}=T_{\rm c}$ seem s to approach a value common to both the nearly antiferrom agnetic case, $!_{\rm cross}=T_{\rm c}$ seem s to depend on $T_{\rm sf}$ and $2^{\circ}_{\rm 0}$ only through the product $T_{\rm sf}$ of which is found experimentally to be approximately constant. Therefore $!_{\rm cross}$ is roughly proportional to $T_{\rm c}$. But, for the same parameters, $T_{\rm c}$ scales approximately linearly with $T_{\rm sf}^{2}$. Hence, for $2^{\circ} = 0.50$ in the nearly ferrom agnetic case, $!_{\rm cross}$ scales approximately linearly with $T_{\rm sf}$.

O ne would like to understand the nature of the crossover frequency !_{cross} in terms of phonon-problem -like parameters. M illis and coworkers⁸ showed that, in the antiferrom agnetic magnetic uctuation case,

where d is a d-wave elective interaction constant $d = -\frac{d}{z}$. They assumed that the dynamical magnetic susceptibility can be separated into a wavevector-dependent factor and a frequency-dependent factor and they adopted an Einstein model to describe the frequencydependent factor. They further assumed that the Eliashberg equations can be reduced to equations involving Ferm i-surface quantities only. A similar calculation can be carried out in the nearly ferrom agnetic case yielding

with $p = \frac{p}{z}$. The results of the more complete calculation described in Section II are compared with these expressions for $!_{cross}=T_c$ in Figure 9. Since (= p;d) is not an independent parameter in ourmodel, we calculated $\log(!_{cross}=T_c)$ and 1= for various values of ². One sees that the expressions given in Eqs. (33) and (34) are a poor approximation to the value of $!_{cross}=T_c$ calculated from the E liashberg equations. The dependence of $!_{cross}=T_c$ on is much weaker than $e^{\frac{1}{2}}$ and is not even monotonic in the nearly antiferrom agnetic case. This noting is consistent with the inability to obtain a simple analytic expression similar to that proposed by M dM illan to represent the T_c calculated numerically via the E liashberg equations²?⁴.

We show in Figure 10 the variation of the norm alised optim al frequency $!_{opt}(q) = T_c w$ ith $q^2_0 = t$ and 2 in the nearly antiferrom agnetic case, with q = (;), and nearly ferrom agnetic case with q = (0; 0). In the nearly antiferrom agnetic case $!_{opt}$ is approximately a constant equal to $10T_c$, which is close to the value it takes in the Hubbard model⁶. It is also of the same order of magnitude as $2 T_c$, the value it takes in the electron-phonon problem ⁵. In the nearly ferrom agnetic case $!_{opt}$

As shown by Bergm ann and Rainer for the phonon problem 5 , it is instructive to compare the frequency dependence of the spectral function with that of T_c. The results for the nearly antiferrom agnetic case and q = (;) are shown in Figure 11 for various values of

Figure 11 shows that in the small ² lim it (strong coupling) the peak in the spectral weight lies below the optimum frequency $!_{opt}$, while for large ² (weak coupling) it lies above $!_{opt}$. This is analogous to the results of Bergm ann and Rainer who found that the transverse phonon mode was below the optimum frequency $!_{opt} = 2$ T_c for strong coupling superconductors such as Hg and above $!_{opt}$ for weak coupling superconductors such as In. The results of Figure 11 suggest an explanation for a maximum T_c as a function of ². As ² ! 0, while the d-wave component of the pairing interaction increases, the frequency at which the spin- uctuation spectral weight is maximum becomes a suppression of T_c.

O ne might have expected that the ² for which T_c is maximum would be such that the peak in the spin- uctuation spectral weight coincides with $!_{opt}$. But for $g^2_{0}=t=10$, the maximum T_c is found at ² 0:35, while the match between the peak in the spectral weight and $!_{opt}$ occurs for ² 1. The shift in the peak of Im V_d relative to $!_{opt}$ allows one to understand the trends in T_c , but the arguments remain qualitative.

Since the location of the peak in the spectral function does not depend on the value of g^2_{0} =t and our results show that the frequency $!_{opt}$ is approximately constant in the nearly antiferrom agnetic case, one does not gain new insights by looking at the frequency dependences of Im V_d (q; $!_{0}$) and T_c (q; $!_{0}$) for di erent coupling constants.

In the nearly ferrom agnetic case, since Im (q ! 0; !) = 0 for ! $\neq 0$, one sees that the situation is quite di erent and thus the shape of the curves Im $V_p(q ; !_0)$ and $T_c(q ; !_0)$ for the optimum wavevector q = 0 will not be similar, unlike the phonon and nearly antiferrom agnetic cases.

IV . D ISC U SSIO N

Our results dem onstrate a num ber of signi cant di erences as well as sim ilarities between the magnetic uctuation-and phonon-pairing mechanisms. In the latter case, the interaction is local in space but non-local in time. This means that there should be almost no variation of $T_c(q;!_0)$ with q and therefore one only need worry about the dependence of T_c on frequency. In the case of magnetic pairing however, the interaction is non-local in both space and time and as a result $T_c(q;!_0)$ exhibits a dependence on both wavevector q and frequency $!_0$.

In the phonon case⁵, addition of an in nitesim al amount of spectral weight at any nonzero frequency $!_0$ results in an enhancement of T_c , with an optimum frequency of 2 T_c . In the limit $!_0 ! 0$, $T_c ! 0$, which is consistent with Anderson's theorem⁹ for isotropic superconductors. On the other hand, for the magnetic interaction model, addition of spectral weight at su ciently low frequencies results in negative values of T_c. The intuitive understanding of this result⁸ is also related to Anderson's theorem . Very low frequency param agnons electively act as a static non-magnetic in purity potential that scatters the quasiparticles. For an isotropic superconductors, Anderson's theorem does not apply and the presence of non-magnetic in purities leads to a supression of T_c . A lso note that for certain wavevectors q , $T_c(q; !_0)$ is always negative, regardless of !₀.

There are also signi cant di erences between the nearly antiferrom agnetic and nearly ferrom agnetic cases. For instance, the crossover frequency $!_{cross}$ at which $T_c(q;!_0) = 0$ dependsmore weakly on the model parameters 2 and $g^2_0=t$ in the nearly antiferrom agnetic case than in the nearly ferrom agnetic case. ($!_{cross}$ is strongly dependent on q in both cases.) Similarly, the optimum frequency $!_{opt}$ at which $T_c(q;!_0)$ is maximum is more weakly dependent on the model parameters 2 and $g^2_0=t$ in the nearly antiferrom agnetic metals than in the nearly ferrom agnetic metals. Moreover, the overall scale of T_c is much larger in the form er case than in the latter, indicating a much greater relative sensitivity of T_c to changes in the spectral weight for nearly ferrom agnetic system s.

O ur results also show sim ilarities between m agnetically m ediated and phonon-m ediated superconductivity. In all cases, the shape of the T_c curves are monotonic with a single optimum frequency (for each wavevector) and, in the high-frequency regime and for wavevectors such that T_c > 0, the curves behave similarly. The decrease of T_c with increasing $!_0$ approximately m information the dange in the interaction parameters as V_{eff} .

The relative positions of the peak $!_{max}$ in the spectral weight $\text{Im } V_d (q = (;);!)$ and optimum frequency $!_{opt}$ in the strong coupling limit where $!_{max} < !_{opt}$ and weak coupling limit in which $!_{max} > !_{opt}$ is similar in some respects to the indings of Bergmann and Rainer⁵ for the phonon problem. In that case, the transverse phonon frequency is below the optimum one for strong coupling superconductors and above in the weak coupling case.

Figure 2 (c) shows a feature that m ay partially explain the di culty in observing superconductivity on the border of itinerant ferror agnetism. Our results (see Figure 2 (c)) show that adding spectral weight at large wavevectors is detrimental to T_c . In other words, antiferror agnetic correlations act to suppress pairing in nearly ferror agnetic systems. In the presence of a lattice, one would generically expect some enhancement of the magnetic response at large wavevectors due to nesting features in the Ferm i surface for nearly-half-lled electronic bands. As explained in References ²^{,4}, magnetic pairing in nearly antiferrom agnetic systems. The antiferrom agnetic correlations inherent to the presence of a crystal lattice tend to suppress magnetic pairing in nearly ferrom agnetic systems, thus making it even m one di cult to observe.

V.OUTLOOK

The dependence of the superconducting transition temperature on model parameters and the role played by dimensionality for O mstein-Zemike like spin- uctuation spectra has been studied in some detail^{2;4}. However, these calculations relect an integral property of the dynamical susceptibility (q;!). In this paper, we presented a study of how dimensions in wavevector q and frequency ! individually contribute to T_c , giving us novel insights into the magnetic interaction model.

The calculations were carried out by adding in nitesimal amounts of spectral weight at dierent wavevectors and frequency and determining the resulting changes in T_c from the numerical solution of the Eliashberg equations. We stress that the work reported here

provides insight only into how di erent regions in q and ! contribute to pairing for the particular magnetic- uctuation spectrum (q;!), Eq. (10). One may infer certain trends in T_c for small changes in the spin- uctuation spectrum, but it may not be warranted to extrapolate our results to large changes in the magnetic spectrum. A lso, the calculations are carried out at T_c . They may give one some idea of how the robustness of pairing is a ected as one goes below T_c and the electronic gap induces changes in the momentum and frequency structure of (q; !), but this involes another extrapolation to large changes in the magnetic spectrum which may not be warranted.

W e found that addition of spectral weight at or near the incipient ordering wavevector in the nearly antiferrom agnetic and nearly ferrom agnetic cases lead to an enhancement of T_c , except at low frequencies where it leads to a suppression of the superconducting transition temperature. However, addition of spectral weight far away from the incipient ordering wavevector results in a lowering of T_c regardless of frequency. These results are in stark contrast to those obtained for phonon-mediated superconductivity where addition of spectral weight at any non-zero frequency leads to an enhancement of the superconducting critical temperature.

The theoretical fram ework presented here to describe system s on the border of m agnetism can be translated to describe system s on the border of other types of instabilities, such as charge-density-wave or ferroelectric instabilities. The same type of calculations could be carried out in those other cases, and compared to the results of this paper, shedding light on the sim ilarities and di erences between the m any possible pairing m echanism s.


FIG.8. The dependence of the crossover frequency $!_{cross}$, norm alised by the superconducting transition temperature T_c , on (a) the coupling parameter g^2_0 =t and on (b) the inverse correlation length ². Both graphs exhibit results obtained in the nearly antiferrom agnetic (NA) case and for three values of the parameter pair (T_{sf} ; 2_0), keeping the product T_{sf} 2_0 constant, in the nearly ferrom agnetic (NF) case. Throughout we have put q = (;) in the nearly antiferrom agnetic case and q = (0;0) in the nearly ferrom agnetic case.


FIG.9. Comparison of our results for the crossover frequency in (a) the nearly antiferrom agnetic case (circles) and (b) the nearly ferrom agnetic case (circles) with the result $!_{cross}=T_c$ $e^{\frac{1}{c}}$, Eq. (33) (squares). We have put the prefactor in this form ula equal to one for the sake of com – parison. We have calculated $!_{cross}$ with $g^2_{0}=t=10$, although the elective interaction constant




FIG.10. The dependence of the optim al frequency $!_{opt}$, norm alised by the superconducting transition temperature T_c , on (a) g^2_0 =t and (b) 2 . We have put $T_{sf} = 0.67$, $^2_0 = 12$ and q = (;) in the nearly antiferrom agnetic case and q = (0;0) in the nearly ferrom agnetic case.


FIG.11. Comparison of T_c = $\frac{0}{T_c} \frac{dT_c}{d}$ (solid line) and Im V_d (dashed line) for various values of the parameter ² for a nearly antiferrom agnetic m etal. The functions are plotted for a value of the coupling g^2_{0} =t = 10 and a wavevector q = (;).














Nearly Antiferromagnetic
