# Ham iltonian Renorm alization G roups

## I.Q ualitative Introduction to Renorm alization G roups (RG)

The RG has been introduced originally in order to handle ultraviolet divergencies in Quantum Electrodynamics. In the late sixties it has been realized by Fisher and Kadano (1) that critical exponents in phase transition can be computed within a RG calculation with a nite cuto . In the seventies the m ethod has been applied to solve the K ondo problem (2,3). In the eighties it has become clear that quantum phase transition at T = 0 and Quantum critical behavior can be studied within the RG method. Today the RG m ethod has become the major tool for investigation of strongly correlated system sat low tem perature. In m any problem swe know the H am iltonian but the Lagrangian might be complicated. Since the original RG method is based on mapping the quantum problem to Euclidean eld theory the absence of a simple action m ight be a problem. In the last years we have developed a method based on the Hamiltonian formalism (4). Here we will present this version of RG. In particular we will use this method to solve the sine-G ordon problem in 1 + 1 dimension which has a Kosterlitz-Thouless transition.

### II. O rder Param eter

The magnetization, the density, or the U (1) phase represent the order parameter and characterizes the phase transition. In all these problem s we are interested in the behavior at long distance. As a result many di erent microscopical problem might have the same long distance (low-energy) behavior. We will assume that we have an ultraviolet cuto , reducing to  $^{0} = = s, s > 1$  such that the measure remains invariant,

and we can construct the renorm alized ham iltonian (h[;P] is the ham iltonian density, " " is the order parameter, "P " is the canonical momentum  $[(x;t);P(x^0;t)] = i (x x^0)$ ). The long distance behavior is obtained from the existence of xed point (a set of coupling constants which are unchanged under ! =s)

#### III. M icroscopic M odels

We will be interested in application to strongly correlated system s H =  $d^dxh[(x);P(x)]$ , where  $h = h_0 + h_I$ ,  $h_0$  is the free apart and  $h_I$  is the interacting part.

for d > 1,  $(\mathbb{Q}_x)^2 \xrightarrow{P} \frac{d}{d_{i=1}} (\mathbb{Q}_i)^2$ , x  $(x_1; d)$  x The Ising model is investigated choosing K = 1 and  $h_{I}[(x)] = \frac{1}{2}U_2^{-2}(x) + \frac{U_4}{4!}^{-4}(x)$ . Interacting electrons in  $1_p + \frac{1}{2}$  dimensions are described by d = 1, 0 < K < 2 with  $h_{I}[(x)] = U \cos(\frac{1}{8}(x))$  with a Kosterlitz-Thouless transition phase characterized by U = 0 with a continuous line of xed points K. For U (s) ! 0 we obtain a set of Luttinger liquids characterized by 0 < K < 2.

#### IV Constructing RG

Our starting point is the ham iltonian density,  $h[(x); P(x)] = h_0[(x); P(x)] + h_1[(x)]$ , where  $h_0[(x); P(x)]$  is given in eq. (2) and  $h_1[(x)] = \int_{P}^{P} u_i O_i(x)$  with  $O_i(x)$  being monomial of (x). The elds (x) (x) and P(x) = P (x) are restricted by .

The RG procedure is based on the following steps:

(a) Project out states in the momentum interval = jqj < using the "Heisenberg picture", choose s = exp', with '! 0 (in nitesimal). The

projection is done such that  $T \exp\left[\frac{i}{h}^{R} dt^{R} d^{d}xh\left[(x;t);P(x;t)\right]\right]$  remains in-variant.

(b) In the second step the cuto =s is restored to by increasing the unit length by a factor of s,  $x^0 = x=s$ ,  $t^0 = t=s$ .

(c) In the last step we determ ine the scaling dimension of (x) and P (x) such that dt  $d^d xh_0[(x;t);P(x;t)]$  remains invariant:  $_{=s}(x;t) = _{=s}(x^0;t^0s) = s$  ( $x^0;t^0$ ) and P  $_{=s}(x;t) = s^{-1}P(x^0;t^0)$  " " is the scaling dimension of (x). From the invariance of the free part (eq. (2)) we obtain  $= \frac{1}{2}(d+1)$  1. Using the scaling dimension of (x) we not the scaling dimension of the monom ials,  $O_{i;=s}(x;t) = s^{-i}O_{i;}(x^0;t^0)$ . This leads to the scaling of the coupling constants  $U_i(s) = s^{d+1} - iU_i(s = 1)$ . When d+1 - i > 0,  $U_i$  is relevant and ow sto 1 fors ! 1. When d+1 - i < 0,  $U_i$  is irrelevant,  $U_i$  ! 0. When d+1 - i = 0,  $U_i$  is marginal.

In order to show how the steps (a) to (c) are implemented we will consider a model in 1 + 1 dimension (d = 1).

We rst separate out the fast modes from the slow ones in the eld (x) as well as its canonical conjugate P (x):  $(x) = {}^{<}(x) + (x)$ ; P  $(x) = P^{<}(x) + P(x)$ . We assumed that there is a momentum cut-o. The slow parts,  ${}^{<}$  and P  ${}^{<}$ , contain those components with momenta jgj =s, while the fast ones, and P, hold the contributions from the momentum shell, =s < jgj , As a result we nd

we keep only  $((x))^n$ , n 2 since we work in the limits ! 1.

To nd out the e ective ham iltonian of the slow modes, we need to integrate out the fast modes de ned in the momentum shell. In the ham iltonian language we have to take the expectation value with the "fast mode" ground state at  $t = 0, j^{>} (t = 0) > jGS^{>} > .$  This corresponds to the "Heisenberg picture" with time dependent operators (x;t), P(x;t). We can achieve this by a unitary transform ation such that the linear coupling between the

eld with the slow modes < is removed. (The elds < (x), P < (x), remain in the Schrodinger picture, only (x;t) and P (x;t) are in the "Heisenberg picture".) This can be carried out by introducing the following unitary transform ation U:

r(x) and (x) are chosen such that the linear term disappear from the transform ed ham iltonian. U sing the H eisenberg eq. of motion we have

Dem and ing  $[(x;t); P(x;t)] = [{}^{0}(x;t); P^{0}(x^{0};t)]$ , we obtain that, (x) and r(x) are not independent:  $(e_{t}r(x;t)) = vK(x;t)$ . We choose  $U = \exp[\frac{i}{2} \prod_{1}^{R_{1}} dx[r(x) P(x) (x) (x)]]$ . By applying the unitary transformation, we get

In eq. (7) we de ne:  $\hat{L} = \frac{1}{vK} \theta_t^2 \frac{v}{K} \theta_x^2 + h_I^0(<x)$ . To set the term zero, we need;  $\hat{L}r(x;t) = h_I^0(<x)$ . This gives the form all solution  $r(x;t) = dy dt^0 G(x;y;t t^0)h_I^0(<y;t^0)$  where  $G(x;y;t t^0)$  is the Green's function of the operator  $\hat{L}$ ,  $\hat{L}G(x;t;t;t^0) = (x y)$  (t t). Since  $\langle x \rangle$  is time independent r(x) is determined only by the spatial Green's function,  $\hat{G}(x;y) = \frac{R_t}{1} dt^0 G(x;y;t t^0)$ . By substituting the solution into eq. (7) we nd

Eq. (8) is exact and the G reen's function G  $(x;y;t;t^0)$  is restricted to the momentum shell. G (q;!) is the Fourier transform of G  $(x;y;t;t^0)$  with =s jgj and 1 ! 1. Since only high momenta in the shell are involved, we replace  $\hat{G}$  by  $\hat{G}^{(0)}$  (the free G reen's function). Now we average H<sup>0</sup> over the ground state of the fast modes. We use  $s = \exp 2$ , 2 and nd:

V.Applications to the Sine-Gordon model

We choose  $h_{I}(<) = U \cos(8)$  we substitute into eq. (9) and add to eq. (9) the term H[<;P] (see eq. (3)). As a result we not the elective ham iltonian

We see that the ham iltonian has the same form as the original one. The superscript "<" indicate that the cut-o of the current model is =s and C 1. To compare with the original system, we need to restore the momentum cut-o to by appropriately rescaling the elds and the parameters. It is advantageous to work with the dimensionless coupling constant g, U = g<sup>2</sup>. So by rescaling the momentum, k ! k=s, or in real space, x ! xs, t ! ts and dem anding that  $dtH_0^{<}$  is invariant, we get the new set of parameters  $\frac{v^0}{K^0} = \frac{v}{K} [1 + C(\frac{v}{K})^2 \frac{u^2}{4}]$  in terms of the old ones:  $v^0 K^0 = vK$  and using s = exp(') with 'a positive in nitesimal, we get the -functions:

An non-trivial xed point is observed to locate at K = 1 and  $g_r = 0$ . Near the point we can de nea new set of variables  $x = 2 (K = 1); y = \frac{C}{2v_0^2}g$ ,  $v_0$  is the ferm i velocity before scaling  $v(Y = 0) = v_0$ . The -functions becomes  $\begin{array}{rcl} \frac{dx}{d'} &=& y^2; \ \frac{dy}{d'} &=& xy \ \text{with the solution} \ x^2 \ (`) & y^2 \ (`) &=& x^2 \ (0) & y^2 \ (0) \\ \mbox{const. The scaling equation for the speed } v \ \mbox{is not necessary since the product } v \ (`)K \ (`) \ \mbox{is a constant. The value for } v \ (`) \ \mbox{can be found trivially by} \\ v \ (`) &=& \frac{v \ (`=0)K \ (`=0)}{K \ (`)}. \end{array}$ 

The RG ow determ ined by eq (12) was not reached by K osterlitz and Thouless (5). There are two trivial xed points, corresponding to the cases y goes to plus/m inus in nity. In the ferm ion language the lim it y + 1 corresponds to the in nite repulsion for particles on neighboring lattice and it is obvious at half-lling the corresponding phase is the M ott insulator. In the opposite lim it y + 1, the corresponding phase at half-lling is a band insulator in which the unit cell of the lattice is doubled and a gap is form ed at the surface of the ferm i sea. There is a third phase which is described by the line y = 0 on the ow diagram. This is the Luttinger liquid, or the spin-liquid phase. The part with x > 0 is a stable liquid phase while the x < 0 part is unstable.
