# S low rotation of a super uid trapped Ferm igas

#### Abstract

$T$ he $m$ om ent of inertia, , is one of the possible observables for the experim ental determ ination whether a trapped Ferm isystem has reached the BCS transition or not. In this article we investigate in detail the tem perature dependence of below the critical tem perature T c. Special care is taken to account for the sm all size of the system, i.e., for the fact that the trapping frequency $\sim$ ! is of the sam e order ofm agnitude as the gap. It is shown that the usualtransport approach, corresponding to the leading order of an expansion in powers of $\sim$, is not accurate in this case. It tums out that does not change rapidly if $T$ becom es $s m$ aller than $T_{c}$, but it rather decreases slow ly. Q ualitatively this behavior can be explained w ithin the two-uid model, which again corresponds to the leading order in $\sim$. Q uantitatively we nd deviations from the two-uid m odel due to the sm all system size.

## I. INTRODUCTION

Since the nst observation of B ose E instein condensa-
 becom e clear that ultra-cold trapped atom ic gases provide an excellent toolto study quantum e ects in system $s$ which are alm ost visible to the naked eye. For exam ple, quantized vortices in the B ose condensate w ere created by stirring the B ose condensate w ith the help of a laser beam $\left[\begin{array}{ll}{[1]}\end{array}\right]$. A lso the quantum pressure related to the P auli principle could be observed in gases oftrapped ferm ionic
 the degeneracy tem perature can be reached.

If it w as possible to trap tw o spin states of a ferm ionic isotope w ith attractive interaction, and to cool the system below the critical tem perature $\mathrm{T}_{\mathrm{c}}$, one could study the BCS transition to the super uid phase. Unlike the transition of B ose gas to the B ose E instein condensate, the BCS transition ofa Ferm igas alm ost does not change the density pro le of the atom ic cloud [7] [1. H ow ever, there are other observables which $m$ ay allow to distinguish between the norm al uid and the super uid phase. In a preceding paper [d] the $m$ om ent of inertia w as proposed, since it is much $s m$ aller in the super uid phase than in the nom al- uid phase (see also Ref. [19] $\underline{1}_{1}^{1}$ ). A nother observable changing from one phase to the other are the frequencies of collective m odes $\left[\frac{1}{1}, 10_{1}^{1}, ~[1] 1_{1}^{1}\right]$. For exam ple, the frequency of the so-called \scissorsm ode", an oscillation of the sym $m$ etry axis of the cloud $w$ ith respect to the sym $m$ etry axis of the trap, is closely related to the mo $m$ ent of inertia [0] [i] R ecently one $m$ ore observable for the detection of the BCS transition was proposed, nam ely the change of the deform ation of the cloud during the expansion of the system when the trapping potential is sw itched o rīb.

The $m$ om ent of inertia of a super uid gas of trapped ferm ionic atom $s$ at zero tem perature was evaluated for the rst tim e in Ref. [ill in close analogy to the calculation of the $m$ om ent of inertia of super uid nuclei $\left.[13]_{1}^{1}\right]$. This derivation was very sim ilar to the one given by $M$ igdal m ore than 40 years ago [14, except that everything w as
reform ulated in phase space in term $s$ of $W$ igner trans form s . In the present article we will generalize the calculation of $R$ ef. [ $\left[_{1}^{1}\right.$ ] to the case of non-zero tem perature. In addition, we w ill give a derivation which further clari es certain points which in Ref. [\%] ${ }^{1}$ ] ay have been passed over rather quickly.

In addition to the tem perature dependence of the mo $m$ ent of inertia, we will address an interesting question which is relevant already at zero tem perature. In nuclear physics it is well know $n$ that the $m$ om ent of inertia of super uid nuclei is much sm aller than the rigid-body value, but still higher than the value corresponding to a purely irrotationalm otion, and that the currents in rotating nuclei have both rotational and irrotational com ponents [1] $\left.{ }^{1}\right]_{1}^{1}$. $T$ he sam e behavior is found in trapped Ferm igases at zero tem perature [i]. In contrast to this, the ordinary hydrodynam ical or transport equations for super uids at zero tem perature, which can be derived from the $\sim$ ! 0 lim it of the tim e-dependent $H$ artree-
 allow only for a purely imrotationalm otion. W e w illw ork out this di erence and discuss the lim its of validity of the hydrodynam ical description.

T he article is organized as follow s: In Sect. II we give a brief review of the form alism, $m$ ainly in order to recallsom e de nitions and to clarify our notation. In Sect. IIT we derive the expression for the density $m$ atrix of the slow ly rotating system w thin linear-response theory. $T h$ is is the generalization of the calculation of $R$ ef. [ ll$]$ to non-zero tem peratures. In Sect. 'IV-1 we again derive the linear response of the density $m$ atrix, but now using the leading order of the ~ expansion of the TD H FB equation. In Sect. V V. we show num erical results for the m om ent of inertia obtained w ithin both form alism s as a function of tem perature and interprete the results and their di erences. $F$ inally, in Sect. $\bar{V} \overline{1} \mathbf{I}$, we sum $m$ arize and draw our conclusions.

## II. BRIEFREVIEW OFTHEFORMALISM

Before considering the rotating super uid trapped Ferm i gas, we will brie y review the equilibrium case. O ur intention is to explain our notation and conventions. D etailed discussions of the sub ject can be found in $m$ any


In this article we assum e for sim plicity that equalnum bers of atom $s$ with two spin projections $=$ "; \# are trapped in a spin-independent harm onic potential

If the density of the trapped system is very low, the atom atom interaction can be approxim ated by a zero-range interaction $w$ ith a coupling constant $g$ proportional to the s-w ave scattering length. D ue to the Pauliprinciple only atom sw ith opposite spin pro jections can interact in this w ay. U nder these assum ptions the ham iltonian takes the form

The $m$ ean- eld potential corresponding to this interaction reads

(N ote that $w$ ith this de nition the localpart of the density m atrix, ( $r$ ) ( $r$; r) corresponds to the density per spin state.) In the presence of pairing correlations, the pairing gap is given by the gap equation

It will tum out that the self-consistent solution of Eq. $\left.{ }^{(515}\right)$ is divergent as a consequence of the zero-range interaction. In the literature several ways how to regularize
 the technical details of the solution of Eq. (S) are not im portant for our purpose.

In order to w rite dow $n$ the $H$ artree Fock B ogolinubov (HFB) equations, which relate the density $m$ atrix and the pairing tensor to the potentialV and the gap, it is usefiulto expand allquantities in a basis of single-particle
wave functions ' $n(r)$, where $n$ represents all quantum num bers except spin, i.e., for an arbitrary operator A :

W hat is relevant for our purpose is the spectrum of the lowest lying quasiparticles, which for a su ciently sm all gap can be obtained within the BCS approxim ation, which is much sim pler than the solution of the full HFB equation (13). We choose a basis in which $h$ is diagonal, i.e., $\mathrm{h}_{\mathrm{nn}}{ }^{0}=\mathrm{h}_{\mathrm{n}} \mathrm{nn}^{0}$. Then, w ithin the BCS approxim ation, and are diagonal, too, and given by

The quasiparticle energies $\mathrm{E}_{\mathrm{n}}=\mathrm{p} \overline{\mathrm{h}_{\mathrm{n}}^{2}+{ }_{\mathrm{n}}^{2}}$ and the quasiparticle occupation numbers $f\left(E_{n}\right)=$ $1=\left[\exp \left(\mathrm{E}_{\mathrm{n}}=\mathrm{T}\right)+1\right]$ are determ ined by the diagonal $m$ atrix elem ents $n \quad n n$ alone. If we neglect the non-diagonalm atrix elem ents of , which are irrelevant for the excitation spectrum and, apart from that, m uch sm aller than the diagonal ones, we can rew rite Eqs. (14) and (15) in the com pact form

It is evident that the generalized density $m$ atrix $R$ given by Eq．（1－1）solves the HFB equation（13）ifh and are assum ed to be diagonal．

For the spherical case（ $!_{0 x}=!_{0 y}=!_{0 z}$ ）and moder－ ate num bers of particles $\left(\mathbb{N}<10^{4}\right)$ ，the self－consistent HFB equation can be solved num erically $\left.{ }^{20}{ }^{-1}\right]$ ．H ow ever， for the deform ed case and large num bers of particles（ex－ perim entally num bers of the order $N \quad 1 \Phi^{\Phi}::: 10^{6}$ have been reached），even w thin the BCS approxim ation，the self－consistent solution becom es num erically intractable． Therefore it m ay be indicated to apply sem iclassical ap－ proxim ations．Sem iclassical $m$ ethods can becom e very accurate for large num bers of particles，and in addition they often allow for a very clear interpretation of the re－ sults．To that end we will use the $W$ igner transform $s$ of the density $m$ atrix ，the pairing tensor ，the single－ particle ham iltonian $h$ ，etc．$T$ he $W$ igner transform of a single－particle operator A is de ned as

 consistently $\underline{l n}_{1,1}^{\prime \prime}$ ， 1$]$ ．Since the pairing gaps and tem pera－ tures considered in this article are very sm all com pared w ith the Ferm i energy，we will use Eq．（211）also in the presence of pairing correlations and at non－zero tem pera－ tures．（T hee ect ofpairing correlations and tem perature on the density pro le（r）was investigated in Ref．［ $\left.\overline{[ }_{1}\right]$ ）． Furtherm ore，in this article we are not interested in the details of the density pro le（r）．A s shown in Ref．［大⿴囗十⿱一⿴⿻儿口一己 $]$ ， the self－consistent solution for $(r)$ can be described to good accuracy by approxim ating the self－consistent po－ tentialV（r）again by a harm onic potential

Contrary to the $T$ hom asferm iapproxim ation for the unpaired density m atrix，Eq．（2 $2 \overline{1}_{1}^{\prime}$ ），which is valid if the potential can be regarded as constant on a length scale of the inverse Ferm im om entum，the local－density ap－ proxim ation in the paired case is valid only if the poten－ tial is also constant on a length scale of the coherence length of the C ooper pairs．T his latter condition is often
 sem iclassical $m$ ethod for the calculation of the gap has been proposed，which，how ever，results in an average gap （ $m$ ore precisely：gap averaged over the Fem i surface）of alm ost the sam em agnitude as the average gap obtained w thin the localdensity approxim ation．

## III. LINEAR RESPONSE TO A SLOW ROTATION

In this section we w ill describe the form alism used for the calculation of the $m$ om ent of inertia of a super uid gas of trapped ferm ionic atom $s$. Looking at a system rotating w ith angular velocity around the $z$ axis, we can calculate the $m$ om ent of inertia from

Where $(r ; p)$ is the density $m$ atrix of the rotating sys tem. H ence the $m$ ain problem in calculating the $m$ om ent of inertia is to calculate $(r ; p)$, from which also other interesting quantities like the current density (per spin state)

T he system is put into rotation by rotating the external trapping potential around the $z$ axis (of course, for this purpose the trapping potential m ust not be axially sym $m$ etric). In the rotating fram e, how ever, the system is still in a stationary state. In this fram e, the H am iltonian receives the additional term

which for su ciently sm all can be treated as a perturbation. T hisperturbation induces a change of the density $m$ atrix, 1 , and of the pairing tensor, 1 . Them ean eld potential is not changed to linear order in, $\operatorname{since} L_{z}$ is a tim e-odd operator. Linearizing Eq. (13), we obtain

where $H$ and $R$ denote the unperturbed quantities, while $H_{1}$ and $R_{1}$ refer to the deviations. ( T his is equivalent to solving the linearized G orkov equations for the norm al and anom alous $G$ reen's functions at equaltim es; see, e.g., $R$ ef. [23].) $T$ he solution reads:

In practice, Eq. ( $3-13)$ is an integral equation, since the change of the gap, 1 , on the rh.s. is related to the change of the pairing tensor, 1 , by the gap equation. In analogy to Eq. (2-6) the gap equation for the perturbed quantities reads

The solution of this integral equation contains som e subtleties. For exam ple, the divergence appearing in Eq. (38) as a consequence of the zero-range interaction has to be regularized in the sam e w ay as the correponding divergence of the unperturbed gap equation (2-6) (see appendix), and the derivations of Eq. (4.34) in Ref. [in or the second equation after Eq. (16) in R ef. [14] are not very explicit about this point. H ow ever, these problem s can be circum vented in the follow ing way [15, 18, 19]: Suppose all single-particle wave functions are m ultiplied by the sam e localphase $\exp [i(r)]$. T hen the H FB equation (13-1) can be rew ritten in term $s$ of the gauge-transform ed $m$ atrices

H ow ever, as we have seen in the previous section, in a sm all system where ~! is of the sam e order ofm agnitude as , the velocity eld is not irrotational. O ur conclusion is that one should be carefulw hen applying transport theory to such system s.

So far we have considered only the zero-tem perature lim it. In the rem aining part of this section we are going to consider also the case $T>0$. In this case it is di cult to solve the coupled Eqs. ( $88 \mathrm{~B}_{1}^{1}$ ) and $\left(88 \mathrm{~B}_{1}^{1}\right)$. ## V. RESULTSAND D ISCUSSION

U sing the results for change of the non-local density $m$ atrix ${ }_{1}(r ; p)$ given in the previous sections, we can now calculate them om ent ofinertia. It should be rem em bered that an idealFerm igas at zero tem perature behaves like a rigid body, i.e., the velocity eld is given by $\mathrm{v}(\mathrm{r})=\mathrm{e}_{\mathrm{z}}$ $r$. Since the critical tem perature for the BCS transition is very low, will approach the rigid-body value riqid for $T!T_{C}$. U sing the $T$ hom asFerm idensity pro le (211) w ith the e ective ham onic oscillator potential (231), we can im m ediately calculate rigid. T he result reads

The previous paragraph can be summ arized in the statem ent that the transport approach, corresponding to the leading order of the $\sim$ expansion, reproduces the two- uid m odel for hom ogeneous system s . It does not give any nite-size corrections, as can be seen from the fact that the result does not depend on the trapping frequencies, except for the purely geom etrical dependence contained in rigid and irrot. In contrast to this, the $m$ ethod described in Sect. 'IIt is capable to describe the di erent behavior of the system depending on whether the trapping frequencies ( m ultiplied by $\sim$ ) are sm all or large com pared w ith the gap. . This dependence is govemed by the G factors appearing in Eq. (10011), resulting from the long-tim ebehavior of the operator $\widetilde{K}_{1}(t)$ [see discussion after Eq. ( $\left.5 \underline{L}_{1}^{\prime}\right)$ ]. In order to reproduce this behaviorw ithin the ~ expansion, one would have to resum a certain class of corrections proportional to $\sim!=$ to all orders, in particular if one wants to cover the w hole range of possible param eters from $\sim$ ! to $\sim$ !

Let us now proceed to a quantitative analysis. In order to calculate the $m$ om ent of inertia as a function of tem perature, we need the tem perature dependence of the gap. A s in Ref. [\$్区N, we w ill assum e that it is described by the sam e universal function relating $=0$ to $T=T_{c}$ in hom ogeneousm atter, where 0 denotes the gap at $T=0$ and $T_{c}=0: 567 \quad 0$. This universal function is given by the solution of the non-linear equation [2] ]

tem perature dependence of discussed above, and via the explicit tem perature dependence of the function $G(x)$ due to the therm alquasiparticle occupation num bers as given by Eq. (633). Ifonly the tem perature dependence of w as included, $\mathrm{G}($ " $=2$ ) as a function of " w ould becom e very strongly peaked at " = 0 for $T!T_{c}$. H ow ever, due to the explicit tem perature dependence of the function $G(x)$, the peak is suppressed and as a function of " the function $G("=2)$ even becom esm ore and $m$ ore at with increasing tem perature, as show $n$ in $F$ ig. of $(0)$ when $T$ approaches $T_{c}$ re ects the decrease of the super uid fraction in the two- uid model.

Next we have to specify the param eters of the system . For our com parison we consider, as in Ref. [ilill $583000{ }^{6}$ Li atom s (i.e., 286500 atom s per spin state) in a harm onic oscillator potential w th average frequency $\sim!=\sim\left(!{ }_{x}!_{y}!_{z}\right)^{1=3}=8: 21 \mathrm{nK}$. The corresponding chem ical potential is $=983 \mathrm{nK}$. In order to sim ulate the $e$ ect of the self-consistent $m$ ean- eld potential, the frequency has been chosen slightly higher than the frequency of the extemaltrapping potential ( $\sim!_{0}=6: 9 \mathrm{nK}$ ) [ ${ }_{-1}^{1}$ ].

In the experim ents the traps are generally very elongated, i.e. we have a strong deform ation $=!_{\mathrm{z}}=$ ! ? , where !? $={ }^{\mathrm{P}} \Gamma_{\mathrm{x}}!_{\mathrm{y}}$ is the average frequencey in the xy plane. In our exam ples we choose $=1=8$. This results in a ratherhigh value for the average transverse frequency of $\sim!$ ? $=\sim!={ }^{1=3}=16: 42 \mathrm{nK}$. In order to rotate the system around the $z$ axis, at least a sm all deform ation in the xy plane is necessary, which we param etrize by
$=!_{x}=!_{y}$. (In practioe, the rotating deform ation of the potential can be generated by a laser beam [4] ].)

Them ain uncertainty com es from the gap at zero tem perature, $0 . N$ ote that the coupling constant $g$ does not appear explicitly. The $m$ om ent of inertia depends on the interaction only via , which can be written as a function of $T$ and 0 . The value of the critical tem perature $\mathrm{T}_{\mathrm{C}}=0: 5670$ is still under investigation. In addition, the $s-w$ ave scattering length a of the atom $s$, and consequently $g$, 0 , and $T_{c}$, can be tuned in the experim ents by a magnetic eld due to the presence of Feshbach resonances. Therefore we will treat 0 as a free param eter. As a rough estim ate, using the scattering length $a=2160 a_{0}$, where $a_{0}$ is the Bohr radius, one obtains that the gap 0 averaged over the Ferm isurface is of the order ofm agnitude of 15 nK [igh], i.e., of the sam e order of $m$ agnitude as the transverse trapping frequency!? .

In $F$ ig. $\overline{3} 1$ tion of the tem perature for two di erent deform ations . The low er curves correspond to a very sm alldeform ation, $=0: 8$. In this case the m om ent of inertia at $\mathrm{T}=0$ is very sm all. W hen T approaches $\mathrm{T}_{\mathrm{C}}$, the norm al uid com ponent becom es $m$ ore and $m$ ore im portant and consequently the $m$ om ent of inertia increases until it nally reaches the rigid-body value at $T=T_{C} \cdot Q$ ualitatively the behavior is sim ilar in the case of a strong deform ation in the xy plane (upper curves), except that in this case the whole curve is shifted upw ards, $m$ ainly due to the $m$ uch larger value of irrot. The di erence betw een the three curves show $n$ for each deform ation $w$ ill be discussed be-

In order to illustrate the origin of the tem perature dependence of , we show in $F$ ig. 4 , the current distributions for the case $=0: 8$ for four tem peratures betw een $T=0$ and $T=T_{C}$. O ne can clearly see the continuous transition from the irrotationalm otion at $T=0$, resulting in a sm all angularm om entum and therefore a sm all m om ent of inertia, to the rigid $m$ otion at $T=T_{C}$.

N ow we are going to discuss the di erences betw een the three curves show $n$ in $F$ ig. '3 for each deform ation. $T$ he short-dashed lines correspond to the results obtained w ithin the ~! 0 approach, Eq. ( $\left.10 \overline{2}_{1}^{\prime}\right)$. T he long-dashed and solid lines were obtained from Eq. (1011), i.e., they take into account the di erence betw een $G$ and G (0), resulting from the long-tim e behavior of the operator $\check{K}_{1}(t)$, Eq. (54). From the de nition $(65)$ it is clear that this di erence is less im portant for large values of , and indeed the long-dashed lines, corresponding to $0=20 \mathrm{nK}$, are closer to the $\sim$ ! 0 results than the solid lines, corresponding to $0=10 \mathrm{nK}$. M ore precisely, the criterion for the validity of the $\sim$ ! 0 approach seem $s$ to be ~! ? rather than $\sim$ ! ? as one $m$ ight expect. This surprising fact can be understood by looking at $F$ ig. 프: W hatever is the actualvalue of the tem perature $T$ [i.e., of ( T$)$ ], the value of $G("=2)$ can alw ays be replaced by G (0) if "=2 $0 \quad 1$.

To show m ore clearly the non-trivial dependence of on , we show in Fig. ${ }^{5}$ the m om ent of inertia for zero tem perature as a function of for the sam e deform ations as in Fig. ${ }_{1}^{2} 1$. The irrotational lim it, indicated by the dashed lines, is reached for ! 1 . If ismuch sm aller than $\sim$ ! $(3: 67 \mathrm{nK}$ in the case $=0: 8$ and $11: 61 \mathrm{nK}$ in the

case $=0: 5$, respectively), the m om ent of inertia even approaches the rigid body value, and the $\sim$ expansion fails com pletely. For exam ple, in nuclear physics strong deviations from the irrotational value are quite com $m$ on $\left[13^{1}, 14^{1}\right]$.
$\bar{F}$ inally let us brie y discuss the question whether the m om ent of inertia is suitable to detect the super uidity in experim ents. In principle the m om ent of inertia can be $m$ easured directly by $m$ easuring the rotationalenergy

Since the rotation does not change the potential energy (at least not to linear order in ), the rotational energy is equal to the di erence of the release energies $E$ rel of the rotating system and ofthe non-rotating system. (T he release energy $\mathrm{E}_{\mathrm{rel}}$ is the totalenergy ofallparticles after the trapping potential has been switched 0 , i.e., the sum of the kinetic energy $E_{k i n}$ and of the interaction energy $E_{\text {int }}$ of the trapped system .) A disadvantage of the direct $m$ easurem ent of $\mathrm{E}_{\text {rot }}$ is that it requires two identical system $s$, one in rotation and one at rest. A s a rough estim ate w e approxim ate the release energy $\mathrm{E}_{\text {rel }}$ by the kinetic energy $\mathrm{E}_{\mathrm{k} \mathrm{m}_{\mathrm{n}}}$ of the particles in the le ective" harm onic potential (23),

U sing these num bers we nd $\mathrm{E}_{\text {rot }}=\mathrm{E}_{\mathrm{k} \text { in }} \quad 0: 1 \quad=$ rigid, i.e., the m om ent of inertia $m$ ight indeed be $m$ easurable.

## VI. SUMMARYAND CONCLUSIONS

In this article we have discussed the tem perature dependence of the $m$ om ent of inertia of a Ferm igas trapped in a slow ly rotating trapping potential. The assum ption of a slow rotation allow ed us to use linear response theory (RPA), but it is clear that in this way certain interesting e ects like the creation of vortices could not be considered, since they depend non-linearly on the angular velocity of the rotation.

In Sect. "İİ we derived the density $m$ atrix of the rotating system using a sem iclassicalm ethod sim ilar to the one described in Ref. [8] $[$, but now taking into account the therm al quasiparticle occupation num bers, which were neglected in Ref. [id] and which give rather im portant contributions. O ne im portant point is that the $m$ ethod takes into account that the energy di erence $\sim$ ! of the states connected by the perturbation ham iltonian (i.e., essentially by $\mathrm{L}_{\mathrm{z}}$ ) is not necessarily negligible in com parison w th the gap. . This leads to a non-trivialbehavior of the density $m$ atrix on $\sim!=$. These e ects can also be regarded as nite-size e ects, since $\sim$ ! vanishes in hom ogeneous system s.

In Sect. 'IIN' we presented an altemative $m$ ethod for the calculation of the density $m$ atrix, where only the leading order of the $\sim$ expansion is retained. This is equivalent to the transport or hydrodynam ical approach which is
 di erence betw een the results obtained with in the two approaches is that the velocity eld obtained in Sect. III has irrotational and rotational contributions at all tem peratures, whereas the transport approach presented in Sect.'IV', gives a purely irrotationalvelocity eld at zero tem perature, as it is the case in hom ogeneous system s . T he dependence on $\sim!=\mathrm{m}$ entioned above is m issed w th in this approach.

In Sect. Ni: we used the density $m$ atrices obtained in the preceding sections for the calculation of the $m$ om ent of inertia. The result can qualitatively be understood w ithin the two- uid model, which describes the superuid system as a m ixture of a super uid and a norm al uid com ponent. The density of the norm al- uid com ponent is zero at $T=0$ and approaches the total density for $T$ ! $T_{C}$. W e have show $n$ that the transport approach exactly reproduces this tw o-uid model. Som ew hat surprisingly, the condition for the transport approach to be valid tums out to be $\sim!\quad 0$, where 0 is the value of the gap at $T=0$. This is less restrictive than the condition ~! , in particular for tem peratures near $\mathrm{T}_{\mathrm{C}}$.

W ithin the transport approach, the $m$ om ent of inertia increases sm oothly from the irrotational lim it at $T=0$ to the rigid-body value at $T=T_{C}$. This is a consequence of the increasing density of the nom al- uid com ponent of the two-uid model. If the condition $\sim!\quad 0$ is not ful lled, the behavior is qualitatively sim ilar, but the m om ent of inertia is alw ays larger than it is w thin the transport approach, because in this case the rotational contributions to the velocity eld are alw ays non-zero due to the nite-size e ects $m$ entioned above. In both cases, the sm oothly increasing m om ent of inertia as a function of tem perature can be obtained only if the therm al quasiparticle occupation num bers are properly included in the calculation. It is not su cient to perform a zero-tem perature calculation and then replace the gap by the tem perature-dependent gap (T).
Looking at the size of the error $m$ ade by neglecting the nite-size e ects, we conclude that for the trapped ferm ionic atom $s$, where $\sim!<0$, the hydrodynam ical approach is just at the lim it of its applicability. H ow ever, we would like to point out that there are other physical situations, where $\sim!>0$, and where nite-size corrections are crucial. For exam ple, the $m$ om ents of inertia of rotating super uid nuclei ( $\mathrm{T}=0$ ) have at least tw ice the irrotational value [1] [1]. A lso for the description of superconducting $m$ etallic grains in a weak $m$ agnetic eld, corresponding to a perturbation $\mathrm{h}_{1}=(e=m \mathrm{c}) \mathrm{p} \quad \mathrm{A}(\mathrm{r})=$ ( $e=m$ C) $B_{z} L_{z}$ (if $B$ is parallel to the $z$ axis) and therefore being form ally equivalent to a slow rotation, these corrections $m$ ight be im portant.

The $m$ ethod used in Sect. 'IIT for the sem iclassical solution of the RPA in super uid system s can also be extended to the dynam ical case, i.e., to tim e-dependent perturbations. In this way collective excitations of the super uid system, in particular the change of their frequencies com pared w ith the norm al- uid phase, can be described. So far the collective $m$ odes in the super uid phase have been studied either within the hydrodynam i-
 ofsphericalsym $m$ etry and $m$ oderate num bers ofparticles [1]

H ow ever, we have to adm it that the above argum ents conceming the divergence in Eq. (A $\left.\overline{-} \bar{T}_{1}\right)$ are a little bit hand-waving. For exam ple, Eq. (27-1) (including an appropriate regularization) is valid only in the local-density approxim ation, and it does not allow for a constant gap , while we have for sim plicity assum ed that is a constant in order to derive Eq. (A-71). Such inconsistencies do not appear w ith in the form alism presented in Sect. ${ }_{\text {ITIIT }}$.
