Slow rotation of a super uid trapped Ferm i gas

The moment of inertia, , is one of the possible observables for the experimental determination whether a trapped Fermi system has reached the BCS transition or not. In this article we investigate in detail the temperature dependence of below the critical temperature T $_{\rm c}$. Special care is taken to account for the small size of the system , i.e., for the fact that the trapping frequency \sim ! is of the same order of magnitude as the gap . It is shown that the usual transport approach, corresponding to the leading order of an expansion in powers of \sim , is not accurate in this case. It turns out that does not change rapidly if T becomes smaller than T_c , but it rather decreases slow ly. Qualitatively this behavior can be explained within the two-uid model, which again corresponds to the leading order in \sim . Quantitatively we not deviations from the two-uid model due to the small system size.

I. IN TRODUCTION

Since the rst observation of B ose-E instein condensation ofm agnetically trapped bosonic atom s [1, 2, 3] it has become clear that ultra-cold trapped atom ic gases provide an excellent tool to study quantum e ects in system s which are alm ost visible to the naked eye. For example, quantized vortices in the B ose condensate were created by stirring the B ose condensate with the help of a laser beam [4]. A loo the quantum pressure related to the P auli principle could be observed in gases of trapped ferm ionic atom s [5, 6], which proves that tem peratures well below the degeneracy tem perature can be reached.

If it was possible to trap two spin states of a ferm ionic isotope with attractive interaction, and to cool the system below the critical tem perature T_c, one could study the BCS transition to the super uid phase. Unlike the transition of a Bose gas to the Bose-E instein condensate, the BCS transition of a Fermi gas alm ost does not change the density pro le of the atom ic cloud [7]. How ever, there are other observables which may allow to distinguish between the norm al-uid and the super uid phase. In a preceding paper [8] the m om ent of inertia was proposed, since it is much smaller in the super uid phase than in the norm al-uid phase (see also Ref. [9]). Another observable changing from one phase to the other are the frequencies of collective m odes [9, 10, 11]. For example, the frequency of the so-called \scissors m ode", an oscillation of the sym m etry axis of the cloud with respect to the symmetry axis of the trap, is closely related to the mom ent of inertia [8]. Recently one m ore observable for the detection of the BCS transition was proposed, namely the change of the deform ation of the cloud during the expansion of the system when the trapping potential is switched o [12].

The moment of inertia of a super uid gas of trapped ferm ionic atoms at zero temperature was evaluated for the rst time in Ref. [8] in close analogy to the calculation of the moment of inertia of super uid nuclei [13]. This derivation was very sim ilar to the one given by M igdal more than 40 years ago [14], except that everything was reform ulated in phase space in terms of W igner transforms. In the present article we will generalize the calculation of Ref. [8] to the case of non-zero tem perature. In addition, we will give a derivation which further clari es certain points which in Ref. [8] m ay have been passed over rather quickly.

In addition to the tem perature dependence of the mom ent of inertia, we will address an interesting question which is relevant already at zero temperature. In nuclear physics it is well known that the moment of inertia of super uid nuclei is much smaller than the rigid-body value, but still higher than the value corresponding to a purely irrotational motion, and that the currents in rotating nuclei have both rotational and irrotational com ponents [13]. The same behavior is found in trapped Ferm i gases at zero tem perature [8]. In contrast to this, the ordinary hydrodynam ical or transport equations for super uids at zero tem perature, which can be derived from the ~ ! 0 lim it of the time-dependent Hartree-Fock-Bogoliubov (TDHFB) equation [15, 16, 17, 18, 19] allow only for a purely irrotationalm otion. W e will work out this di erence and discuss the lim its of validity of the hydrodynam ical description.

The article is organized as follows: In Sect. II we give a brief review of the form alism, mainly in order to recall some de nitions and to clarify our notation. In Sect. III we derive the expression for the density matrix of the slowly rotating system within linear-response theory. This is the generalization of the calculation of Ref. [3] to non-zero tem peratures. In Sect. IV we again derive the linear response of the density matrix, but now using the leading order of the ~ expansion of the TD HFB equation. In Sect. V we show numerical results for the moment of inertia obtained within both form alisms as a function of tem perature and interprete the results and their di erences. Finally, in Sect. V I, we sum marize and draw our conclusions.

II. BRIEF REVIEW OF THE FORMALISM

Before considering the rotating super uid trapped Ferm i gas, we will brie y review the equilibrium case. Our intention is to explain our notation and conventions. Detailed discussions of the subject can be found in m any articles [7, 8, 20] and textbooks [21].

In this article we assume for simplicity that equal num bers of atom s with two spin projections = ";# are trapped in a spin-independent harm onic potential

If the density of the trapped system is very low, the atom atom interaction can be approximated by a zero-range interaction with a coupling constant g proportional to the s-wave scattering length. Due to the Pauli principle only atom swith opposite spin projections can interact in this way. Under these assumptions the ham iltonian takes the form

The mean-eld potential corresponding to this interaction reads

where we have used the following notation for the nonlocal density matrix:

(N ote that with this de nition the local part of the density m atrix, (r) (r;r) corresponds to the density per spin state.) In the presence of pairing correlations, the pairing gap is given by the gap equation

It will turn out that the self-consistent solution of Eq. (5) is divergent as a consequence of the zero-range interaction. In the literature several ways how to regularize this divergence can be found [7, 8, 20, 22], but in fact the technical details of the solution of Eq. (5) are not important for our purpose.

In order to write down the Hartree-Fock-Bogoliubov (HFB) equations, which relate the density matrix and the pairing tensor to the potential V and the gap , it is useful to expand all quantities in a basis of single-particle

wave functions $'_n$ (r), where n represents all quantum num bers except spin, i.e., for an arbitrary operator A :

Expressing the eld operators $\ (r)$ and $\ ^y$ (r) in terms of annihilation and creation operators a_n and a_n^y , we recover the usual de nitions

The index n^0 in Eq. (9) denotes the time-reversed state characterized by $'_{n^0}(\mathbf{r}) = '_{n^0}(\mathbf{r})$. We need also the matrix elements h_{nn^0} of the grand-canonical (mean-eld) single-particle ham iltonian (i.e., of the single-particle ham iltonian minus the chemical potential)

and them atrix elements $_{nn^0}$ of the gap . For them ore general case that the ham iltonian is not time-reversal invariant, we introduce the notation $A_{nn^0} = A_{n^0n}$. If the m atrices mentioned above are combined as follows:

the HFB equations [21, 23] can be written in the form of a 2 2 m atrix equation,

W hat is relevant for our purpose is the spectrum of the lowest lying quasiparticles, which for a su ciently small gap can be obtained within the BCS approxim ation, which is much simpler than the solution of the full HFB equation (13). We choose a basis in which h is diagonal, i.e., $h_{nn^0} = h_{n nn^0}$. Then, within the BCS approximation, and are diagonal, too, and given by

The quasiparticle energies $E_n = \frac{p_{n}}{h_n^2 + \frac{2}{n}}$ and the quasiparticle occupation numbers $f(E_n) =$ $1=[\exp(E_n=T) + 1]$ are determined by the diagonal matrix elements n_{nn} alone. If we neglect the non-diagonal matrix elements of , which are irrelevant for the excitation spectrum and, apart from that, much sm aller than the diagonal ones, we can rewrite Eqs. (14) and (15) in the compact form

It is evident that the generalized density $m \operatorname{atrix} R$ given by Eq. (16) solves the HFB equation (13) if h and are assumed to be diagonal.

For the spherical case ($!_{0x} = !_{0y} = !_{0z}$) and moderate num bers of particles (N $< 10^{4}$), the self-consistent HFB equation can be solved num erically [20]. However, for the deform ed case and large num bers of particles (ex-10⁶ :::10⁶ have perim entally num bers of the order N been reached), even within the BCS approximation, the self-consistent solution becom es num erically intractable. Therefore it may be indicated to apply sem iclassical approximations. Sem iclassical methods can become very accurate for large numbers of particles, and in addition they often allow for a very clear interpretation of the results. To that end we will use the W igner transforms of the density matrix , the pairing tensor , the singleparticle ham iltonian h, etc. The W igner transform of a single-particle operator A is de ned as

The W igner transform h(r;p) of the single-particle ham iltonian h is particularly simple: It is just the classical ham iltonian. We also recall the useful relations $\mathbb{A}^{y}](r;p) = A$ (r;p) and $\mathbb{A}](r;p) = A(r; p)$. One advantage of the W igner transforms in sem iclassical calculations is the product rule for the W igner transform of the product of two operators A and B [21], directly leading to an ~ expansion:

where the symbol stands for the Poisson bracket

From the de nition (17) it is clear that the local density can be written as $\overline{7}$

As a very simple case we consider the Thom as Ferm i (~ ! 0) limit for the density matrix without pairing correlations (i.e., = = 0) at zero temperature. Quantum -mechanically the density matrix is in this case just given by the Ferm isea lled up to the Ferm ienergy , i.e., = (h). To leading order in ~ the W igner transform of this expression gives (r;p) = [h(r;p)]. The corresponding (local) density reads

Eq. (21) together with Eq. (3) can easily be solved selfconsistently [7, 8]. Since the pairing gaps and tem peratures considered in this article are very sm all compared with the Ferm i energy, we will use Eq. (21) also in the presence of pairing correlations and at non-zero tem peratures. (The e ect of pairing correlations and tem perature on the density pro le (r) was investigated in Ref. [7]). Furtherm ore, in this article we are not interested in the details of the density pro le (r). As shown in Ref. [8], the self-consistent solution for (r) can be described to good accuracy by approximating the self-consistent potential V (r) again by a harm onic potential

with <code>\e</code> ective" frequencies !_i > !_{0i} (we consider an attractive interaction, i.e., g > 0) and an appropriately readjusted chem ical potential . In the remaining part of this article we will use the approxim ate potential (23).

In order to include the pairing correlations, one can also use the HFB equation (13) in the lim it ~! 0:

This implies that, to leading order in \sim , at each point r the solution R (r;p) as a function of p is given by the solution for a hom ogeneous system with the density corresponding to the local density at this point r [Local-Density Approximation (LDA)]:

Inserting the expression for (r;p) corresponding to Eq. (25) into Eq. (26), we obtain the following non-linear equation for the gap:

A sm entioned before, this equation is divergent and needs some regularization (see Refs. [7, 8, 22] for details).

C ontrary to the T hom as Ferm i approximation for the unpaired density matrix, Eq. (21), which is valid if the potential can be regarded as constant on a length scale of the inverse Ferm i momentum, the local-density approximation in the paired case is valid only if the potential is also constant on a length scale of the coherence length of the C ooper pairs. This latter condition is offen not fulled. Therefore, in Refs. [8, 25] an alternative sem iclassical method for the calculation of the gap has been proposed, which, how ever, results in an average gap (m ore precisely: gap averaged over the Ferm i surface) of alm ost the same magnitude as the average gap obtained within the local density approximation.

III. LINEAR RESPONSE TO A SLOW ROTATION

In this section we will describe the form alism used for the calculation of the moment of inertia of a super uid gas of trapped ferm ionic atom s. Looking at a system rotating with angular velocity around the z axis, we can calculate the moment of inertia from

where (r;p) is the density matrix of the rotating system. Hence the main problem in calculating the moment of inertia is to calculate (r;p), from which also other interesting quantities like the current density (per spin state)

and the velocity eld v(r) = j(r) = (r) can be derived.

The system is put into rotation by rotating the external trapping potential around the z axis (of course, for this purpose the trapping potential must not be axially sym metric). In the rotating frame, how ever, the system is still in a stationary state. In this frame, the H am iltonian receives the additional term

which for su ciently small can be treated as a perturbation. This perturbation induces a change of the density matrix, 1, and of the pairing tensor, 1. The mean eld potential is not changed to linear order in , since L_z is a time-odd operator. Linearizing Eq. (13), we obtain

where H and R denote the unperturbed quantities, while H₁ and R₁ refer to the deviations. A sum ing that the unperturbed quantities , , h, and are diagonal (BCS approximation), we can solve Eq. (31) for $_1$ and $_1$. (This is equivalent to solving the linearized G orkov equations for the norm aland anom abus G reen's functions at equaltimes; see, e.g., Ref. [23].) The solution reads:

In practice, Eq. (33) is an integral equation, since the change of the gap, $_1$, on the rh.s. is related to the change of the pairing tensor, $_1$, by the gap equation. In analogy to Eq. (26) the gap equation for the perturbed quantities reads

The solution of this integral equation contains som e subtleties. For example, the divergence appearing in Eq. (38) as a consequence of the zero-range interaction has to be regularized in the same way as the corresponding divergence of the unperturbed gap equation (26) (see appendix), and the derivations of Eq. (4.34) in Ref. [8], or the second equation affer Eq. (16) in Ref. [14] are not very explicit about this point. How ever, these problem s can be circum vented in the following way [15, 18, 19]: Suppose all single-particle wave functions are multiplied by the sam e local phase exp[i (r)]. Then the HFB equation (13) can be rew ritten in term s of the gauge-transform ed m atrices

Eq. (42) is again a system of integral equations which for an arbitrary function (r) is completely equivalent to the original one, Eqs. (31) and (38). However, since the perturbation \tilde{h}_1 is time-odd, the change of the gap, \sim_1 , is purely in aginary and therefore can be eliminated by an appropriately chosen function (r). Physically, this choice of (r) corresponds to a transformation into the local rest frame of the Cooper pairs [24]. In this particular gauge the linearized HFB equation reduces to

We now proceed to the evaluation of Eq. (48). The unperturbed quantities and entering in $F_{nn^0}^{\ h}$ [Eq.(34)] can be rewritten in term sofh and according to the BCS relations (14) and (15). In addition, as in Ref. [3], we replace _n by its average value at the Ferm isurface, , because F ^h and all other relevant quantities are strongly peaked at "_F. This allows us to write $F_{nn^0}^{\ h}$ as a function of two energies = h_n and $^0=h_n\circ$:

where we have introduced the abbreviations $E = \frac{1}{2} + \frac{1}{2}$ and $E^0 = \frac{1}{2} + \frac{1}{2}$. In contrast to Ref. [8], we will not drop the therm all quasiparticle occupation numbers f(E) and $f(E^0)$. As described in detail in Ref. [8], the W igner transform of an expression like Eq. (48) can be evaluated sem iclassically in the following way. First we rewrite Eq. (48) as an operator equation:

To leading order in ~ the W igner transform of the product of the three operators in the second line of Eq. (53) can be expressed as the product of their W igner transform s [see Eq. (19)]. Then the integral over T gives a function of the form [h(r;p)] and the integral over becomes trivial.

However, for the operator product in \tilde{h}_1 (t) [Eq. (54)] we will not use the product rule. In this sense we resum certain ~ corrections to all orders. One can also say that, since the W igner transform of Eq. (54) involves the classical trajectories (see below), the long-time inform ation is preserved. On the other hand, developing the W igner transform of Eq. (54) with the product rule (19) into powers of ~ would lead to the W igner-K irkwood ~ expansion, which is only valid in the short-time lim it (see Ref. [21]). The di erent treatm ent of the operator products in Eqs. (53) and (54) is necessary for the following reason: The operator \tilde{h}_1 connects states with an energy di erence of the order ~! . This is sm all com pared with the Fermi energy, which is the relevant scale for the [since the result γ (r;p) will be used in intevariable grals over p], but not necessarily sm all com pared with the gap , which is the relevant scale for the variable " [this point will become clearer when we investigate the function F^h (+"=2; "=2) explicitly].

In the case of the e ective harm onic oscillator potential (23) the W igner transform of Eq. (54) can be calculated exactly. The result reads

Note that the contribution of the M igdal term is crucial in order to satisfy the continuity equation. The easiest way to see this is to consider the lim it ! 1. In this lim it we have G ! 1 and $\frac{18}{1}$ (r;p) ! 0, which in plies $J^{\rm IB}$ (r) ! 0. Hence, with the Inglis-Belyaev contribution alone, Eq. (81) cannot be satis ed.

A sobserved in Ref. [8], the velocity eld v (r) describes a m ixture of rotationalm otion, corresponding to a velocity eld proportional to e_z r, and irrotationalm otion, corresponding to a velocity eld proportional to r $(r_x\,r_y)$. The ordinary rigid rotation is realized if $G_+=G_-=0$. This is the case if the tem perature approaches the critical tem perature T_c , where the gap vanishes [the tem perature dependence of the function G(x) will be discussed in Sect. V], but it can also happen at zero tem perature if -?, as discussed in Ref. [8]. Purely irrotational m otion, as it is expected in hom ogeneous super uids, is reached if $G_+=G_-=1$. This is only possible if the tem perature is very low and if -?.

For completeness let us also discuss the change of the pairing tensor, $_1$ (r;p), which can be obtained in a way completely analogous to the calculation of the change of the density matrix, $_1$ (r;p). The result reads

Since the last term is of the order ~ 1 [see Eq. (70)], it has been argued that a sem iclassical description is possible only in the particular gauge where + $_{1}$ is real and where this term vanishes [18, 19].

IV. SUPERFLUID ROTATION IN TRANSPORT THEORY

The transport or hydrodynam ical equations for superuid system s can be derived by taking the ~! 0 lim it of the tim e-dependent Hartree-Fock-Bogoliubov (TDHFB) equation [18, 21, 23]

i.e., by replacing the W igner transform s of the com m utators in Eq. (83) by Poisson brackets of the W igner transform s [15, 16, 17, 18, 19]. Due to the transform ation into the rotating frame, we are dealing with a static problem, where the TDHFB equation (83) reduces to the HFB equation (13). Again we make use of the gauge transform ation and retain only term s of linear order in the perturbation. Then, if (r) is chosen such that \sim_1 vanishes Eq. (50)], the leading order in \sim of Eq. It is rather a direct consequence of the vanishing of \sim_1 , which in turn follows immediately from the \sim ! 0 limit of the linearized HFB equations for time-odd perturbations and zero temperature. However, as we have seen in the previous section, in a small system where \sim ! is of the same order of magnitude as , the velocity eld is not irrotational. Our conclusion is that one should be careful when applying transport theory to such system s.

So far we have considered only the zero-tem perature lim it. In the remaining part of this section we are going to consider also the case T > 0. In this case it is di cult to solve the coupled Eqs. (84) and (85). However, if we in analogy to the previous section assume that the the unperturbed gap is constant, we not the following solution for \sim_1 and \sim_1 :

U sing the results for change of the non-local density matrix _1 (r;p) given in the previous sections, we can now calculate them on ent of inertia. It should be remem bered that an idealFerm igas at zero tem perature behaves like a rigid body, i.e., the velocity eld is given by v (r) = e_z r. Since the critical tem perature for the BCS transition is very low, will approach the rigid-body value _______ rigid for T ! T_c. The previous paragraph can be summarized in the statem ent that the transport approach, corresponding to the leading order of the ~ expansion, reproduces the two-uid model for hom ogeneous systems. It does not give any nite-size corrections, as can be seen from the fact that the result does not depend on the trapping frequencies, except for the purely geom etrical dependence contained in rigid and irrot. In contrast to this, the m ethod described in Sect. III is capable to describe the di erent behavior of the system depending on whether the trapping frequencies (multiplied by ~) are small or large com pared with the gap . This dependence is govemed by the G factors appearing in Eq. (101), resulting from the long-time behavior of the operator ${\tt \tilde{h}}_1$ (t) [see discussion after Eq. (54)]. In order to reproduce this behavior within the ~ expansion, one would have to resum a certain class of corrections proportional to ~! = to all orders, in particular if one wants to cover the whole range of possible parameters from ~! to ~! .

Let us now proceed to a quantitative analysis. In order to calculate the moment of inertia as a function of tem perature, we need the tem perature dependence of the gap . As in R ef. [8], we will assume that it is described by the same universal function relating = $_0$ to $T=T_c$ in hom ogeneousm atter, where $_0$ denotes the gap at T=0 and $T_c=0.567~_0$. This universal function is given by the solution of the non-linear equation [26]

For the calculation of the moment of inertia we also need the function G ("=2), which depends on T via the




FIG.1: Universal function for the tem perature dependence of the gap (T_c = 0.567 $_0$).




FIG .2: Behavior of the function G ("=2) for di erent tem – peratures between 0 and $T_{\rm c}\,.$

tem perature dependence of discussed above, and via the explicit tem perature dependence of the function G (x) due to the therm all quasiparticle occupation num bers as given by Eq. (63). If only the tem perature dependence of

was included, G ("=2) as a function of "would become very strongly peaked at " = 0 for T ! T_c . However, due to the explicit tem perature dependence of the function G (x), the peak is suppressed and as a function of " the function G ("=2) even become some and more at with increasing tem perature, as shown in F ig.2. The decrease of G (0) when T approaches T_c relects the decrease of the super uid fraction in the two-uid model.

Next we have to specify the parameters of the system. For our comparison we consider, as in Ref. [3], 583000 ⁶Li atom s (i.e., 286500 atom s per spin state) in a harmonic oscillator potential with average frequency $\sim ! = \sim (!_x !_y !_z)^{1=3} = 8.21 \text{ nK}$. The corresponding chem – ical potential is = 983 nK. In order to simulate the e ect of the self-consistent m ean-ekl potential, the frequency has been chosen slightly higher than the frequency of the external trapping potential ($\sim !_0 = 6.9 \text{ nK}$) [8].




FIG. 3: M om ent of inertia as a function of $T=T_{c}$ for small $(!_{x}=!_{y}=0.8)$ and large $(!_{x}=!_{y}=0.5)$ deform ations in the xy plane and two values of $_{0}$ (10 and 20 nK). The short-dashed lines correspond to the ~! 0 lim it.

In the experiments the traps are generally very elongated, i.e. we have a strong deformation $= !_z = !_z$, where $!_z = p \frac{p}{!_x !_y}$ is the average frequencey in the xy plane. In our examples we choose = 1=8. This results in a rather high value for the average transverse frequency of $\sim !_z = \sim != ^{1=3} = 16.42 \text{ nK}$. In order to rotate the system around the z axis, at least a small deformation in the xy plane is necessary, which we parametrize by $= !_x = !_y$. (In practice, the rotating deformation of the potential can be generated by a laser beam [4].)

The main uncertainty com es from the gap at zero tem perature, 0. Note that the coupling constant g does not appear explicitly. The moment of inertia depends on the interaction only via , which can be written as a function of T and 0. The value of the critical tem perature $T_c = 0.567_0$ is still under investigation. In addition, the s-wave scattering length a of the atom s, and consequently g, $_0$, and T_c , can be tuned in the experiments by a magnetic eld due to the presence of Feshbach resonances. Therefore we will treat $_0$ as a free param eter. As a rough estimate, using the scattering length a = 2160a, where a_0 is the Bohr radius, one obtains that the gap 0 averaged over the Ferm i surface is of the order of m agnitude of 15 nK [8], i.e., of the sam e order of m agnitude as the transverse trapping frequency $!_{?}$.

In Fig. 3 we display the moment of inertia as a function of the temperature for two di erent deform ations . The lower curves correspond to a very small deform ation, = 0.8. In this case the moment of inertia at T = 0is very small. When T approaches T_c , the norm al- uid component becomes more and more important and consequently the moment of inertia increases until it nally reaches the rigid-body value at $T = T_c$. Qualitatively the behavior is similar in the case of a strong deform ation in the xy plane (upper curves), except that in this case the whole curve is shifted upwards, mainly due to the much larger value of $_{\rm irrot}$. The di erence between the three curves shown for each deform ation will be discussed be-




FIG. 4: Current distributions $j(r_x; r_y; 0)$ in the xy plane (arbitrary units) for $!_x = !_y = 0.8$, $_0 = 20 \text{ nK}$, and four di erent tem peratures: $T = T_c = 0, 0.4, 0.6$, and 1.

low .

In order to illustrate the origin of the tem perature dependence of , we show in Fig.4 the current distributions for the case = 0.8 for four tem peratures between T = 0 and T = T_c . One can clearly see the continuous transition from the irrotationalm otion at T = 0, resulting in a sm all angular m om entum and therefore a sm all m om ent of inertia, to the rigid m otion at T = T_c .

Now we are going to discuss the di erences between the three curves shown in Fig. 3 for each deform ation. The short-dashed lines correspond to the results obtained within the ~! 0 approach, Eq. (102). The long-dashed and solid lines were obtained from Eq. (101), i.e., they take into account the di erence between G and G (0), resulting from the long-time behavior of the operator \tilde{h}_1 (t), Eq. (54). From the de nition (65) it is clear that this di erence is less in portant for large values of , and indeed the long-dashed lines, corresponding to $_0 = 20 \, \text{nK}$, are closer to the ~! 0 results than the solid lines, corresponding to $_0 = 10 \, \text{nK}$. More precisely, the criterion for the validity of the ~! 0 approach seems to be $_0$ rather than ~! ? , as one m ight expect. ~! ? This surprising fact can be understood by looking at Fig. 2:W hatever is the actual value of the tem perature T [i.e., of (T)], the value of G ("=2) can always be replaced by G (0) if "=2 0 1.




FIG. 5: M om ent of inertia for zero tem perature as a function of for small (! $_x=!_y = 0.8$) and large (! $_x=!_y = 0.5$) deform ations in the xy plane. The dashed lines indicate the corresponding irrotational lim its.

To show more clearly the non-trivial dependence of on , we show in Fig. 5 the moment of inertia for zero temperature as a function of for the same deform ations as in Fig. 3. The irrotational limit, indicated by the dashed lines, is reached for ! 1 . If is much smaller than ~! (3:67 nK in the case = 0:8 and 11:61 nK in the

case = 0.5, respectively), the m om ent of inertia even approaches the rigid body value, and the ~ expansion fails completely. For example, in nuclear physics strong deviations from the irrotational value are quite comm on [13, 14].

Finally let us brie y discuss the question whether the m om ent of inertia is suitable to detect the super uidity in experiments. In principle the m om ent of inertia can be m easured directly by m easuring the rotational energy

Since the rotation does not change the potential energy (at least not to linear order in), the rotational energy is equal to the di erence of the release energies E $_{rel}$ of the rotating system and of the non-rotating system . (The release energy E $_{rel}$ is the total energy of all particles after the trapping potential has been switched o , i.e., the sum of the kinetic energy E $_{kin}$ and of the interaction energy E $_{int}$ of the trapped system .) A disadvantage of the direct m easurem ent of E $_{rot}$ is that it requires two identical system s, one in rotation and one at rest. As a rough estim ate we approxim ate the release energy E $_{rel}$ by the kinetic energy E $_{kin}$ of the particles in the \e ective" harm onic potential (23),

Hence, as a function of the average transverse trapping frequency $!_{?} = \frac{p}{!_{x}!_{y}}$ and the deformation $= !_{x}=!_{y}$ we obtain

Since we used linear response theory, our results are valid only for slow rotations, ! ? . In particular the angular velocity must be small enough in order to avoid the creation of vortices. For an optim istic estim ate we choose $= 0.4!_{?}$. Since the di erence of between T = T_c and T = 0 is most pronounced for sm all deform ation (see Fig. 3), we choose = 0.8. Using these numbers we nd E_{rot}=E_{kin} 0:1 $= _{rigid}$, i.e., the moment of inertia m ight indeed be m easurable.

VI. SUMMARY AND CONCLUSIONS

In this article we have discussed the tem perature dependence of the m om ent of inertia of a Ferm igas trapped in a slow ly rotating trapping potential. The assumption of a slow rotation allowed us to use linear response theory (RPA), but it is clear that in this way certain interesting e ects like the creation of vortices could not be considered, since they depend non-linearly on the angular velocity of the rotation.

In Sect. III we derived the density matrix of the rotating system using a sem iclassical method similar to the one described in Ref. [8], but now taking into account the therm al quasiparticle occupation numbers, which were neglected in Ref. [8] and which give rather important contributions. One important point is that the method takes into account that the energy di erence ~! of the states connected by the perturbation ham iltonian (i.e., essentially by L_z) is not necessarily negligible in com parison with the gap . This leads to a non-trivial behavior of the density matrix on ~! = . These e ects can also be regarded as nite-size e ects, since ~! vanishes in hom ogeneous system s.

In Sect. IV we presented an alternative method for the calculation of the density matrix, where only the leading order of the ~ expansion is retained. This is equivalent to the transport or hydrodynamical approach which is often used in the literature [9, 10, 12]. The qualitative di erence between the results obtained within the two approaches is that the velocity eld obtained in Sect. III has irrotational and rotational contributions at all tem peratures, whereas the transport approach presented in Sect. IV gives a purely irrotational velocity eld at zero tem perature, as it is the case in hom ogeneous system s. The dependence on ~! = mentioned above is missed within this approach.

In Sect. V we used the density matrices obtained in the preceding sections for the calculation of the mom ent of inertia. The result can qualitatively be understood within the two-uid model, which describes the superuid system as a mixture of a super uid and a norm aluid component. The density of the norm al-uid com ponent is zero at T = 0 and approaches the total density for T ! T_c. W e have shown that the transport approach exactly reproduces this two-uid model. Som ewhat surprisingly, the condition for the transport approach to be valid turns out to be ~! $_0$, where $_0$ is the value of the gap at T = 0. This is less restrictive than the condition ~! , in particular for tem peratures near T_{c} .

W ithin the transport approach, the moment of inertia increases smoothly from the irrotational lim it at T = 0to the rigid-body value at $T = T_c$. This is a consequence of the increasing density of the norm al-uid component of the two-uid model. If the condition ~! _∩ is not ful led, the behavior is qualitatively sim ilar, but the m om ent of inertia is always larger than it is within the transport approach, because in this case the rotational contributions to the velocity eld are always non-zero due to the nite-size e ects mentioned above. In both cases, the smoothly increasing moment of inertia as a function of tem perature can be obtained only if the therm al quasiparticle occupation numbers are properly included in the calculation. It is not su cient to perform a zero-tem perature calculation and then replace the gap

by the tem perature-dependent gap (T).

Looking at the size of the error made by neglecting the nite-size e ects, we conclude that for the trapped ferm ionic atom s, where ~! < 0, the hydrodynam ical approach is just at the lim it of its applicability. However, we would like to point out that there are other physical situations, where ~! > 0, and where nite-size corrections are crucial. For example, the moments of inertia of rotating super uid nuclei (T = 0) have at least twice the irrotational value [13]. A lso for the description of superconducting metallic grains in a weak magnetic eld, corresponding to a perturbation $h_1 = (e=m c)p = A(r) =$ (e=m c)B_zL_z (if B is parallel to the z axis) and therefore being form ally equivalent to a slow rotation, these corrections m ight be important.

The m ethod used in Sect. III for the sem iclassical solution of the RPA in super uid systems can also be extended to the dynam ical case, i.e., to time-dependent perturbations. In this way collective excitations of the super uid system, in particular the change of their frequencies com pared with the norm al- uid phase, can be described. So far the collective m odes in the super uid phase have been studied either within the hydrodynam icalapproach [9, 10] or quantum -m echanically for the case of spherical symmetry and m oderate num bers of particles [11].

At this stage the disadvantage of the present m ethod as com pared with the m ethod used in Sect. III becom es obvious, since we encounter a divergent integral over d^3p , whereas in Sect. III all expressions were nite. This divergence is the same one which also appears in the gap equation (27) for the unperturbed gap in local-density approximation. If we assume that this equation is regularized in some way, we can use it to get rid of the divergence in Eq. (A 7), and we obtain

However, we have to adm it that the above arguments concerning the divergence in Eq. (A7) are a little bit hand-waving. For example, Eq. (27) (including an appropriate regularization) is valid only in the local-density approximation, and it does not allow for a constant gap , while we have for simplicity assumed that is a constant in order to derive Eq. (A7). Such inconsistencies do not appear within the form alism presented in Sect. III.

It remains to show that the M igdalterm, calculated as the second term of Eq. (32), is consistent with the result given in Eq. (78). This can be done with the aid of the explicit expression for F , which turns out to be
