# Im pact of deviation from precise balance of spike-tim ing-dependent plasticity

Im pact of deviation from precise balance of spike-tim ing-dependent plasticity

#### A bstract

Recent biological experimental indings have shown that synaptic plasticity depends on the relative timing of pre- and post-synaptic spikes and this is called spike-timing-dependent plasticity (STDP). Many authors have claimed that a precise balance between long-term potentiation (LTP) and long-term depression (LTD) of STDP is crucial in the storage of spatio-temporal patterns. Some authors have numerically investigated the impact of an imbalance between LTP and LTD on the network properties. However, the mathematical mechanism remains unknown. We analytically show that an associative memory network has the robust retrieval properties of spatio-temporal patterns, and these properties make the network less vulnerable to any deviation from a precise balance between LTP and LTD when the network contains a nite number of neurons.

#### 1 Introduction

Recent biological experimental ndings have indicated that synaptic plasticity depends on the relative timing of pre- and post-synaptic spikes. This relative tim ing determ ines whether long-term potentiation (LTP) or long-term depression (LTD) is induced (Bi and Poo, 1998; Markram et al., 1997; Zhang et al., 1998). LTP occurs when presynaptic ring precedes postsynaptic ring by no more than about 20 ms. In contrast, LTD occurs when presynaptic ring follows postsynaptic ring. A rapid transition between LTP and LTD takes place within a few milliseconds. A learning rule of this type is called spike-timing-dependent plasticity (STDP) (Song et al., 2000) or temporally asymmetric Hebbian learning (TAH) (Abbott and Song, 1999; Rubin et al., 2001). The functional role of STDP has been investigated by many authors (Gerstner et al., 1996; Kempter et al., 1999; Abbott and Song, 1999; Munro and Hemandez, 2000; Rao and Sejnowski, 2000; Song et al., 2000; Rubin et al., 2001; Levy et al., 2001; van Rossum et al., 2001; Song and Abbott, 2001; Yoshioka, 2002; Fu et al., 2002; Karmarkar and Buonom ano, 2002; M atsum oto and O kada, 2002). Som e of these authors have claim ed that the precise balance between the LTP and LTD of STDP is crucial in the storage of spatio-tem poral pattterns (M unro and H emandez, 2000; Yoshioka, 2002; M atsum oto and O kada, 2002). In our previous work, we analytically showed that STDP has the same qualitative e ect as the covariance rule when the balance is precisely maintained (Matsum oto and Okada, 2002). In the brain, though, it is inconceivable that such a balance will be precisely maintained. Som e authors num erically have investigated the impact of an imbalance between LTP

and LTD on network properties (Song et al., 2000; M unro and H emandez, 2000; Y oshioka, 2002). M unro and H emandez showed that spatio-tem poral patterns cannot be retrieved in a noisy environment when there is no LTD (M unro and H emandez, 2000). However, the mathematical mechanism that accounts for this remains unknown.

In this paper, we analytically investigate the retrieval properties of spatiotem poral patterns in an associative mem ory network where there is an imbalance between the LTP and LTD of STDP by using a method of the statistical neurodynamics (Amariand Maginu, 1988; Okada, 1996; Matsumoto and Okada, 2002). U sing this theory, we discuss the macroscopic behavior of the network at a therm odynam ic lim it: the number of neurons is in nite. When the balance is precisely maintained, sequential patterns can be stored in the network (Matsum oto and Okada, 2002). Also, when the mean deviation from the precise balance is 0 and the uctuation is nite, patterns can be stored at a therm odynam ic lim it (M atsum oto and 0 kada, 2003). This im plies that when the balance is maintained on average, patterns can be stored. We also showed that when the mean is not 0, patterns cannot be stored since a cross-talk noise diverges at a therm odynam ic lim it. However, previous work using computer simulation has shown that the stored limit cycle is stably retrieved when the number of neurons is nite (Munro and Hemandez, 2000; Yoshioka, 2002). In the brain, the number of neurons is considered to be nite. Therefore, it is important to discuss this situation, although no analytical works regarding this has been reported. The purpose of the work reported in this paper was to analytically investigate the retrieval properties when the number of neurons is nite. We found that a network containing a nite

num ber of neurons becom es robust regarding this deviation from a precise balance between the LTP and LTD of STDP. Since the number of neurons in the brain is considered to be nite, our results might apply to the brain.

We introduce our model for the storage of spatio-tem poral patterns in section 2. In section 3, we analytically discuss our model as it applies when the balance between the LTP and LTD of STDP is precisely maintained and when it is not precisely maintained, and in section 4 we investigate the properties of our model. In section 5, we sum marize this paper. The Appendix presents a detailed derivation of the model's dynamical equations of the model when the balance is precisely maintained.

#### 2 M odel

The model contains N binary neurons with reciprocal connections. Each neuron takes a binary value: f0;1g. We de ne discrete time steps and the following rule for synchronous updating:

where  $x_i$  (t) is the state of the i-th neuron at time t,  $u_i$  (t) is the internal potential of that neuron, and is a uniform threshold. If the i-th neuron resatt, its state is  $x_i(t) = 1$ ; otherwise,  $x_i(t) = 0$ .  $J_{ij}$  is the synaptic weight from the j-th neuron to the i-th neuron. Each element i of the -th memory pattern = (1; 2; N)

is generated independently by

The expectation of is E[i] = f; thus, f is considered to be the mean ring rate of the mem ory pattern. The mem ory pattern is sparse when f! 0, and this coding scheme is called sparse coding.

The synaptic weight  $J_{ij}$  follows the form of synaptic plasticity, which depends on the di erence in spike times between the i-th (post-) and j-th (pre-) neurons. This di erence determ ines whether LTP or LTD is induced. Such a learning rule is called spike-timing-dependent plasticity (STDP). Biological experimental indings have shown that LTP or LTD is induced when the di erence between the pre- and post-synaptic spike times falls within about 20 ms (Zhang et al., 1998) (Figure 1 (a)). There are also other types of STDP (Abbott and Nelson, 2000). The STDP type of Figure 1 (a) has often been used in theoretical work (e.g., Song and Abbott (2001); Rao and Sejnowski (2000)). We transformed this type of window function into the time window shown in Figure 1 (b). This time window shows that LTP is induced when the j-th neuron resone time step before the i-th neuron resone time step affer the i-th neuron resone time step before the i-th neuron resone time step affer the i-th neuron resone time step in equations (1 (3)) as 20 ms, and any duration of less than 20 ms is ignored. A synaptic plasticity obeying this time window is described by

A fterm em ory patterns are em bedded by STDP, the synaptic weight is written as

where the value  $\frac{1}{N \pm (1-1)}$  is a scaling factor and the number of memory patterns is p = N where is defined as the loading rate. If both the i-th neuron and the j-th neuron resimultaneously, neither LTP nor LTD occurs because equation (6) does not include the term of  $_{i-j}$ . Since the relative LTP and LTD magnitudes are more critical than the absolute magnitudes, the LTD magnitude changes while the LTP magnitude and the time duration are xed. denotes deviation from a precise balance. When = 0, the balance is precisely maintained and this model is equivalent to the previous one Matsum oto and Okada, 2002). A sequence of p memory patterns is stored by STDP:  $^{1}$ !  $^{2}$ !  $^{1}$ !  $^{1}$ !  $^{1}$ !  $^{1}$ ! In other words,  $^{1}$  is retrieved at t = 1,  $^{2}$  is retrieved at t = 2, and  $^{1}$  is retrieved at t = p + 1. There is a critical value  $_{C}$  of the loading rate, so that a loading rate higher than  $_{C}$  causes retrieval of the pattern sequence to become unstable.  $_{C}$  is therefore called the storage capacity.

## 3 Theory

### 3.1 The Case where Balance is Precisely Maintained

Here, we brie y discuss the case where the balance is precisely maintained, which we previously discussed in detail (Matsum oto and Okada, 2002). This discussion will help explain the case where the balance is not precisely maintained.

First, we consider a simple situation where there are very few memory patterns

relative to the number of neurons; i.e., p = 0 (1). Let the state at time t be equivalent to the t-th mem ory pattern: x(t) = t. The internal potential  $u_i(t)$  of equation (1) is then given by

 $u_i$  (t) depends on two independent random variables,  $i^{t+1}$  and  $i^{t-1}$ . The rst term  $i^{t+1}$  is the signal term for the recall of the pattern  $i^{t+1}$ , which is intended to be retrieved at time  $i^{t+1}$ , and the second term  $i^{t-1}$  may interfere with the retrieval of  $i^{t+1}$ . A coording to equation (7),  $u_i$  (t) takes a value of 0, 1 or +1. The probability distribution of  $u_i$  (t) is given by Figure 2 (a); i.e.,

Prob  $(u_i(t)) = (f f^2) (u_i(t) 1) + (1 2f + 2f^2) (u_i(t)) + (f f^2) (u_i(t) + 1): (8)$ If the threshold is set between 0 and +1, the probability of  $u_i(t) = 0$  is 1 2f +  $2f^2$ , that of  $u_i(t) = +1$  is  $f^2$ , and that of  $u_i(t) = 1$  is  $f^2$ . The overlap between the state x(t+1) and the memory pattern t+1 is given by

At a sparse  $\lim$  it, the overlap  $m^{t+1}(t+1)$  approaches 1. In other words, the m em ory pattern t+1 is retrievable.

Next, we consider the case where there is a large number of mem ory patterns, i.e., p = 0 (N ). The i-th neuronal internal potential  $u_i$  (t) at time t is given using the periodic boundary condition of  $_i^{p+1}=_i^1$  and  $_i^0=_i^p$  by

The rst term in equation (11) is the signal term for the recall of pattern that represents the contributions of non-target patterns other than that represents the contributions of non-target patterns other than that represents the retrieval of the target pattern that the cross-talk noise is assumed to obey a Gaussian distribution with mean 0 and time-dependent variance that the recursive equation for the overlap mthat (t) between the state x (t) and the target pattern that by using the method of the statistical neurodynamics (Amari and Maginu, 1988; Okada, 1995; Matsum oto and Okada, 2002) to calculate the overlap mthat (t). The recursive equation is given by

The details of this derivation are given in the Appendix. To obtain the storage capacity  $_{\rm C}$ , we calculate the overlap in the steady state. We set the initial state of the network at the rst memory pattern: x (1) =  $^{\rm 1}$ . Setting the initial values at

m  $^1$  (1) = 1,  $^2$  (1) = 2 f,U (1) = 0, and q(1) = f and using the recursive equations (13-16), we obtain the overlap in the steady state. There is a critical value  $_{\rm C}$  of the loading rate, so that the loading rate higher than  $_{\rm C}$  causes retrieval of the pattern sequence to become unstable. In computer simulation, when the overlap in the steady state is smaller than 0.5, the critical loading rate is regarded as the storage capacity  $_{\rm C}$ .

#### 3.2 The Case Where Balance is not Precisely Maintained

The case where balance is not precisely maintained is discult to treat because the mean of the cross-talk noise is not 0. However, previous work using computer simulations has shown that the stored limit cycle is stably retrieved when the number of neurons is nite (Munro and Hernandez, 2000; Yoshioka, 2002). However, this mathematical mechanism has remained unknown. To investigate this unknown mechanism, we will use the theory derived in section 3.1.

First, let the state at time t be equivalent to the t-th memory pattern: x(t) = t. The i-th neuronal internal potential  $u_i(t)$  at time t is then given using the periodic boundary condition of i = t and i = t by

where  $_{\rm j}$  =  $_{\rm j}$  f. Here, we evaluate the second term; that is, the compensation term in equation (18). The average of this term is  $_{\rm 1 f}^{\rm f}$  N q(t) where

 $q(t) = \frac{1}{N} \sum_{j=1}^{P} x_j(t) = f$  when x(t) = t. A typical value of this term is 0:19 for N = 5000, = 0:067, = 0:05 and f = 0:1, which are typical values used in the following analysis. This value is small enough for the overlap  $m^t(t)$  1. The uctuation in the compensation term can be eliminated since the order of the variance of this term is smaller than that of the average. Therefore, the average term of the compensation term adds to the signal term in equation (11).

Next, we will discuss a mechanism that enables memory patterns to be retrieved in the small and nite N case. The internal potential with x(t) = t is given by

When  $\uphi$  0, each distribution of  $u_i$  (t) shifts by  $\frac{f^2}{1-f}$  N as shown in Figure 2 (b). For the typical case at N = 5000, = 0.067, = 0.05, f = 0.1, and = 0.52, each distribution of  $u_i$  (t) would shift left by 0.19. Since the threshold is 0.52, the probability of  $u_i$  (t + 1) = +1 is little changed. In other words, for the small and nite N case, retrieval of the next pattern  $^{t+1}$  is successful. Otherwise, the retrieval fails.

Since the average term of the compensation term adds to the signal term in equation (11), the i-th neuronal internal potential  $u_i$  (t) at time t is given by

Here, the rst term is the signal term and the second is the cross-talk noise term. The third term is the compensation term. Statistical neurodynam ics enables us to derive dynam ical equations. These equations are almost the same as those in section 3.1 other than  $_{0}$ ,  $_{1}$  and  $_{2}$ . In  $_{0}$ ,  $_{1}$  and  $_{2}$ , is replaced by

#### 4 Results

We used statistical neurodynam ics and computer simulation to investigate the properties of our model and exam ine its behavior.

Figure 3 shows the dependence of the overlap m<sup>t</sup>(t) on the loading rate when the mean ring rate of the memory pattern is f=0.1 and the threshold (optim ized to maxim ize the storage capacity) is =0.52. The solid line denotes the steady-state values of the overlap m<sup>t</sup>(t) at =0.0 in (a) and =0.05 in (b). We obtained m<sup>t</sup>(t) by setting the initial state of the network at the rst memory pattern: x(1) = 1. The storage capacity is c = 0.27 in (a) and c = 0.067 in (b). The data points and error bars (with the former indicating median values and the latter indicating 1/4 and 3/4 deviations) show the computer simulation results from 11 trials with 5000 neurons (N = 5000). The discrepancy between the values of m<sub>C</sub> obtained from the computer simulations and the analytical results was caused by the nite size e ect of the computer simulations (M atsum oto and 0 kada, 2002).

Figure 4 (a) shows the storage capacity  $_{\rm C}$  as a function of . In the computer simulaton, when the overlap in the steady state is smaller than 0.5, the critical bading rate is regarded as the storage capacity  $_{\rm C}$ . The data points and error bars (with the former indicating mean values and the latter indicating standard deviations) show the computer simulation results from 10 trials at f=0.1, = 0.52, and N = 3000 ( ) or N = 5000 ( ). The solid line shows the theoretical

results at N = 3000, while the dashed line and the gray solid line show the results at N = 5000 and N = 100000, respectively. As j jincreased, c decreased. When = 0.5, the storage capacities for N = 3000 and N = 5000 were 0.017 and 0.011, respectively. However, the storage capacity for N = 100000 was 0. In other words, when the number of neurons is nite, c takes a nite value. These computer simulation results are consistent with the theoretical results at small. Figure 4(b) shows the maximum number of storable memory patterns,  $p_{max} = {}_{C}N$ , as a function of . This is replot of Figure 4(a). The solid line shows the theoretical results at N = 3000, while the dashed line and the gray solid line show the results at N = 5000 and N = 100000, respectively. As j jincreased, actual number of storable memory patterns decreased.

Figure 5 shows  $_{\text{C}}$  as a function of . The solid line shows the theoretical results at f=0.1 and =0.52, while the dashed line shows  $\log_{10}$   $_{\text{C}}=\log_{10}$  N +1.435 at N =5000, f=0.1, and =0.52. This gure shows that  $_{\text{C}}$  converged to 0 as the order of  $\frac{1}{N}$  (i.e., O  $(\frac{1}{N})$ ) at a large N  $\lim$  it.

## 5 Sum mary and Discussion

We have investigated, using an associative memory network, how the balance between the LTP and LTD of STDP a exts the retrieval of spatio-tem poral patterns. O ther authors have numerically investigated the impact of an imbalance between LTP and LTD on network properties. We have analytically investigated the retrieval properties by applying statistical neurodynamics. In the case where the value of LTD deviates from a precise balance the stored limit cycle using STDP

is unstable at the therm odynam ic  $\lim$  it. However, the stored  $\lim$  it cycle is stable when the number of neurons is nite. Moreover, computer  $\lim$  ulation results were consistent with the theoretical results at  $\lim$  and  $\lim$  in the number of neurons becomes robust against deviation from a precise LTP/LTD balance. Since the number of neurons in the brain is considered to be nite, our results might be applicable to the brain. Furthermore, the storage capacity converges to 0 as 0  $\frac{1}{N}$  at a large N  $\lim$  if it.

## Appendix. Derivation of Recursive Equations when Balance is Precisely Maintained

In this appendix, we derive recursive equations for the overlap m  $^{t}$  (t) when the balance between the LTP and LTD of STDP is precisely maintained. Figure 1: The time window of spike-timing-dependent plasticity. (a): Results of the biological experiment (Zhang et al., 1998). (b): STDP in our model. LTP occurs when the j-th neuron resone time step before the i-th neuron. LTD occurs when the j-th neuron resone time step after the i-th neuron.

Figure 2: Probability distribution of the i-th neuronal potential  $u_i$  (t) at time t. (a) The balance between the LTP and LTD of STDP is precisely maintained; i.e., = 0. (b) The balance is not precisely maintained; i.e., 6 0. Each distribution shifts by  $\frac{f^2}{1-f}$  N.

Figure 3: The solid line shows the overlap in the steady state when the ring rate of stored patterns is 0:1 at = 0.0 in (a) and = 0.05 in (b). The storage capacity is 0:27 in (a) and 0:067 in (b). In both gures, the threshold is 0:52 and the number of neurons is 5000. The data points indicate the median values and the ends of the error bars indicate 1/4 and 3/4 derivations, respectively, from 11 computer simulation trials.

Figure 4: (a)The storage capacity  $_{\text{C}}$  and (b)the maximum number of storable memory patterns,  $p_{\text{max}} = _{\text{C}} N$ , (b) as a function of . The data points and error bars (with the former indicating the mean values and latter indicating standard deviations) in (a) show computer simulation results from 10 trials at N=3000 ( ) or N=5000 ( ). The solid line, dashed line and gray solid line show the theoretical results at N=3000, N=5000, and N=100000, respectively. All results were obtained at f=0.1 and f=0.52. As j jincreased, f=0.52 and f=0.52 are decreased.

Figure 5: Storage capacity  $_{\text{C}}$  as a function of at N = 5000, f = 0:1, and = 0:52. The solid line shows the theoretical results while the dashed line shows  $\log_{10}$   $_{\text{C}}$  =  $\log_{10}$  N + 1:435.  $_{\text{C}}$  converged to 0 as 0 ( $\frac{1}{N}$ ) at a large N limit.










