# D ynam ics of a Bose-E instein C ondensate near a Feshbach R esonance

# Abstract

We discuss the response of a Bose-E instein condensate to a change in the scattering length, which is experimentally realized by tuning the magnetic eld near a Feshbach resonance. In particular, we consider the collapse of the condensate induced by a sudden change in the scattering length from a large positive to a small negative value. We also consider the condensate dynamics that results from a single pulse in the magnetic eld, due to which the scattering length is rapidly increased from zero to a large value and then after some time rapidly decreased again to its initial value. We focus primarily on the consequences of the quantum evaporation process on the dynamics of the Bose-E instein condensate, but also discuss the elects of atom -m olecule coherence.

#### I. IN TRODUCTION

From single-channel scattering theory it is well known that the collisional cross section changes dram atically if the energy of the incoming particles is close to the energy of a longlived bound state in the interaction potential. In particular, the magnitude of the s-wave scattering length a of an attractive potential well diverges as the depth of the potential well is increased such that a new bound state enters the well [1]. A sim ilar behavior occurs in the case of a Feshbach resonance, when the energy of the two particles in the incom ing channel is close to the energy of a bound state in a closed channel [2]. In the case of collisions between alkaliatoms, the coupling between the two channels is provided by the hyper ne interaction. Due to the spin ips involved in this interaction, the di erence in energy between the bound state and the continuum, the so-called detuning, is adjustable by m eans of a m agnetic bias eld. Feshbach resonances were rst predicted theoretically [3, 4], but have now also been observed experimentally, in various atom ic species [5, 6, 7, 8]. As a result the experiments with magnetically-trapped ultracold atom ic gases, where the s-wave scattering length fully determines the interaction e ects, have an unprecedented high level of control over the interatom ic interactions. In this paper we focus on  $^{85}$ Rb in the f = 2;m<sub>f</sub> = 2 hyper ne state, which has a Feshbach resonance at a magnetic eld of  $B_0$ 154:9 (G)auss [9]. Near the resonance the scattering length, as a function of magnetic eld, is given by




FIG.1: The scattering length as a function of the magnetic eld for <sup>85</sup>Rb in the state  $jf = 2;m_f = 2i$ . The position of the resonance is indicated by the vertical dashed line. At the horizontal dashed line the scattering length vanishes. The dashed-dotted line indicates the background scattering length  $a_{bg}$  450a<sub>0</sub>.

The resonance is characterized by the width B 11:6 G and the o-resonant background scattering length  $a_{bg}$  450a, with  $a_0$  the Bohr radius. In Fig. 1 the scattering length is shown as a function of the magnetic eld. Clearly, it can be adjusted experimentally from large negative values, to large positive ones. Moreover, at a magnetic eld of B 166:5 G the scattering length vanishes, and the gas behaves electively as an ideal Bose gas.

With this experimental degree of freedom it is possible to study very interesting new regimes in the many-body physics of ultracold atom ic gases. The rst experimental application was the detailed study of the collapse of a condensate with attractive interactions. In general a collapse occurs when the attractive interactions overcom e the kinetic energy of the condensate atom s in the trap. Since the typical interaction energy is proportional to the density, there is a certain maximum number of atoms above which the condensate is unstable [10, 11, 12, 13, 14]. In the rst observations of the condensate collapse by B radley et al. [15], a condensate of doubly spin-polarized <sup>7</sup>Li atom s was used. These atom s have a magnetic-eld independent scattering length of a 27a. For the experimental trap param eters this leads to a maximum number of condensate atom s that was so low that nondestructive in aging of the condensate was in possible. Moreover, them al uctuations due to a large therm al component make the initiation of the collapse a stochastic process, thus preventing also a series of destructive m easurem ents of a single collapse event [16, 17, 18]. A statistical analysis has nevertheless resulted in important information about the collapse process. Very recently, it was even possible to overcom e these problem s [19].

In addition to the experiment with  ${}^{7}Li$ , experiments with  ${}^{85}Rb$  have been carried out. In particular, Roberts et al. [20] also studied the stability criterion for the condensate, and D onley et al. [21] studied the dynamics of a single collapse event in great detail. Both of these experiments make use of the above-mentioned Feshbach resonance to achieve a well-de ned initial condition for each destructive measurement. It turns out that during a collapse a signi cant fraction of atom s is expelled from the condensate. M oreover, one observes a burst of hot atom s w ith an energy of about 150 nK. Severalm ean-eld analyses of the collapse, which m odel the atom loss phenom enologically by a three-body recombination rate constant, have o ered some theoretical insight [22, 23, 24, 25, 26, 27]. How ever, the physical m echanism responsible for the explosion of atom s out of the condensate and the form ation of the noncondensed component is still largely ununderstood at present.

A second experimental application of the Feshbach resonance has been in plemented by C laussen et al. [28]. Starting from the noninteracting limit, the scattering length is made to jump very fast back and forth to a large and positive value. Surprisingly, in this case one also observes loss of atom s from the condensate, as well as a burst of hot atom s. Even more surprising is the fact that the am ount of atom s expelled from the Bose-E instein condensate decreases with time during some intervals, excluding a theoretical explanation in term s of a loss process characterized by a rate constant.

A sa third application D onley et al. [31] have conducted an experiment where two trapezoidal pulses in the magnetic eld were applied. A sa function of the time between the two pulses an oscillatory behavior in the number of condensate atom s is observed, which is attributed to coherent R abi oscillations between atom s and molecules [32, 33, 34]. In this paper we will not consider this experiment, but instead focus on the rst and second experimental applications. In particular the single-pulse experiment has not received much attention theoretically, even though an understanding of this experiment. Therefore, the discussion of this most recent experiment will be postponed to a future publication.

In a previous paper we have considered the loss of atom s by m eans of elastic two-body collisions, in the situation where the condensate collapses [29]. However, the mechanism put forward in this paper is much more general. In particular, the mechanism should also be relevant for the above m entioned single-pulse experiments. The main goal of this paper is to present the theory behind it in great detail. Since the mechanism is able to describe loss from a condensate at zero tem perature we will hereafter refer to it as quantum evaporation. The two-pulse experiments of Donley et al. [31] have made it clear that atom -molecule coherence can have an important e ect on the dynamics of a Bose-Einstein condensate. Besides the quantum evaporation process, we thus want to consider this physics in the case of the single-pulse experiments as well. We are able to achieve this because very recently we have derived an elective quantum eld theory that o ers a description of the Feshbach resonance in terms of an atom -m olecule ham iltonian that captures all the relevant two-body physics exactly [30]. A part from a detailed discussion of the condensate collapse, the main application of this paper therefore concerns the e ect of quantum evaporation in the singlepulse experiments and the investigation of the importance of atom -m olecule coherence in this case. With respect to the latter remark it should be noted that the e ect of atom m olecule coherence in the case of the condensate collapse will be neglected in the following, because the magnetic eld is tuned to a far o -resonant value to induce the collapse.

In view of this the above the paper is organized as follows. In Sec. II we present and discuss the theoretical description of quantum evaporation. In Sec. III we present the applications to the condensate collapse, and to the single-pulse experiments with positive scattering length. We end in Sec. IV with our conclusions.

## II. QUANTUM EVAPORATION

In this section we derive the generalized G ross-P itaevskii equation that includes the correction term due to the quantum evaporation of atom s out of the condensate. From this result follows a rate equation for the change in the number of atom s in the condensate. Sec. IIA is rather technical and m ay be om itted in a rst reading. To facilitate this the nal rate equation, which is m ost in portant for our purposes, is presented in Sec. IIB.

### A. Generalized Gross-Pitaevskii equation

A lthough the desired rate equation for the number of atom s can also be derived from the in aginary-time form alism by means of a W ick rotation to real time, the equation of motion for the condensate wave function can not be derived in this manner. Therefore, we use a functional formulation of the Schwinger-Keldysh nonequilibrium theory [35, 36] developed in Refs. [37, 38, 39], from which the equation of motion for the condensate wave function for the \classical" part of the uctuating order-parameter eld.

W ithin this form alism, the W igner probability distribution of the order parameter is written as a functional integral over complex elds (x;t) and (x;t). These elds are de ned on the Keldysh contour  $C^t$ , which runs from  $t_0$  to t and then back to  $t_0$ . The probability distribution is given by

where we absorbed the appropriate initial condition  $P[;;t_0]$  into the measure of the

functional integral [39]. The action in the exponent of the integrand is given by

where V  $^{\text{ext}}(x)$  is the external trapping potential. The interaction is determined by the two-body T (ransition) matrix element T<sup>2B</sup> (t) = 4 a(t)h<sup>2</sup>=m, where a(t) a (B (t)) is the interatom ic s-wave scattering length, and m is the mass of one atom. Note that we explicitly allowed the scattering length to depend on time. This is experimentally realized by tuning the magnetic eld near the Feshbach resonance.

To arrive at an elective action for the condensate wave function, we explicitly separate out the condensate part from the eld (x;t). Therefore we write  $(x;t) = {}_{0}(x;t) + {}^{0}(x;t)$ , and substitute this into the action in Eq. (3). In this separation,  ${}_{0}(x;t)$  describes the condensed part of the gas, whereas  ${}^{0}(x;t)$  describes the uctuations. The precise distinction between the condensate and the noncondensed part is discussed in detail in Sec III. Physically, the idea is that  ${}_{0}(x;t)$  describes the Bose E instein condensate and its collective modes, whereas  ${}^{0}(x;t)$  is associated with the modes not occupied by the condensate. To de ne these two parts consistently, we have to require that they are essentially orthogonal, i.e.,  ${}_{Z}$

This condition ensures that the Jacobian of the transform ation of integration variables in the functional integral in Eq. (2) is equal to one. In the operator form alism, this condition in plies that the Bose eld operators  $^{0}(x;t)$  and  $^{0}(x;t)$  associated with the uctuations, obey the usual Bose commutation relations in the Fock space built upon the states orthogonal to  $_{0}(x;t)$ .

A fler this substitution the functional integral becomes

Here, we de ne S<sup>0</sup>[ $_{0}$ ;  $_{0}$ ;  $_{0}$ ;  $_{0}$ ;  $_{0}$ ] such that it contains the term s up to quadratic order in the uctuations. We do not retain the term s proportional to ( $_{0}^{0}$ )<sup>2</sup> and ( $_{0}^{0}$ )<sup>2</sup>, since these so-called anom alous term s are only needed to describe the collective motion of the condensate. Their e ect is therefore already included in the action S [ $_{0}$ ;  $_{0}$ ] for the part of the eld that describes the condensate. In principle S<sub>int</sub>[ $_{0}$ ;  $_{0}$ ;  $_{0}^{0}$ ] contains term s which are either of rst, third or fourth order in the uctuations. We neglect, however, the term s of third and fourth order, which is known as the Bogoliubov approximation. This approximation is valid for the zero-tem perature applications under consideration in this paper. Moreover, the term s of higher order in the uctuations describe the interactions among the ejected atom s and are expected to be of little importance in determining the ejection rate for the atom s expelled from the condensate.

W e write the quadratic action  $S^{0}[_{0};_{0};_{0};_{0}]$  as

where we introduced the G reen's function G  $(x;t;x^0;t^0)$  for the uctuations by m eans of

Here, the delta function in the time variables is de ned on the Keldysh contour, by means of  $_{C^t} dt^0$  (t;t) = 1. The part of the action that describes the interactions between the condensed and noncondensed parts of the system is, in rst instance, given by

It is important to note that this part of the action does not vanish because the condensate wave function, as we see in a moment, does not obey the usual G ross-P itaevskii equation once we include the quantum evaporation process. Furthermore, the eld  $^{0}(x;t)$  describes the high-energy part of the system, and thus has an expansion in terms of the high-energy trap states. As a result we are allowed to neglect the terms proportional to the single-particle H am iltonian. The term swith the time derivative vanish because of the orthogonality condition in Eq. (4). The action in Eq. (8) therefore reduces to

The functional integral over the uctuations in Eq. (5) is a Gaussian integral and can be easily performed. This de nes the elective action for the condensate on the Keldysh contour by means of

where  $T_{C^t}$  denotes time ordering along the Keldysh contour and  $(t_0)$  represents the initial density matrix of the gas, this G reen's function can be decomposed into its analytic pieces by means of

with (t;t) the H eaviside function on the K eldysh contour. The G reen's functions  $G^{>}$  and  $G^{<}$  thus correspond to averages of a xed order of creation and annihilation operators. Note that these G reen's functions essentially describe the propagation of a noncondensed atom in the presence of the m ean-eld interaction with the condensate.

To nally derive the generalized G ross-P itaevskii equation for the condensate wave function, we want to separate out the \classical" part of the eld  $_0$  (x;t). This is achieved by m eans of the transform ation

Here, (x;t) denotes the condensate wave function, whereas the eld (x;t) describes its uctuations. The upper (lower) sign in Eq. (15) corresponds to the forward (backward) branch of the Keddysh contour. When substituting this transformation into the elective action in Eq. (12), we should in principle only keep terms up to quadratic order in the uctuations, to avoid a double counting of the interactions that we have already taken into account. However, to read o the generalized G ross-P itaevskii equation, including the correction terms associated with the quantum evaporation process, it su ces to consider only the linear terms in the uctuations. This is can be understood from the fact that with this approximation a functional integration over the uctuations leads to a constraint for

(x;t), which is precisely the \classical" equation of motion that we are interested in. W ith the transformation in Eq. (15) we thus project the elective action on the real-time axis and read of the equations of motion for (x;t) and (x;t) by putting the coefficient of the terms linear in (x;t) and (x;t) equal to zero, respectively. A first straightforward but somewhat tedious algebra this results in

with the complex conjugate expression for (x;t). We de ned the retarded and the advanced G reen's functions in the usualway by

Note that the Heaviside function in this de nition is precisely such that the equation of motion for (x;t) is causal.




FIG. 2: These time-ordered Feynmans diagrams correspond to terms associated with quantum evaporation in the equation of motion for the condensate wave function

The time-ordered Feynman diagrams corresponding to the two terms in the generalized Gross-Pitaevskii equation describing the quantum evaporation process are given in Figs. 2 (a) and (b), respectively. In these diagrams, a condensate atom is denoted by a

dashed line. An ingoing dashed line thus corresponds to a factor (x;t), and an outgoing dashed line to a factor (x;t). The advanced and retarded propagators of the ejected atom s are denoted by solid lines. A retarded propagator is denoted by an arrow pointing from  $(x^0;t^0)$  to (x;t), and corresponds to the propagation of a particle. An advanced propagator is denoted by an reversed arrow, and can be interpreted as the propagation of a \hole". Note that the rst term in Eq. (16) has an additional factor of two with respect to the second term. This is understood from the fact that the corresponding diagram (Fig. 2 (a)) has two outgoing lines at (x;t) and therefore contributes twice, whereas the diagram in Fig. 2 (b) has only one outgoing line at those coordinates.

# B. Rate equation

In the previous section we have generalized the G ross-P itaevskii equation to include the quantum evaporation process. W ith this equation we derive a rate equation for the number of atom s in the condensate. It is given by

The retarded propagator  $G^{(+)}(x;t;x^0;t^0)$  describes the noncondensed atom s. Note that in both this rate equation, and the equation of motion in Eq. (16) we have taken the lim it  $t_0 !_h 1$  to eliminate initial transient e ects. Furtherm ore, we have made use of the fact that  $G^{(+)}(x;t;x^0;t^0) = G^{(-)}(x^0;t^0;x;t)$ , which follows from the de nition of this G reen's function.

The nonmarkovian rate equation in Eq. (18) describes the evolution of the number of condensate atoms due to a change in the scattering length or the condensate wave function. Physically the coupling between the condensed and noncondensed parts of the system allows the condensate to eject atoms. Since we have neglected the interactions among the ejected atoms, this rate equation is applicable only for short times and does not describe the rethermalization of the ejected atoms. Because of this approximation the ejection process is coherent, and atoms can come back into the condensate on short time scales. To get more physical insight in the quantum evaporation process, we discuss the weak-coupling limit, where it just corresponds to elastic condensate collisions.

In the weak-coupling limit, where the mean-eld interaction is small compared to the energy-level splitting of the external trapping potential, the rate equation for the number of atom s in the condensate acquires a familiar form. To see this, we note that in this limit the retarded propagator is given by

because the single particle states  $_n(x)$  and energies  $_n$  are, in this limit, by de nition not a ected much by the interactions. The sum in this expression is over all the trap states, except for the condensate mode, i.e., the one-particle ground state.

The condensate wave function is given by

where  $_0$  is the ground state energy, and N<sub>c</sub> 1 is the number of atom s in the condensate. U sing these expressions, the rate equation for the number of atom s in Eq. (18) can be rewritten as

which is precisely Ferm i's Golden Rule for the rate to scatter out of the initial state Di, found from second-order perturbation theory. The sum is over all nal states of the form

with energy  $_n + .$  Since we are dealing with identical bosons these states are symmetric. This nalstate thus represents a condensate atom and an ejected atom, whereas the initial state with energy 2 is given by

and therefore represents two condensate atom s. The additional factor  $N_c^3$  is a result of the Bose statistics of the atom s. There is a factor  $N_c (N_c - 1)=2$   $N_c^2=2$  for the number of condensate atom pairs and an additional factor  $1 + N_c - N_c$  for the condensate atom that is Bose stimulated back into the condensate. Finally, the potential is given by




FIG.3: Energy levels of the noncondensate atom s (thin solid lines), in the presence of a condensate at a given chem ical potential (dotted line). The potential felt by the noncondensed atom s is indicated by the solid line.

We see that, in the weak-coupling limit, the energy-conserving delta function can never be obeyed, and thus  $dN_c = dt = 0$ , as expected in this limit. Another important observation is that energy conservation also forbids the ejection of atom sout of a static condensate with repulsive interactions, even in the strong-coupling limit. This is because of the fact that the energy of a condensate atom, i.e., the chemical potential, is positive in this case, and that the energy of the excited states is always larger than the chemical potential. In the Thom as-Ferm i limit, where the mean-eld interaction is much larger than the kinetic energy of the atom s, this is illustrated in Fig. 3. In this gure, the harm onic trapping potential is denoted by the dashed line. For a given chemical potential , indicated by the dotted line,

the noncondensed atom s feel the potential indicated by the solid line. The energy levels of the states in this potential are also drawn schem atically. C learly, the energy of the rst excited state is always larger than the chem ical potential, and therefore the ejection of atom s out of the condensate by m eans of elastic collisions is forbidden due to energy conservation.

This leads to the important conclusion that in order to eject atom sout of the condensate by means of the quantum evaporation process, there has to be a strong time dependence of either the condensate wave function, or of the scattering length. In the next section, we discuss two experimentally relevant examples where this is the case.

# III. A P P L IC A T IO N S

In this section we apply the theory, described in the previous section, to two di erent experimental situations. In the rst part, we consider the case where the Feshbach resonance is used to investigate the collapse of a condensate [9, 21]. In the second part we apply our theory to the situation where the scattering length is changed very rapidly back and forth from zero to a large and positive value [28]. We also discuss the importance of atom -m olecule coherence in this case.

# A. Condensate collapse

The use of a Feshbach resonance has made it possible to explore the physics of the collapse in two di erent regimes. First, we can have a collapse in which the dynamics of the condensate is mostly determined by the mean-eld interactions. This is the case in the experiments with <sup>7</sup>Li [15, 16, 17, 19], which has a xed negative scattering length. In these experiments, there is always a large therm aloom ponent which feeds the condensate. Therefore, we call such a collapse a Type I collapse, in analogy with a Type I supernova, which is believed to be the result of an accreting white dwarf that explodes when the accumulated mass becomes to large [50], similar to the <sup>7</sup>Li condensate that grows from the therm al cloud and then collapses. The more recent experiments by D onley et al. [21] also deal with a Type I collapse, since one starts a collapse from the noninteracting limit, where the density is relatively high compared to Bose-E instein condensates with a repulsive self-interaction.

C om plem entary to this regim e we can have a second type of collapse where the dynam ics is mostly determ ined by the external trapping potential. This regim e was considered experim entally by C omish et al. [9]. U sing the Feshbach resonance of <sup>85</sup>Rb one rst makes a large, stable and essentially pure condensate, i.e., there is no visible therm all cloud present, with repulsive interactions. Then, one suddenly switches the interactions from repulsive to slightly attractive, and watches the subsequent collapse. Because the collapse in this case starts at low density due to the initially large and repulsive interatom ic interactions and the magnitude of the nal negative scattering length is much smaller than the initial positive one, its dynam ics is mostly determined by the trapping potential. We call such a collapse a Type II collapse, in analogy with a Type II supernova. Such a supernova is the fate of a massive star analogous to the large condensate with repulsive interactions.

In the experiments on the Type II collapse it was found that after such a collapse the number of atom s in the condensate is of the same order as the maximum number of atom s allowed to have a metastable condensate [40]. This suggests that during such a collapse enough atom s are ejected from the condensate, so that the condensate becomes metastable. The most important theoretical task is therefore to identify the physical mechanism responsible for this ejection. We have recently argued that the quantum evaporation process provides an explanation for these experiments [29]. Moreover, we will explicitly show here that the decay solely by means of three-body recombination does not explain the experimental results for the Type II collapse.

Interestingly, the m etastable condensate that is the result of a Type II collapse is precisely the starting point for a Type I collapse, m aking this last collapse a much more violent phenom enon. We restrict ourselves here to the description of the Type II collapse, because a proper treatment of the Type I collapse requires a full num erical solution of the generalized G ross-P itaevskii equation that includes the nonlocal correction term due to quantum evaporation. This is beyond the scope of the present paper, and we use a simpler variational approach here that we believe is appropriate for a Type II-collapse event.

# 1. Gaussian approximation and sem iclassical retarded propagator

In principle, we must now numerically solve the generalized G ross-P itaevskii equation in Eq. (16) that includes nonlocal terms. However, in order to gain physical insight, we will make several approximations to reduce the solution of this equation to a numerically more tractable problem. First of all, we use a gaussian variational approach to the condensate wave function [51]. More precisely, we assume the condensate wave function to be of the form

In the limit of a small number of condensate atom s N<sub>c</sub>(t) this ansatz becomes an exact solution of the G ross-P itaevskii equation for a harmonic external trapping potential, and therefore a good description of the condensate after the collapse. It is, how ever, also known that a gaussian ansatz gives good results on the frequencies of the collective modes, even in the Thom as-Ferm i regime [41]. M oreover, since we consider only the Type II collapse and therefore by de nition assume that the trapping potential is more important than the mean-eld interactions, we expect the gaussian ansatz to give physically reasonable results at all times.

In the case of the ordinary G ross-P itaevskii equation the variational parameters obey Newton's equation of motion [12]

with a potential given by

where the frequencies  $!_{j}$  are the frequencies of the harm onic external trapping potential in the three spatial directions. We have recently extended the above variational calculus also to the case of a nonlinear Schrodinger equation including an imaginary term due to the presence of a therm all cloud, and found that the equation of motion for the variational parameters in principle contains a damping term [18]. However, we are interested in the zero-tem perature situation, in which this damping term is negligible. This means that for a description of the collapse, we only have to couple Eq. (26) to the rate equation for the num ber of atom s in Eq. (18).

To determ ine this rate equation in detail, we need an expression for the propagator of the ejected atom s. A nticipating that the energy of the ejected atom s will be much higher than the energy of a condensate atom, we take for the one-particle G reen's function of the ejected atom s the sem iclassical approxim ation,

where we introduced the center of m ass coordinate  $R = (x + x^0)=2$ , and used  $T = (t + t^0)=2$  for notational convenience. The energy of the ejected atom s is, in this approximation, given by

This energy is measured from 1, which is the rst excited level in the trap. This energy thus determ ines the cut-o between the condensate and the ejected atom s. A lthough this cut-o is important to make the distinction between condensate and noncondensate atom s, we not that our num erical results are not very sensitive to its precise value.

Since the most in portant contribution to the rate equation comes from the center of the trap, we expect that we can, to a good approximation, take for the energy of an ejected atom the value (k;0;T) (k;T). We use this value for the energy of an ejected atom from now on. This approximation is very convenient, since we can now perform the spatial integrals in the rate equation, as well as the integral over the momenta in the expression for the retarded propagator analytically. The nal result is given in Appendix A.

In the ansatz in Eq. (25) we have included a global phase  $_0$  (t). This is important, since we have already seen in the previous section that this global phase determ ines the energy of a condensate atom in equilibrium. We can determ ine this global phase by insertion of the ansatz in the Gross-P itaevskii equation including the correction term in Eq. (16), and separating out the real part. N eglecting the contribution of the quantum evaporation process

to the mean-eld energy, it is up to an irrelevant constant given by [18]

Note that in equilibrium this results in a phase factor  $e^{i t=h}$  for the condensate wave function, with =  $@V(q;N_c)=@N_c$ . This is clearly the correct expression for the chemical potential.

W ith the above approximations we have reduced the dicult problem of solving a partial di erential equation with a nonlocal correction term to the problem of solving the ordinary di erential equations for the variational parameters in Eq. (26) coupled to the rate equation for the change in the number of atoms in Eq. (18). This rate equation is now only nonlocal in time, since all the integrals can be done analytically for the gaussian wave function and the sem iclassical retarded propagator we are considering here. In the next section we will present our results obtained by num erically solving these equations.

## 2. Results

We have performed numerical simulations for the experimental conditions of Comish et al. [9, 40] with <sup>85</sup>Rb. The frequencies of the external trapping potential are equal to  $!_r=2 = 17.4 \text{ Hz}$  and  $!_z=2 = 6.8 \text{ Hz}$ , in the radial and axial direction, respectively. One starts with a condensate consisting of N<sub>c</sub>(0) 4000 atom s and a scattering length of a (B<sub>i</sub>) = 2500a<sub>0</sub>, where B<sub>i</sub> is the magnetic eld at the initial time. Initially, there is no visible therm all cloud present so the system is approximately at zero temperature. One then ramps the magnetic eld linearly in a time t from its initial value B<sub>i</sub> to the nal value B<sub>f</sub>, chosen such that a (B<sub>f</sub>) = 60a<sub>0</sub>. The ramp time is taken equal to t= 0.5 m s.

To investigate the importance of three-body recombination during the collapse, we have included it in our simulations in addition to the quantum evaporation process. This amounts to including a term

on the right hand side of Eq. (16), from which the contribution to the rate equation for the num ber of atom s can be easily found. A lthough there are several predictions for the norm alcomponent rate constant K<sub>3</sub> [42, 43, 44, 45], its behavior as a function of the magnetic eld is unknown near the Feshbach resonance and precise experimental data is unavailable [46]. Following Saito and U eda [26], we take K<sub>3</sub> = 1.2  $10^{27}$  cm<sup>6</sup>/s. W ith this value these authors have been able to explain some of the results of the experiment on the Type I collapse by D onley et al. [21]. Since the nal value of the magnetic eld is in the same range for both experiments, we expect the three-body recombination rate constant to be of the same order of magnitude.




FIG. 4: (a) Radial and (b) axial width of the condensate as a function of time during a Type II collapse. At the origin of the time axis the scattering length vanishes as it is changed from large and postive to negative. The solid line corresponds to a simulation where both quantum evaporation and three-body recombination are included. The dashed line corresponds to a simulation including only three-body recombination. The experimental points are also shown and taken from Ref. [40].




FIG. 5: Number of atoms in the condensate as a function of time during a Type II collapse. The solid line corresponds to a simulation where both quantum evaporation and three-body recombination are included. The dashed line corresponds to a simulation including only three-body recombination. The experimental points are also shown and taken from Ref. [40].

In Figs. 4 and 5 we present the results of our simulations. The widths of the condensate in the radial and axial direction, i.e., the variational parameters  $q_r$  and  $q_z$ , are shown as a function of time in Fig. 4 (a) and (b), respectively. The number of atoms as a function of time is displayed in Fig. 5. The origin of the time axis is chosen such that the scattering length is equal to zero at t = 0. The solid line corresponds to a simulation that includes both the quantum evaporation process and three-body recombination. The condensate collapses rst in the radial direction in a time =  $(2!_r)$  14 ms and during the last part of this

radial collapse the condensate ejects a large fraction of its atom s, by m eans of the quantum evaporation process. In our simulations, we md that the three-body recombination hardly contributes. A fiter a time  $=(2!_z)$  36 m s the axial width of the condensate reaches its m inimum, resulting again in a slight increase of the ejection rate. Note that these time scales are expected, since the dynam ics is determined by the external trapping potential. M ore remarkably, for a very short time the number of atom s increases with time during the collapse. In principle, this can occur, because the quantum evaporation process is coherent, and can thus describe multim ode R abi oscillations between the condensate and the noncondensed part of the system, as we shall see in much m ore detail in the next section.

The simulation that includes the quantum evaporation process shows quantitative agreement with the experimental results [40], which are also shown in the Figs. 4 and 5. The disagreement for small values of the widths of the condensate is a result of the fact that the experimental resolution for the condensate size is about 4 m [40].

We have also performed a simulation that includes only three-body recombination and

no quantum evaporation. The results for this simulation are shown in Figs. 4 and 5 by the dashed lines. The fact that the minima in the widths of the condensate in Fig. 4 are lower than the results including quantum evaporation, indicates that the condensate density has to be relatively high for recombination of atom s to occur. Once such a high density is reached, the ejection of atom s occurs very fast, resulting in a staircase-like pattern for the number of atom s as a function of time, which is clearly not visible in the experimental data. Att 38 m s the condensate decays so fast, that the radial direction becomes stable again, resulting in a large increase of the radial width.

Finally we make some remarks about the properties of the ejected atom s. In Ref. [29] we have calculated the distribution of the kinetic energy of the ejected atom s, as well as the angular distribution. We have also performed preliminary calculations of the average kinetic energy emitted in the radial and axial directions, and have found that the energy distribution of the ejected atom s is anisotropic. D onley et al. [21] have measured the angular and radial temperatures of the emitted atom s and have indeed found an anisotropic distribution of the energies. However, our calculations are done for the Type II collapse and our approximations are especially suited for this case, whereas these experiments deal with a Type I collapse. Therefore, we do not directly compare our results with the available experimental data of D onley et al. [21]. Moreover, to improve the experimental resolution limit, one expands the gas at the end of each destructive measurement by an increase in the scattering length. Therefore, the resulting mean-eld energy and retherm alization e ects may play an important role in determining the energy of the ejected atom s, which is not included in our calculations of the energy distribution function in Ref. [29].

In conclusion, we have shown in this subsection that the simulations of the Type II collapse that include quantum evaporation show quantitative agreement with the experimental results. The most important feature of these experimental results is the fact that the condensate starts to eject atoms almost immediately after the initiation of the collapse. We have also shown that solely three-body recombination does not account for this rapid onset of the loss of atoms. At this point it is important to notice that this conclusion also holds




FIG. 6: The scattering length as a function of time in the experiments by C laussen et al. [28], and the corresponding magnetic eld (inset). One increases the scattering length in a time  $t_{rise}$  by means of a linear ramp in the magnetic eld, and holds the magnetic eld for a time  $t_{hold}$ , before ramping back. The position of the Feshbach resonance is indicated by the dashed line.

if we num erically solve the generalized G ross-P itaevskii equation, without approximations. The reason for this is that the gaussian ansatz used here is certainly appropriate for the rst part of the collapse, when the dynam ics is not yet very violent. This is borne out by num erical simulations of the G ross-P itaevskii equation, which have also shown that when the highest densities are reached during a Type I collapse, high-density \spikes" can form on the prole of the wave function [23, 24, 25, 26, 27]. These \spikes" are not included in our ansatz for the condensate wave function and therefore our approximations might be less appropriate for the highest densities reached during the collapse. However, our results suggest that such high-density \spikes" may well never occur if one includes the e ects of the quantum evaporation process.

## B. Multimode Rabioscillations

In this experim ent, one observes particle loss from the condensate as a function of the both the rise time and the hold time, accompanied by a \burst" of atoms from the condensate. The temperature of the burst atoms is of the same order as in the case of the experiments on the collapse, i.e., about 150 nK. Most importantly, the amount of atoms lost from the

condensate decreases with increasing t<sub>rise</sub> over some interval, which can never be the case for atom loss characterized by a rate constant, such as three-body recombination. A los note that the time scales of the pulse are very sm all compared to the time scales set by the inverse frequencies of the external trapping potential. This means that the density pro le of the condensate hardly changes its shape during the pulse, since the collective modes which alter the density pro le have frequencies on the same order of magnitude.

## 1. Retarded propagator

The single-pulse experiments start in the noninteracting limit where the density prole of the condensate has the shape of a gaussian, and the pulse in the magnetic eld is so fast that the condensate wave function hardly changes due to the interactions. This makes it convenient to expand the propagator for the ejected atom s in the excited harm onic oscillator eigenstates, since the condensate part is then left out most easily. The fact that the condensate density pro le almost remains the shape of the ground state of the trap makes this problem easier to dealwith theoretically and makes it therefore worthwhile to determ ine the propagator for the ejected atom s as accurate as possible. With the Type II-collapse problem of the previous subsection this objective is much more di cult since then the condensate wave function changes its shape considerably during the collapse. This means that at each time a di erent number of trap states has to be included in the wave function, making the cut-o between condensate and noncondensed atom s strongly time-dependent. Therefore we have applied several approximations in that case. Even though the density pro le of the condensate does not change much, the phase of the condensate wave function does change very fast in the single-pulse case. Therefore we use for the phase of condensate wave function the phase of the gaussian ansatz given in Eq. (25). Since this wave function also describes the low-lying collective modes of the condensate, we have to exclude these from the propagator of the noncondensed atom s.

Denoting the eigenstates of the single-particle ham iltonian again by  $_n$  (x) and the corresponding eigenvalues by  $_n$ , we have for the propagator of the ejected atom s

The prime denotes sum m ation over all the excited trap states not contained in the condensate wave function. The equation of m otion for the expansion coe cients a  $_{n,n^0}$  (t; t<sup>0</sup>) can be found by inserting Eq. (31) into the equation of m otion for the G reen's function given in Eq. (7). However, it is easier to realize that the G reen's function is in Eq. (13) shown to be related to the expectation value of the product of two H eisenberg annihilation and creation operators for the noncondensed atom s. The equation of m otion for the annihilation operator of interest is given by

with the herm itian conjugate expression for the creation operator. We solve this equation by expanding the annihilation operator as




FIG. 7: The fraction of atom s in the condensate as a function of time for a calculation that includes only quantum evaporation. The initial number of condensate atom s is  $N_c(0) = 16500$ . The rise time  $t_{rise} = 12.5$  s and the hold time is  $t_{hold} = 200$  s. The scattering length is equal to  $a = 2000a_0$  during hold.

where the Schrodinger operator  $^{n_0}_m$  annihilates an atom in the harm onic-oscillator state with quantum numberm. We then expand also the functions  $_m$  (x;t) in trap states by means of

which depend on time through the variational parameters in the gaussian ansatz in Eq. (25) and the number of condensate atom s. These matrix elements can be calculated analytically and the result is given in Appendix. B. The advantage of the above approach is that we do not have to solve the equation for the derivative of  $a_{n,n^0}$  (t;t<sup>0</sup>) with respect to t<sup>0</sup> separately.

Putting the results together, we  $% \mathcal{A}$  nd for the coe cients in the expansion of the G reen's function the expression  $% \mathcal{A}$

W ith this G reen's function we have perform ed simulations of the single-pulse experiments by C laussen et al. [28], of which the results are presented in the next section.

#### 2. Results

We perform our calculations for the parameters of the experiment by Claussen et al. [28]. In particular, the frequencies of the external trapping potential are the same as in the




FIG.8: Fraction of atom s in the condensate as a function of the hold time. The rise time is kept xed at the value  $t_{rise} = 12.5$  s. The initial number of condensate atom s is taken N<sub>c</sub>(0) = 6100 (solid line) and N<sub>c</sub>(0) = 16500 (dotted line). The scattering length is equal to a = 2000a<sub>0</sub> during hold. (a) The result of the calculation that includes only quantum evaporation. (b) The calculation that includes both quantum evaporation and three-body recombination. The experimental points are taken from Ref. [28].

previous section. Fig. 7 shows the fraction of atom s in the condensate as a function of time, for a pulse such that  $t_{rise} = 12.5$  s and  $t_{hold} = 200$  s. The magnetic eld during the hold is B = 156.9 G, which corresponds to a scattering length of  $a = 2000a_0$ . The simulation shows s that once the scattering length nearly takes on its largest value and the coupling between the condensate and the excited states is therefore largest, the condensate starts ejecting atom s. Part of these atom s then oscillate back and forth between the condensate and the excited states are dealing with several excited states and thus a multim ode R abi oscillation. At the end of the pulse the rate, i.e., the slope of the curve, becom es equal to zero because the coupling between the scattering length is equal to zero.

To compare our results with the available experimental data we calculate the number of atom s as a function of the hold time  $t_{hold}$  and the rise time  $t_{rise}$ . Fig. 8 (a) shows the result




FIG.9: Fraction of atom s in the condensate as a function of the rise time for a calculation that includes only quantum evaporation. The hold time is kept xed at  $t_{hold} = 1$  s (solid line),  $t_{hold} = 5$  s (dashed line), and  $t_{hold} = 15$  s (dotted line). The scattering length is equal to a = 2000a<sub>0</sub> during hold.

of a calculation of the fraction of condensate atom s as a function of  $t_{hold}$ , with  $t_{rise} = 12.5$  s xed. The calculation is done for two di erent initial numbers of condensate atom s. The solid line displays the result for N<sub>c</sub>(0) = 6100 and the dashed line for N<sub>c</sub>(0) = 16500. Notice that the latter initially has a larger slope because the elective Rabi coupling between the condensate and the excited states is larger in this case. This is because of the fact that it is

proportional to the condensate density.

The results of the sinulation that includes only quantum evaporation, shown in Fig.8 (a), show an oscillation in the fraction of condensate atom s as a function of the hold time. This oscillation is not observed in experiment, because of the fact that three-body recombination plays an important role in this case since it becomes large near the resonance [46]. Therefore, we also want to perform a calculation that includes both quantum evaporation and three-body recombination. However, the magnetic-eld dependence of the rate constant for this process is unknown. Nevertheless, we are able to make progress by realizing that the hold time is generally larger than the rise time for the experimental points shown in Fig.8. Since experimentally three-body recombination of three-body recombination will be most important during hold, where the magnetic eld is closest to the resonance. This suggests that we only need to include it during hold. Note that for this approximation to be valid it is essential that the rise time is shorter that the hold time. If the rise time is larger than the hold time the magnetic eld dependence of the magnetic is of importance, since the magnetic eld is then time eld performance.

Fig. 8 (b) shows the result for a calculation that includes both quantum evaporation and three-body recombination, with a rate constant  $K_3 = 3 10^{23} ext{ cm}^6/\text{s}$  during hold. This value for the norm al-component rate constant agrees with the order of magnitude of the experimental data [46]. This calculation shows good quantitative agreement with experiment for both initial numbers of condensate atom s.

Finally, we have calculated the number of atom s in the condensate as a function of the rise time. The result of this calculation is shown in Fig. 9, for various hold times. The solid

line corresponds to  $t_{hold} = 1$  s. The dashed and dotted line correspond to hold times of 5 s and 15 s, respectively. The scattering length during hold is equal to  $a = 2000a_0$  for this simulation. For all the results in Fig. 9 the rise time of the pulse is larger than the hold time. This means that the magnetic-eld dependence of the three-body recombination rate constant is very important in this case, since the magnetic eld is varying most of the time. Fitting the dependence to the experiments is dicult due to the long times taken by the num erical computations. Therefore we refrain from including three-body recombination in these simulations. Nevertheless, there is agreement with the experimental results regarding several aspects of our results. First, we nd that the number of atoms increases with the rise time over some interval. This was also found in the experiment by Claussen et al. [28]. N ote that this fact can not be explained by any loss process characterized by a rate constant because the amount of atom loss will then always be larger with longer times. Second, the m inim a of the curves in Fig. 9 shift to lower values of  $t_{rise}$  with longer hold times. This was also observed in the experiment by Claussen et al. [28]. These minima also occur on approximately the experimental values of trise. The fact that in the experiment the minima become lower with increasing hold time can be explained by three-body recombination.

In conclusion, we have applied the generalized G ross-P itaevskii equation to the recent single-pulse experiments by C laussen et al. [28]. We have shown that the number of atoms increases with time over some ranges. This can not be understood in terms of conventional loss processes such as three-body recombination or dipolar decay. However, to obtain agreement with the available experimental data we had to include three-body recombination in our simulations. Due to the fact that the magnetic eld dependence of this process is completely unknown we are not able to make a to experiment in all situations.

## C. Atom -m olecule coherence

Recent experimental and theoretical work has shown that atom -m olecule coherence is of importance in the case of a double pulse in the magnetic eld [31, 32, 34]. Therefore, we may expect it to have an important elect in the case of the single-pulse experiments as well. To make the discussion of these experiments more complete, we investigate the role of the molecules by means of a quantum led theory that we derived recently [30]. This theory incorporates the correct molecular binding energy and scattering properties of the atom s at the quantum level by using coupling constants that are dressed by ladder diagram s and by including the molecular self-energy. Introducing H eisenberg operators  $^{\circ}_{a}$  and  $^{\circ}_{m}$  that annihilate an atom and a bare molecule, respectively, the ham iltonian for the atom -molecule system reads

Here,  $g = h 2 a_{bg} B = m$  is the atom -molecule coupling constant and (B) = (B (t) B<sub>0</sub>) denotes the detuning, i.e., the energy di erence between two atoms and the bare molecule. It is determined by the di erence in magnetic moment between the atom s and the bare molecule, which in the case of <sup>85</sup>Rb is equal to  $22_B$  [32].




FIG.10: Fraction of atom s converted in the condensate as a function of the hold time. The rise time is kept xed at the value  $t_{rise} = 12.5$  s. The initial number of condensate atom s is taken  $N_{c}(0) = 6100$  (solid line) and  $N_{c}(0) = 16500$  (dashed line). The scattering length is equal to  $a = 2000a_{0}$  during hold. (a) The result of the calculation that includes only the coupling of the atom ic condensate to the molecular eld. (b) The calculation that includes both atom -m olecule coupling and three-body recombination. The experimental points are taken from Ref. [28].

where the coe cients <u>C (k)</u> are normalized as  ${}^{R} dk j C (k) j^{2} = (2 )^{3} = 1$  Z (B). It contains with an amplitude  ${}^{Q}$  Z (B) the bare molecular state  $j_{m}$ ; barei. Moreover, because of the coupling to the two-atom continuum the molecule acquires a nonzero component in the open channel. The wave function renormalization factor Z (B) is given by [30]

which approaches one for values of the magnetic eld far o resonance, where the dressed molecular state reduces to the bare molecular state, as expected. However, for values of the magnetic eld close to the resonance, it is much smaller than one. In particular, for the case of the single-pulse experiments we always have that Z (B) 1, which implies that the magnetic moment of the dressed molecule is in very good approximation equal to twice the magnetic moment of an atom. For magnetically trapped atoms this implies that the dressed molecule is subject to twice the trapping potential for the atoms. W ith respect to this remark it is important to note that the result of the calculations of K okkelm ans and H olland [32] for the density of the molecular condensate should be multiplied by a factor 1=Z (B) 1 to obtain the density of real dressed molecules, since these authors calculate the expectation value of the bare molecular eld operator  $h_m^{\circ}$  (x;t)i.

To bring out the physics of Eq. (38) more clearly, we introduce the operator  $\int_{m}^{0} = \int_{m}^{q} \frac{1}{2} (B)$  that creates a dressed molecule, i.e., a molecule with an internal state as in Eq. (40). Since we intend to consider the situation where initially all atoms are in the atom is condensate, we are allowed to make a mean-eld approximation for the atom is eld operator and consider only its expectation value. There are however no molecules present at the initial time and this requires a quantum treatment of the molecular eld operators. The resulting equations for the atom is condensate wave function coupled to the dressed molecular eld reads for the experimental conditions of interest

where  $\hat{h_a}i, Z(t) = Z(B(t))$ , and m(t) = m(B(t)). In the derivation of the above coupled equations we have assumed that we are allowed to make an adiabatic approximation for the renormalization factor Z(B) and that we can evaluate it at every time at the magnetic eld B(t). In principle there are retardation extra due to the fact that the dressed molecular state does not change instantaneously. It turns out that these extra can be neglected if




FIG.11: Fraction of atom s in the atom ic condensate for the situation where the atom ic condensate is coupled to the molecular eld. Initially there are N<sub>c</sub>(0) = 16500 atom s and no molecules. The magnetic eld is such that a = 2000a<sub>0</sub> during the hold. (a) Fraction of atom s as a function of the real time for  $t_{rise} = 200$  s (solid line) and  $t_{rise} = 100$  s (dashed line). The hold time is equal to  $t_{hold} = 1$  s for both pulses. (b) Fraction of atom s as a function of the rise time for di erent hold times of  $t_{hold} = 1$  s (solid line),  $t_{hold} = 5$  s (dashed line) and  $t_{hold} = 15$  s (dotted line).

which is fulled for almost the entire duration of most of the pulses in the experiments of C laussen et al. [28]. We come back to this point in the discussion at the end of the paper. In principle, the coupling between the two-atom continuum and the molecule also contains an incoherent part corresponding to the rogue dissociation process considered by M ackie et al. [33]. The rate for this process will be small, how ever, under the condition given in Eq. (43). M oreover, the mean-eld elects of the condensate on the therm all atoms will suppress this process even further. It can, in principle, be included straightforwardly and will take the form of a dissipation term in the equation for the molecular operator.

We solve the equations for the atom ic condensate wave function coupled to the dressed molecular eld by using for the condensate wave function again the gaussian ansatz in Eq. (25), and by expanding the dressed molecular annihilation operator in harmonic oscillator eigenstates, similar to the expansion in Eq. (33). As initial condition we assume that at t = 0 only condensed atom s are present. The results of our calculations are shown in

Figs. 10 and 11.

The calculations presented in Fig 10 are performed for the same experimental conditions as in Fig. 8. This result clearly shows that a large fraction of atom s is coherently converted into molecules as a result of the fast ramp in the magnetic eld and that these oscillate back and forth between the atom ic condensate and the molecular states. Due to the fact that the conversion of the atom s to the molecular states is coherent, the operator  $\hat{m}_{m}^{0}$  (x;t) acquires a nonzero expectation value. Fig 10 (b) shows the results of simulations where also three-body decay is taken into account in the sam emanner as in the previous section. The norm al component rate constant is taken equal to K $_3 = 3$  10<sup>23</sup> cm<sup>6</sup>/s. Interestingly, the initial decay without three-body recombination is already larger than the experim ental data and by adding three-body recombination it is therefore impossible to make a t to the experimental data. This is possibly the result of neglecting the retardation e ects of the renorm alization factor Z (B (t)) and the rogue-dissociation process, since the condition in Eq. (43) is violated for a signi cant fraction of the total duration of the pulse in this case. For the simulations presented in Fig. 11 this condition is violated only for a very sm all fraction of the total duration of the pulse for rise times larger that trise 50 s and is not violated at all for t<sub>rise</sub> 150 s. Note that the e ect of retardation and roque dissociation lead to decoherence, which means that our calculations give an upper bound on the amount ofm olecules that are coherent with the atom s.

Fig. 11 (a) shows the result of two calculations for di erent rise time as a function of the total time. As expected, the number of atoms in the atom is condensate rst oscillates with large frequency since the dressed molecular binding energy is large here. As the magnetic

eld approaches values closer to the resonance, the frequency decreases. From Fig. 11 (a) it is clear that only the largest frequency, which also has the largest am plitude since the gas is then closest to resonance, gives a signi cant contribution to the frequency observed in the number of condensate atom s as a function of the rise time, because the larger frequencies with smaller am plitude average out. However, these oscillations are not observed in the experimental data of Ref. [28]. Introducing three-body recombination to t the theory to experiment is in possible with pulses having relatively long rise times, for the same reasons as in the previous section. Nevertheless, the am plitude of the oscillations are in this case, except for the longest hold time, comparable to that of the simulations where only quantum evaporation is included. This is plies that for a thorough treatment of the single-pulse experiments both atom-molecule coherence and quantum evaporation is in progress.

# ${\tt IV}$ . ${\tt CONCLUSIONS}$

We have put forward a generalized G ross-P itaesvkii equation that includes nonlocal term s which describe the quantum evaporation of the Bose-E instein condensate. We have applied this equation to two experimental situations which make use of a Feshbach resonance to alter the interaction properties of the atom s. First we have considered the case where the condensate undergoes a Type II collapse whose dynamics is mainly determined by the external trapping potential and have found good quantitative agreement with experiment. Second we have considered the recent single-pulse experiments [28]. In general we have also found agreement with experiment in this case, keeping in mind that the magnetic-eld dependence of the three-body recombination rate constant is completely unknown. The latter is the rst serious complication in the theoretical analysis. A part from considering quantum evaporation we have also considered the role of atom -m olecule coherence in the single-pulse experiments, by means of an adiabatic approximation to our elective quantum

eld theory for the description of Feshbach resonances [30]. In rst instance atom -m olecule coherence appears to be an important e ect. However, the second theoretical complication is that the adiabatic approximation in general overestimates the e ect and does not take into account rogue dissociation [33]. Including this process damps out the Rabi oscillations between the atom s and m olecules and leads to the production of energetic atom s that may contribute to the experimentally observed bursts [31]. Due to these two complications, a completely satisfying quantitative description of these experiments is still lacking. It should be mentioned that our calculations take into account the inhom ogeneity of the trapped gas exactly and not in local-density approximation. In addition, we do not make a single-mode approximation either for the atom is condensate or the dressed molecules. In future work we intend to consider quantum evaporation, rogue dissociation, and three-body recombination simultaneously to obtain more insight into these intriguing JILA experiments.

Here,  $q_r$  (t) and  $q_z$  (t) denote the radial and axial width of the condensate, respectively.

#### APPENDIX B:MATRIX ELEMENTS

In this Appendix we calculate the matrix elements  $V_{n,n^{\circ}}(t)$  in Eq. (36). Because of the fact that we are dealing with a trapping potential that is symmetric around the z-axis, the excited states factorize into a radial and an axial part. It is convenient to characterize the radial part of the excited states by the quantum numbers  $(n_r;m)$ , where  $n_r$  counts the number of radial nodes in the wave function and m is the quantum number corresponding to the projection of the angular momentum on the z-axis. The third quantum number  $n_z$  counts the number of nodes in the axial direction. In cylindrical coordinates these states are given by [48]

The overlap integral with two functions of the form as in Eq. (B1) with a gaussian of arbitrary width is, to the best of our know ledge, not tabulated. Nevertheless, we can make analytical progress by realizing that we only have to take into account the states with m = 0, since the interaction conserves parity.
