Point-contact spectroscopy of M gB₂

Point-contact spectroscopy measurements on magnesium diboride reveal the existence of two superconducting energy gaps closing at the same transition temperature in line with the multiband model of superconductivity. The sizes of the two gaps (= 2.8 meV and = 6.5-7 meV) are respectively smaller and larger than the expected weak coupling value of the one-gap superconductor. The smaller gap is rapidly led by a small magnetic eld of about 1-2 Tesla much lower than the real upper critical eld H $_{c2}$. The larger gap is closed at the anisotropic H $_{c2}$. Above the gap energies reproducible non-linearities are observed at the characteristic phonon energies of M gB₂.

I. IN TRODUCTION

Point-contact spectroscopy o ers the possibility to study very findam ental superconducting properties. Namely, the superconducting energy gap can be addressed via the Andreev re ection and the electronphonon (boson) interaction can be inferred as well. From the very beginning since the discovery of M gB₂ [1] this technique has been applied for the investigation of this com pound. Here, we shortly review the state of art which unequivocally supports the fact that M gB₂ represents an extraordinary example of multigap superconductivity which phenom enon attains interest since the files [2,3].

The electronic structure calculations have predicted [4] that several electronic bands cross the Ferm i level in M gB₂ with two di erent superconducting gaps at di erent sheets. These predictions have been experim entally evidenced by di erent techniques like speci c heat m easurements [5], tunneling [6{8], Raman spectroscopy [9], and so on. Am ong these investigation m ethods also spectroscopy based on the Andreev re ection process gave one of the proofs of such multi-gap superconductivity [10]. For the larger gap attributed to the two-dimensional -band parallel to the c-axis originating from the boron $p_{x v}$ orbitals, the reduced gap value 2 = $k_B T_c '$ 4 has been found. The smaller gap on the 3D -band of the boron p_z -orbitals has the reduced value much below the BCS weak coupling lim it of a one-band superconductor (2 = $k_B T_c$ ' 1:7). The behavior of the both gaps in magnetic eld has been studied in detail [10{12]. The small gap is led very rapidly by a small eld of about 1-2 Tesla at low tem peratures. The large gap is closed at the real upper critical eld of M gB $_2$ which is an isotropic.

The relatively high value of the superconducting crit-

ical tem perature T_c in M gB₂ is supposed to originate from the strong anham onic coupling of the -band to the E_{2g} phonons [4]. The recent de Haas-van Alphen experim ents [13] give indications for such an anisotropic electron-phonon interaction, but there is no direct spectroscopic evidence for the overall shape of the E liashberg function of the electron-phonon interaction. The very rst point-contact spectroscopy studies of the electron-phonon interaction which are available [14{17] indicate reproducible non-linearities of the current-voltage characteristics at the M gB₂ characteristic phonon energies. Further experiments and theoretical studies are necessary to elucidate details of the phononic interaction mechanism.

II. SUPERCONDUCTING ENERGY GAPS

Below T_c a phase coherent state of Cooper pairs is form ed in a superconductor. Transport of charge carriers across a norm al-m etal/superconductor (N/S) interface involves the unique process of Andreev re ection. If the N/S interface consists of a ballistic point contact with the mean free path 1 bigger than the diam eter of the contact orice, the excitation energy eV of charge carriers is controlled by the applied voltage V . For a quasiparticle incident on the N/S interface with an excitation energy eV < , a direct transfer of the charge carriers is forbidden because of the existence of the energy gap in the quasiparticle spectrum of the superconductor. For this case, the charge transfer of an injected charge carrier takes place via the retrore ection of a hole back into the norm almetal with the form ation of a Cooper pair in the superconductor. At excitation energies above the

gap quasiparticles can be transferred directly across the interface. The Andreev re ection process leads to a two times higher conductance of a N/S contact at V < =e (zero-tem perature lim it) for the case of ballistic transport with transm ission probability of the charge carriers T = 1. The opposite lim it of ballistic transport is given by the tunneling process for an insulating barrier at the interface where T << 1. For G iaevertunneling between a superconductor and a norm alm etal, it is wellknown that the conductance goes to zero for eV <(again in the zero-tem perature lim it). In contrast to the point-contact tunneling where the well-developed gap structures could also be due to other e ects, like sm all particle charging [18], the Andreev re ection directly probes the coherent superconducting state. The more general case for arbitrary transmission T has been treated by Blonder, T inkham and K lapw ik (BTK) [19]. The voltage dependence of the conductance of a N /S contact gives direct spectroscopic information on the superconducting order param eter . The conductance data can be compared with the BTK theory using as input parameters the energy gap , the parameter Z (measure for the strength of the interface barrier with transmission coe cient T = $1 = (1 + Z^2)$ in the norm al state), and a parameter for the quasiparticle lifetim e broadening [20]. The evolution of the dI=dV vs. V curves for di erent interfaces characterized with the barrier strength Z is schem atically presented in Fig. 1a.

The rst point-contact measurements on sintered M gB₂ pellets were performed by Schmidt et al. [21]. They showed that by the Au tip it was possible to change from the G iaever tunneling regime to the pure Andreev relation. In both cases the s-wave gap was observed with a value of 4.3 meV. The smallness of this value compared to the expected value for a 39-K BCS superconductor was ascribed to a chemically modil ed surface layer with lower T_c , but the particular T_c of the point contact was not determined.

K ohen and D eutscher [22] found the energy gap in the polycrystalline M gB₂ scattered between 3 and 4 m eV. The point contacts were done by m eans of the Au tip. The tem perature dependence of the 3 m eV energy gap followed the BCS form with T_c about 29 K. But even for this transition tem perature, reduced in comparison with the bulk m aterial, the resulting 2 =k $_{\rm B}$ T_c ' 2.4 is much too sm all for a weak coupling BCS superconductor. The Ferm ivelocity 4:7 10⁷ cm /s was calculated from the Z parameter with an assumption that the lowest Z originated just from the Ferm ivelocity m ism atch between Au and M gB₂. The obtained value was in agreement with the band structure calculations [23].

M easurem ents by P lecenik et al. [24] on M gB_2/Ag and M gB_2/In junctions perform ed on M gB_2 wires indicated the same problem with a small size of the energy gap. The temperature dependence of the 4 m eV energy gap showed a signi cant deviation from the BCS form which

has been ascribed to an interference of two gaps with two di erent T_c 's in line with the published multigap scenario [4]. In their model Liu et al. [4] suggested that the two gaps are sensitive to in purity scattering. In contrast to Anderson's theorem for a one-gap superconductor, non-magnetic interband scattering can decrease T_c in this case of multi-gap superconductivity. Moreover, in the lim it of strong scattering both gaps will be averaged into one single BCS gap ((0)' 4 m eV) which will close at T_c ' 27 K.P lecenik et al. suggested that their point contacts represent a parallel connection of two junctions: one probing the smallgap in the clean region and another the averaged BCS gap in the dirty part with a reduced T_c .

Laube et al. [25] and G onnelli et al. [26] have also proposed explanations for the observed sm all gaps in their data in terms of multigap superconductivity.

Indications for the two-gap superconductivity have been found in the point-contact measurements of S. Lee et al. [27] and Liet al. [28]. The latter group claim the second large gap being around 10 meV which is much higher than the other experimental observations and the theoretical predictions.

In our work [10] we have shown the presence of two superconducting energy gaps in M gB₂ closing at the same bulk T_c. The point-contact measurements have been performed on polycrystalline M gB₂ samples with critical temperature T_c = 39:3 K and width T_c = 0:6 K of the superconducting transition. The pressure-type contacts could be adjusted in-situ by pressing a copper tip on the freshly polished surface of the M gB₂ superconductor using a di erential screw mechanism. The crystallites of the M gB₂ samples were larger than a few micron. For a typical size of the metallic constriction below 10 nm, the point-contact probes therefore presumably a single crystallite but of unknown orientation.

In gure 2 we show typical examples of the di erential conductance dI=dV versus voltage spectra for Cu-M gB₂ point contacts in the superconducting state at 4.2 K. The three upper curves reveal a clear two-gap structure corresponding to the maxim a placed symmetrically around zero bias. However, 90% of the contacts reveal a spectrum dominantly showing the small-gap structure with only a sm all shoulder-like contribution around the largegap voltage. These variations from contact to contact are ascribed to current injection along di erent crystal directions of locally probed crystallites. The conductance curves of gure 2 have been tted to the BTK theory using the sum of two contributions, + (1) with a weight factor between the small- and largegap contributions, and respectively. Details of the thing to the sum of two BTK conductances are shown in Fig. 1b. The weight factor varied from 0.65 to 0.95 for the di erent contacts. The resulting energy gaps are = 2:8 0:1 meV for the small gap and = 6:8 0:3 m eV for the large gap.

Point-contact data with a very low peak (s) height to background ratio (PHBR) have been reported in som e of the above m entioned papers. In the case of the (prevailing) one-gap spectrum the low PHBR (e.g. in com parison with those in Fig. 1a) is caused by the large sm earing parameter . But even a structureless, parallel leakage current to the norm alregions on the surface of M gB2 can occur as mentioned in [24]. In the case of an important contribution of the both conductances to the spectrum (we have found = 0.65) with generally two di erent broadenings and Z parameters, PHBR is more com plicated but for a low ! 0 it never went below 1.4 in our measurements. The spectra shown in Fig. 2 reveals also the lowered PHBR in comparison with those the Fig. 1b and Fig. 3. Again, it is caused by the increased broadening parameter. For example = 0:13and = 0:07 is found for the top curve and = 0.22in the case of the bottom curve.

In the calculations of two-band superconductivity in $M gB_2$ [4], the small gap is situated on the isotropic band and the large gap on the two-dimensional band (cylindrically shaped parallel to the c-axis). The Ferm isurface topology of the two bands would explain the observed di erences in the spectra for di erent contact orientations. The small gap, being isotropic, will be observed for all directions of current injection. However, the two-dimensional cylindrical Ferm i surface will give most contribution to the interface current for current injection parallel to the ab-plane. The observation of two-gap structures in a m inority of the investigated contacts m ight mean that the crystallites in the polycrystalline samples are mostly textured with the ab-planes at the surface. Thus, the spectra in Fig. 2 represent an evolution from the c-axis tunneling to the -band (bottom curve) to the bigger ab-plane contributions (higher curves) revealing the both - and -gaps.

The smaller gap could apriori be caused by di erent reasons, including a surface layer of reduced superconductivity or surface proximity e ects. However, most of the scenarios would still require a scaling of the gap with the critical tem perature. That is why it was im portant to show an existence of the small gap at high tem peratures in order to establish its origin in the two-band superconductivity. The tem perature dependencies of the point-contact spectra have been examined on di erent sam ples. Due to therm alsm earing, the two well resolved peaks in the spectrum merge together as the tem perature increases. Consequently, the presence of two gaps is not so evident in the raw data (see Fig. 3a). For instance at 25 K the spectrum is reduced to one sm eared maximum around zero bias. Such a spectrum itself could be tted by the BTK formula with only one gap, but the transparency coe cient Z would have to change significantly in comparison with the lower temperatures and moreover a large sm earing factor would have to be in-

troduced. However our data could be well tted at all

tem peratures by the sum of two BTK contributions with the transparency coe cient Z and the weight factor kept constant and without any parallel leakage conductance. The point-contact conductances of one spectrum at di erent tem peratures are shown in Fig. 3a together with the corresponding BTK ts. The resulting energy together with those obtained for two gaps and other point contacts with di erent weight values are shown in Fig. 3b. In a classical BCS theory, an energy qap with = 2.8 m eV could not exist for a system with T_c above 2 =3.5k _B 19 K, but as shown in Ref. [29] even a one-gap spectrum (shown as the bottom curve in Fig. 2) leads to the sam e tem perature dependence (T) with the bulk $T_{\rm c}$ as those indicated in Fig. 3b.

Since it is evident that both gaps are closing near the sam e bulk transition tem perature, our data give experim ental support for the two-gap m odel. W e obtained a very weakly coupled gap with 2 $=k_B T_c ' 1.7$ and a strongly coupled gap with 2 $=k_B T_c ' 4$ in very good agreem ent with the predictions of Brinkm an et al. [30] (a 3D gap ratio 2 = $k_B T_c$ ' 1.61 and a 2D gap ratio 2 = $k_B T_c$ ' 4.22). The tem perature dependencies are in a good agreem ent with the prediction of the BCS theory. Sm all deviations from this theory have been predicted by Liu et al. but these deviations are within our error bars for the large gap while in the case of the sm all gap there is a tendency for more rapid closing at higher tem peratures near to T_c (see Fig. 3b) as expected theoretically.

Later point-contact measurements conmed the twogap scenario in MgB₂. Bugoslavsky et al. [31] have demonstrated in their point contacts made on MgB₂ coriented thin lms that the two distinct gaps can be evidenced already in the raw data at low temperatures ($_1 = 2.3 \text{ meV}$ and $_2 = 6.5 \text{ meV}$) and they both close at the same bulk T_c. The observed di erences in relative weight of the two gaps have also been ascribed to di erences in crystallographic orientation under the Au tip and in barrier strength of their junctions. Bobrov et al. [14] and Naidyuk et al. [32] have presented the Andreev re ection spectra on the Ag/M gB₂ c-axis oriented lm point contacts at 4.2 K. Their histogram of the gap distribution reveals distinct maxim a at 2.4 and 7 m eV.

Very recently G onnelli et al. [33] have presented the point-contact spectroscopy on the M gB₂ single crystals. Their directional measurements have shown that the point-contact current parallel to the M gB₂ ab-plane probes both the and bands revealing the two gaps (=7:1 meV and =2:9 meV) while the point-contact current in jected along the c-axis reveals only one gap on the -band. They also con rm ed that the tem - perature dependence of the small gap reveals a stronger suppression near T_c while the large gap closes in line with the BCS tem perature dependence.

Figure 4 dem onstrates that the application of a magnetic eld has been important to show the co-presence of both sm all and large energy gap at high tem peratures m uch above the tem perature $T = 2 = 3.52 k_B$ ' 19 K corresponding the BCS weak coupling limit. Indeed, the two distinct gaps clearly visible in the Andreev rejection spectrum at low tem peratures get completely merged together due to them all sm earing at tem peratures above 20 K. How ever, because the sm all gap is very sensitive to the applied eld, the large-gap spectrum becomes better resolved in a eld of a few tenths of Tesla even at tem peratures above 30 K. The suppression of the sm all gap structure enhances the large-gap structure which is only suppressed at larger elds. This di erence in the eld sensitivity of both gaps published for the rst time in our previous paper [10] opened the question about di erent magnetic eld scales in the separate and bands.

III. UPPER CRITICAL MAGNETIC FIELDS

Fig. 5 shows the behavior of the junction with the prevailing one-gap spectrum (weight factor of 0.95 of the -band contribution) as a function of magnetic eld at 42, 15 and 25 K. The e ect of the applied magnetic eld is very unexpected. The small magnetic elds below 2 T rst shift the peak position to higher voltages. In the usual case of a one-gap superconductor the application of magnetic eld can only lead to a shrinkage of the distance between the gap-like peaks in the pointcontact/tunneling spectrum [34]. This is a simple consequence of the fact that the magnetic pair-breaking for increasing applied eld lls up forbidden states inside the gap. O by iously, the e ect dem onstrated in Fig. 5 is due to an interplay of the two gaps which are inevitably always present together in any spectrum with arbitrary weight factor . As calculated by Brinkm an et al. [30] even for strictly c-axis tunneling there is one percent tunneling probability into the -band. However, unlike the case of tunneling spectroscopy with a very dom inant contribution for perpendicular-to-the-barrier transport, we have to note that the ballistic transport in m etallic contacts in jects electrons through the contact with a much larger cos- angular spreading. Thus, if in som e cases only a peak due to the smaller gap is apparent, its width is hiding a contribution of the second gap. Then, in a magnetic eld, the small gap in the -band is rapidly suppressed and the large gap will de nitely em erge. This superposition of the rapidly suppressing peak of the sm all gap and the emerging of the large one with a very small weight factor causes the observed shift of the peak towards higher voltages. At even higher elds the magnetic pair-breaking in the -band leads to conventional shrinkage of the broadened gap peaks of the large gap. Such a smooth shift without any major change in peak position during transition from prevailing observation of the small gap to the large one is a consequence of an im portant broadening already at zero m agnetic eld. W ith

m agnetic eld the broadening substantially increases and the two "peaks" m erge to the one. F ig. 4 dem onstrates the e ect of the eld on the spectrum w ith a sm allbroadening at zero eld. At 42 K the two peaks or shoulders from the large and sm allgaps are well separated and they just shrink their voltage position w ith a eld. At 20 K the tem perature sm earing causes that the two peaks m erge to one already at zero eld. Then, again the applied eld suppresses the sm all gap contribution, the peak position rst shifts to higher voltages and at a certain eld it starts to shrink.

Being aware of possible uncertainty we can de ne the magnetic eld where the shift of the peak towards higher voltages turns back to lower voltages as the "upper critical eld" H $_{c2}$ of the -band without any interband scattering. At 4.2 K this eld is at about 1.7 Tesla, at 15 K at about 1.4 T, at 25 K at about 0.7 T. The full tem - perature dependence of this pair-breaking eld of the

-band H $_{\rm c2}$ determined in the same way at more tem – peratures is displayed in Fig. 6. The obtained temperature dependence reveals a qualitative agreement with the W ertham er, Helfand and Hohenberg prediction for one-band type-II superconductor [35].

D ue to the interband scattering, the superconductivity would be present in the -band also above H $_{\rm c2}$ as induced from the -band until the same T_c and the bulk H $_{\rm c2}$. In this sense H $_{\rm c2}$ would only be a certain crossover eld where the small superconducting energy gap gets lled. In our data in the Fig. 5 it is indeed demonstrated that the superconductivity persists well above H $_{\rm c2}$ and is still observable at 3-4 T m ainly due to the large energy gap

on the -band.

The e ect reveals di erently in di erent experiments. Bouquet et al. [11] have shown in their low temperature speci c heat experiments on MgB₂ single crystals that up to 0.5 Tesla the electronic contribution term grows extremely rapidly and isotropically with magnetic eld. The e ect has been attributed to the lling of the small gap on the -band. Then, at higher elds an isotropic increase of was observed crossing the normal state values at H_{c2jjc} 3 T and H_{c2jjab} 18 22 T.By scanning tunneling spectroscopy E skildsen et al. [12] have observed a very large vortex core = 50 nm for the magnetic eld H jc corresponding to H_{c2} = 0.13 T while the real H_{c2jjc} was again about 3 T.

In recent transport, ac-susceptibility and speci c heat m easurem ents on the M gB₂ single crystals [36], we have show n the tem perature dependence of the upper critical eld for both principal orientations with H $_{c2jpc}$ (0 K) ' 3.5 T and H $_{c2jpb}$ (0 K) ' 17 T. In the point-contact m easurem ents show n in Fig. 5 the superconducting feature is getting com pletely suppressed (i.e. the -band large gap is suppressed) above 5 T indicating that this particular orientation of the m agnetic eld with respect to the crystallite under the tip was in between the c-axis and the ab-planes of M gB₂.

In Fig. 7 a behavior of the Cu-M gB₂ junction with two superconducting energy gaps as a function of the magnetic eld is shown. Data are presented for two different contacts (one data set for elds below 3 T and the other for higher elds up to 20 T) with comparable zero-eld spectra. The weight parameter was equal to 0.68 what is in a perfect agreement with the calculations of B rinkm an et al. [30] for the in portant M gB₂ ab-plane current component. The small gap is again suppressed at small elds around 1-2 Tesla but the large gap persists close to H _{c2 jjab}. We conclude that while the smaller gap is rapidly closed by a small magnetic eld, the large gap is closed at the anisotropic H _{c2}.

Similar conclusions on a rapid lling of the small energy gap in a eld of about 1 Tesla and an anisotropic lling of atmuch higher elds near the real H $_{c2}$ have been con med by the later study of G onnelliet al. [33].

IV.ELECTRON-PHONON INTERACTION

Ballistic contacts between normal metals have been successfully used for a direct measurement of the electron-phonon interaction [38,39]. For the situation of a long m ean-free-path com pared to the contact size, the electrons passing the m etallic contact are accelerated with a well de ned excess energy eV given by the applied voltage over the contact. A fier an inelastic scattering process (for instance the spontaneous em ission of phonons) the injected electrons can ow back through the contact. These inelastic scattering processes lead to corrections to the current which depend on the applied voltage because of the energy-dependent scattering rate of the electrons. Finally, the measured second derivative $d^2V = dI^2$ is directly proportional to the electron-phonon interaction function ²F. The Eliashberg function ²F is the convoluted product of the phonon density of states F and the matrix element for the electron-phonon interaction. This method has been extensively employed for the investigation of the electron-phonon interaction in norm alm etals. However, for superconductors the same m ethod can be used by applying a magnetic eld to drive the metal into the norm al state.

Point-contact studies of the non-linear current-voltage characteristics in the superconducting state have also revealed features of the electron-phonon interaction in the $d^2V=dI^2$ curves (see for a review [40]). These structures are explained in terms of either the inelastic quasiparticle scattering near the point contact or the energydependence of the energy gap. The form er m echanism is sim ilar to the point-contact spectroscopy in the norm alm etals: the quasiparticles generate phonons and are back scattered to the free quasiparticle states, now those available in the superconducting state. The latter m echanism is of in portance for strong coupling superconductors. The elastic current channel in the point contact com prises the excess current due to the Andreev re ection and depends on the superconducting energy gap, analogously to the Rowell-M cM illan spectroscopy of the electron-phonon interaction in tunneling experiments. If the spectrum is just due to the second mechanism it can not be observed above the superconducting phase transition.

A few studies have been devoted on an experimental study of the electron-phonon interaction in M gB₂ using point contacts [14{17]. The measurements of [15] have been done on Nb-MgB2 (compacted powder) junctions at 4.2 K. The observed nonlinearities in the $d^2V = dI^2$ (V) characteristics have been interpreted in the fram e work of the Rowell-M dM illan spectroscopy of the electronphonon interaction in tunneling experiments accounting for the proxim ity e ect. The calculated E liashberg function reveals three peaks located at 37, 62 and 90-92 m eV. The energy position is in agreem ent with the characteristic phonon energies of M qB_2 as detected by neutron experim ents [41,42]. The peak intensity at 62 m eV does not show a prevailing am plitude. The calculations of Liu et al. [4] predict a strong anharm onic electron-phonon coupling between the in-plane boron mode E_{2q} near 60 meV and the $p_{x,y}$ orbitals form ing the 2D Ferm i sheets, but to resolve this the k-space sensitive experiments on single crystals are necessary.

Figure 8 shows the $d^2V = dI^2$ spectra of the point contact with signi cant two gap features. Now the spectra are shown in a voltage (energy) scale up to 120 m V. They were measured below and above the superconducting transition T_c (H) [43]. The top panel shows $d^2V = dI^2$ curves measured in a xed magnetic eld of 9 Tesla at di erent tem peratures. The bottom panel displays eld dependencies of $d^2V = dI^2$ curves at a xed tem perature of T = 30 K. The dotted lines in both panels represent the spectra in the norm alstate. At the top curves in the both panels, the observed structure below 10 m eV is related to the superconducting energy gap. The $d^2V = dI^2$ spectra in the norm al state show structures centered around 38, 62,80, and 92 m V. Sim ilar point-contact data have been reported by Bobrov et al. on c-axis oriented M gB₂ thin In s [14]. These voltage positions can be well compared with the observed peaks in the phonon density of states obtained from inelastic neutron scattering experiments (acoustic phonon peak at 36 m eV, optic bands at 54, 78, 89 and 97 m eV [41]). In the point-contact data the E_{2q} mode is more situated around 60 meV instead of around 54 m eV from the neutron data. B oth experim ental techniques show a broadening of up to 10 meV in phonon data which can be partly ascribed to the dispersion of the optic phonon branches.

The calculations of Liu et al. [4] beside a strong anharm onic electron-phonon coupling between the E_{2g} m ode and the 2D Ferm i sheets, foresee a hardening (12 %) of this m ode upon entering into the superconducting state. Choi et al. [44] have predicted the dom inant peak in the E liashberg function ${}^{2}F$ (!) at 63 m eV for the case of harmonic phonons but at 77 m eV for anharmonic phonons. We also do not observe a particularly strong one peak in comparison with others in this energy range in the point-contact spectra. Moreover, there is no signi cant change in position and intensity of the electron-phonon interaction structure upon passing through the superconducting transition [16]. It means that observed structures in our $d^{2}V=dI^{2}$ spectra are not due to the strong coupling e ect but rather due to the inelastic scattering.

Following experimental studies of Yanson et al. [17] show similar energy correlations of their $d^2V=dI^2$ (V) spectra with the phonon density of states [45]. Moreover, it is shown that in the point-contact spectra with a small value of the M gB₂ superconducting energy gap () only a weak structure due to the electron-phonon interaction is observed but the structure grows when is increased to about 3.5 m eV presumably due to the interband scattering.

R am an studies have also not observed any hardening of the E $_{2g}$ m ode below the superconducting transition tem – perature [46]. We note that the spectroscopic measurements of the electron-phonon interaction have been done on polycrystals of unknown contact orientation. Like for the case of the energy-gap structure, the contact orientation will also in uence the measured electron-phononinteraction spectra via the anisotropy. Therefore, single crystal studies are expected to give further conclusive information with respect to the electron-phonon interaction in M gB₂.

V.CONCLUSIONS

In conclusion, we have dem onstrated that the magnesium diboride is a two-gap superconductor. The small gap on the three-dim ensional -band is very weakly coupled with 2 = $k_B T_c$ ' 1.7 and the large gap is strongly coupled with 2 = $k_B T_c$ ' 4. The sm all superconducting energy gap can be suppressed by the magnetic eld of about 1-2 Tesla at low tem peratures. This eld represents the -band upper critical magnetic eld H_{c2} if there was no interband scattering to the -band. Its tem perature dependence presented for the st time in this paper, reveals conventional behavior predicted for a oneband type-II superconductor. The large gap along with the anisotropy of the Ferm i surface are decisive for the real upper critical eld of M gB₂. Superconductivity in $M qB_2$ is mainly supplied by electrons from the -band. P relim inary point-contact experiments on the electronphonon interaction reveal the phonon modes in the measured second derivatives of the current-voltage characteristics but do not show a particular stronger coupling of the in-plane E_{2g} boron m ode. Forthcom ing point-contact experiments on single crystals will be very worthwhile to

resolve the problem of the anisotropic electron-phonon interaction.




FIG.1. a) Numerical simulation of the BTK model at di erent values of the barrier strength Z, representing behavior of the point-contact spectra for = 7 m eV between G iaever tunneling (Z = 10) and clean Andreev re ection (Z = 0) at T = 42 K [10]. b) The Andreev re ection spectrum with two gaps on the Cu-M gB₂ junction together with thing by two BTK conductances (0.3 and 0.7 curves are shifted to unity). The nal thing curve has been generated at Z = 0.5, = 2.8 m eV, = 7 m eV, = 0 with a weight = 0.7 at T = 42 K [29].




FIG.2. b) $Cu - M gB_2$ point-contact spectra at T = 4.2 K (full lines). The upper curves are vertically shifted for the clarity. D otted lines display tting results for the therm ally smeared BTK model with = 2.8 0.1 meV, = 6.8 0.3 meV for di erent barrier transparencies and weight factors [10].




FIG.3. a) Dierential conductances of $Cu - M gB_2$ point-contact measured (full lines) and tted (dotted lines) for the them ally smeared BTK model at indicated temperatures. The tting parameters = 0.71, Z = 0.52 0.02, = 0.02 m eV had the same values at all temperatures. b) Temperature dependencies of both energy gaps ((T) - solid symbols, (T) - open symbols) determined from the tting on three dierent point-contacts are displayed with three corresponding dierent symbols. (T) and (T) points determined from the same contact are plotted with the same (open and solid) symbols. Full lines represent BCS predictions [10].




FIG.4. Experimentally observed in uence of the applied magnetic eld on the two-gap structure of the normalized point-contact spectra at indicated temperatures. These spectra clearly reveal that both gaps exists in zero eld up to T_c as shown by the rapid suppression of the small gap structure (= 2.8 m eV) with magnetic eld which leads to a broad deep minimum at zero bias [10].






FIG.6. Tem perature dependence of the $-band pair-breaking magnetic eld H _{c2}$




FIG.7. Cu-M gB_2 point-contact spectrum showing two gaps with an important ab-plane current contribution in elds approximately parallel to the ab-planes of M gB_2 up to 20 T at 4.2 K [37].




FIG.8. Point-contact spectra $d^2V = dI^2$ (V) of the Cu-M gB₂ junction m easured at di erent tem peratures and m agnetic elds below and above the superconducting transition (dashed lines in the norm al state) [16].
