# Bulk and surface properties in the critical phase of the two-dim ensional X Y m odel

Abstract. Monte Carlo simulations of the two-dimensional XY model are performed in a square geometry with various boundary conditions (BC). Using conform alm appings we deduce the exponent (T) of the order parameter correlation function and its surface analogue  $_{\rm k}$  (T ) as a function of the temperature in the critical (low -tem perature) phase of the model. The tem perature dependence of both exponents is obtained num erically with a good accuracy up to the K osterlitz-T houless transition tem perature. The bulk exponent follows from simulations of correlation functions with periodic boundary conditions or order parameter proles with open boundary conditions and with symmetry breaking surface elds. At very low tem peratures, (T) is found in a pretty good agreem ent with the linear tem peraturedependence of Berezinskii's spin wave approximation. We also show some evidence that there are no noticeable logarithm ic corrections to the behaviour of the order param eter density pro le at the Kosterlitz-Thouless (KT) transition temperature, while these corrections exist for the correlation function. At the KT transition the value  $(T_{K,T}) = 1=4$  is accurately recovered. The exponent associated to the surface correlations is sim ilarly obtained after a slight modi cation of the boundary conditions: the correlation function is computed with free BC, and the pro le with m ixed xed-free BC. It exhibits a m onotonous behaviour with tem perature, starting linearly according to the spin wave approximation and increasing up to a value  $_{\rm k}$  (T<sub>KT</sub>) ' 1=2 at the Kosterlitz-Thouless transition temperature. The thermal exponent "(T) is also computed and we give some evidence that it keeps a constant value in agreem ent with the marginality condition of the tem perature eld below the KT transition.

## 1. Introduction

The two-dimensional classical XY model has a rich variety of applications in condensed matter physics [1]. It describes of course magnetic lm s with planar anisotropy y, but also thin-lm super uids or superconductors, or two-dimensional solids. In statistical physics, this model was also extensively studied for fundamental reasons, as describing for example classical C oulom b gas or uctuating surfaces and the roughness transition. A lthough no exact solution exists for this model, many of its essential properties are known from dierent approaches.

The model undergoes a standard tem perature-driven param agnetic to ferrom agnetic phase transition in d > 2, characterised e.g. by a power-law divergence of the correlation length near criticality,

(see e.g. Ref. [2]). In two dimensions, it exhibits a rather dimension behaviour, since long-range order of spins with continuous symmetries (if there is no source of anisotropy in spin space) is forbidden according to the M emmin-W agner theorem [3, 4]. Indeed there is no spontaneous magnetisation at nite temperature in two-dimensional systems having a continuous symmetry group, for example X Y or O (2) spin models, since order would otherwise be destroyed by spin wave excitations [5]. On the other hand, there is an in nite susceptibility at low temperatures, indicating another type of transition [6]. Such systems can indeed display a low-temperature phase with quasilong-range order and a defect-m ediated transition towards a usual param agnetic phase at high temperatures. This transition is governed by unbinding of topological defects.

We now specify the case of the 2d X Y -m odel: consider a square lattice with twocomponents spin variables  $w = (\cos w; \sin w), j w f = 1$ , located at the sites w of a lattice of linear extent L, and interacting through the usual nearest-neighbour ferrom agnetic interaction

where  $K = J=k_B T$ , with J the ferrom agnetic coupling strength and = 1;2 labels the directions in (^ is the corresponding unit vector). The angle w measures the deviation of w from an arbitrarty reference direction.

The low-tem perature regime, governed by spin-wave excitations, was investigated by Berezinskii [5] in the harmonic approximation. In the low-temperature limit (also called spin-wave phase), localised non-linear excitations (called vortices) are indeed bounded in pairs of zero vorticity, and thus do not a ect crucially the spinwave description. At a rst approximation the e ect of vortices can be completely neglected and the spin wave approximation, after expanding the cosine, reproduces the main features of the low-temperature physics. This harmonic approximation is justi ed, provided that the spin disorientation remains small, i.e. at su ciently low

W ithin this approximation, the quadratic energy corresponds to a Gaussian equilibrium distribution and the two-point correlation function at inverse tem perature becom es [7, 8, 9, 10]

When the temperature increases, the bounded vortices appear in increasing number. Their in uence becomes more prominent, producing a deviation from the linear spin-wave contribution in equation (6), but the order parameter correlation function still decays algebraically with an exponent (T) which depends on the temperature. The transition eventually takes place at a temperature  $T_{KT}$  (usually called B erezinskii-K osterlitz-T houless critical temperature) when the pairs dissociate, thereby destroying short-range order in the system. The mechanism of unbinding of vortices was studied by K osterlitz and Thouless [11, 12, 13] using approximate renormalization group methods. Above  $T_{KT}$  (in the vortex phase), the correlation function recovers a usual exponential decay. This very peculiar topological transition is characterised by essential singularities when approaching the critical point from the high temperature phase,  $t = T = T_{KT} + 0^+$ ,

The existence of a scale-invariant power-law decay of the correlation function implies that at each value of the temperature there corresponds a xed point, or equivalently that there is a continuous line of xed points at low temperatures. The temperature is thus a marginal eld in the spin-wave phase which becomes relevant in the vortex phase.

Not much is known in the intermediate regime between the spin wave approximation at low temperature and the Kosterlitz-Thouless results at the topological transition and in fact the precise determ ination of the critical behaviour of the two-dimensional XY model in the critical phase remains a challenging problem. Most of the studies were dedicated to the determination of critical properties at  $T_{KT}$  z. Many results were obtained using Monte Carlo simulations (see e.g.

z W hen approaching the transition from above, the value of  $T_{KT}$  is often obtained by xing = 1=2 in equation (7), and ( $T_{KT}$ ) then follows from a t of the susceptibility to equation (8).

Refs. [18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29]) at  $T_{KT}$  and slightly above, or high-tem perature series expansions [30, 31], but the analysis was made di cult by the existence of logarithm ic corrections, e.g.

at  $T_{KT}$  exactly [15, 32, 33], with a probable value of  $=\frac{1}{16}$  [34]. Due to these bigarithm ic corrections which make the ts quite di cult to achieve safely, the values of  $T_{KT}$  and  $(T_{KT})$  were a bit controversial as shown in table 1 of reference [29]. The resort to large-scale simulations was then needed in order to con m this picture [28]. A lithough essentially dedicated to the KT point, some of these papers also report the value of (T) computed from the correlation function decay at several temperatures in the critical phase [18, 21, 22, 23], while a system atic study of the helicity modulus at low temperature previously led more directly to the same information [35].

Recently, we proposed a rather di erent approach [36, 37] which only requires a moderate computation e ort. A ssuming that the low-temperature phase exhibits all the characteristics of a critical phase with conformal invariance [38] (invariance under rotation, translation and scale transformations, short-range interactions, isotropic scaling), we use the covariance law of n point correlation functions under the mapping of a two-dimensional system con ned inside a square onto the in nite or half-in nite plane. The scaling dimensions are then obtained through a simple power-law twhere the shape e ects are encoded in the conform alm apping, via the de nition of a rescaled distance variable adapted to the description of the con ned geometry.

This technique is well known since the appearance of conformal invariance. Conformal mappings have been extensively used, mainly in the case of Ising or Potts models, in order to investigate the critical properties in restricted geometries. Density pro les or correlations have been investigated in various con ned systems (surfaces [39, 40], comers [41, 42], strips [43, 44, 45, 46], squares [47, 48] or parabolic shapes [49, 50, 51] for a review, see [52]). The exact expression of the two-point correlation functions have also been calculated on the torus for the pure Ising case [53], and large scale M onte C arlo simulations of the 2d Ising model have been shown to reproduce the correct behaviour, including corrections due to the nite size of the lattice [54, 55].

In this paper, we report a system atic application of conform alm appings to the investigation of critical properties of the 2d X Y model in the spin-wave phase. The physical quantities are obtained using M onte C arbo simulations in square shaped conned systems. We may then determ ine accurately the correlation function exponent (T) in the low-temperature phase T  $T_{KT}$  [36] but also, by choosing convenient boundary conditions (BC), the surface critical exponent which describes the decay of the correlation function parallel to a free surface,  $_k$  (T) [37]. The therm alexponent "will also be considered. Section 2 presents the expected functional expressions of correlation functions and density profiles with various BC, and use of these expressions is system atically reported in section 3. It is not noticing already that the results following the analysis of the two-point correlation functions are not fully convincing, but the main conclusions are then supported by the most re-

investigations of the density pro les. A discussion of the results is given in the last section.

2. Functional expressions of correlation functions and density pro les in a square-shaped critical system

# 2.1. Prelim inary and notations

In the follow ing, we shall specify two di erent types of geom etries, depending on our purpose. They are related through a conform altransform ation. The critical properties in the rst system will be reached through the study of the con ned system in the second one.

i) The in nite plane

This is the system which is eventually interesting in the therm odynam ic lim it. It is of course not directly accessible from num erical techniques. In the second case, the existence of a free surface materialised here by the real axis will allow to de ne both bulk and surface quantities.

ii) The square

This is the natural geometry for M onte Carlo simulations. The boundary conditions may be open at the edges (square) or periodic (torus). In the following, we will obtain numerical results in the square or the torus, and our aim will be to translate them into their half-in nite or in nite system counterpart x.

It is worth referring also to the in nitely long strip of width L, k + il, 1 < k < +1, 0 + 1, 0 + 1. L: this geometry is incidentally mentioned here because the choice of the boundary conditions is more obvious there than in the square system. A lthough no computation will be performed in this geometry, we will refer to it when introducing the proles. It is particularly interesting, since many results concern such strips, e.g. when obtained with transfer matrices [56] or quantum chains [57] which correspond

x Here and in the follow ing, z will constantly refer to a complex coordinate in the plane, while w will refer to the complex coordinate in the square geom etry. In the plane, uhp speci es the upper halfplane. In the square, pbc, fbc, Fbc, and Ffbc m eans that the boundary conditions are respectively periodic, free, xed, or m ixed xed-free according to a description which will be given later. to the Ham iltonian lim it of classical systems con ned in strips. In the transverse direction (1 coordinate), the boundary conditions may be open (strip) or periodic (cylinder). A very accurate num erical study of the O (n) model (including X Y) using the transfer matrix of a related loop gas model was for example reported by B lote and N ienhuis [56]. The periodic strip is obtained from the plane through the standard logarithm ic mapping  $k + il = \frac{L}{2} \ln z$  which in plies an asymptotic exponential decay for the correlation functions along the strip at criticality,

The scaling dimensions are thus determined by the universal correlation length amplitudes,  ${}^{1}=2$  x =L, which are given, in the transfermatrix formalism, by the two leading eigenvalues of the transfermatrix  ${}^{1}=\ln({}_{0}={}_{1})$ . B beta and N ienhuis obtained the most precise values of the thermal and magnetic scaling dimensions at the KT transition,  $x_{*}=\frac{1}{2}$  \*= 2:000 000 (2) and  $x=\frac{1}{2}$  = 0:125 000 (1). In the following, we will exploit expressions similar to equation (14), transposed in the square geometry. We mention here that our approach proceeds from M onte C arb simulations and cannot pretend to an accuracy comparable to the results of B beta and N ienhuis.

#### 2.2. Conform al rescaling of the correlation functions

In an in nite system at criticality, the correlation function is known to behave asymptotically as

This denes the bulk correlation function exponent . The surface critical properties are also interesting and extra universal critical exponents can be measured from simulations performed in nite systems with open boundary conditions. In the sem i-in nite geometry z = x + iy (the free surface being dened by the x axis), the two-point correlation function is xed up to an unknown scaling function. Fixing one point  $z_1$  close to the free surface  $(z_1 = i)$  of the upper half-plane (uhp), and leaving the second point  $z_2$  explore the rest of the geometry, the following behaviour is expected:

of the universal scaling function is constrained by the special conformal transformation [39, 40], and its asymptotic behaviour is implied by scaling e.g. (!)  $!^{x^1}$  when  $y_2$  1, with  $x^1 = \frac{1}{2}_k$  the magnetic surface scaling dimension.

In a square system, the order parameter correlation function  $h_{w_1 w_2}$  is strongly a ected by boundary and shape e ects and thus deviates significantly from the therm odynamic limit expressions (15) and (16). It should obey a scaling form which reproduces the expected power-law behaviours, for example

where the function  $f_{sq}$  encodes shape e ects in a very complicated manner which also depends on the boundary conditions, so that the connection between equations (15) or

(16) and (18) is not obvious. Conform al invariance provides an e-cient technique to avoid these shape e-ects, or at least, enable to include explicitly the shape dependence in the functional expression of the correlators through the conform al covariance transform ation under a mapping w (z):

C onform al invariance holds in isotropic system s with short range interactions which exhibit translation, rotation, as well as scale invariance. U sually these conditions are so restrictive that they can only be valid at the critical point, and we assume here that the general covariance equation (19) holds in the whole  $T < T_{KT}$  phase.

In order to get a functional expression of the correlation function inside the square geom etry w, one simply has to use the convenient m apping w (z):

i) C onform alm apping of the plane onto the torus: in the continuum lim it, the correlation function of the Ising model on the torus is exactly known [53, 40, 58]

. For simplicity, we x in the following one point  $(w_1)$  as the origin, and the second point is simply written w. The dependence on the relative distance w in the above expression,



A sketch of the correlation functions in the plane and in the square geometries is shown in gure 1.

ii) C on form al rescaling of the upper half-plane in side a square: the conform al transform ation of the half-plane  $z = x + iy (0 \quad y < 1)$  inside a square w = u + iv of size L L (L=2 u L=2, 0 v L) with open boundary conditions along the four edges is realized by a Schwarz-Christo eltransform ation [59]



U sing the m apping (25), one obtains the local rescaling factor in equation (19),  $w^{0}(z) = \frac{L}{2K} [(1 \quad z^{2})(1 \quad k^{2}z^{2})]^{1=2}$ , and inside the square, keeping  $w_{1}$  0 (1) xed, the two-point correlation function becomes (see e.g. Ref. [60])

where fbc speci es that the open square has free boundary conditions. This expression is correct up to a constant amplitude determined by  $(w_1)$  which is kept xed, but the function (!) is still varying with the location of the second point, w.

A sketch of the correlation functions in the plane and in the square geometries is shown in gure 2.

## 2.3. Density pro les in restricted geometries

In order to cancel the role of the unknown scaling function in the half-plane geom etry in equation (28), it is more convenient to work with a density prolem (w) in the presence of symmetry breaking surface elds  $h_{\ell}$  on the boundary  $\ell$  of the lattice. This is a one-point correlator which scales in the half-in nite geometry as:

where the function (w) de ned in equation (28) again comes from the mapping and Fbc means that the open square has xed boundary conditions (gure 3).

Equation (29) is a special case of conform ally invariant prodes predicted e.g. by Burkhardt and X ue [44, 45] in strip geometries k + ilor in their half-in nite counterpart z = x + iy:


The scaling function  $F_{ab}(x)$  depends on the universality class and on the boundary conditions denoted by a and b [61]. This notation is reminiscent from the strip geom etry where a and b speci es the two boundaries of the strip at l = 0 and l = L respectively. In the case of xed BC (denoted by Fbc in the square and FF in the strip) corresponding to equation (29) and (30), one gets

k The spins located on the x > 0 halfaxis (l= 0 strip surface) are kept xed while those of the x < 0 halfaxis (l= L strip surface) are free.

This expression was since then mainly used in the strip geometry [62, 63]. In the square geometry, the xed-free BC correspond to keeping the spins xed for u > 0, and the prole is expected to obey the following ansatz [37] (gure 3):

In this paper we will essentially apply equations (24), (28), (30) and (34) in order to determ ine  $and_k$ .

## 3. M onte Carlo sim ulations

## 3.1. Description of the algorithm

Simulations of 2d XY-spins are performed using W ol's cluster M onte Carlo algorithm [64]. The boundary conditions may be periodic, free or xed. When the boundaries are left periodic or free, there is no particular problem, but a relatively precise numerical determination of the order parameter pro le of the 2d XY m odel con ned inside a square with xed boundary conditions (playing the rôle of ordering surface elds  $h_{(0)}$ ) introduces a priori a technical di culty which is

easily circum vented. In practice, the symmetry is broken by keeping the boundary spins located along the four edges of the square xed, e.g.  $_{\rm W}$  = (1;0);8w 2 @ during the M onte C arlo simulation. The W ol algorithm should thus become less e cient, since close to criticality the unique cluster will often reach the boundary and no update would be made in this case. To prevent this, we use the symmetry of the H am iltonian (2) under a global rotation of all the spins. Even when the cluster reaches the xed boundaries @ (w), it is updated, and the order parameter pro le is then measured with respect to the common new direction of the boundary spins, m  $_{\rm Fbc}$  (w) = h  $_{\rm W}$   $_{\rm @ (w)}$  is  $_{\rm Fbc}$ . The new con guration reached would thus correspond – after a global rotation of all the system to re-align the boundary spins in their original (1;0) direction -to a a new con guration of equal total energy and thus the same statistical weight as the one actually produced.

In the literature, m any papers were dedicated to the study of the characteristic properties of the K osterlitz-T houless transition. The value of  $T_{KT}$  will be considered as known with a good accuracy {. We will take here the value reported by G upta and B aillie [23], or C am postrini et al [34],  $k_B T_{KT} = J = 0.893$  (1).

## 3.2. Behaviour of the correlation functions

3.2.1. Scaling of correlations on the torus: Simulations are performed on a square with periodic boundary conditions. Here we choose systems of size L = 100. A fler therm alization ( $10^6$  iterations) and computation ( $10^6$  other iterations), we get the spin orientations f  $_w$  g at all the lattice sites. The correlation function is de ned as

where 0 is an arbitraty reference site (e.g. a corner in gure 1).

It has to be tted to equation (24) with (w) given by equation (23). Expansions of the -functions can be found in the literature, e.g. in A bram ow itz and Stegun [65],



It is instructive to recover the cylinder limit from the torus geometry. We can then plot the correlation function data directly versus the rescaled variable (w) on a log-log scale, as shown in gure 4. On this scale, a linear behaviour would indicate a power-law decay. A deviation from the straight line can be observed at large values of (w) where the data are scattered. The quality of the data is unfortunately not improved by a better statistics (ten times more iterations). This correction is more pronounced as the KT point is approached where one knows that logarithm ic corrections are present. From this gure, it is clearly di cult to get a reliable estimation of the exponents, but we nevertheless perform ed a t in the range

 $(w) < 4.10^{-4}$  where the behaviour is closer to a pure power law . The straight lines reported there correspond to (power-law ts with) slopes (T) as given in table 1 in the conclusion. They match perfectly the correlation function data in the regime of sm all (w), therefore if they do not con m nicely the expression in (24), they at least do not contradict this equation. A stronger support to equation (24) is the fact that the values of the exponents reported in table 1 are consistent with m ore re ned estimates deduced from the t of the order parameter pro le in section 3.3 (the reader can compare columns a and b in table 1 to convince him self of the compatibility of the results).

3.2.2. Scaling of correlations in open square: Simulations are then performed according to a similar procedure, but now in an open square with free BC along the four edges. Equation (28) may be used to estimate the surface exponent  $_{\rm k}$  (T). P lotting the quantity



As we already mentioned above, these are not our most precise determinations of the bulk scaling dimensions, but the deviation with the forthcoming results of the following section being small (see table 1), there is no dram atic consequence to use them.




#### 3.3. Behaviour of the density pro les

3.3.1. Scaling ofm  $_{\rm Fbc}$  (w): Density pro lespresent the advantage of being one-point functions. They are thus supposed to be determ ined more precisely numerically than two-point correlation functions and should therefore lead to more rened estimations of the critical exponents. We start with simulations inside an open square with xed boundary conditions (Fbc), according to the prescriptions given in the description of the algorithm. The order parameter prolem  $_{\rm Fbc}$  (w) is dened according to the nition of a reference orientation on the xed boundaries, i.e.

A fler averaging over the 'production sweeps', one gets a characteristic sm ooth prole as shown in gure 6 which also presents a typical conguration with xed BC.





A log-log plot of  $m_{Fbc}(w)$  with respect to the reduced variable (w) is shown in gure 7 at two di erent tem peratures below  $T_{KT}$ , roughly at  $T_{KT}$ , and one tem perature slightly above. A rst observation is the con rmation of the functional form of equation (30) in the whole low tem perature phase. One indeed observes a very good data collapse of the  $L^2$  points onto a single power-law master curve (a straight line on this scale). The next information is the rough con rmation of the value of the critical tem perature, since above  $T_{KT}$ , the master curve is no longer a straight line, indicating that the corresponding decay in the half-in nite geometry di ers from a power-law as it should in the high-tem perature phase yy. In reference [36], we have shown how

yyOne should nevertheless mention that this does not lead to a precise determ ination of  $T_{K\,T}$ , since at  $k_B T=J = 0.9$  for example, the master curve is hardly distinguishable from a straight line.




Figure 7. M onte Carlo sim ulations of the 2d X Y m odel inside a square 100 100 spins  $(10^6 \text{ M C S/spin}$  after cancellation of  $10^6 \text{ for therm alization}$ , cluster update algorithm). The gure shows the rescaled order parameter density against the rescaled distance on a log-log scale at di erent tem peratures below the K osterlitz-T houless transition tem perature and slightly above.

the computation the  $^2$  per d.o.f. as a function of temperature is an indicator of the location of the KT transition. The  $^2$  has a very small value, revealing the high quality of the t, in the low-temperature phase and then increases significantly above  $T_{\rm KT}$  when the behaviour of the density proble is no longer algebraic.

We have also shown that there is probably no logarithm ic correction at the K osterlitz-Thouless point, since the curve of gure 7 does not seem to dier signi cantly from a true power-law. A libough not a proof, a numerical evidence of that is the plot of  $m_{\rm Fbc}(w)$  [  $(w)^{\frac{1}{2}=8}$  vs (w) which remains constant on the whole range of values of (w) [  $(w)^{\frac{1}{2}=8}$  vs (w) which remains constant on the whole range of values of (w) [ (w) convenient quantity for the determination of the bulk correlation functions exponent, since it displays a pure algebraic decay up to the K osterlitz-T houless transition point y.


Fitting the curves of gure 7 to power-laws leads to the values of the scaling dimension (T) in the whole critical region T  $T_{KT}$  as shown in gure 10 in the conclusion. The data are also reported in table 1 in the conclusion. The accuracy is

much better than in the case of the two-point correlation functions.

3.3.2. Scaling of  $m_{Ffbc}(w)$ : For this last choice of boundary conditions, hereafter referred to as  $\ xed$ -free BC" (and denoted by Ffbc), the open square has half of its boundaries which are left free while the other half is kept xed. This is illustrated in qure 8 where the averaged pro le is also shown at two di erent tem peratures. The

shape of the plotted surface helps understanding the BC.

In the previous section, we reported som e evidence that the logarithm is corrections at the K T point are negligible for the order parameter prolew ith xed BC. Assuming that there will be no substantial di erence for xed-free BC, we perform a t of  $\lim_{F \to C} (w)$  against the two-dimensional linear expression, const  $\frac{1}{2}$  (T)  $\ln$  (w) +  $\frac{1}{2}_{k}$  (T)  $\ln$  (w), as expected from equation (34). The value obtained for the bulk correlation function exponent (T) (already known precisely from previous section) will be a test for the reliability of the t. The simulations are performed at several tem peratures, up to  $k_B T_{KT} = J' 0.893$ . The three parameters linear ts lead to correct determ inations of both exponents (we studied di erent system sizes ranging between L = 48 and L = 100 and even 200 at the KT point). The value of the bulk exponent is in a good agreement with the determ ination which follows from the t of the prole with xed BC, and the surface exponent also ts nicely to the values deduced from the two-point correlation function with free BC.


3.3.3. Scaling of "<sub>Fbc</sub> (w): We concentrated mainly up to now on the magnetic properties. The therm al exponents are also interesting quantities which characterise a critical point. In the case of the X Y model, the temperature is a marginal edd, responsible for the existence of a critical line in the whole low-temperature phase. It thus implies a thermal scaling exponent  $x_{*} = d$  y = 2 which ensures a vanishing RG eigenvalue  $y_{t} = 0$  (up to  $T_{KT}$  where it is consistent with the essential singularity of above the KT point). The energy-energy correlation function should thus decay algebraically as

We check qualitatively this expression of the energy-energy correlations from the behaviour of the energy density prole. The energy density at site w is for example de ned as the average value of the energies of the four links reaching w:

In comparison with the magnetisation prole, a diculty occurs due to the existence of a regular contribution in the energy density. This term cancels after

a suitable di erence between pro les obtained with di erent BC.For that reason, we made two di erent series of simulations with free (fbc) and xed (Fbc) boundary conditions. From the latter simulations we had already extracted the singular behaviour of the magnetisation pro le since there is no regular contribution in the scale-invariant phase,

where  $A_{\,m}\,\,(T\,)$  is a non-universal \critical" amplitude z which depends on the temperature.

On the other hand, the two series of simulations are necessary in order to extract the singularity associated to the energy density which contains a non universal regular contribution  $h''_0$  (T) i which depends on T and a singular contribution:

This is clearly illustrated in gure 9 where convergence towards the same tem peraturedependent constant  $h_0^{"}(T)$  is shown. We also observe that the amplitudes of the singular terms have opposite signs. Therefore a simple difference of the quantities m easured in the square geometry,


The insert in gure 9 shows a log-log plot of the di erence e(w) vs (w) at three tem peratures below  $T_{KT}$ . Due to strong uctuations, the data scatter around straight lines which represent the theoretical slopes  $[(w)]^2$ . This gure, though far from being de nitely conclusive, con m s that the exponent of the decay of energy-energy correlations keeps a constant value  $_{w}(T) = 4$  in the low-tem perature phase of the X Y m odel. At the K T transition, this value was con m ed very accurately by B lote and N ienhuis [56].

## 4. D iscussion

The di erent determ inations of the bulk and surface correlation function scaling dimensions reported in this paper are mutually consistent. These exponents are obtained using completely independent techniques, from four independent series of simulations (the boundary conditions, but also the quantities which are computed are di erent). The ts them selves are di erent, since these quantities obey speci c functional expressions.

The exponents are plotted in gure 10 for di erent system sizes. Our results (for a few values of the tem perature) are also given in table 1. In column a, b, and c we present the bulk exponent. Columns d and e give the surface exponent. The error bars (for the values resulting from the ts of the magnetisation proles, columns b, c, d) correspond to one standard deviation. We have to mention here that these error bars should be considered with some care for at least two reasons. A rst reason is that we did not make any extrapolation to the therm odynamic limit, because the results at a few sizes seem already very stable as it can be observed in gure 10.

A lthough we did not analyse system atically the size e ects, we believe that this is not the most important contribution to the error. A second reason has more drastic consequences. This is the in uence of the tting window. W hen the range of t is varied in a reasonable scale in the large ' regime, it usually produces a sm all deviation in the resulting exponent. If the window range is changed signi cantly on the other hand, we do no longer control the stability of the results, since the errors increase considerably (for = 0.247(92) for 0.50 < (w) < 1). Because of these constraints, we believe exam ple that the values of the exponents that we measure are reliable, but the errors are only rough estim ates.

The weaker result of the paper probably comes from the correlation function with periodic boundary conditions which was tted to an approximate functional expression. There are also in this case logarithm ic corrections and an unavoidable scattering of the data which prevent a t in the interesting asymptotic region. The consequence is a bulk exponent which is a priori obtained with a poor level of con dence, and for this reason we decided to avoid any error bar in column a of table 1. It is am azing to observe that in spite of these restrictions, these results do indeed agree with the most re ned values deduced from the magnetisation density pro lew ith xed boundary conditions (see column b in table 1). A nother consequence of our approach

is again the a priori weak level of con dence of the surface exponent deduced from the correlations in the open system (column e in the table), since we use the bulk values from column a as input parameters for this latter t. The surface exponent in fact ts correctly the most re-ned values deduced from the magnetisation density pro-le with mixed xed-free boundary conditions (column d). O byiously, the stronger results come from the magnetisation pro-les analyses. We believe also that another result of interest is the con-mation that the functional expressions derived in section 2 are valid and are in fact very e cient for the num erical investigation of critical properties of two-dimensional systems. Such applications of conform alm appings are of course well known in the case of strip geometries with e.g. the celebrated correlation length

am plitude-exponent relation [66].

Let us now discuss brie y the results. In the low-tem perature limit, one knows that the spin-wave description captures the essential of the physics of the problem. From this limit, the linear behaviour of the bulk exponent with the tem perature,

(T) =  $k_B T=2 J$ , is easily recovered. It is of course reasonable to expect that the low-tem perature lim it of the surface exponent can also be recovered by the spin wave approximation (see appendix). Indeed, the surface properties of the Gaussian model at the ordinary transition were studied by Cardy [39]. They describe to the low-tem perature regime of the X Y model. The surface-bulk correlation function exhibits an algebraic decay

and the corresponding surface exponent is thus given in the spin wave approximation by the linear behaviour

This result is simply twice the bulk value,  $_{\rm k}$  (T) = 2 (T). This relation to the numerical data at low temperature as shown in gure 10 or in the table.

At the KT transition, the bulk exponent is fully coherent with the result of K osterlitz and Thouless RG analysis  $(T_{KT}) = 1=4$ . For the surface, the value  $_{k}(T_{KT})' = 0.54$  is close to the known result  $\frac{1}{2}$  [39], a value which cannot be excluded from our analysis (though out of the error bar), since the uncertainties that we quote are only indications. It is also coherent with the surface exponent obtained at the KT point of the quantum A shkin-Teller chain ( $= 2^{1=2}$  in reference [67]),  $_{k}(T_{KT}) = 2^{-1} \arccos() = 1=2$ . This value is furtherm ore in agreement with the relation  $_{k}(T) = 2$  (T), provided that it is valid up to the KT point. This relation was established in the spin-wave approach, and to extend it to the vortex dom inated regin e, closer to  $T_{KT}$ , we note that the e ect of vortices (when T !  $T_{KT}$ ) when treated in the spin wave approach [13, 15] is only to increase the e ective temperature in the spin wave approximation, hence to enhance the decay of the correlations. Like  $_{k}(T) = 2$  ( $T = k_{B}T = J$  is correct in the spin wave treatment, the relation  $_{k}(T_{e}) = 2$  ( $T_{e} = k_{B}T_{e} = J$  should hold in the whole critical phase, with a shift in temperature which depends on the vortices interactions,


where hq(0)q(r)i are the vortex intensity correlations (which are negative in the neutral low temperature phase). It is thus reasonable to expect that the relation  $_{k}(T) = 2$  (T) is exact for the whole critical phase of the model. It can be checked that the num erical values in table 1 support this expression.

The approach of the KT point, where the tem perature dependence of the bulk correlation function exponent is known, is also interesting. From the num erical data,

(T) can be expanded close to the KT point T  $! T_{\rm KT}$ , showing a leading square root behaviour [14, 23] as illustrated in gure 11. The same behaviour is obtained for the surface exponent. One should nevertheless mention here that the plot of ( (T)  $\frac{1}{4}$ )<sup>2</sup> or ( $_{\rm K}$ (T)  $\frac{1}{2}$ )<sup>2</sup> against T seem to indicate a slightly lower value of  $T_{\rm KT}$  than 0.893. A clari cation of that point is beyond the scope of this paper, since it would de nitely require simulations of really large system s in order to rule out the possibility of nite-size dependence of the measured quantities.

Eventually, we mention that our analysis of the energy density proles is compatible with the marginality condition of the temperature in the low temperature phase of the X Y model. This condition, equivalent to the continuous variation of the magnetic scaling dimension, indeed in plies that the therm alscaling dimension keeps a constant value  $x_{*} = 2$  which do not depend on the temperature, and this value enable to t reasonably the numerical data.

In this paper, we perform ed an accurate study of the low-tem perature phase of the 2d X Y model using e cient techniques, based on a conform alm appings of the correlation functions and density pro les. At the Kosterlitz-Thouless transition, the results are in agreement with the general picture of the RG analysis and the critical

exponents describing the algebaric decay of the correlations in the low temperature phase are measured.
