A b stract

The quantum interference e ect on the quasiparticle density of states ( $D$ O S ) is studied w ith the diagram $m$ atic technique in tw o-dim ensional $d-w$ ave superconductors $w$ th dihute nonm agnetic im purities both near the B om and near the unitary lim its. W e derive in details the expressions of the G oldstonem odes (cooperon and di uson) for quasiparticle di usion. The DOS for generic Ferm isurfaces is shown to be sub ject to a quantum interference correction of logarithm ic suppression, but w ith various renorm alization factors for the B om and unitary lim its. Upon approadhing the combined lim it of unitarity and nested Ferm i surface, the D OS correction is found to becom e a -function of the energy, which can be used to account for the resonant peak found by the num erical studies.

## I. Introduction

Since the experim ents revealed the $d$-wave sym $m$ etry of the order param eter in cuprate superconductors $\left[\begin{array}{ll}{[1]}\end{array}\right]$, the physics of low energy quasiparticle excitations in disordered two-dim ensional (2D ) d-w ave superconductors has been a sub ject of ongoing
intensive research $[\underset{-2}{[2]}]$. T he characteristic feature of the $\mathrm{d}_{\mathrm{x}^{2}} \mathrm{y}^{2} \mathrm{w}$ ave pairing state is the existence of four nodal points w here the order param eter van ishes. In the vicin ity of the gap nodes there exist low-lying D iractype quasiparticle excitations. A n understanding of the disorder e ect induced by random ly-distributed im purities on these low-energy states is essential for the elucidation of the therm odynam ic and transport properties of disordered d-w ave superconductors. D uring the years a num ber of theoretical approaches, such as the self-consistent approxim ation schem es [3\{9], non-perturbative $m$ ethods [10\{17], and num erical studies [18-22], have been developed to calculate the quasiparticle density of states (D O S ) in the presence of disorder. U nfortunately, m any of these theories contradict each other. The DOS at zero energy was variously predicted to be nite [3\{10], vanishing [11\{14,18,21], and divergent $[15,20]$. Recently, it has been m ade clear that $[16,17,19,22] \mathrm{m}$ uch of this controversy roots in the fact that the d-w ave superconductor is fundam entally sensitive to the details of disorder, as well as to certain sym $m$ etries of the norm al state $H$ am iltonian.

In order to clarify the physics of the various asym ptotic results for the DOS, Yashenkin et al. $[\underline{2} \overline{3} \overline{1}]$ analyzed the di usive $m$ odes in disordered $d$-w ave superconductors and calculated the w eak-localization correction to the D O S w ith the diagram matic technique. It is well known that the weak localization in electron system s is a m anifestation of the quantum interference ( $Q$ I) e ect, whidh stem $s$ from the existence of the Goldstone m odes (cooperon and di uson) $\bar{R} \overline{4} \overline{4}$. A s pointed out by A ltland and Z imbauer $\left[\underline{2} \overline{5}_{1}^{\prime}\right]$, the $G$ oldstone $m$ odes in a superconductor have di erent features from those in a norm alm etal, for the local particle-hole sym $m$ etry of the superconducting state gives rise to a com bination of im purity- and A ndreev-scattering processes. A s a result, every cooperon or di uson mode in the retarded-advanced (RA) channelentails a corresponding $m$ ode in the retarded-retarded ( $R R$ ) or advanced-advanced ( $A A$ ) channel. In the combined lim it of the unitarity and nested Ferm i surface (the UN lim it), each of these 0-m ode cooperon and di uson has a mode counterpart due to
 was found $\left[\begin{array}{ll}{[2]}\end{array}\right]$ that in generic situations the quasiparticle D OS is sub ject to a loga-
rithm ic weak-localization correction due to the 0 -m ode cooperon, and the existence of di usive -m odes can give rise to a nite, or even divergent zero-energy DOS upon approaching the UN lim it.

T he weak-localization calculations carried out by Yashenkin et al. appear to capture the physical origin of the discrepancies betw een predicted low -energy quasiparticle D O S.Furtherm ore, the quasiparticle w eak-localization e ect w as also suggested to have im portant in uences on transport properties such as the electrical [ $\overline{6}_{1} \overline{1}$, spin $\left[\underline{1} \frac{1}{1} 1\right]$, ther-
 have been w idely investigated for disordered norm alm etals $\left[\underline{2} \bar{L}_{1}^{1}\right]$, a corresponding theory for random D irac ferm ions in superconducting cuprates is far from w ell established, and thus highly deserves further developm ent.
$T$ his paper presents an intensive study of the Q I e ect on the quasiparticle DOS in 2D d-w ave superconductors w ith dihute nonm agnetic im purities both near the B om and near the unitary lim its. These two lim iting cases are considered to be closely related with the disorder e ects in cuprate superconductors. It is reasonable that the disorder due to defects o the copper-oxygen plane $m$ ay be treated in the Bom approxim ation and that defects in the plane $m$ ay be in the unitary lim it [G]. A beit sharing certain aspects w ith Ref. [2] in d-wave superconductors, and obtain som e new results in this paper. First, the expressions of the $G$ oldstone $m$ odes for quasiparticle di usion are derived in details both near the B om and near the unitary lim its. Second, we calculate the additional contributions to the D O S from those low est-order self-energy diagram s containing nonsingular ladders, which were not taking into account previously. T hese diagram s are shown to give rise to various renorm alization factors for the DOS correction in the Bom and unitary lim its. Third, by taking into account a new nontrivial selfenergy diagram w th the m ode di uson, we show that the Q I correction to the D O S becom es a -function of the energy upon approaching the UN $\lim$ it. This result can be used to account for the resonant peak found by the previous num erical studies [1]

The structure of this paper is as follow s. In Sec. II, the com m only used self-
consistent $T$ m atrix approxim ation (SCTMA) is described for a weakly-disordered $d_{x^{2}} y^{2}{ }^{-w}$ ave superconductor. U sing the SCTMA, we derive in Sec. III the expressions of the 0 m ode and m ode cooperons and di usons. The Q I correction to the quasiparticle D O S is calculated in Sec. IV , and the conclusions are sum m arized in Sec. V. T he A ppendix provides som e $m$ athem atical form ulas, which are useful for our derivations.

## II. SCTM A for $d-w$ ave superconductors

Let us consider a most extensively studied $m$ odel for a $2 \mathrm{D} \quad \mathrm{d}_{\mathrm{x}^{2}} \mathrm{y}^{2}$ w w ave superconductor. In the tight-binding approxim ation, the norm al-state dispersion of a square lattice is given by $k=t\left(\operatorname{cosk}_{\mathrm{x}} \mathrm{a}+\operatorname{cosk}_{\mathrm{y}} \mathrm{a}\right) \quad \mathrm{w}$ here a is the lattice constant, t is the nearest-neighb or hopping integral, and is the chem ical potential. T he nested Ferm i surface corresponds to the half-lling case $(=0)$. The order param eter of the $d_{x^{2}} y^{2}$ wave pairing state can be expressed by $k=0\left(\operatorname{cosk}_{x} a \quad \operatorname{cosk}_{y} a\right)$. The four gap nodes are given by $k_{n}=\left(k_{\theta} ; k_{\theta}\right)$ with $k_{0}=(1=a) \arccos (=2 t)$, which satisfy $k_{n}=k_{n}=0$. In the presence of random $l y$-distributed nonm agnetic im purities, the tim e-reversal and spin-rotational sym $m$ etries rem ain preserved. T hus the system belongs to sym $m e-$ try class C I in the classi cation of $R$ ef. 1 point-like, $m$ eaning that the intra-and inter-node scatterings are described by a single potentialstrength $V$. For a low im purity concentration $n_{i}$, the quasiparticle selfenergy in the SCTMA $\left[{ }_{[2]}^{2}\right]$ can be expressed in the N am bu spinor representation as

Throughout th is paper, wem ainly consider the cases near ether the $B$ om or the unitary $\lim$ it. It is worthy to point out that the values of the im purity potentialV driving the system into these tw o lim its are dependent on the band structure.

## III. T he di usive m odes

Since the Q I e ect is related to the di usive m odes, we rst derive the expressions of the $0-m$ ode and $m$ ode cooperons and di usons for a disordered $d-w$ ave superconductor.
A. $0-\mathrm{m}$ ode cooperon and di uson

The 0-m ode cooperon and di uson exist both in RA and in RR channels due to the local particle-hole sym m etry ${ }_{2} \mathrm{G}_{\mathrm{k}}^{\mathrm{R}}()_{2}=\mathrm{G}_{\mathrm{k}}^{\mathrm{A}}(\quad)$. The ladder diagram s for the cooperon are given by Fig. 1 (b) in Ref. $\overline{\underline{2}} \overline{\underline{3}} \mathbf{1}$ ]. T he equation for 0 -m ode cooperon can be expressed as

Upon approaching the UN lim it ( is sm allenough), the contributions from the 0 -m ode and m ode cooperons cancel out each other, so that the D O S correction is given only by the contribution of the $m$ ode di uson, ie.,

This result can be used to account for the sharp peak found in the num erical studies of the D O S [19

## V.Sum m ary

W e have extensively investigated the $Q$ Ie ect on the quasiparticle D OS in $a d_{x^{2}} y^{2-}$ w ave superconductor w ith dihute nonm agnetic im purities. A s in the study of disordered norm alm etals $[\underline{[24} \overline{4}]$, the understanding of the di usive $m$ odes is essential for the investigation of the Q I e ect in a superconductor. Through detailed derivations, we have obtained the expressions for the di usive $m$ odes both near the B om and near the unitary lim its. It is dem onstrated that these $G$ oldstone $m$ odes $m$ ay contain non-diagonal com ponents in the interm ediate region far from these two lim its. Therefore, a re ned weak-localization theory is necessary for the generic situations.

For generic Ferm i surfaces, the Q I e ect results only from the 0fm ode cooperon, yielding a logarithm ic suppression to the quasiparticle D O S near the B om or unitary lim 过. We show that those non-trivial selfenergy diagram s containing non-singular ladders give rise to various renorm alization factors of the D O S correction for the B om and unitary lim its.
$N$ ear the UN (unitary and nesting) lim it, the Q I e ect com es not only from the contribution of the 0-m ode cooperon, but also from those of the m ode cooperon and di uson. It is found that the selfenergy diagram s w ith both im purity-scattering vertioes corrected by the $m$ ode di uson have an im portant contribution to the D OS, which is proportional to $=\left({ }^{2}+{ }^{2}\right)$. A s a result, the quasiparticle D O S is sub ject to a positive correction induced by the di usive m odes. Upon approaching the UN lim it (! 0), the contributions of the 0-m ode and m ode cooperons cancel out each other (even including the renorm alization contributions induced by the non-singular ladders), so that the D O S correction becom es a -function of the energy. This result can be used to account for the resonant peak found in the previous num erical studies [1] $\overline{1}$ grond sim ilar sharp peak of electronic D OS has been found num erically in a disordered 2D tight-binding $m$ odel for the norm al state $[\underline{3} \overline{0} \bar{O}]$. T he appearance of this sharp peak can be also explained by the contribution of $F$ ig. 2 (a) with the $m$ ode di uson ( $F$ ig. 2 (b) has a vanishing contribution for the norm al state) [ $\left.{ }_{\underline{3}} \overline{1}_{1}^{-}\right]$.

Like in the case of disordered interacting-electron system s $\underset{\underline{2} \overline{9}]}{1}]$, all the leading polarization diagram s responsible for the Q I e ect on the quasiparticle conductitity can be
generated in the conserving approxim ation from the low est-order self-energy diagram s show n in F igs. 1 and 2. For the nom al state, it has been show n that the contributions of those polarization diagram $s w$ th $m$ ode di uson lead to an antilocalization correction to the conductivity in the UN lim it $[\overline{3} \overline{2}]$ ]. H ow the $Q$ I processes related w ith the di usive m odes a ect the transport properties, such as electrical and spin conductivities, in a d-w ave superconductor is another interesting problem, and will.be studied in our future work.
