# Tom onaga-Luttinger $m$ odelw ith an im purity for a weak two-body interaction

#### Abstract

The $T$ om onaga-Luttinger $m$ odel $w$ ith im purity is studied by $m$ eans of ow equations for $H$ am iltonians. The system is form ulated within collective density uctuations but no use of the bosonization formula is $m$ ade. The truncation schem $e$ includes operators consisting of up to four ferm ion operators and is valid for sm all electron-electron interactions. In this regim $e$, the exact expression for the anom alous dim ension is recovered. Furthem ore, we verify the phase diagram of $K$ ane and $F$ isher also for interm ediate im purity strength. The approach can be extended to $m$ ore general one-body potentials.

## I. INTRODUCTION

Ten years ago, $K$ ane and $F$ isher show ed in their in $u-$ ential work on the transm ission through barriers in onedim ensional (1D ) conductors, that at T = 0 an arbitrarily weak barrier leads to perfect re ection at the im purity in the presence of repulsive tw o-body interaction whereas not even an arbitrarily large barrier can hinder the electrons from perfect transm ission through, the im purity if there is attractive tw o-body interaction ${ }^{1} 1 l^{1}$ Em ploying the bosonic representation of a 1D ferm ionic system, the results were obtained from a perturbative renom alization group ( $\mathrm{R} G$ ) analysis in the im purity strength, treating the weak coupling as well as the dualstrong coupling regim e. A rguing that theRG ow cannot cross them arginal xed point line of zero interaction, the authors obtained their universal results independent of the im purity strength. The approach and result is closely connected to the perturbational RG treatm ent of a B rownian particle in a periodic potential which experiences a phase transition from di usive to localized behavior at som e critical coupling strength, rst observed by Schm id ${ }^{13}$

In the follow ing years $m$ any authors con $m$ ed and also disproved the above results and the controversy w as only resolved four years ago in favor of the initial results by nite-size meferm ionization at the exactly solvable Toulouse-point ${ }^{14} T$ he reason for the steady interest is the experim ental relevance of the results since 1D transport properties are $m$ ainly determ ined by the transm is sion through the barrier and thus show algebraic behavior as a function of the tem perature involving non-universal exponents, in accordance w ith Luttinger liquid theoryln Furtherm ore, the spectral density of states at the im purity site show s algebraic suppression at the chem ical potential, but the pow er-law is govemed by a larger exponent than the bulk exponent of a translational invariant m odel. Recently, evidence was found that the conductance in $G$ aA s/A IG aA squantum w iresbehaves according to the theqretical predictions based on the bosonization technique But it was also pointed out that nite size e ects $m$ ight becom e im portant since the bosonic representation of the 1D Ferm igas is only applicable w th in an
asym ptotically sm all regim e around the Ferm ienergy ${ }^{-1 /}$
In this work, we want to apply a novel renorm alization schem e to thep-problem, the ow equation approach
 to be in a way com plem entary to the RG approach of $K$ ane and $F$ isher as it is valid for sm all two-body interaction but arbitrary im purity strength, Further, it does not rely on the bosonization technique ${ }^{10}$ and it can easily be extended to $m$ ore general one-body potentials. The fact that the ow equation approach is a novel renor$m$ alization schem e involving di erent approxim ations can also be seen from the analysis of the two-dim ensional H ubbard, m odel. W hereas functional renorm alization schem e1 ${ }^{111}$ rely on the static $\lim$ it $!=0$, this kind of approxim ation is not present in the ow equation approach since the $H$ am iltonian form ulation of the problem is preserved. U navoidable in the ow equation treatm ent is the neglect of higher order coupling term $s$ in the onsite interaction $U$. $N$ evertheless, the anti-ferrom agnetic instability of the strong coupling regim e is predicted ${ }^{2}$ [1. Sim ilarly, we will - in the follow ing - recover the exact coupling-dependent anom alous dim ension even though our truncation schem $e$ is valid only for sm all electronelectron interaction.

The paper is organized as follow s. In Sec. II, we w ill rst treat the $T$ om onaga-Luttinger ( $T \mathrm{~L}$ ) model within the ow equation approach, deriving the exact results for correlation functions in the position-tim e space by $m$ aking explicit use of the bosonization form ula. W e will then employ the usual representation of the ferm ionic eld operator, where approxim ations becom e necessary. K eeping track of only the rst non-trivial term, we will obtain the algebraic power-law behavior for small twobody interaction and the exact anom alous dim ension is recovered. In Sec. III, we will add an im purity to the system and show within the sam e truncation schem e as in the case of the TL m odel that the backw ard scattering constant yields the dom inant contribution and either tends to zero or in nity depending on (weak) attractive or repulsive interaction. Since the asym ptotic behavior of the ow equations tums out to be independent of the in itial conditions, the result also holds for the regim e of interm ediate im purity strength which w as not explicitly
treated by the RG schem e of $K$ ane and $F$ isher．$W$ e also evaluate the spectral density at the im purity after ne－ glecting the irrelevant forw ard scattering term．In Sec． IV ．we close w ith conclusions．

## II．TOMONAGA－LUTTINGER MODEL

In the follow ing section，we brie y derive the $\mathrm{T} L \mathrm{~m}$ odel starting from a continuous 1D interacting electron gas， $m$ ainly in order to introduce the notation．W e then dis－ cuss the m odel via ow equations $w$ ith and w thout the use of the bosonization form ula．The T L m odel is closely related to the $n$－orbital $m$ odel in 1D on－w hich $W$ egner introduced the $m$ ethod of ow equations ${ }^{\prime 2} \mathrm{~W}$ e also w ant to $m$ ention the recent work by H eidbrink and U hrig on 1D spinless ferm ions on a lattice $w$ ith nearest neighbar interaction using continuous unitary transform ations ${ }^{12}{ }^{31}$

A．Them odel

W e start w ith the description of one－dim ensional，non－ relativistic，interacting spinless electrons on a ring of length $L$ ．The continuum version of the $H$ am iltonian reads

where the ferm ionic eld（x）obeys periodic bound－ ary conditions and the canonical anti－com $m$ utation rela－ tion．$V(x)$ resem bles the tw o－body potentialbetw een the ferm ions and we also included a possible one－body poten－ tial $U(x)$ ，which shall be zero for this section $P$ P erform－ ing the Fouries transform ation $(x)=L{ }^{1=2}{ }_{k} e^{i k x} q_{k}$ ， $V(x)=L^{1}{ }_{q} \mathrm{e}^{\mathrm{iqx}} \mathrm{V}_{\mathrm{q}}$ with k ；$q=2 \mathrm{n}=\mathrm{L}, \mathrm{n} 2 \mathrm{Z}$ and focusing on the low－energy properties in the high－ density lim it of the system，the energy dispersion can be linearized around the Ferm ipoints $k_{F}$ where $k_{F}=$ $2 \mathrm{~N}=\mathrm{L}, \mathrm{N}$ being the number of electrons．W ith the Ferm i velocity $V_{F} \quad k_{F}=m$ the $m$ om entum representa－ tion of the H am iltonian is then given by

where $\mathrm{c}_{\mathrm{k}}{ }^{(\mathrm{y})}$ creates（anninilates）the plane w ave w ith w ave number k．Further，we neglected－and will neglect throughout this work－contributions from the num ber－ of－particle operator，since they vanish in the them ody－ nam ic lim it．

The system can be form ulated by tw o anti－com m uting species of ferm ions，the left－and right－m overs，$C_{k}^{L=R}$ ，re－ lated to the two Ferm i－points $k$ ． 141 A mathem atically m ore rigorous treatm ent is possible if the tw o branches of the linear dispersion are extended，ranging from $k=1$ to $\mathrm{k}=1{ }_{15}^{15}$ To assure a well－de ned ground－state，the statesw ith negative energy have to be lled up w ith D irac ferm ions，$d_{k}$ ．A fter proper norm alization，the creation and annihilation operators of the left－and right－m oving density uctuations then obey exact bosonic com muta－ tion relations．These operators are de ned as

$N$ ote that the kinetic term is renorm alized by scat－ tering processes which conserve the energy，denoted as $g_{4}$－processes in the $g$－ology modell ${ }^{10} \mathrm{~A}$ lso in the ow equation treatm ent of the n －orbital m odel，one has to
include scattering term $s$ which conserve the num ber of electrons above and below the Ferm ipoints to the diagonal H am iltonian ?
B. Solution via ow equation

Since the H am iltonian in Eq. $\left.{ }^{(515}\right)$ is bilinear in bosonic operators and the left-and right-m oving uctuations are only coupled by the the sam e w ave num ber, diagonalization is straightforw ard via B ogoljubov transform ation. But we want to diagonalize the H am iltonian via ow equations, i.e. we perform a continuous unitary transform ation param etrized by the ow param eter '.

In di erential form, the in nitesim al transform ations read @, H ( $)=[(`) ; H(`)]$, characterized by the antiHem itian generator ( $)^{\mathrm{y}} \mathrm{y}^{\mathrm{y}}$ ( ). The task is to properly de ne the generator such that the interaction term vanishes in the lim it '! 1 . W egner proposed to choose

B ut the above choige of also induces energy-scale separation, i.e. for a sim ple $m$ odelW egner show ed that the energy di erence betw een the eigenstates of $\mathrm{H}_{0}$, which are just being decoupled, is given by ' ${ }^{1=2}$. Even though allgeneratorsw hich diagonalize the system for'! 1 are essentially equivalent, a system atic decoupling schem e becom es im portant when approxim ations are involved. For a recent review on the ow equation $m$ ethod, see Ref. $2 \underline{2}$ '.

Nevertheless, an analytic treatm ent is then not possible anym ore and we do not want to extend the present approach. ## III. TOMONAGA-LUTTINGER MODELW ITH IM P URITY

T he tw o exam ples of the previous section show ed that the ow equation approach can yield the exact anom alous dim ension even w thin a rather crude truncation schem e. W e will now add an im purity to the system and em ploy the sam e truncation scheme as above, i.e. we use the ferm ionic representation of the eld operators to represent the im purity and only keep track of the rst nontrivialterm.

## A. The m odel

N otice that ${ }^{B}$ is not nom al ordered in the usual sense such that the ferm ionic creation operators are left from the ferm ionic annihilation operators. For the follow ing discussion, this param eter regim e has to be excluded.

It can be deduced from the exact solution and yields $u_{q}(\Upsilon)$ !

Setting $=0$, weobserve after som ealgebra that the ow of the im purity strength delicately depends on the sign of the interaction potential $\mathrm{v}_{\mathrm{q}}$. For attractive electronelectron interaction $\mathrm{v}_{\mathrm{q}}<0$ the absolute value of the backw ard scattering potential ${ }^{B}$ decreases whereas it increases for repulsive interaction. We will now show that $j^{B}$ jtends to either zero or in nity which resembles the $m$ ain_ result of $K$ ane and $F$ isher.

N ote that the phase separation is due to the asym ptotic ow in which the system is already alm ost decoupled, i.e. the tw o-body interaction $u_{q}(`)$ is exponentially sm all. T he localization phenom ena is thus a genuine low -energy phenom ena. U nder these considerations it appears plausible that for real (nite) sam ples this asym ptotic regim e m ay be hard to reach

W hat is still left to verify is that the forw ard scattering potential ${ }_{q}^{F}$ w ill be negligible com pared to ${ }_{q}^{B}$ for ' ! 1 . The_asym ptotic behavior of the inhom ogeneous part of q . ( $\overline{4} \overline{\mathrm{O}}$ ) $)$ is given by

For $v>2 v_{F}$ - one must question whether the truncation schem e still holds for this coupling regim e- ${ }_{q}^{\mathrm{F}}$ goes to in nity, but with a weaker power-law behavior than the backw ard scattering potential. T he forw ard scattering term $w$ ill therefore alw ays resem ble the less relevant contribution to the asym ptotic ow .

A nalyzing the above equation for nite system size $L$, we nd that the maxim um value of $j^{F} j$ increases exponentially as a function of the initial value o before it eventually tends to zero. Since an extended ow equation schem e would couple the forw ard scattering and backw ard scattering potentials, this behavior could result in a signi cant change of the absolute value of ${ }^{B}$ in nite-size system swhich is found in Ref. $\overline{1}_{1}$. W e also
$w$ ant to $m$ ention that a spatially dependent im purity potential $U(x)$ already couples the forw ard and backw ard scattering potentials $w$ thin the above truncation schem $e$.

If we set the forw ard scattering potential ${ }^{\mathrm{F}}$ zero from the beginning and sim ply neglect the norm alordered contributions of the generated operators ( $q+h: c:$ ), the ow equations close involving only the generator ${ }^{\text {ee }}$. W ith ${ }_{\mathrm{F}}=0$ for all , , we obtain the sam e asym ptotic ow equations for ! ${ }_{q}, u_{q}$, and ${ }^{B}$ and thus the sam e scenario as above. This simpli cation will be useful for the evaluation of correlation functions, outlined in the next subsection. In this context, we also $w$ ant to $m$ ention $R$ efs.远 m ed using M onte C arlo and B ethe ansatz techniques, respectively.

## C . Spectral density at the im purity

To discuss correlation functions, the observable has to be subjected to the same sequence of in nitesim al transform ations that led to the diagonalization of the H am iltonian. The ow equations for the observable read @, $R(x)=[; R(x)]$ and di er for $x=0$ and $x \in 0$. At $x=0$, the leading term $s$ are given by

The di erent expressions are crucial in order to distinguish betw een the bulk and the boundary regim e.

The ow equations for the eld operator tum out to be rather com plicated. This is a general feature of the $m$ ethod since ow equations are designed to diagonalize the H am iltonian and, not to yield sim ple expressions for the observable ow '24'W e w ill therefore allow for the above $m$ entioned simpli cation of the $H$ am iltonian ow by neglecting the forw ard scattering contribution to the Ham iltonian. Since now only the generator ee is involved, we can use the calculations of the previous section to determ ine correlation functions, but we loose the distinction between the bulk and the boundary regim e. $T$ he truncation schem e of the eld operator is thus given by Eq. ( $\left.1 \overline{1}_{1}^{\prime}\right)$ for all $x$. Still, we obtain di erent expressions for the approxim ate $G$ reen function, as de ned in

Eq. (23), for attractive and repulsive interaction due to the di erent xed point $H$ am iltonians $H$.

For attractive interaction, the xed point $H$ am iltonian H is given by the free bosonic bath and the ferm ionic ground-state FD Si is obtained w ith the help of the K ronig relation of Eq. (4). Follow ing the procedure of the last section, we thus recover that the spectral function is govemed by the exact bulk exponent $=2 \mathrm{~s}^{2}$ throughout the system even at $x=0$.

For repulsive interaction, due to the rem nant backward scattering potential, the xed point H am iltonian has to be transform ed further to assure a sim ple groundstate. First, we again $m$ ap the non-interacting bosonic bath onto the non-interacting Ferm i gas w th linear dispersion em ploying the K ronig relation. The extemalpotential w ith zero width and zero transm ission can now be absorbed by changing the boundary conditions of the physical eld operator from periodic to xed or open boundary conditions. To describe a linearized 1D system with xed boundary conditions, only right-m overs need to be introduced ${ }^{33}$. W e thus transform the original ladder-operators of the left-and right-m overs according to the follow ing substitution schem e:

$T$ he sign-change of the $m$ om entum in the case of the left-m overs expresses the fact that there are only rightm overs; the relative phase factor stem s from the condition that the physical eld operator has to obey xed boundary conditions, i.e. $\quad(x=0)=R(x=0)+$
$\mathrm{L}(\mathrm{x}=0)=0$.
For nite system size, the transform ation is m ore com plicated since a periodic system of size L can only be $m$ apped onto an open system of size 2 L in order to account for the di erent w ave num bers and to conserve the density of the right-m oversi3. Since we are only interested in results valid in the therm odynam ic lim it, we w ill stick to the sim ple substitution schem e of Eq. (4G) and divide the transform ed xed point $H$ am iltonian by two in order to preserve the density of the right-m overs, i.e. H ! $\mathrm{v}_{\mathrm{c}}{ }^{\mathrm{C}} \mathrm{k}_{\mathrm{k}}^{\mathrm{k}} \mathrm{k}_{\mathrm{k}}^{\mathrm{y}} \mathrm{q}_{\text {. }}$.

Perform ing the substitution also in Eq. ( $\overline{1} \bar{F}_{1}$ ), one sees that only the com bination ${ }^{\prime} \sim_{q}\left(\underset{q}{\mathrm{R}}+\mathrm{r}_{\mathrm{q}}^{\mathrm{L}}\right)$ enters. $W$ ith the sam e approxim ations as in the previous section and $w$ th $/ \sim \quad n_{q}{ }^{1=2} / \sim_{q}$ for $q \quad q$ and zero otherw ise, the spectral density of states at the im purity is given by

W e thus recover the exact boundary exponent = $e{ }^{4 E_{q}} \quad 1=g$, where the last de nition corresponds to the notation of $K$ ane and $F$ isher.

IV . CONCLUSION S

In the present work, we applied ow equations for H am iltonians to the T L model with impurity in the lim it of weak electron-electron interaction but arbitrary im purity strength. We form ulated the TL m odel by collective density uctuationswhich obey B ose statistics, but to represent the im purity potential no use of the bosonization technique was made. We obtained the phase diagram of $K$ ane and $F$ isher and could provide analytic evidence that it also holds in the regim e of interm ediate im purity strength. Sim plifying the ow of the H am ittonian by neglecting the forw ard scattering contribution in the initial H am iltonian, ow equations for the eld operator could be analyzed to yield the exact anom alous dim ensions for the di erent phases as they follow from the bosonization approach. Generalizations of the extemal one-body potentials are straightforw ard. $T$ he presented approach $m$ ight also be usefiul for other systems and resembles an altemative and in a way com plem entary $m$ ethod com pared to functional renor$m$ alization schem es.
