# Tom onaga-Luttinger m odel with an impurity for a weak two-body interaction

The Tom onaga-Luttinger m odel with in purity is studied by m eans of ow equations for H am iltonians. The system is formulated within collective density uctuations but no use of the bosonization formula is made. The truncation scheme includes operators consisting of up to four ferm ion operators and is valid for sm all electron-electron interactions. In this regime, the exact expression for the anom alous dimension is recovered. Furtherm ore, we verify the phase diagram of K ane and F isher also for intermediate in purity strength. The approach can be extended to more general one-body potentials.

#### I. IN TRODUCTION

Ten years ago, K ane and F isher showed in their in uential work on the transm ission through barriers in onedim ensional (1D) conductors, that at T = 0 an arbitrarily weak barrier leads to perfect re ection at the in purity in the presence of repulsive two-body interaction whereas not even an arbitrarily large barrier can hinder the electrons from perfect transmission through the impurity if there is attractive two-body interaction.<sup>1</sup> Employing the bosonic representation of a 1D ferm ionic system, the results were obtained from a perturbative renorm alization group (RG) analysis in the impurity strength, treating the weak coupling as well as the dual strong coupling regime. Arguing that the RG ow cannot cross the marginal xed point line of zero interaction, the authors obtained their universal results independent of the impurity strength. The approach and result is closely connected to the perturbational RG treatment of a Brownian particle in a periodic potential<sup>2</sup> which experiences a phase transition from di usive to localized behavior at som e critical coupling strength, rst observed by Schm id.<sup>3</sup>

In the following years many authors con med and also disproved the above results and the controversy was only resolved four years ago in favor of the initial results by nite-size referm ionization at the exactly solvable Toulouse-point.<sup>4</sup> The reason for the steady interest is the experim ental relevance of the results since 1D transport properties are mainly determ ined by the transm ission through the barrier and thus show algebraic behavior as a function of the tem perature involving non-universal exponents, in accordance with Luttinger liquid theory.<sup>1,5</sup> Furtherm ore, the spectral density of states at the im purity site shows algebraic suppression at the chem ical potential, but the power-law is governed by a larger exponent than the bulk exponent of a translational invariant model. Recently, evidence was found that the conductance in G aA s/A IG aA squantum wires behaves according to the theoretical predictions based on the bosonization technique.<sup>6</sup> But it was also pointed out that nite size e ects might becom e im portant since the bosonic representation of the 1D Ferm igas is only applicable within an

asym ptotically sm all regime around the Ferm i energy.

In this work, we want to apply a novel renorm alization scheme to the problem, the ow equation approach for Ham iltonians.<sup>8,9</sup> The presented treatment turns out to be in a way complementary to the RG approach of K ane and F isher as it is valid for sm all two-body interaction but arbitrary in purity strength. Further, it does not rely on the bosonization technique<sup>10</sup> and it can easily be extended to more general one-body potentials. The fact that the ow equation approach is a novel renorm alization scheme involving di erent approximations can also be seen from the analysis of the two-dimensional Hubbard model. W hereas functional renormalization schemes<sup>11</sup> rely on the static limit ! = 0, this kind of approximation is not present in the ow equation approach since the H am iltonian form ulation of the problem is preserved. Unavoidable in the ow equation treatment is the neglect of higher order coupling terms in the onsite interaction U. Nevertheless, the anti-ferrom agnetic instability of the strong coupling regime is predicted.<sup>12</sup> Sim ilarly, we will - in the following - recover the exact coupling-dependent anom alous dimension even though our truncation scheme is valid only for small electronelectron interaction.

The paper is organized as follows. In Sec. II, we will rst treat the Tom onaga-Luttinger (TL) model within the ow equation approach, deriving the exact results for correlation functions in the position-time space by making explicit use of the bosonization form ula. W e will then employ the usual representation of the ferm ionic eld operator, where approxim ations becom e necessary. Keeping track of only the rst non-trivial term, we will obtain the algebraic power-law behavior for small twobody interaction and the exact anom alous dimension is recovered. In Sec. III, we will add an impurity to the system and show within the same truncation scheme as in the case of the TL model that the backward scattering constant yields the dom inant contribution and either tends to zero or in nity depending on (weak) attractive or repulsive interaction. Since the asymptotic behavior of the ow equations turns out to be independent of the initial conditions, the result also holds for the regime of interm ediate in purity strength which was not explicitly

treated by the RG scheme of K ane and F isher. We also evaluate the spectral density at the impurity after neglecting the irrelevant forward scattering term . In Sec. IV .we close with conclusions.

#### II. TOM ONAGA-LUTTINGER MODEL

In the following section, we brie y derive the TL m odel starting from a continuous 1D interacting electron gas, m ainly in order to introduce the notation. We then discuss the model via ow equations with and without the use of the bosonization form ula. The TL m odel is closely related to the n-orbital model in 1D on which W egner introduced the method of ow equations.<sup>9</sup> W e also want to mention the recent work by Heidbrink and Uhrig on 1D spinless fermions on a lattice with nearest neighbor interaction using continuous unitary transform ations.<sup>13</sup>

### A. Themodel

W e start with the description of one-dimensional, nonrelativistic, interacting spinless electrons on a ring of length L. The continuum version of the Ham iltonian reads

where the ferm ionic eld (x) obeys periodic boundary conditions and the canonical anti-com mutation relation. V (x) resembles the two-body potential between the ferm ions and we also included a possible one-body potential U (x), which shall be zero for this section P Perform ing the Fourier transform ation (x) = L<sup>1=2</sup> k e<sup>ikx</sup> Q<sub>k</sub>, V (x) = L<sup>1</sup> g<sup>eiqx</sup> v<sub>q</sub> with k; q = 2 n=L, n 2 Z and focusing on the low-energy properties in the highdensity limit of the system, the energy dispersion can be linearized around the Ferm i points  $k_F$  where  $k_F =$ 2 N=L, N being the number of electrons. W ith the Ferm i velocity  $v_F$   $k_F = m$  the momentum representation of the H am iltonian is then given by

where  $c_k^{(y)}$  creates (annihilates) the plane wave with wave number k. Further, we neglected – and will neglect throughout this work – contributions from the numberof-particle operator, since they vanish in the therm odynam ic lim it. The system can be form ulated by two anti-commuting species of fermions, the left- and right-movers,  $c_k^{\rm L=R}$ , related to the two Fermi-points  $k_{\rm F}$ .  $^{14}$  A m athematically more rigorous treatment is possible if the two branches of the linear dispersion are extended, ranging from k=1 to k=-1  $^{15}$  To assure a well-de ned ground-state, the states with negative energy have to be lied up with D irac fermions,  $d_k$ . A fler proper normalization, the creation and annihilation operators of the left- and right-m oving density uctuations then obey exact bosonic commutation relations. These operators are de ned as

The commutation relation thus reads  $[b_q^i; b_{q^0}^{i^0 Y}] = i_{j;i^0 q;q^0}$ , with  $i_j; i^0 = L; R$ .

The interaction term of the Ham iltonian given in Eq. (2) can now be decoupled into left- and right-moving uctuations if we assume the interaction to be longranged in position space, i.e.  $v_q = v_F$ 1 for q q.,  $k_{\text{F}}$  denotes the interaction cuto  $.^{14}$  This where q<sub>c</sub> suppresses scattering processes from one branch to the other, i.e. g1-processes according to the g-ology model, due to v<sub>2k</sub> 0. A som ehow counter-intuitive approach is to assume a delta-interaction in position space. A RG analysis then shows that repulsive q1-processes scale to zero, i.e. are marginally irrelevant.<sup>16</sup> The so-called  $q_2$ processes, associated with the density-density interaction between left-and right-movers, are then renorm alized to  $g_2 = g_2 \quad q_{\bullet}^{17}$ 

To also express the kinetic term by the newly introduced bosonic operators, the K ronig relation has to be employed,

where we neglected contributions of the number-ofparticle operator of the left- and right-m overs.<sup>18</sup> The resulting TL m odel resembles the xed point H am iltonian of 1D interacting electron system  $s_r^5$

Note that the kinetic term is renormalized by scattering processes which conserve the energy, denoted as  $g_4$ -processes in the g-ology model<sup>16</sup> A lso in the ow equation treatment of the n-orbital model, one has to

include scattering terms which conserve the number of electrons above and below the Ferm i points to the diagonalH am iltonian.<sup>9</sup>

#### B. Solution via ow equation

Since the H am iltonian in Eq. (5) is bilinear in bosonic operators and the left- and right-moving uctuations are only coupled by the the sam e wave num ber, diagonalization is straightforward via Bogoljubov transform ation. But we want to diagonalize the H am iltonian via ow equations, i.e. we perform a continuous unitary transform ation param etrized by the ow param eter `.

In di erential form, the in nitesim al transform ations read  $(\cdot, H(\cdot)) = [(\cdot); H(\cdot)]$ , characterized by the anti-Herm it ian generator (') =  $y(\cdot)$ . The task is to properly de ne the generator such that the interaction term vanishes in the lim it '! 1 . We gener proposed to choose

=  $[H_0;H]$ , where  $H_0$  denotes the diagonal H am iltonian which is assumed to be solved. This choice guarantees that the trace of the squares of the o-diagonal elements is a monotonically decreasing function of ', i.e.  $(0.Tr[(H + H_0)^2]) = 0.$ 

But the above choice of also induces energy-scale separation, i.e. for a simple model W egner showed that the energy di erence between the eigenstates of H<sub>0</sub>, which are just being decoupled, is given by  $\cdot$  <sup>1=2</sup>. Even though all generators which diagonalize the system for  $\cdot$ ! 1 are essentially equivalent, a system atic decoupling scheme becomes important when approximations are involved. For a recent review on the ow equation method, see Ref. 20.

In order to abbreviate the notation we de ne  $b_q = b_q^R$ and  $b_q = b_q^L$  for q > 0. Neglecting the shift of the ground-state energy, the '-dependent H am iltonian then takes the following form :

where we already used the fact that the ow equations preserve the symmetry between left- and right-movers, i.e.  $!_q(') = !_q(')$  and  $u_q(') = u_q(')$  for all '. The above choice is likely to eliminate the interaction term V for '! 1,<sup>9</sup> but also di erent generators are possible.<sup>21</sup>

Since [('); (°)] = 0 we can also calculate the unitary operator U that diagonalizes the TL Ham iltonian. Generally it is given by U U (' = 1) with U (') = L exp( $_0 d^{v_0}$  (°)) where the operator L denotes the '-ordering operator, de ned in the same way as the time-ordering operator. We obtain U = exp( $_{q60} E_q (b_q b_q \quad b_q b_q^v)$ ) with the familiar relation tanh (4E $_q$ ) =  $v_q = (2 v_F + v_q)$ , where we de ned  $E_q \quad E_q$  (' = 1).

To determ ine the ow of the observables we will use the representation of the 1D ferm ionic eld operator of the left- and right-m overs,  $_{\rm L=R}$  (x), which involves the operators of the bosonic density uctuation.<sup>5,22</sup> It is given by  $_{\rm L=R}$  (x) =  $F_{\rm L=R}$  e  $^{\rm L=R}$  (x), where the operator  $F_{\rm L=R}$  low- ers the number of left- and right-m overs by one, respectively and commutes with the bosonic operators  $b_q^{(y)}$ , i.e.  $b_q^{(y)}$ ;  $F_{\rm L=R}$  ] = 0.<sup>23</sup> The phase eld is de ned as

where, for convenience, we om itted the ultraviolet convergence factor. Due to the preserved sym m etry between left- and right-m overs, only the transform ation of the right-m oving eld needs to be considered. Since U (') only consists of bosonic operators and thus commutes with  $F_R$ , we have U  $_R(x)U^{y} = F_R e^{U_{-R}(x)U^{y}}$ for all '. Therefore it su ces to consider the ow equations for the phase eld, i.e.  $e^{Q_{-R}}(x) = [; R(x)]$ . In the limit  $\cdot$ ! 1 we recover the well-known result for the transformed eld operator

### C. Approxim ations

It is not surprising that the ow equation approach could be applied in a rather straightforward manner because we took advantage of the bosonization technique. Now we want to calculate the commutator [;  $_{R}$  (x)] directly, employing the usual representation  $_{R}$  (x) =  $L^{1=2}$   $_{k}^{1=2}$   $_{k}^{ikx} c_{k}^{R}$ . W ith the de nition of Eq. (14) this yields

Further we have  $[; q^{R=R}(x)] = 2q q^{R=L}(x)$ . This shows that the ow equations (0, R(x)) = [; R(x)] do not close but generate an in nite series of operators. We thus make the following ansatz for the fermionic eld:

The initial conditions are given by g(`= 0) = 1 and  $r_q^{L=R}$  (`= 0) = 0. The above ansatz in plies that we only keep track of the rst non-trivial term generated by the ow equations.

The ow equations depend on the decoupling scheme of the higher order term s. If one neglects bilinear term s in the bosonic operators without norm all ordering them, the parameter g is left un-renorm alized, i.e. g = 1 for all `. The ow equations then read

Expanding also the fermionic eld up to linear bosonic operators, i.e.  $_{R}(x)$  !  $F_{R}(1 + _{q>0}n_{q}^{1=2} R_{q}(x))$ , we see that the ow equation approach yields the correct result of Eq. (16) up to terms which are linear in the bosonic operators, i.e. U  $_{R}(x)U^{\gamma}$  !  $F_{R}(1 + _{q>0}n_{q}^{1=2}(c_{q}R_{q}(x)) + s_{q}R_{q}(x))$ . Note that the Bogoljubov-coe cients s  $_{q}$  and  $c_{q}$  are exactly recovered.

C onsider now the transform ation of the ferm ionic ladder operators of the right-m overs  $c_k^R$ . The ow equations  $\emptyset \cdot c_k^R = [; c_k^R]$  do not close and we will again truncate the series after the term s which are linear in the bosonic operators,

N eglecting terms which are bilinear in the bosonic operators in their non-norm all ordered form leads to the same dimensial equations as for the ow parameters of the truncated fermionic eld operator. The solution is thus again given by g = 1 for all ' and

So far we do not know what e ect the above truncation scheme has got on physical quantities. with the step function (k) which equals one for k = 0 and zero otherwise.

Considering k =  $k_{\rm F}$  + q with q > 0, only the last term of the above equation contributes to  $n_k^{\rm R\,;1}$ . It is now convenient to work with a nite interaction cuto q. 2  $n_{\rm E}{=}L$  and choose the interaction potential as a step function in momentum space, i.e. s $_{\rm q}$  for q $_{\rm c}$  and zero otherwise. Like this, we avoid ultraviolet givergences and are able to obtain analytic results. The last limit was taken in the case of weak coupling, where we assumed that the logarithm stems from a power-law expansion. In this perturbative regime we thus recover the well-known algebraic behavior around the Fermi point  $k_{\rm F}$ . We also not the remarkable result that the above truncation scheme yields the exact anom alous dimension  $2s^2$ .

For wave numbers below the Ferm ipoint, ie. for k = q w ith q > 0, the calculations are not so plane and  $k_F$ we will have to make further approximations. In the follow ing, we have to discard  $q_{q^0>0} e_q e_{q^0} = (n_q n_{q^0})$  ( (k  $_F$  + k)  $(k_F + q^0 k) + (k_F q q_P k) (k_F q$ q k) (k  $_{\rm F}$   $q^{\rm c}$  k)) and the constant term  $\left[ \begin{array}{c} q_{\rm p} \\ q_{\rm q} \end{array} \right] = n_{\rm q}$ . The neglect of the rst term s can be justiled since they resemble higher order contributions to the logarithm ic expansion and by only considering the rst non-trivial term in the expansion of  $_{\rm R}$  (x), these contributions cannot be accounted for. The second, constant term im plies that the neglected operators should be included in the ow more adequately. Norm al ordering before neglecting these operators would result in a renorm alization of g which would also give rise to a constant contribution, partially canceling the rst one. Nevertheless, an analytic treatm ent is then not possible anym ore and we do not want to extend the present approach. For a detailed discussion on the observable ow in the case of a num erically solvable, but non-trivialm odel, see Ref. 24.

W ith these approximations, one then obtains for the whole regime in the limit of small coupling

The pre-factor 1=2 associated with the power-law behavior is also recovered from simple perturbation theory.<sup>19</sup> This factor could not be recovered unam-biguously from the calculations of the approximate occupation number of the n-orbitalm odel.<sup>9</sup>

Finally, we want to check if also dynam ical quantities can be recovered from the above truncation scheme. For this we will calculate the approximate G reen function de ned as

In order to evaluate the time dependence of the fermionic eld of the right-m overs we have to work with a constant potential in momentum space, i.e. v  $v_q$  for all q. This yields a linear energy dispersion for the xed point H am iltonian, i.e.  $H = v_c _{q60} j_j j_q v_q b_q$  with the renormalized Ferm i or charge velocity  $v_c = v_f (1 + v=(v_F))^{1=2}$ . W ith the help of the K ronig relation of Eq. (4), the time dependence of the ferm ionic and bosonic ladder operators in the H eisenberg picture at ' = 1 is given by  $c_k^R$  (t) =  $c_k^R e^{-ikv_c t}$  and  $b_q$  (t) =  $b_q e^{-ij_j j_v t}$ .

The G reen function of Eq. (23) can now be expressed as a function of the conform alvariables L=R x yt and yields

An important consistency check of the above truncation schemes is given by the fact that  $n_k^{R,1} = \frac{R_{L=2}}{L=2} dxe^{-ikx} iG_R^{<,1} (x;t=0)$ . But working with a constant potential in momentum space, i.e. a delta-potential in position space, yields the well-known ultraviolet divergences. In the following we will therefore introduce an ultraviolet cuto and also label it with  $q_c$ .

A physical observable is given by the occupied density of states  $_{R}^{<}$  (!) which is observed in photo-em ission experiments. In the above approximation, it is given by

In the lim it of sm all coupling we thus obtain the well-known algebraic suppression at the renorm alized Ferm i energy, again governed by the exact anom alous dimension =  $2s^{2}$ .<sup>25</sup> N ote that for the static correlation function  $n_{k}^{R,1}$  the anom alous dimension is being accounted for by either left-m overs ( $k > k_{F}$ ) or right-m overs ( $k < k_{F}$ ) whereas both branches contribute in equal parts in case of the dynam ic correlation function  $R_{R}^{r,1}$  (!). Finally, we want to mention that Eqs. (21) and (26) are also obtained within RPA perturbation theory.<sup>26</sup>

## III. TOMONAGA-LUTTINGER MODELWITH IMPURITY

The two examples of the previous section showed that the ow equation approach can yield the exact anom abus dimension even within a rather crude truncation scheme. We will now add an impurity to the system and employ the same truncation scheme as above, i.e. we use the fermionic representation of the eld operators to represent the impurity and only keep track of the rst nontrivial term.

# A. Themodel

Departing from the H am iltonian of Eq. (1), the onebody potential shall now be given by U(x) = 0 (x). Perform ing the sam e approximations that led to the TL m odel and employing the sam e notation as in the previous section, we arrive to the following H am iltonian:

### B. Solution via ow equations

W e will now set up ow equations which will preserve the form of the Ham iltonian of Eq. (27). This strategy has already proved to be successful in the context of the spin-boson model.<sup>27</sup> The generator of the innitesim al transform ations shall consist of three parts ee + F + B according to the canonical generator

Notice that  $^{\rm B}$  is not norm all ordered in the usual sense such that the ferm ionic creation operators are left from the ferm ionic annihilation operators. For the following, we thus want to de ne norm all ordering such that the creation (annihilation) operators  $b_q^{\rm V}$  (bq) are left (right) from the  $2k_{\rm F}$ -operators  $_{\rm R}^{\rm Y}$   $_{\rm L}$  and  $_{\rm L}^{\rm Y}$   $_{\rm R}$ , respectively. By this, we take on the standpoint that the bosonic operators  $b_q^{\rm V}$  are independent entities with no internal structure.

In Eq. 35, we introduced the 'dependent parameter  $_{q60} n_q^{-1} u_q$ . The symbol in Eqs. (34) and (35) signi es that we neglect normal ordered operators which consist of two bosonic operators and one  $2k_F$  -operator ( $_{R}^{y}$  \_ L or  $_{L}^{y}$  \_ R). This is our truncation scheme which should be valid for sm all electron-electron interaction  $v_q$  as was pointed out in the previous section.

We will now look more closely at Eq. (36). First, we note that the factor N =L em erges from the regularization of the anti-com mutation relation f  $_{L=R}$ ;  $_{L=R}^{y}g =$  $L_{k}^{1}$  N=L, having in m ind the restriction of the sum to the rst Brillouin zone. However, there is evidence based on investigations of the TL model with open boundaries that these terms represent boundary e ects which - in the therm odynam ic  $\lim t - do$  not alter the universal features of the m odel.<sup>28</sup> The evolution of H  $_{\rm R}$  shall thus be neglected.

We will now specify the ow. The generators <sup>ee</sup> and <sup>F</sup> are determined according to the canonical generator <sub>c</sub> [H<sub>0</sub>;H], i.e.  ${}^{ee}_q = !_q u_q$  and  ${}^{F}_q = !_q n_q^{1=2} L^{1} {}^{F}_q$ .




FIG.1: The qualitative ow of j<sup>B</sup> jdepending on the sign of the two-body interaction v as it follows from perturbative RG analysis (lh.s.) and from the ow equation approach (rh.s.). The solid lines resemble analytic results whereas the dashed lines are inferred.

where  $_{\rm B}$  v=(2  $\psi$  + v) and  $^{\rm B}$  denotes the 'independent asymptotic part of  $^{\rm B}$ . This leads to the scenario described above and we want to stress that the asymptotic behavior is independent of the initial condition, i.e. holds for arbitrary initial impurity strength  $_{0}$ . In Fig. 1, the qualitative ow of j  $^{\rm B}$  j depending on the sign of the two-body interaction v is shown as it follows from the one-loop perturbative RG analysis of K ane

and Fisher (lhs.) and from the ow equation approach (rhs.). The solid lines resemble analytic results whereas the dashed lines are inferred.

N ote that the phase separation is due to the asym ptotic ow in which the system is already almost decoupled, i.e. the two-body interaction  $u_q$  (') is exponentially sm all. The localization phenom ena is thus a genuine low -energy phenom ena. Under these considerations it appears plausible that for real ( nite) sam ples this asym ptotic regim e m ay be hard to reach.<sup>7</sup>

W hat is still left to verify is that the forward scattering potential  $_{q}^{F}$  will be negligible compared to  $_{q}^{B}$  for '! 1. The asymptotic behavior of the inhom ogeneous part of Eq. (40) is given by

with the error function  $\operatorname{erf}(x)$  2  ${}^{1=2} {}^{R_x}_{0} dx^{0} e^{x^{02}}$  ! 1  $e^{x^2} = (x )$  for x ! 1. The dimensional equation of Eq. (40) can thus be solved in leading order as `! 1 to yield  ${}^{\mathrm{F}}_{\mathrm{q}} = {}^{1=2} (u=!) ({}^{\mathrm{B}} = {}^{\flat}_{\mathrm{q}})^2 `{}^{\mathrm{B}} {}^{1=2}$ .

Since  $_{\rm B} = v = (2 v_{\rm F} + v)$ , the forward scattering in – purity strength tends to zero as '! 1 for  $v = 2 v_{\rm F}$ . For  $v > 2 v_{\rm F}$  – one must question whether the truncation scheme still holds for this coupling regime –  $_{\rm q}^{\rm F}$  goes to in nity, but with a weaker power-law behavior than the backward scattering potential. The forward scattering term will therefore always resemble the less relevant contribution to the asymptotic ow.

A nalyzing the above equation for nite system size L, we nd that the maximum value of  $j^F j$  increases exponentially as a function of the initial value  $_0$  before it eventually tends to zero. Since an extended ow equation scheme would couple the forward scattering and backward scattering potentials, this behavior could result in a signi cant change of the absolute value of  $^B$  in nite-size system s which is found in Ref. 7. We also

want to mention that a spatially dependent in purity potential U (x) already couples the forward and backward scattering potentials within the above truncation scheme.

If we set the forward scattering potential  $^{\rm F}$  zero from the beginning and simply neglect the normalordered contributions of the generated operators ( $_{\rm q}$  + h c:), the ow equations close involving only the generator  $^{\rm ee}$ . With  $^{\rm F}$  = 0 for all ', we obtain the same asymptotic ow equations for ! $_{\rm q}$ , u $_{\rm q}$ , and  $^{\rm B}$  and thus the same scenario as above. This simplication will be useful for the evaluation of correlation functions, outlined in the next subsection. In this context, we also want to mention Refs. 30,31,32 where the results of K ane and F isher are conmed using M onte C arlo and Bethe ansatz techniques, respectively.

#### C. Spectral density at the impurity

To discuss correlation functions, the observable has to be subjected to the same sequence of in nitesimal transformations that led to the diagonalization of the Hamiltonian. The ow equations for the observable read  $\emptyset \cdot_{R}(x) = [; _{R}(x)]$  and dier for x = 0 and  $x \notin 0$ . At x = 0, the leading terms are given by

which is symmetric in the left-and right-movers and only the initial condition indicates the evolution of the right-moving eld. The leading expansion of the eld operator at  $x \in 0$  is given by

The di erent expressions are crucial in order to distinguish between the bulk and the boundary regime.

The ow equations for the eld operator turn out to be rather complicated. This is a general feature of the method since ow equations are designed to diagonalize the H am iltonian and not to yield simple expressions for the observable ow  $^{24}$  W e will therefore allow for the above mentioned simplication of the H am iltonian ow by neglecting the forward scattering contribution to the H am iltonian. Since now only the generator <sup>ee</sup> is involved, we can use the calculations of the previous section to determ ine correlation functions, but we loose the distinction between the bulk and the boundary regime. The truncation scheme of the eld operator is thus given by Eq. (17) for all x. Still, we obtain di erent expressions for the approxim ate G reen function, as de ned in Eq. (23), for attractive and repulsive interaction due to the di erent  $\mbox{ xed point } H\mbox{ am iltonians } H$  .

For attractive interaction, the xed point H am iltonian H is given by the free bosonic bath and the ferm ionic ground-state f D S i is obtained with the help of the K ronig relation of Eq. (4). Following the procedure of the last section, we thus recover that the spectral function is governed by the exact bulk exponent =  $2s^2$  throughout the system even at x = 0.

For repulsive interaction, due to the rem nant backward scattering potential, the xed point Ham iltonian has to be transform ed further to assure a sim ple groundstate. F irst, we again map the non-interacting bosonic bath onto the non-interacting Ferm i gas with linear dispersion em ploying the K ronig relation. The external potential with zero width and zero transm ission can now be absorbed by changing the boundary conditions of the physical eld operator from periodic to xed or open boundary conditions. To describe a linearized 1D system with xed boundary conditions, only right-m overs need to be introduced.<sup>33</sup> W e thus transform the original ladder-operators of the left- and right-m overs according to the following substitution schem e:

The sign-change of the momentum in the case of the left-m overs expresses the fact that there are only rightm overs; the relative phase factor stems from the condition that the physical eld operator has to obey xed boundary conditions, i.e.  $(x = 0) = {}_{R} (x = 0) + {}_{L} (x = 0) = 0.$ 

For nite system size, the transform ation is more complicated since a periodic system of size L can only be mapped onto an open system of size 2L in order to account for the di erent wave numbers and to conserve the density of the right-movers.<sup>33</sup> Since we are only interested in results valid in the therm odynam ic limit, we will stick to the simple substitution scheme of Eq. (46) and divide the transformed xed point H am iltonian by two in order to preserve the density of the right-movers, i.e. H  $! v_c \ _k \ kc_k^y \ Q_k$ .

Perform ing the substitution also in Eq. (17), one sees that only the combination  $\sim_q$  ( $r_q^R + r_q^L$ ) enters. With the same approximations as in the previous section and with  $\sim$   $n_q^{1=2} \sim_q$  for q q and zero otherwise, the spectral density of states at the impurity is given by

with !  $v_{\xi}k_F$  ! and  $(\sim + 1)^2$ . A susual, for small interaction algebraic behavior is inferred and the asterisk denotes the limiting value as `! 1.

The di erential equation for  $\sim$  follows from Eq. (18) and yields the nalresult

We thus recover the exact boundary exponent =  $e^{4E_q}$  1=g, where the last de nition corresponds to the notation of K ane and F isher.

IV. CONCLUSIONS

In the present work, we applied ow equations for Hamiltonians to the TL model with impurity in the lim it of weak electron-electron interaction but arbitrary impurity strength. We formulated the TL model by collective density uctuations which obey Bose statistics, but to represent the impurity potential no use of the bosonization technique was made. We obtained the phase diagram of K ane and F isher and could provide analytic evidence that it also holds in the regime of interm ediate in purity strength. Sim plifying the ow of the Hamiltonian by neglecting the forward scattering contribution in the initial Ham iltonian, ow equations for the eld operator could be analyzed to yield the exact anom alous dimensions for the dierent phases as they follow from the bosonization approach. Generalizations of the external one-body potentials are straightforward. The presented approach might also be useful for other systems and resembles an alternative and in a way com plem entary m ethod com pared to functional renormalization schemes.
