Dowe understand electron correlation e ects in Gadolinium based intermetallic compounds?

Recognising the di culties in system atic understanding of the physical characteristics of strongly correlated f-electron system s, we considered it worthwhile to subject the so-called "norm al" f-electron systems like those of Gd to careful investigations. We nd that the spin-disorder contribution to electrical resistivity () in the param agnetic state, instead of remaining contant, surprisingly increases with decreasing tem perature (T) in the param agnetic state in som e of the Gd alloys. In som e cases, this "excess resistance" is so large that a distinct minimum in the plot of versus T can be seen, mim icking the behaviour of K ondo lattices. This excess resistance can be suppressed by the application of a magnetic eld, naturally resulting in large magnetoresistance. In addition, these alloys are found to exhibit heavy-ferm ion-like heat-capacity behavior. These unusual ndings in ply hither-to-unexplored electron correlation e ects even in Gd-based alloys.

I. IN TRODUCTION

The physical characteristics of the materials containing som e of the f-elements like Ce, Eu, Yb and U, arising from strong electron correlation e ects, have been of great interest during last two decades in condensed matter physics and the identi cation of new materials containing these ions often resulted in discovery of novel phenomena. But, the fact remains that, inspite of intense theoretical and experim ental activities, there are considerable di culties in system atic understanding of these properties even at a qualitative level. How ever, it has been recognised that the observed anom alies are in som e way related to the tendency of the f-orbital to get delocalised, in other words, to the capability of these fions to exist in m ore than one valence state. N aturally, the f-ions with deeply localised f-orbital, like G d, are expected to behave norm ally without any unusual electron correlation e ects known for the above-m entioned class of f-ions and therefore careful investigations on G d systems by and large do not exist in the literature. During the course of our investigations of strongly correlated electron system s (SCES), we cam e across som eGd alloys in which the observations are so puzzling that this fundam ental assumption in this eld is questionable. This

article, surveying our experimental ndings with few examples, raises a question whether the understanding of the electron correlation e ects in "norm al" rare-earths is truly complete.

II. UNUSUAL RESULTS IN TERNARY GD COMPOUNDS DER IVED FROM ALB2-DER IVED HEXAGONAL STRUCTURE

A systematic investigation of G d based alloys was actually motivated by our original observation of heavy-fermion-like heat-capacity (C) anomalies in G d-substituted LaC $u_2 S i_2^{1}$, similar to that known for C e alloys in the low-coupling lim \pm^2 . Subsequently, we noticed that the electrical resistivity () of G dN $i_2 S i_2^{3}$ and G dN i^4 over a wide temperature (T) range above respective magnetic ordering temperatures (T_o) could be suppressed to relatively smaller values by the application of a magnetic eld (H). In other words, these G d compounds are found to exhibit negative magnetoresistance (M R), the magnitude of which increases with decreasing temperature. This noting implies that there is a T-dependent

-component in excess of lattice contribution present in these materials. W hile all these features, new as far as G d albys are concerned, are typical of K ondo albys, no distinct minimum in the T dependence of could be observed in the raw experimental data. It is therefore of interest to bok for G d albys which can directly show this minimum in the raw data. In this respect, the ternary G d compounds, crystallizing in the A B₂-derived hexagonal structure, provided an unique situation to dem onstrate this aspect as well. W hile the reader m ay refer to all our published articles for various measurements and discussions 5;6;7;8;9;10;11;12;13;14, here we summarise the key experimental ndings.

The behaviour of the com pound $G d_2 P dSi_5^5$ by far remains as the best example to demonstrate our point. We have con med by various measurements including $^{155}G d$ M ossbauer e ect studies that the compound $G d_2 P dSi_3$ undergoes long range antiferrom agnetic ordering at $(T_N =) 21$ K. As far as (T) behaviour is concerned, what one would therefore expect is that the T-coe cient of is positive above 21 K. Looking at gure 1 (a and c), $(T) of G d_2 P dSi_3$ gradually decreases as the T is low ered down to 60 K, how ever followed by an upturn below about 45 K, thus giving rise to a resistivity minimum at about $(T_m in) 45$ K. The value of before the onset ofm agnetic ordering (say, at 22 K) is about 5% higher compared to that at $T_m in$.

Such a behaviour of with a distinct minimum in the param agnetic state was not previously observed for any "norm al" (that means, with deeply localised forbital) fion based interm etallic com pound. Further low ering of T below T_N does not result in a drop in (T), as expected due to the loss of spin-disorder contribution, and this nding is not relevant to the present discussion; this is understandable in terms of opening of a pseudogap at som e portions of the Ferm i surface due to the onset of antiferrom agnetic ordering]. Substitution of Y for G d results in a depression of T_N as expected, but the m inimum in (T) persists (see Fig. 1a). The fact that the m in im um is observable also in the sam ple with the highest Y content (x = 0.8) excludes any explanation for the observed minimum at 45 K in Gd_2PdSi_3 in term softhe opening of an energy gap above 21 K .W e have also estim ated the 4f-contribution $(_{4f})$ to by subtracting the of Y analogue; for this purpose, we adjusted the slope of (T) plot with that of Gd_2PdSi_3 at 100 K and then m atching the value at 100 K; though such an analysis to subtract out lattice contribution is not free from am biquities, one gets an idea about T-dependence of "excess " ($_{4f}$ = (T)- $_{lattice}$) from the derived data (shown in Fig. 1b). Irrespective of the nature of reference for lattice contribution, the tem perature coe cient of 4f is found to be distinctly negative in the param agnetic state.

W e have also m easured in the presence of an externally applied H. For x = 0.0, it is found that MR, de ned as [(H)- (0)]/ (0), is about -10% at 40 K in the presence of, say, H = 70 kOe, which is very large for a norm al interm etallic com pound in this tem perature range⁵. Interestingly, the minimum in (T) vanishes in the presence of H (say at 50 kO e) and exhibits a posit ive T coe cient in the entire range (Fig. 1b). The m agnitude of MR keeps increasing with decreasing T for a given H. These features are characteristics of K ondo alloys as well. It is to be noted⁵ that a large MR was not observed even for the analogous K ondo com pound, Ce_2PdSi_3 , which emphasizes the importance of the nding in the Gd compound. A nother noteworthy nding is that the T at which MR starts taking noticeably large values (with a negative sign) decreases with decreasing G d concentration⁵, following the trend in T_N . This im – plies that the observed anom alies are magnetic in origin.

W ith respect to the C data (Fig. 1d), apart from the peaks attributable to magnetic ordering at T_N , the 4f contribution (C_m) to C exhibits a tail extending over a wide T range above T_N . For instance, for x= 0.8, for which T_N is lower than 2 K, the tail in C_m (T) extends to T as high as 20 K, with the value of C/T as large as 1 J/m ol K² at 2 K, com parable to the behaviour of prototype heavy-ferm ion system, CeCu₂Si₂.

It is clear from the above results that the compound, $G d_2 P dSi_3$, exhibits all the characteristics of (antiferrom agnetically) ordering K ondo lattice systems in , M R and C data, including a resistivity m inimum. These features could be con med even in single crystals of this compound⁸. In addition, the therm opower also exhibits

a large value at 300 K, typical of K ondo system s⁶. In order to explore whether these anom alies are due to an artifact of spin-glass freezing setting in around 45 K, we have probed frequency-dependence of ac susceptibility as well as possible irreversibilities in zero-eld-cooled and eld-cooled dc susceptibility behaviour carefully^{6;?}. The results obtained, apart from establishing that the magnetic ordering below 21 K is of a long-range type, rule out any type of m agnetic ordering above 21 K. Therefore, a question arises whether this compound could be the rst G d-based K ondo-lattice. O urphotoem ission data on the other hand revealed¹⁴ that there is no 4f-derived feature at the Ferm i level (E $_{\rm F}$) and that 4f-level is placed about 8 eV well below E_F , thereby conclusively establishing that this compound can not be categorised as a K ondo alloy. W e will return to further discussion on this "magnetic precursor e ect" (T-dependent "excess" and C_m above T_{o}) in Section 4.

Before closing this section, it is worth stating that two m one isostructural G d com pounds, viz., $G d_2 P t S i_3^{13}$ and $G d_2 C u G e_3^{12}$, have been subsequently identi ed to exhibit properties resembling those of $G d_2 P d S i_3$. This suggests that the anom alies discussed here m ust be m ore com m on am ong G d interm etallics.

III. BEHAVIOUR OF SOM E OTHER GD COM POUNDS

The observation of unusual magnetic precursor e ects in the ternary G d compounds mentioned above raises many questions: (i) A re these anomalies specic c to this crystal structure? (ii) Is it something to do with the layered nature of G d ions in this crystal structure? (iii) Is it due to polarization of the d-band of some of the transition metal ions, like Pt or Pd, which are prone for induction of m om ents by the large m om ent-carrying neighbouring ions (like G d)? (iv) Is this magnetic precursor e ect anything to do with the type of magnetic structure at lower tem peratures? (v) Is there relationship between C and

anom alies? In order to tackle these issues, we have investigated a large number of G d com pounds⁷ with different crystal structures. The results clearly established that there is no straightforward relationship between the observation of the "excess " on the one hand, and the crystal structure or the type of transition m etal and sp ions present in the com pound, on the other. It was also established that possible onset of m agnetic correlations within a layer before long-range m agnetic order sets in can not be o ered as the sole reason for excess , as m any of the com pounds with G d layers are not characterized by this "excess ". A lso, G d com pounds exhibiting excess

fall into the category of both ferrom agnets and antiferrom agnets and therefore the nature of the magnetic structure below T $_{\circ}$ is not the determ ining factor.

A further careful look at the features above T_{o} in the and C data revealed⁷ that the G d alloys can be classied into three categories: (i) M agnetic precursor e ects

appearing in both and C; (ii) "Excess " and hence "M R anom aly" are negligible, but C tail persists over a wide tem perature range; (iii) Both "excess " and "excess C" are absent. The behaviour of the second category of G d com pounds is dem onstrated in gure 2 by showing the data for G dC u_2 G e_2 , crystallizing in the layered ThC r_2 Si₂-type crystal structure, for which T_N is about 13 K. It is obvious from this gure that, apart from sm all m agnitude, the sign of M R is not even negative (unlike rst category of G d alloys) in the entire T range.

IV . D ISC U SSIO N

The central experim ental observation is that, in some Gd alloys, the spin-disorder contribution to in the param agnetic state apparently is not a constant value, but increases gradually with decreasing T as one approaches magnetic ordering temperature, resulting in Kondo-lattice-like characteristics. At this juncture, it may be mentioned that sim ilar observations have been m ade also for $Eu_2CuSi_3^{11}$ and $Tb_2PdSi_3^{17}$ and therefore these anom alies must be more com mon among other rareearths as well with deeply localised forbitals. Since this feature does not arise from the Kondo e ect, the origin of this unusual magnetic precursor e ect remains a puzzle. One can not attribute it to Fisher-Langer type of critical spin- uctuations at T $_{\circ}^{15;?}$, considering that the T-range over which these features above T_o appear is too large to be explained by this idea; in addition, the absence of a relationship between C and anomaly in second category of G d com pounds is convincing enough to rule out this possibility. It therefore appears that the "excess " in rst category Gd compounds arises from a hitherto unrecognised phenomenon in momentcarrying m etals above To. W e speculate that the form ation "magnetic polarons" (localisation or trapping of the conduction electron cloud polarised by the s-f exchange interaction) above T_o could be the root-cause of these anom alies. The proposed magnetic localisation could be triggered by G d4f short range m agnetic order and consequent spatial magnetic uctuations, just as crystallographic disorder reduces the mobility of charge carriers. W e have observed⁸ distinct anom alies in Hall coe cient around 100 K in single crystals of Gd2PdSi3 and it is not clear at present whether this signals possible magnetic localisation e ects. The application of a magnetic eld suppresses the spin uctuations or alters the localization length resulting in an enhancem ent of the m obility of the electron cloud. This explains the suppression of the minimum in the paramagnetic state in a magnetic eld. Below $T_{\rm C}$, in ferror agnetic G d compounds like $G dN 1^4$, the polarons are anyway it inerant as they are coupled ferrom agnetically with the Gd 4fm om ent; as a result polaronic contribution can be turned o below T $_{\rm C}$. It must however be stated that the concept of m agnetic polarons have been generally ignored in m etals

in the literature due to the fact that large carrier density is expected to m ake these polarons delocalised. Possibly, in poor metals, one may have to still invoke this concept. If this proposal is con med in the compounds under discussion, one should explore various factors determ ining the presence or the absence of such e ects. Some of the decisive factors could be the relative magnitudes of mean free path, localization length and short range correlation length, in addition to the strength of polarization of the conduction band and carrier density.

A nother outcom e of the studies on G d alloys is the observation of negative M R even at tem peratures far above T_{\circ} (till $3T_{\circ}$), peaking at T_{\circ} in som e G d alloys (not presented here). These materials turned out to be one of the rst few interm etallics exhibiting giant magnetoresistance behavior in the param agnetic state at rather high temperatures. This nding established that neither double-exchange nor Jahn-Teller e ects (proposed for by-now well-known "manganites") is crucial to observe GMR behavior. Sim ilar conclusions were drawn based on the observation of GMR behaviour in the pyrochlore, $T \downarrow M n_2 O_7^{18;?}$, for which the concept of m agnetic polarons has been discussed²⁰. It is to be stressed that Gd2PdSi3 turned out to be the rst norm al intermetallic compound exhibiting $T \downarrow M n_2 O_7$ -like (T) behaviour.

V.CONCLUSION

The discussion presented in this article su ciently dem onstrates that, Gd interm etallics, which have been traditionally considered uninteresting from the magnetism point of view, exhibit novel behaviour in some com pounds with rich features in their physical properties, even in the param agnetic state. Our results on G d alloys bring out for the st time that the understanding of electron correlation e ects even in such "norm al" materials is far from complete. We hope that our data on several Gd com pounds will motivate new theoretical approaches in magnetism. W hatever be the microscopic origin of the anom alies, the results o er a message: O ne has to be a bit cautious while attributing low-tem perature upturns in and C in alloys of Ce, U or Yb non-Ferm i liquid and K ondo e ects, since these features may also be as a precursor e ect to the magnetic transitions occuring at further lower tem peratures. It is of interest to explore, both theoretically and experim entally, whether magnetic polarons can give rise to non-Ferm i liquid phenom ena.

DO WE UNDERSTAND ELECTRON CORRELATION EFFECTS IN GADOLINIUM BASED INTERMETALLIC COMPOUNDS?

Abstract.




Figure 1. (a) The electrical resistivity (ρ) of the alloys, $(Gd_{1-x}Y_x)_2PdSi_3$, normalised to respective 300 K values, as a function of temperature (T). (b) An estimate of "excess ρ " as a function of T for Gd_2PdSi_3 , obtained as described in the text. (c) The ρ as a function of T for Gd_2PdSi_3 in the absence of a magnetic field and in the presence of 50 kOe. (d) The 4f-contribution to heat-capacity as a function of T for the alloys, $(Gd_{1-x}Y_x)_2PdSi_3$.

We have confirmed by various measurements including ¹⁵⁵Gd Mössbauer effect studies that the compound Gd_2PdSi_3 undergoes long range antiferromagnetic ordering at $(T_N=)$ 21 K. As far as $\rho(T)$ behaviour is concerned, what one would therefore expect is that the T-coefficient of ρ is positive above 21 K. Looking at figure 1(a and c), $\rho(T)$ of Gd_2PdSi_3 gradually decreases as the T is lowered down to 60 K, however followed by an upturn below about 45 K, thus giving rise to a resistivity minimum at about (T_{min}) 45 K. The value of ρ before the onset

of magnetic ordering (say, at 22 K) is about 5% higher compared to that at T_{min} .

Such a behaviour of ρ with a distinct minimum in the paramagnetic state was not previously observed for any "normal" (that means, with deeply localised f-orbital) f-ion based intermetallic compound. Substitution of Y for Gd results in a depression of T_N as expected, but the minimum in $\rho(T)$ persists (see Fig. 1a). The fact that the minimum is observable also in the sample with the highest Y content (x = 0.8) excludes any explanation for the observed ρ minimum at 45 K in Gd₂PdSi₃ in terms of the opening of an energy gap above 21 K. We have also estimated the 4f-contribution (ρ_{4f}) to ρ by subtracting the ρ of Y analogue; for this purpose, we adjusted the slope of $\rho(T)$ plot with that of Gd_2PdSi_3 at 100 K and then matching the ρ value at 100 K; though such an analysis to subtract out lattice contribution is not free from ambiguities, one gets an idea about T-dependence of "excess ρ " ($\rho_{4f} = \rho(T) - \rho_{lattice}$) from the derived data (shown in Fig. 1b). Irrespective of the nature of reference for lattice contribution, the temperature coefficient of ρ_{4f} is found to be

distinctly negative in the paramagnetic state.

We have also measured ρ in the presence of an externally applied H. For x= 0.0, it is found that MR, defined as $[\rho(H)-\rho(0)]/\rho(0)$, is about -10% at 40 K in the presence of, say, H= 70 kOe, which is very large for a normal intermetallic compound in this temperature range (5). Interestingly, the minimum in $\rho(T)$ vanishes in the presence of H (say at 50 kOe) and ρ exhibits a positive T coefficient in the entire range (Fig. 1b). The magnitude of MR keeps increasing with decreasing T for a given H. These features are characteristics of Kondo alloys as well. It is to be noted (5) that a large MR was not observed even for the analogous Kondo compound, Ce₂PdSi₃, which emphasizes the importance of the finding in the Gd compound. Another noteworthy finding is that the T at which MR starts taking noticeably large values (with a negative sign) decreases with decreasing Gd concentration (5), following the trend in T_N . This implies that the observed anomalies are magnetic in origin.

With respect to the C data (Fig. 1d), apart from the peaks attributable to magnetic ordering at T_N , the 4f contribution (C_m) to C exhibits a tail extending over a wide T range above T_N . For instance, for x = 0.8, for which T_N is lower than 2 K, the tail in $C_m(T)$ extends to T as high as 20 K, with the value of C/T as large as 1 J/mol K² at 2 K, comparable to the behaviour of prototype heavy-fermion system, CeCu₂Si₂.

It is clear from the above results that the compound, Gd_2PdSi_3 , exhibits all the characteristics of (antiferromagnetically) ordering Kondo lattice systems in ρ , MR and C data, including a resistivity minimum. These features could be confirmed even in single crystals of this compound (8). In addition, the thermopower also exhibits a large value at 300 K, typical of Kondo systems (6). In order to explore whether these anomalies are due to an artifact of spin-glass freezing setting in around 45 K, we have probed frequency-dependence of ac susceptibility as well as possible irreversibilities in zero-field-cooled and field-cooled dc susceptibility behaviour carefully (6, 9). The results obtained, apart from establishing that the magnetic ordering below 21 K is of a long-range type, rule out any type of magnetic ordering above 21 K. Therefore, a question arises whether this compound could be the first Gd-based Kondo-lattice. Our photoemission data on the other hand revealed (14) that there is no 4f-derived feature at the Fermi level (E_F) and that 4f-level is placed about 8 eV well below E_F , thereby conclusively establishing that this compound can not be categorised as a Kondo alloy. We will return to further discussion on this "magnetic precursor effect" (T-dependent "excess" ρ and C_m above T_o) in Section 4.

Before closing this section, it is worth stating that two more isostructural Gd compounds, viz., Gd_2PtSi_3 (13) and Gd_2CuGe_3 (12), have been subsequently identified to exhibit properties resembling those of Gd_2PdSi_3 . This suggests that the anomalies discussed here must be more common among Gd intermetallics.

3. Behaviour of some other Gd compounds

The observation of unusual magnetic precursor effects in the ternary Gd compounds mentioned above raises many questions: (i) Are these anomalies specific to this crystal structure? (ii) Is it something to do with the layered nature of Gd ions in this crystal structure? (iii) Is it due to polarization of the d-band of some of the transition metal ions, like Pt or Pd, which are prone for induction of moments by the large moment-carrying neighbouring ions (like Gd)? (iv) Is this magnetic precursor effect anything to do with the type of magnetic structure at lower temperatures? (v) Is there relationship between C and ρ anomalies? In order to tackle these issues, we have investigated a large number of Gd compounds (7) with different crystal structures. The results clearly established that there is no straightforward relationship between the observation of the "excess ρ " on the one hand, and the crystal structure or the type of transition metal and s-p ions present in the compound, on the other. It was also established that possible onset of magnetic correlations within a layer before long-range magnetic order sets in can not be offered as the sole reason for excess ρ , as many of the compounds with Gd layers are not characterized by this "excess ρ ". Also, Gd compounds exhibiting excess ρ fall into the category of both ferromagnets and antiferromagnets and therefore the nature of the magnetic structure below T_{ρ} is not the determining factor.




Figure 2. Electrical resistivity in zero magnetic field and in the presence of a magnetic field of 50 kOe and magnetic contribution (C_{4f}) to heat-capacity, for GdCu₂Ge₂, demonstrating that this compound belongs to Category-II as described in the text.

A further careful look at the features above T_o in the ρ and C data revealed (7) that the Gd alloys can be classified into three categories: (i) Magnetic precursor effects appearing in both ρ and C; (ii) "Excess ρ " and hence "MR anomaly" are negligible, but C tail persists over a wide temperature range; (iii) Both "excess ρ " and "excess C" are absent. The behaviour of the second category of Gd compounds is demonstrated in figure 2 by showing the data for GdCu₂Ge₂, crystallizing in the layered ThCr₂Si₂-type crystal structure, for which T_N is about 13 K. It is obvious from this figure that, apart from small magnitude, the sign of MR is not even negative (unlike first category of Gd alloys) in the entire T range.

4. Discussion

The central experimental observation is that, in some Gd alloys, the spindisorder contribution to ρ in the paramagnetic state apparently is not a constant value, but increases gradually with decreasing T as one approaches

magnetic ordering temperature, resulting in Kondo-lattice-like characteristics. At this juncture, it may be mentioned that similar observations have been made also for Eu_2CuSi_3 (11) and Tb_2PdSi_3 (17) and therefore these anomalies must be more common among other rare-earths as well with deeply localised f-orbitals. Since this feature does not arise from the Kondo effect, the origin of this unusual magnetic precursor effect remains a puzzle. One can not attribute it to Fisher-Langer type of critical spin-fluctuations at T_o (15, 16), considering that the T-range over which these features above T_o appear is too large to be explained by this idea; in addition, the absence of a relationship between C and ρ anomaly in second category of Gd compounds is convincing enough to rule out this possibility. It therefore appears that the "excess ρ " in first category Gd compounds arises from a hitherto unrecognised phenomenon in moment-carrying metals above T_o . We speculate that the formation "magnetic polarons" (localisation or trapping of the conduction electron cloud polarised by the s-f exchange interaction) above T_{o} could be the root-cause of these anomalies. The proposed magnetic localisation could be triggered by Gd4f short range magnetic order and consequent spatial magnetic fluctuations, just as crystallographic disorder reduces the mobility of charge carriers. We have observed (8) distinct anomalies in Hall coefficient around 100 K in single crystals of Gd₂PdSi₃ and it is not clear at present whether this signals possible magnetic localisation effects. The application of a magnetic field suppresses the spin fluctuations or alters the localization length resulting in an enhancement of the mobility of the electron cloud. This explains the suppression of the ρ minimum in the paramagnetic state in a magnetic field.

Below T_C , in ferromagnetic Gd compounds like GdNi (4), the polarons are anyway itinerant as they are coupled ferromagnetically with the Gd 4f moment; as a result polaronic contribution can be turned off below T_C . It must however be stated that the concept of magnetic polarons have been generally ignored in metals in the literature due to the fact that large carrier density is expected to make these polarons delocalised. Possibly, in poor metals, one may have to still invoke this concept. If this proposal is confirmed in the compounds under discussion, one should explore various factors determining the presence or the absence of such effects. Some of the decisive factors could be the relative magnitudes of mean free path, localization length and short range correlation length, in addition to the strength of polarization of the conduction band and carrier density.

Another outcome of the studies on Gd alloys is the observation of negative MR even at temperatures far above T_o (till $3T_o$), peaking at T_o in some Gd alloys (not presented here). These materials turned out to be one of the first few intermetallics exhibiting giant magnetoresistance behavior in the paramagnetic state at rather high temperatures. This finding established that neither double-exchange nor Jahn-Teller effects (proposed for by-now well-known "manganites") is crucial to observe GMR behavior. Similar conclusions were drawn based on the observation of GMR behaviour in the pyrochlore, $Tl_2Mn_2O_7$ (18, 19), for which the concept of magnetic polarons has been discussed (20). It is to be stressed that Gd_2PdSi_3 turned out to be the first normal intermetallic compound exhibiting $Tl_2Mn_2O_7$ -like $\rho(T)$ behaviour.

5. Conclusion

The discussion presented in this article sufficiently demonstrates that, Gd intermetallics, which have been traditionally considered uninteresting from the magnetism point of view, exhibit novel behaviour in some compounds with rich features in their physical properties, even in the paramagnetic state. Our results on Gd alloys bring out for the first time that the understanding of electron correlation effects even in such "normal" materials is far from complete. We hope that our data on several Gd compounds will motivate new theoretical approaches in magnetism. Whatever be the microscopic origin of the anomalies, the results offer a message: One has to be a bit cautious while attributing low-temperature upturns in ρ and C in alloys of Ce, U or Yb non-Fermi liquid and Kondo effects, since these features may also be as a precursor effect to the magnetic transitions occuring at further lower temperatures. It is of interest to explore, both theoretically and experimentally, whether magnetic polarons can give rise to non-Fermi liquid phenomena.
